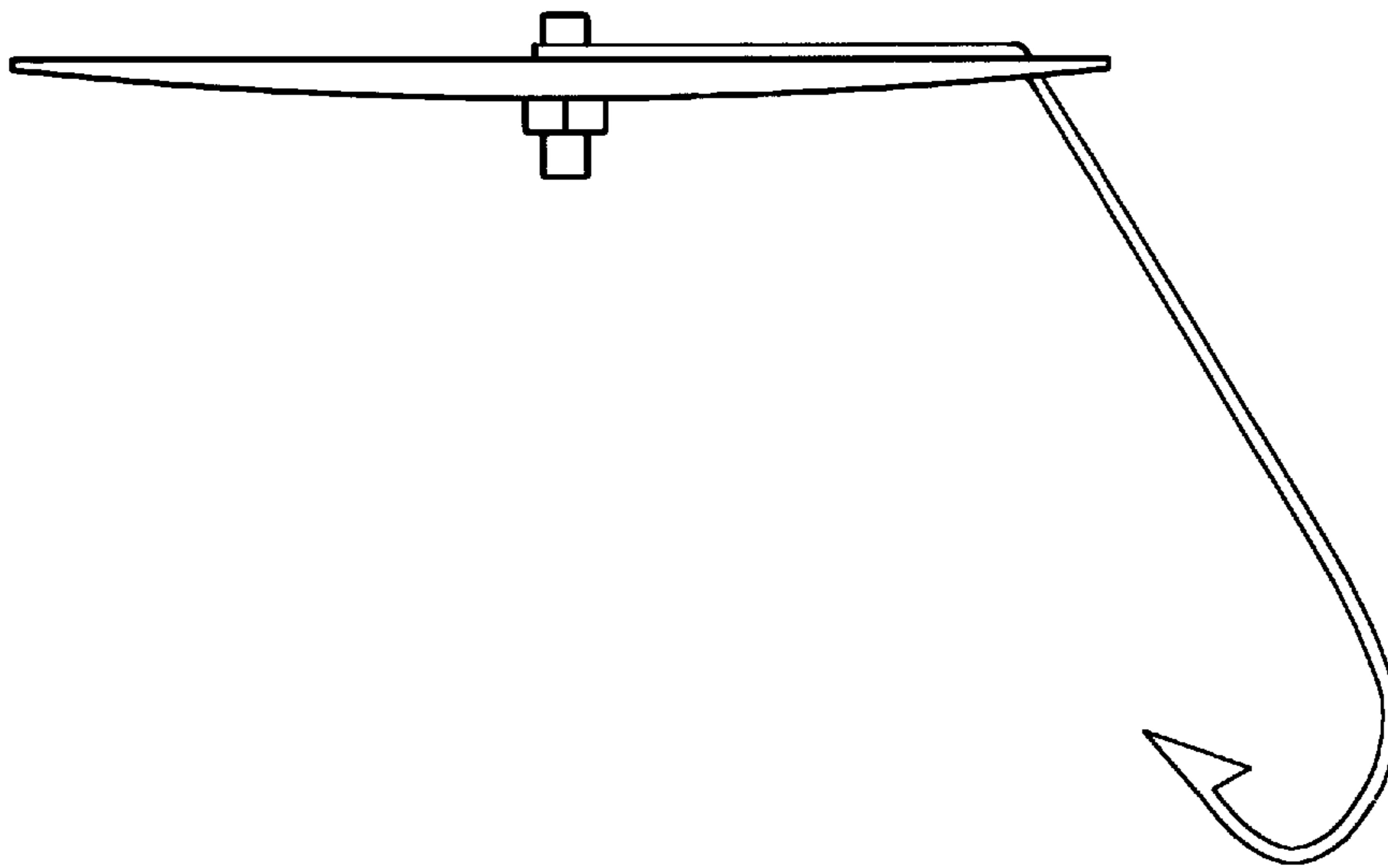
[57] **CLAIM**

The ornamental design for a fishing lure, as shown and described.

DESCRIPTION

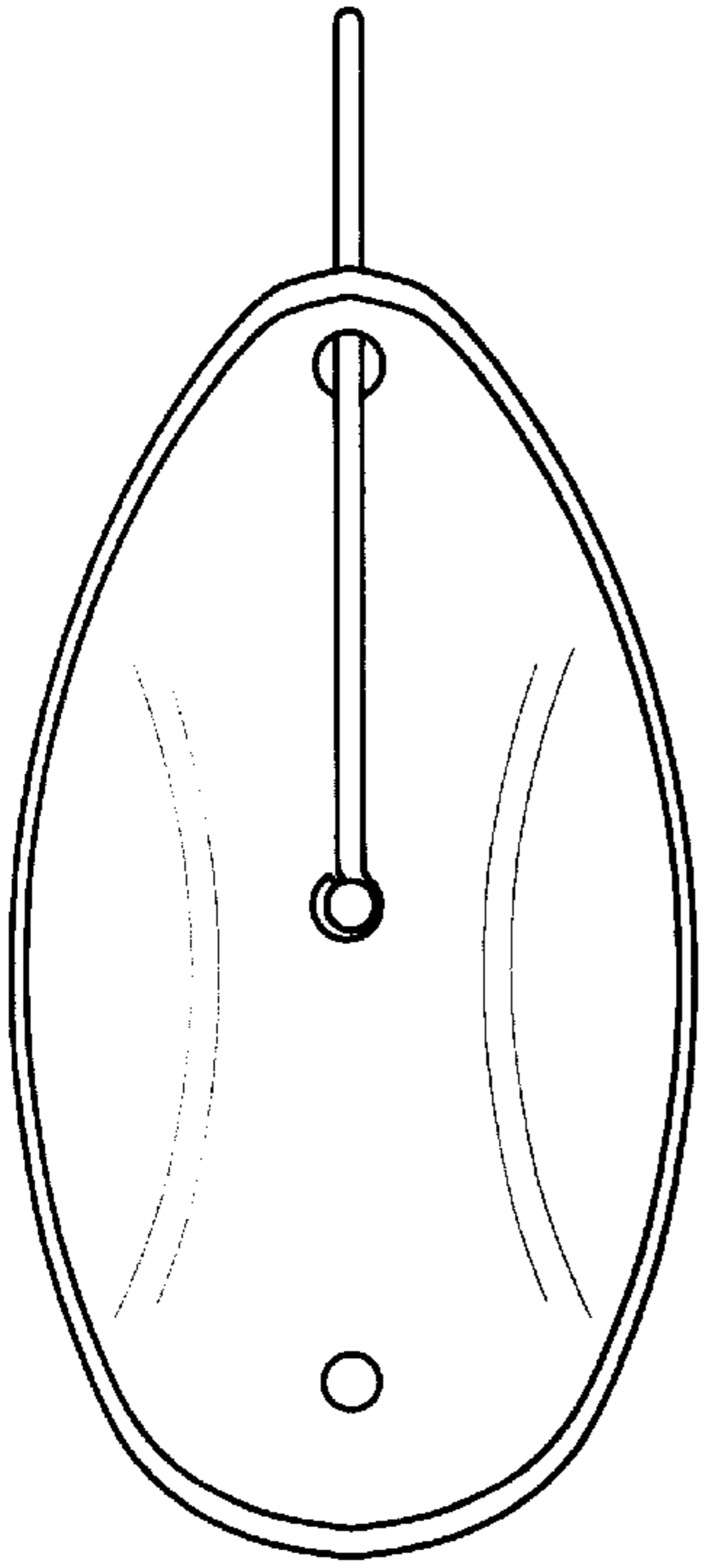

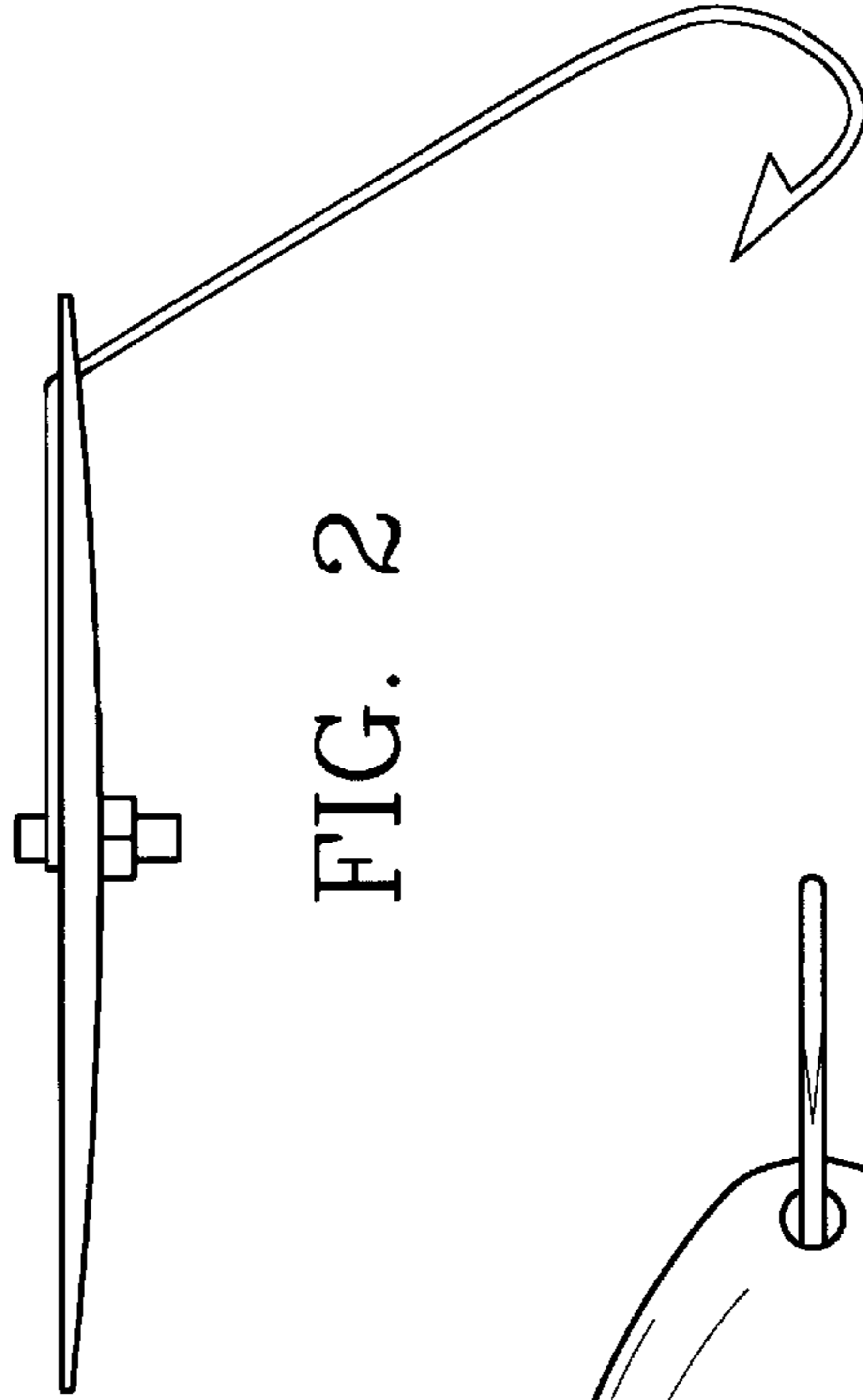

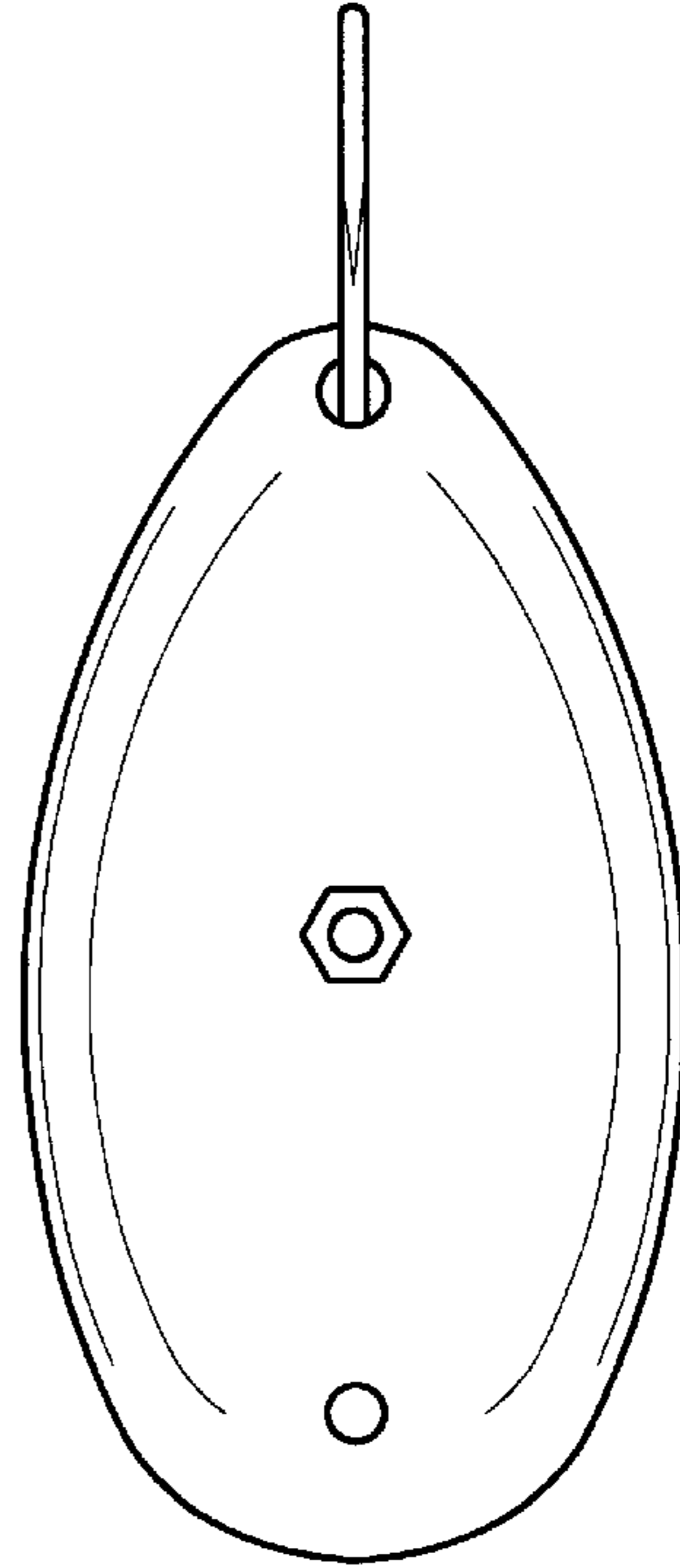
