DESCRIPTION

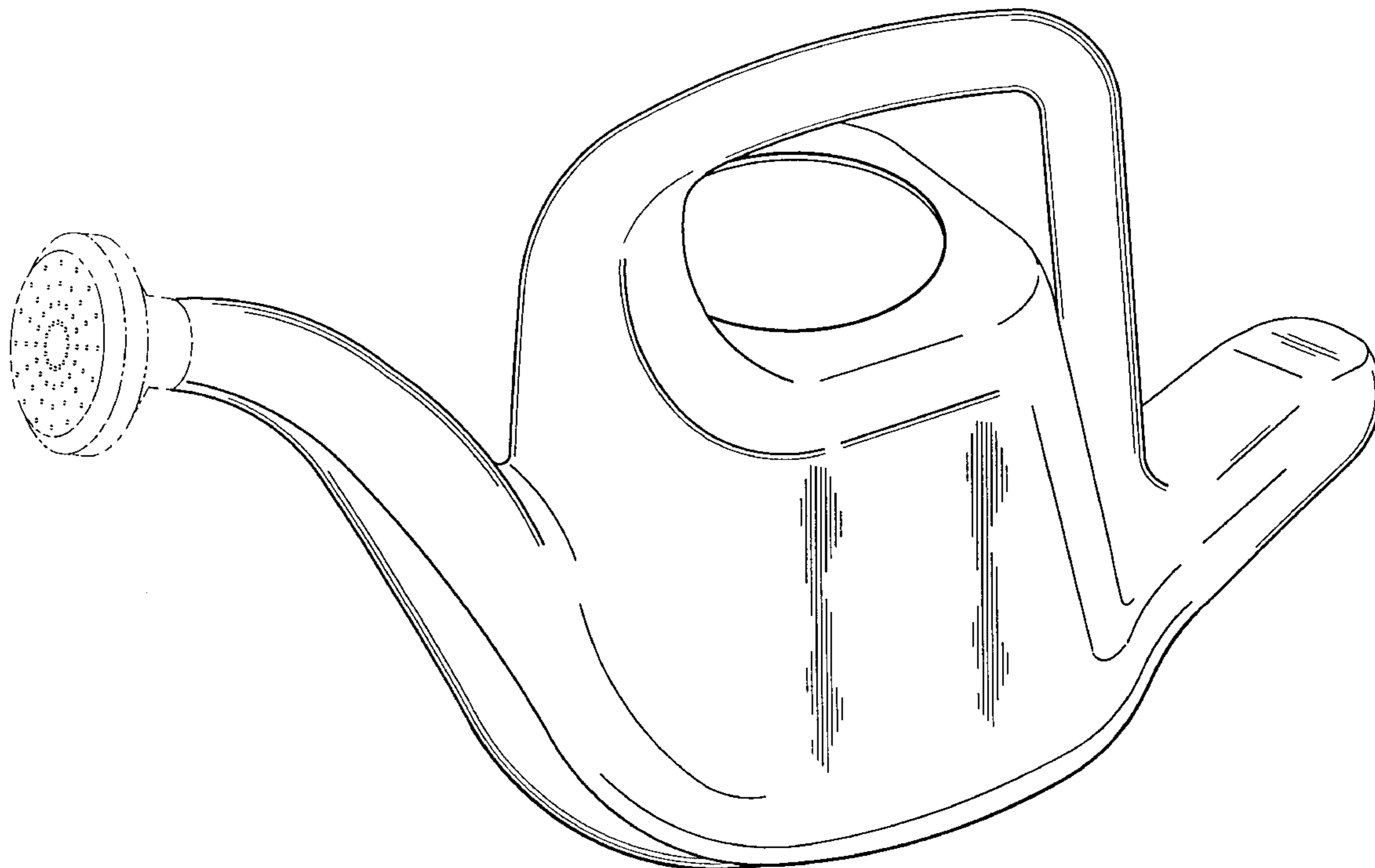
FIG. 1 is a perspective view of a watering can, constructed in accordance with the presently disclosed design; FIG. 2 is a top plan view thereof, shown in a different scale for ease of illustration; FIG. 3 is a side elevation view of FIG. 2, the opposite side being a mirror image thereto; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; and, FIG. 6 is a bottom plan view thereof. The dotted line showing of a watering spout is for illustrative purposes only and forms no part of the claimed design.

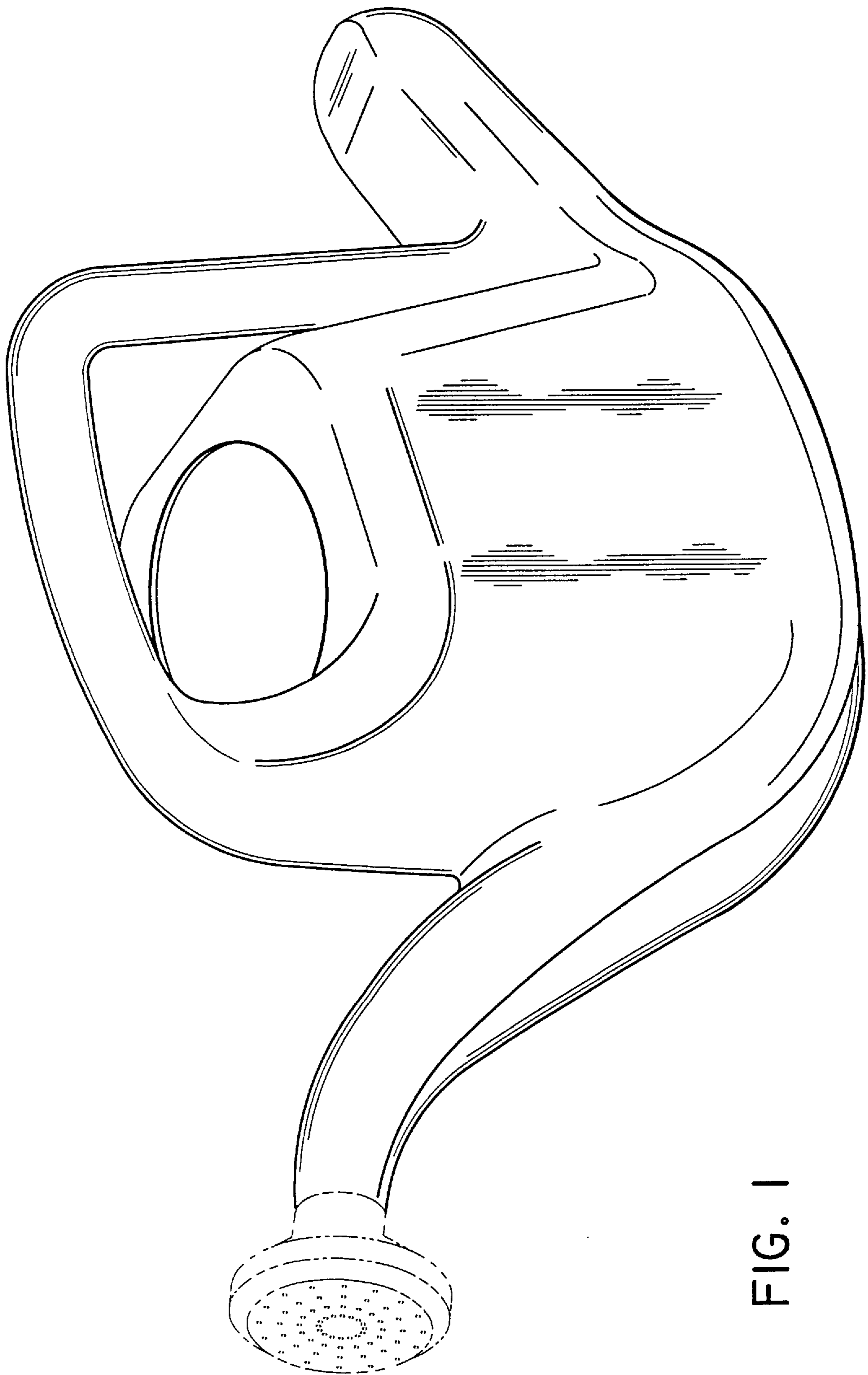

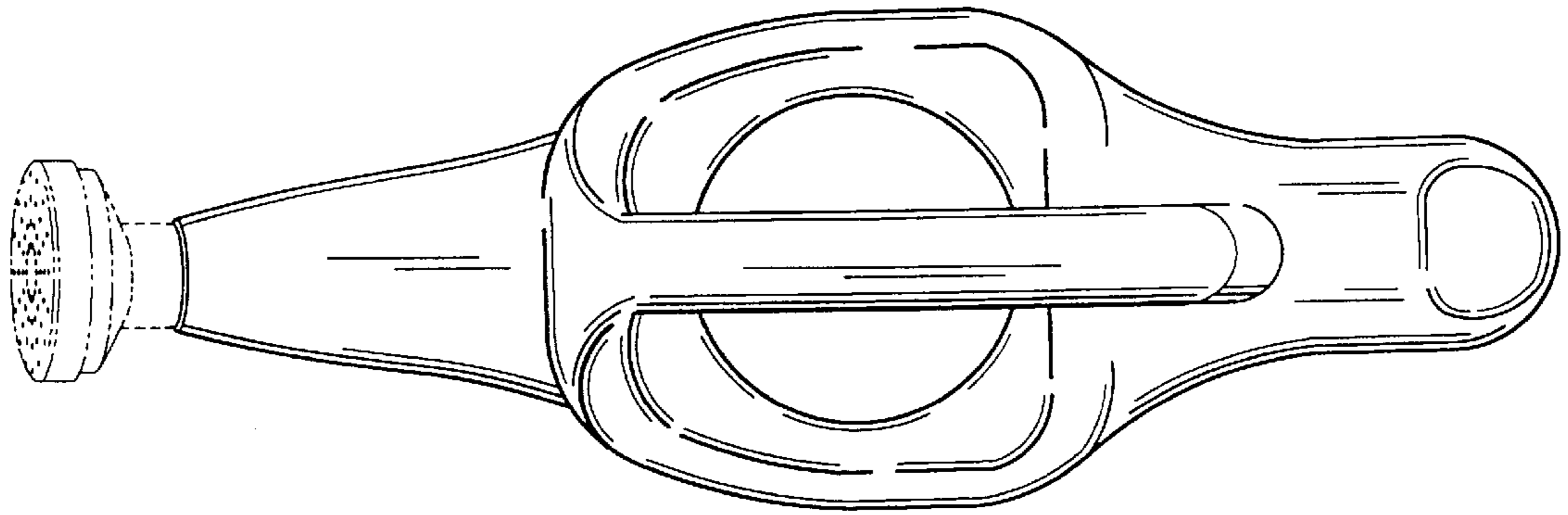

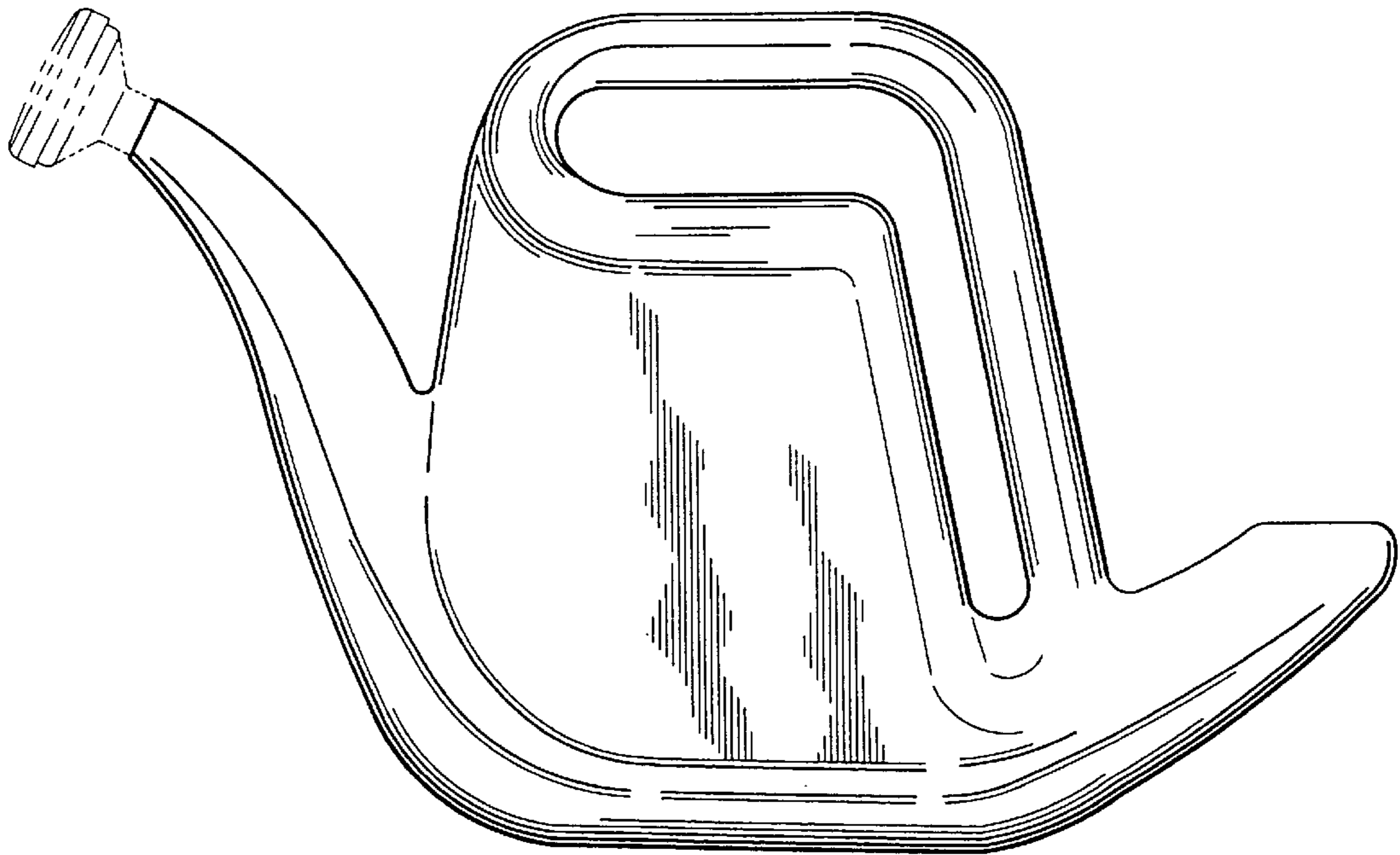

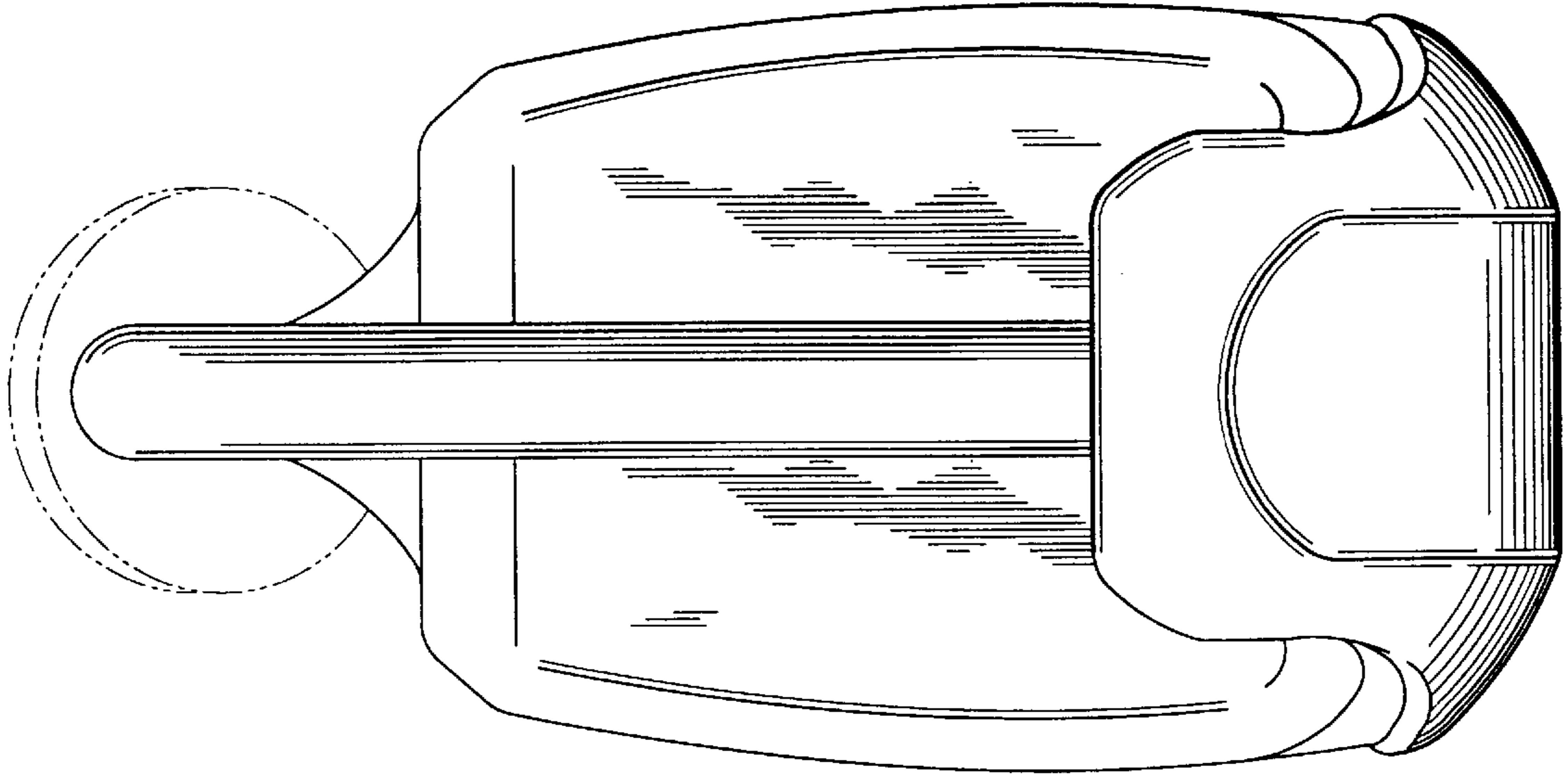

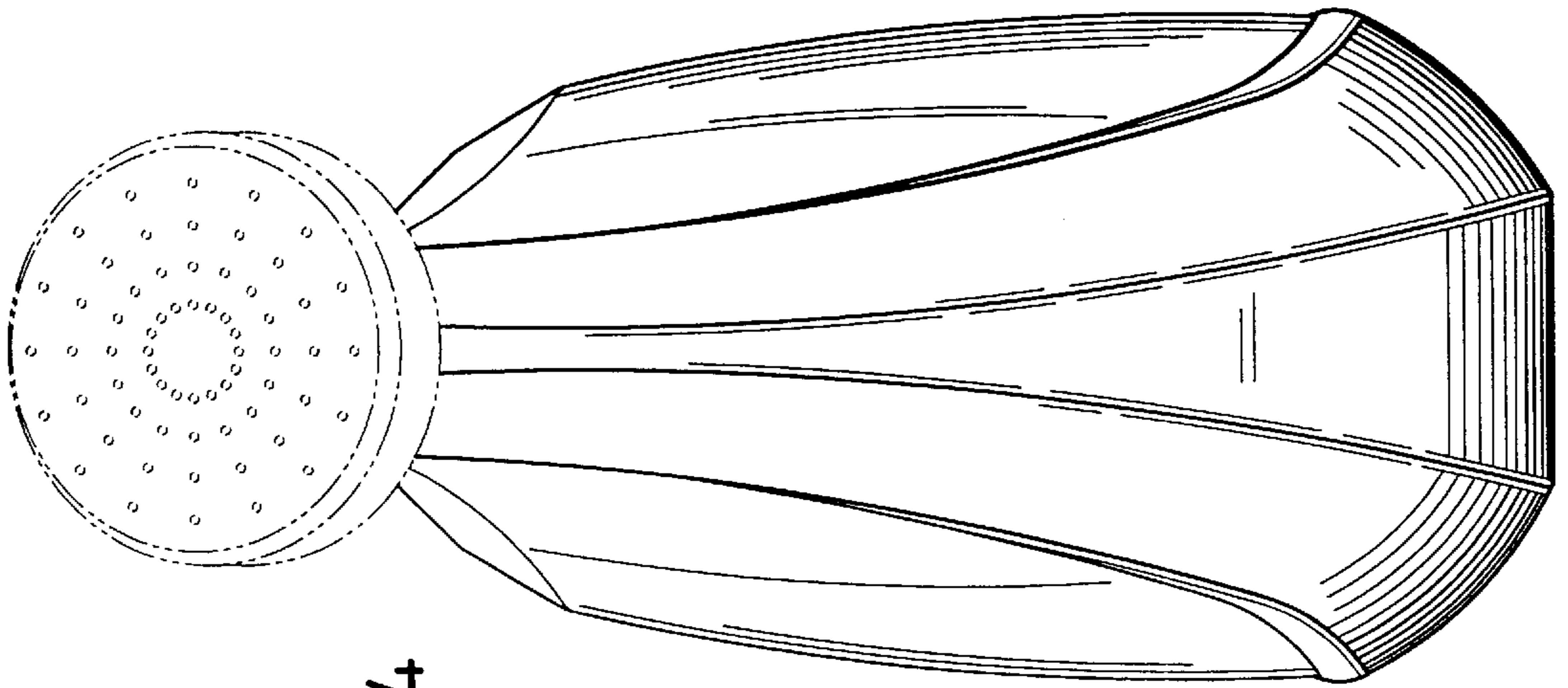

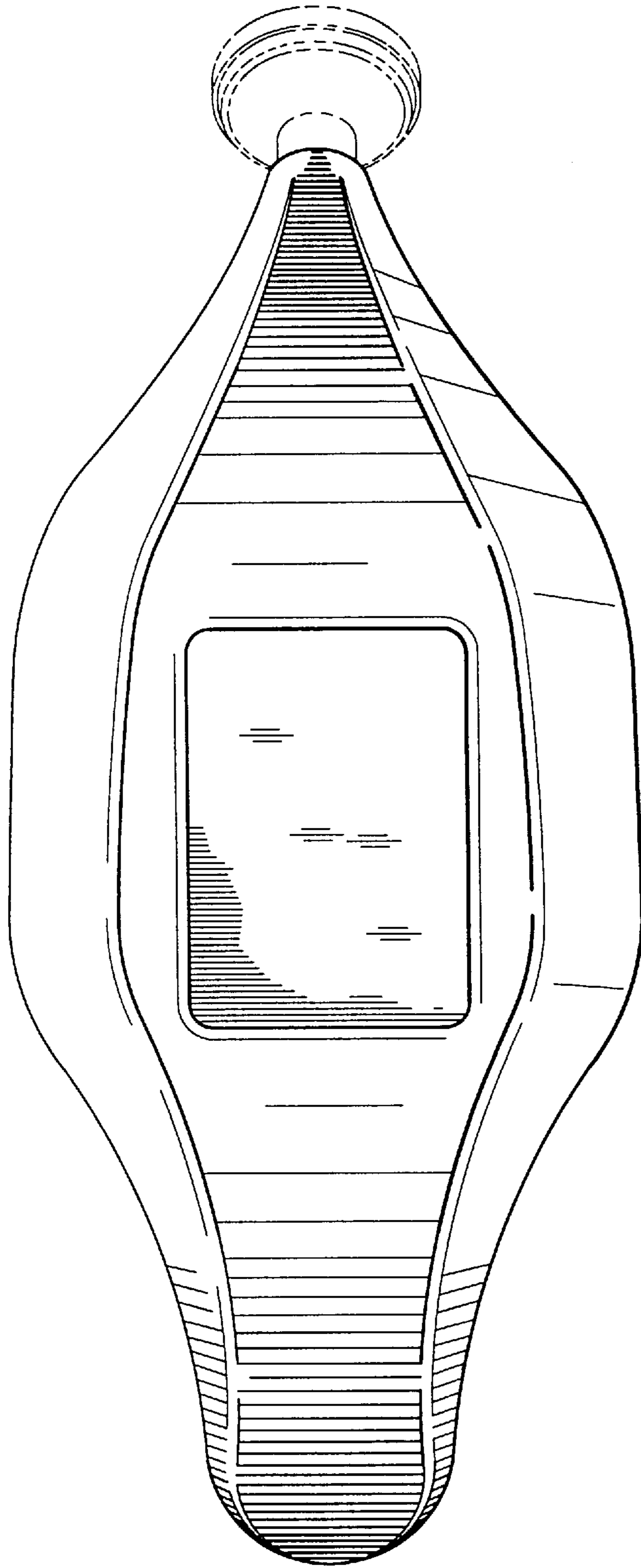
