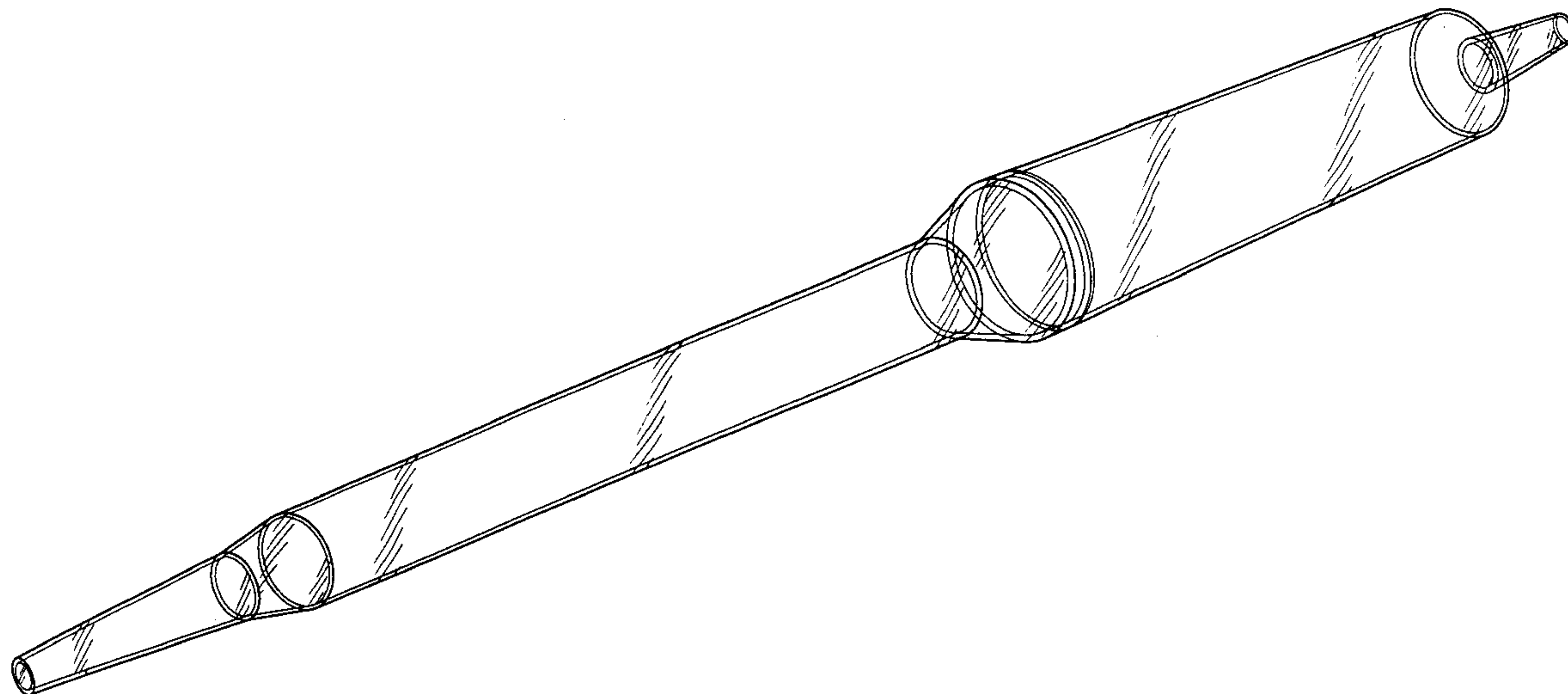
[57] **CLAIM**

The ornamental design for a multistage pipet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the multistage pipet; FIG. 2 is a rear perspective view thereof; FIG. 3 is a top plan view with all the sides being a mirror image of one another; FIG. 4 is a left end elevational view thereof; and, FIG. 5 is a right end elevational view thereof.

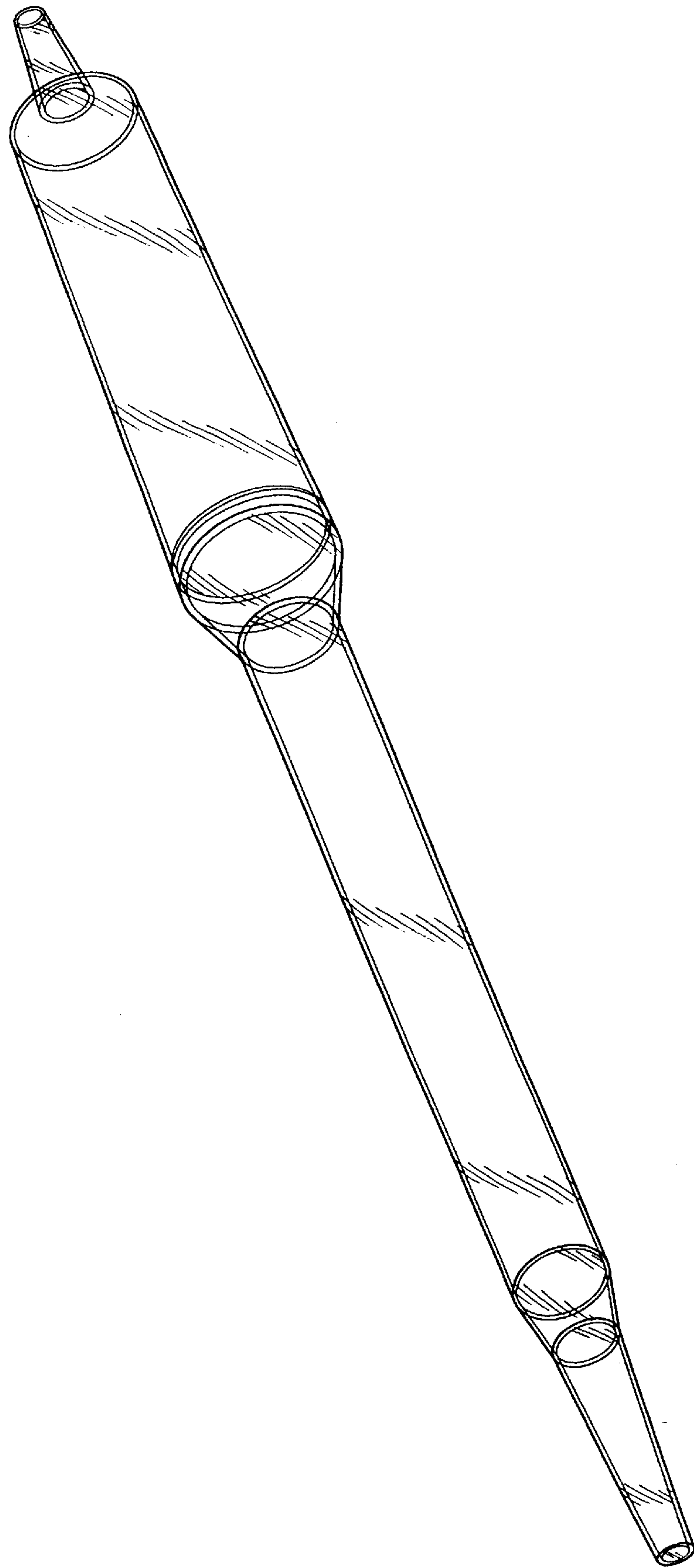

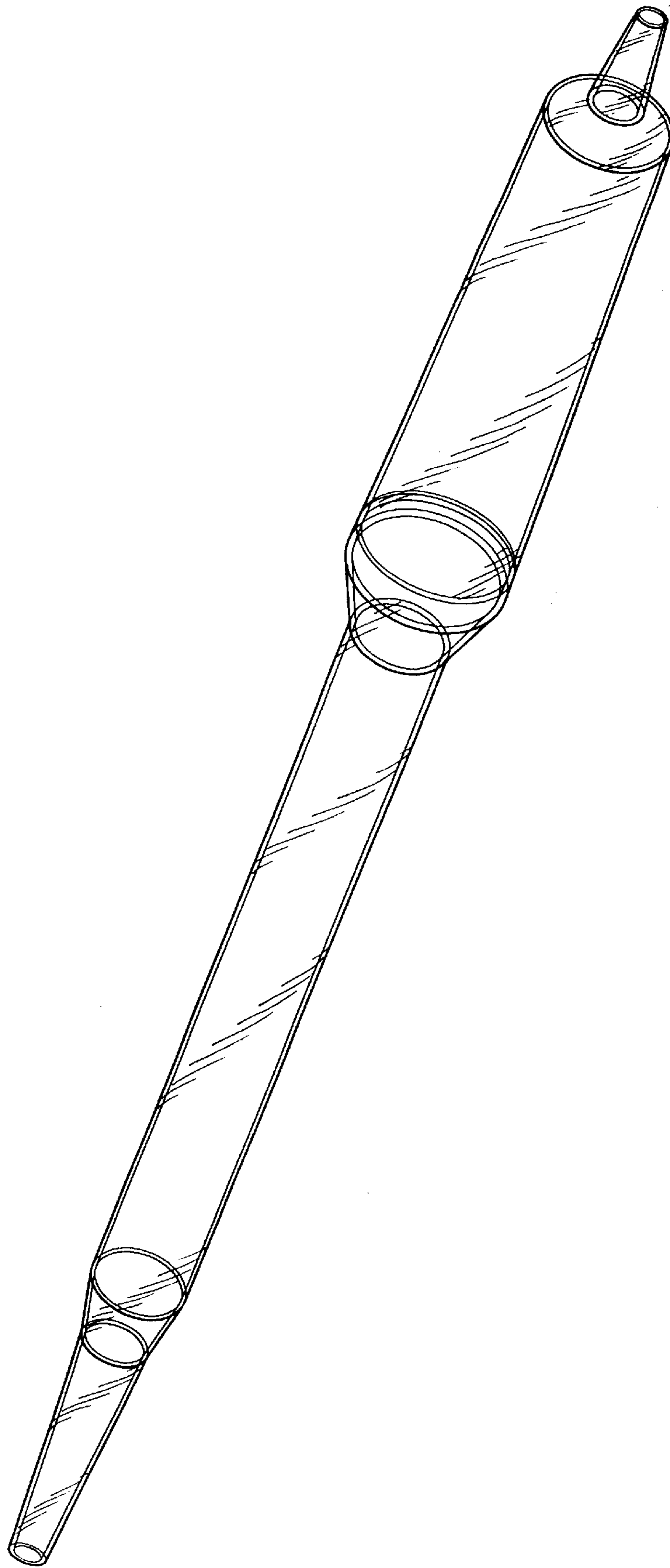

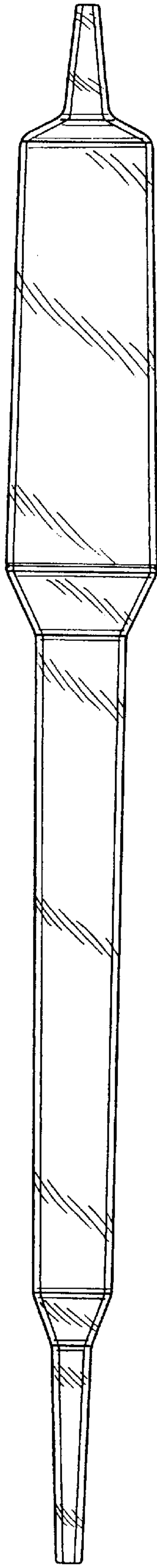

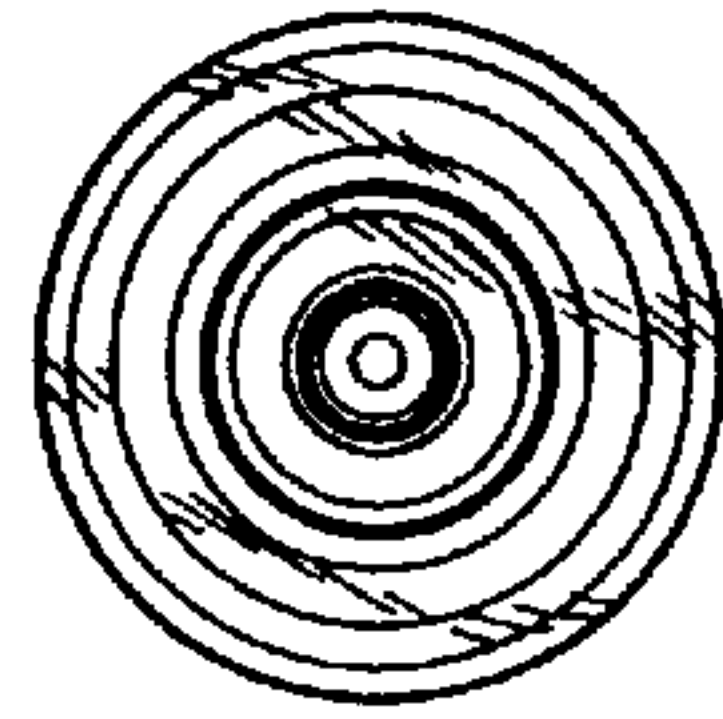
