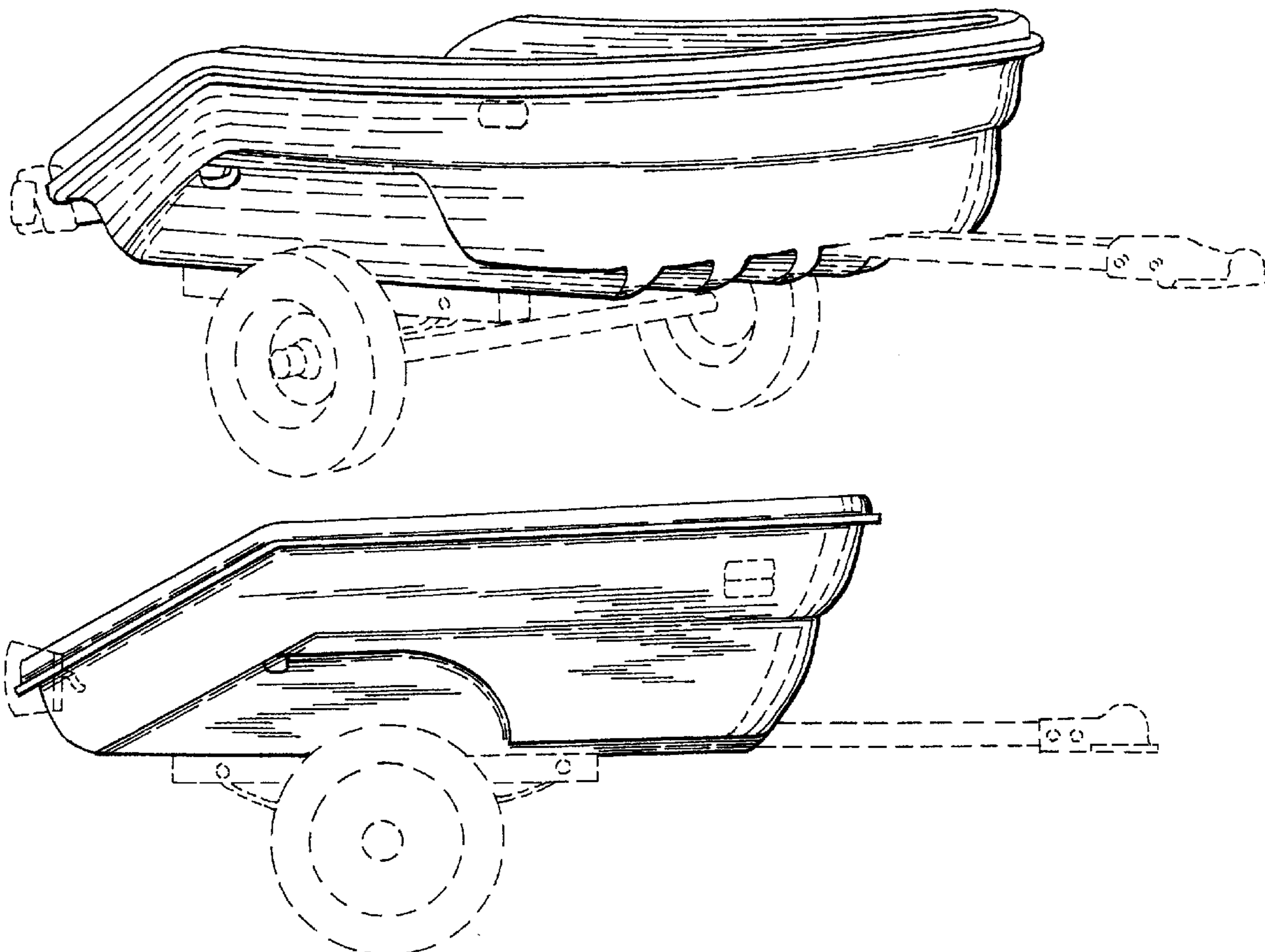

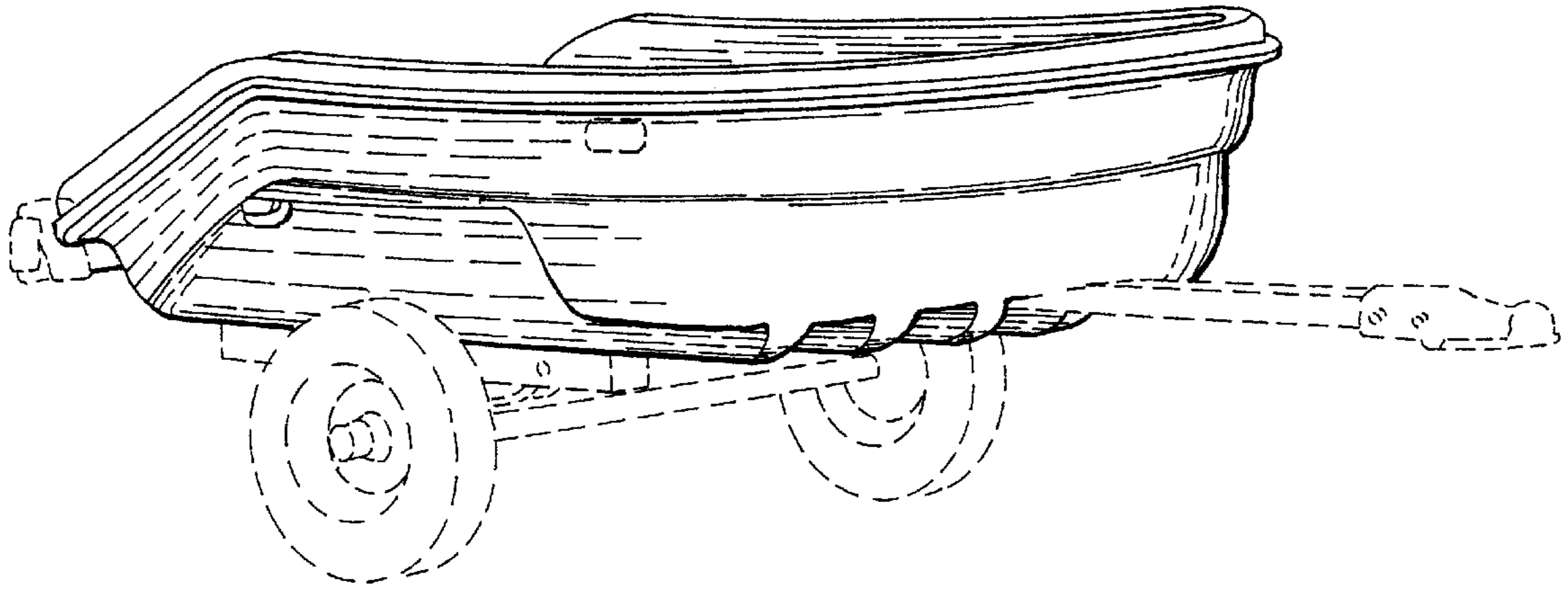
The ornamental design of a trailer, as shown and described.

**DESCRIPTION**

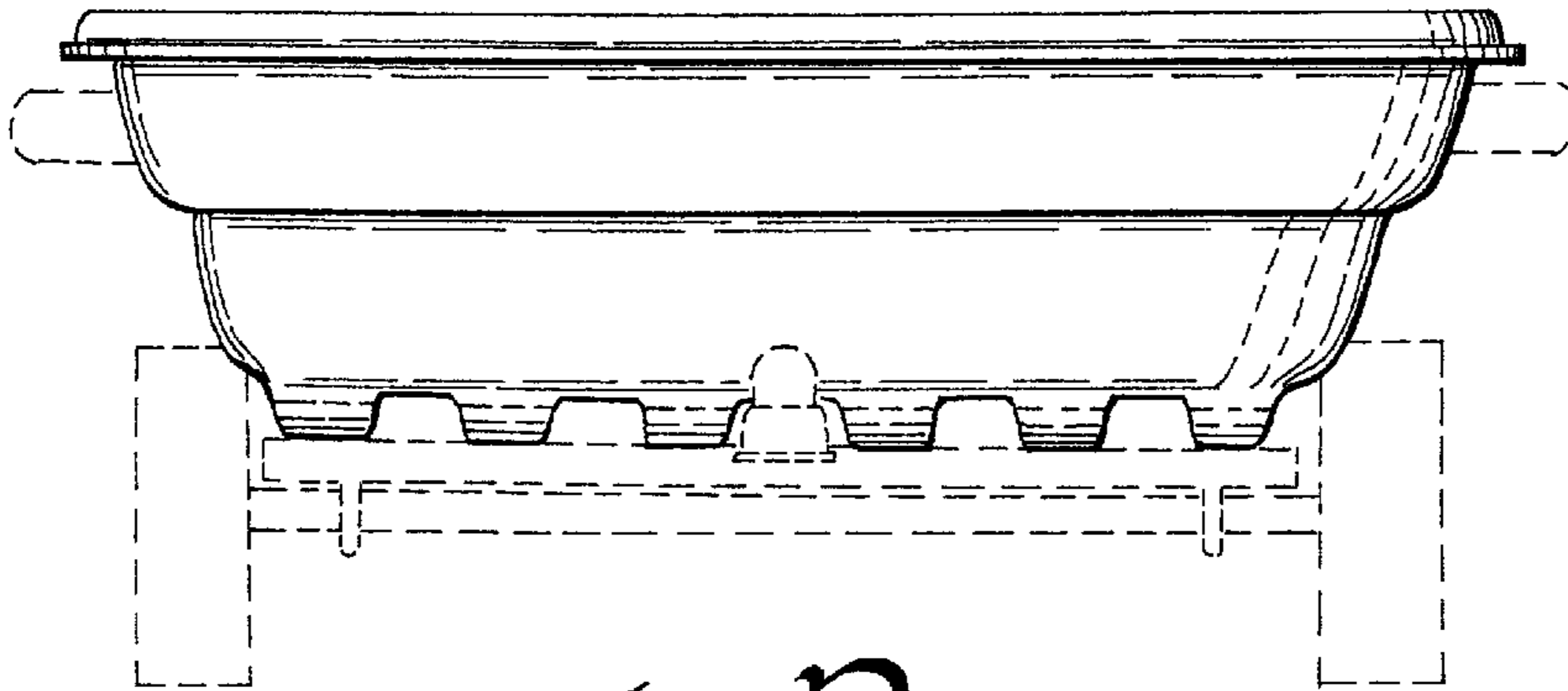
FIG. 1 is a perspective view of the trailer of the present invention;  
FIG. 2 is a front elevational view thereof;

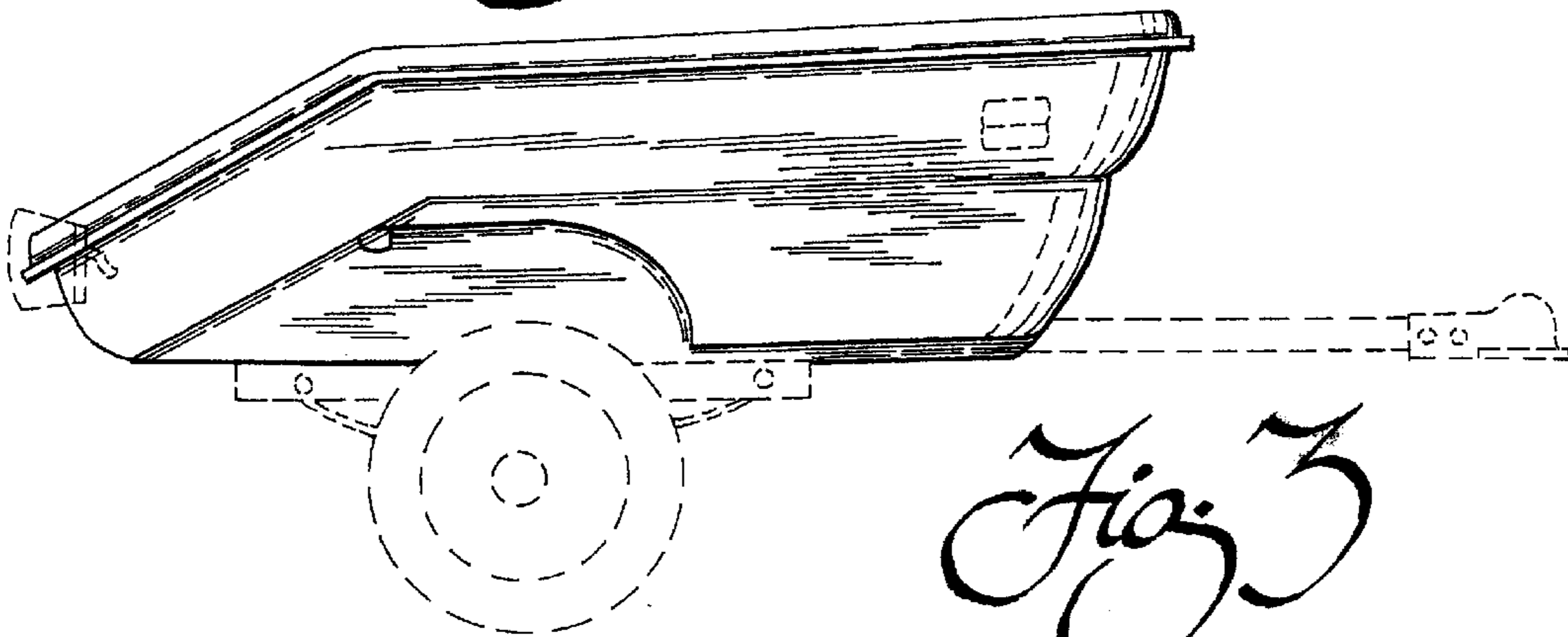




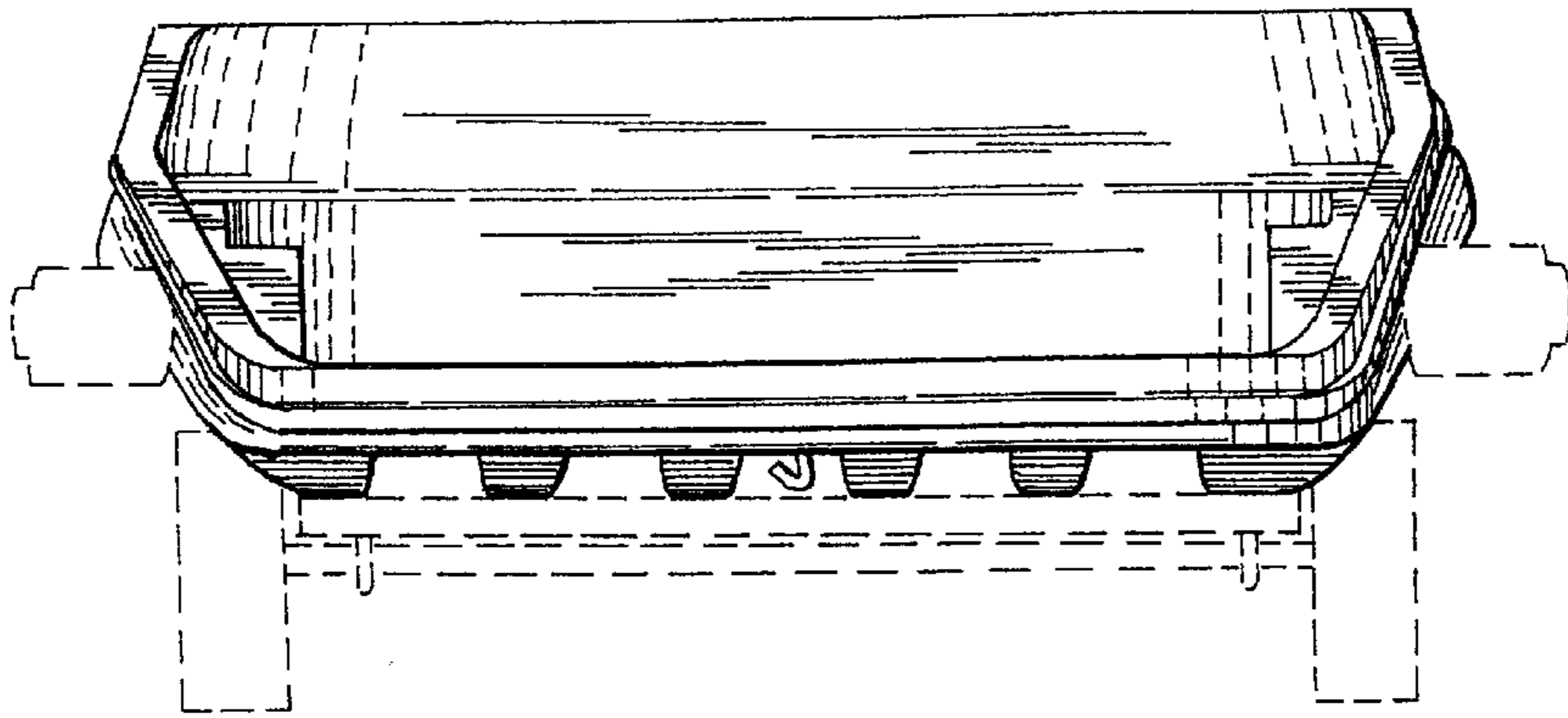

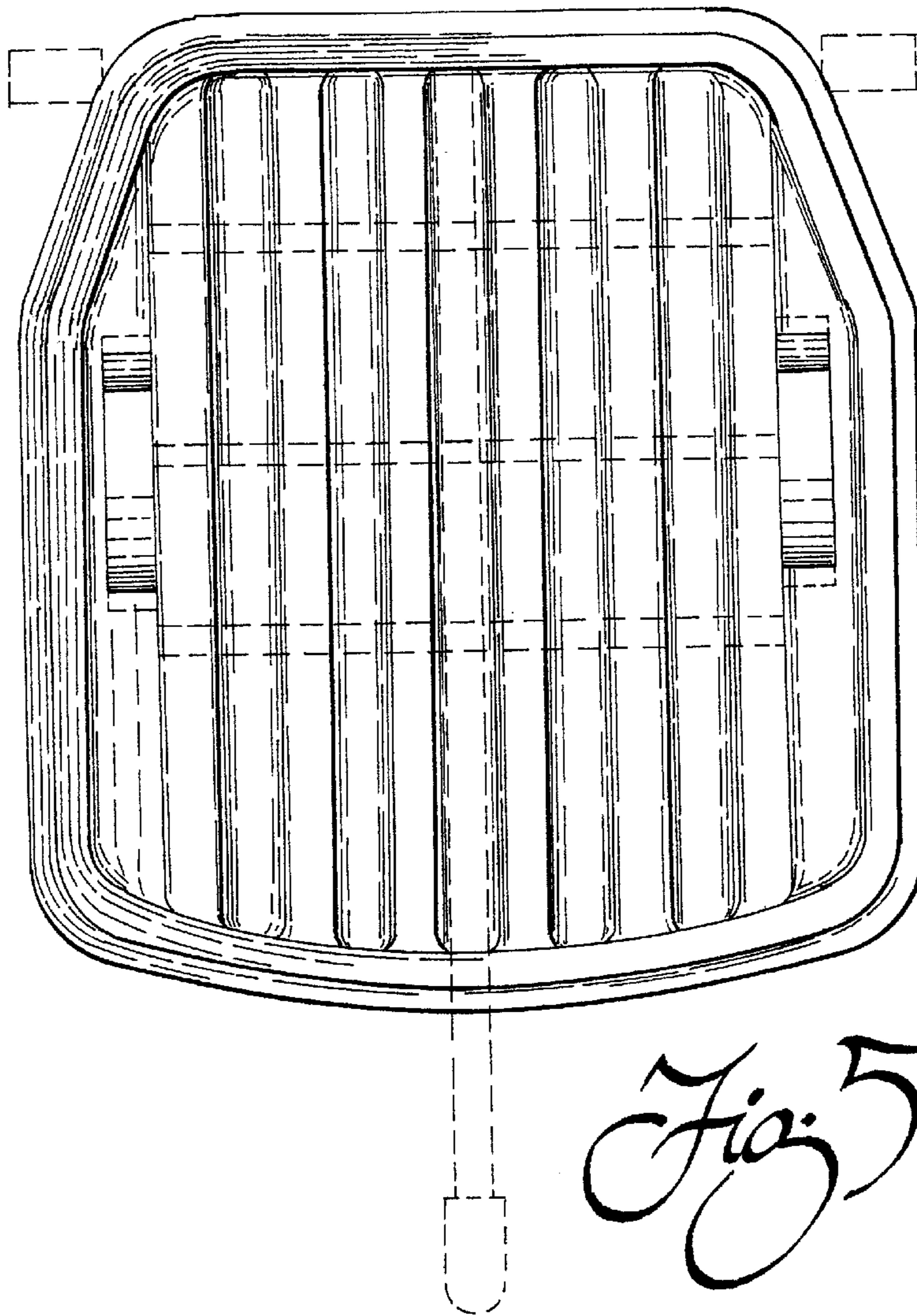

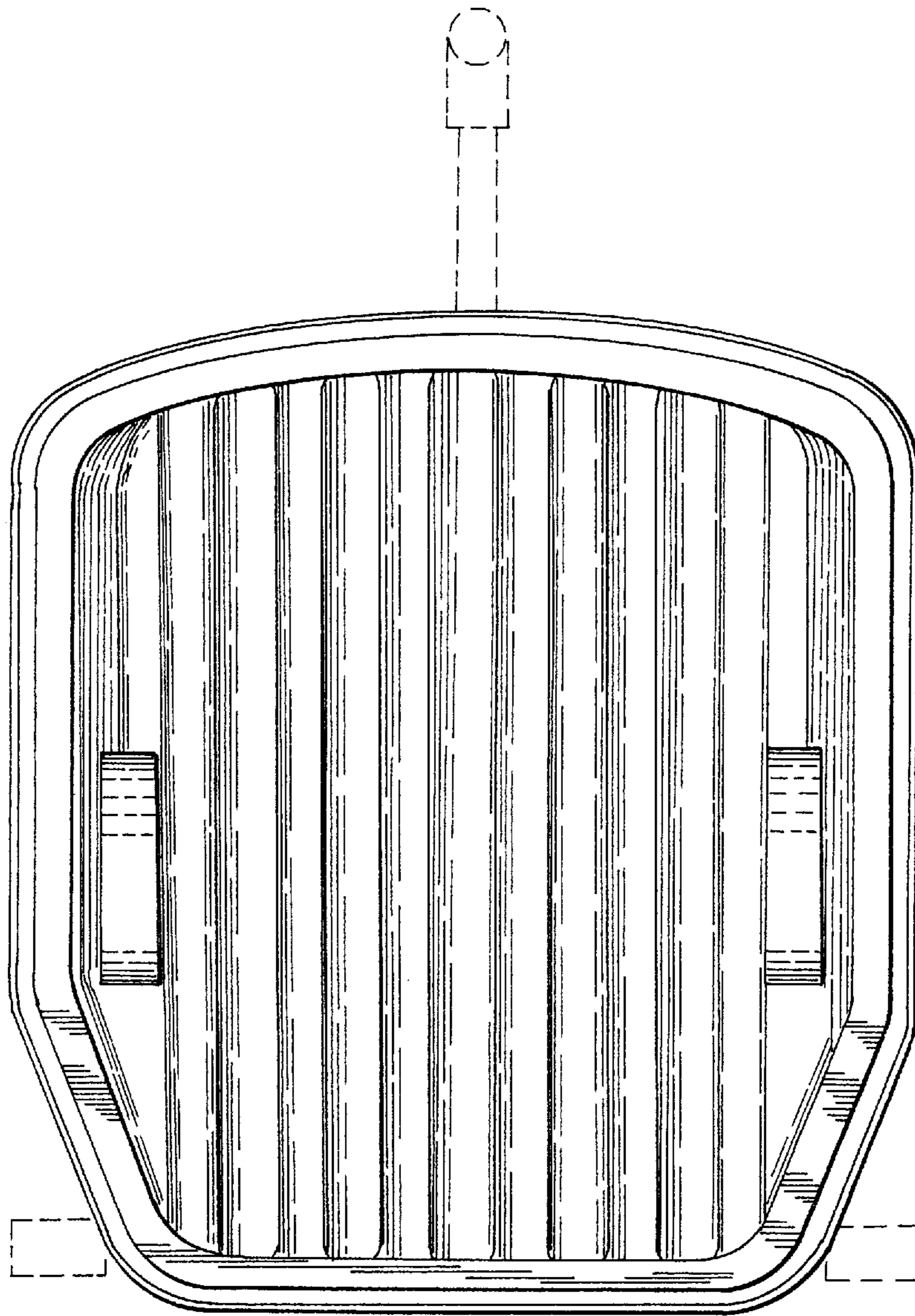
