[57] **CLAIM**

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a shoe sole showing my new design;
FIG. 2 is a bottom plan view thereof of an alternate embodiment of the design shown in FIG. 1;
FIG. 3 is a reduced right side elevational view of FIG. 1, the broken lines showing a shoe upper being for illustrative purposes only and forming no part of the claimed design;
FIG. 4 is a reduced right side elevational view of FIG. 1;
FIG. 5 is a left side elevational view of FIG. 1;
FIG. 6 is a front elevational view of FIG. 1; and,
FIG. 7 is a rear elevational view of FIG. 1.
The unshaded surface opposite FIGS. 1 and 2 are understood to represent unclaimed subject matter.

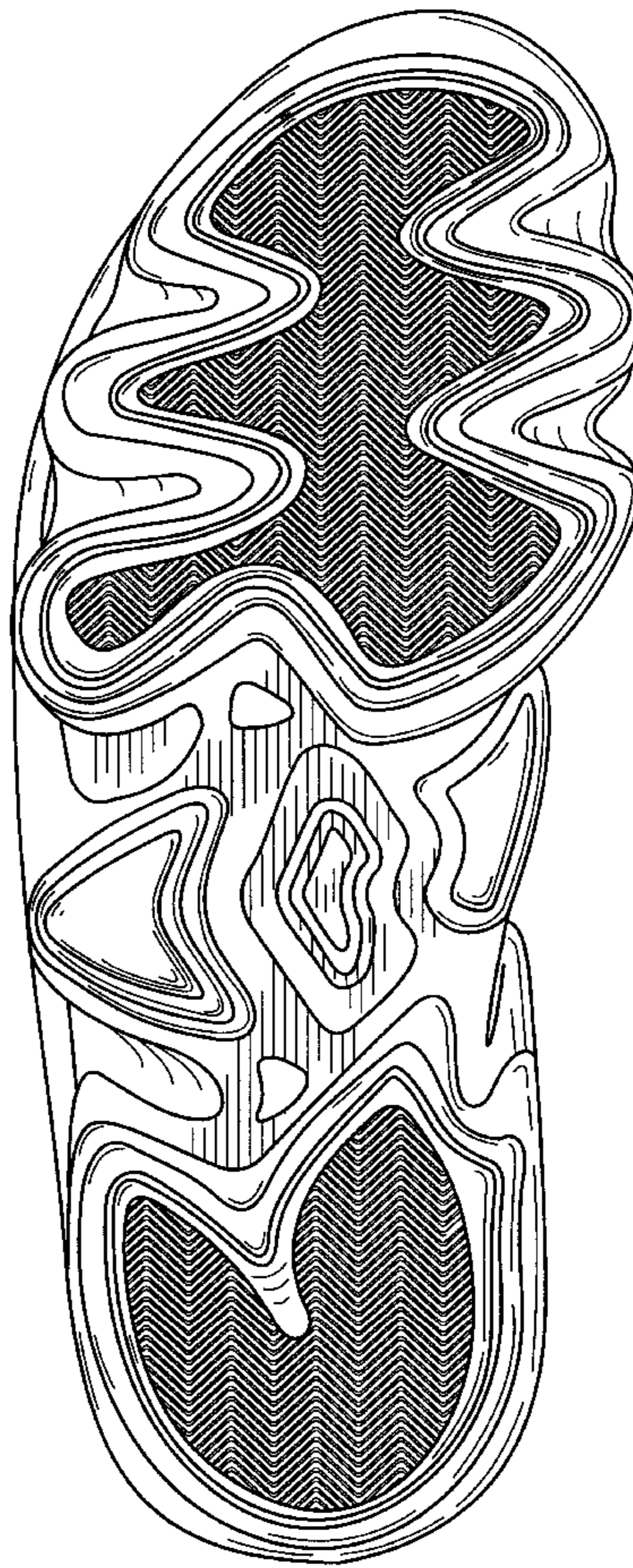
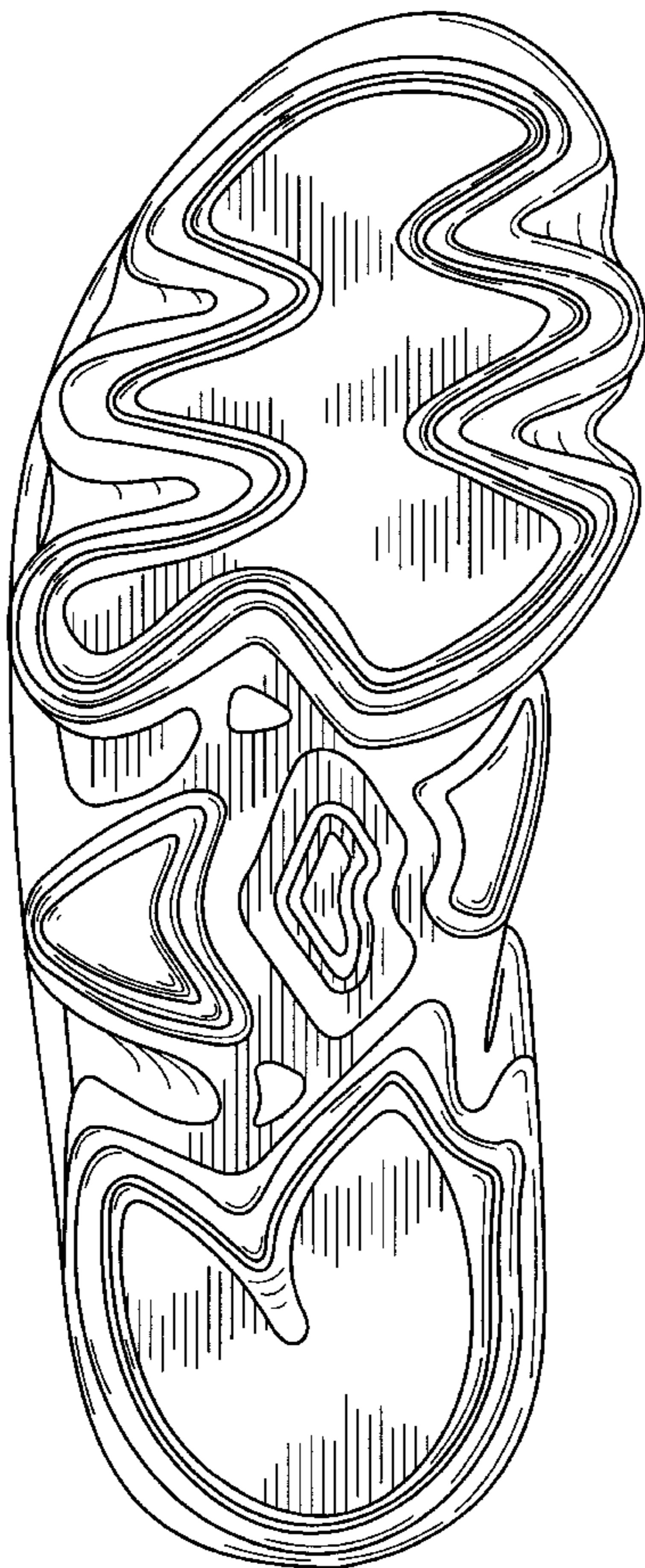

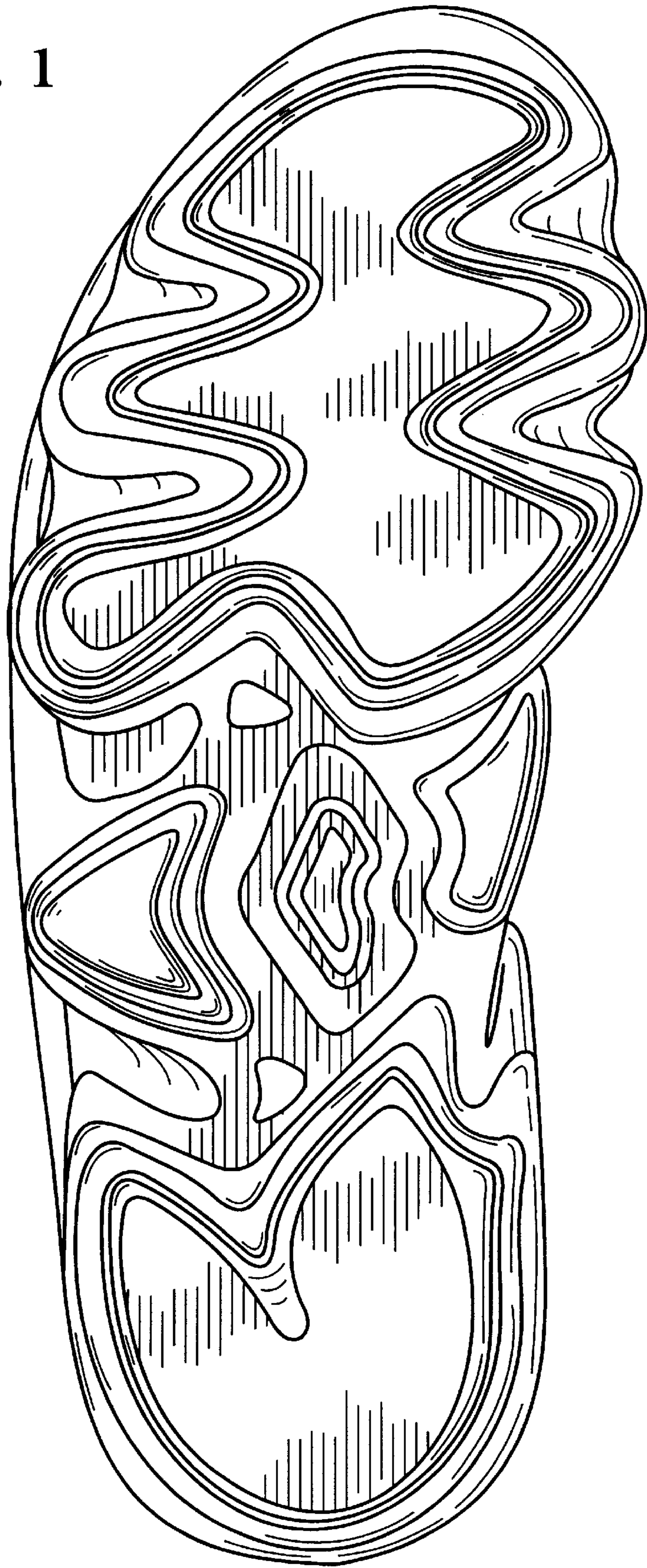
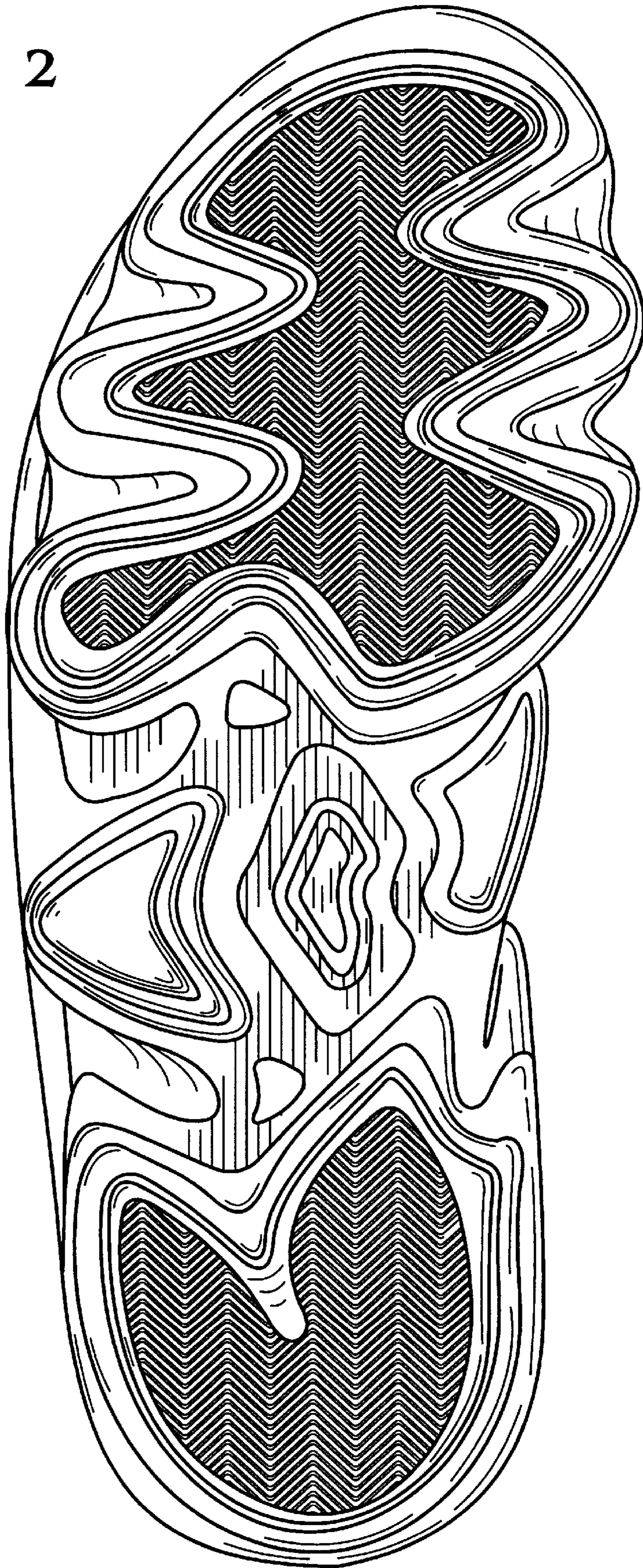

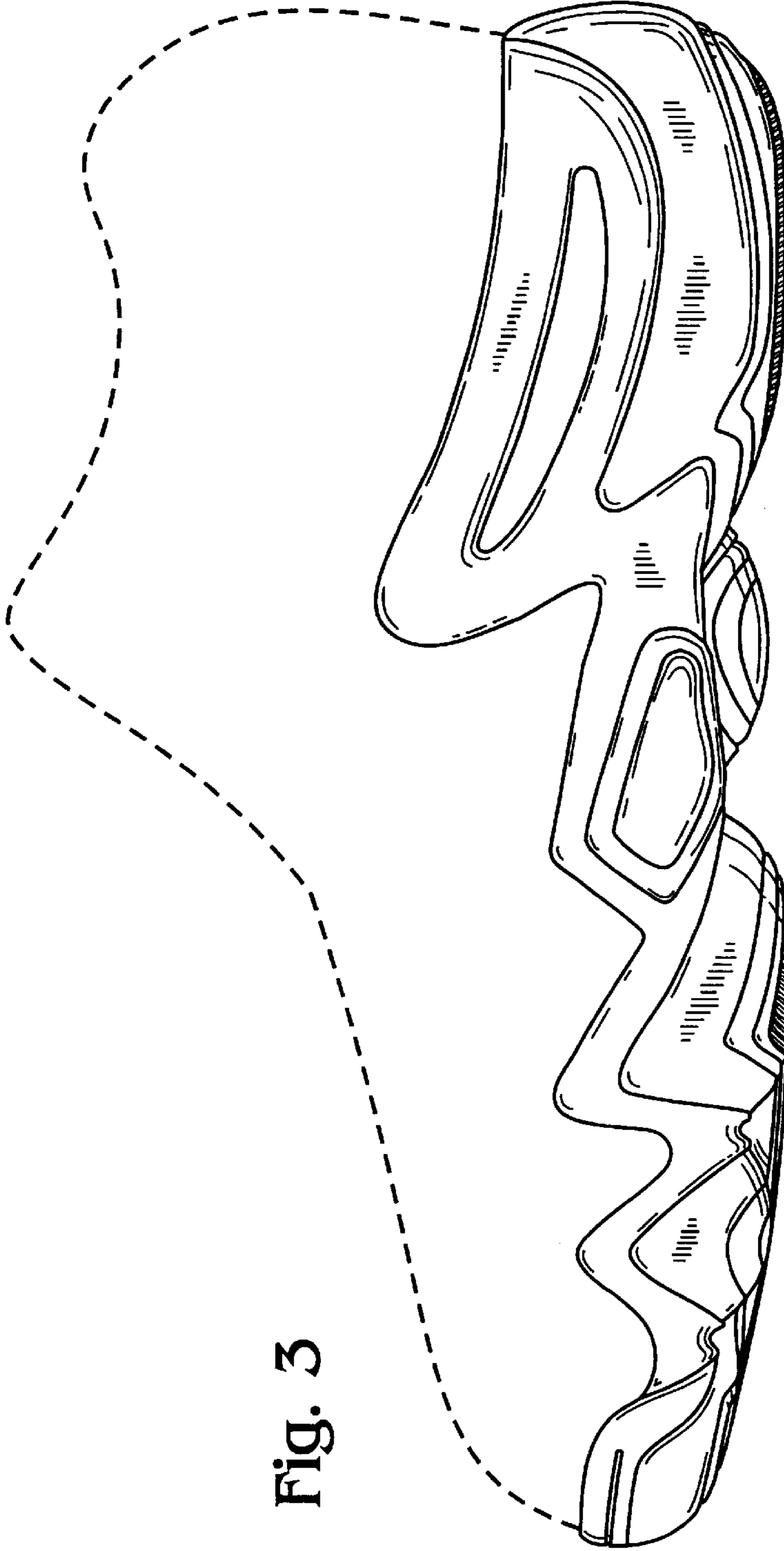

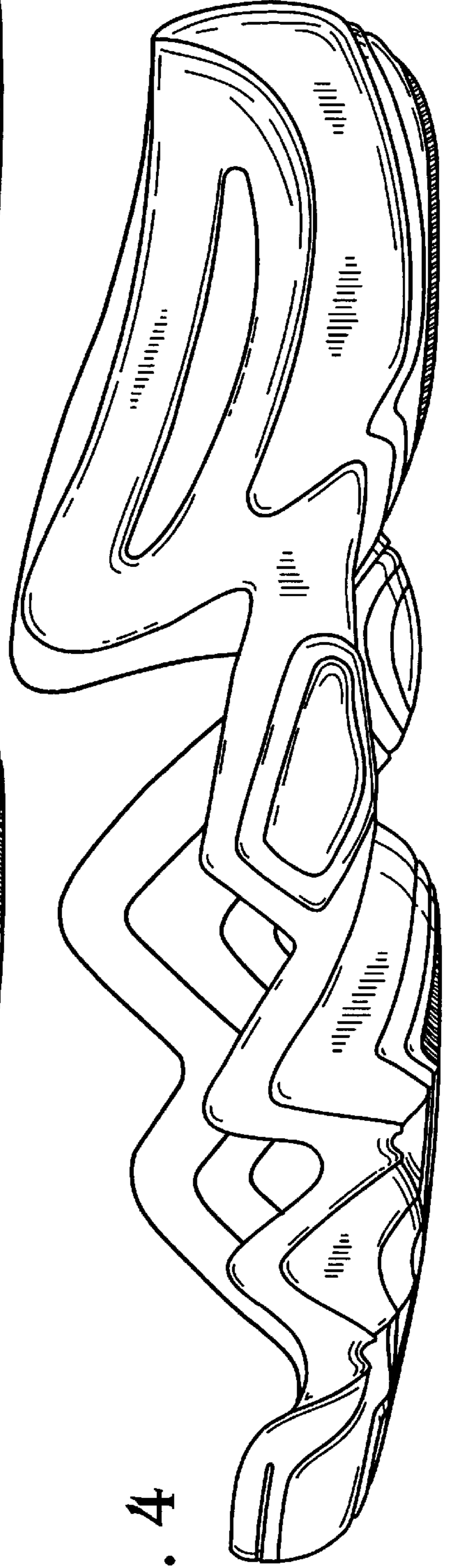

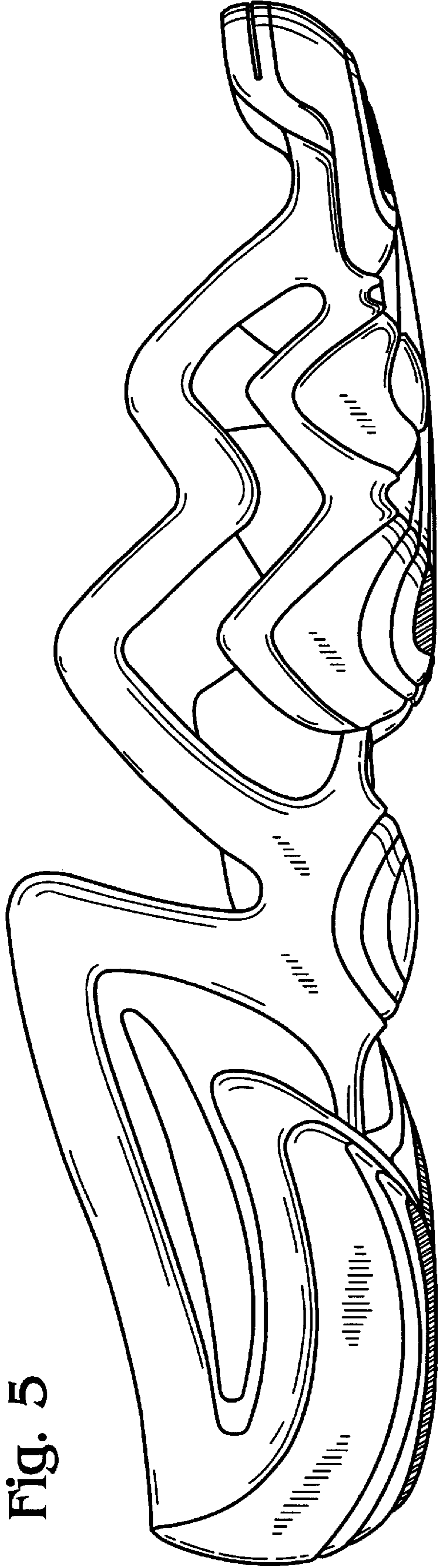

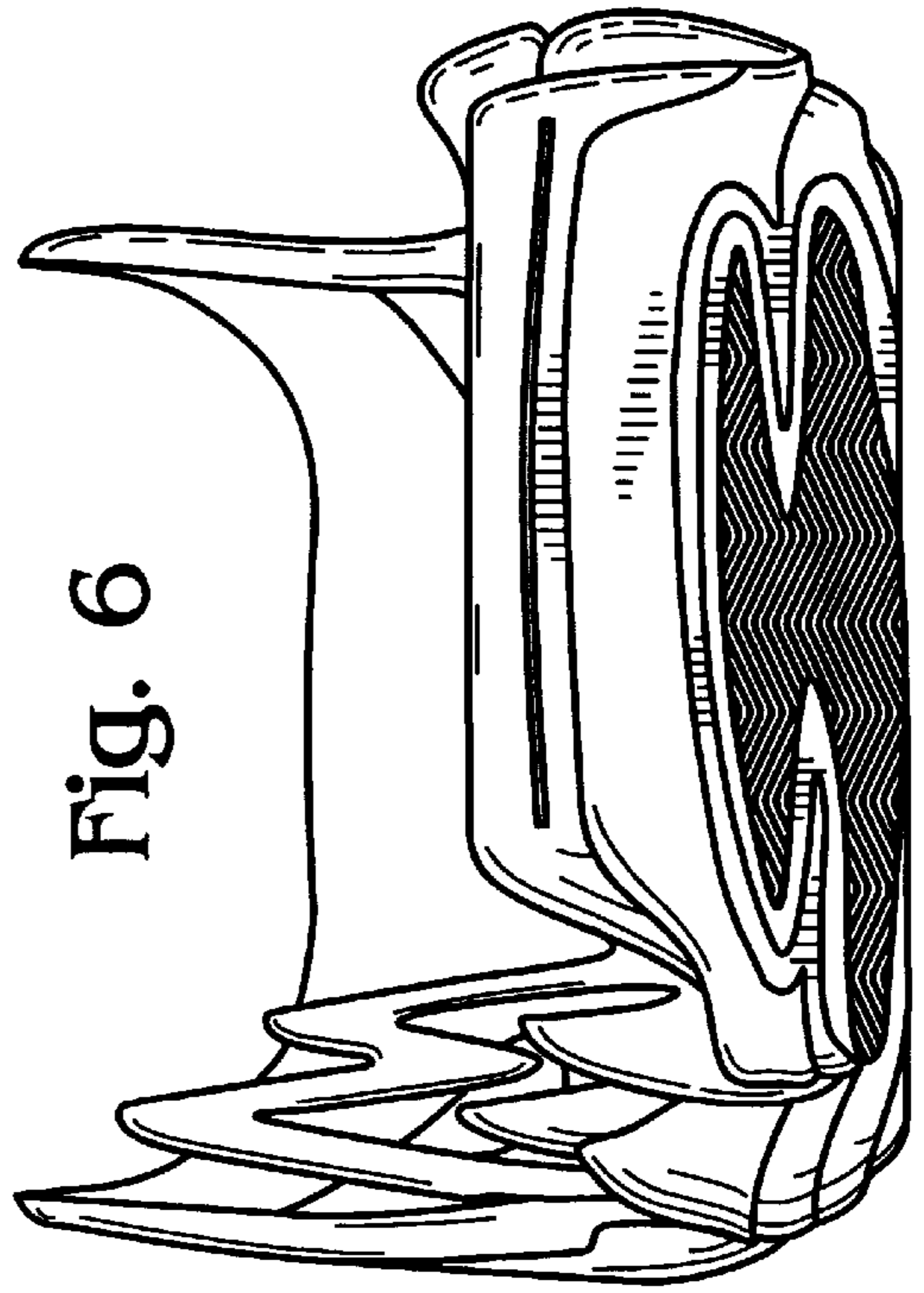
