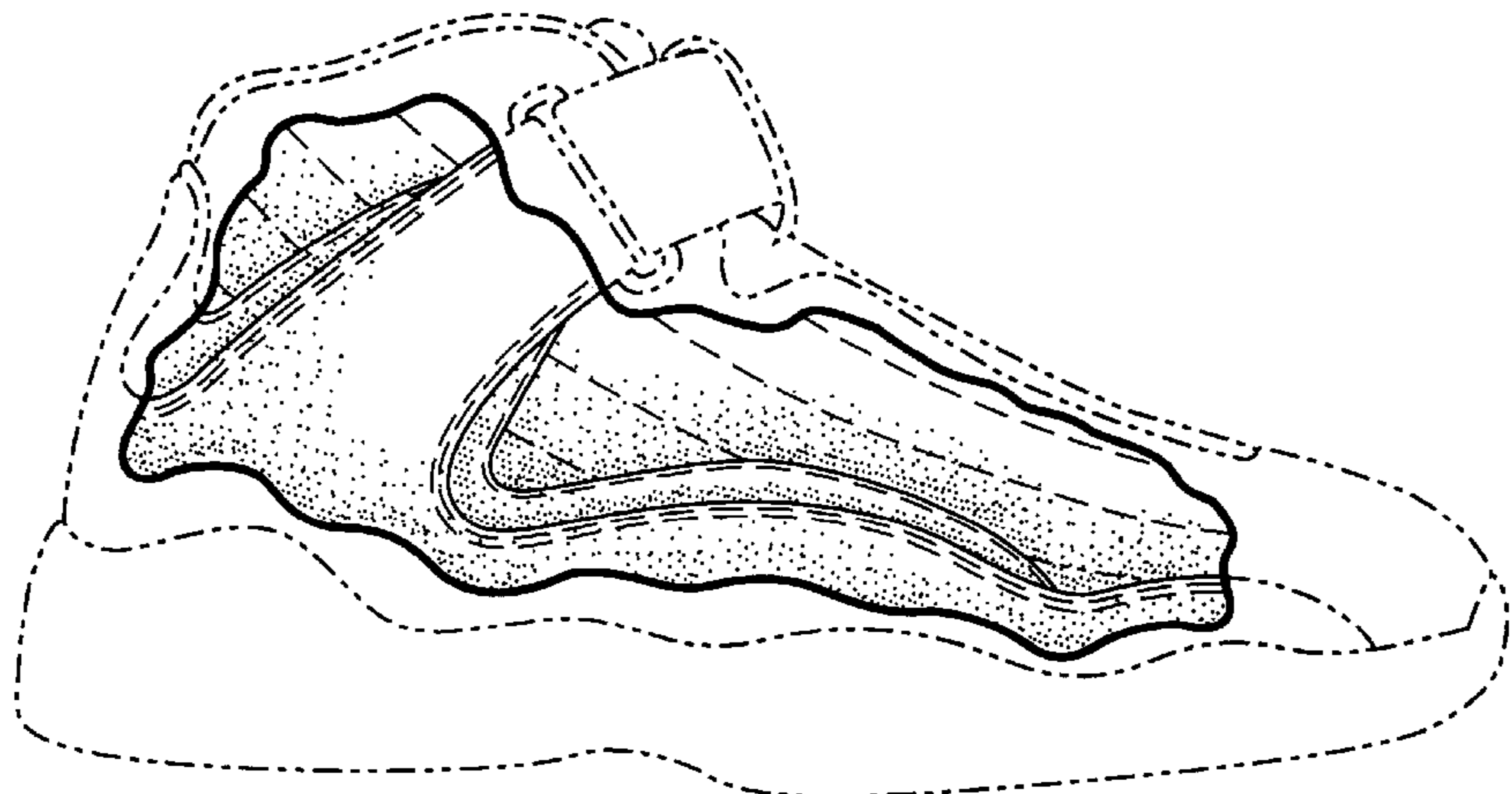

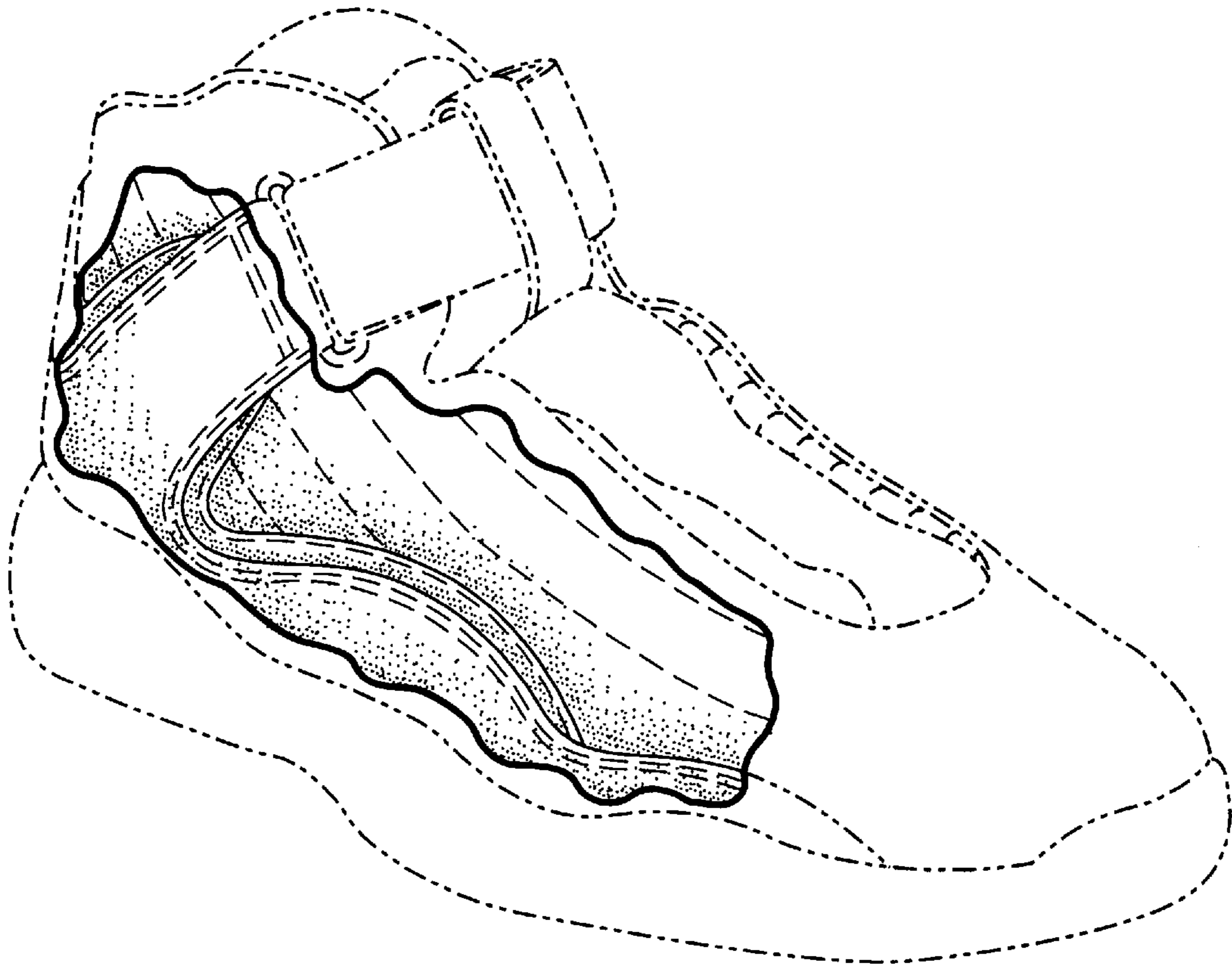

FIG. 5 is a top view thereof.

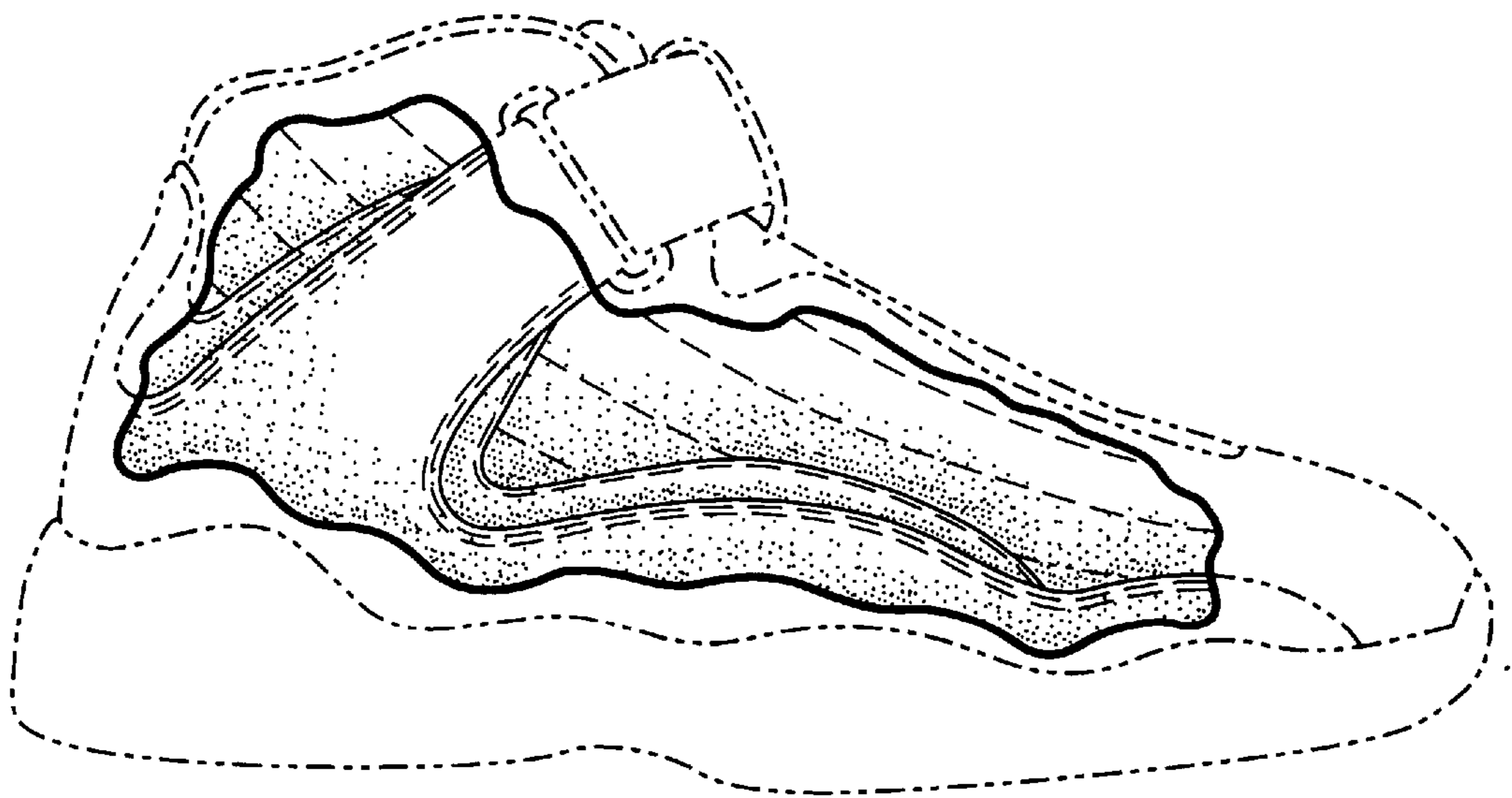
The broken line showing of a shoe sole and the remaining

design.

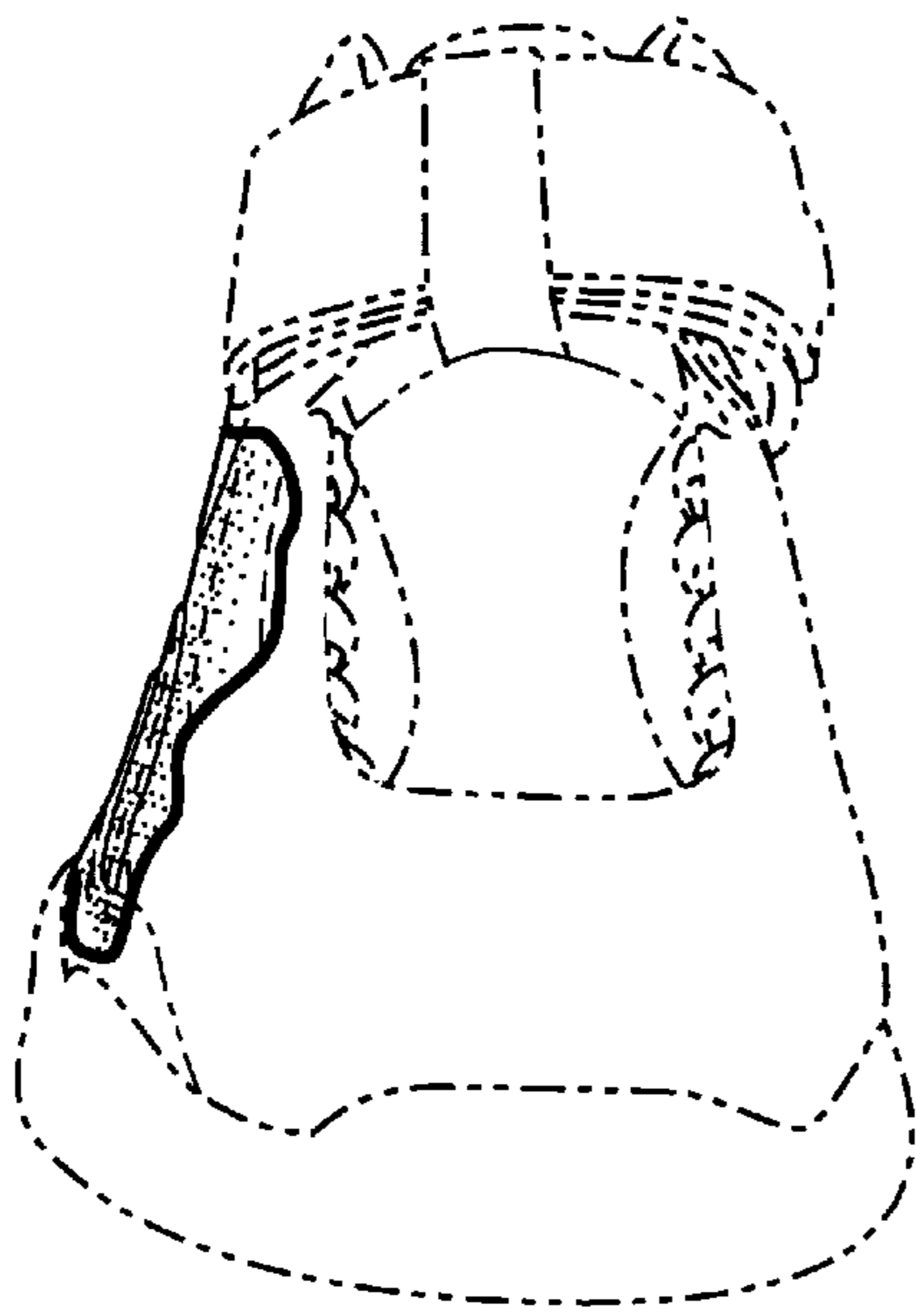

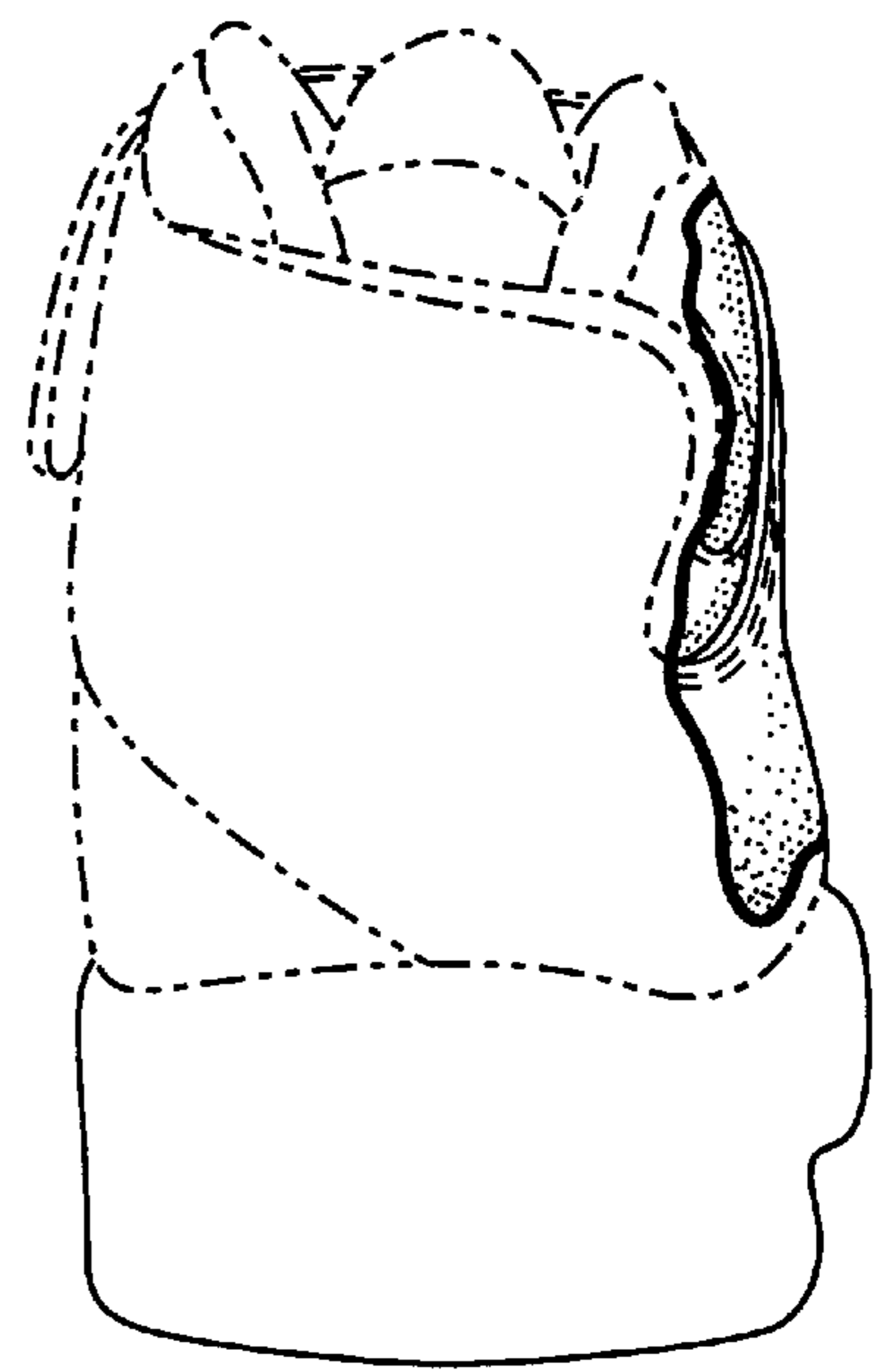

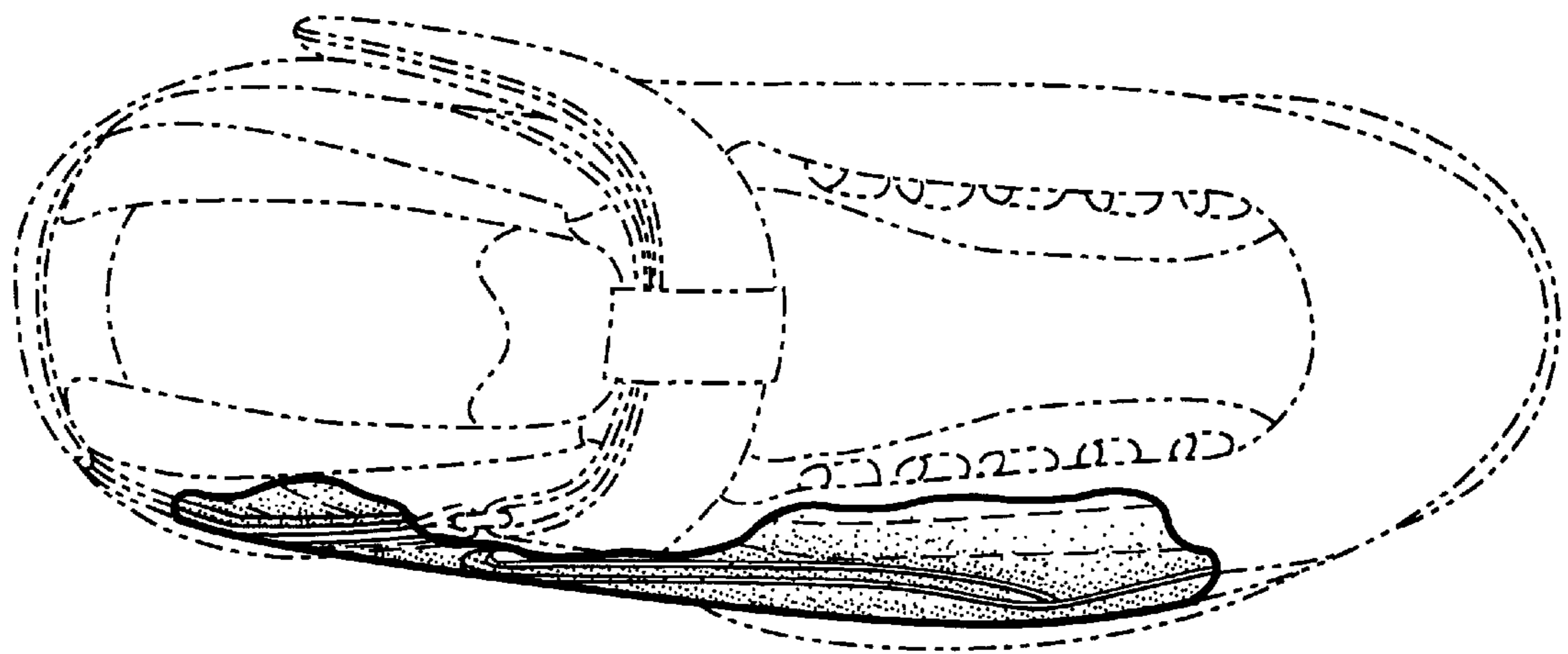
