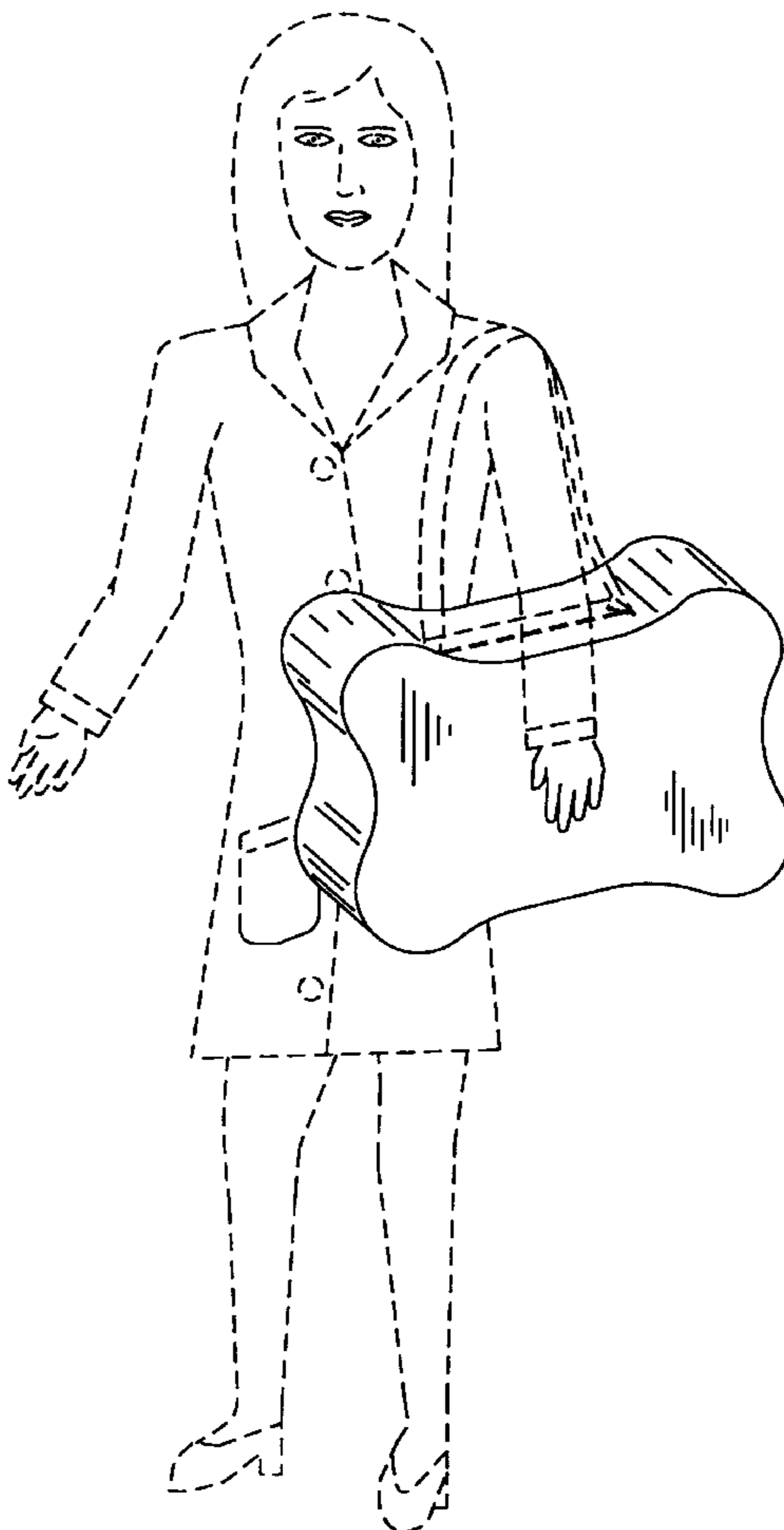
[57] **CLAIM**

We claim the ornamental design for the bone shaped carrying bag, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the bone shaped carrying bag showing our new design;  
FIG. 2 is a front and rear view thereof, both sides being identical;  
FIG. 3 is a right and left side view thereof, both sides being identical;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a top right perspective view of the bone shaped carrying bag showing a second embodiment thereof;  
FIG. 7 is a rear view thereof;  
FIG. 8 is a top and bottom view thereof, both sides being identical; and,  
FIG. 9 is a side view thereof, both sides being identical.  
In FIG. 1, the woman and shoulder strap shown in broken lines are not part of the design sought to be patented. In FIGS. 6, 8, and 9, the waist strap shown in broken lines is not part of the design sought to be patented.

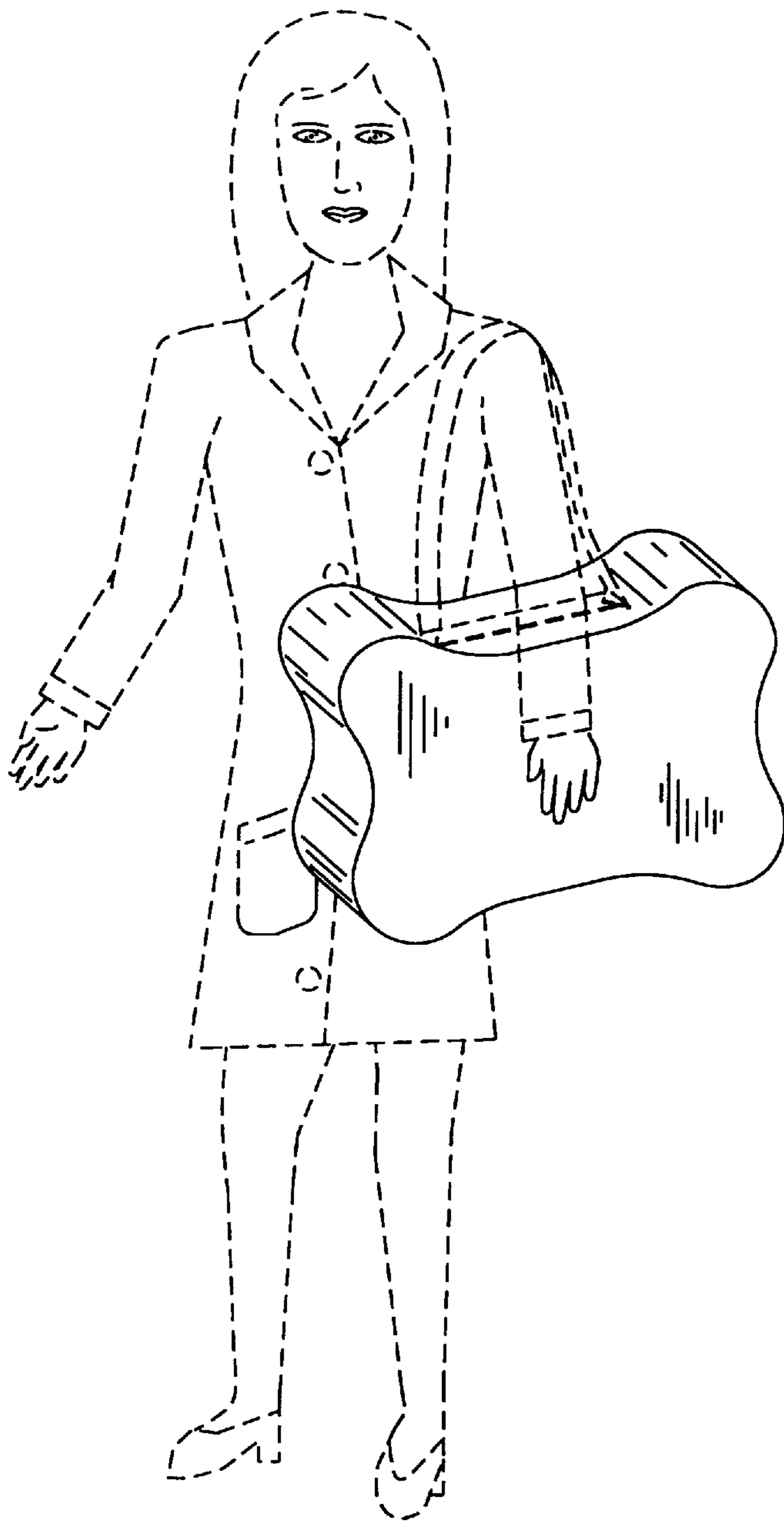

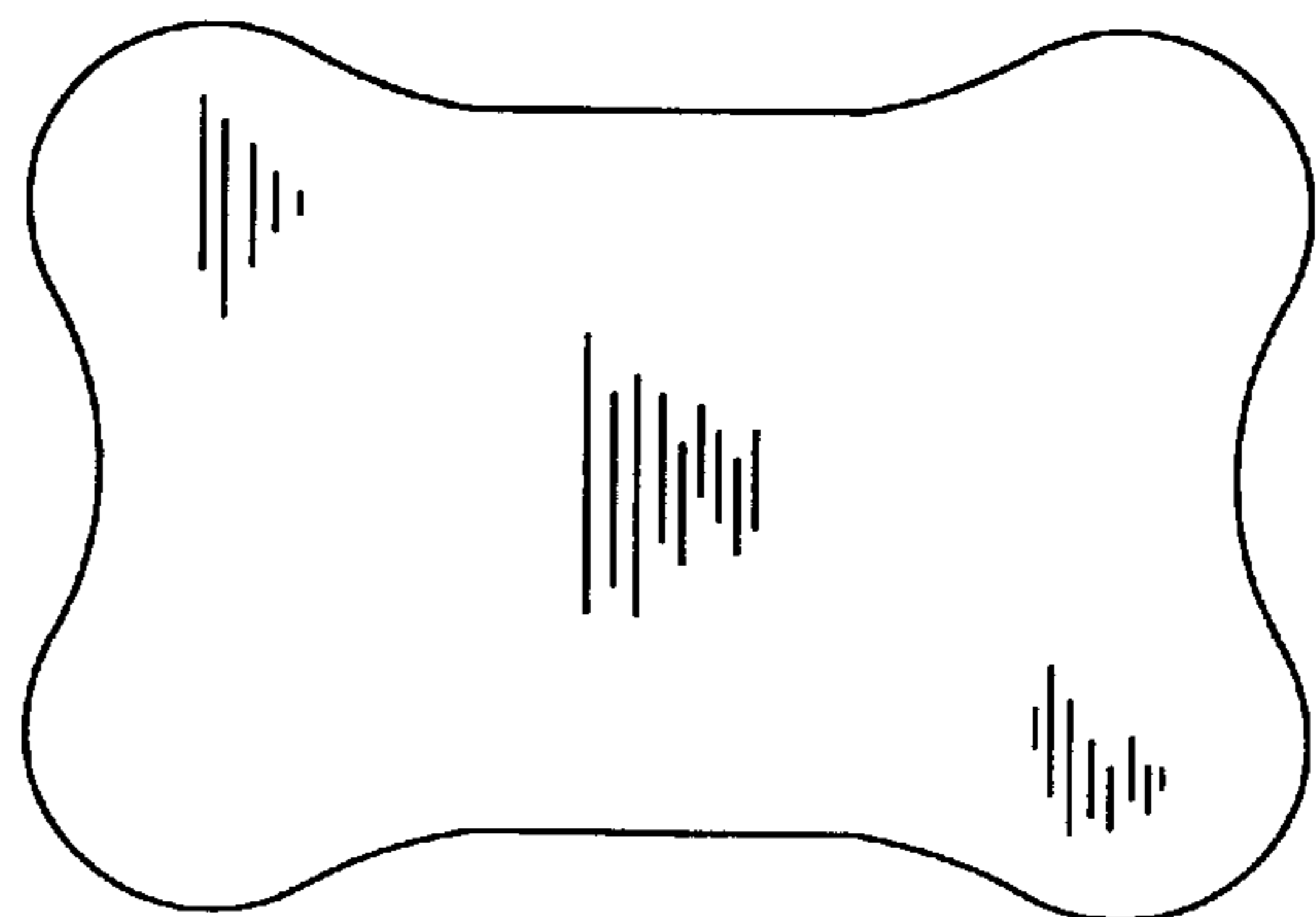

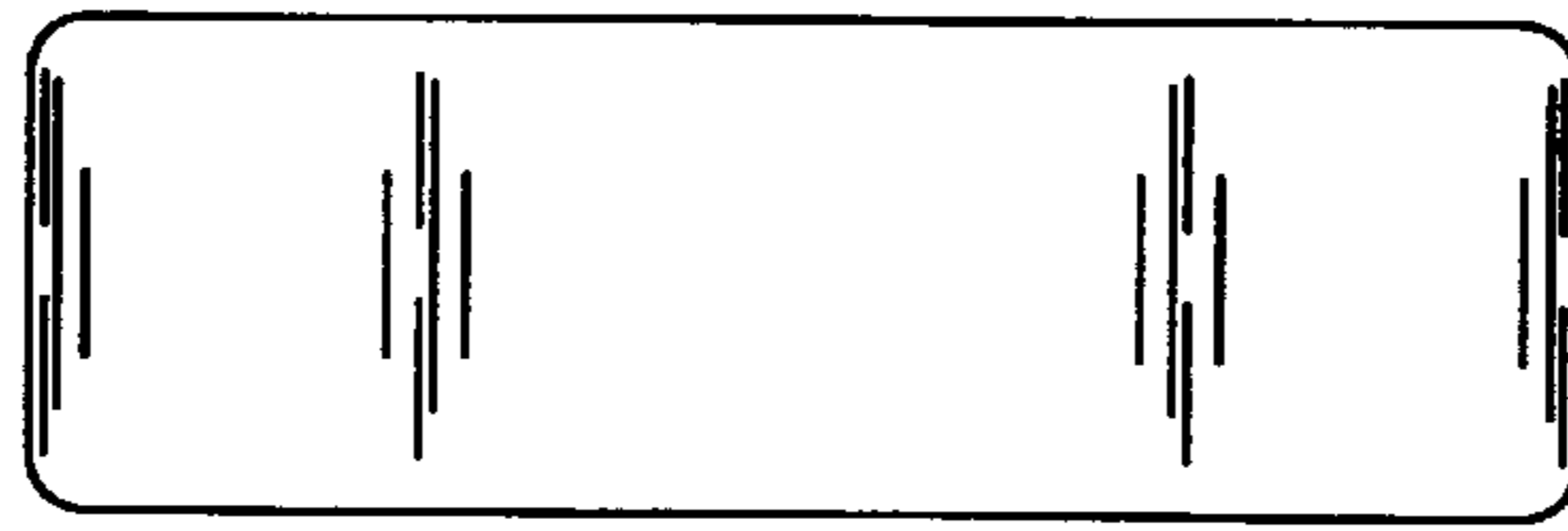

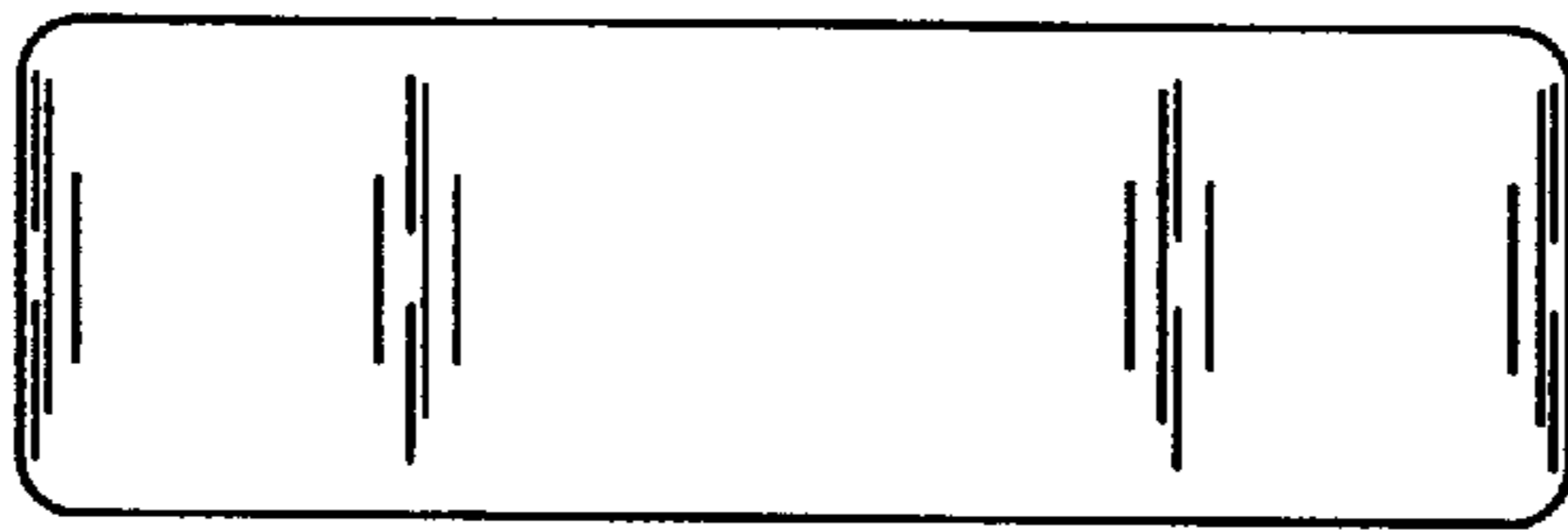

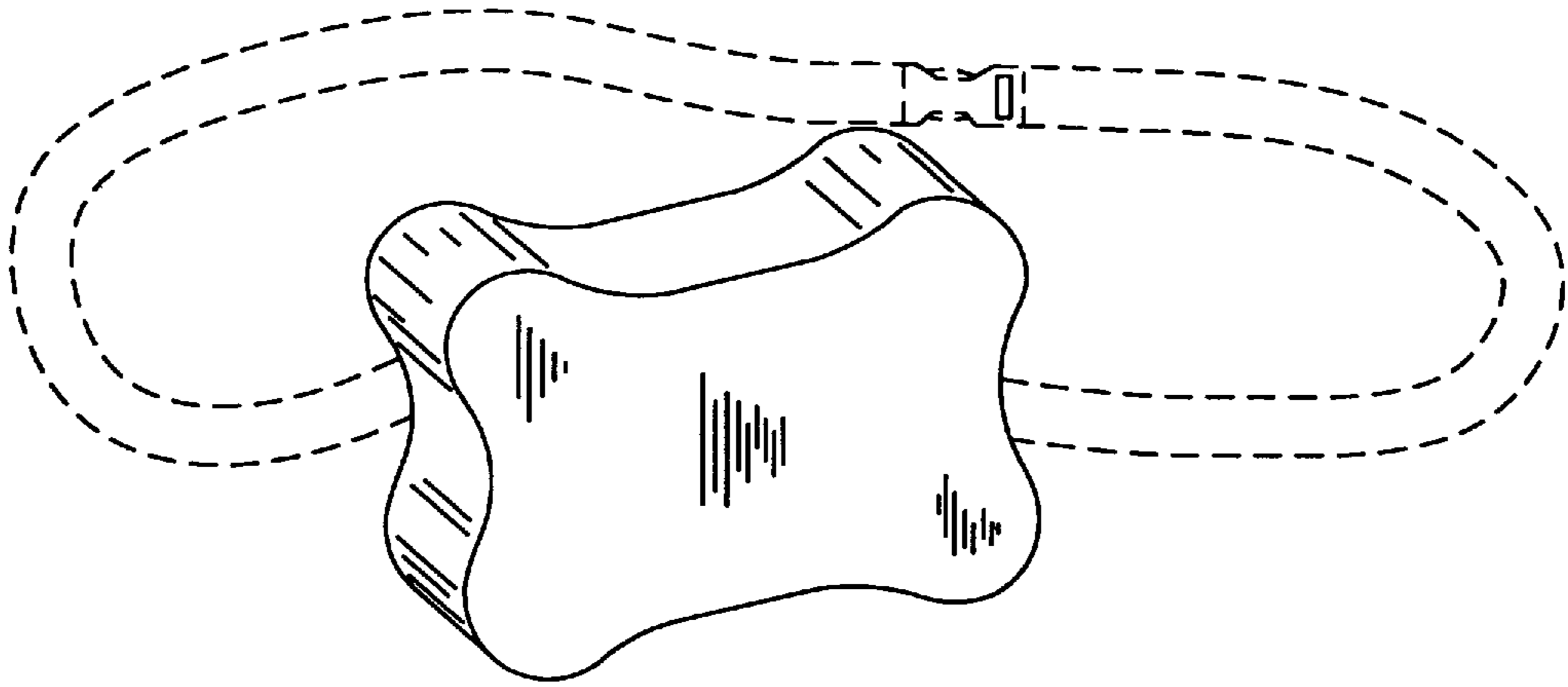

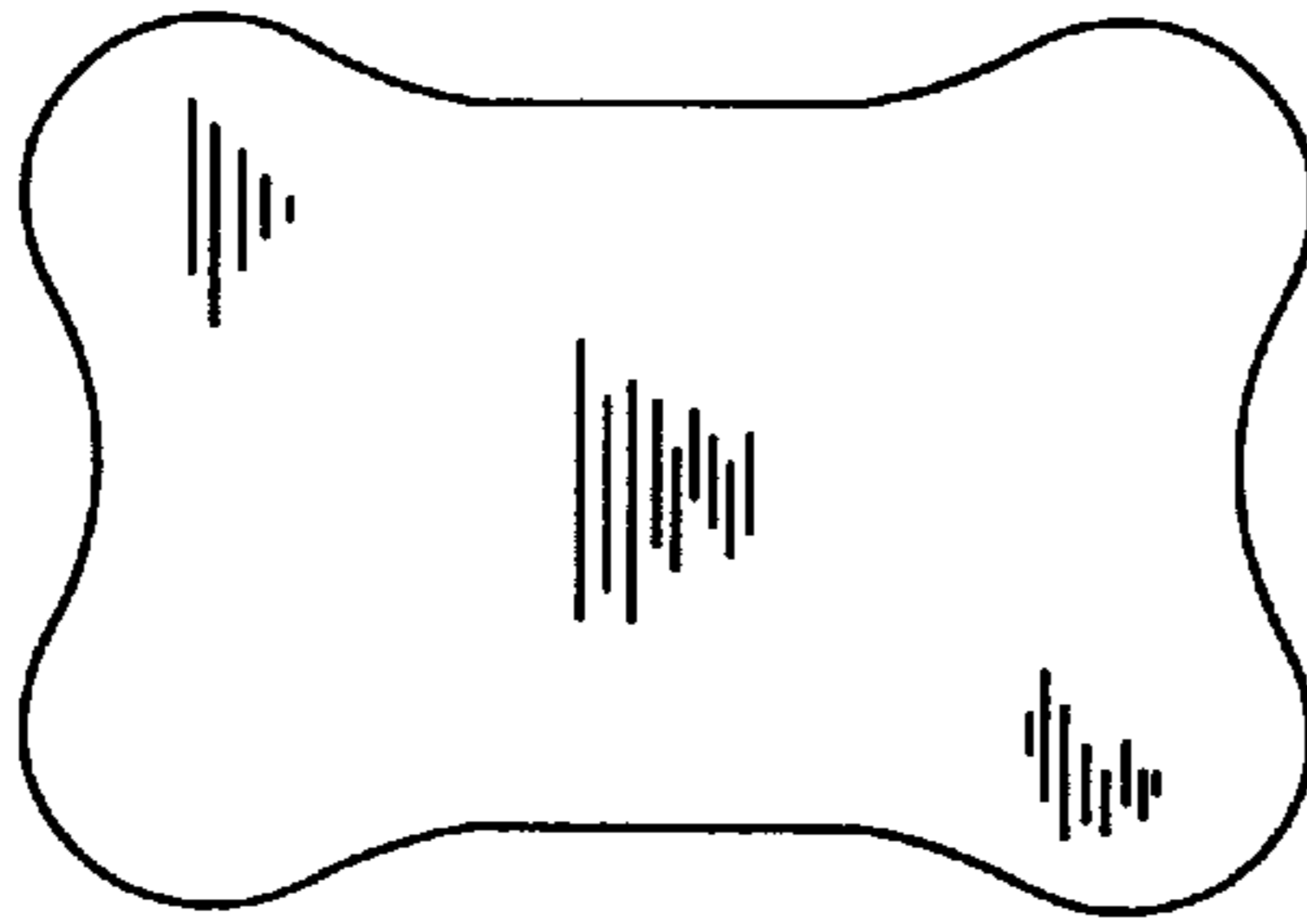

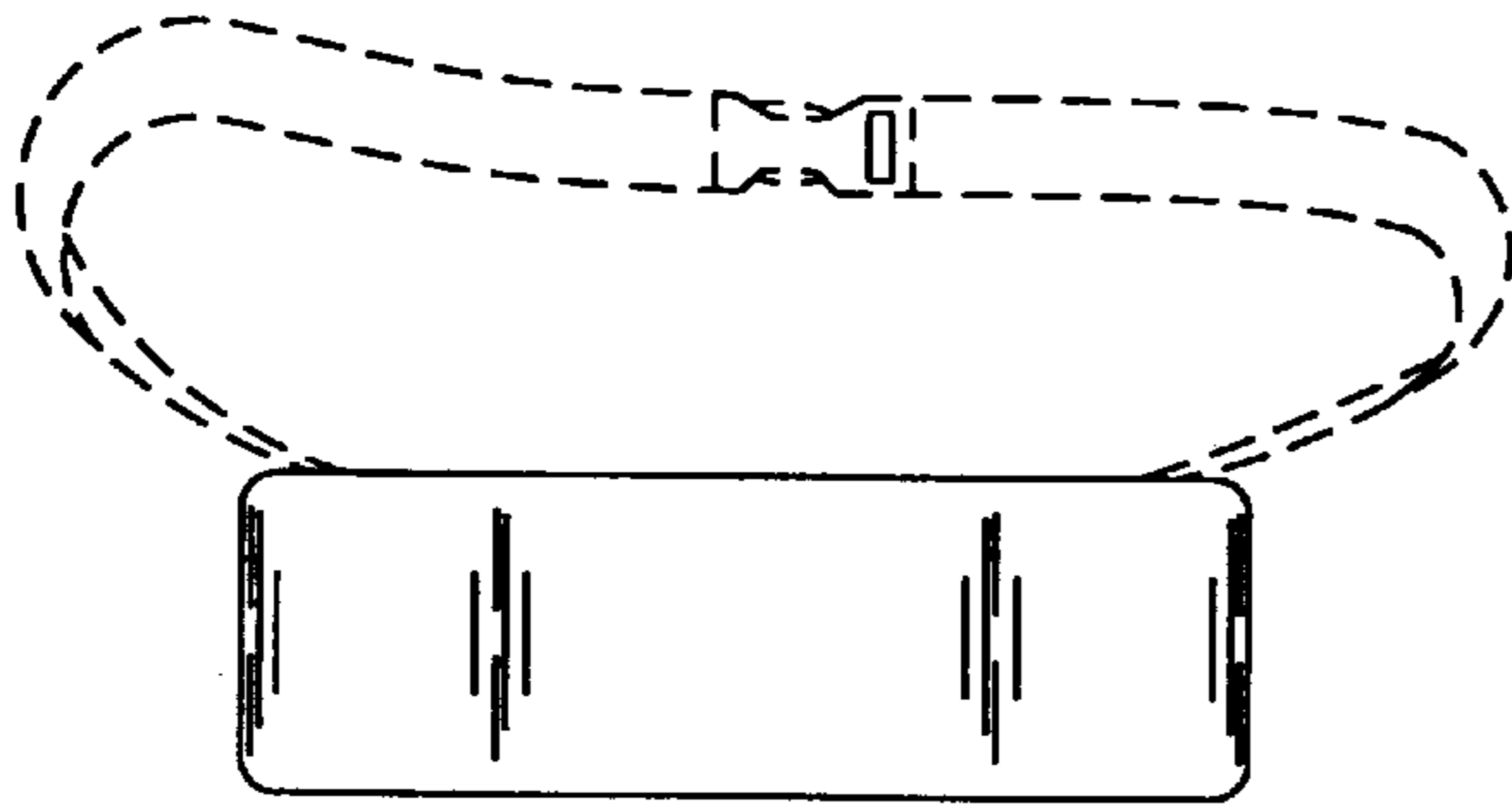

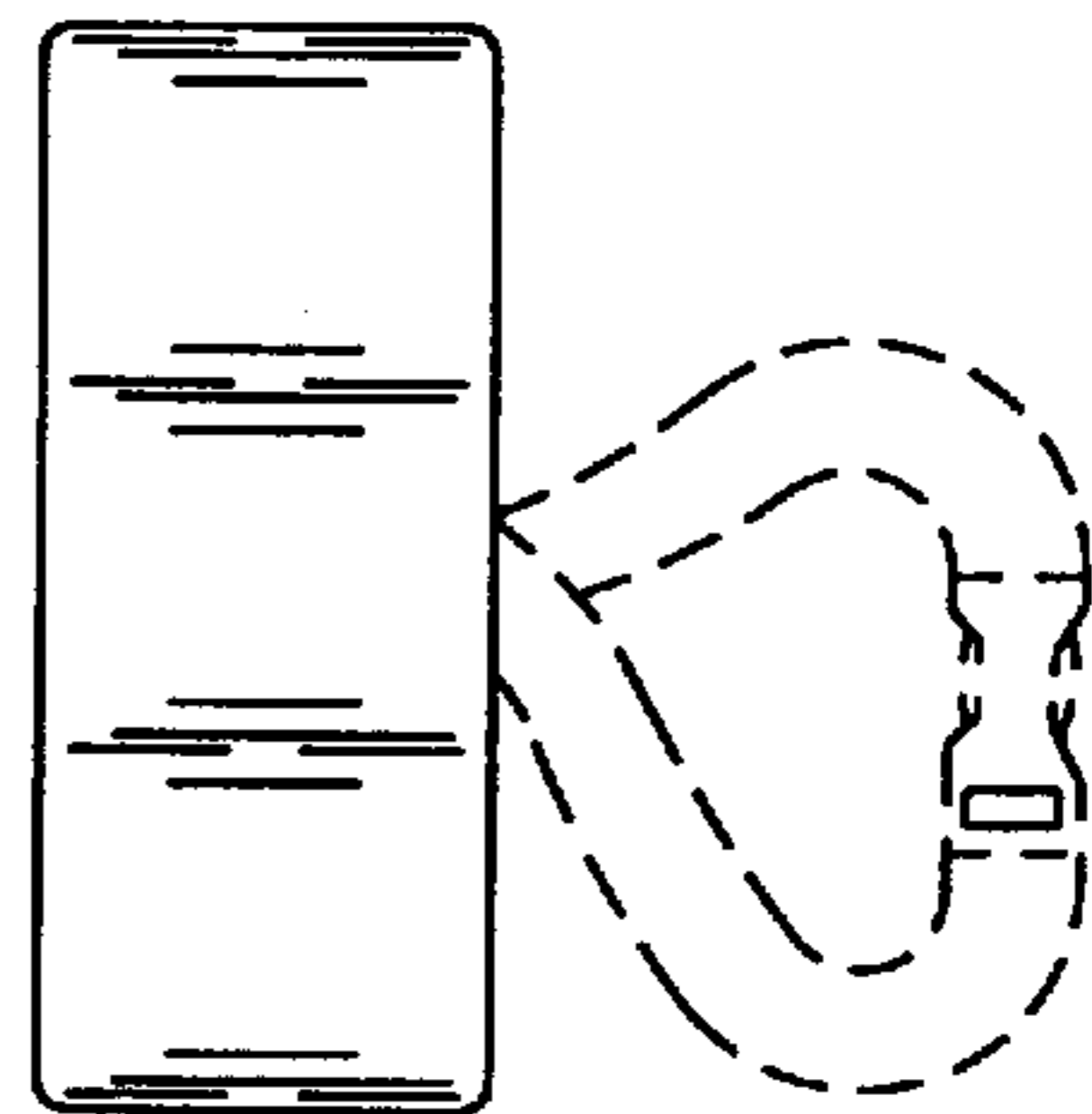
