The ornamental design for a seal assembly, as shown and described.

DESCRIPTION

FIG. 1 is a top, end and front perspective view of a seal assembly showing our new design;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a front elevation view thereof;

FIG. 7 is a right end elevation view thereof;

FIG. 8 is a left end elevation view thereof;

FIG. 9 is a top perspective view of a second embodiment thereof;

FIG. 10 is a top plan view of FIG. 9;

FIG. 11 is a bottom plan view of FIG. 9;

FIG. 12 is a rear elevation view of FIG. 9;

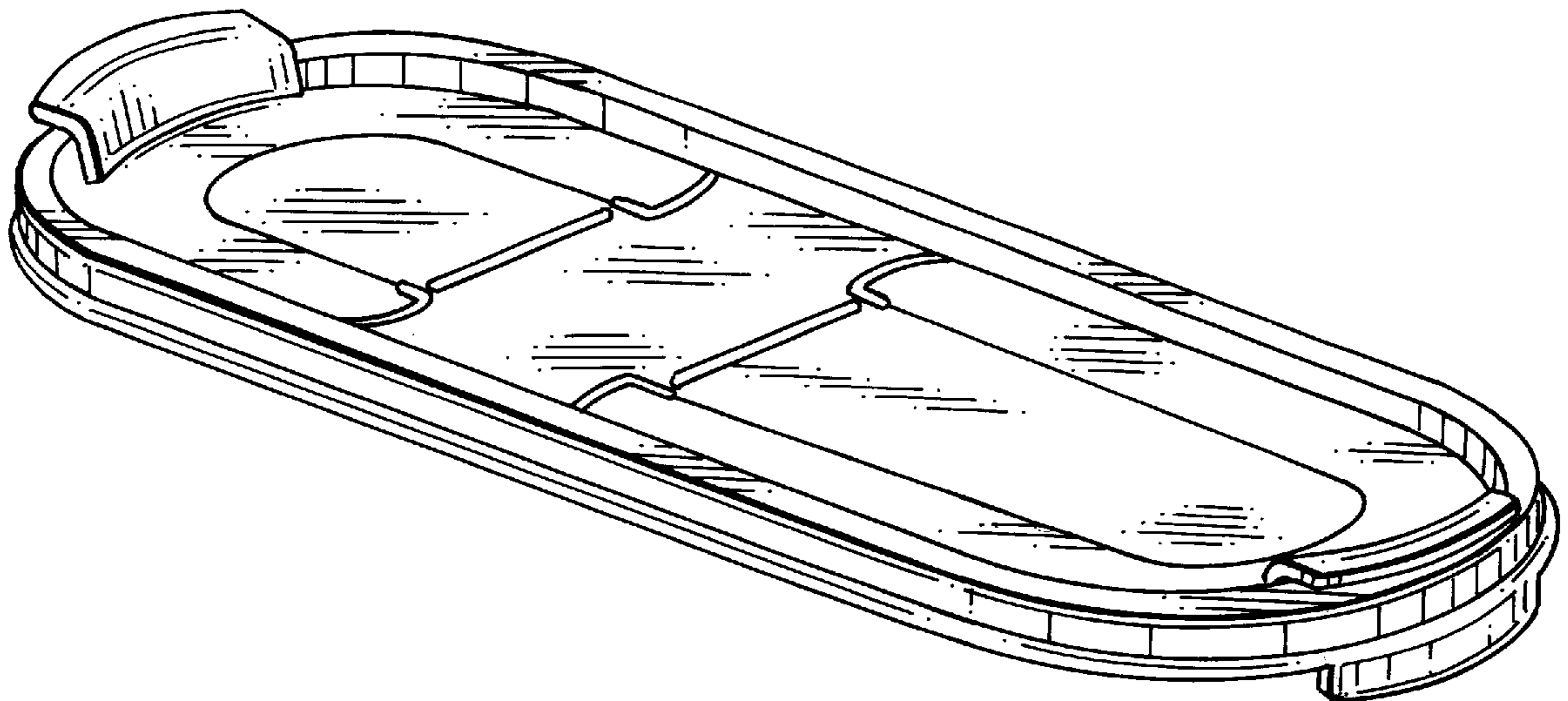
FIG. 13 is a front elevation view of FIG. 9;

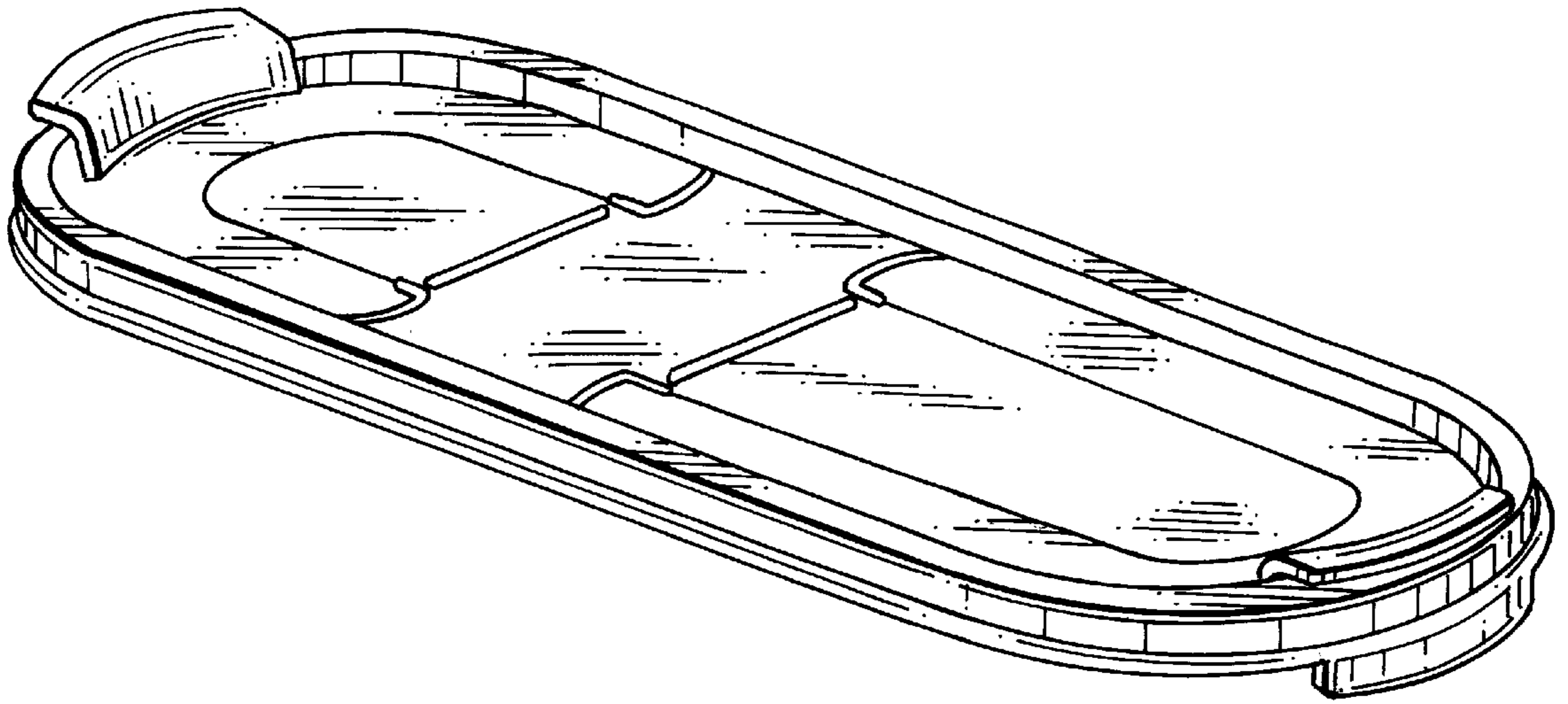

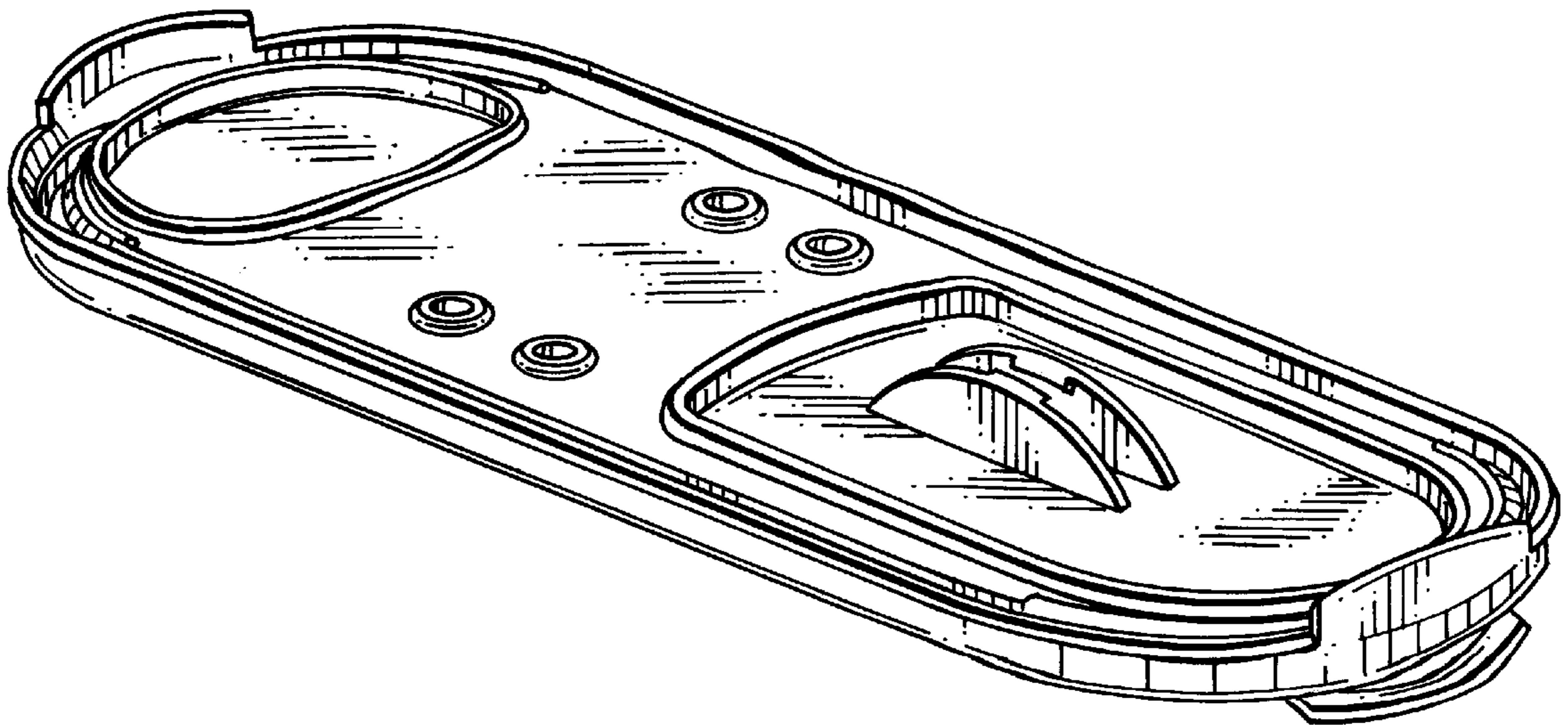

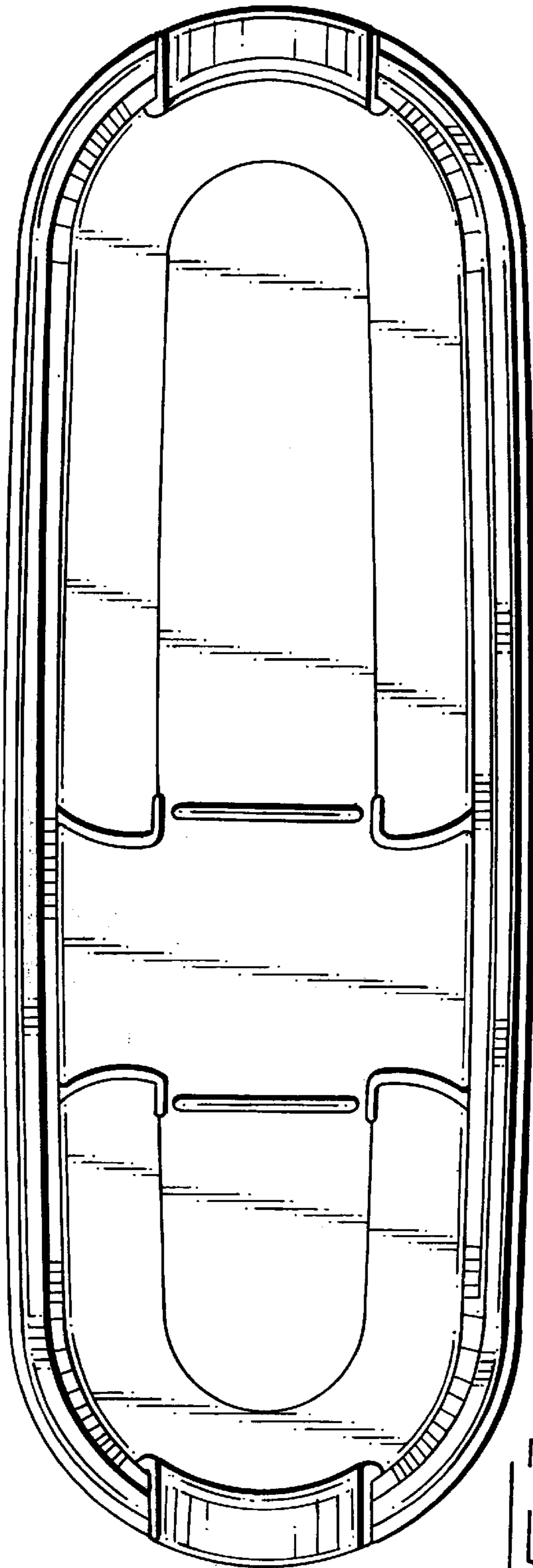
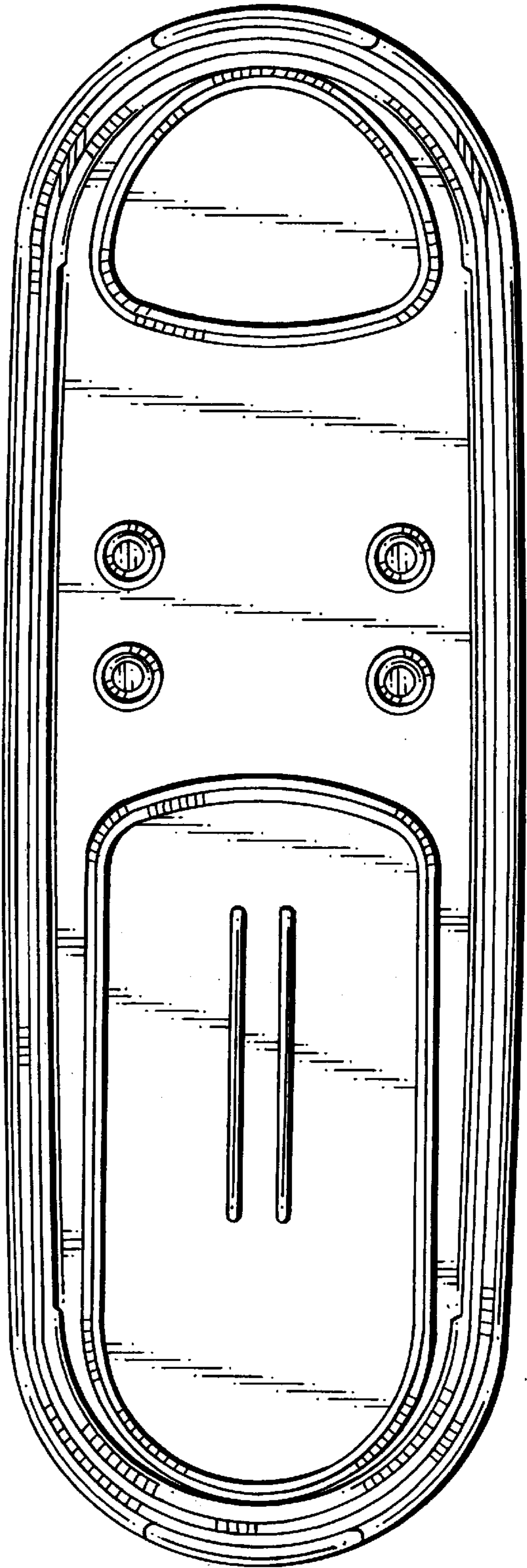

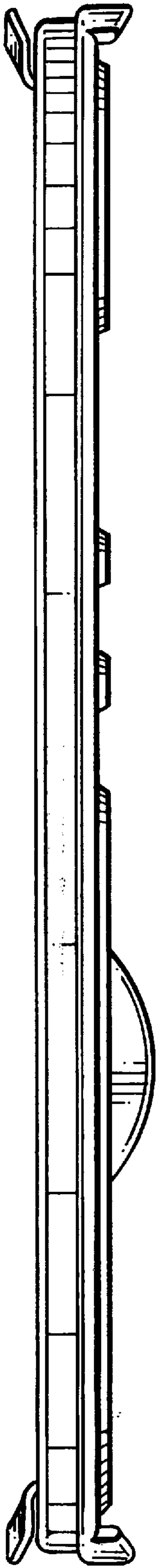

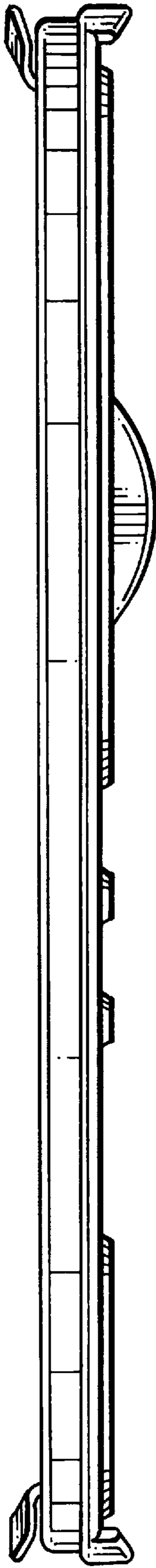

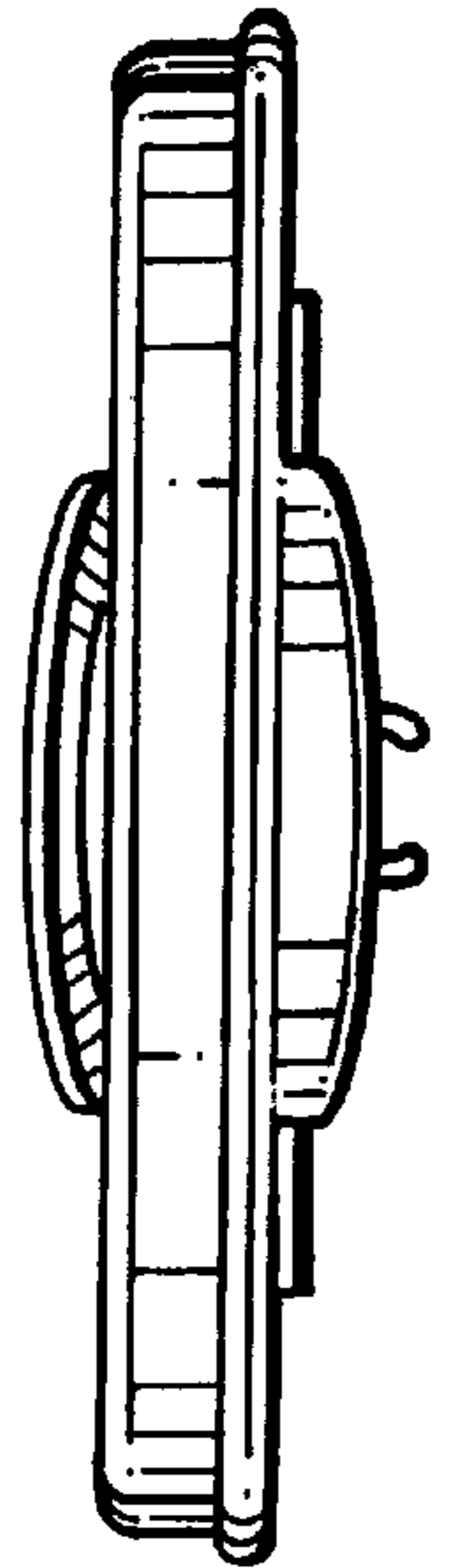
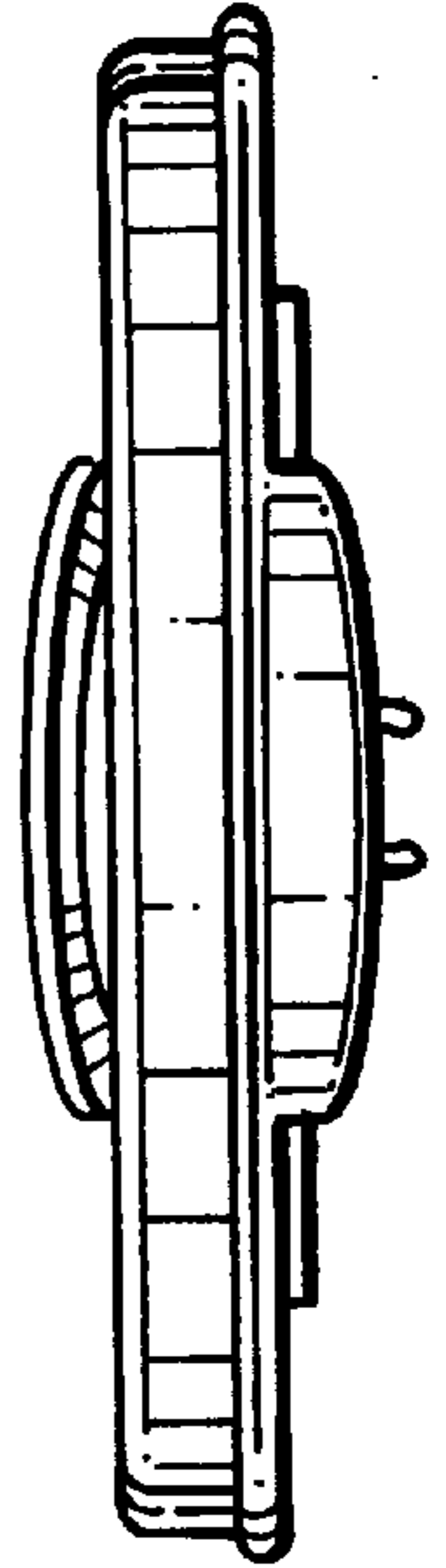

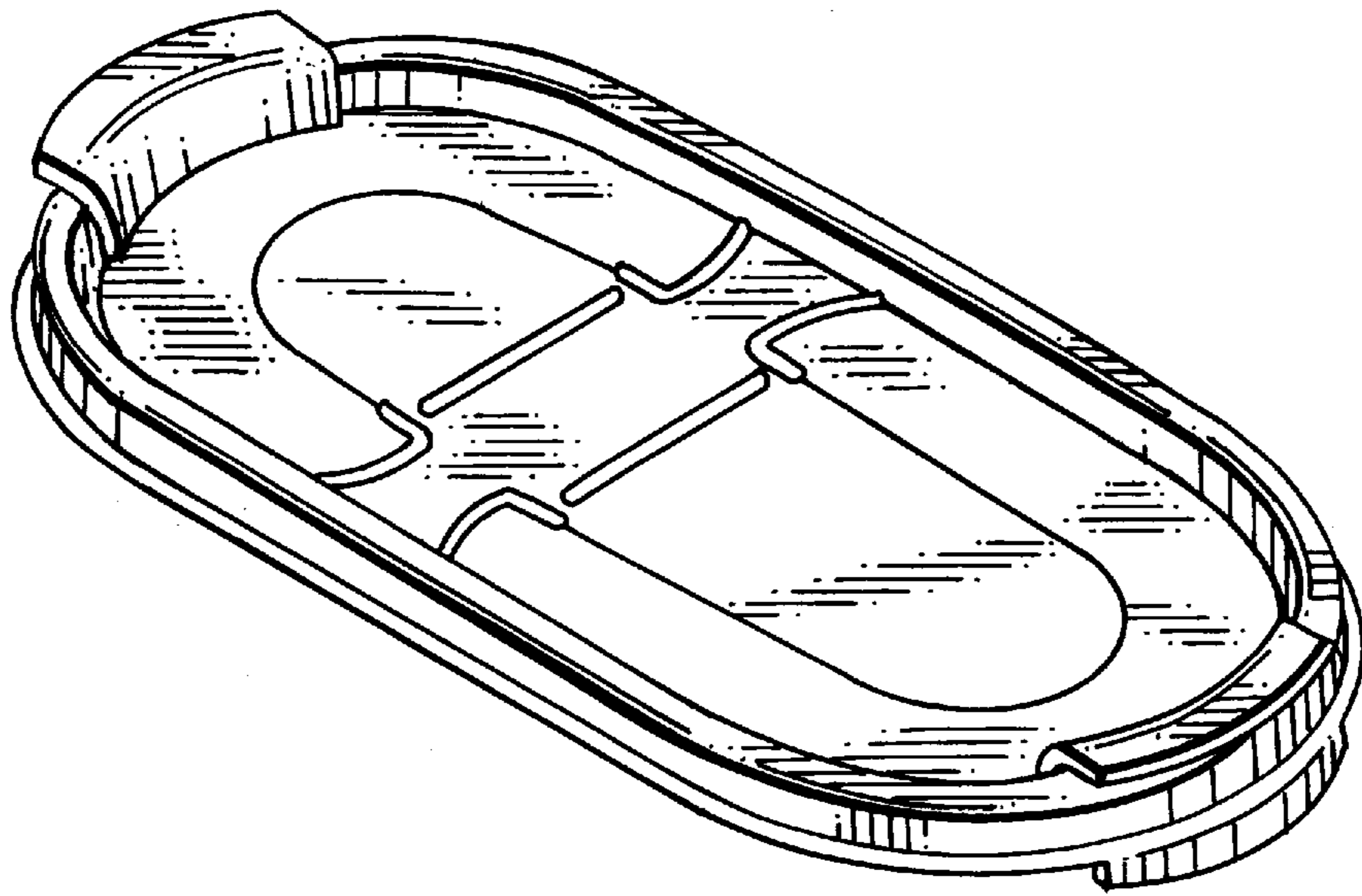

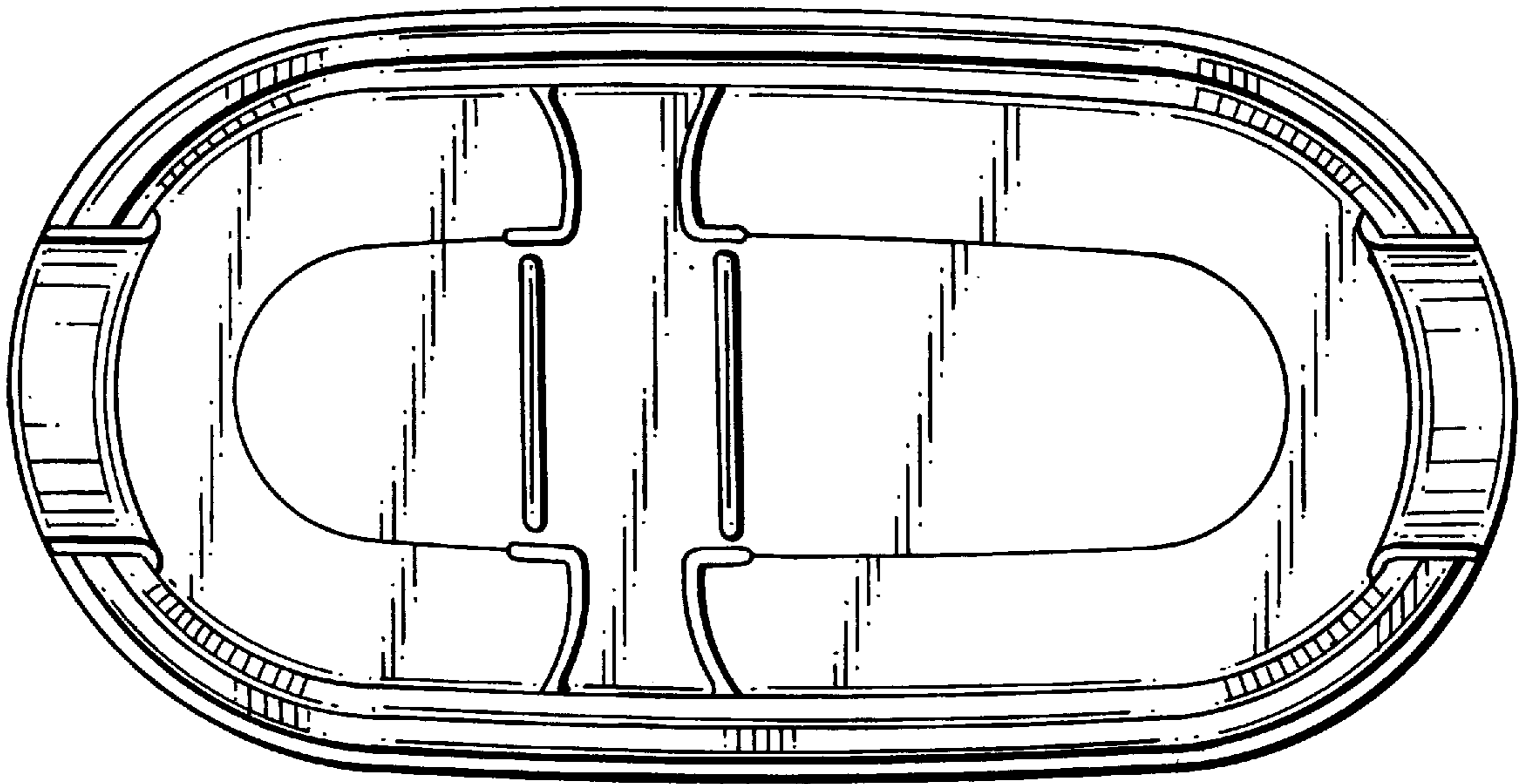

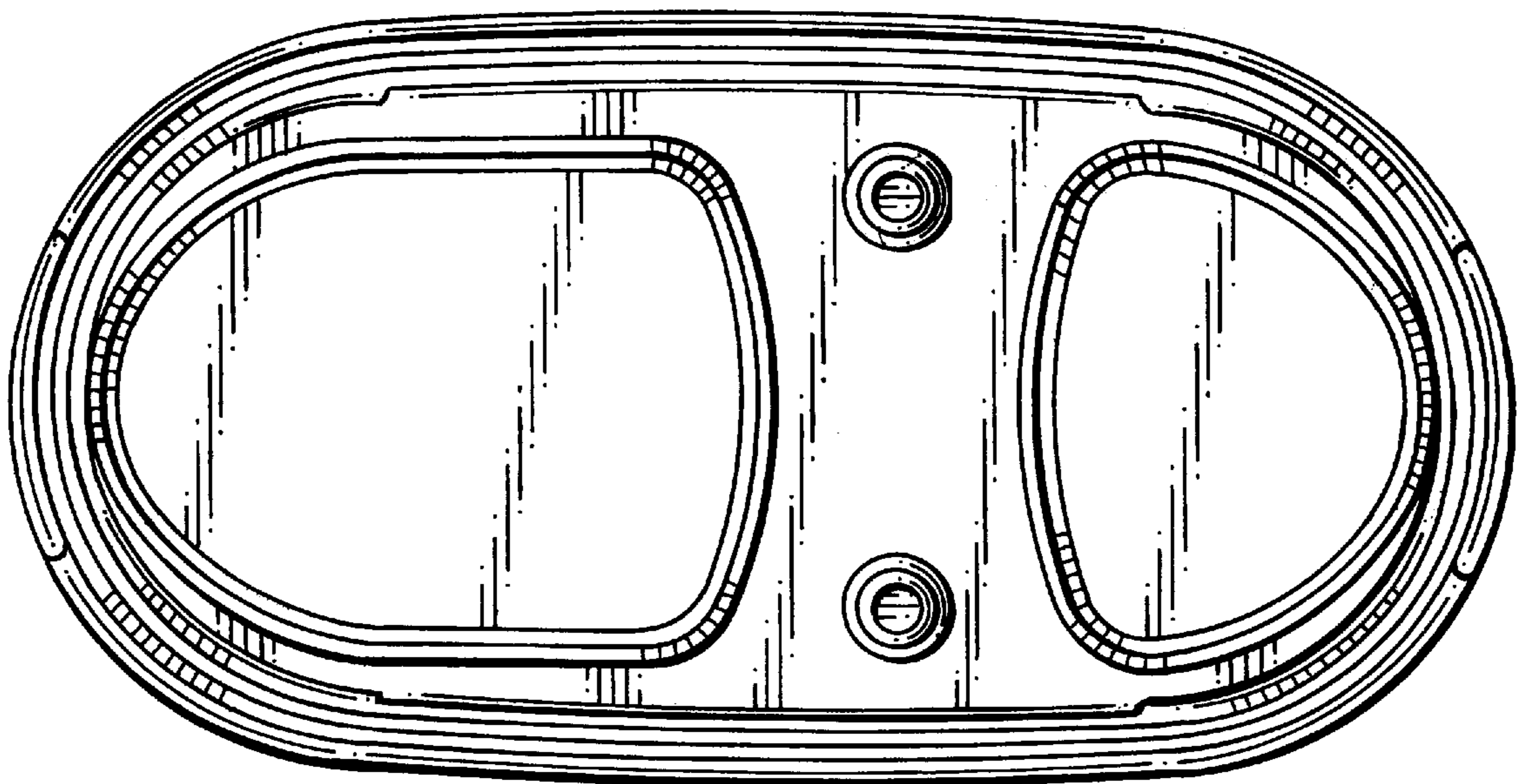

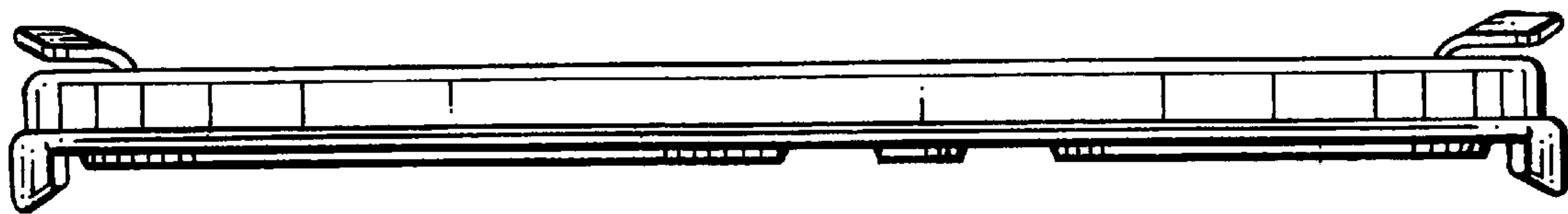

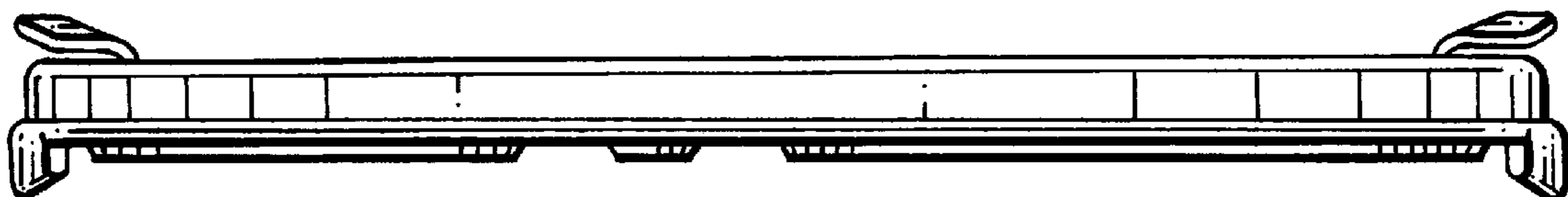

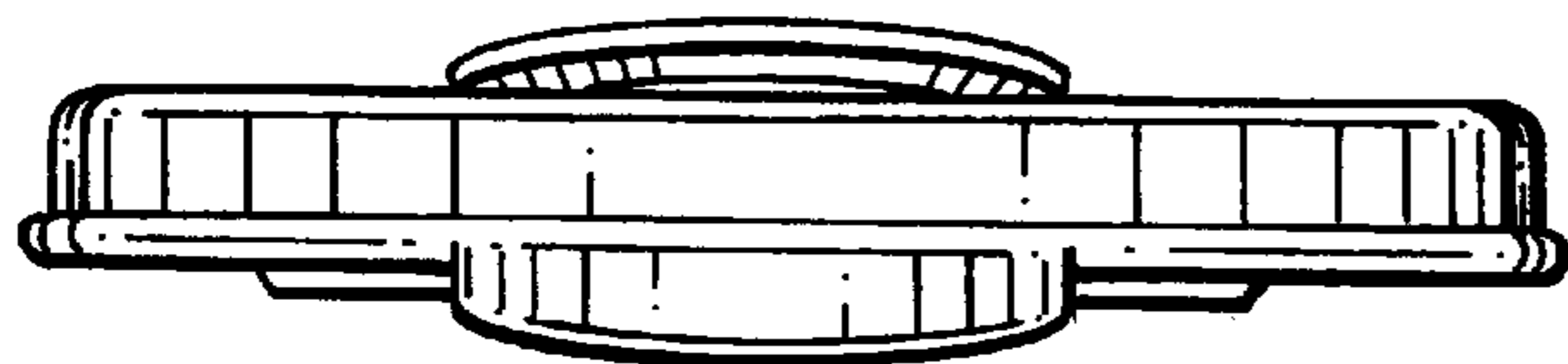

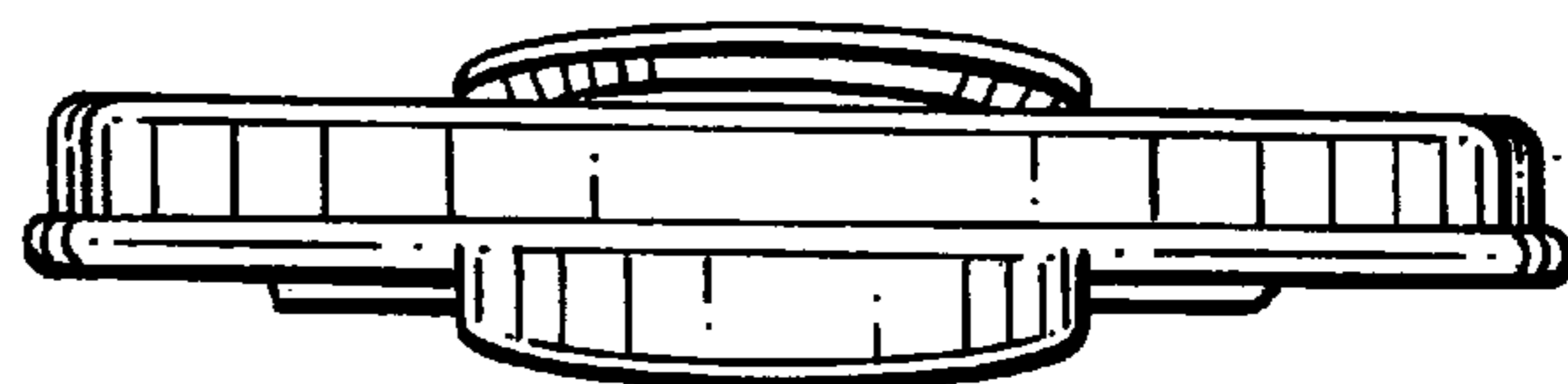
