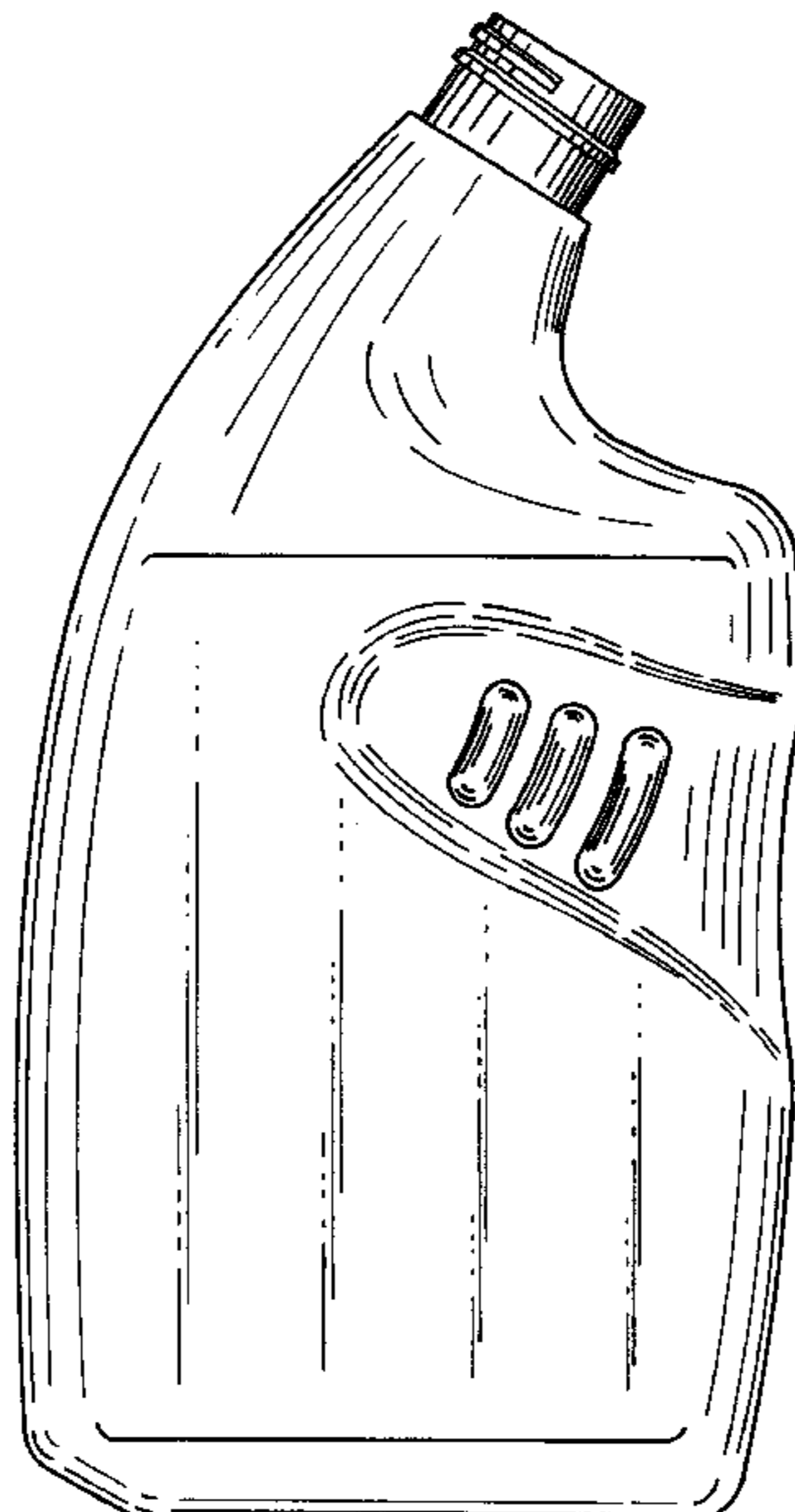
[57] CLAIM

DESCRIPTION

FIG. 1 is a perspective view of the bottle embodying the new design;
FIG. 2 is a front elevational view thereof;

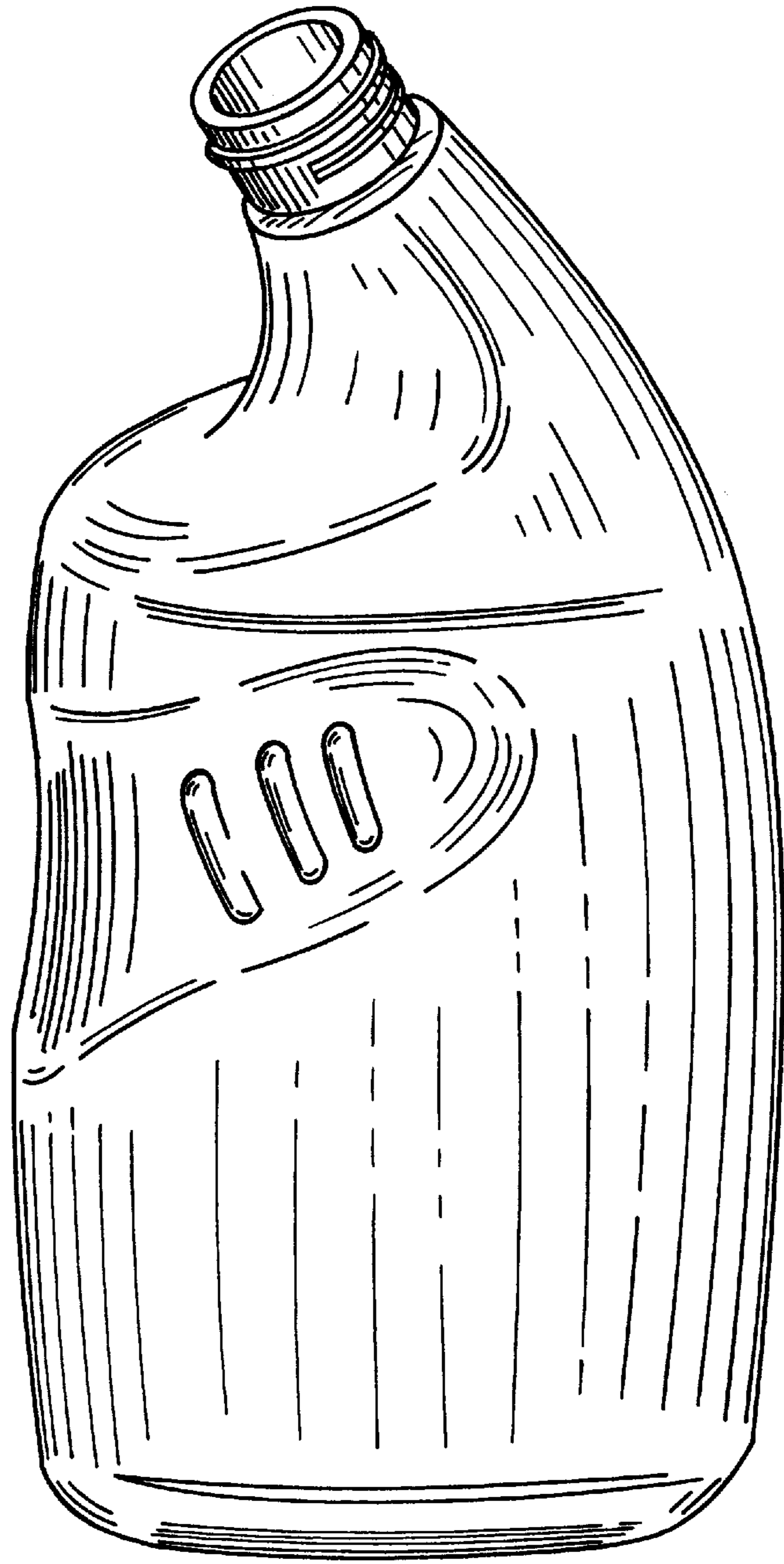

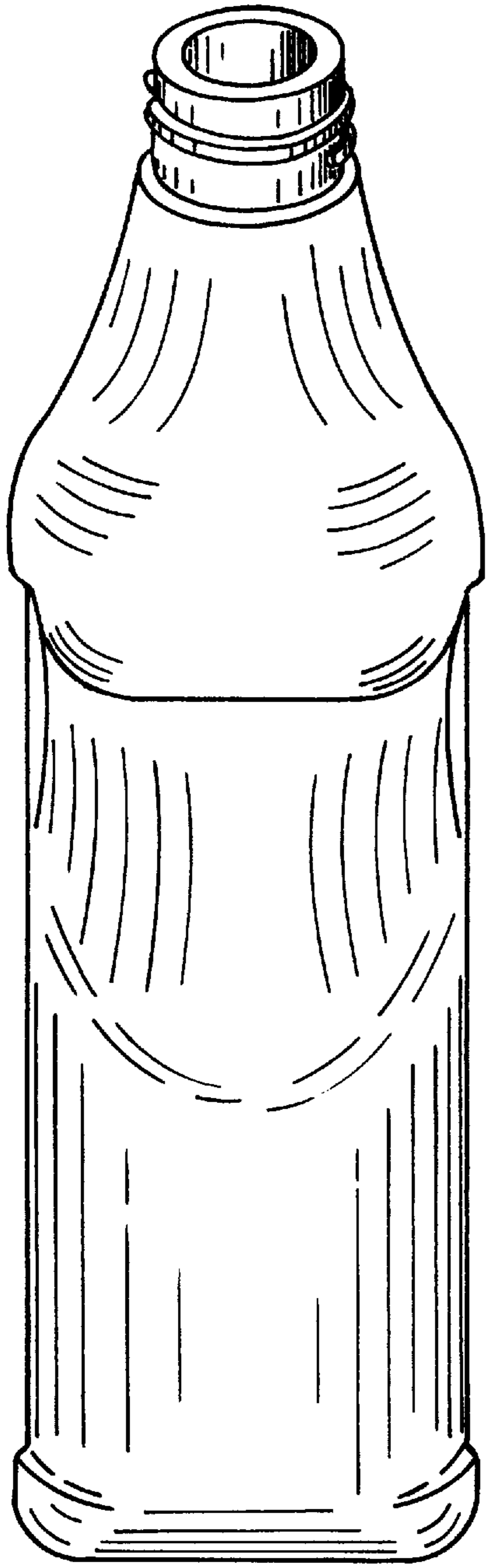

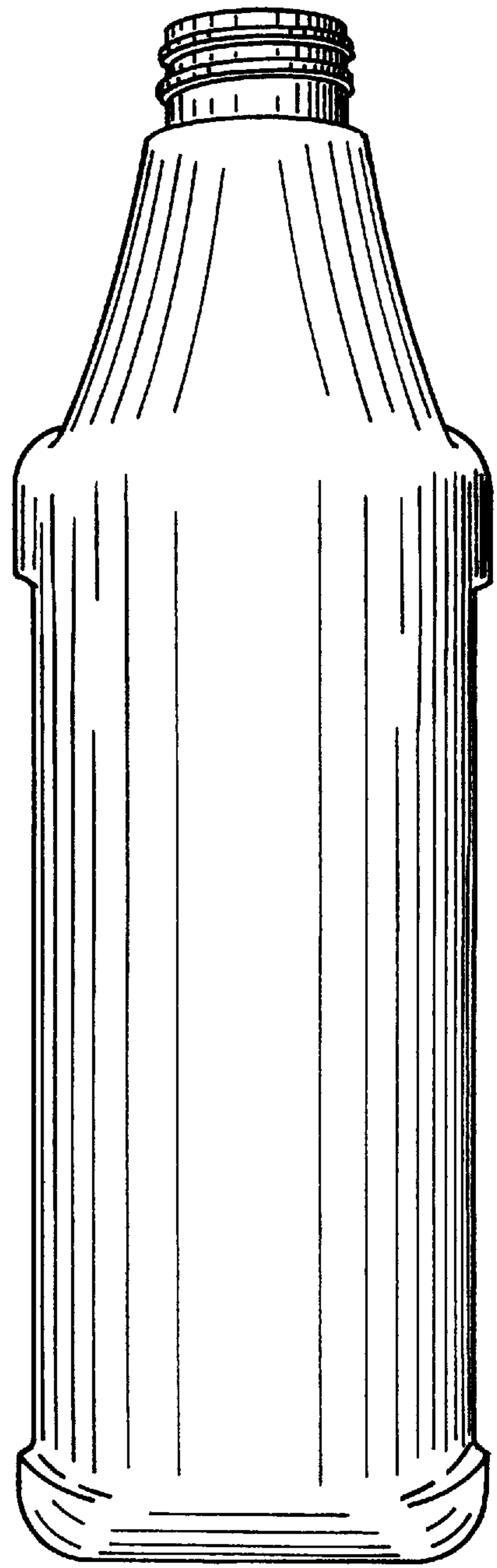

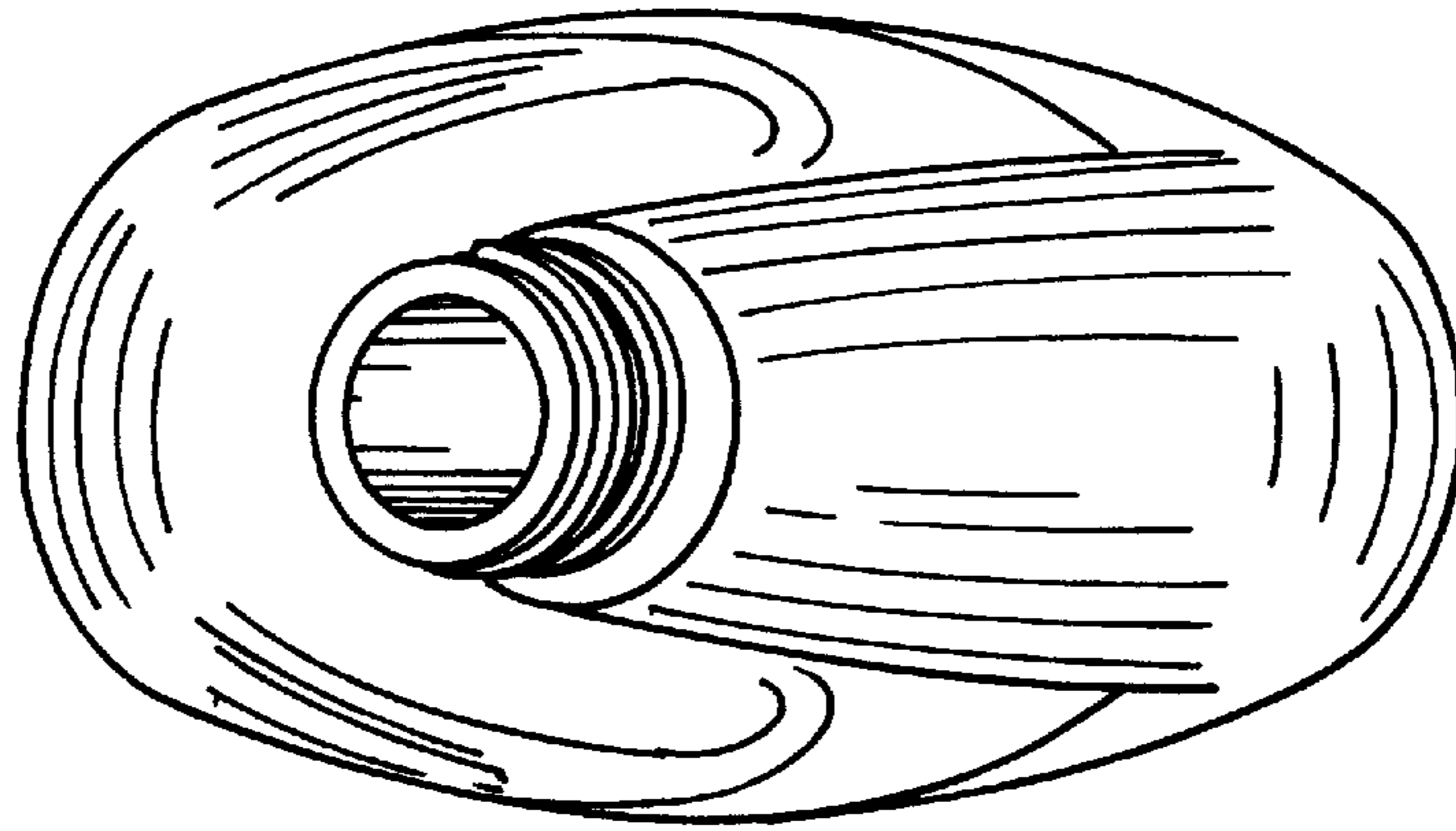

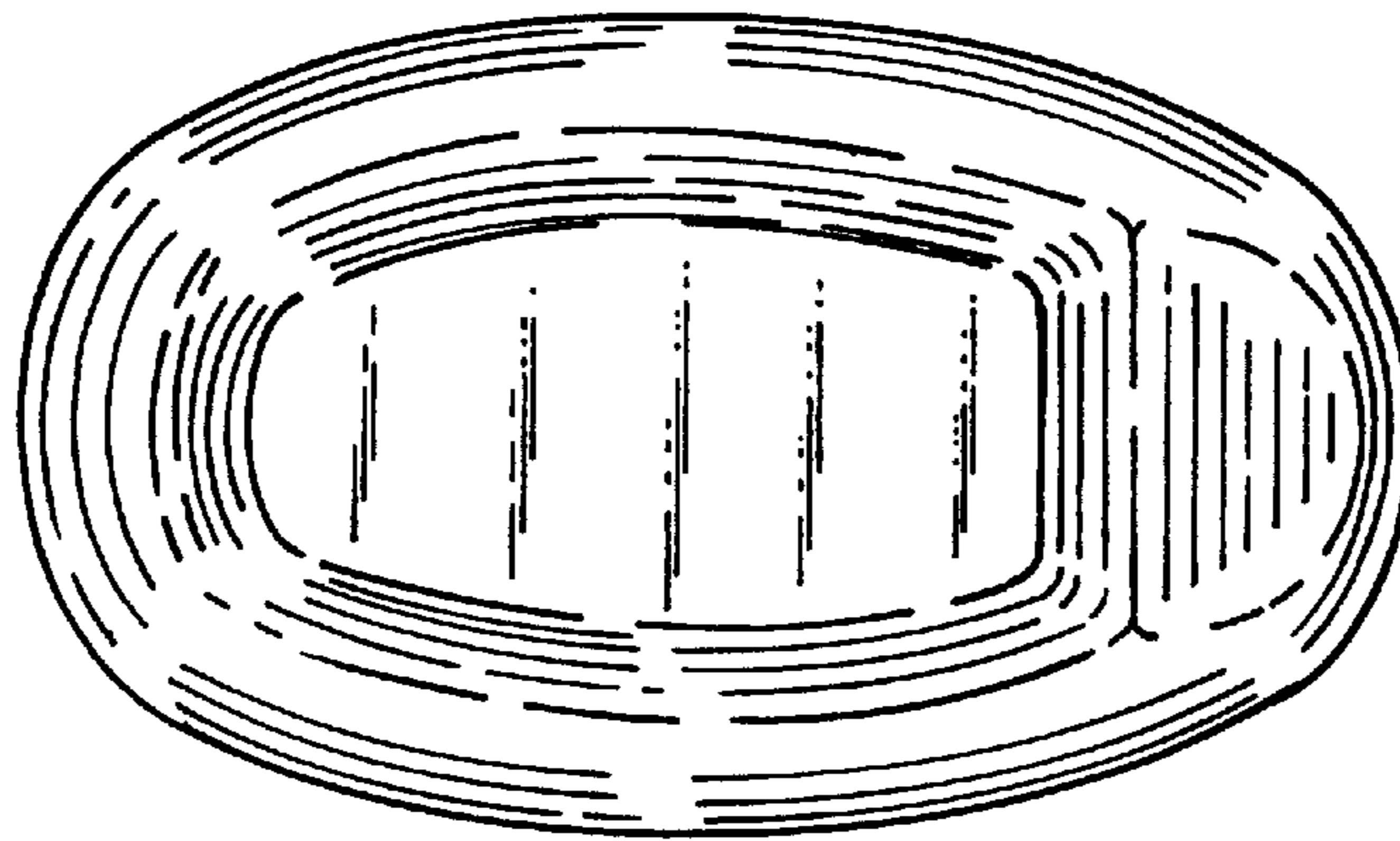

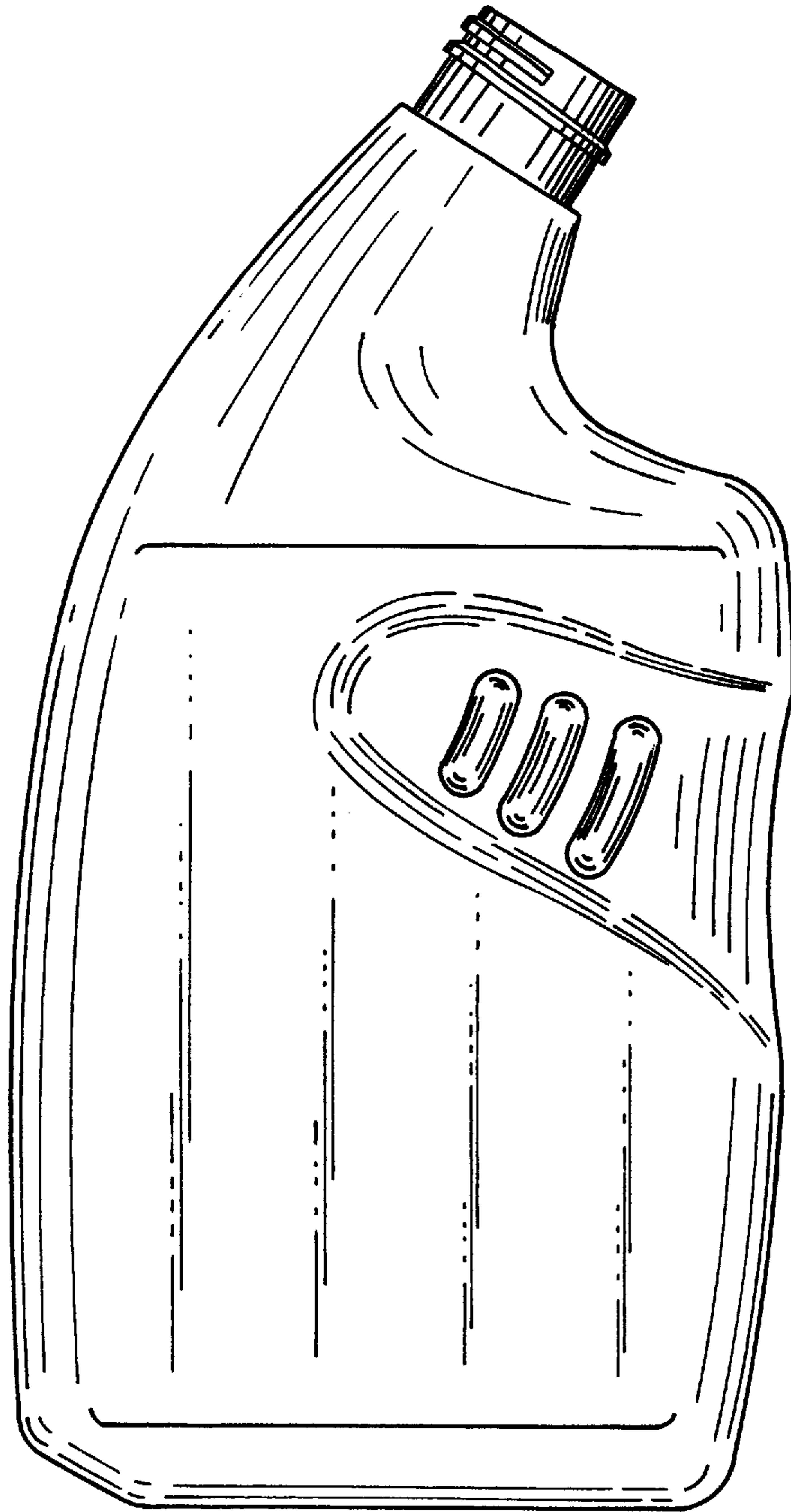

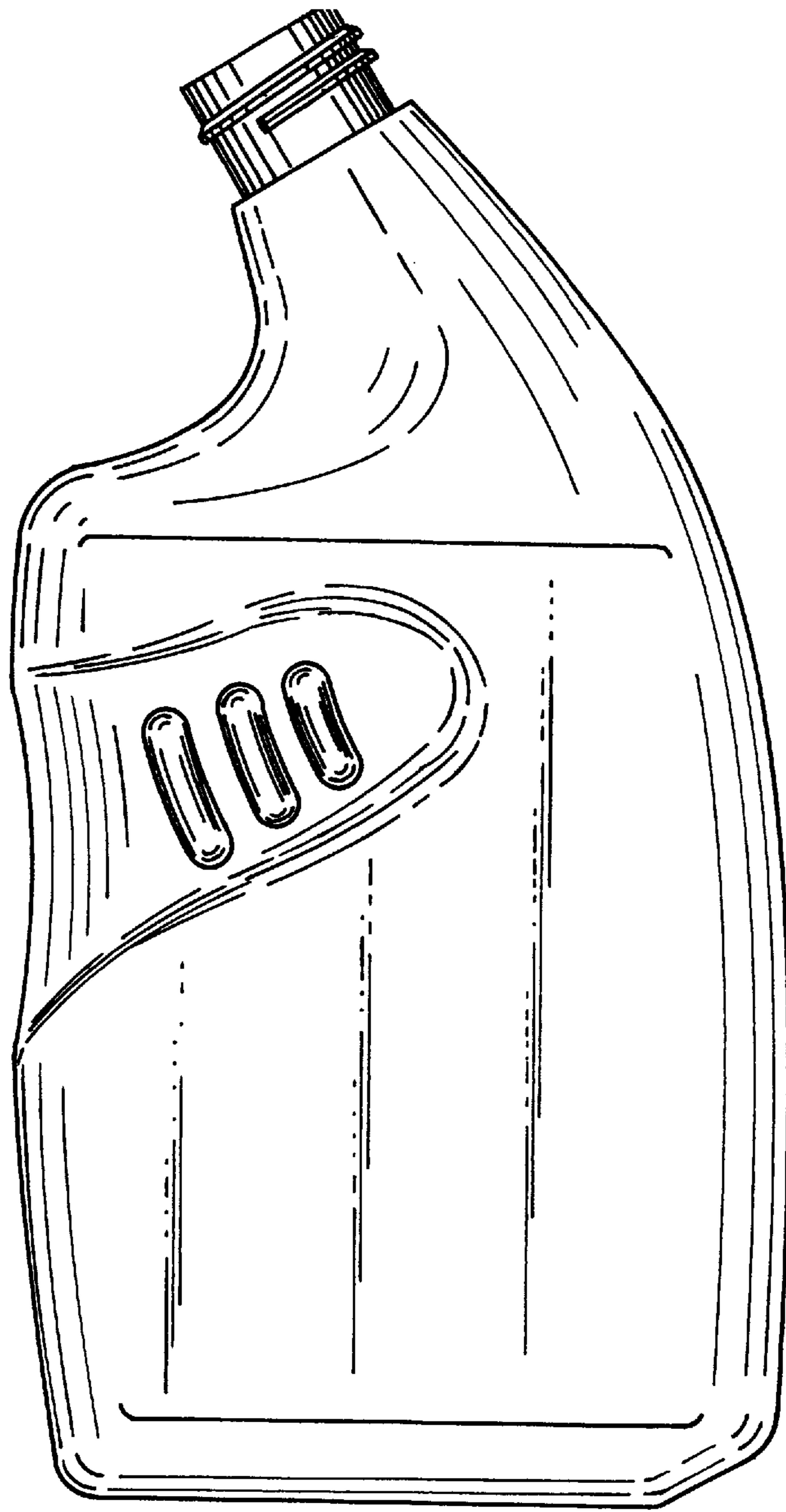
