FIG. 3 is a left side view of a golf club showing my new design;

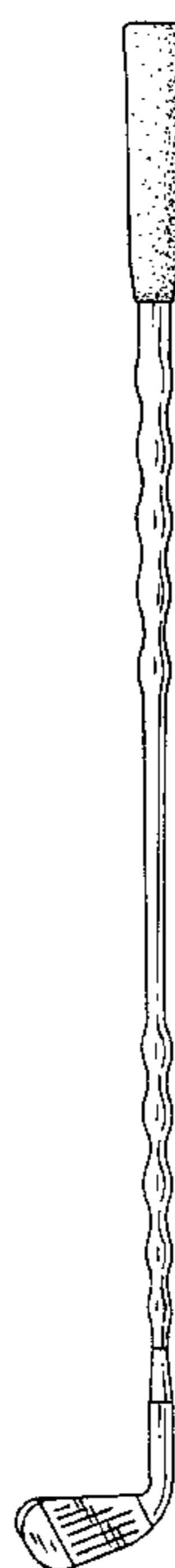
FIG. 4 is a right side view of a golf club showing my new design;

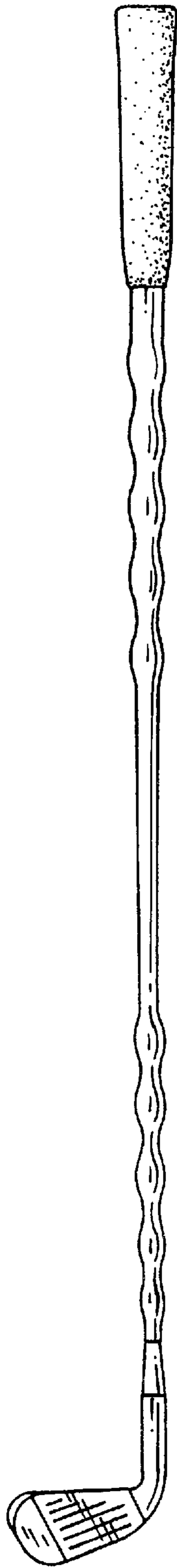

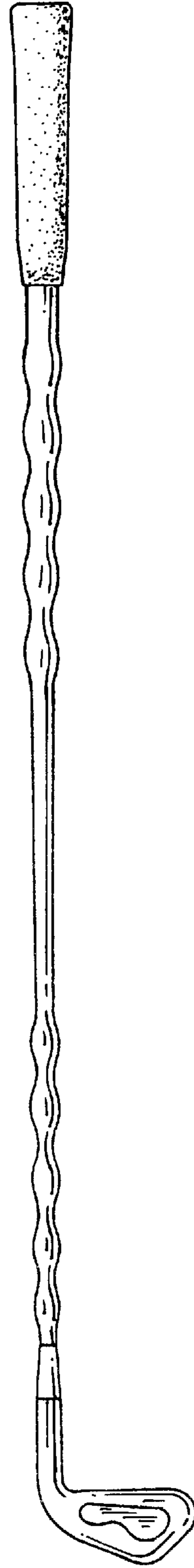

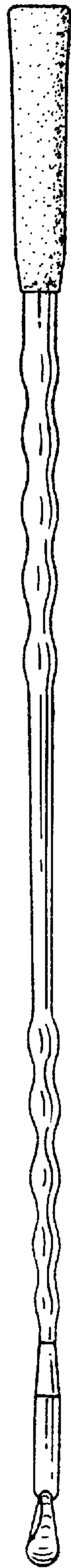

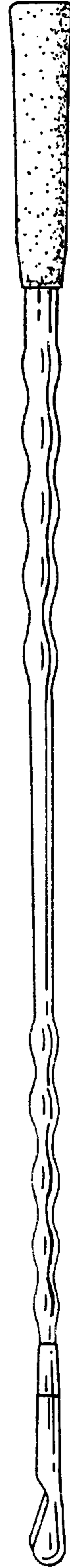

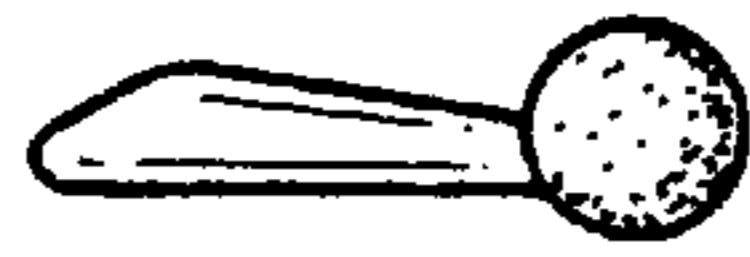

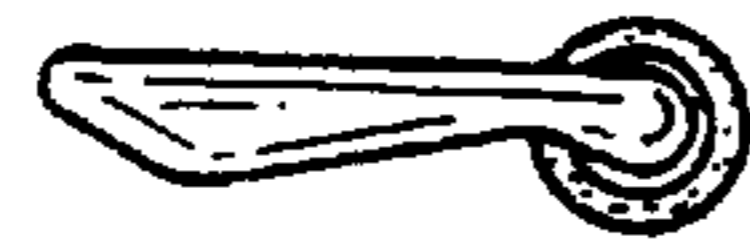

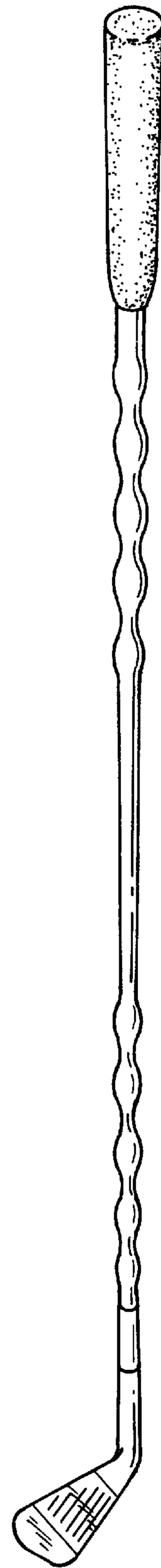
