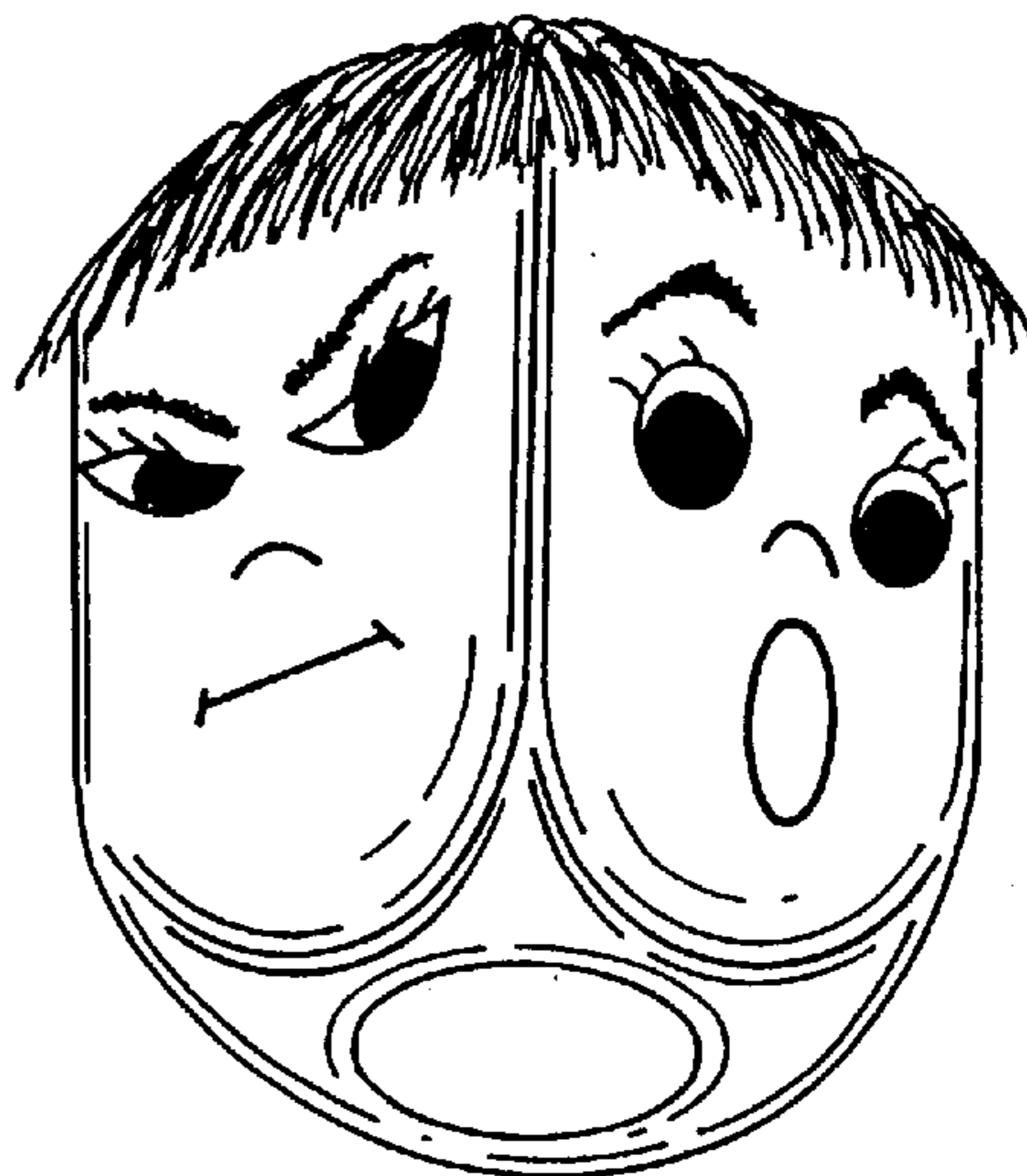
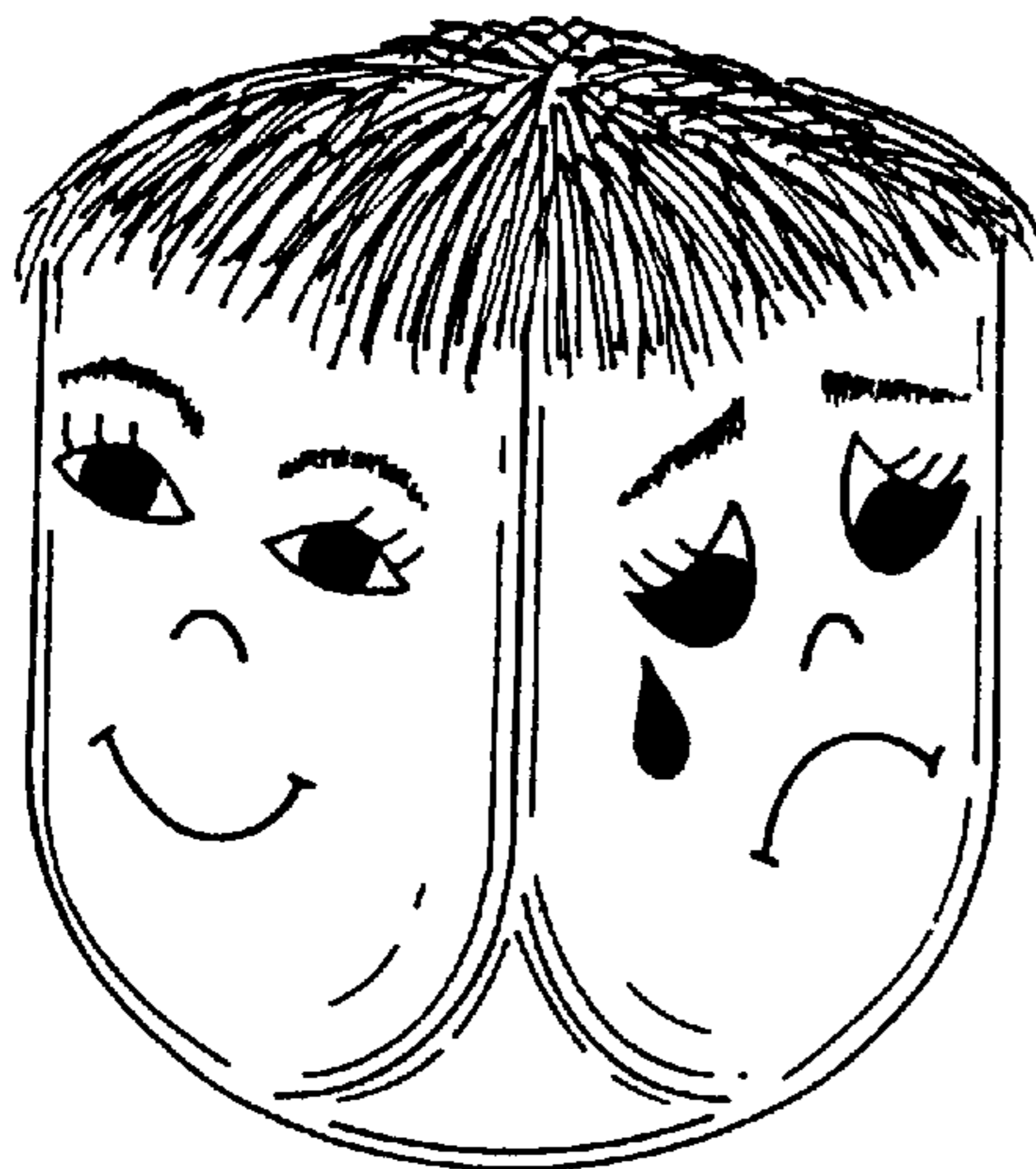
[57] **CLAIM**

The ornamental design for a doll's head, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a doll's head showing a first embodiment of my new design;  
 FIG. 2 is a left side elevational view thereof;  
 FIG. 3 is a right side elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a bottom view thereof;  
 FIG. 6 is plan view thereof;  
 FIG. 7 is a front and right side perspective view thereof;  
 FIG. 8 is a rear and left side perspective view thereof;  
 FIG. 9 is a front elevational view of a doll's head showing a second embodiment of my new design;

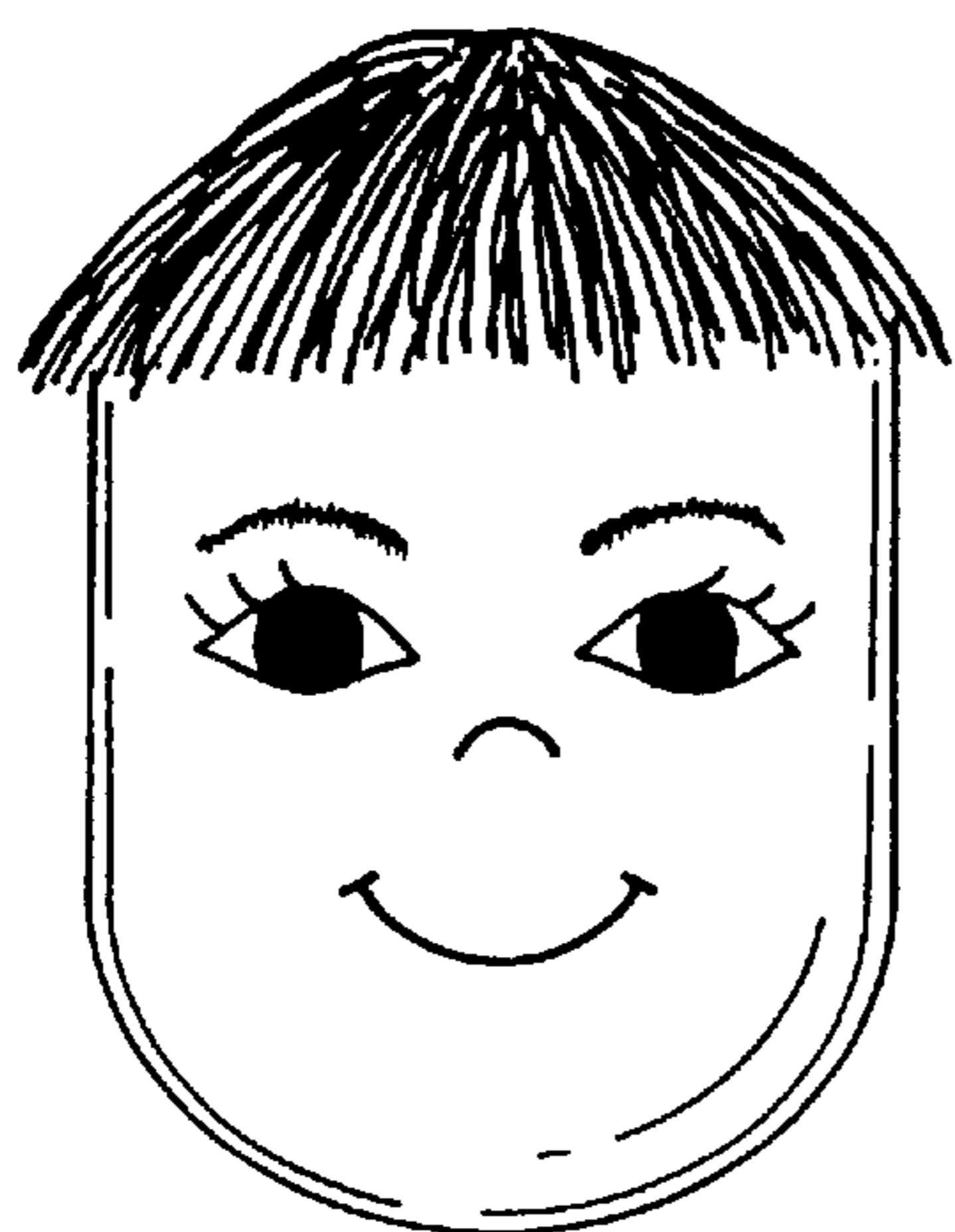

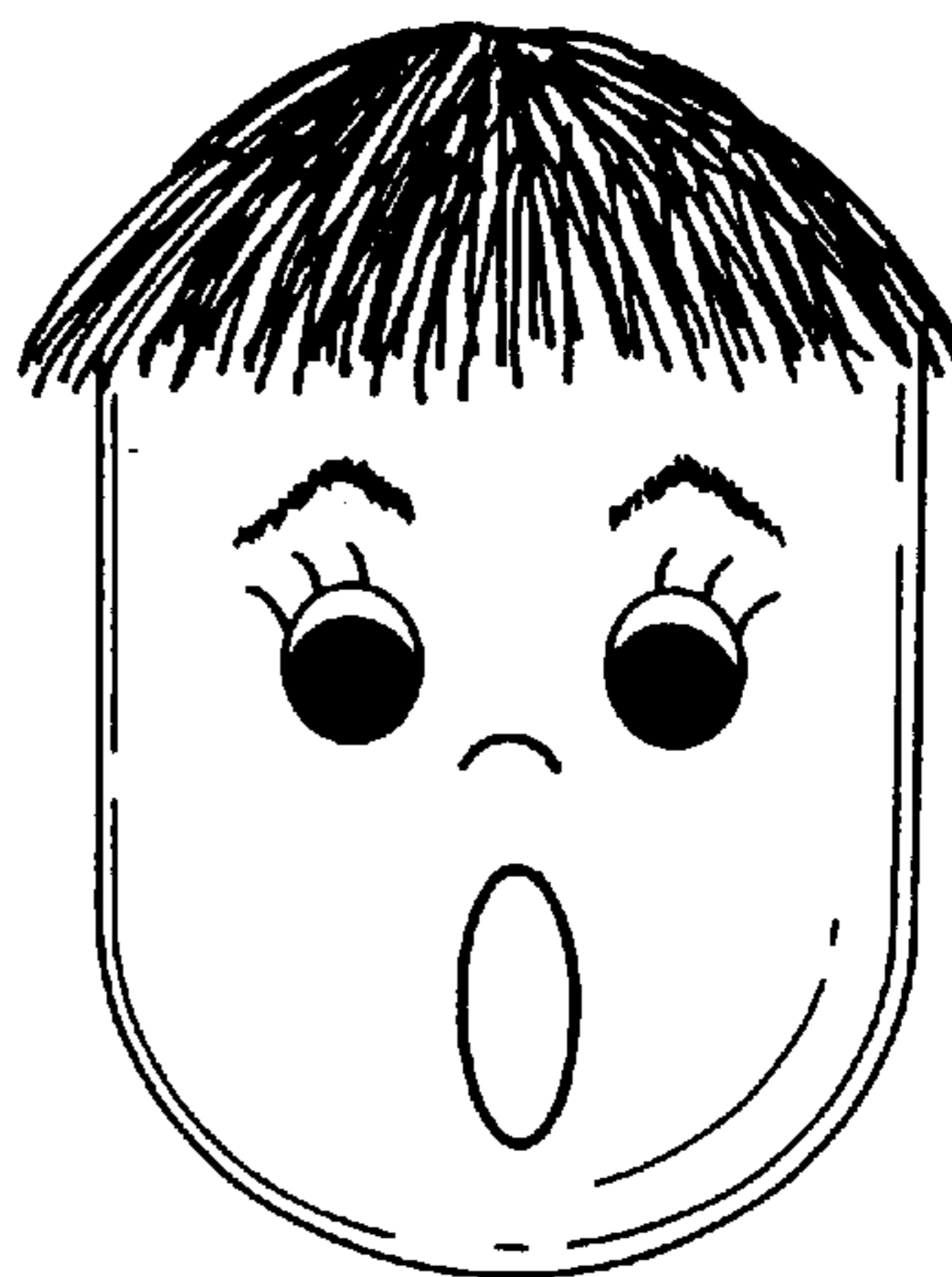

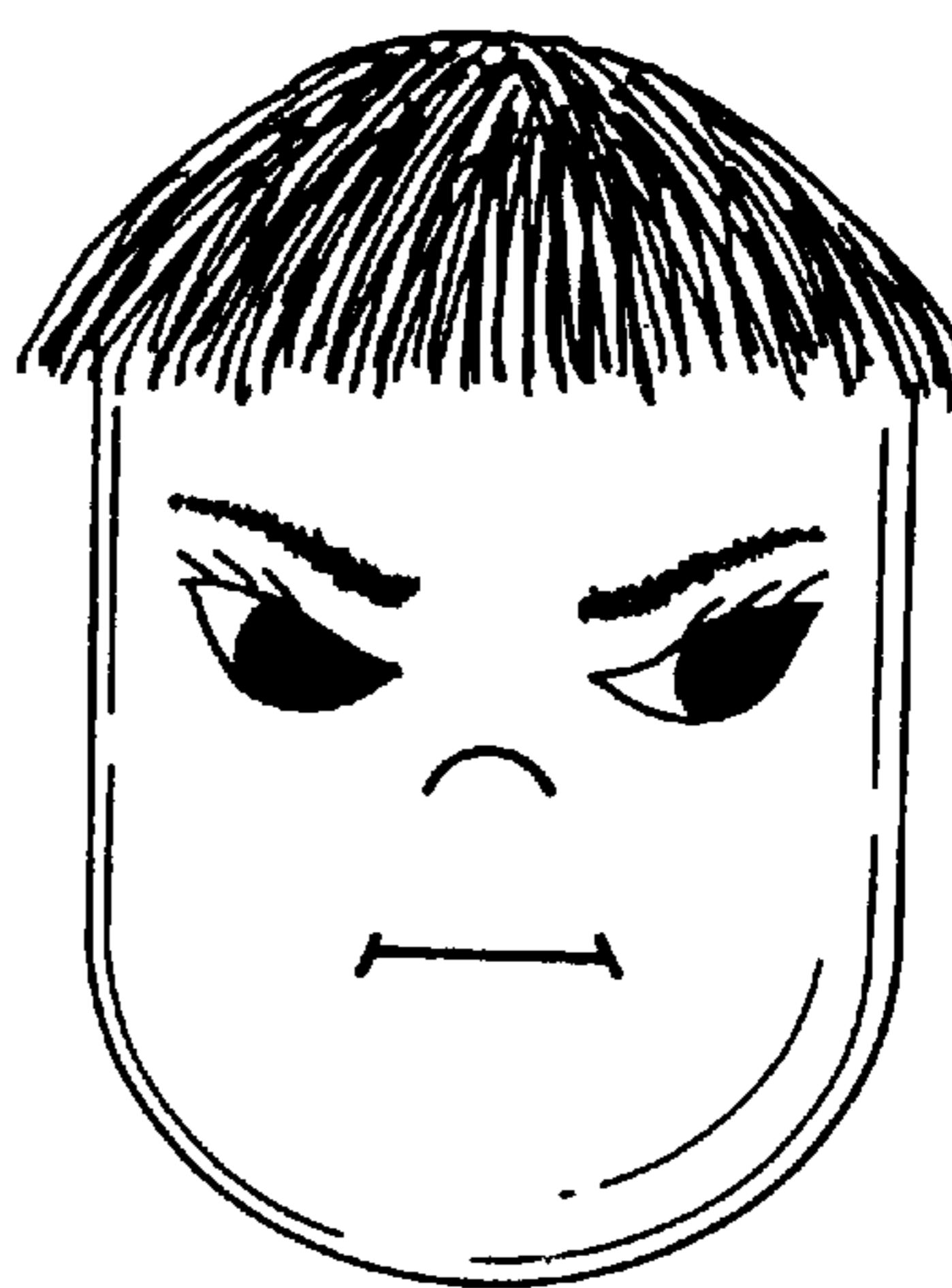
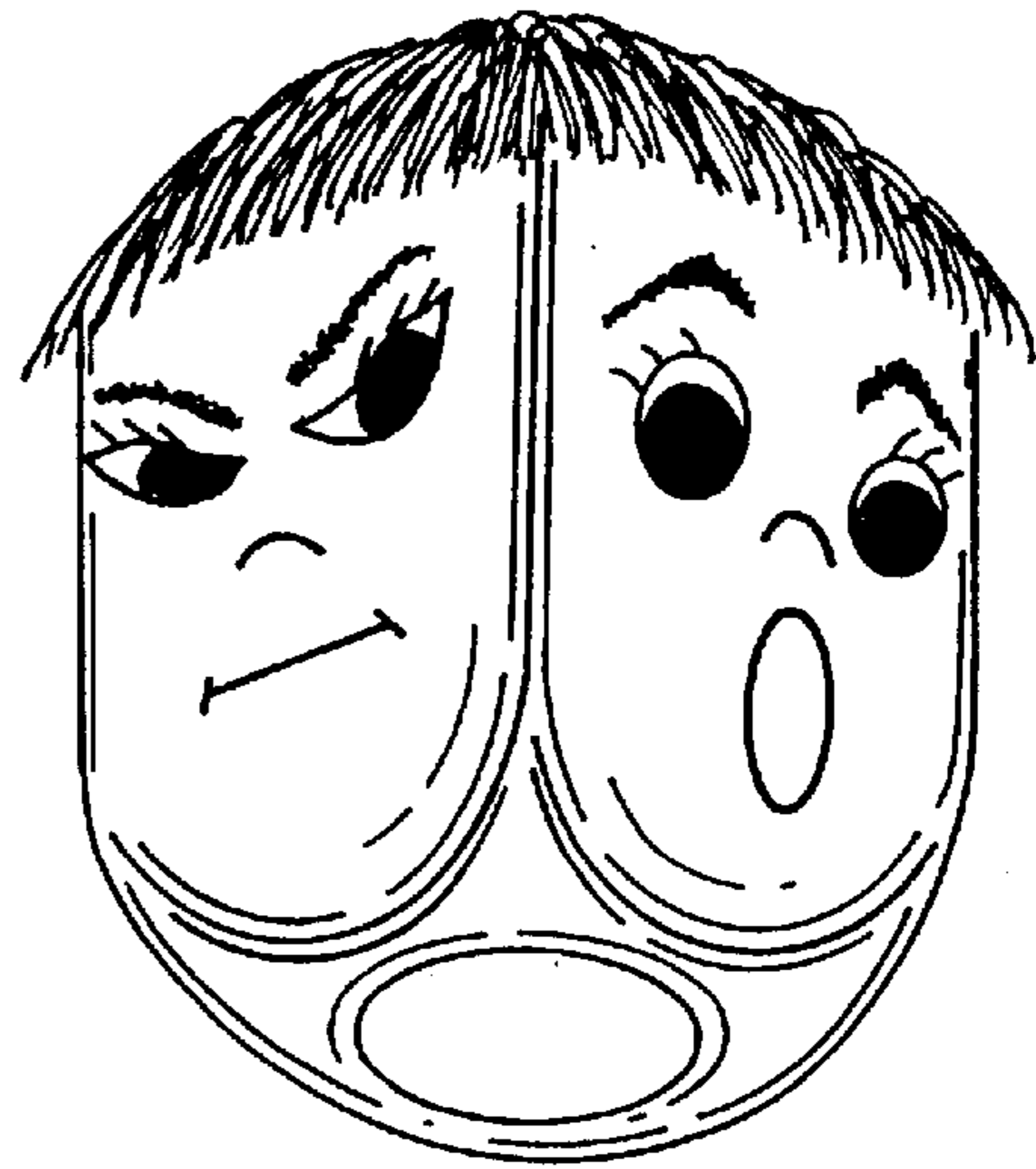
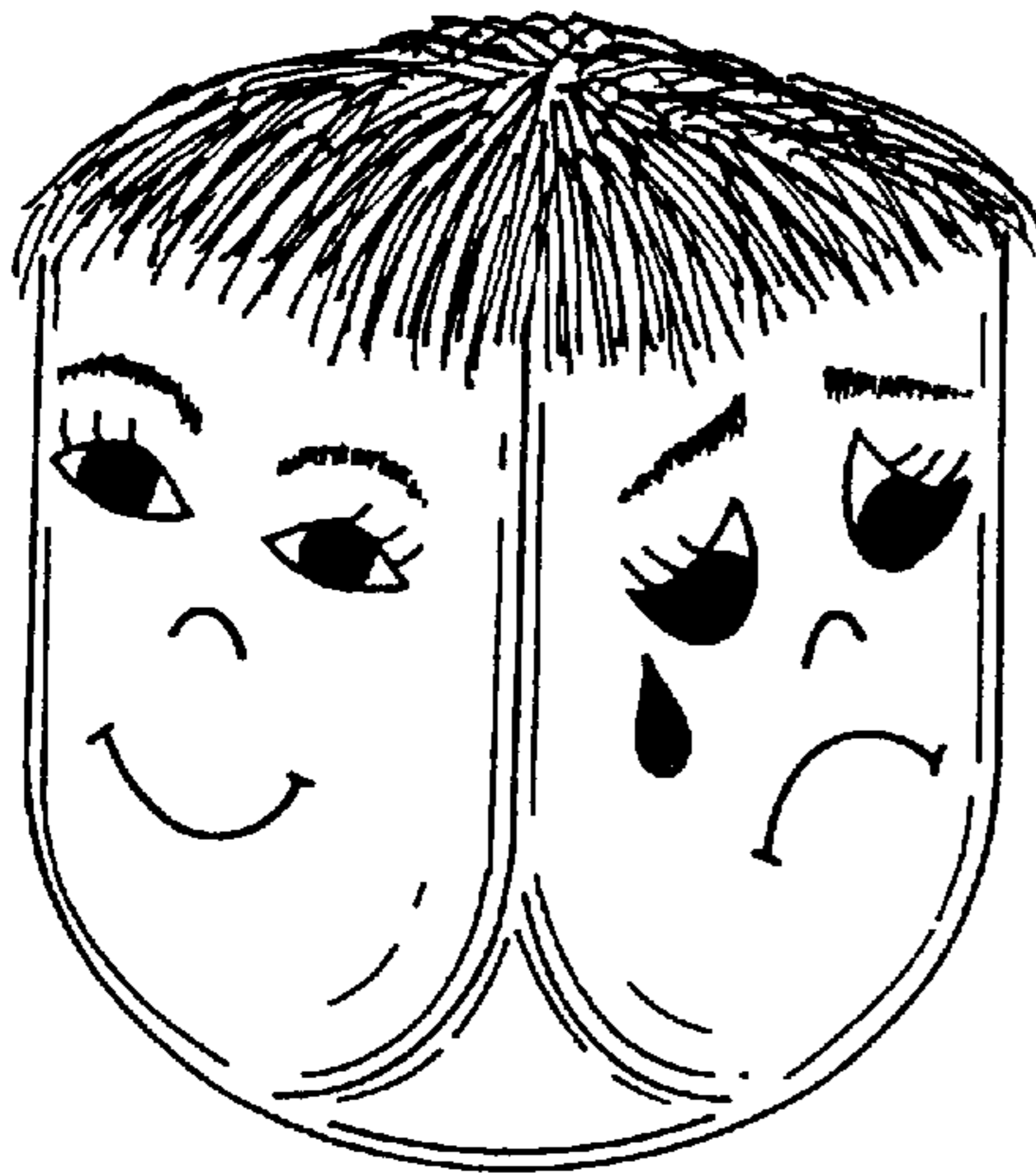
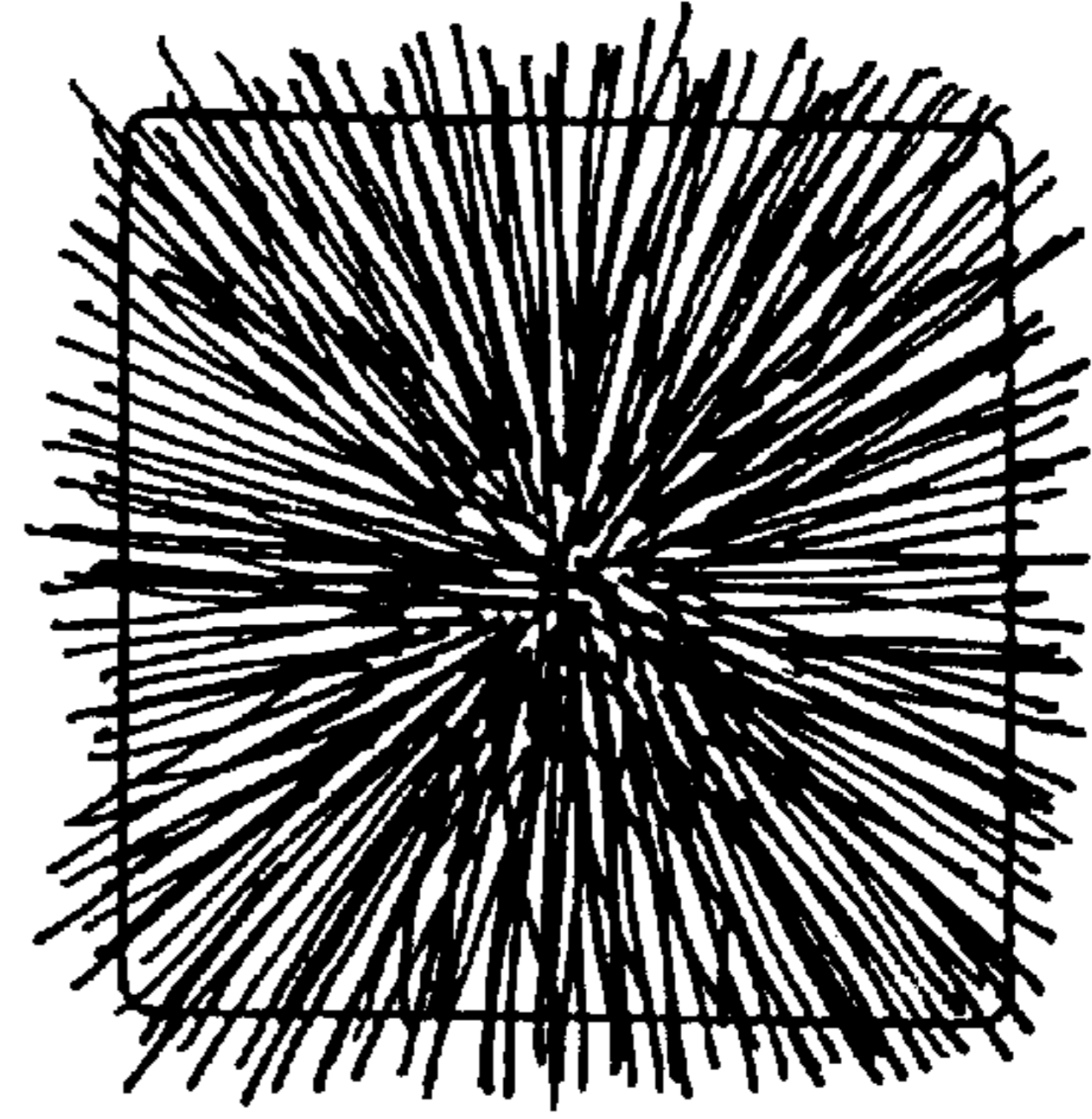
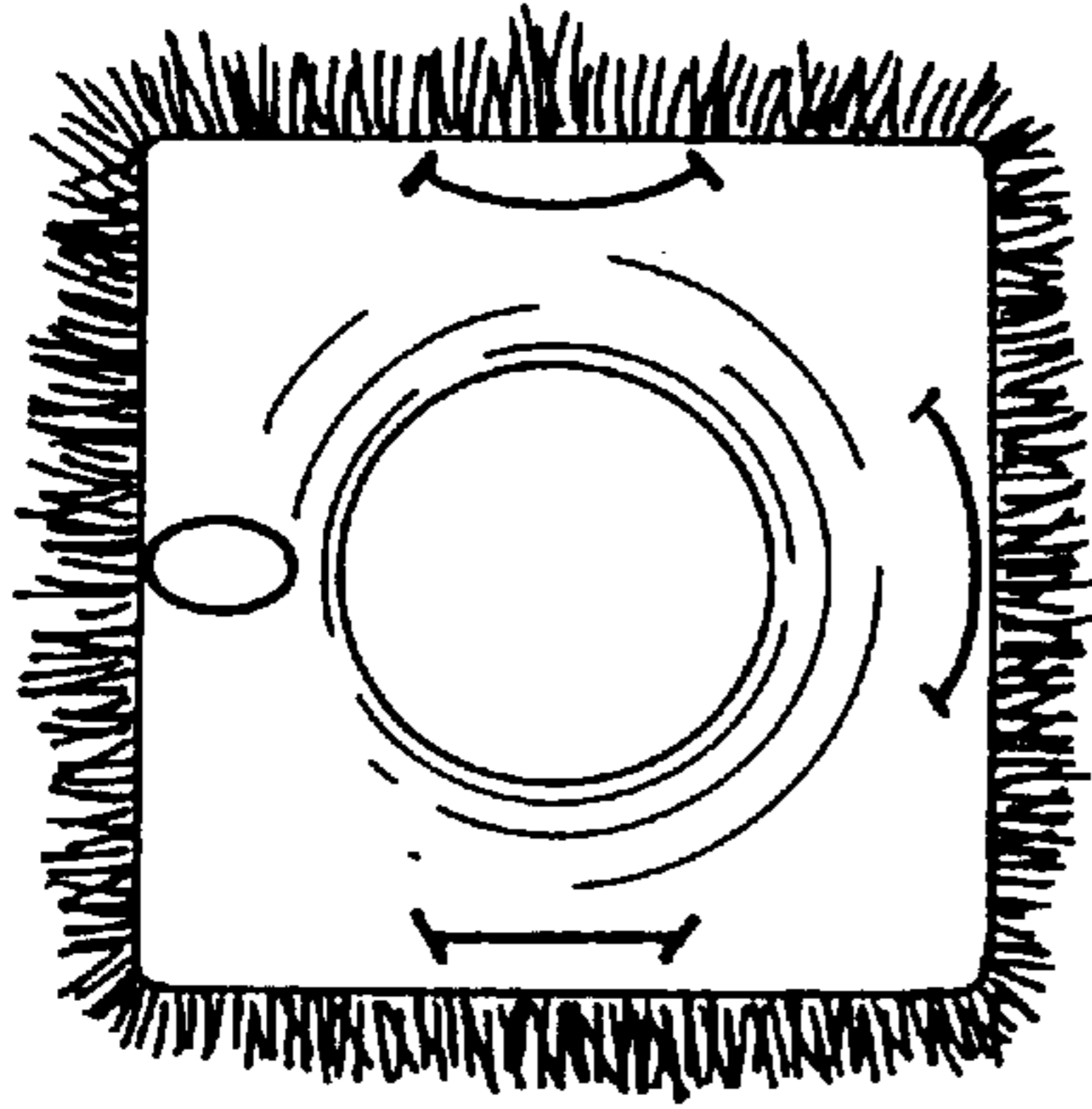
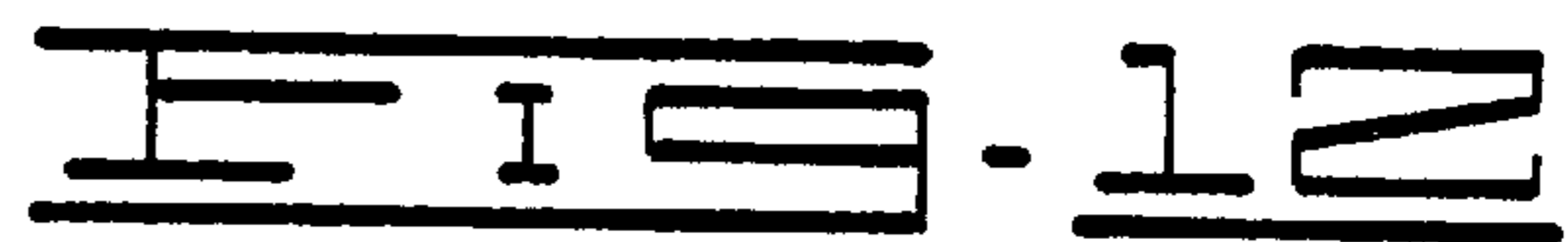
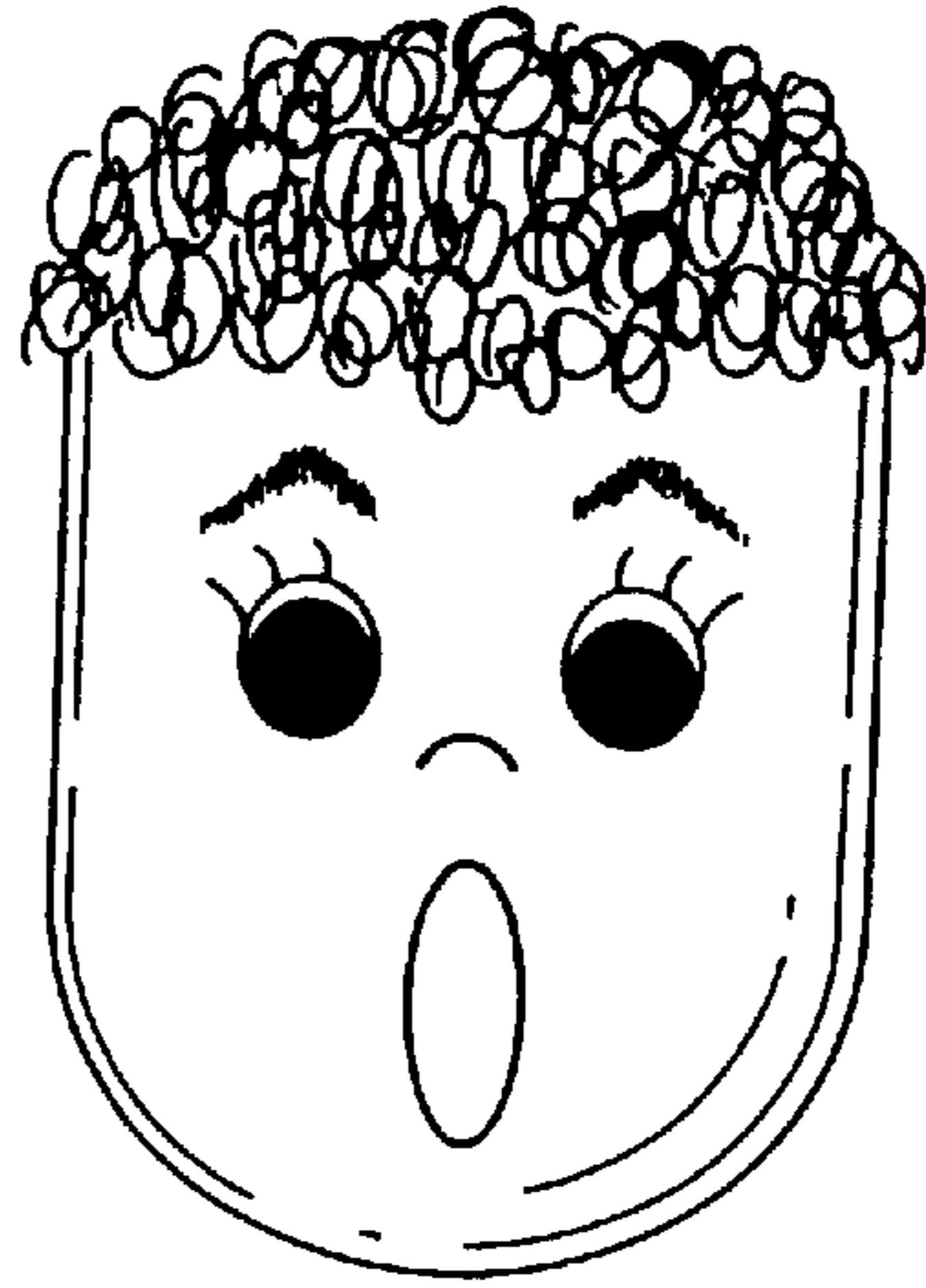
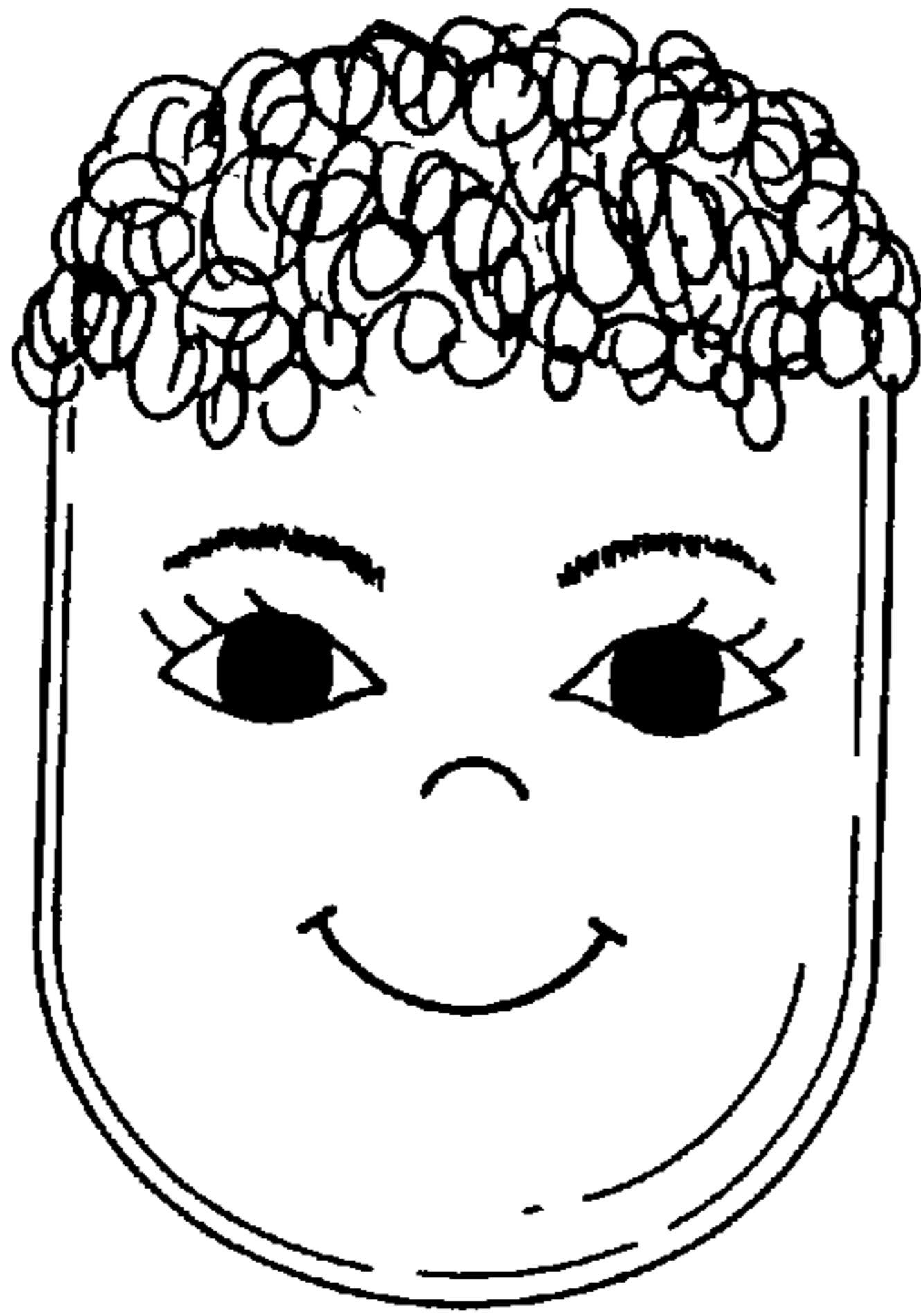

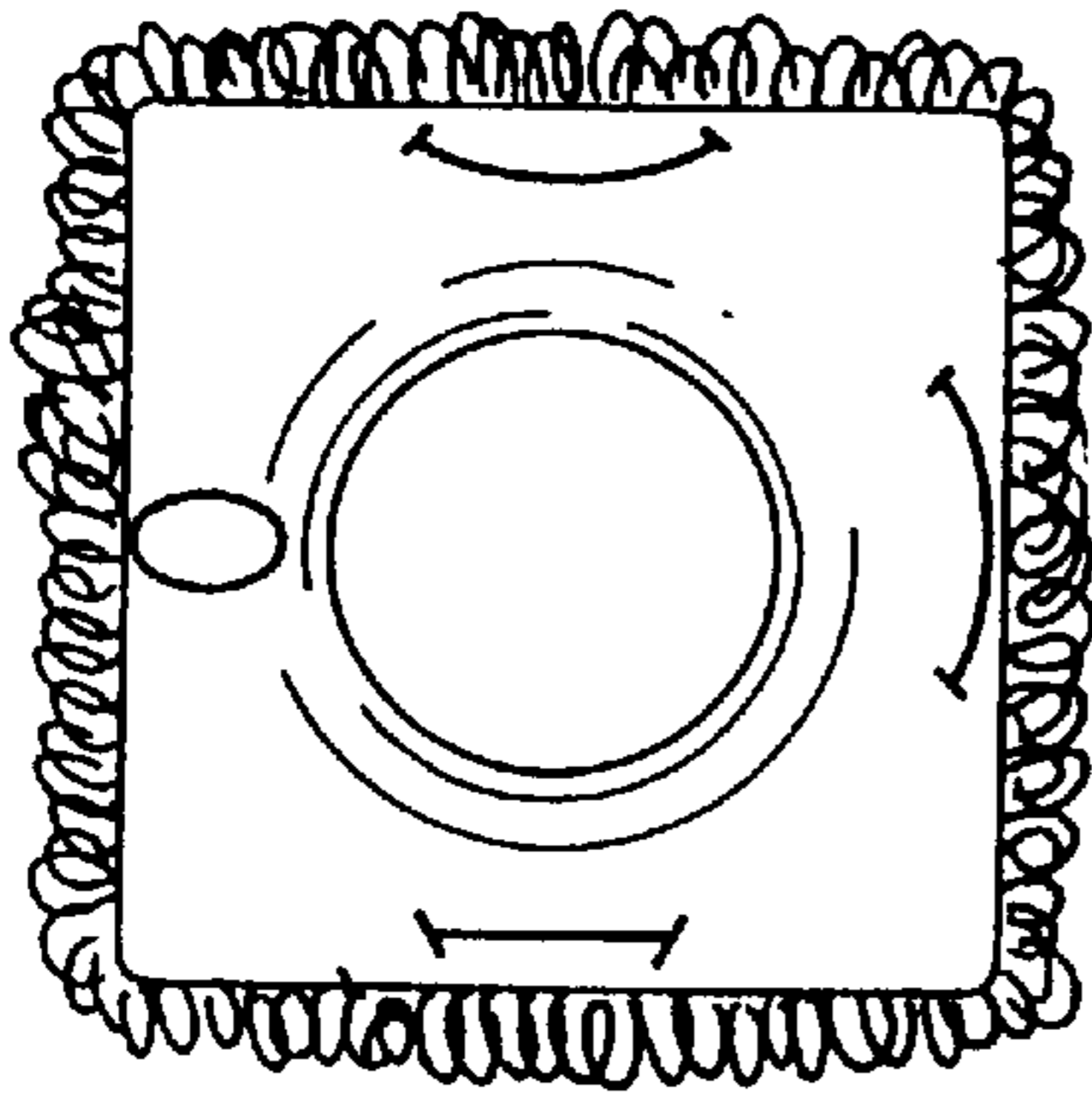

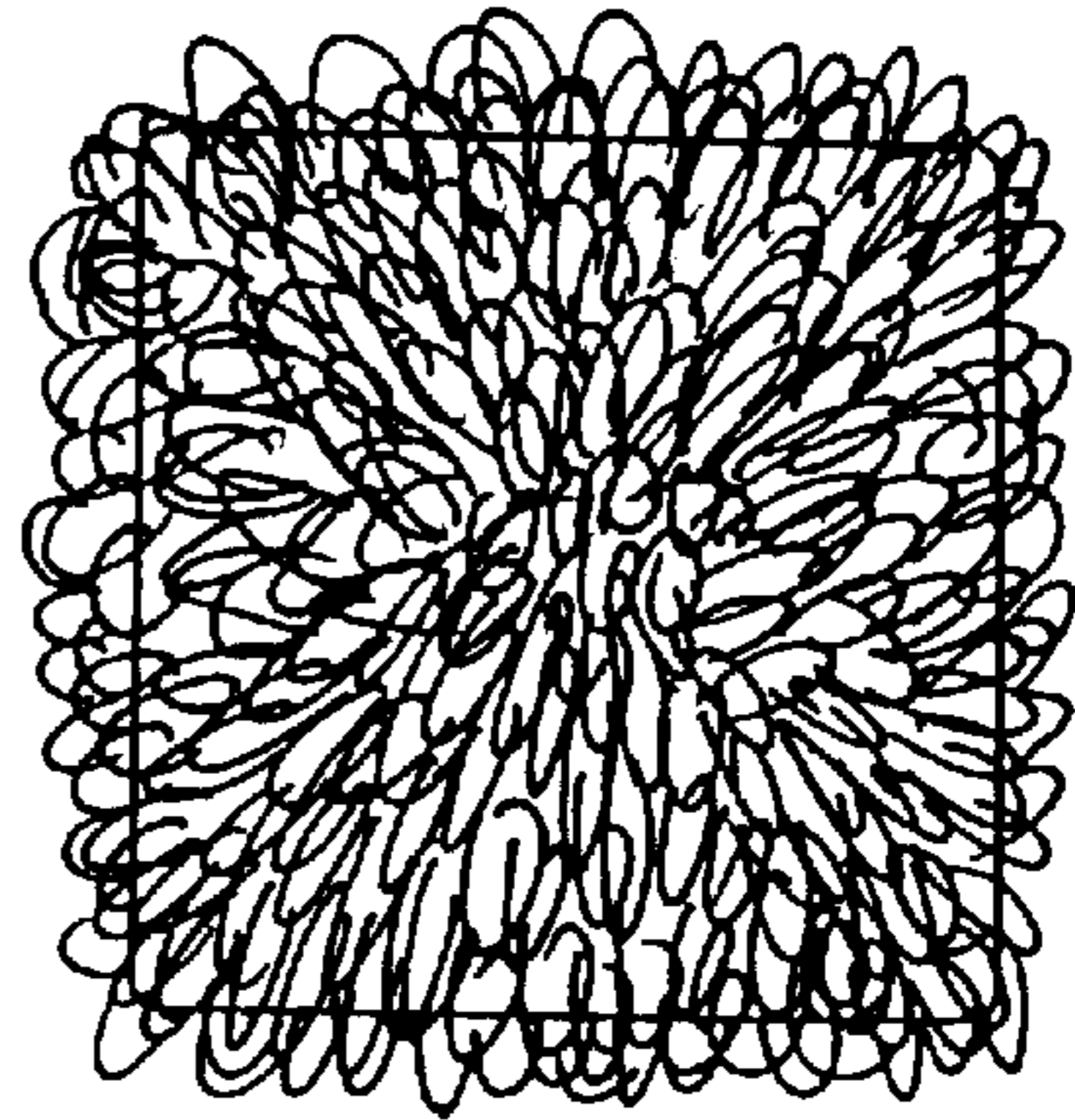

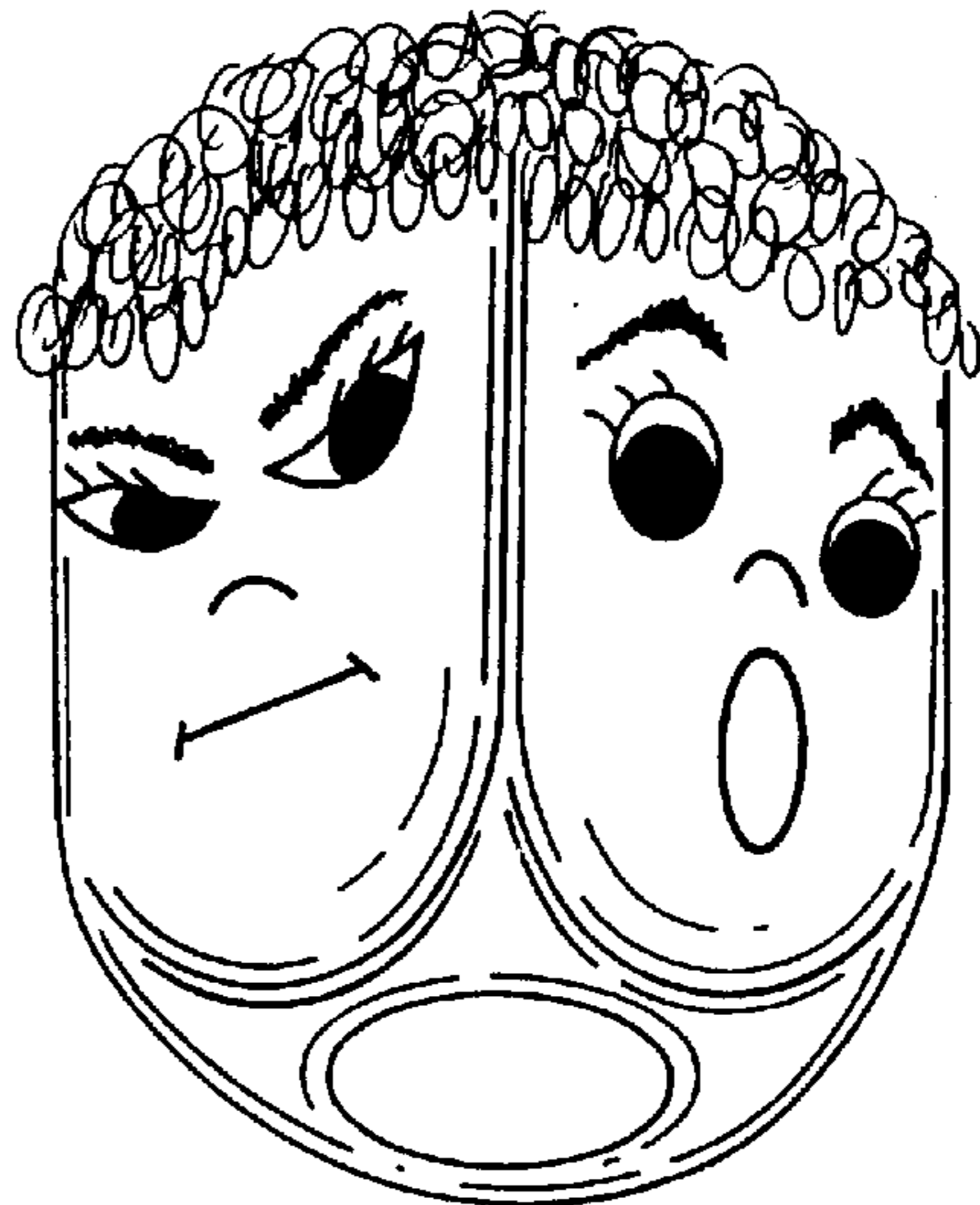
