**DESCRIPTION**

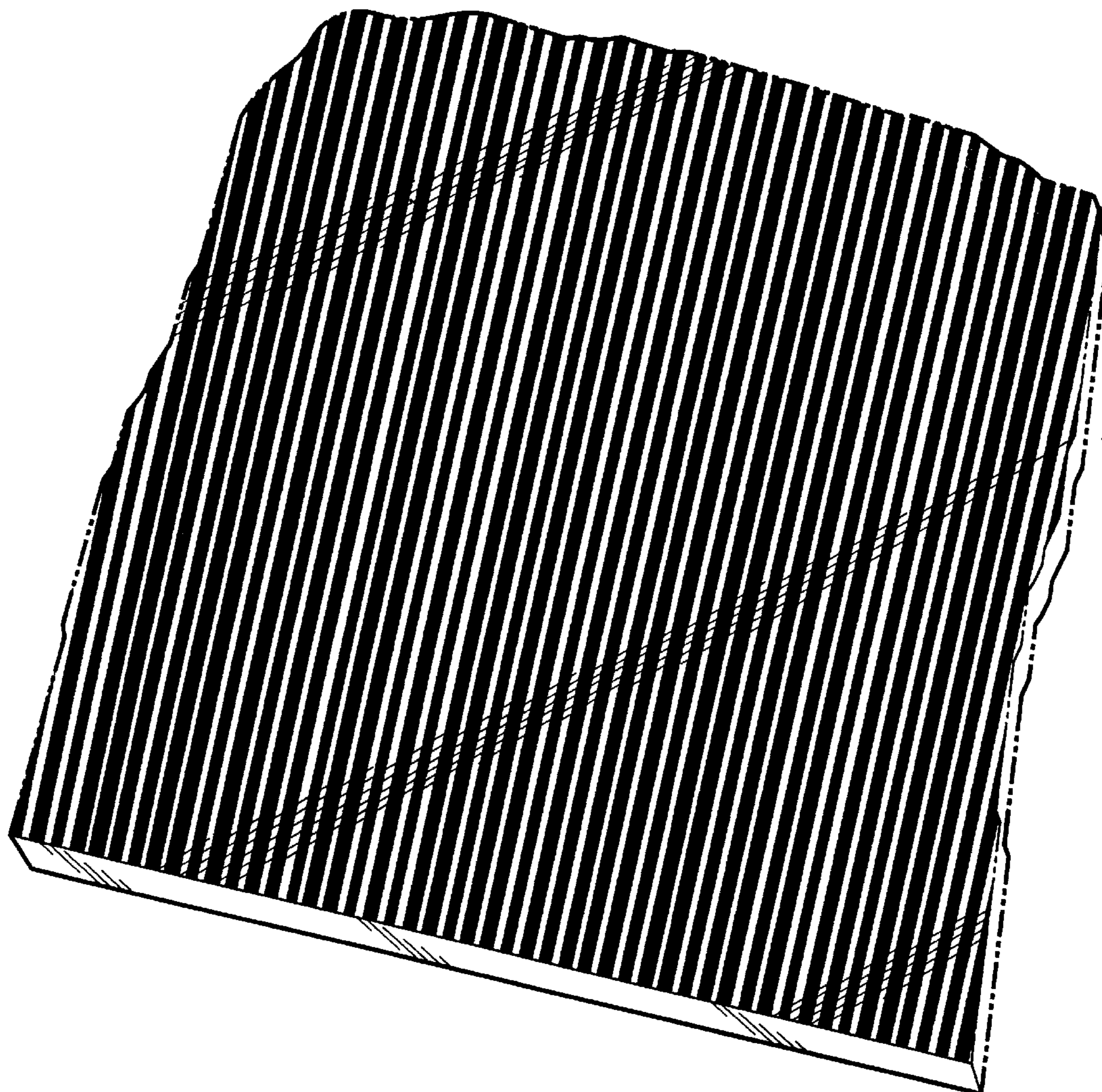
FIG. 1 is a top, front and right side perspective view of sheet of glass showing my new design;

The broken line showing of the bounds of the claimed design form no part thereof.

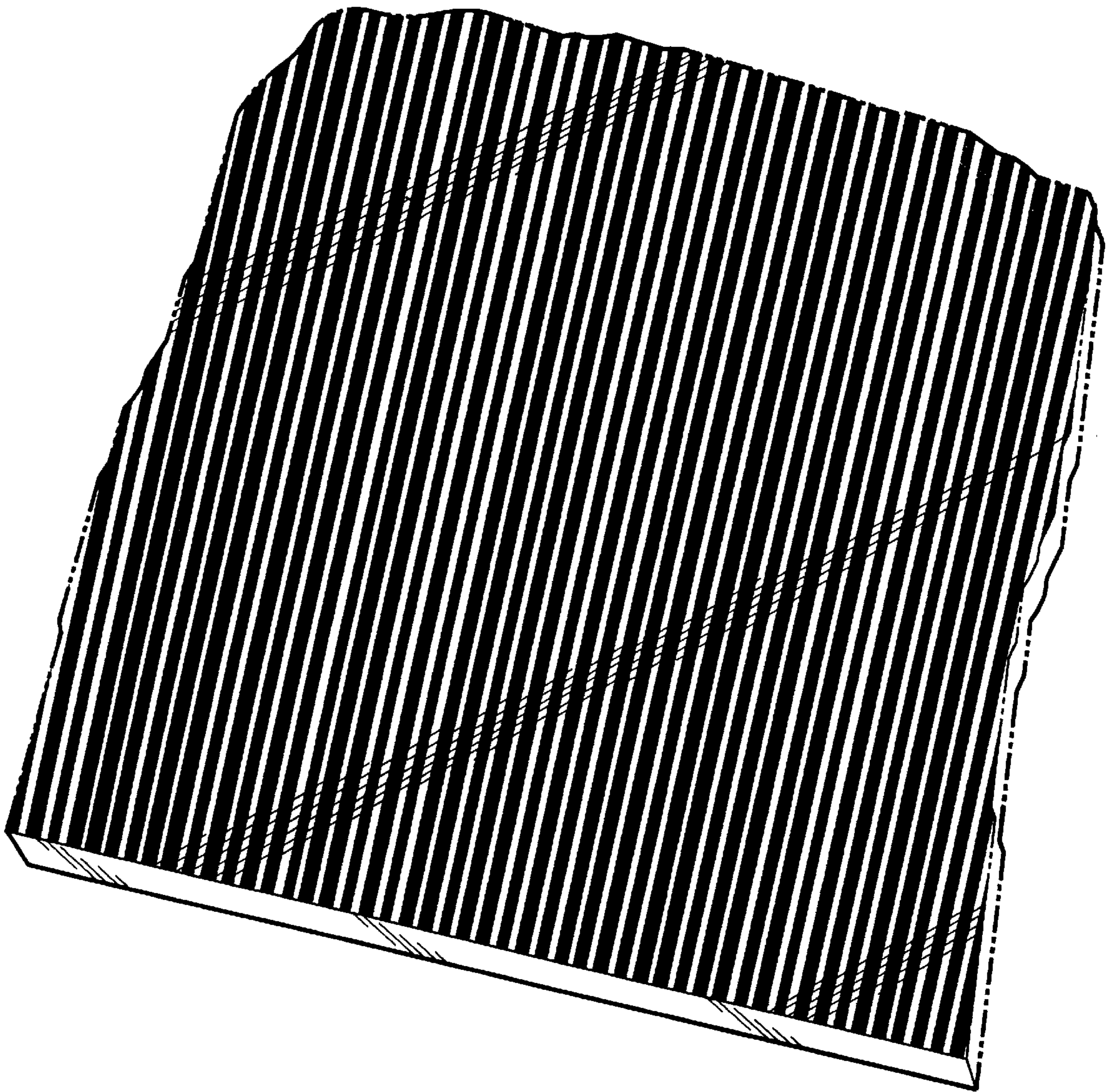

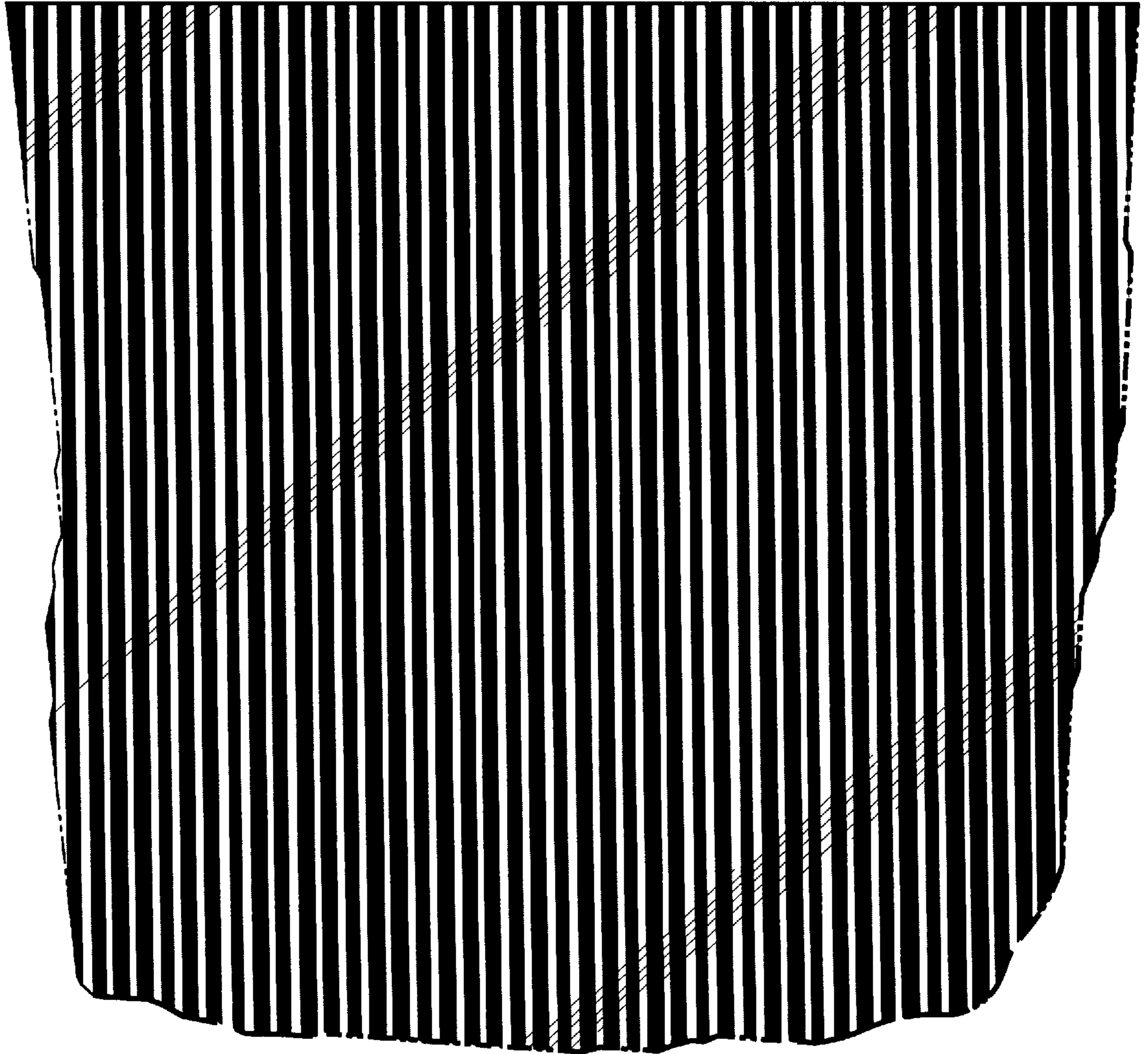
