[57] **CLAIM**

The ornamental design for a perimeter skirting for elevated structures, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of my new design for perimeter skirting for elevated structures, with the particular interlock at each end of the skirting panel shown in dotted lines to illustrate the environment of use;

FIG. 2 is a front elevation view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 21 is a top plan view thereof;

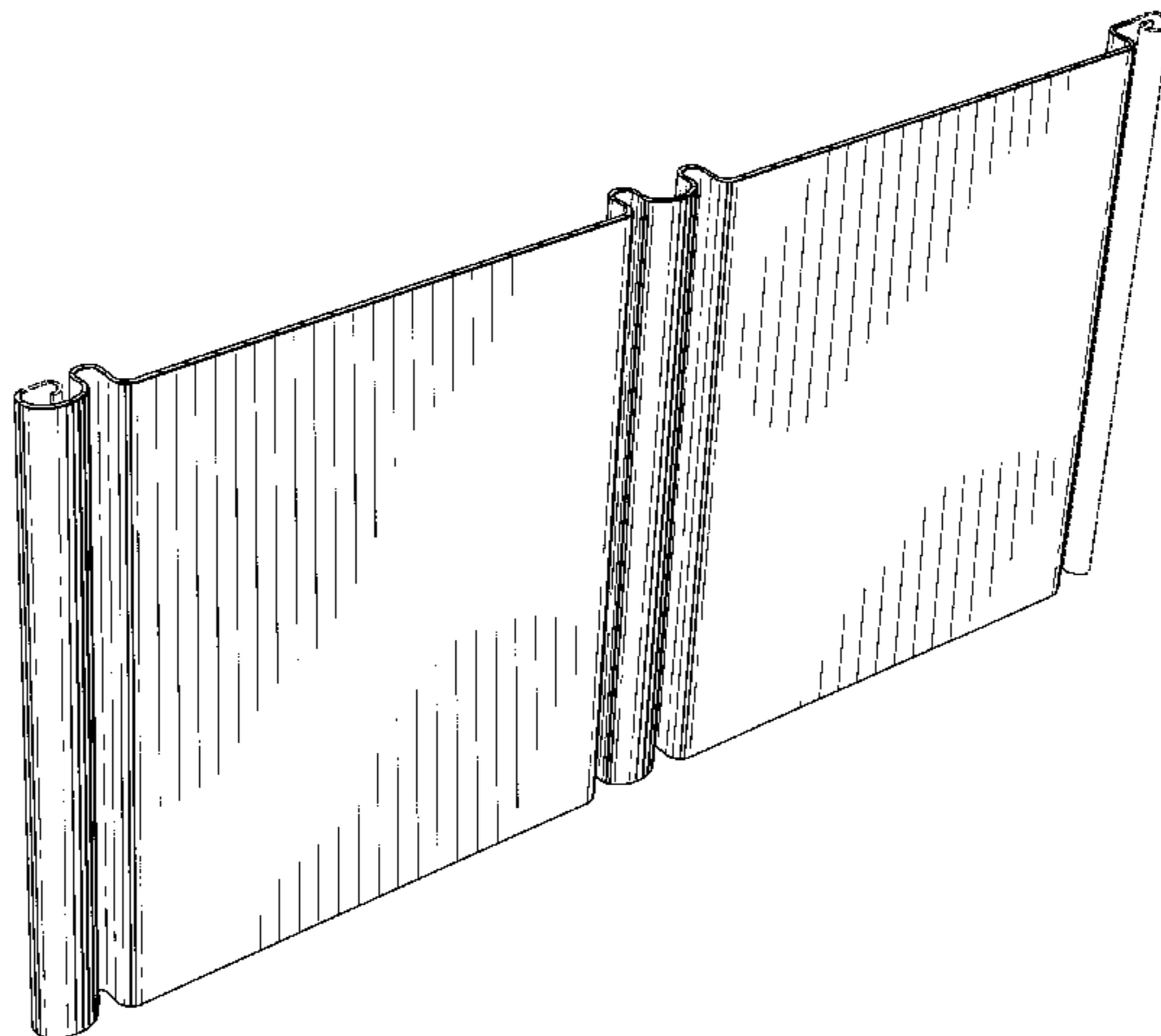
FIG. 22 is a right side elevational view thereof;

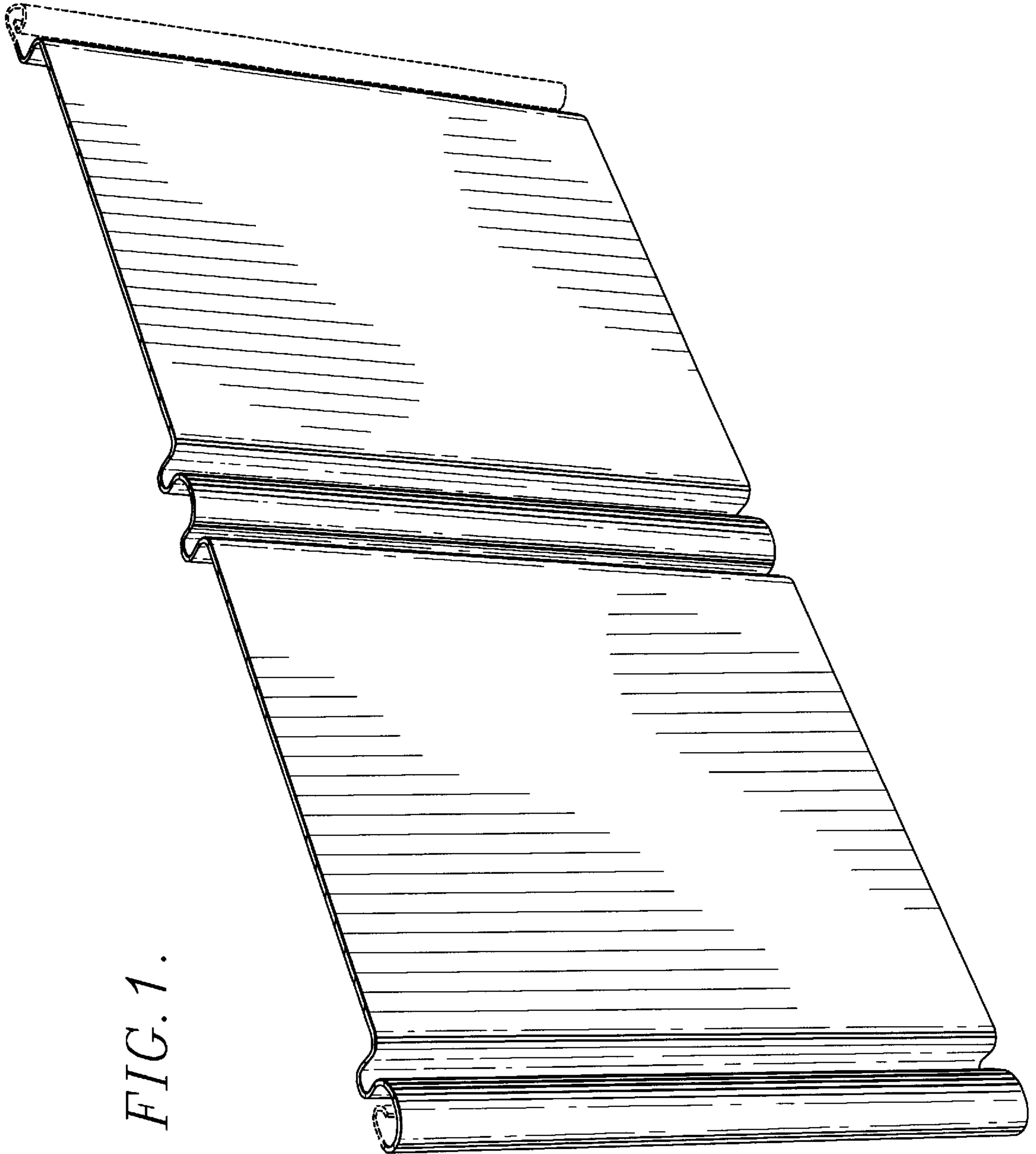


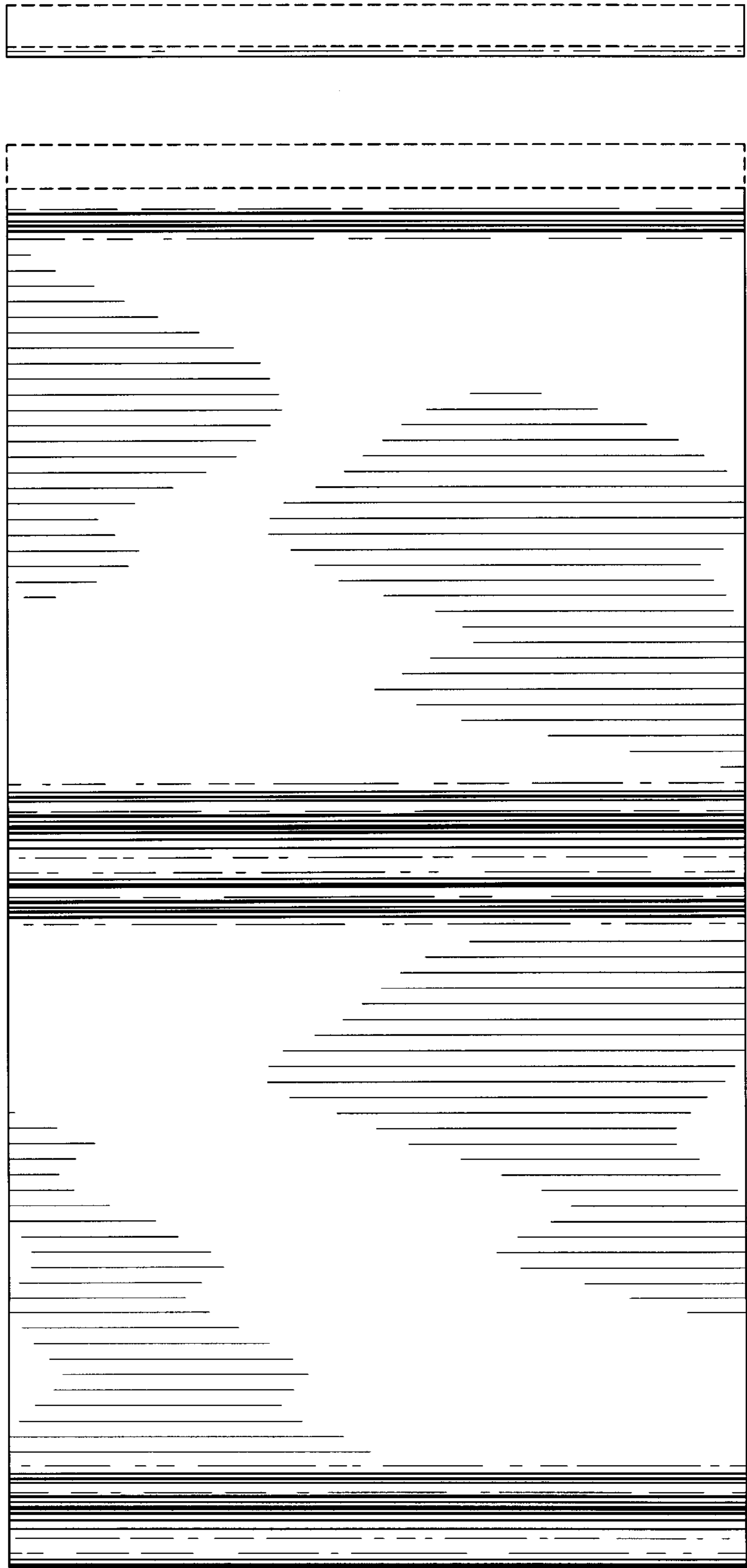

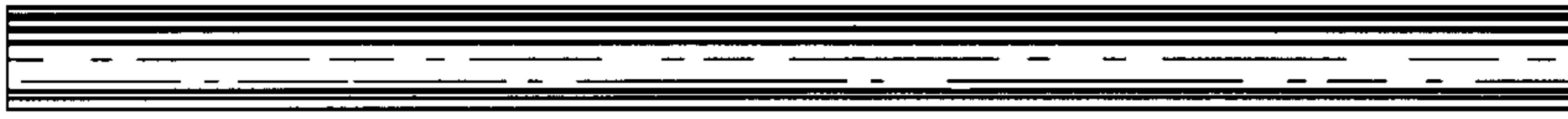

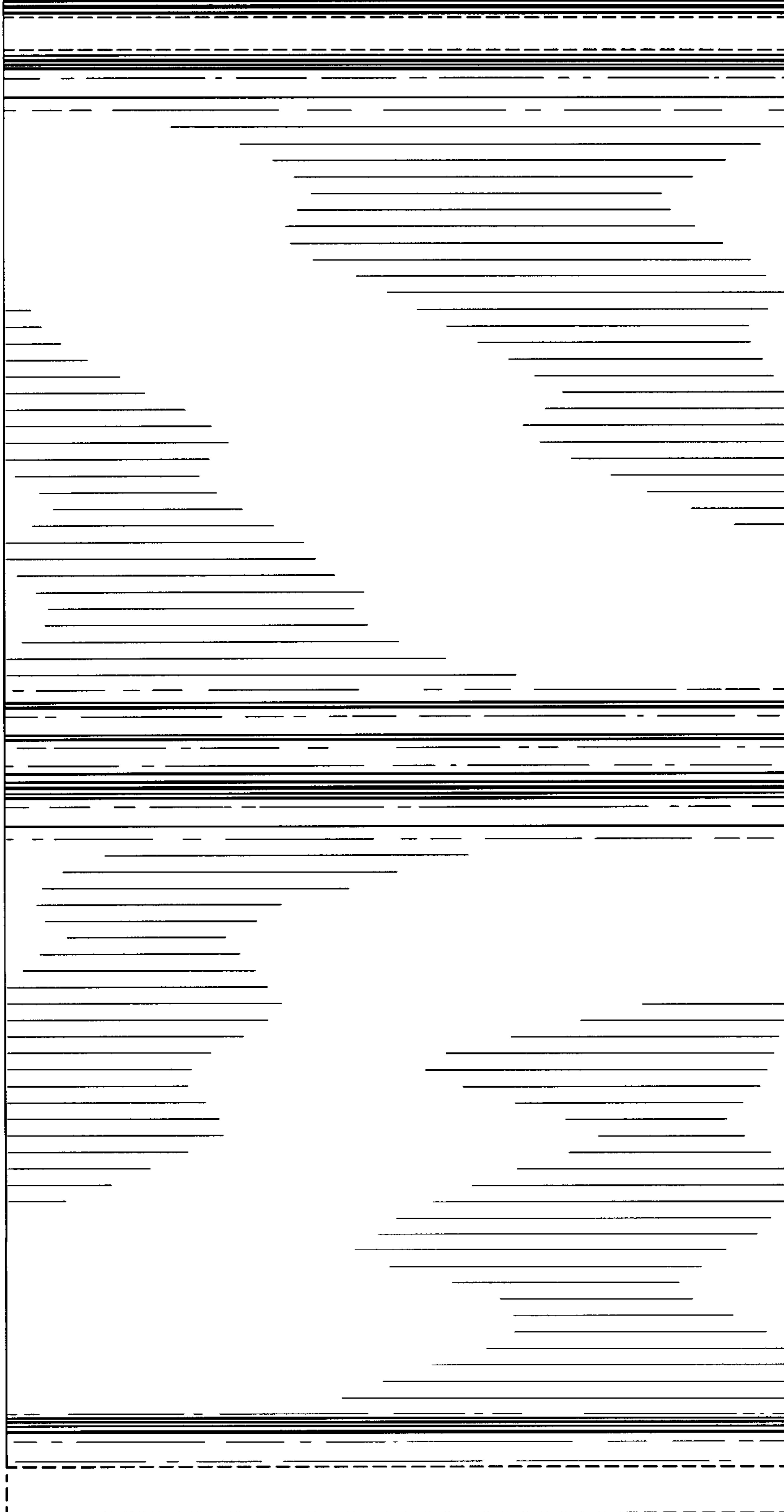

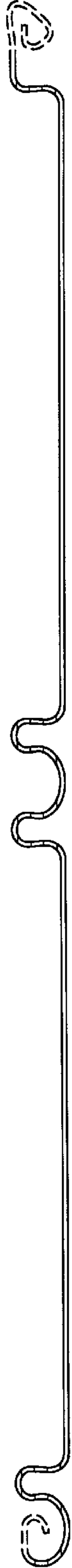
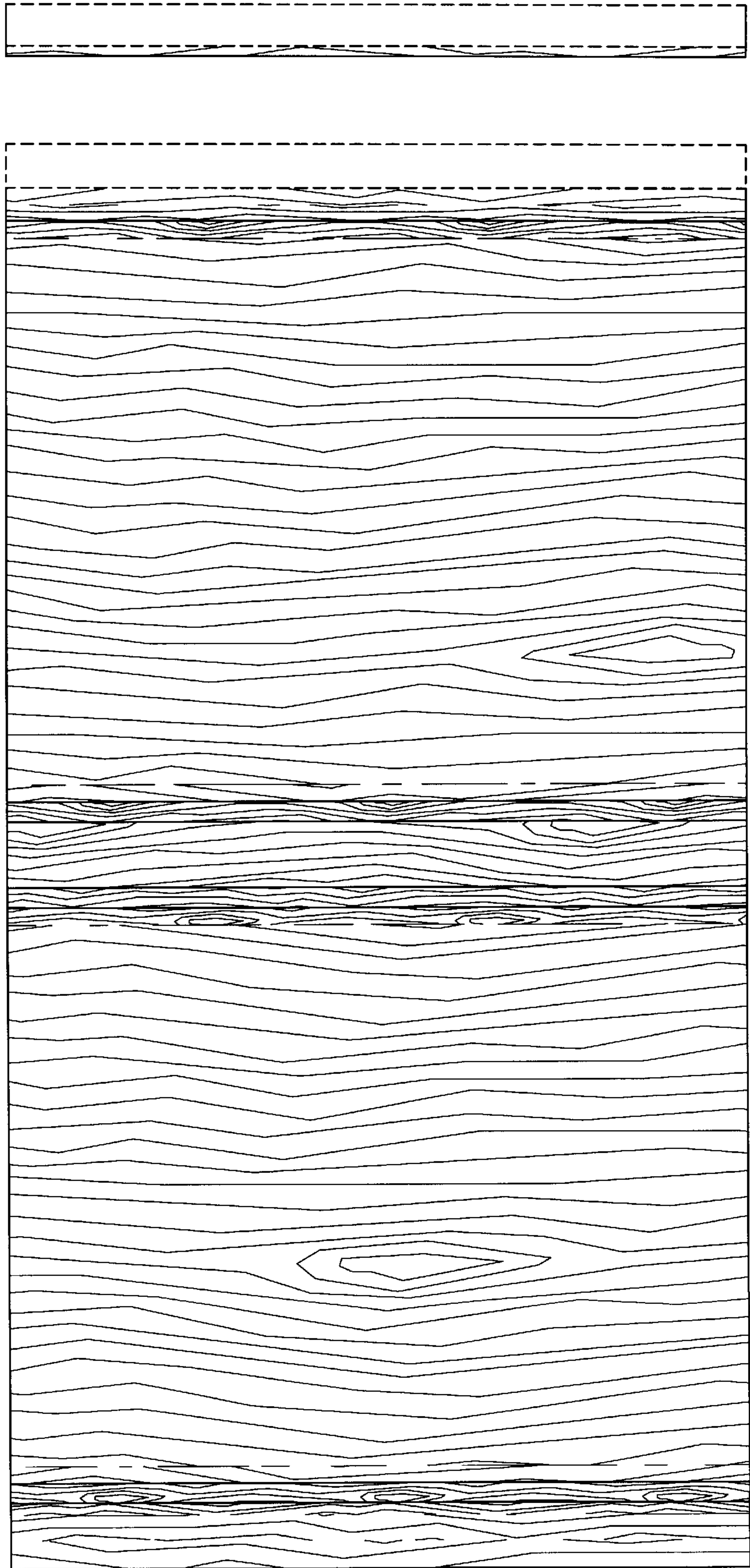

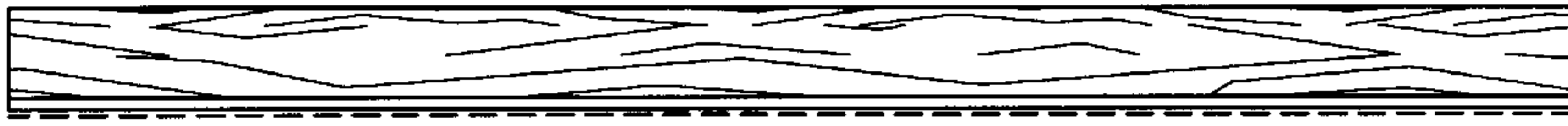

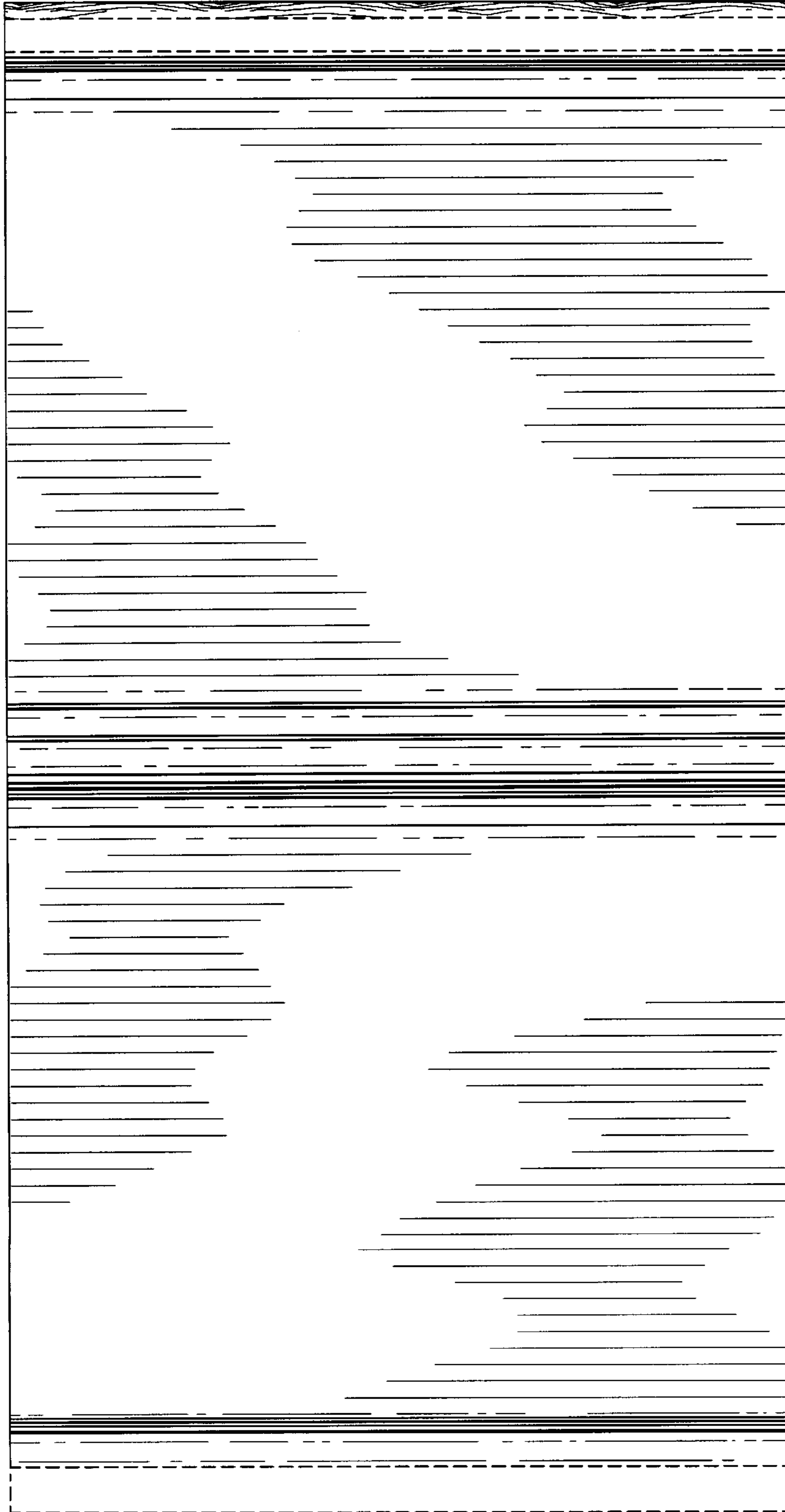

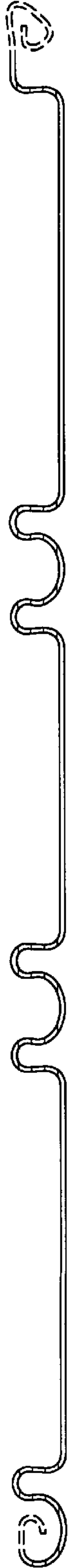
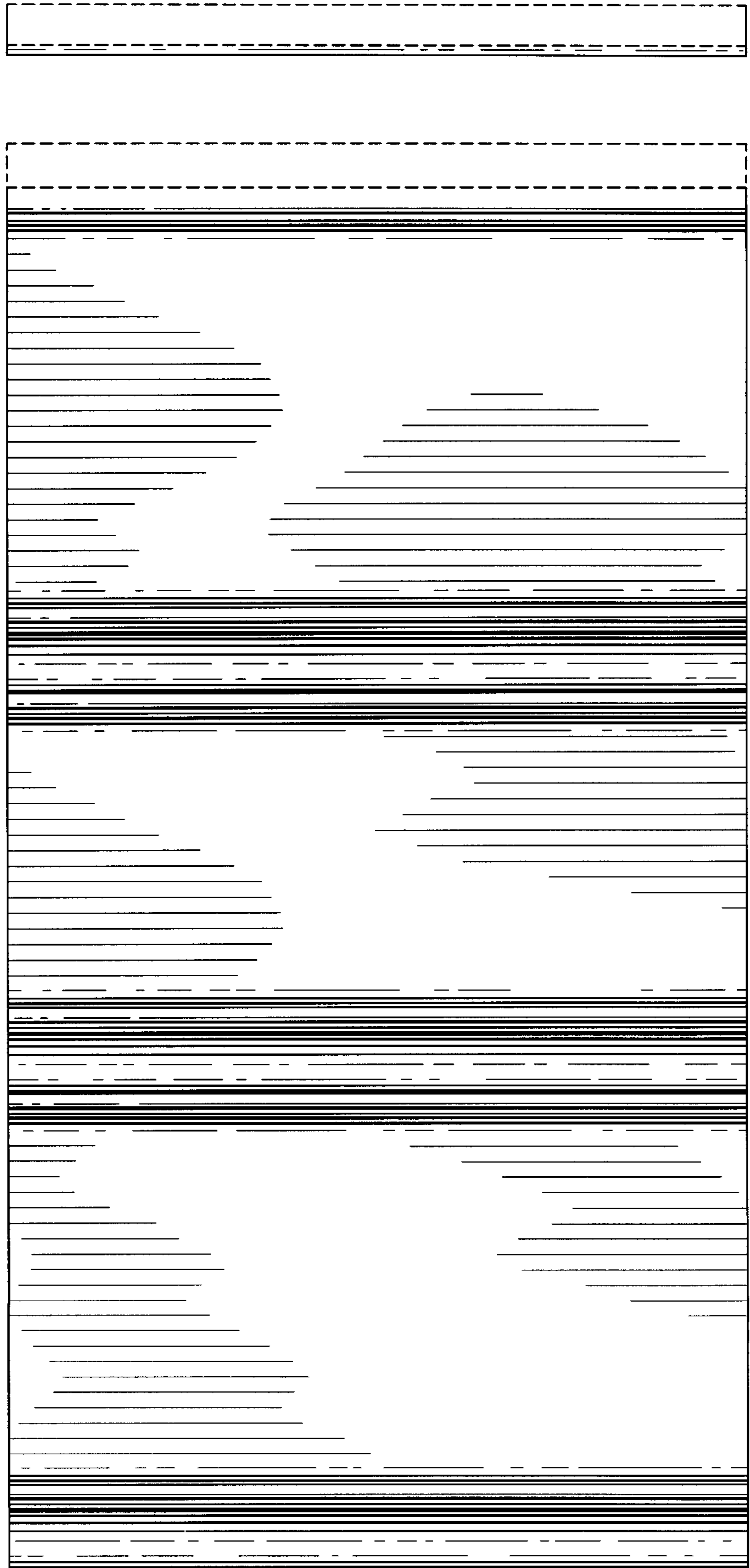

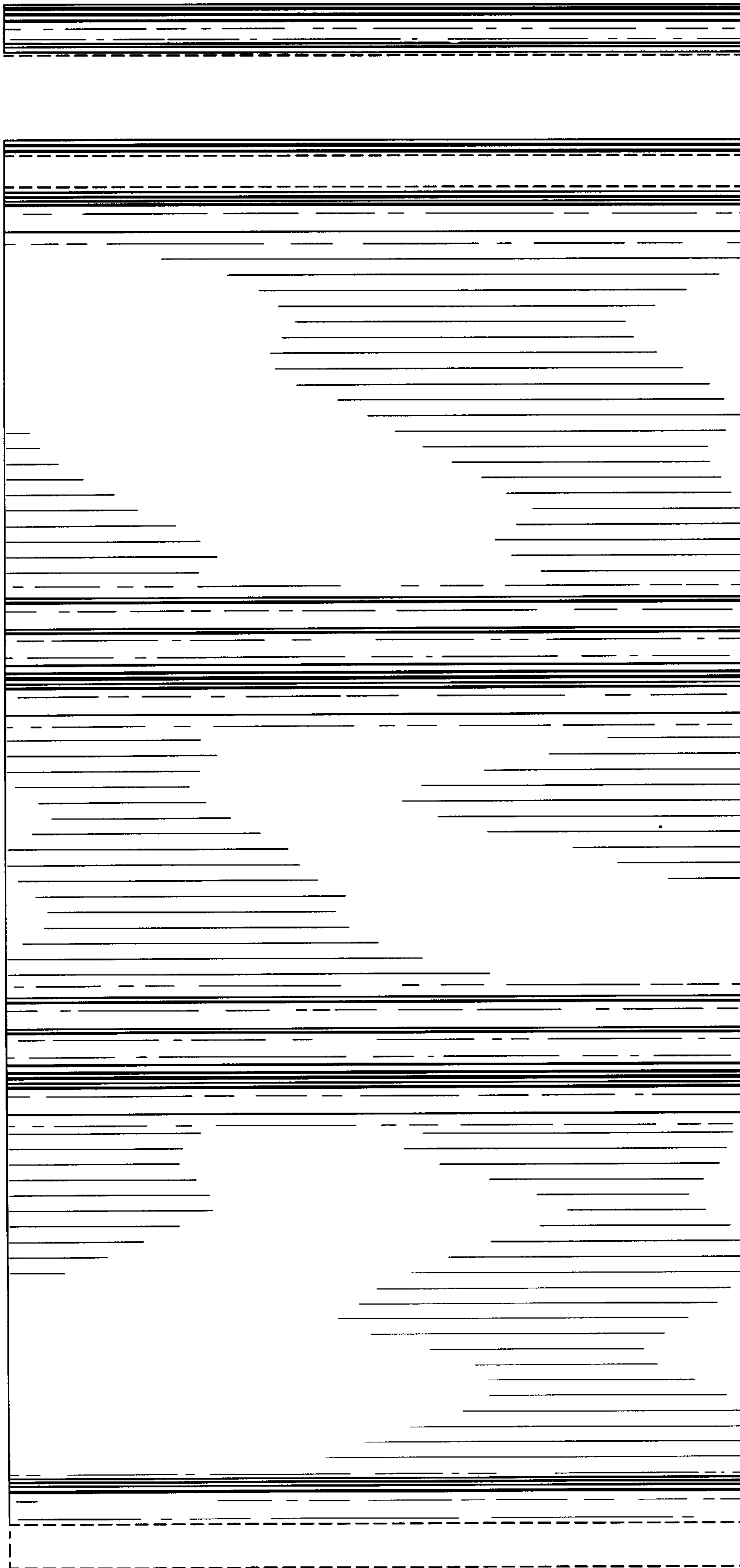

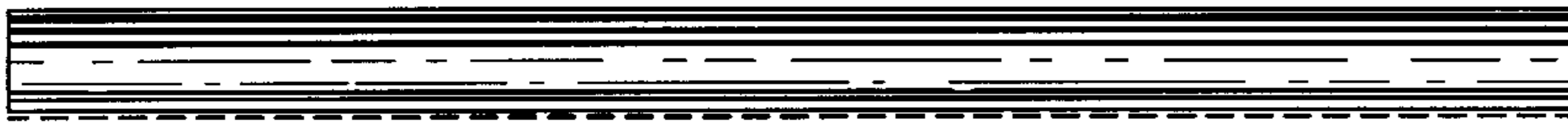

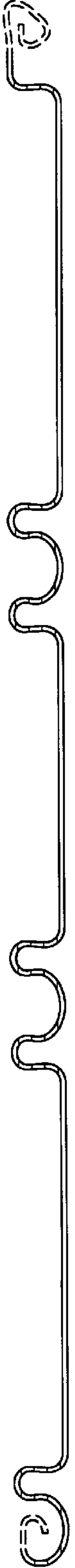
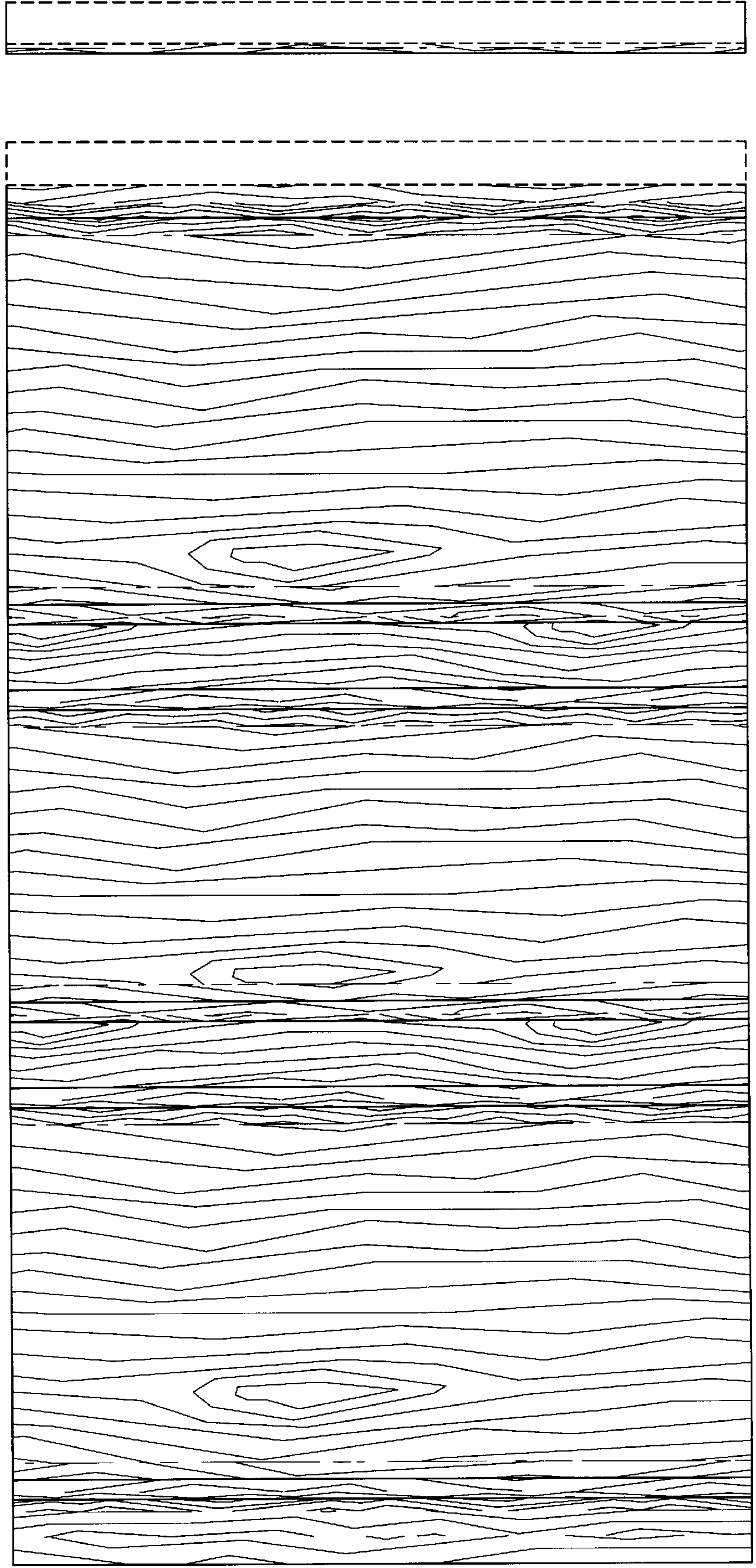

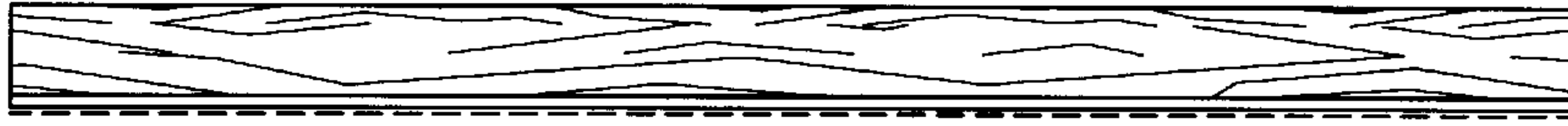

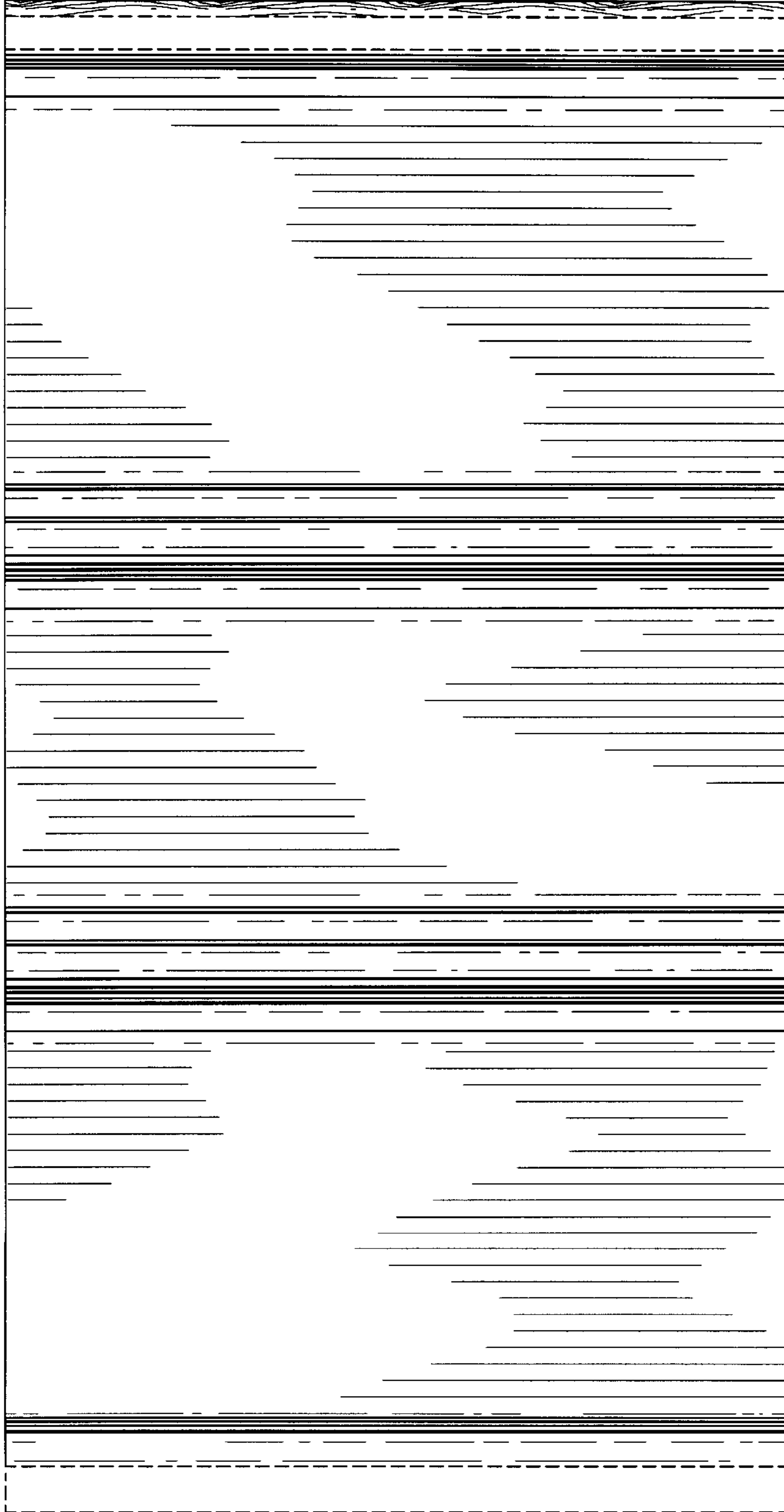
