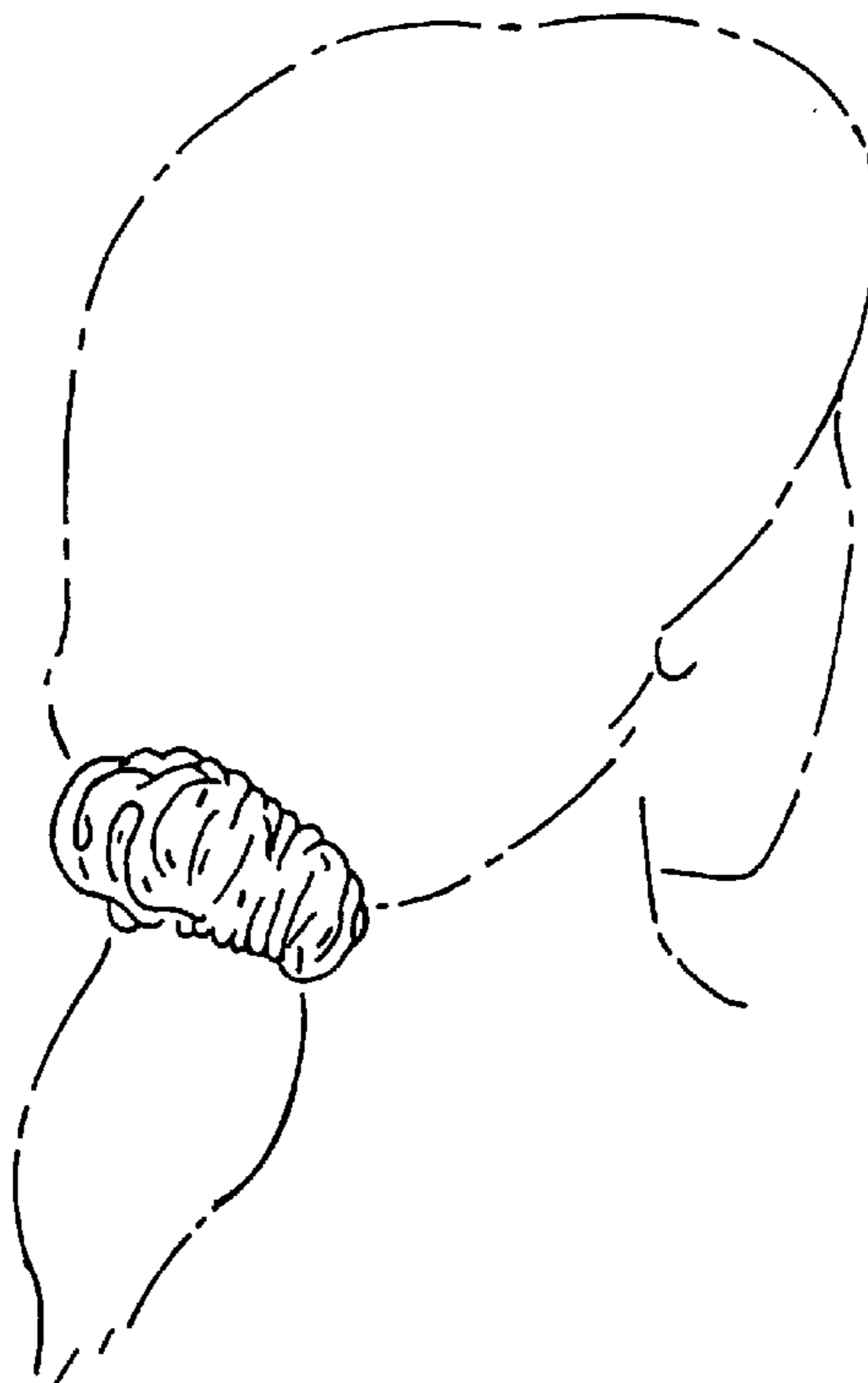
[57] **CLAIM**

The ornamental design for a hair band, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a decorative hair band showing my design, the broken lines showing the human form being for illustrative purposes only and forming no part of the claimed design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof, the right side being a mirror image thereto;
FIG. 4 is a rear side elevational view thereof; and,
FIG. 5 is a top plan view thereof, the bottom view being a mirror image thereto.

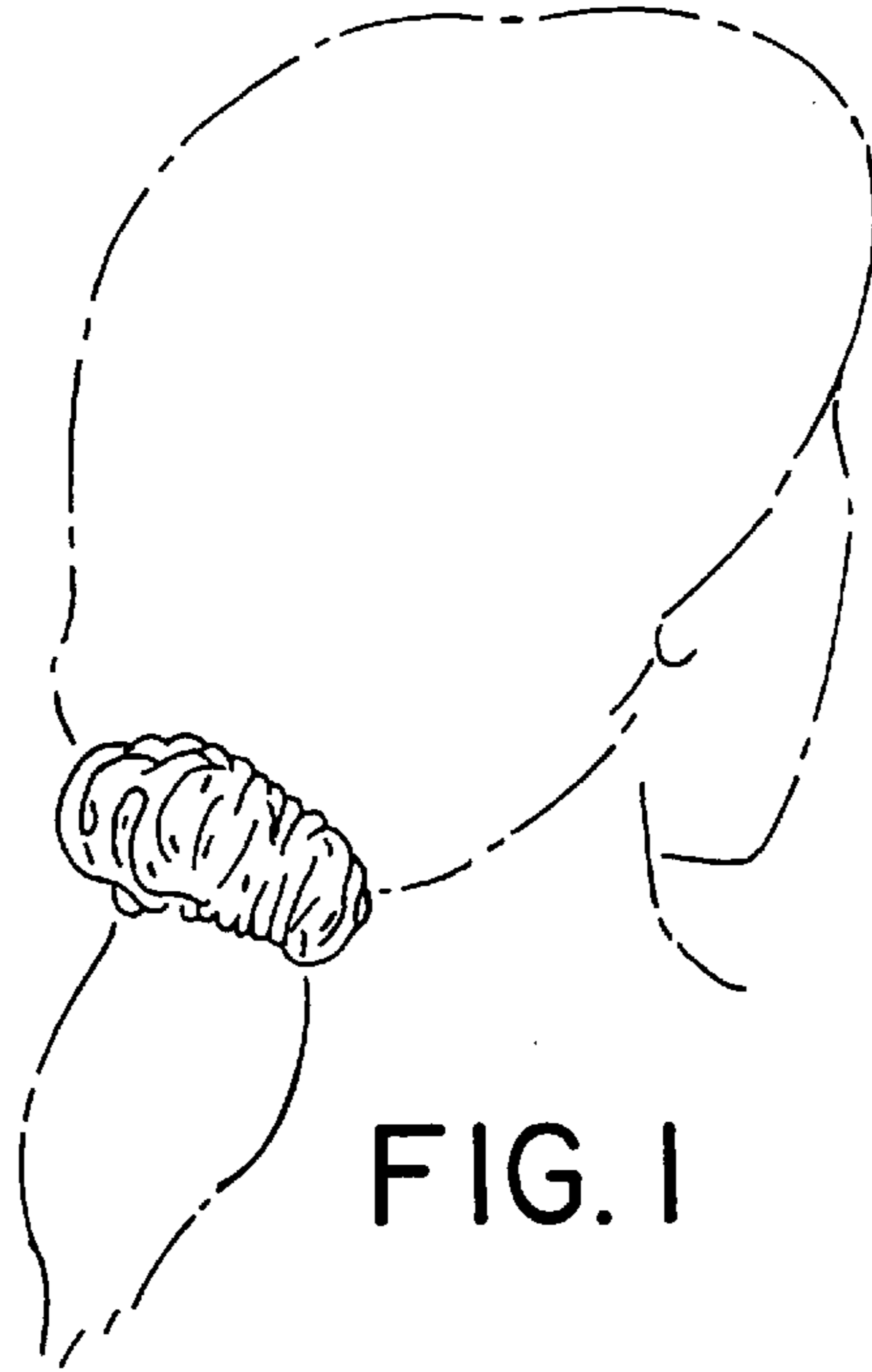

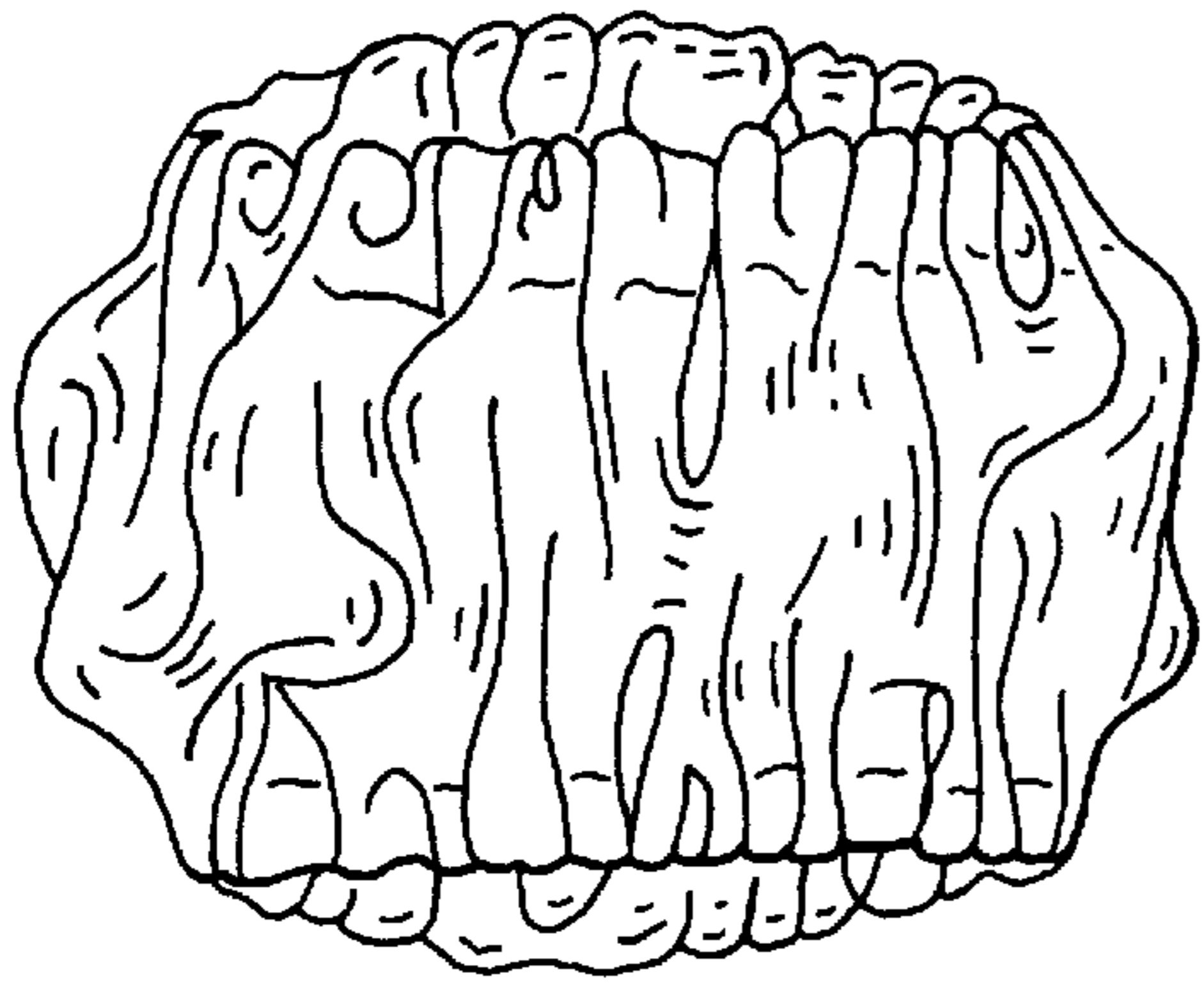

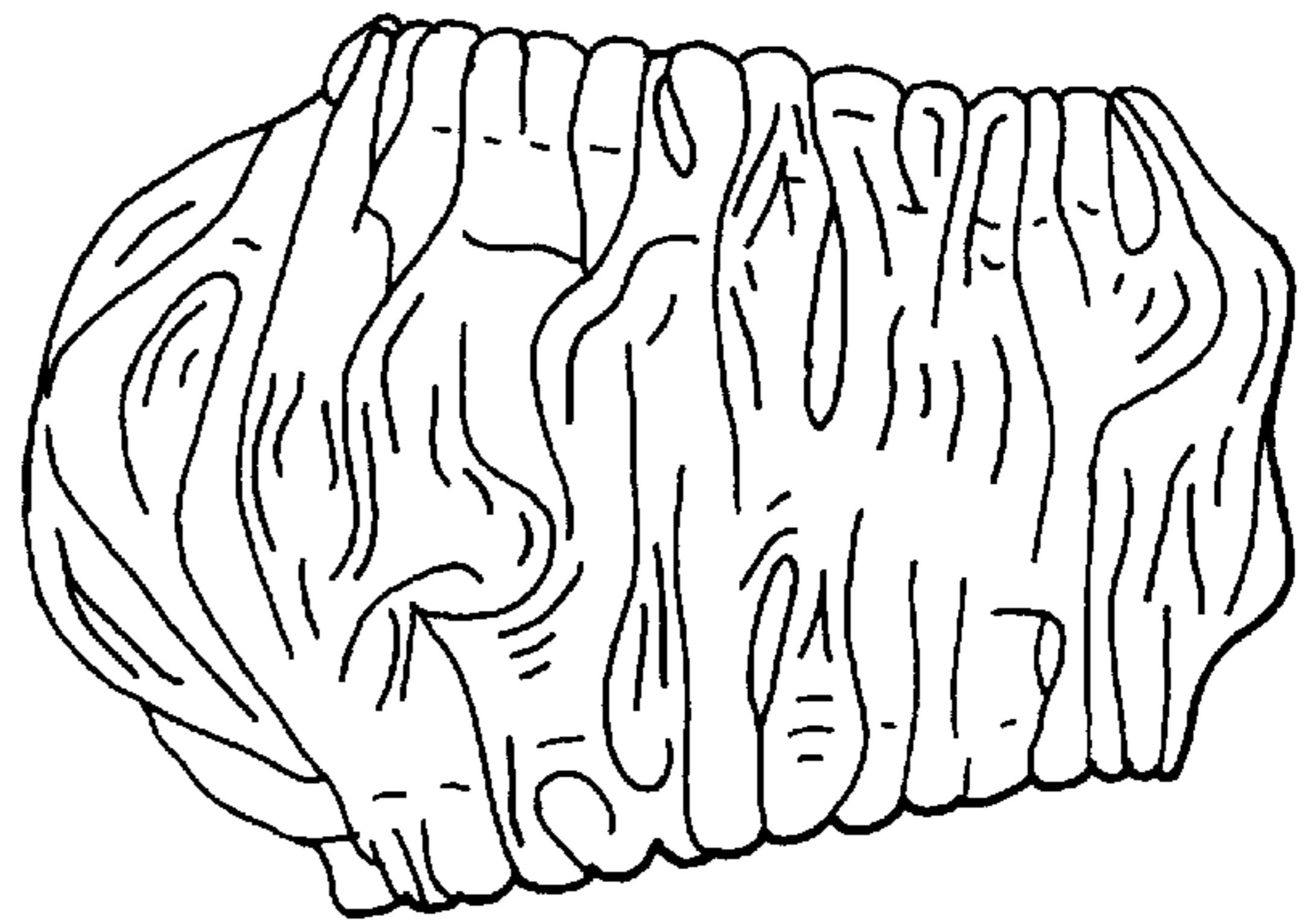

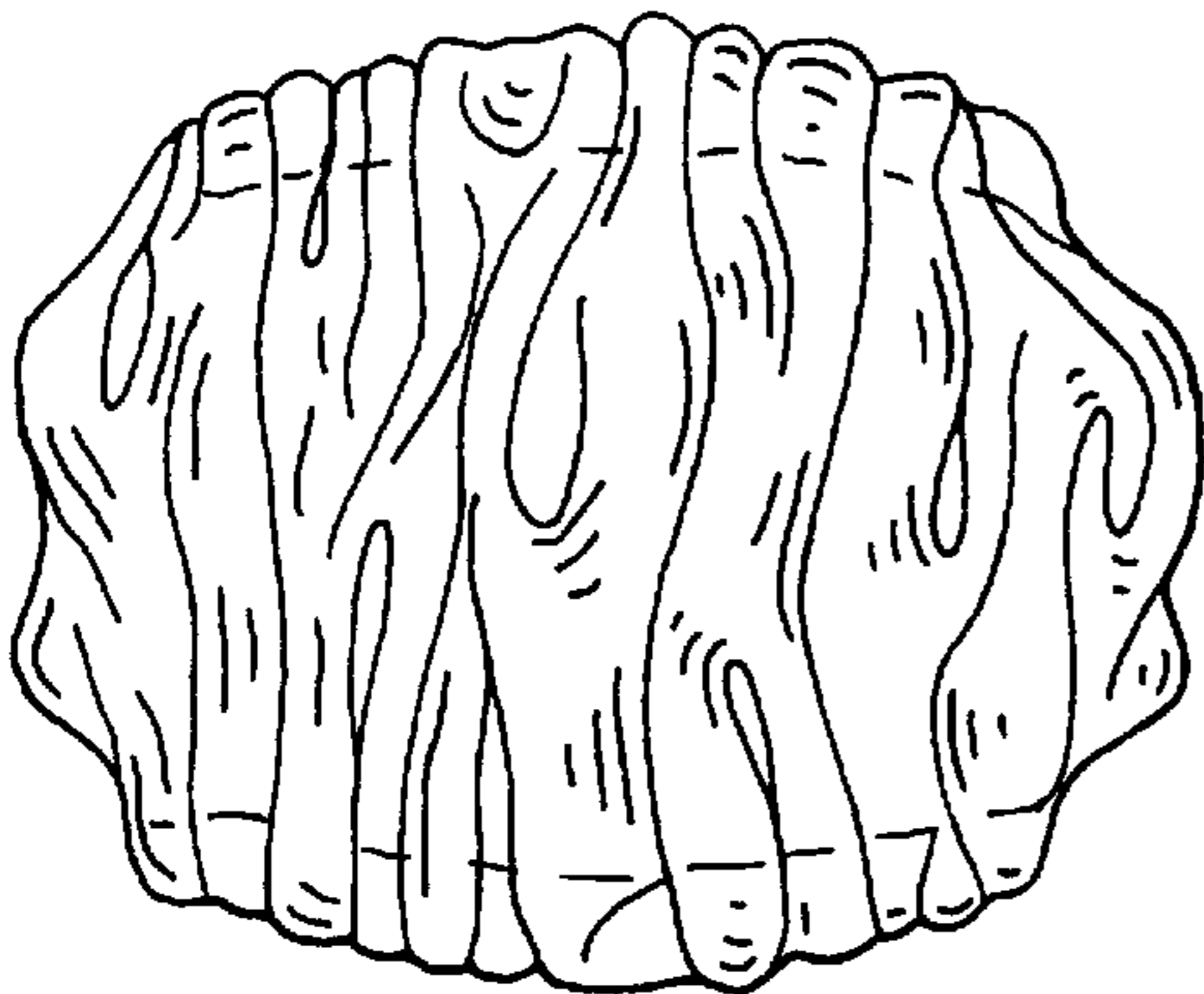
