[57] CLAIM

The ornamental design for a guard bar, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right perspective view of the guard bar, the undisclosed left end being a mirror image of the right end shown;
FIG. 2 is a perspective view of the guard bar in place on a razor head;
FIG. 3 is a side view thereof;
FIG. 4 is a top view thereof; and
FIG. 5 is a frontal view thereof.
The broken line showing of the razor head is for illustrative purposes only and forms no part of the claimed design.

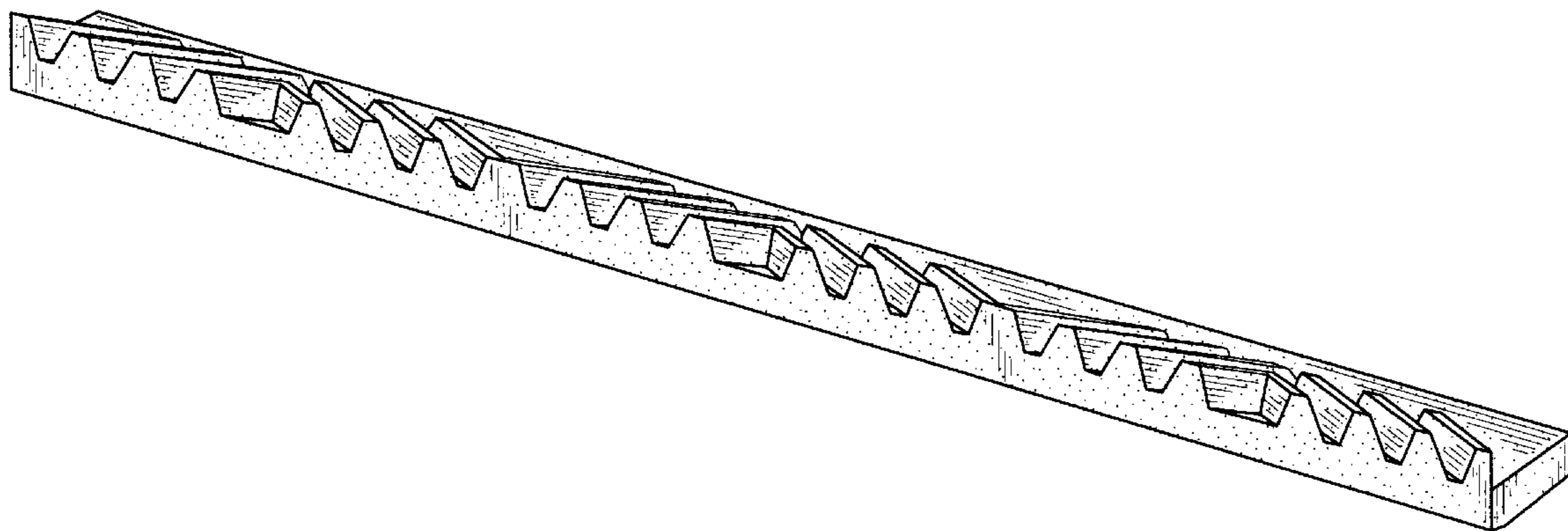

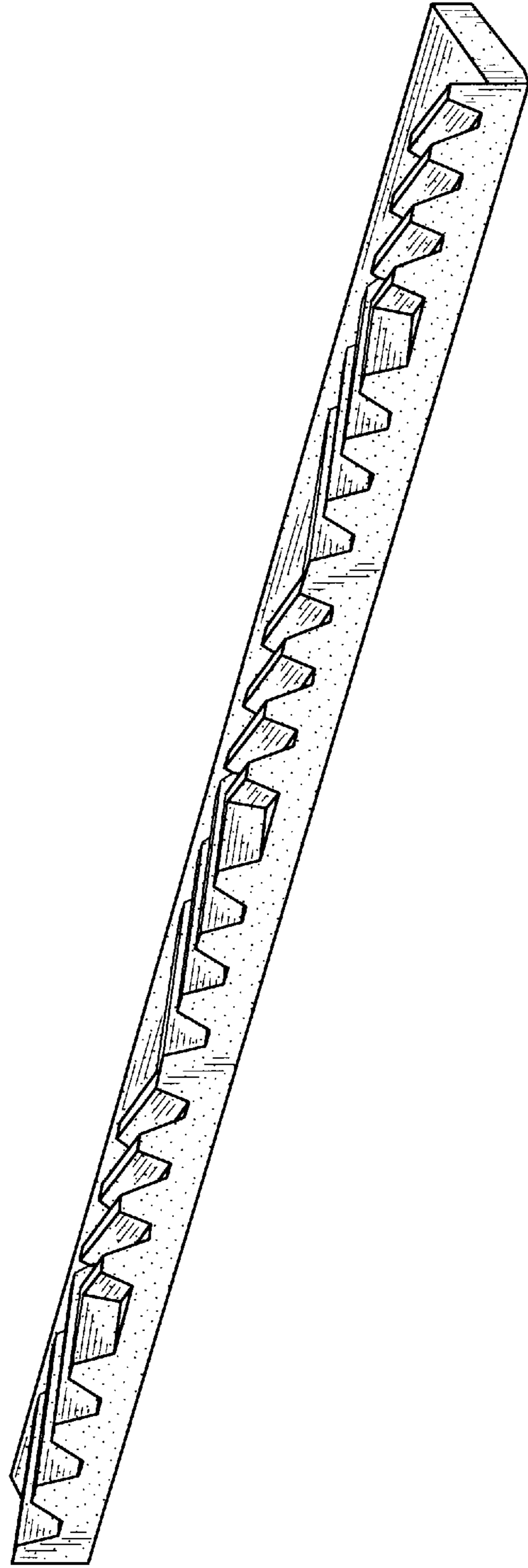

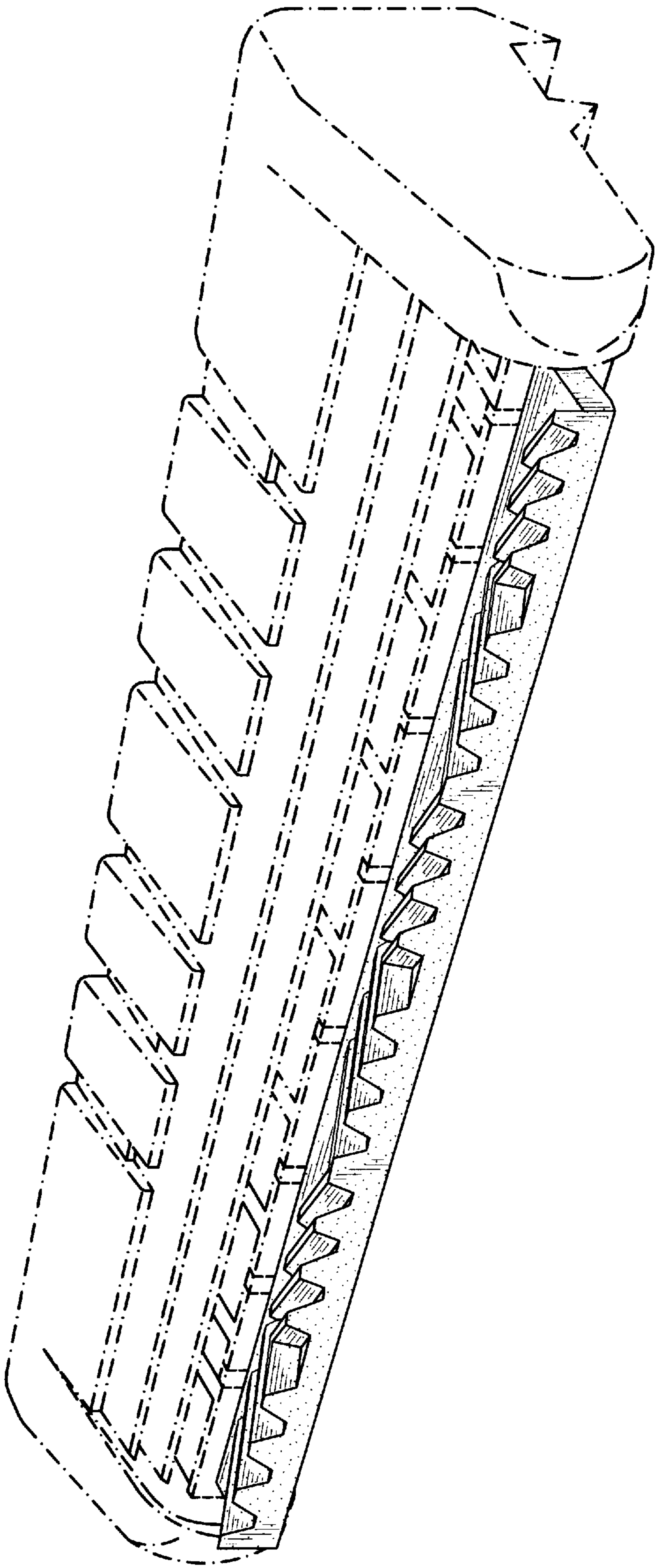

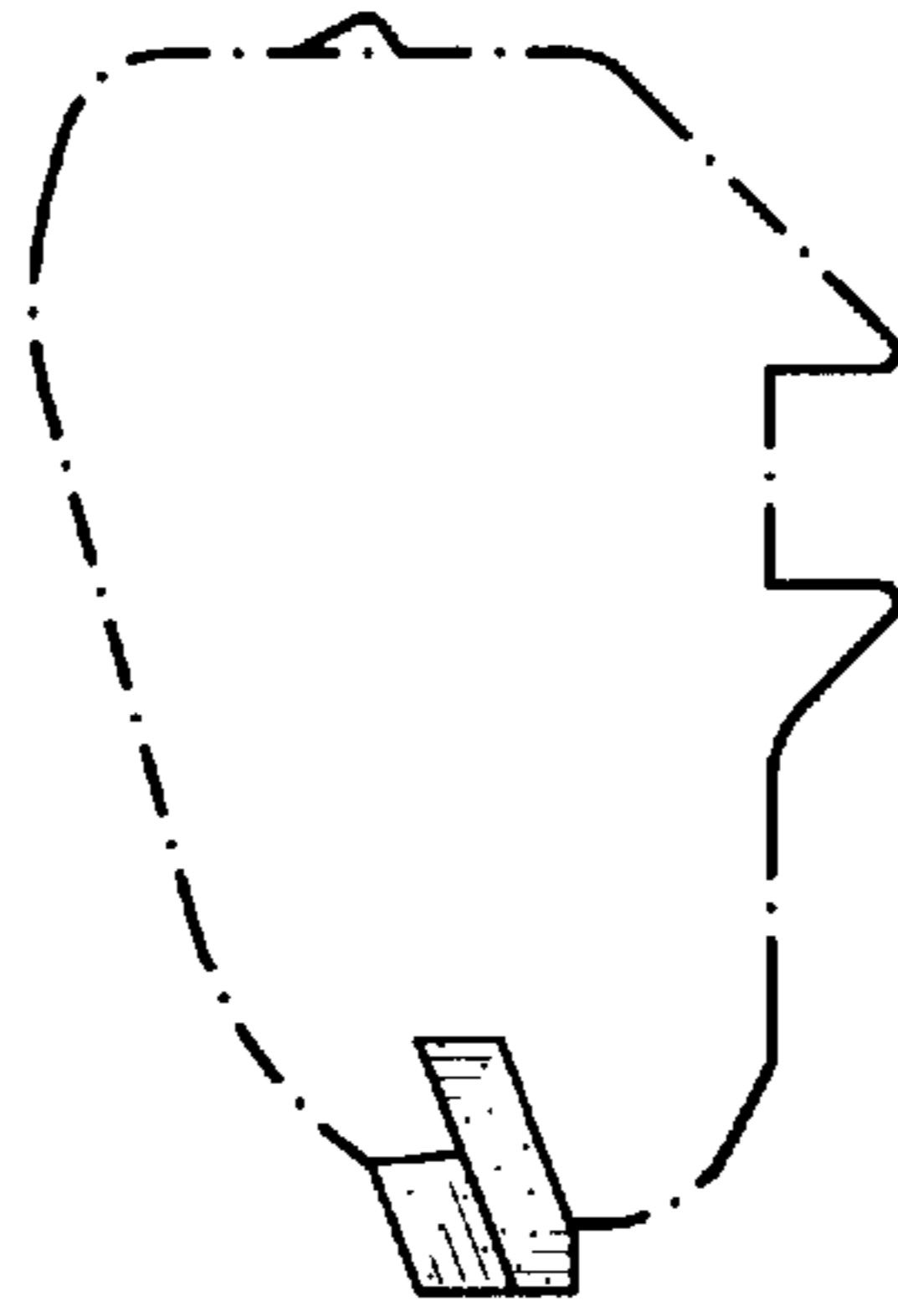

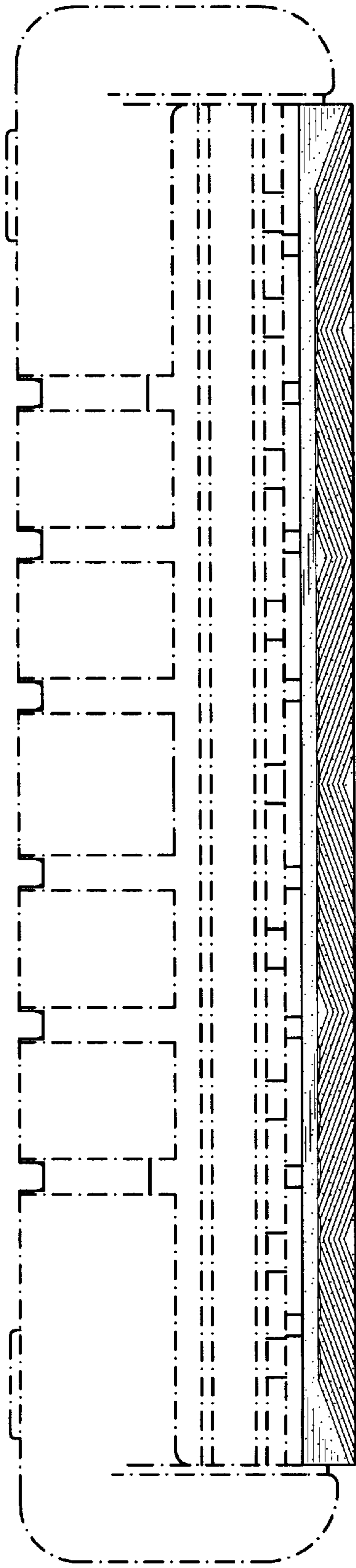
