FIG. 2 is a front plan view thereof;

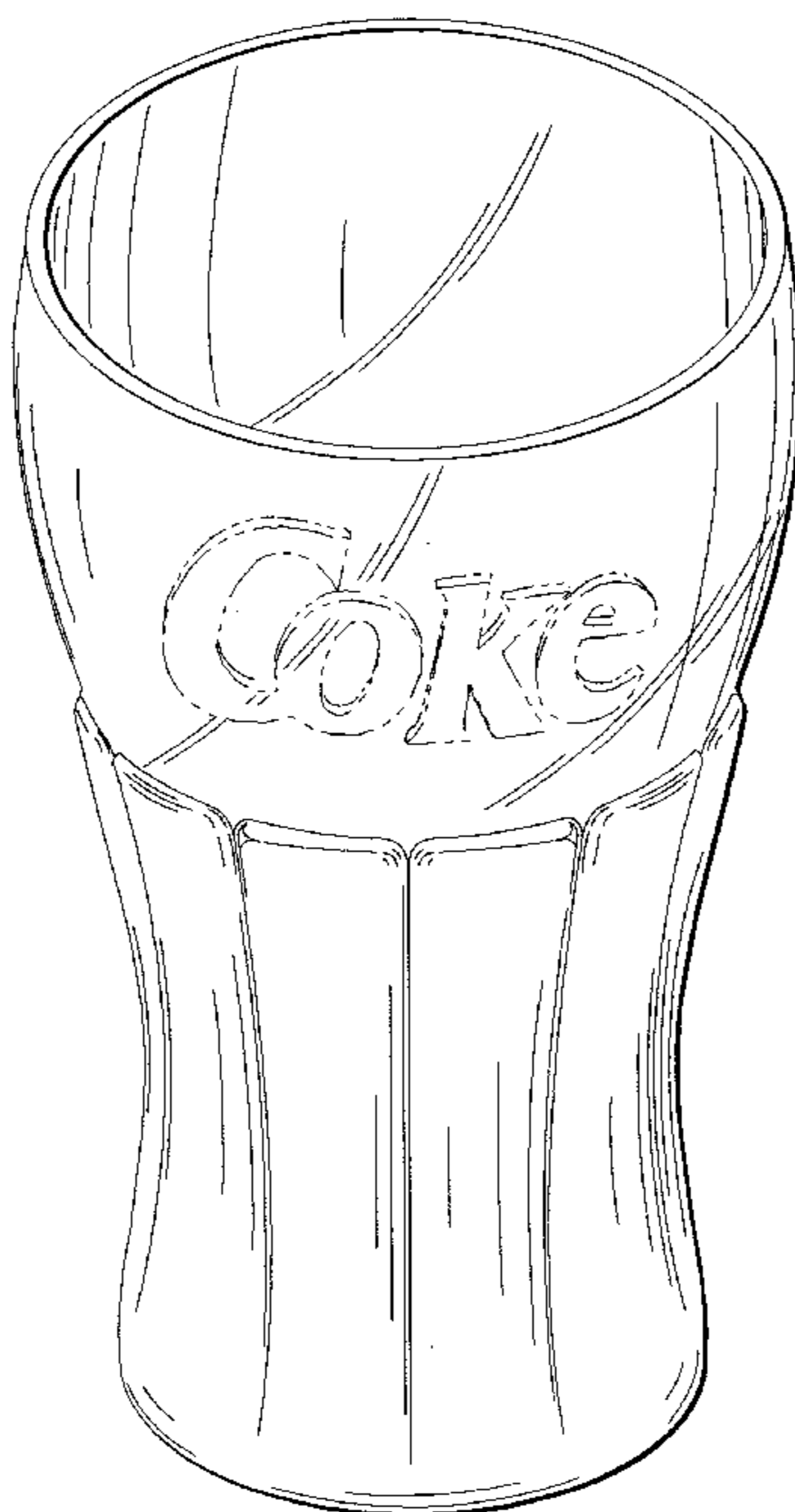
FIG. 3 is a rear plan view thereof;

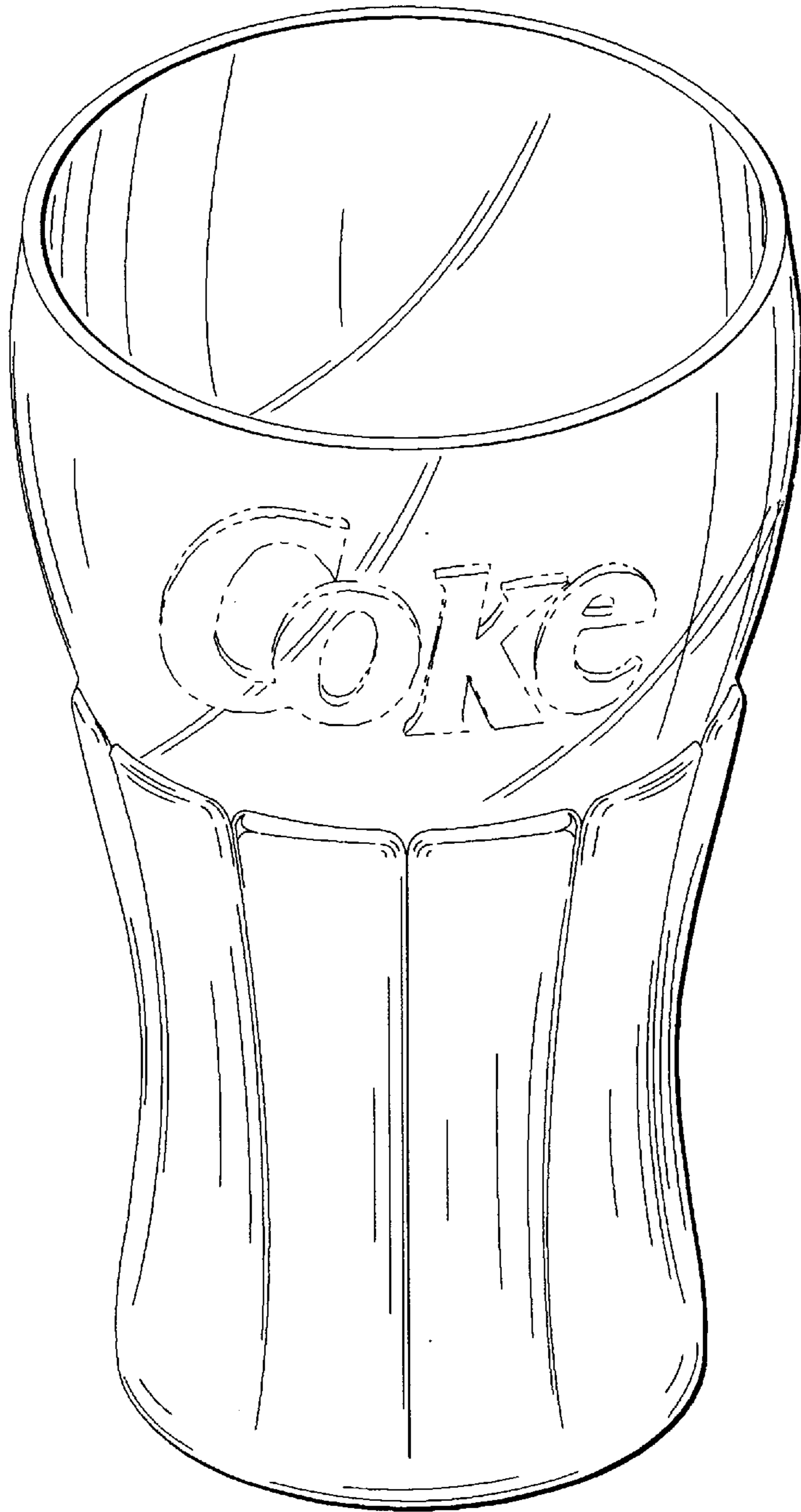

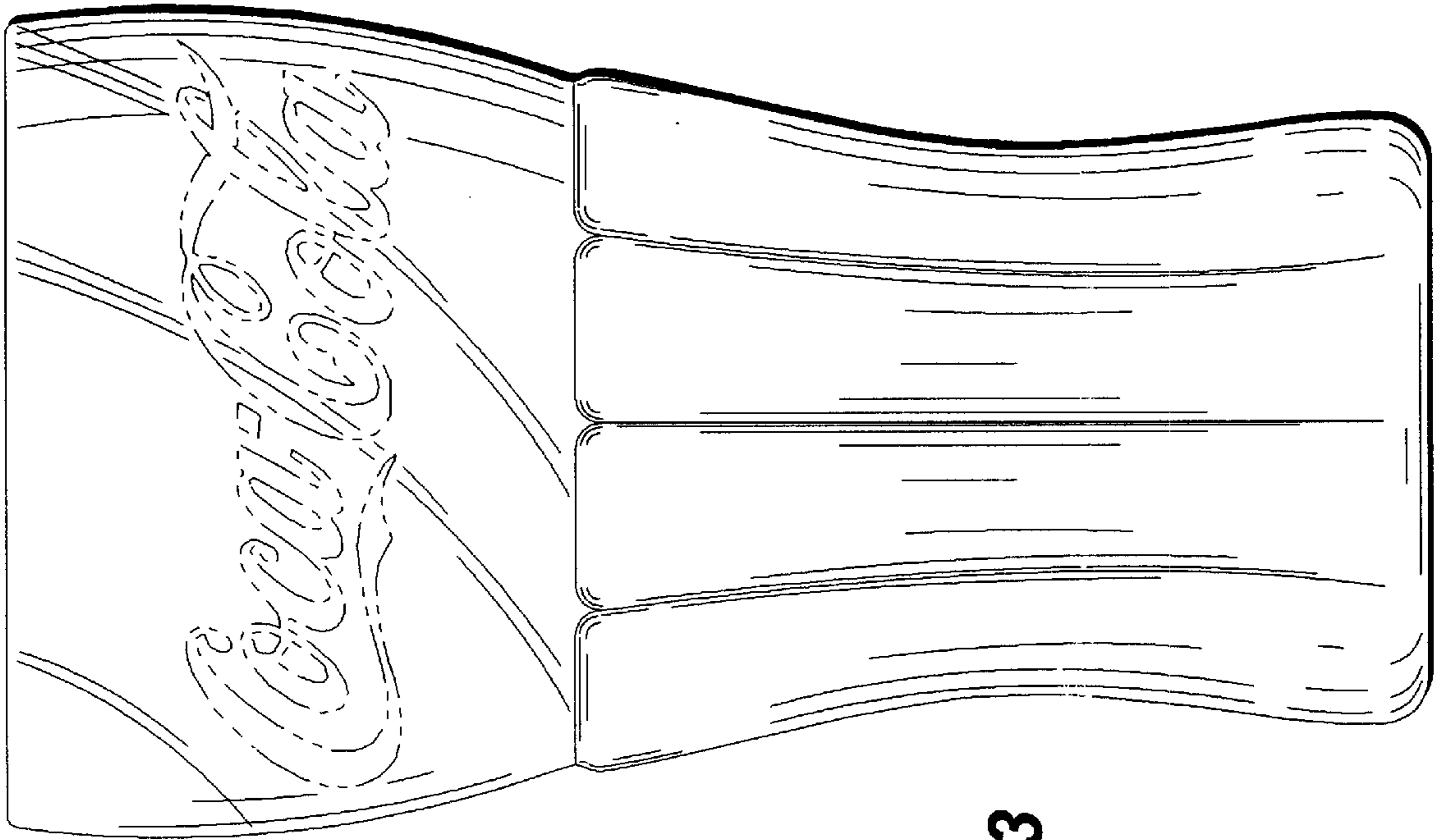

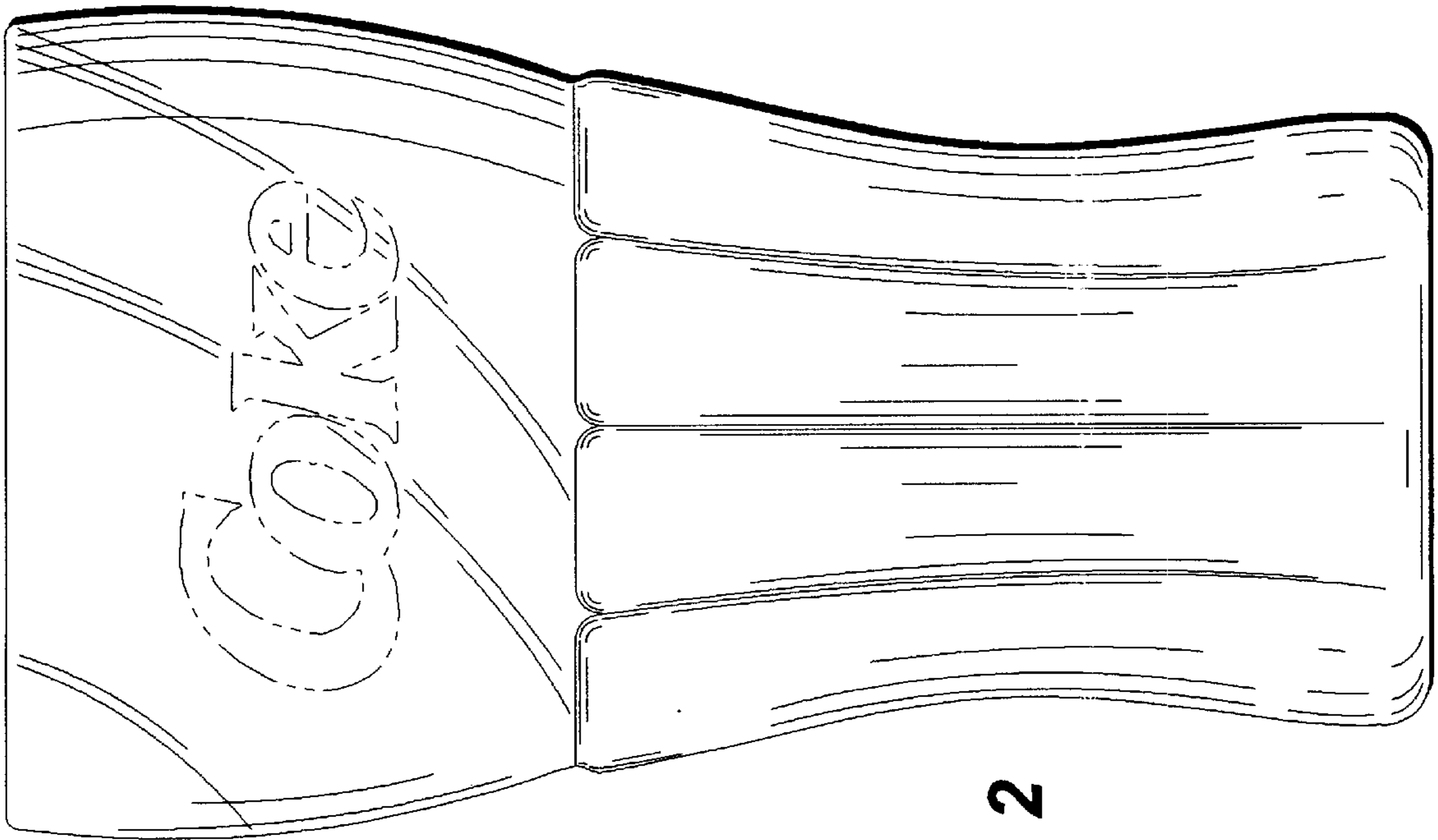

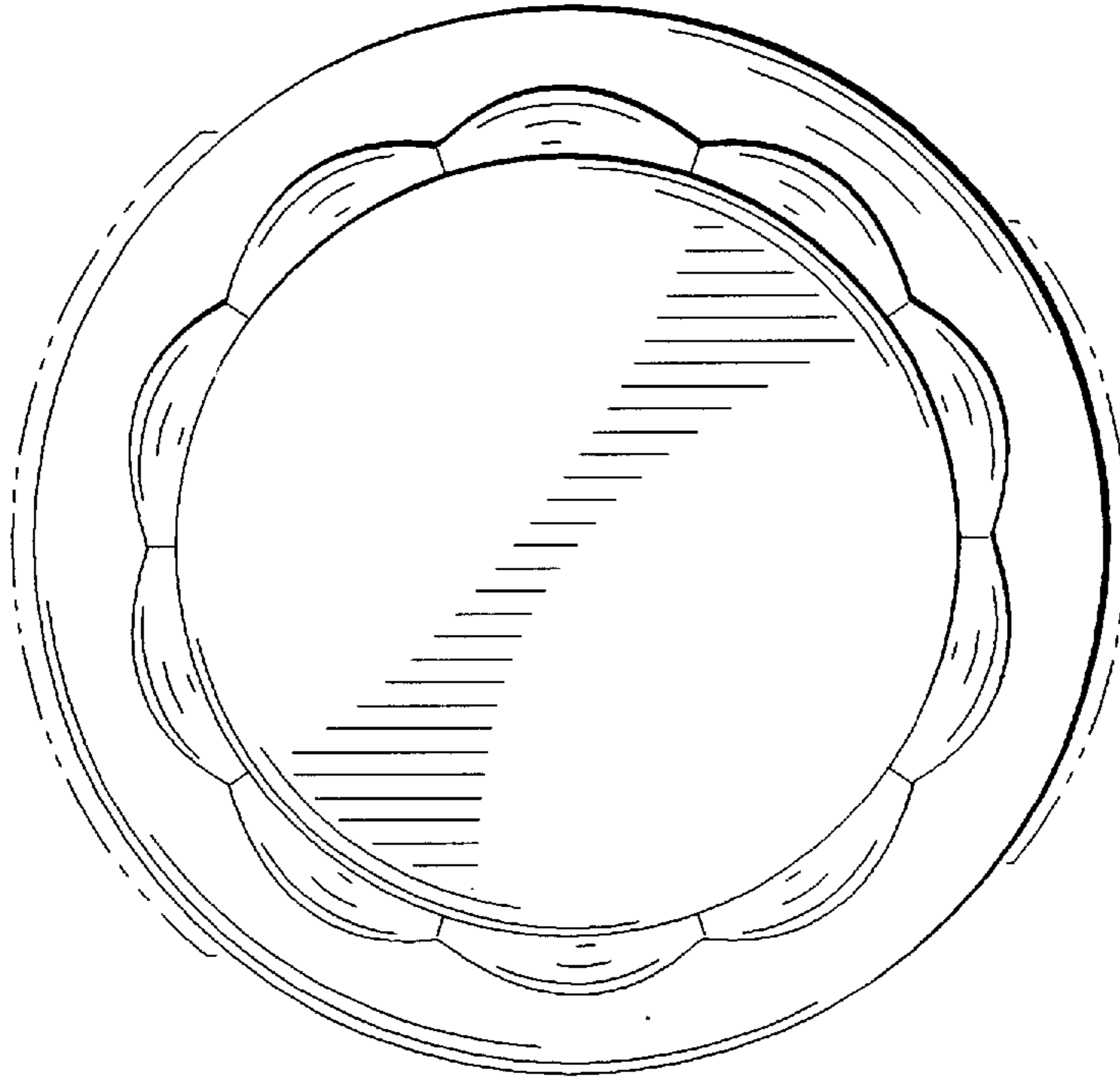

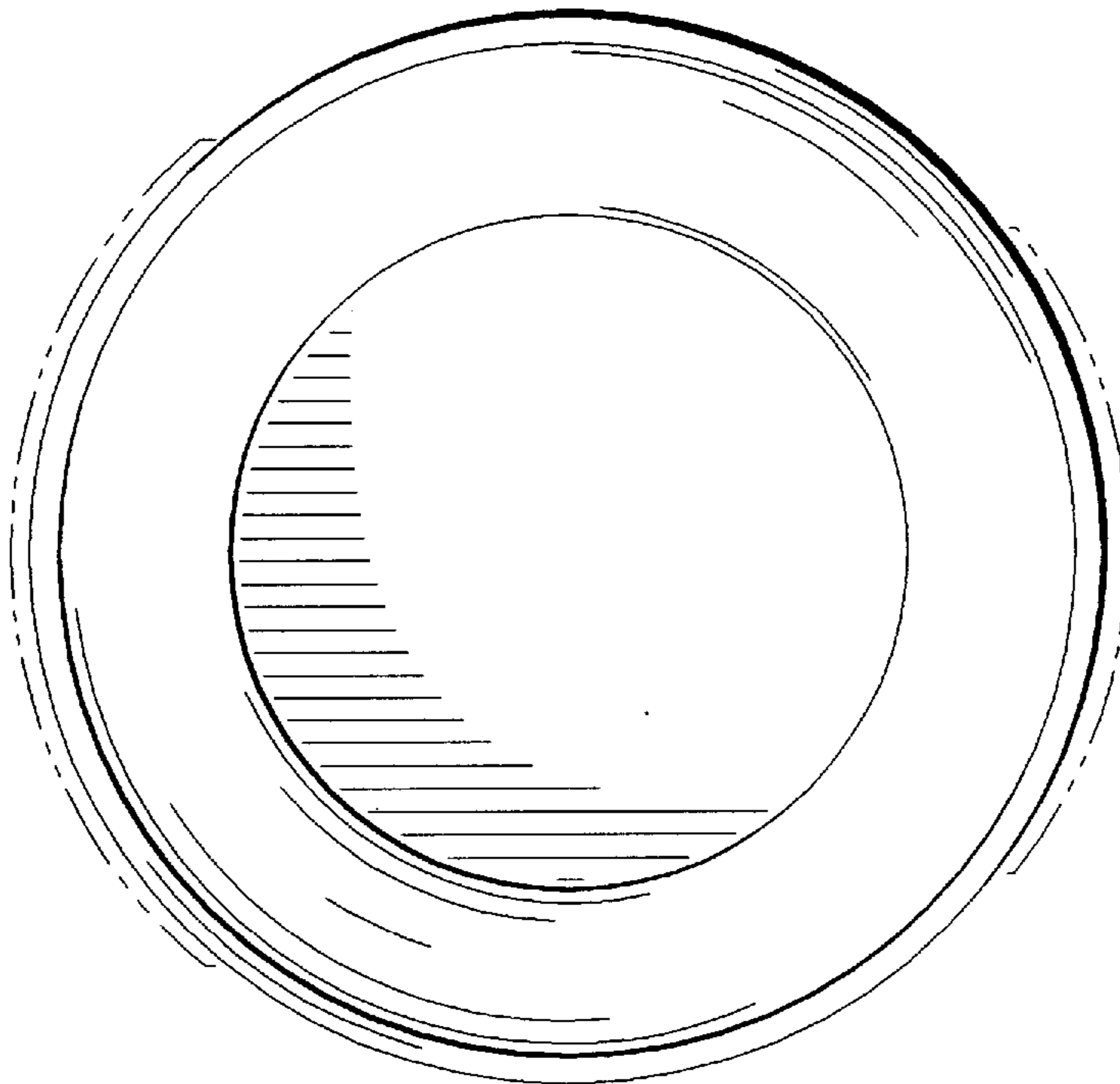
