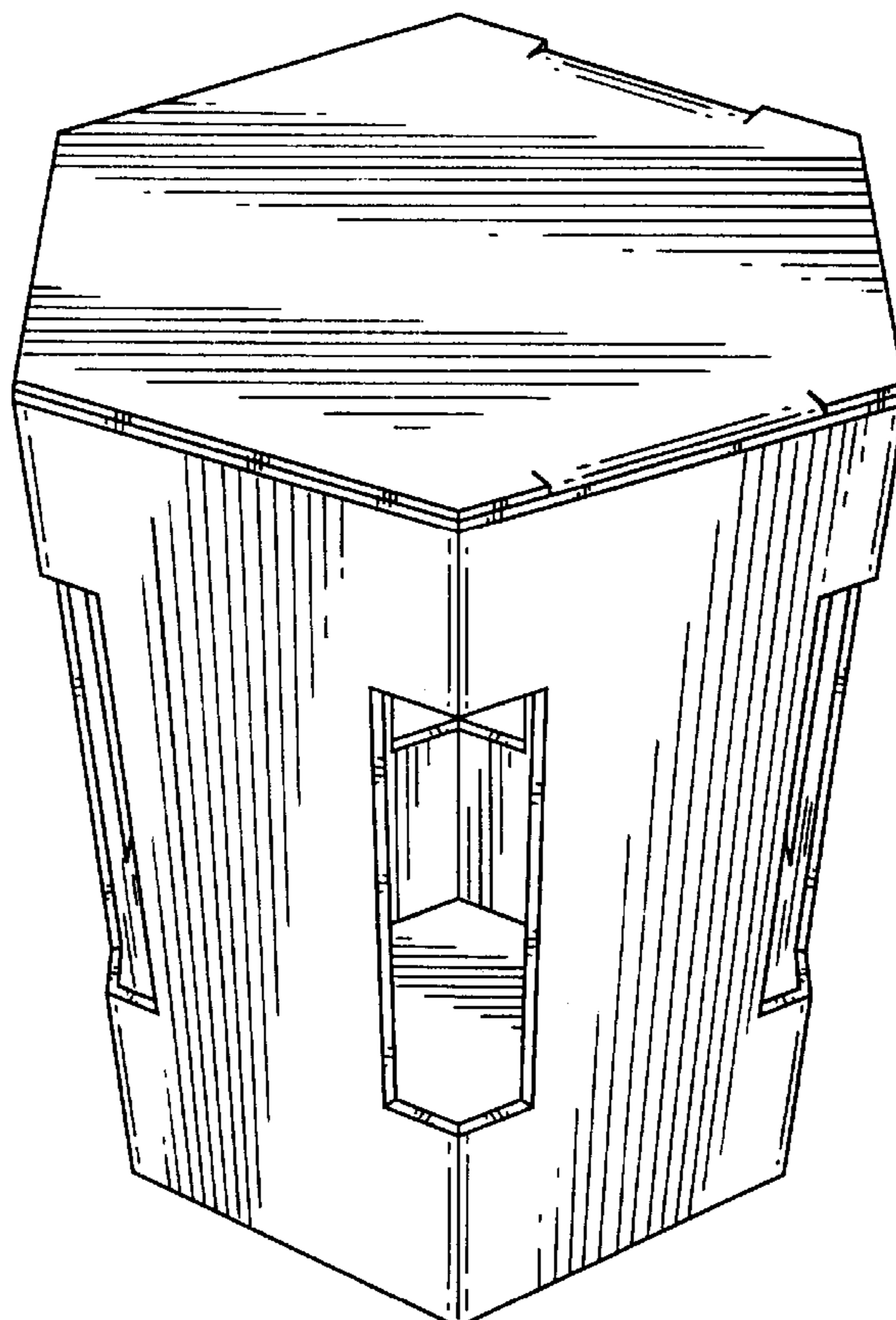

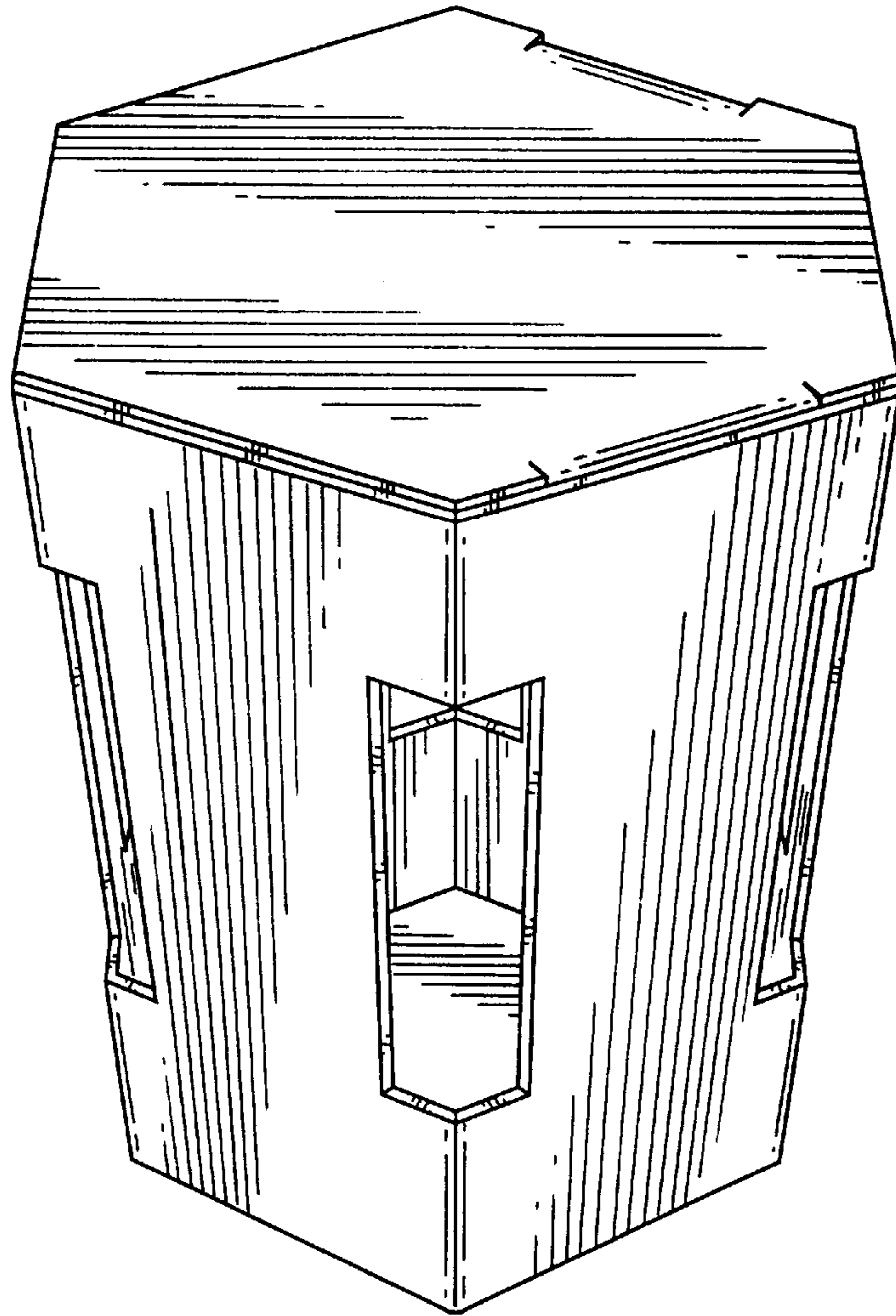

**DESCRIPTION**

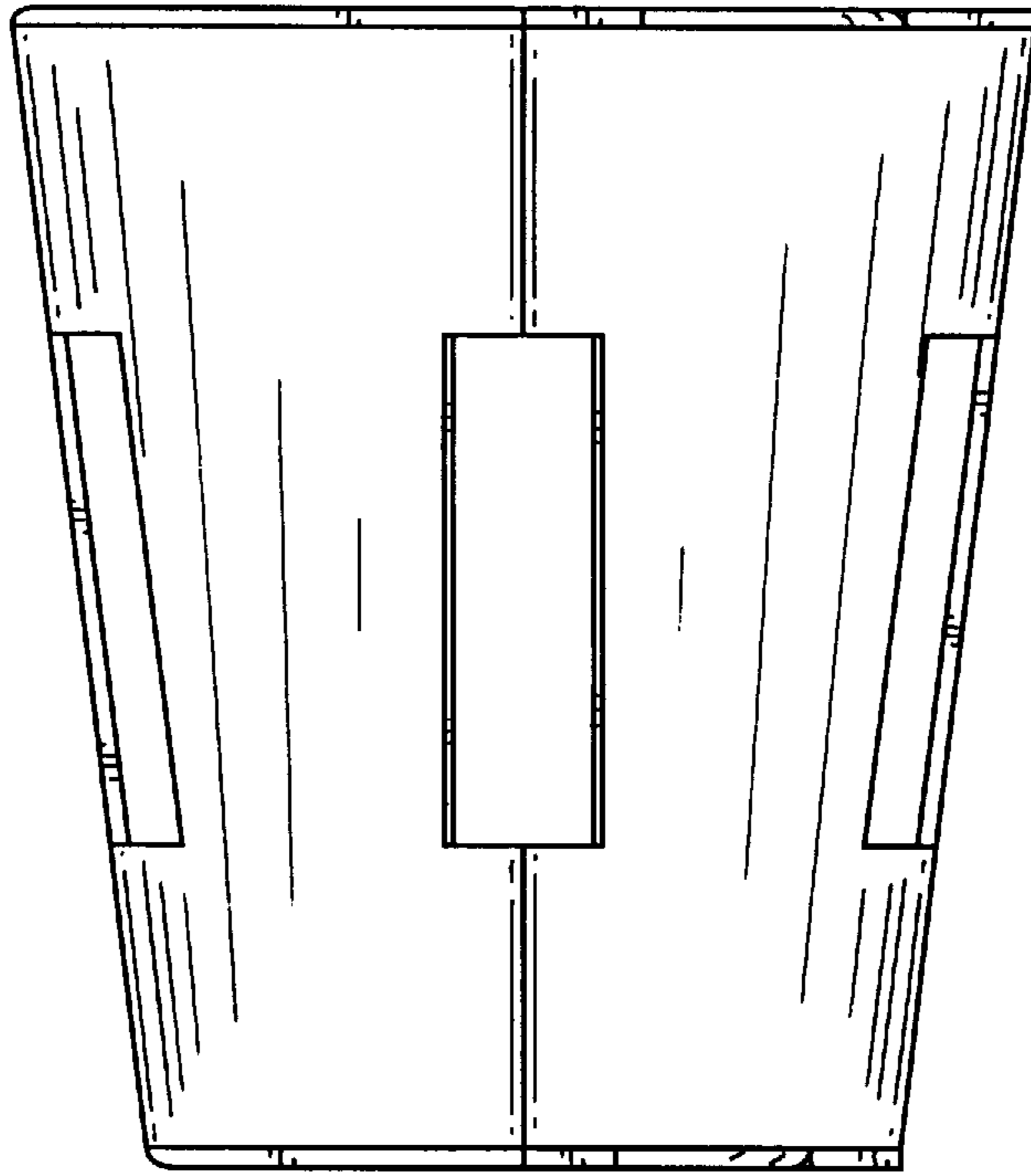

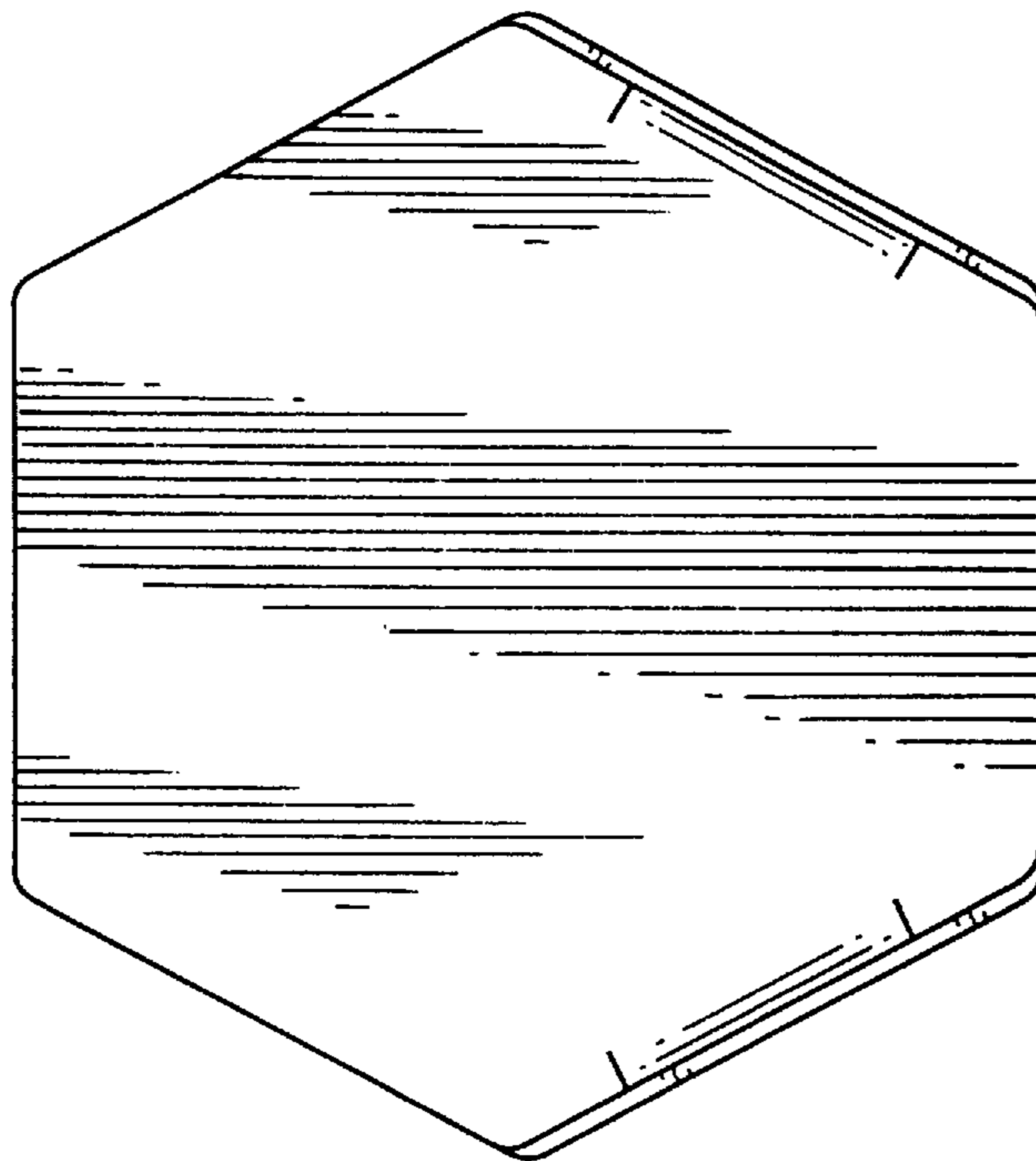




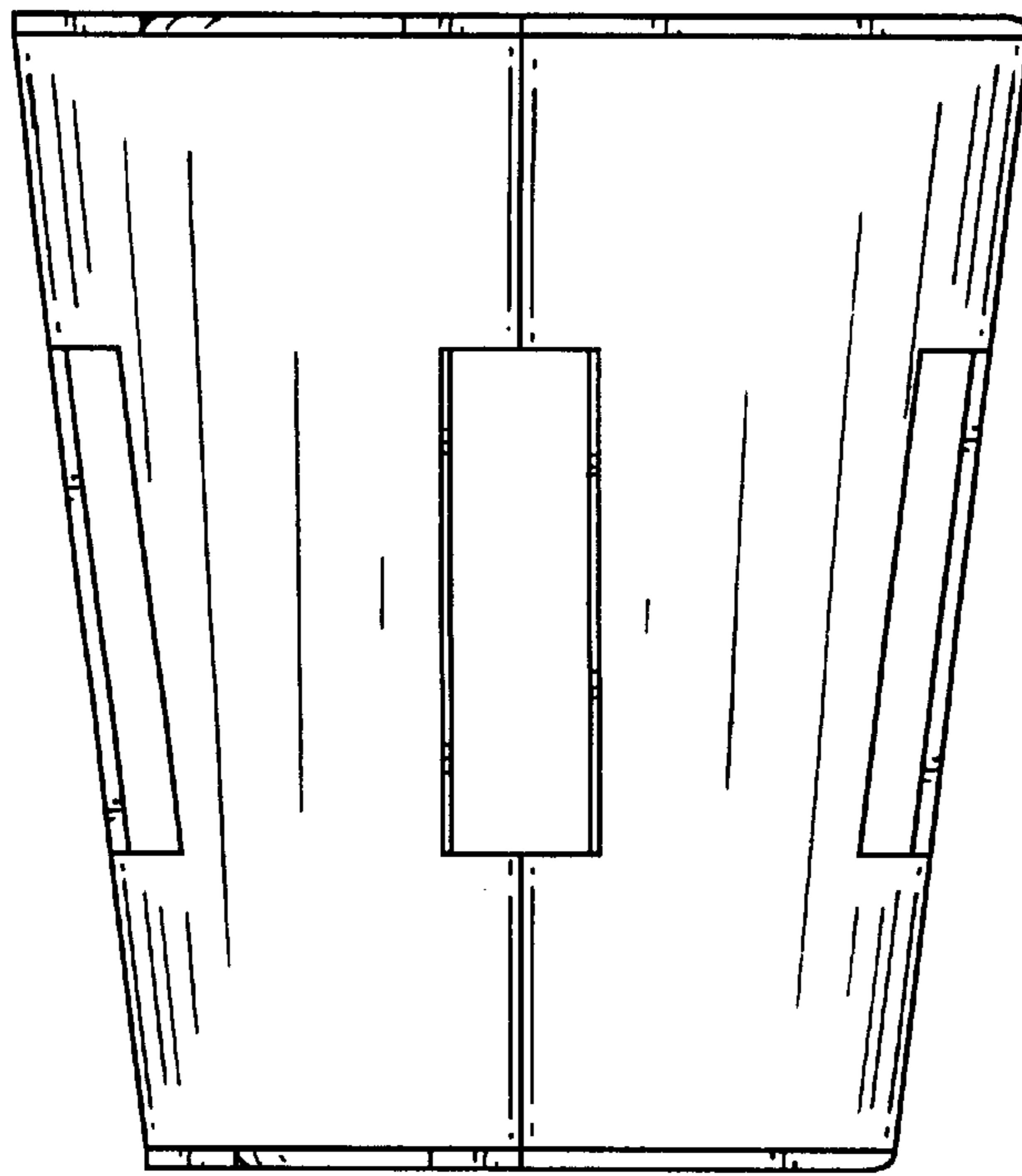

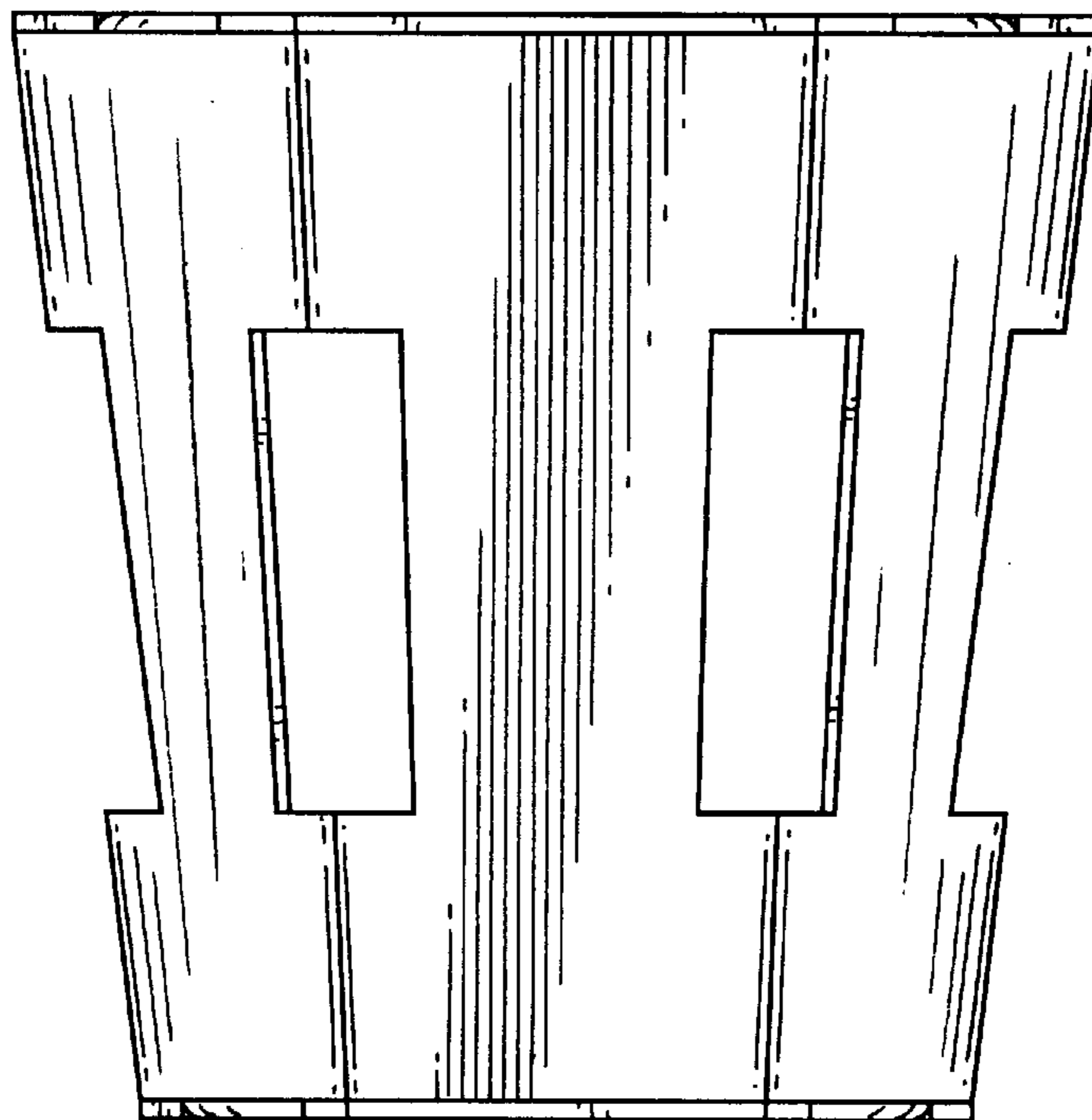

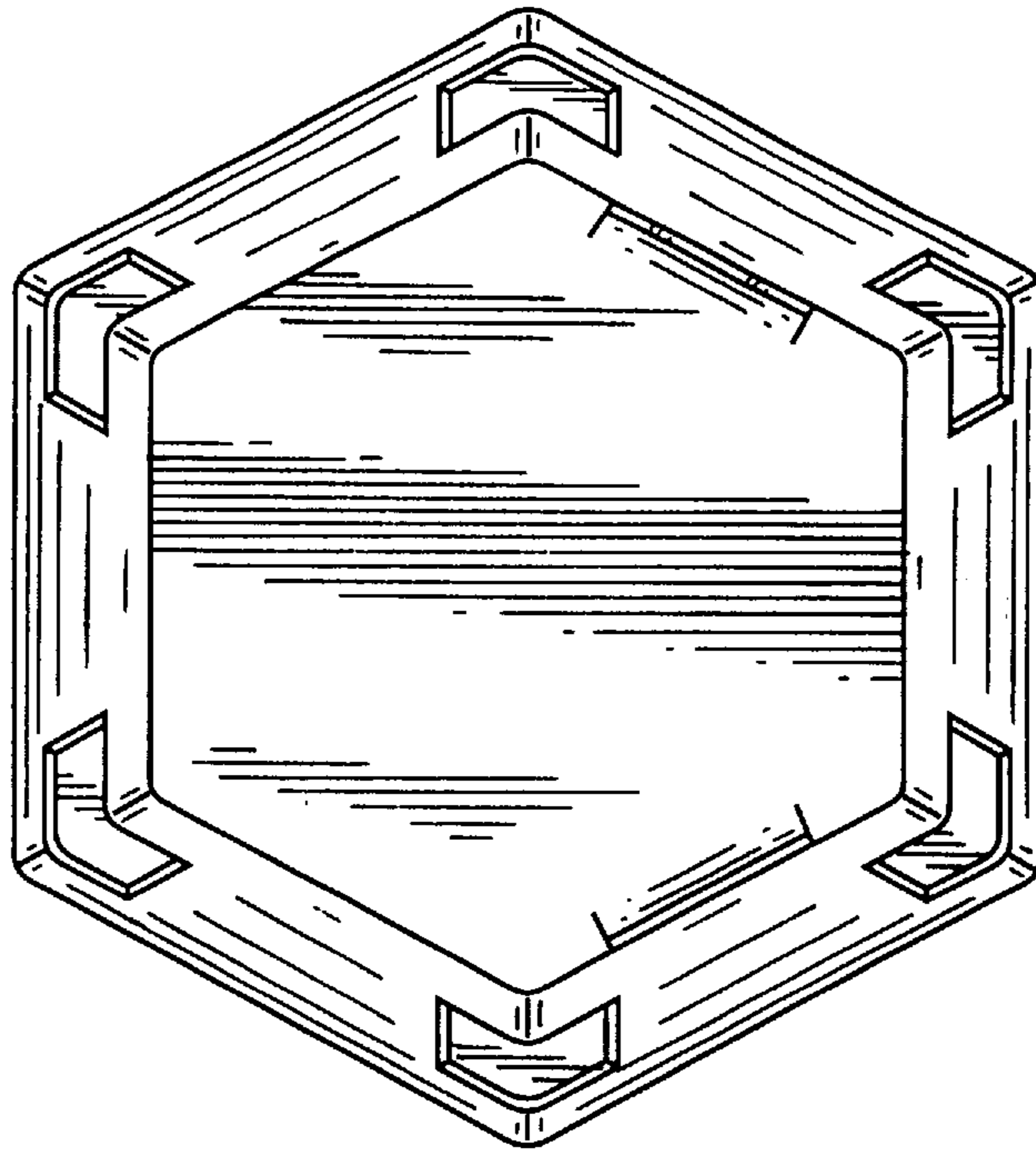

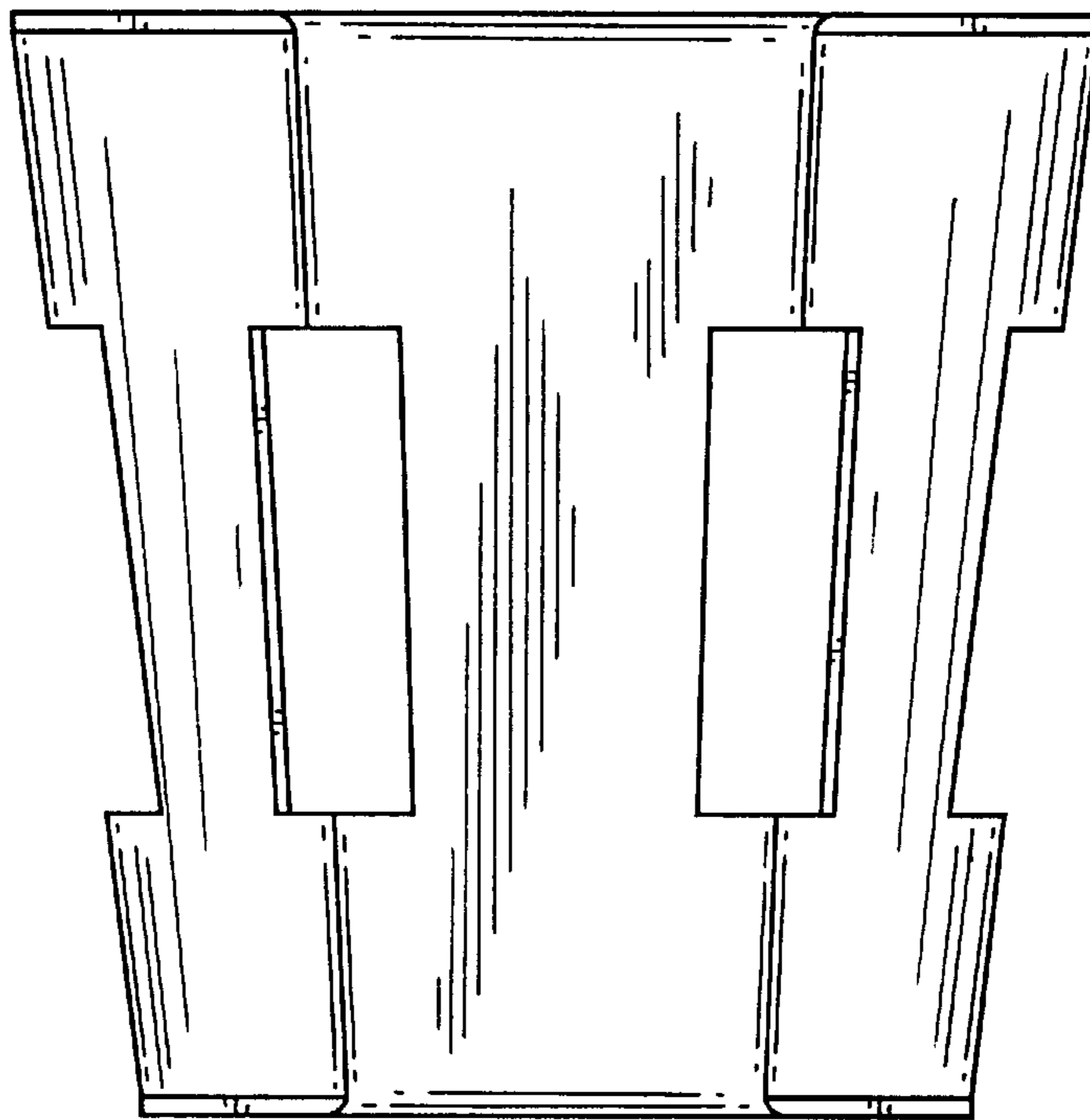
