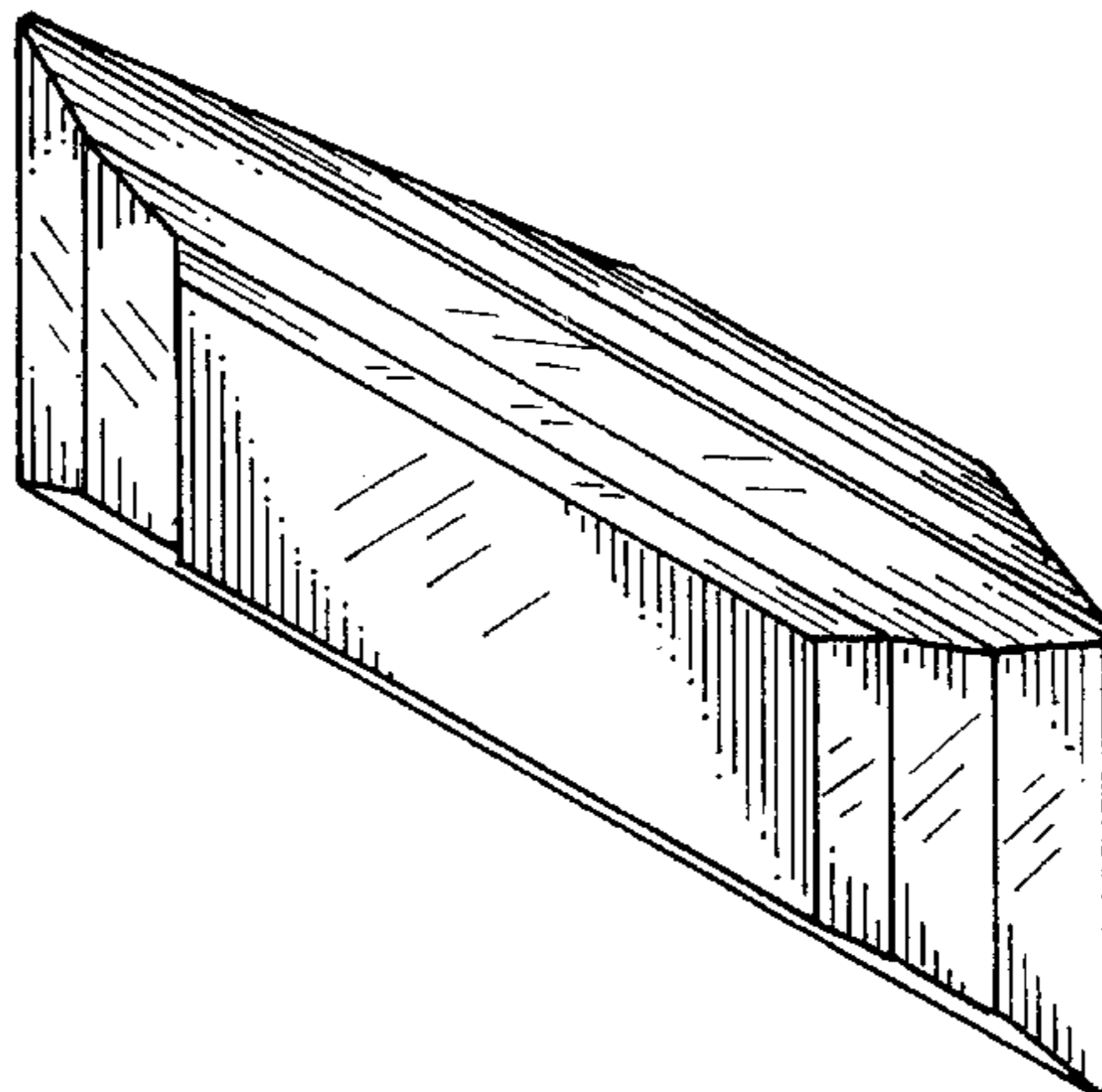
[57] CLAIM

The ornamental design for a jewelry stone, as shown and described.

DESCRIPTION

FIG. 1 is a bottom left perspective of a baguette jewelry stone in accordance with my new design;
FIG. 2 is a top right perspective view thereof;
FIG. 3 is a right side elevation view thereof, the left side elevational being a mirror image thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a rear elevational view thereof, the front elevational view being the same.

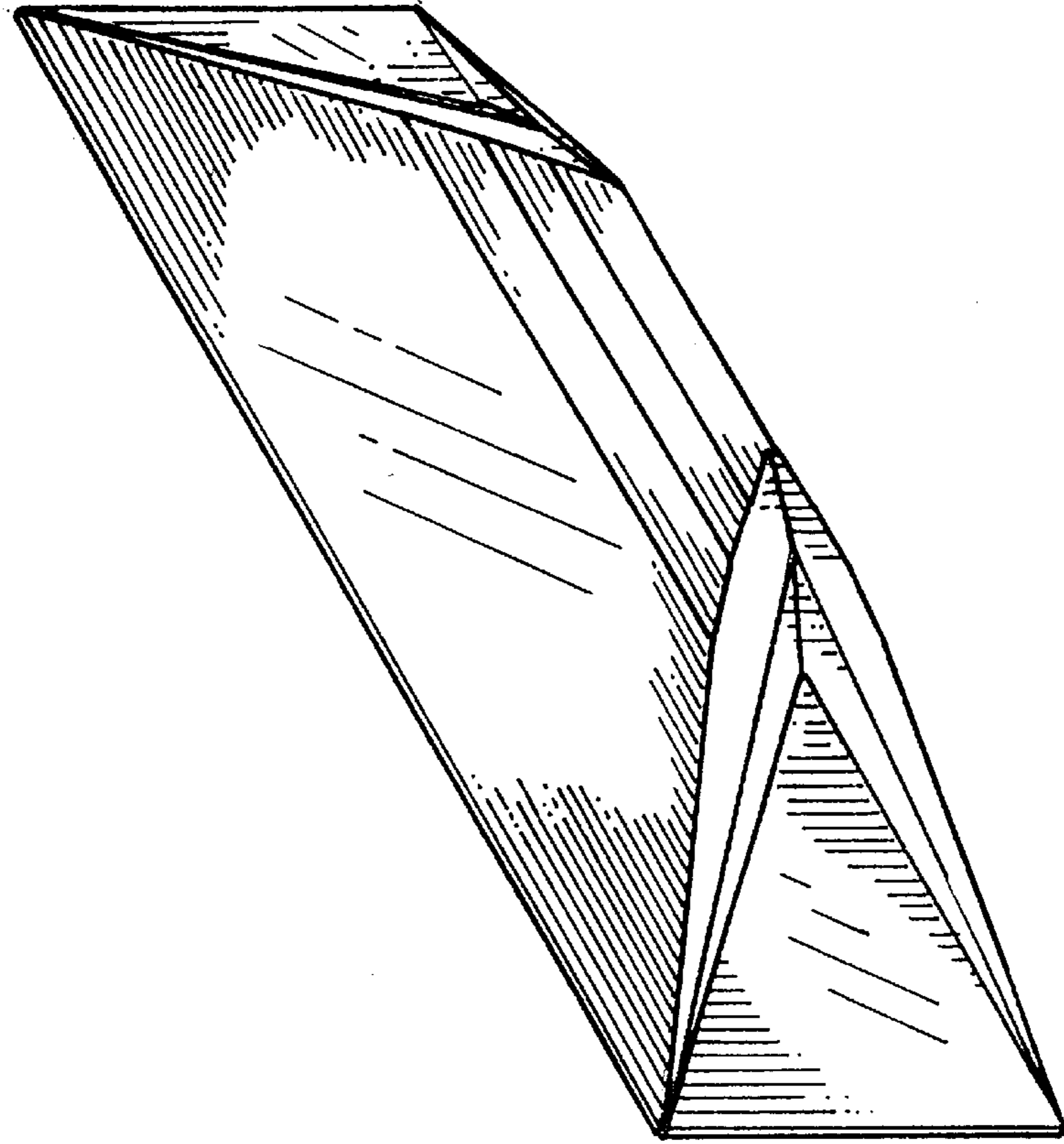
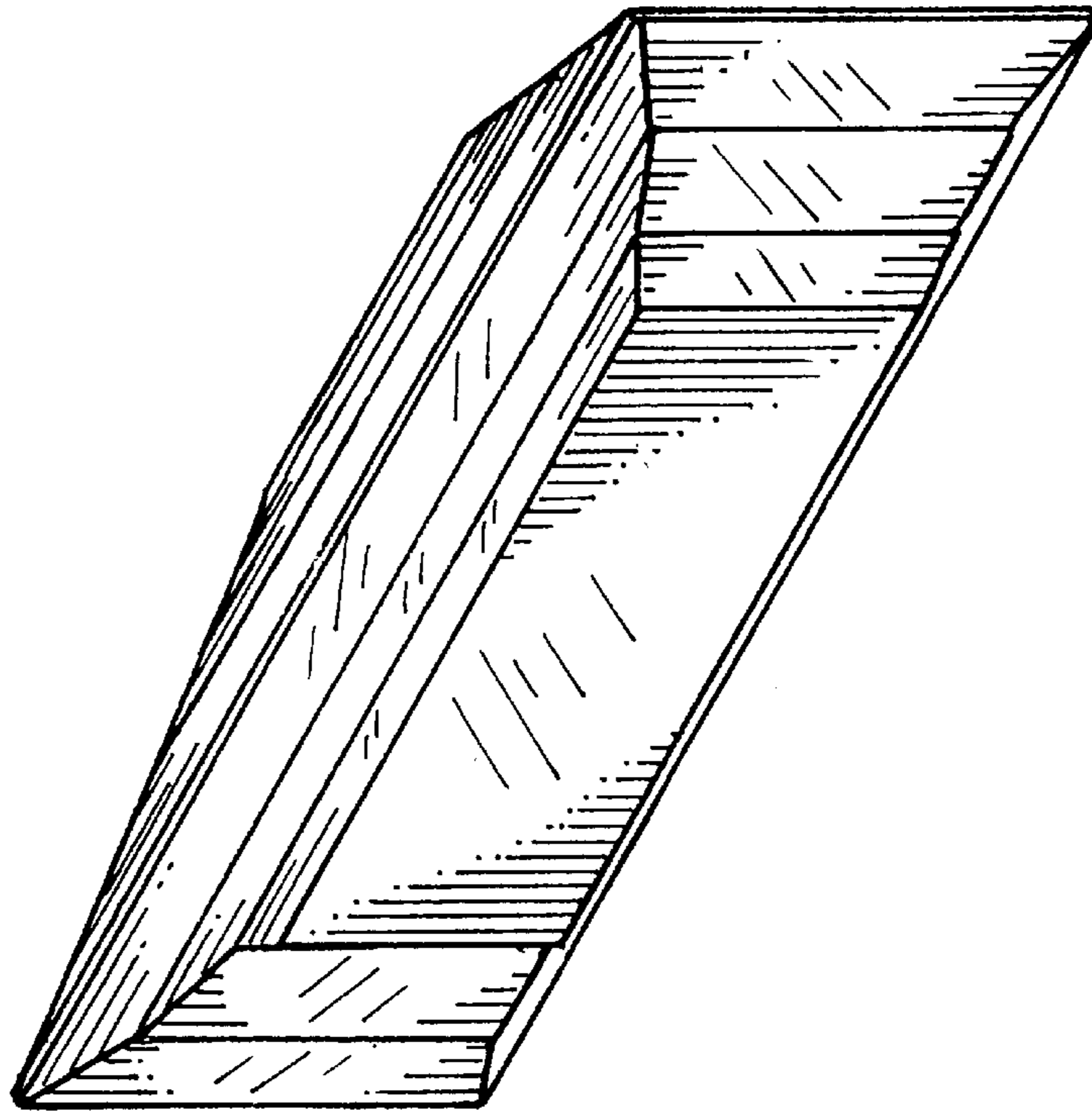

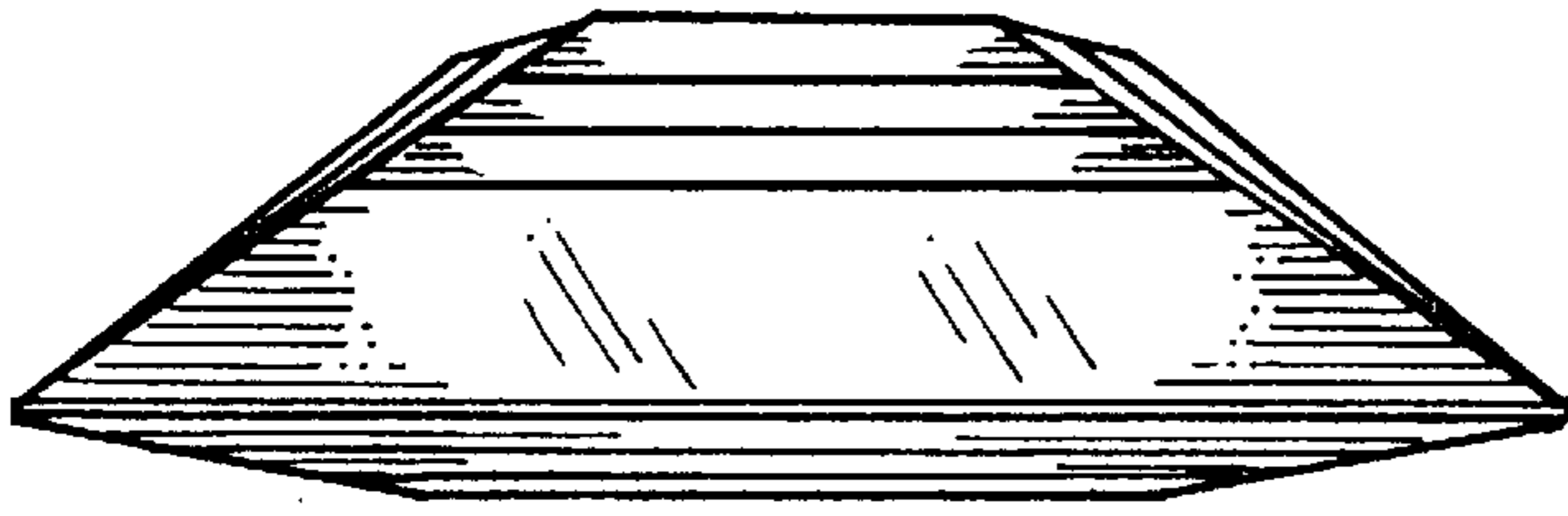

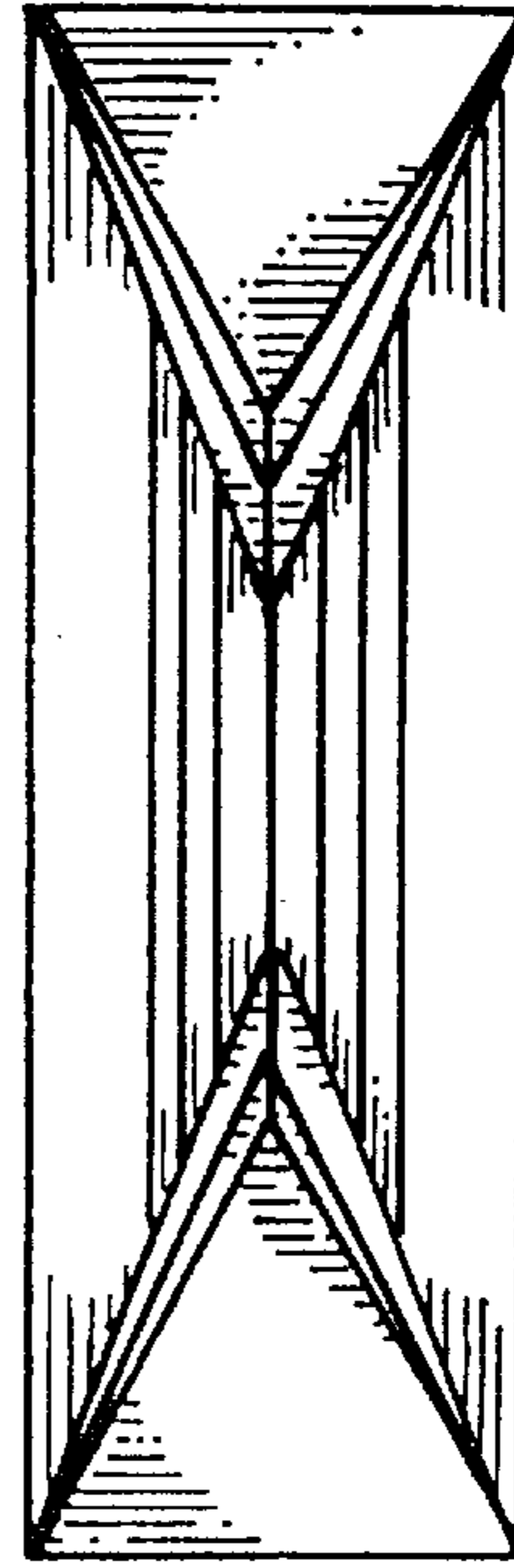

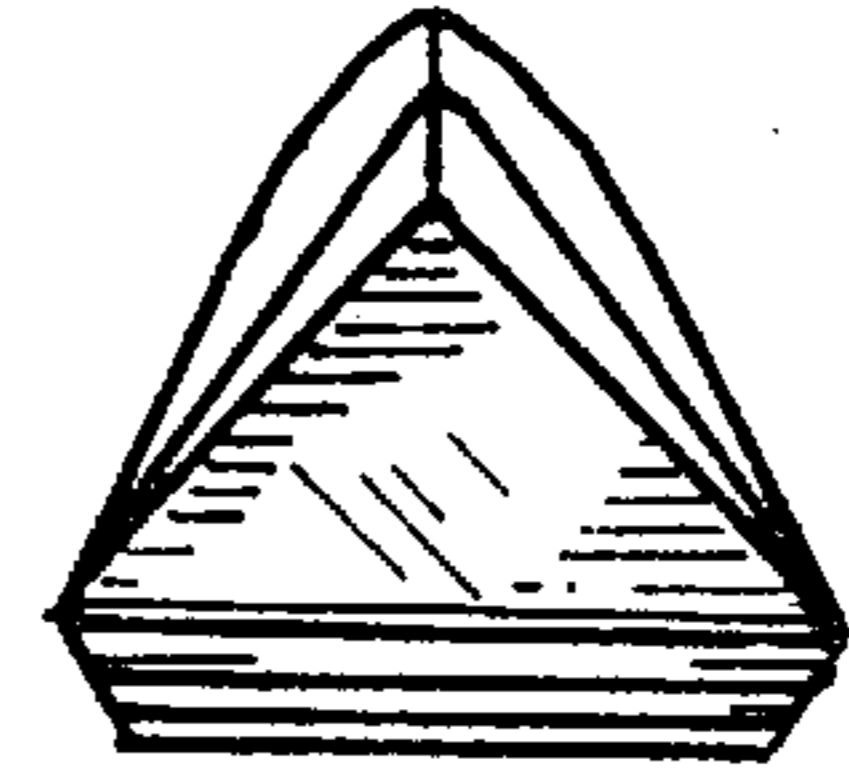

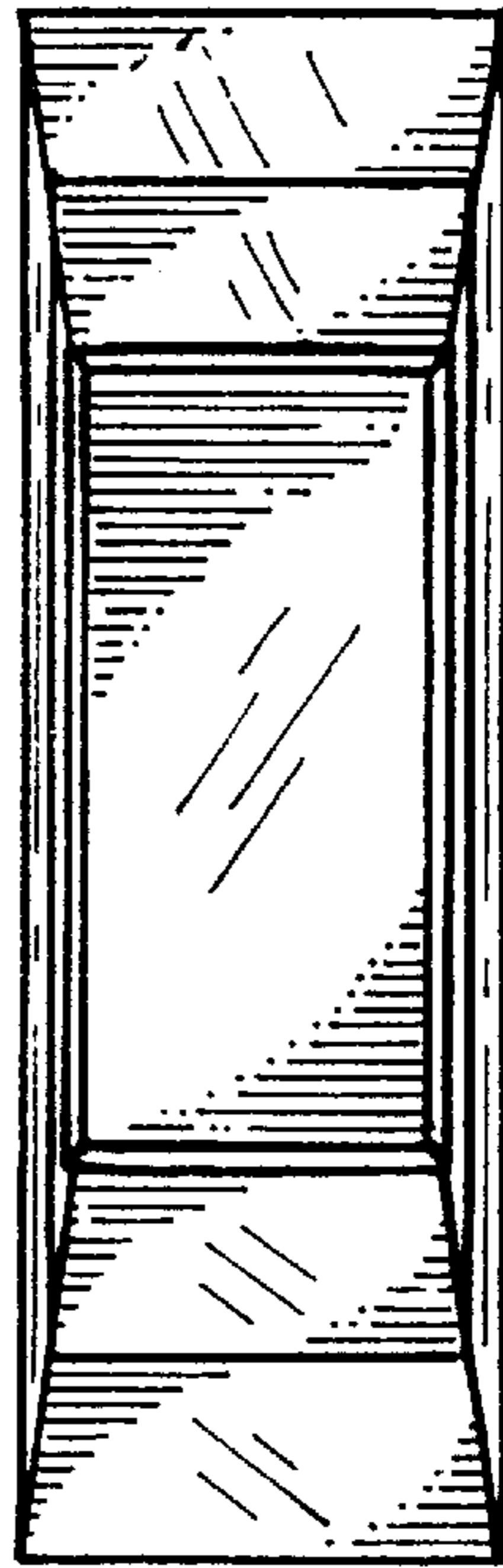
