FIG. 5 is a front view of a fifth embodiment thereof;

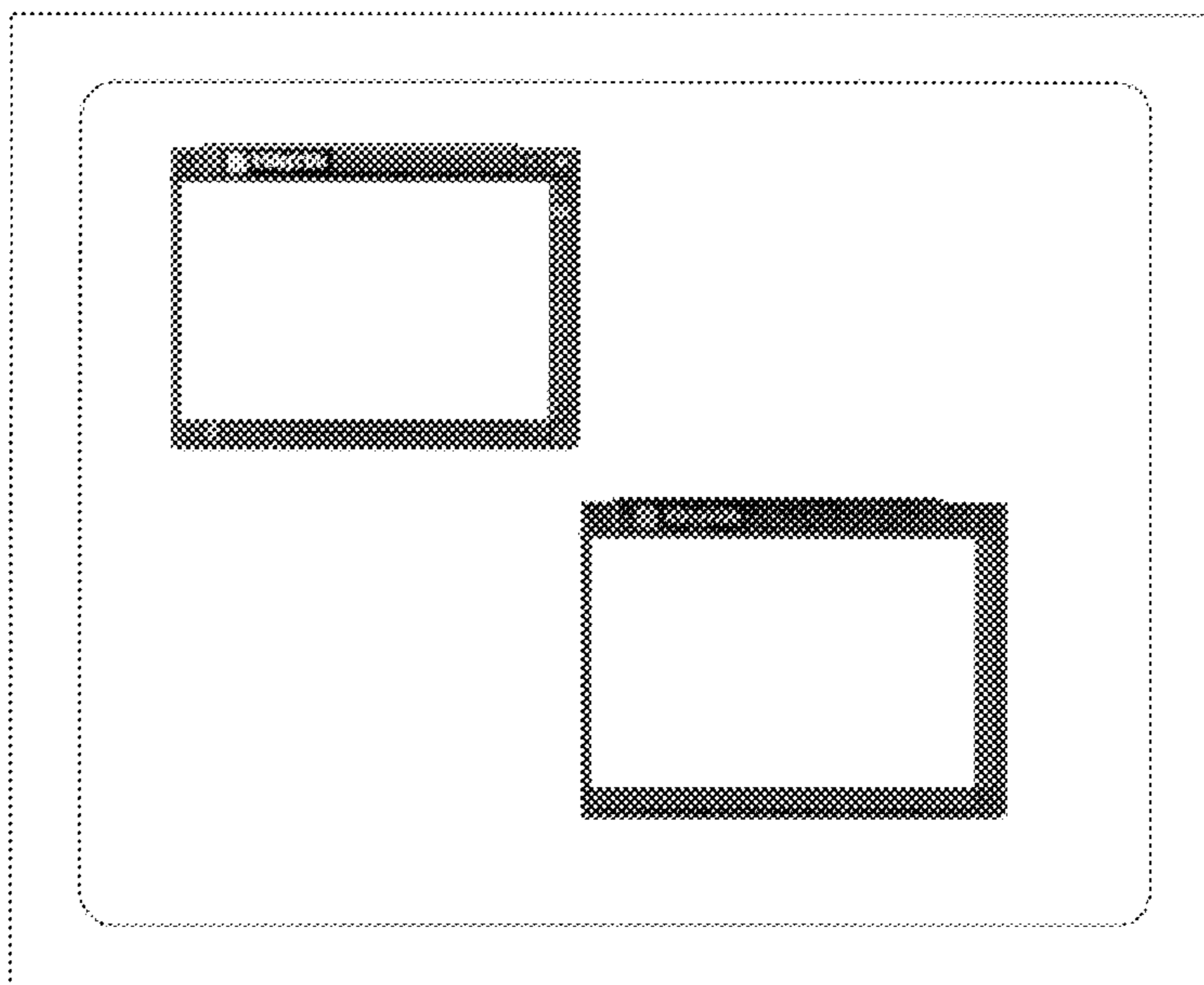
FIG. 6 is a front view of a sixth embodiment thereof;

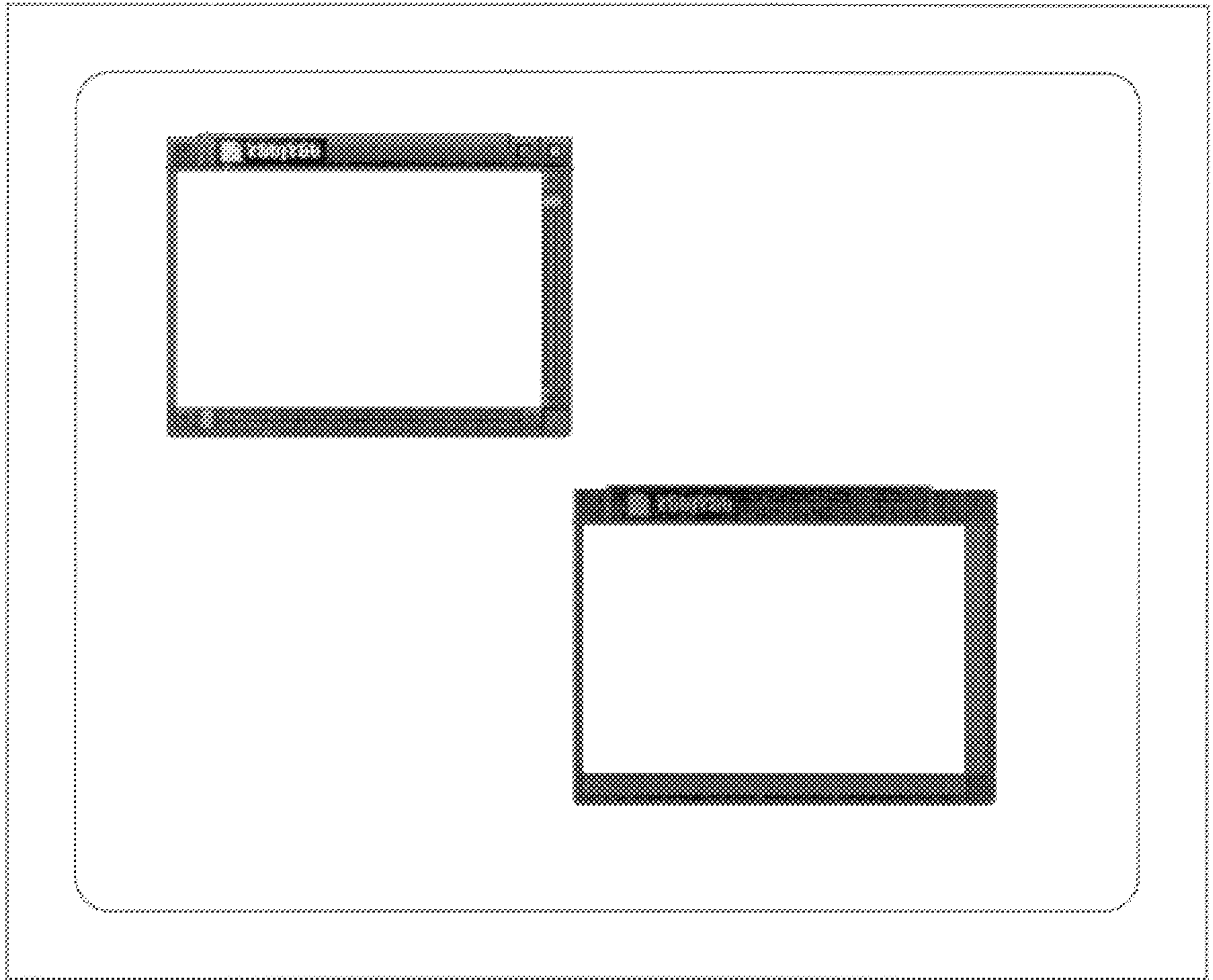

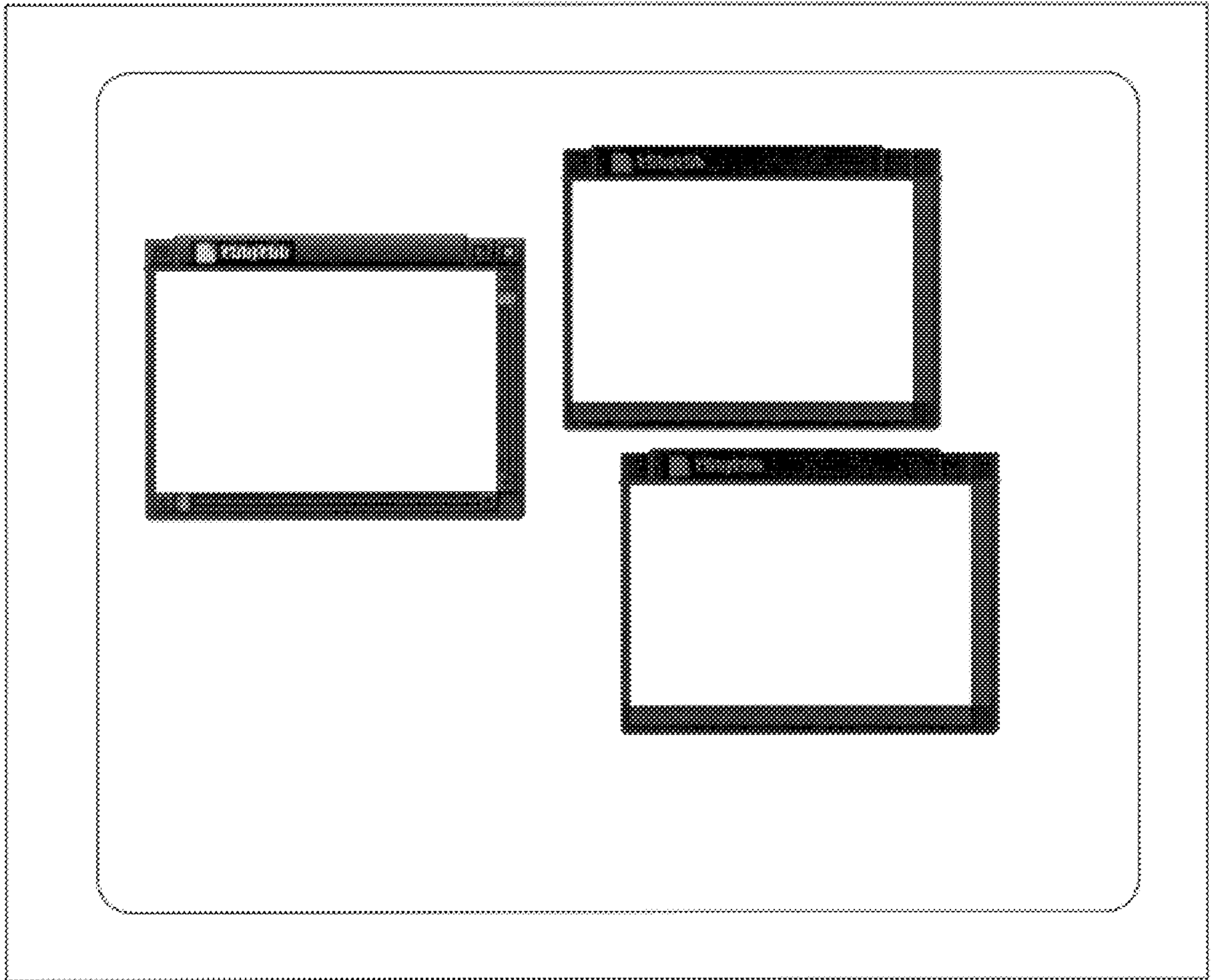

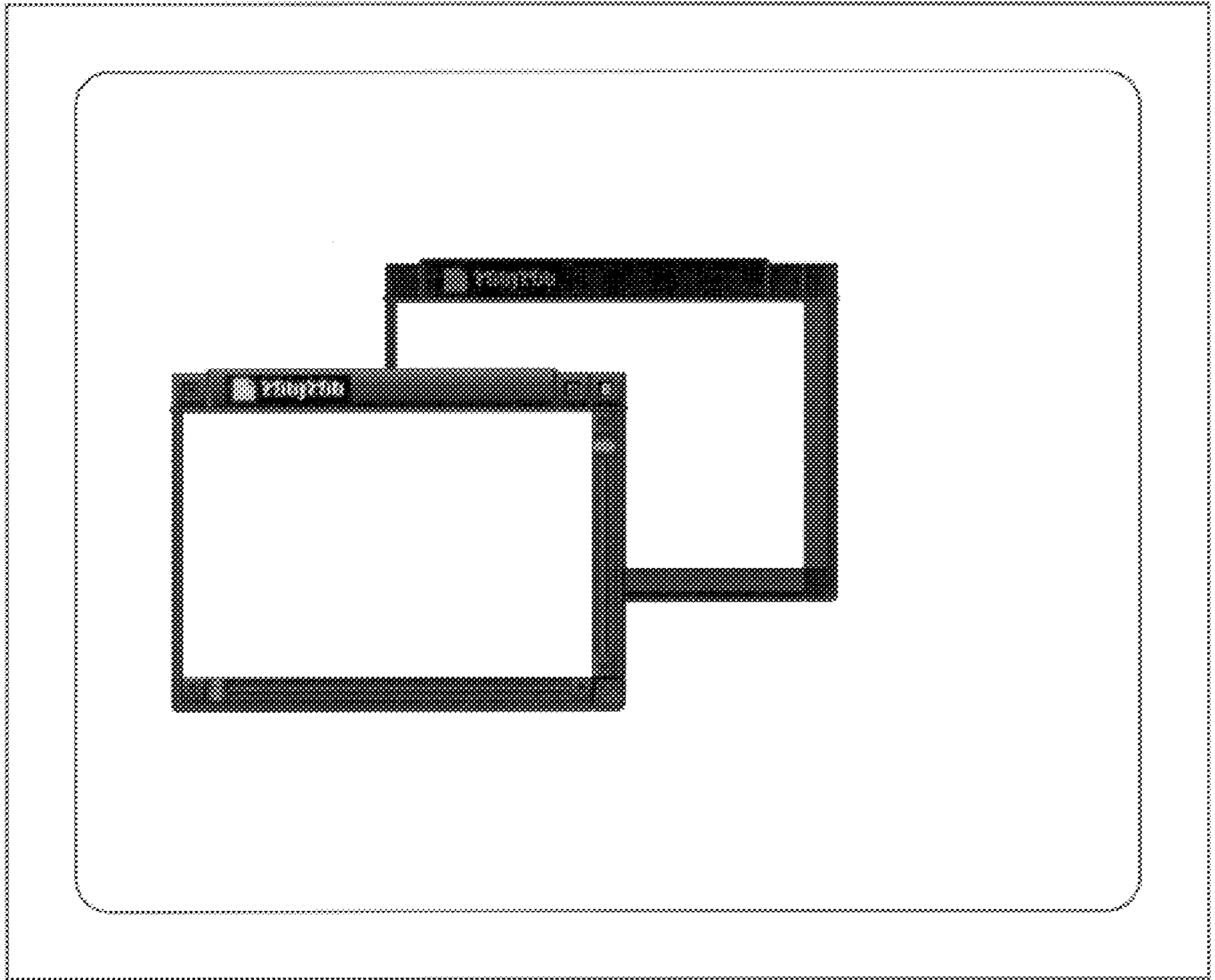

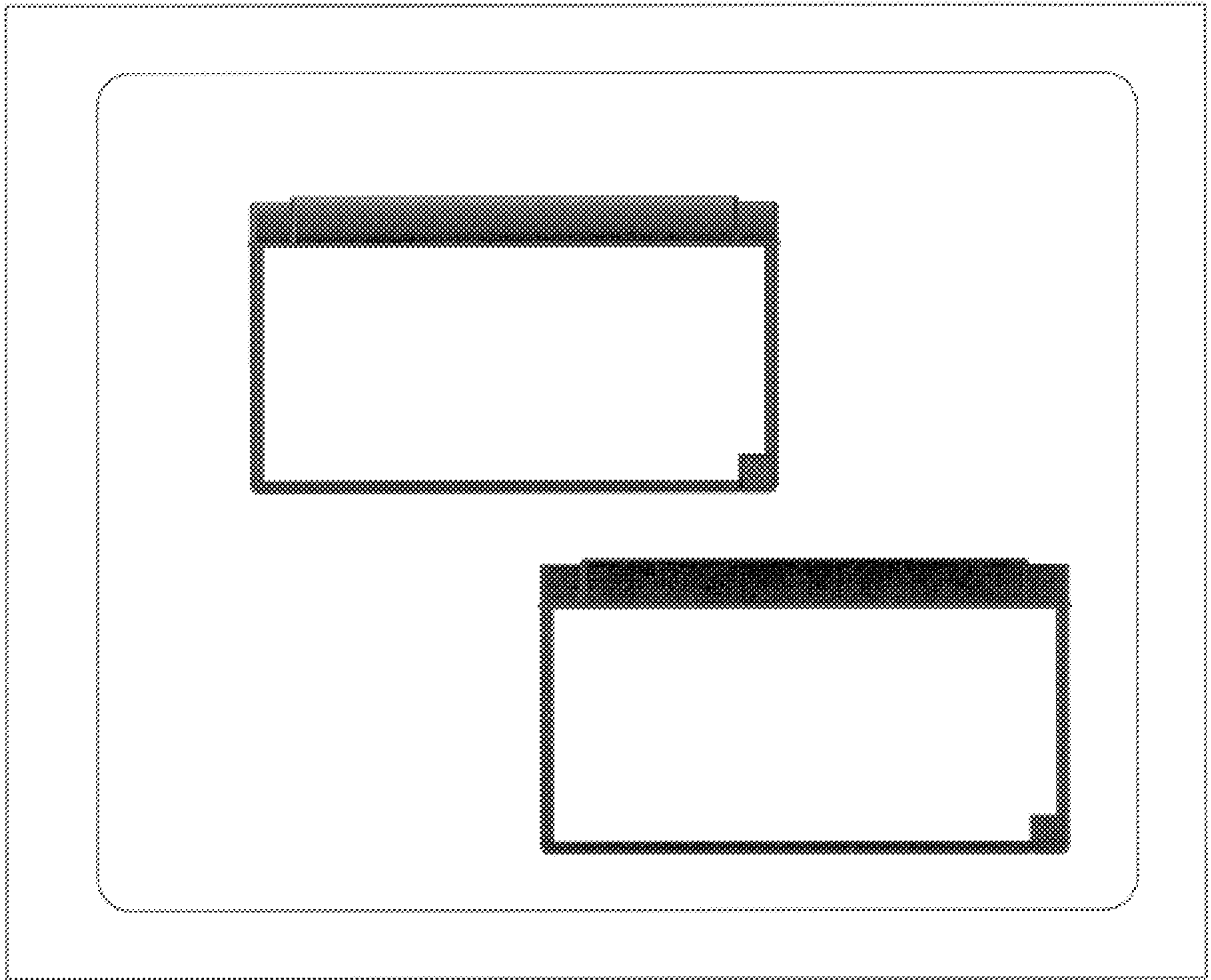

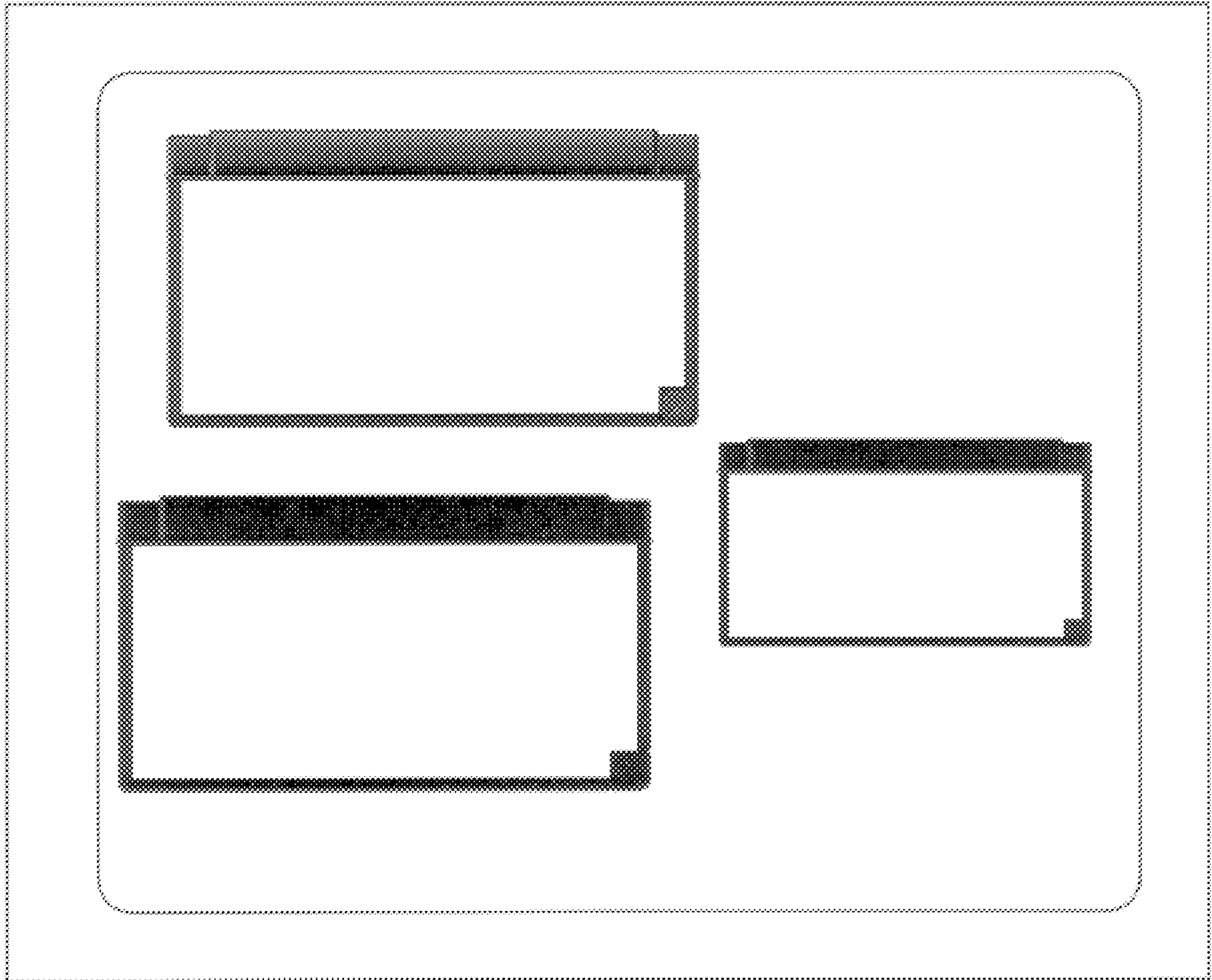

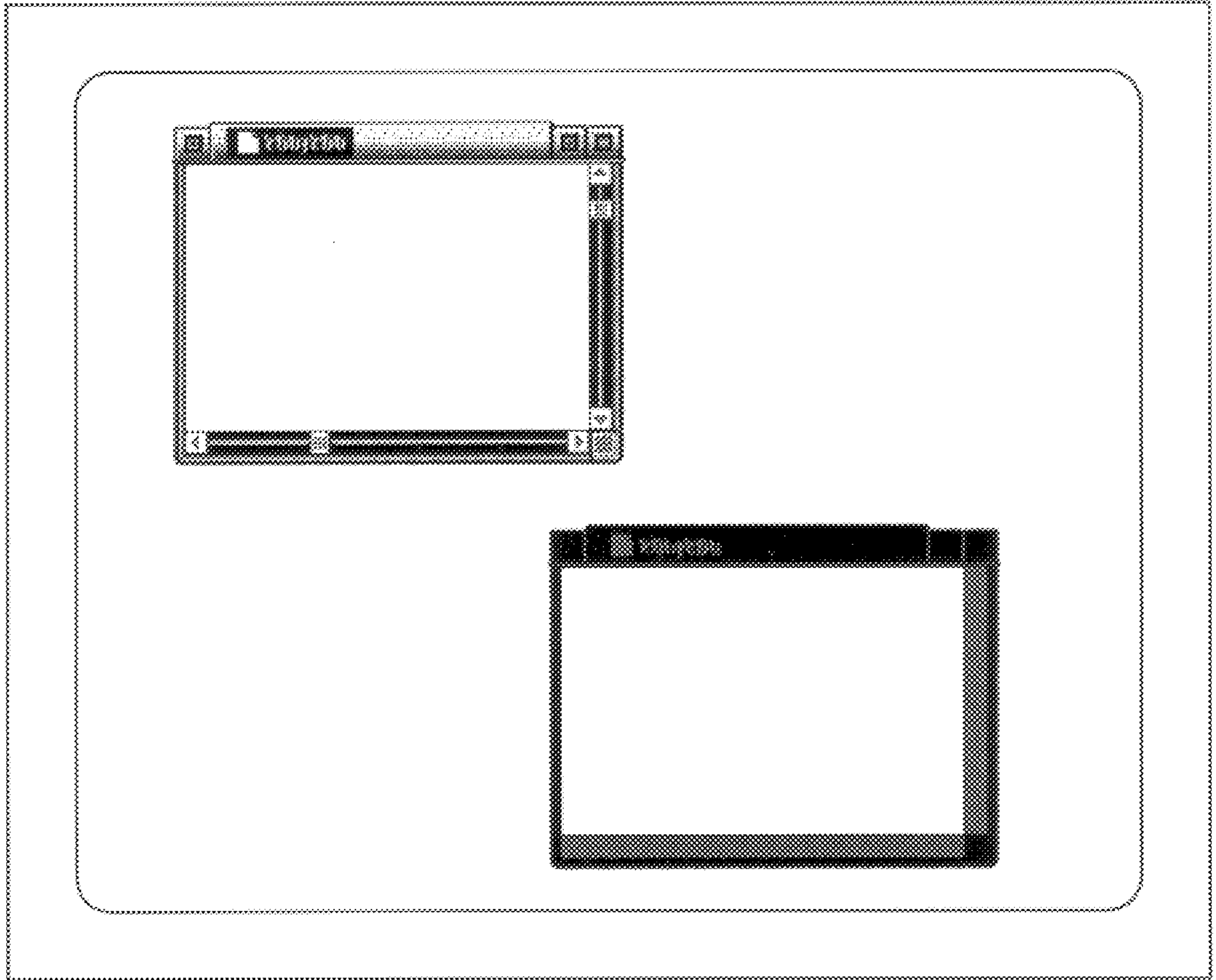

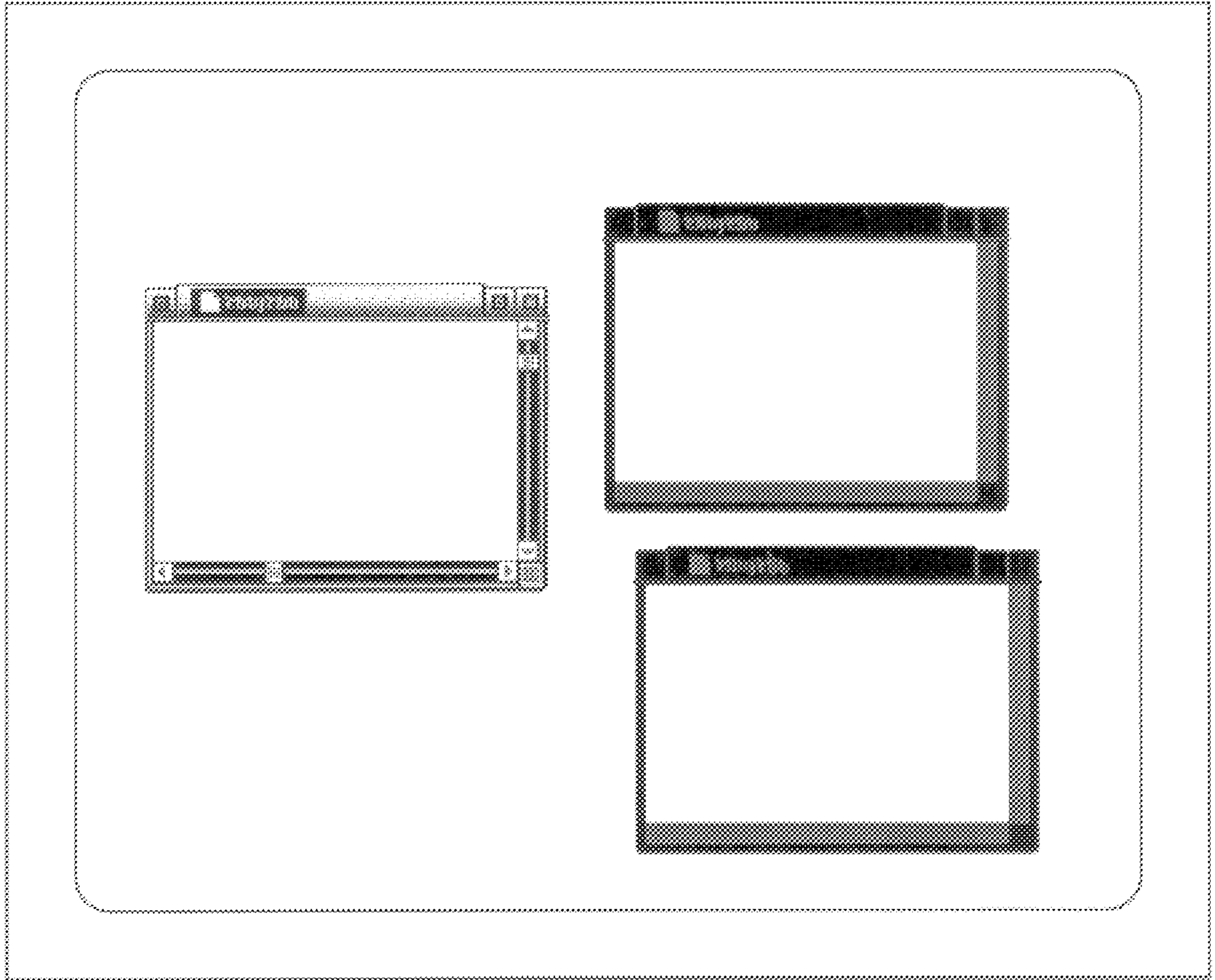

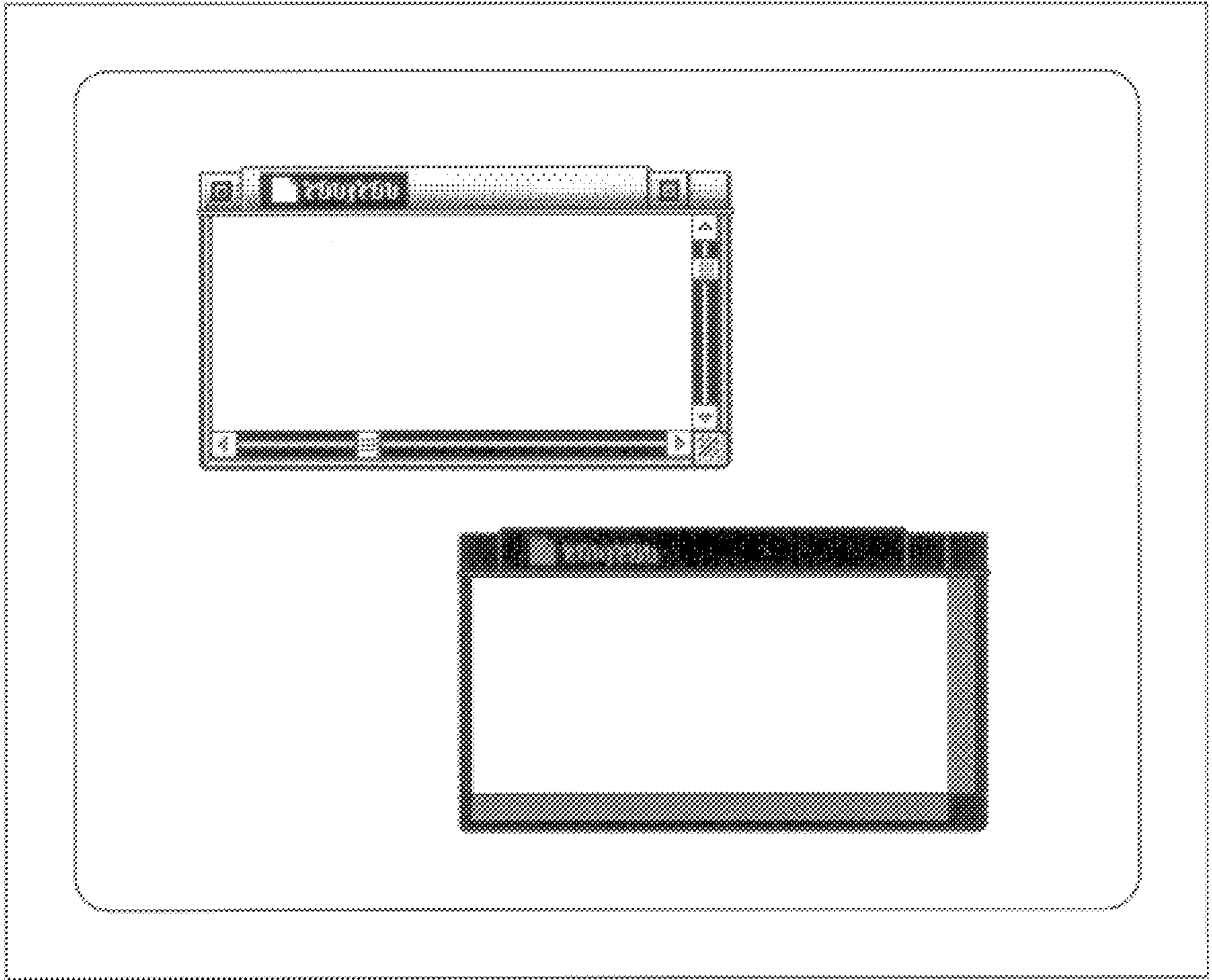

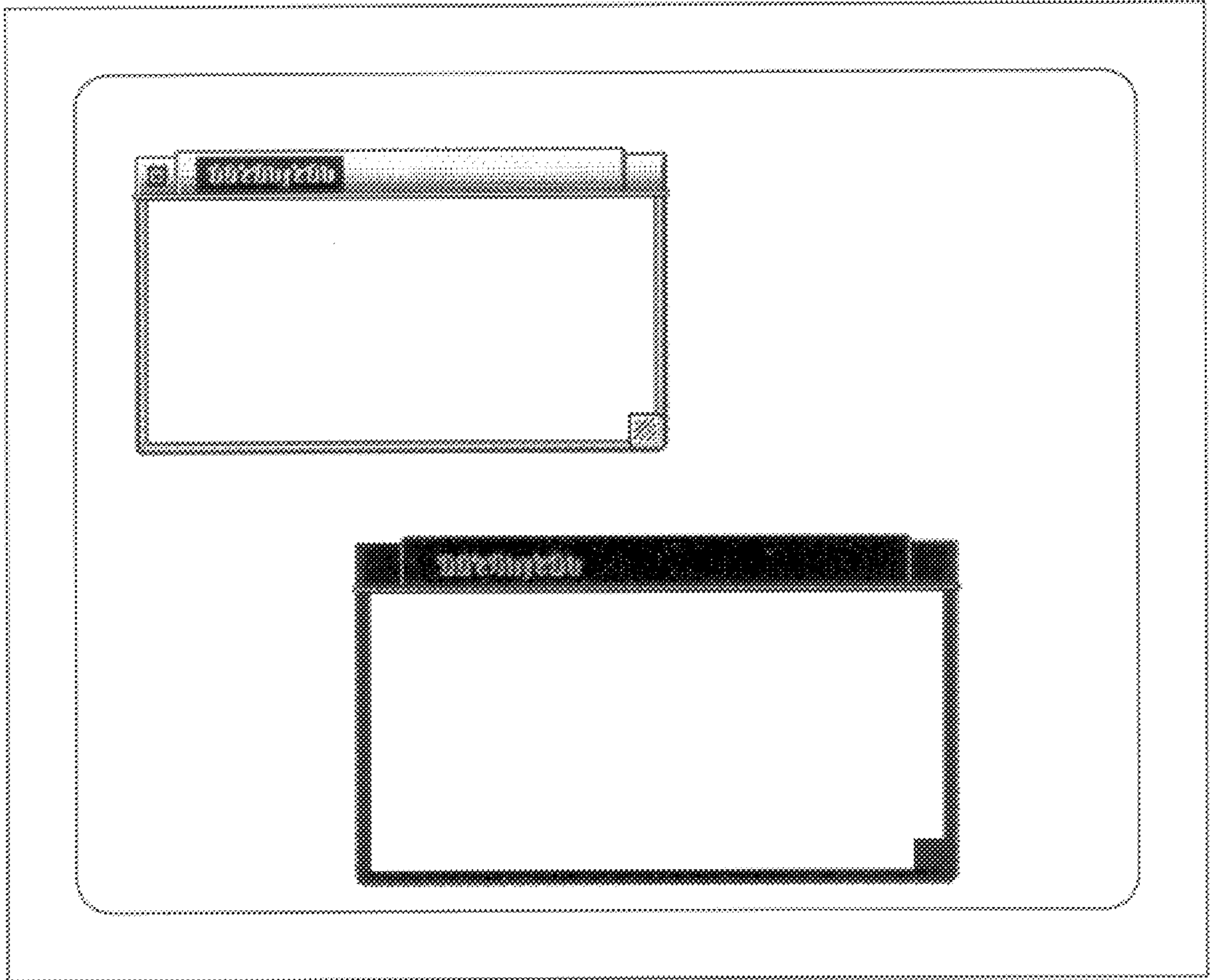
