The ornamental design for a display panel with a computer-generated icon, as shown and described.

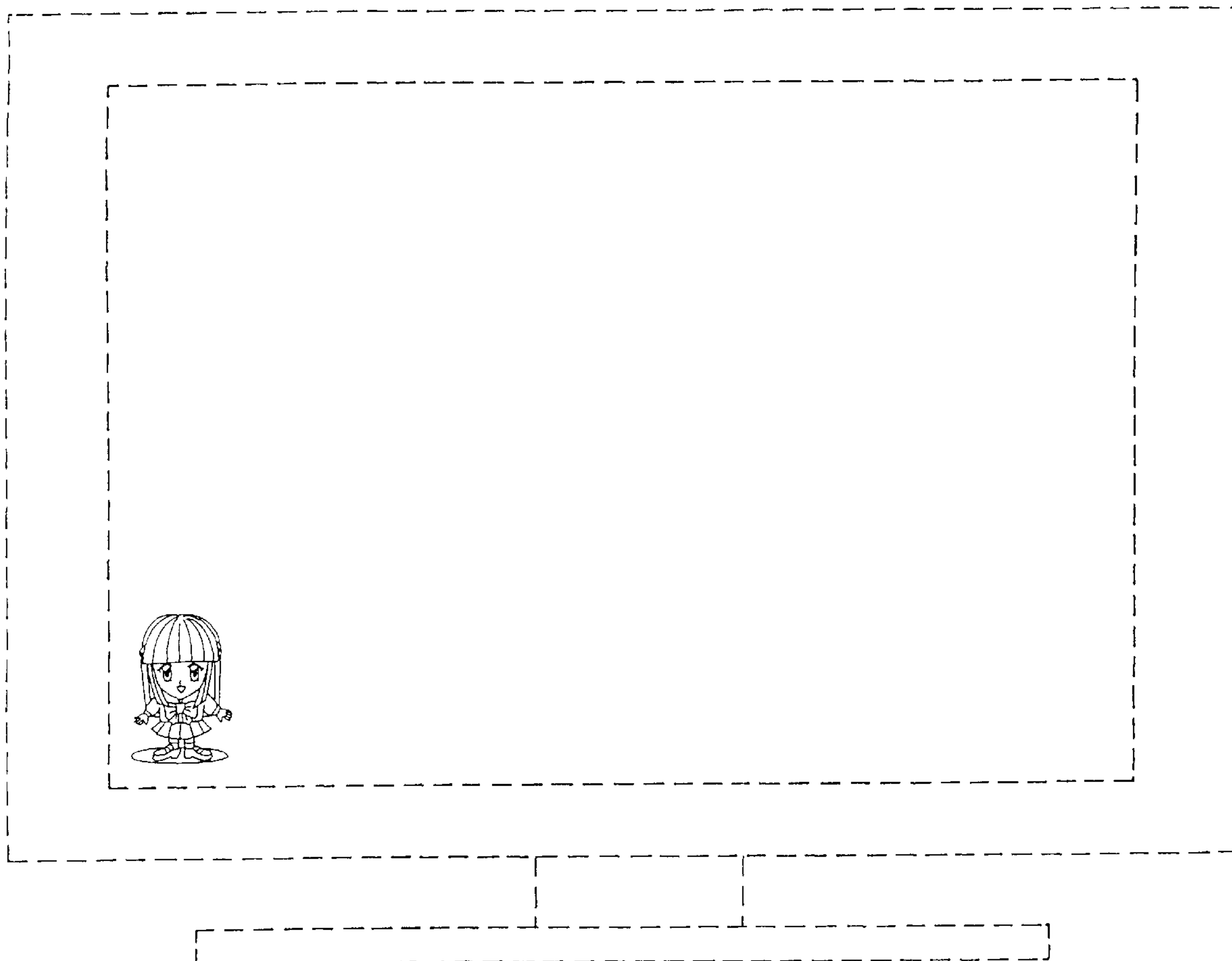
### **DESCRIPTION**

FIG. 1 is a front view of the display panel with a computer-generated icon; and,

FIG. 2 is a front view of a portion thereof, on an enlarged scale, a portion shown for ease of illustration.

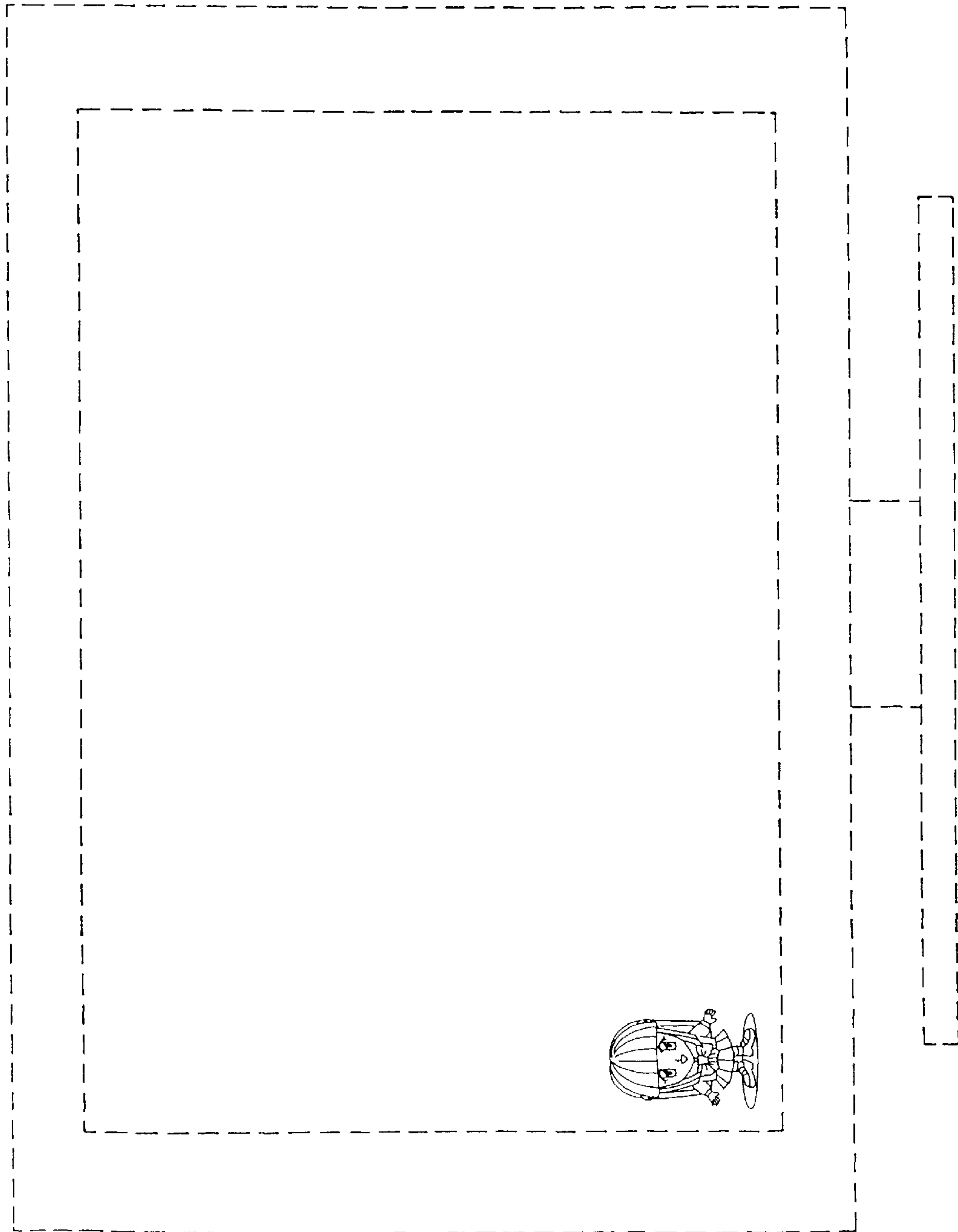

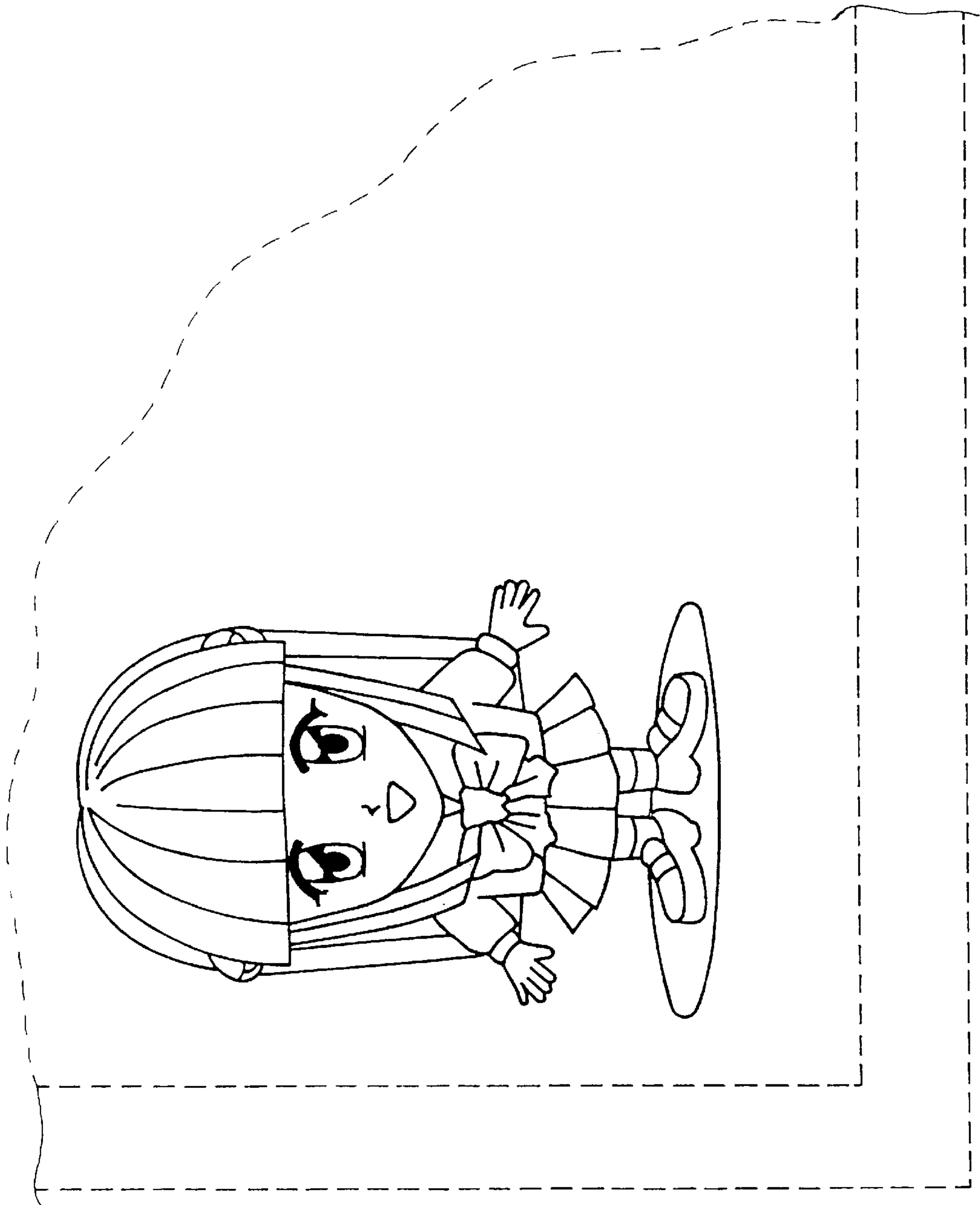
