### [57] **CLAIM**

The ornamental design for the pager phone having recessed thumb grip and power button located in base, as shown and described.

### **DESCRIPTION**

FIG. 1 is a perspective view of the pager phone having a recessed thumb grip and power button located in the base showing my new design;

FIG. 2 is a side elevational view thereof;

FIG. 3 is a top plan view thereof;

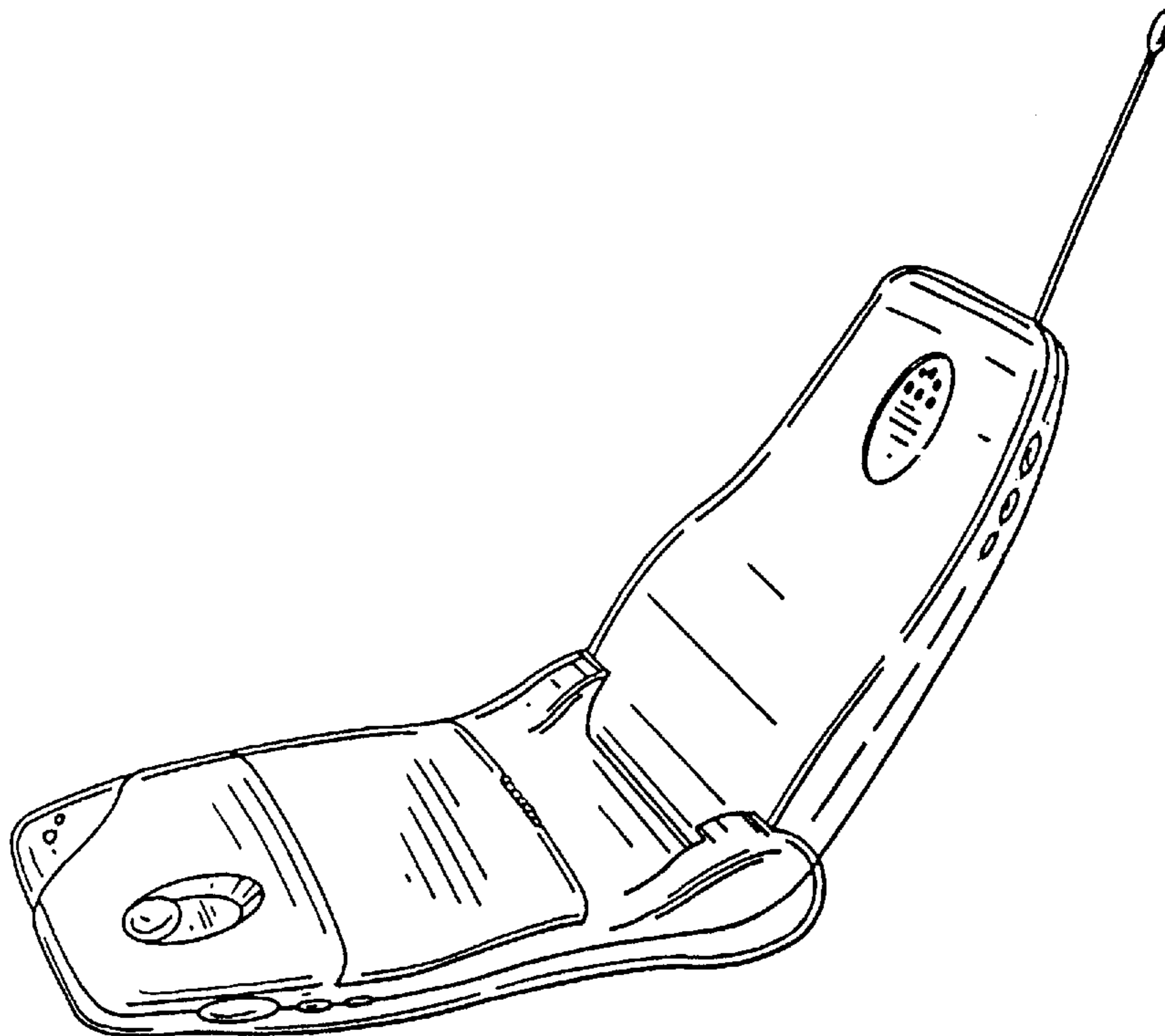
FIG. 4 is a bottom plan view thereof;

FIG. 5 is a rear elevational view thereof; and,

FIG. 6 is a front elevational view.

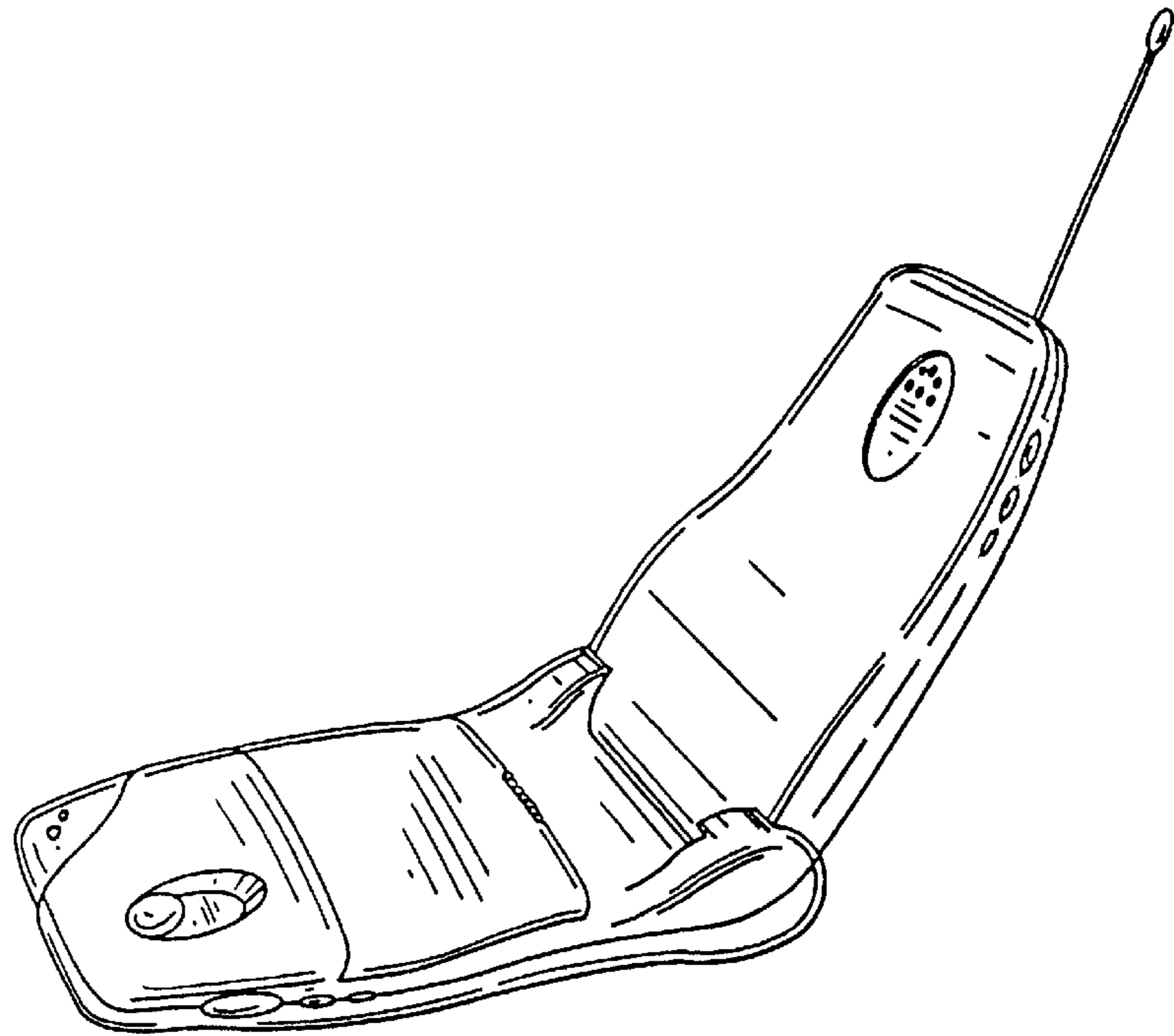

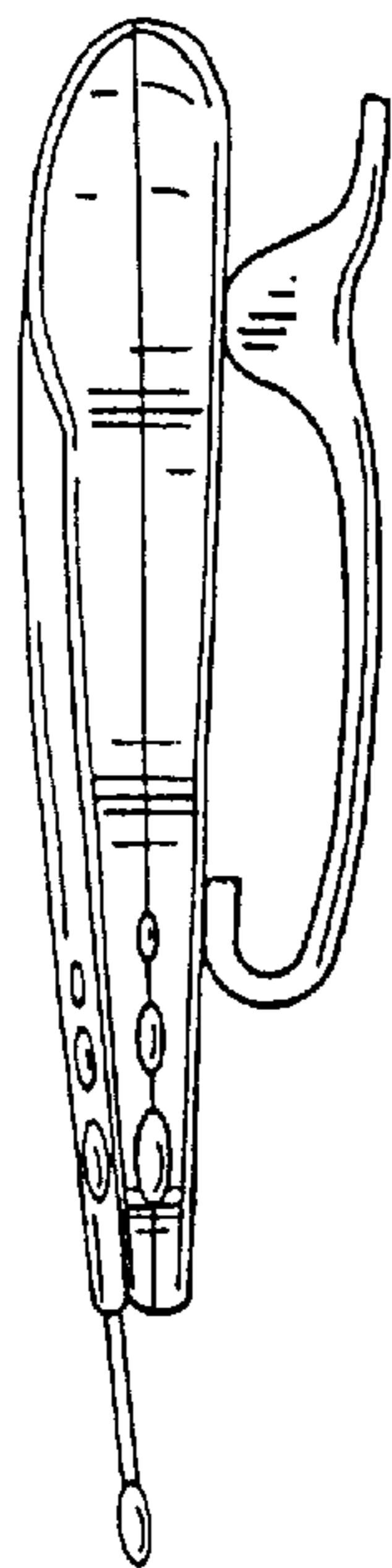

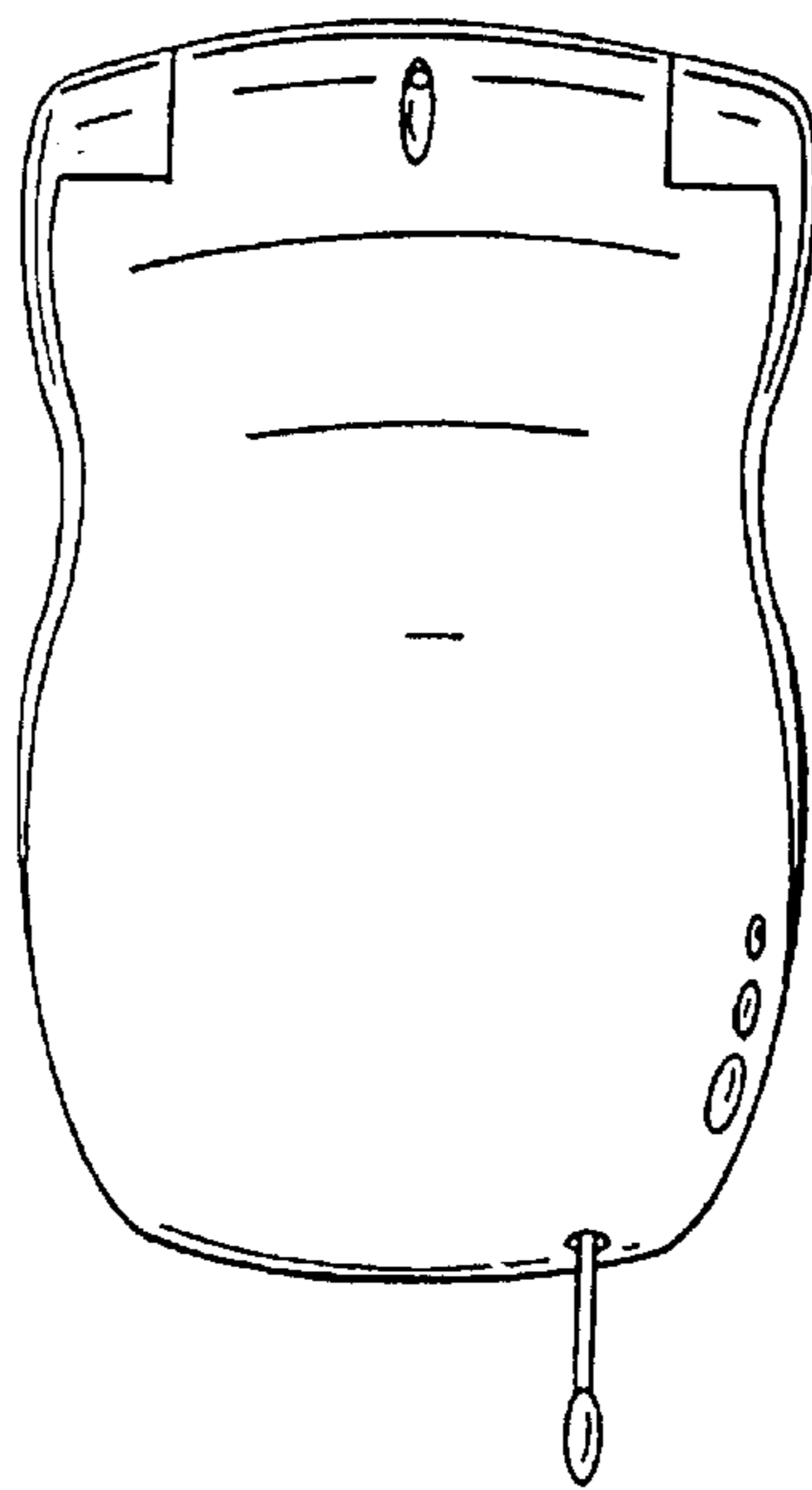

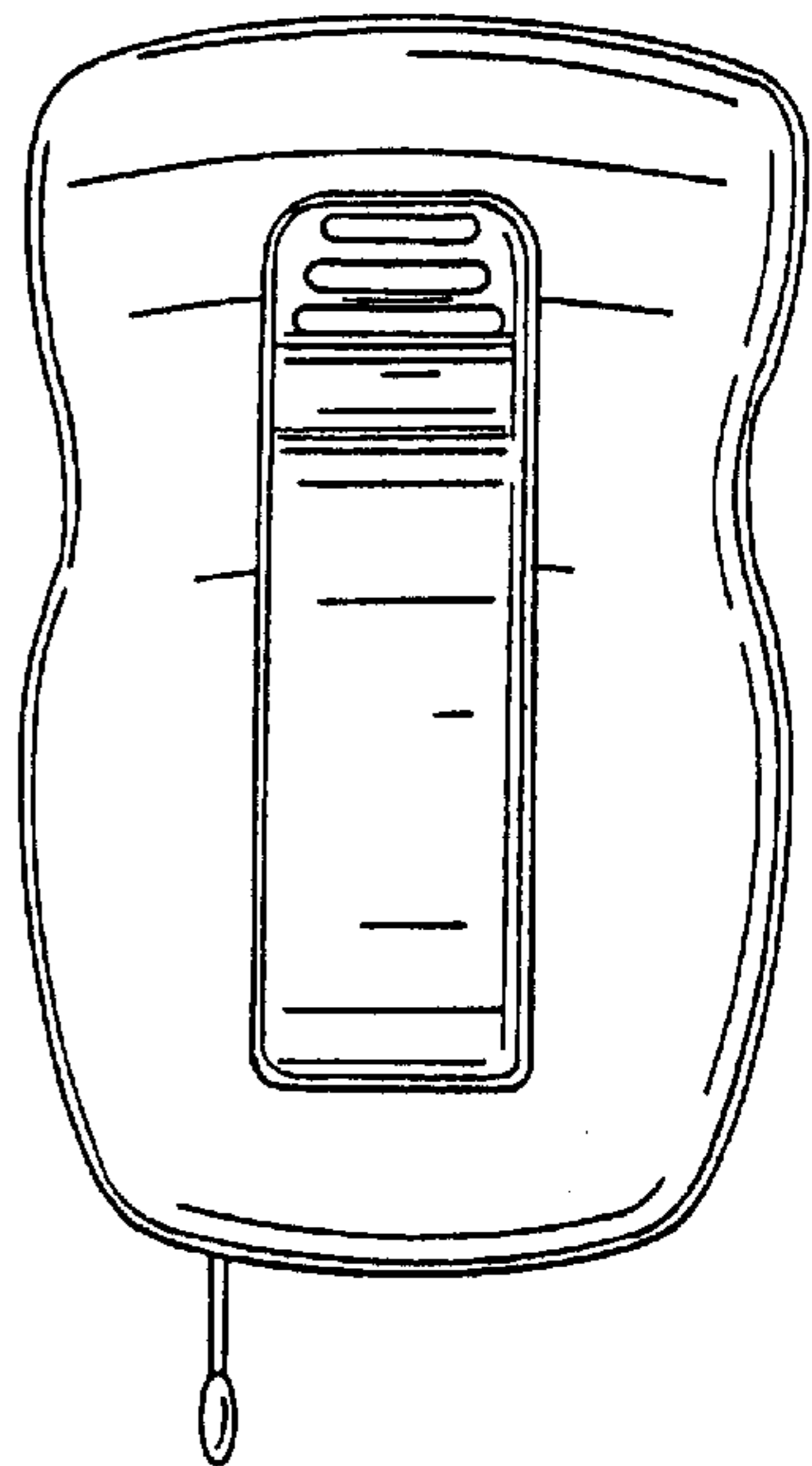

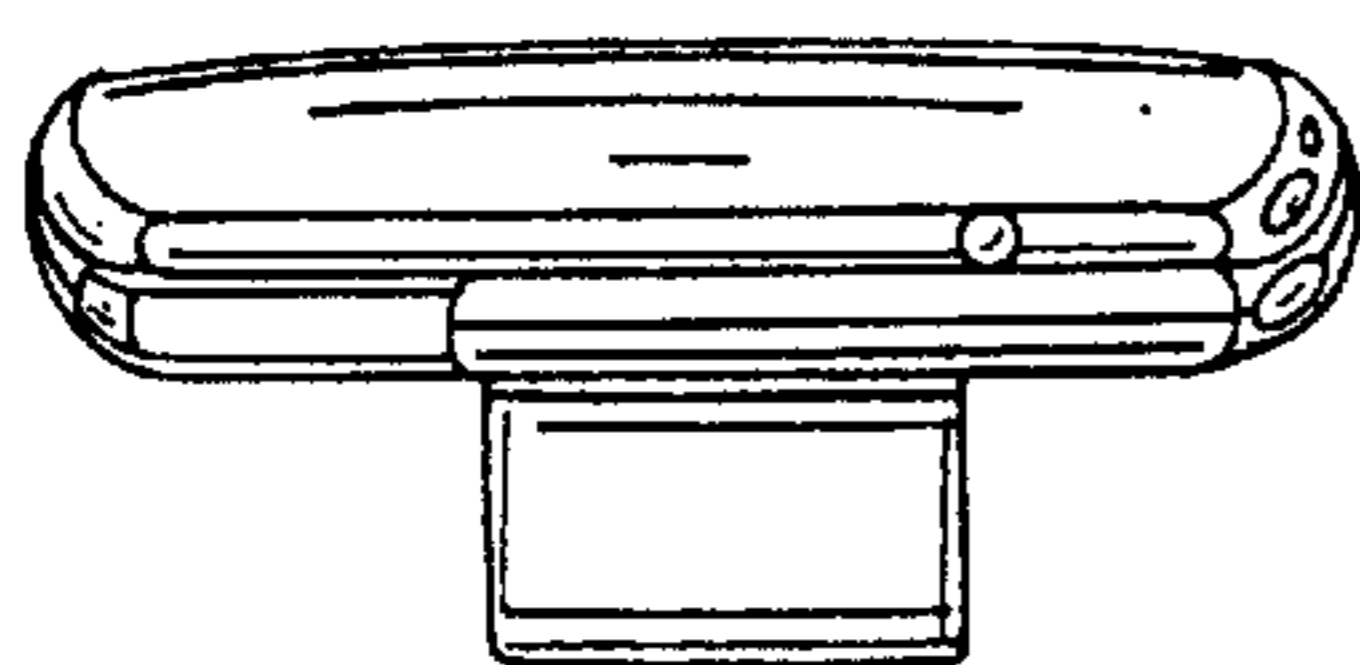

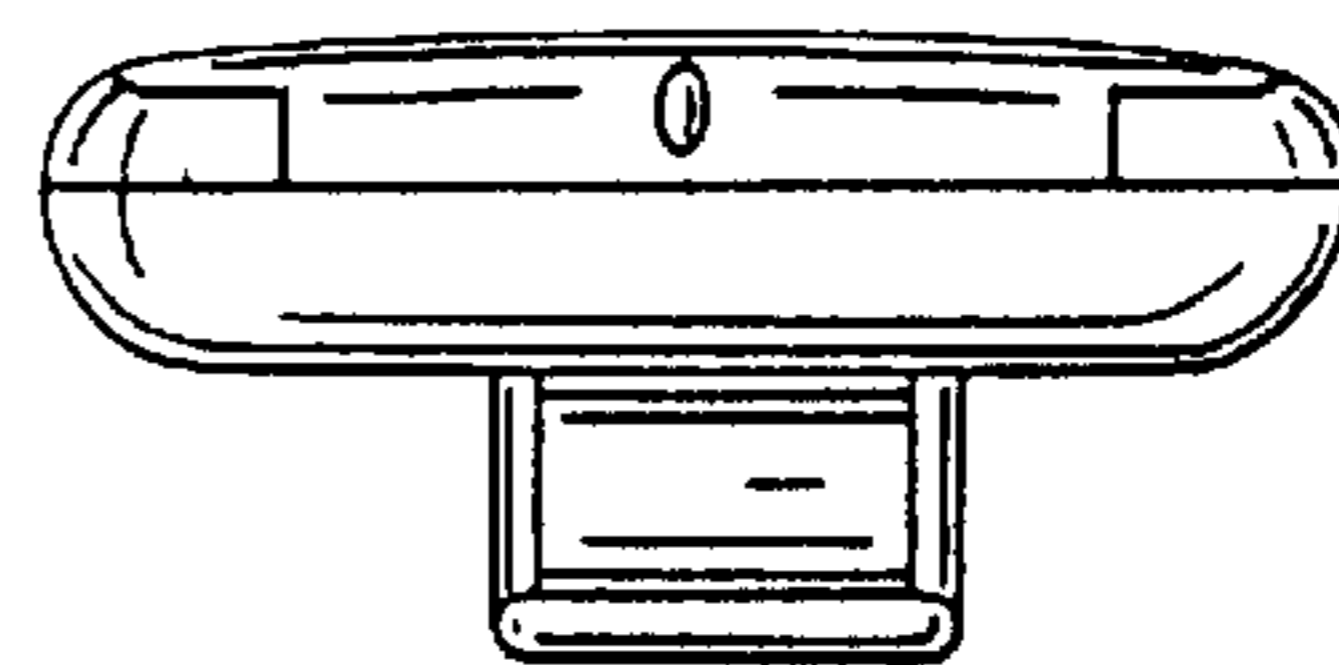
