[57] **CLAIM**

The ornamental design for a 2-wheeled attachment for a brush cutter, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a 2-wheeled attachment for a brush cutter showing my new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a rear view thereof, and;
FIG. 7 is a perspective view of the 2-wheeled attachment of FIG. 1.
FIG. 7 is shown on an enlarged scale.

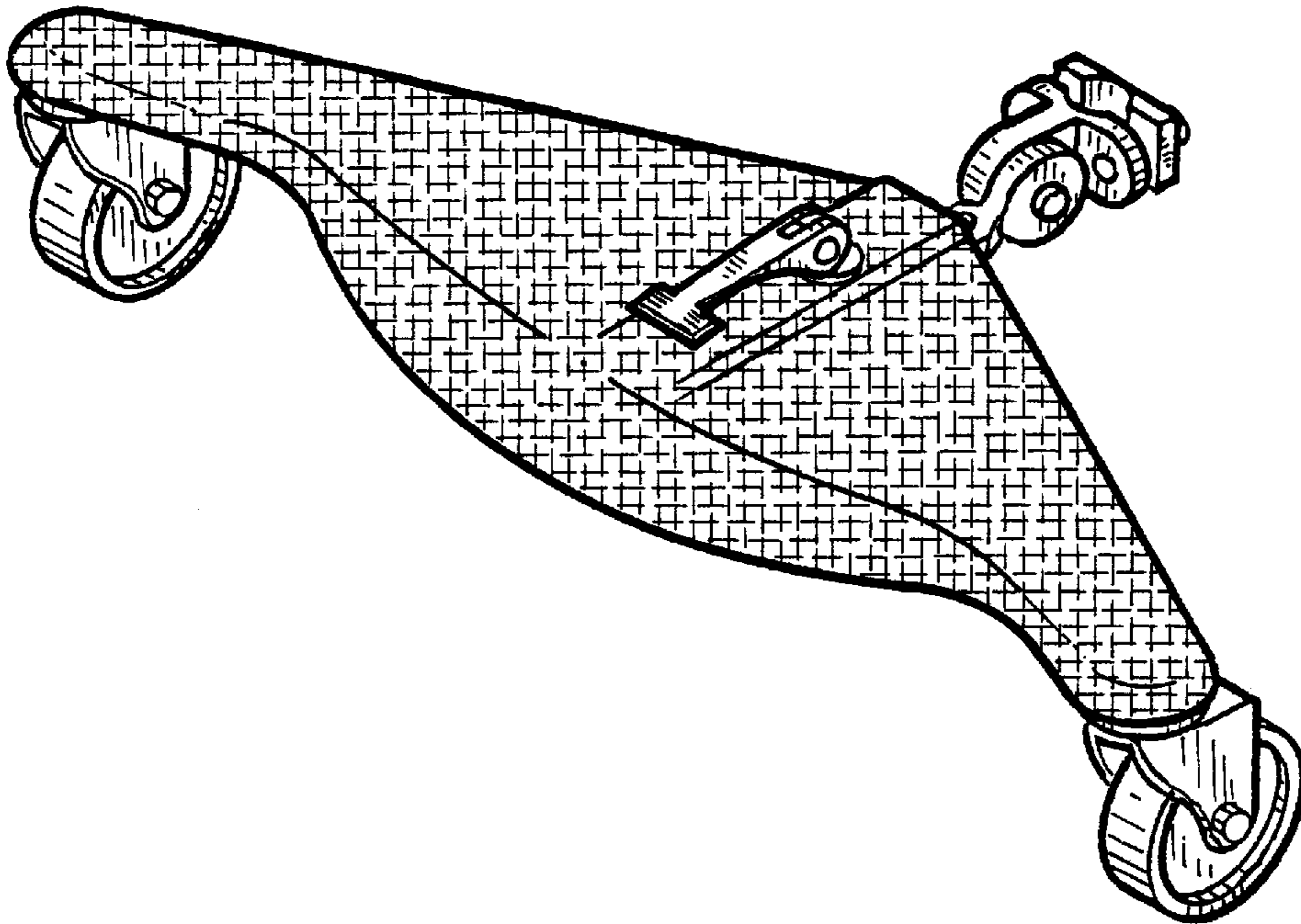

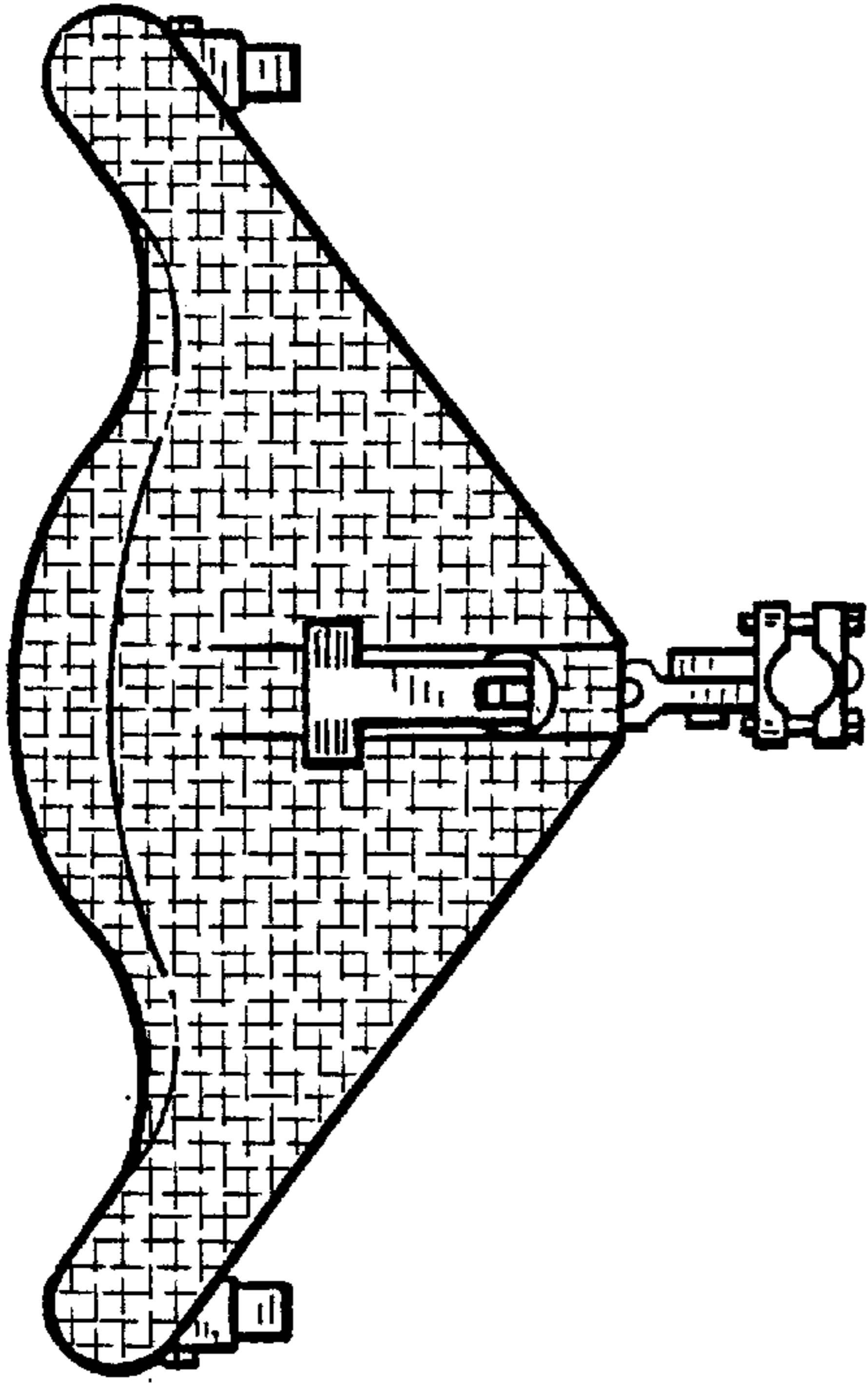

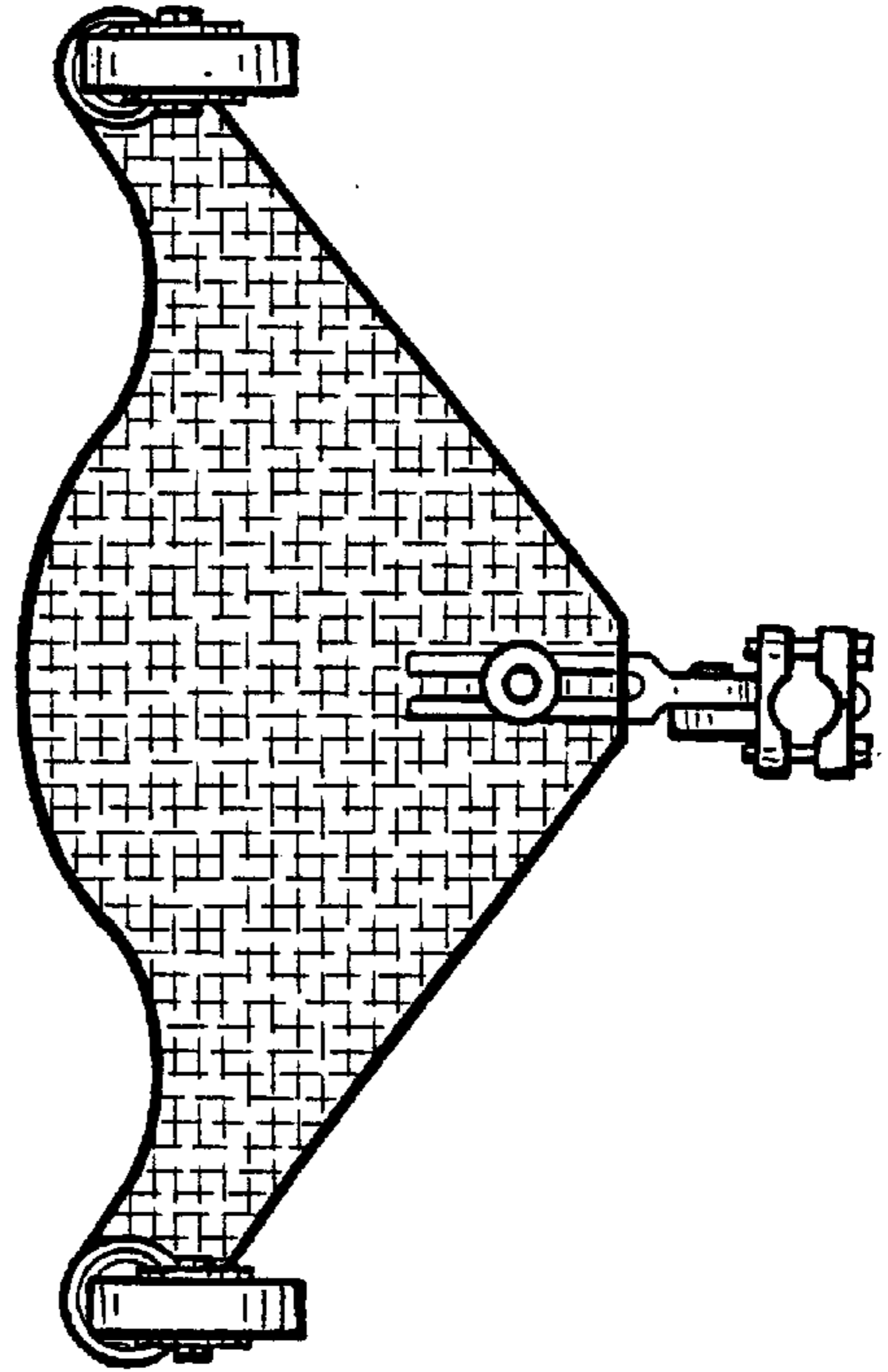

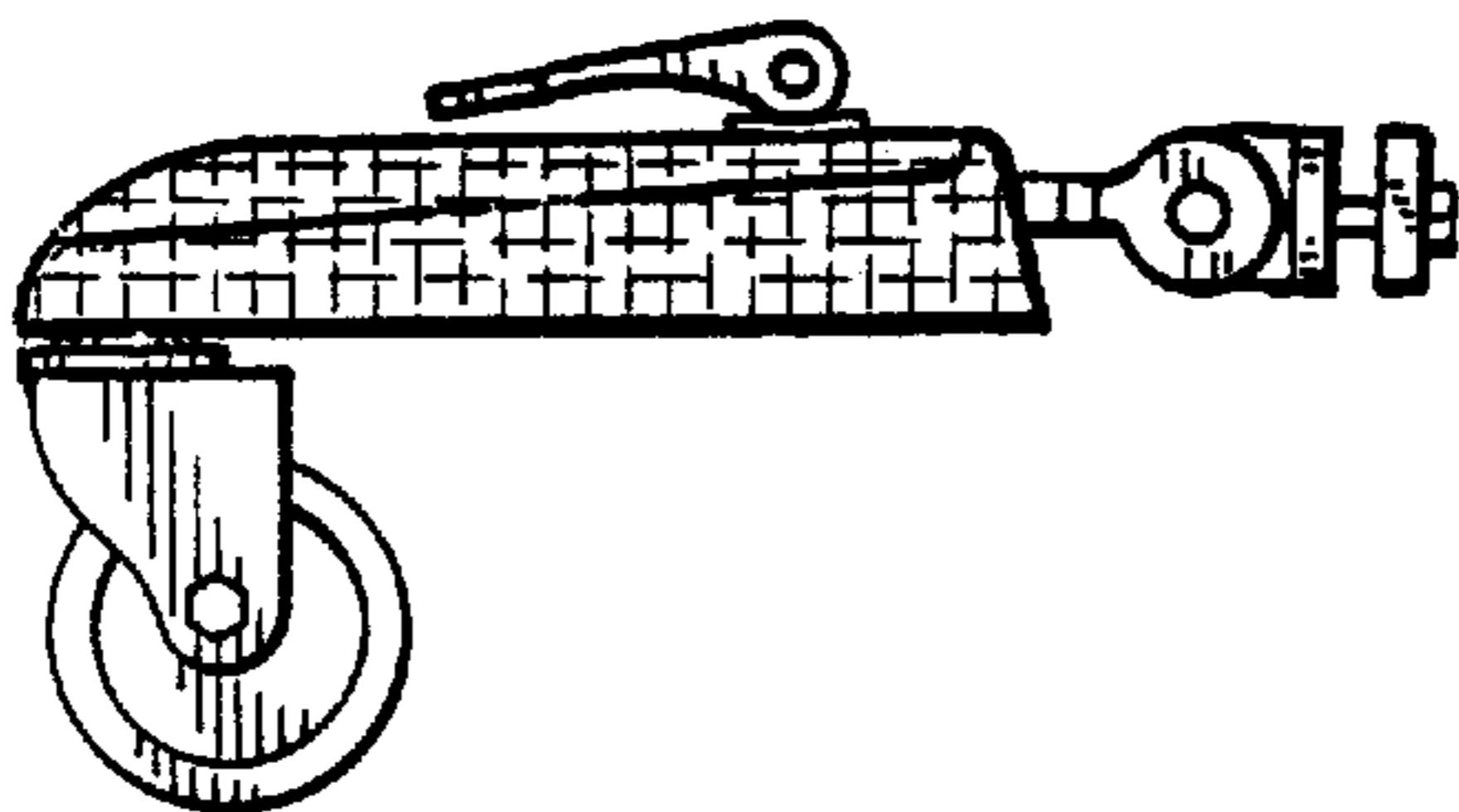

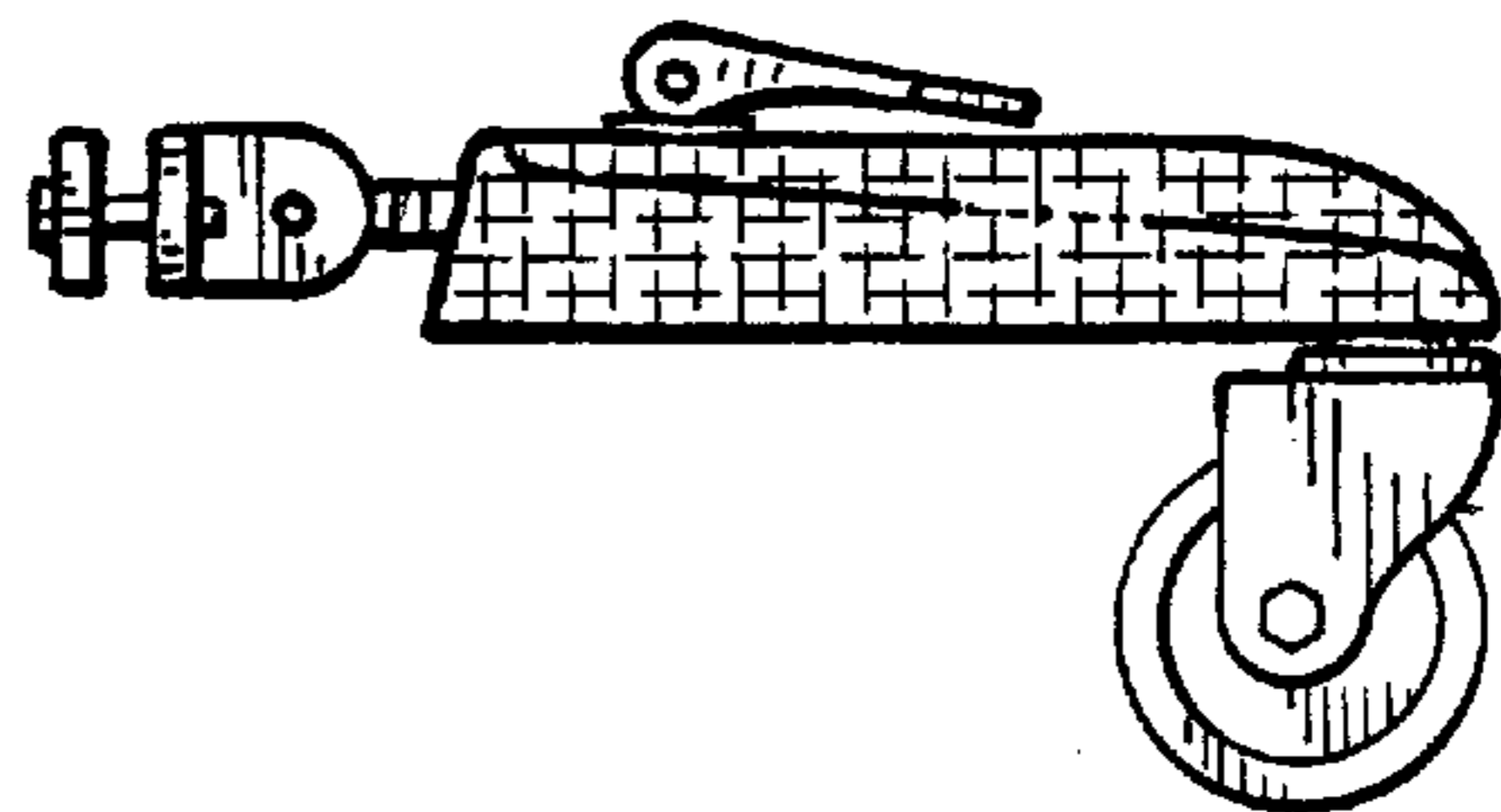

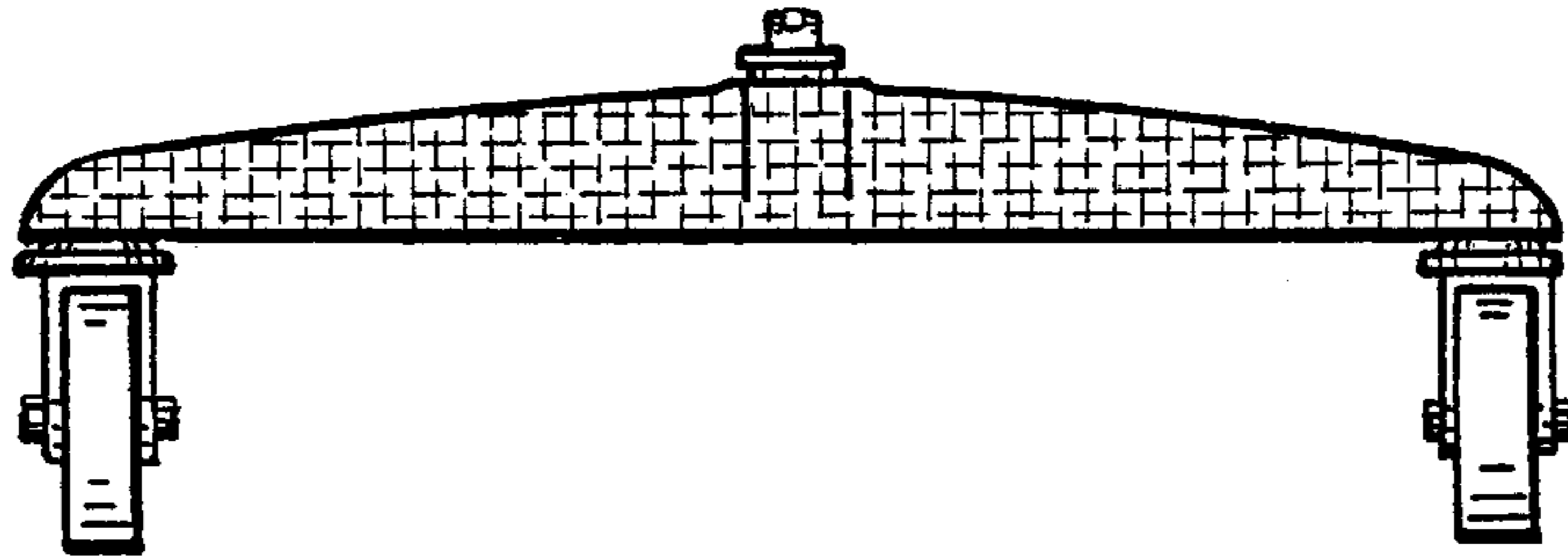

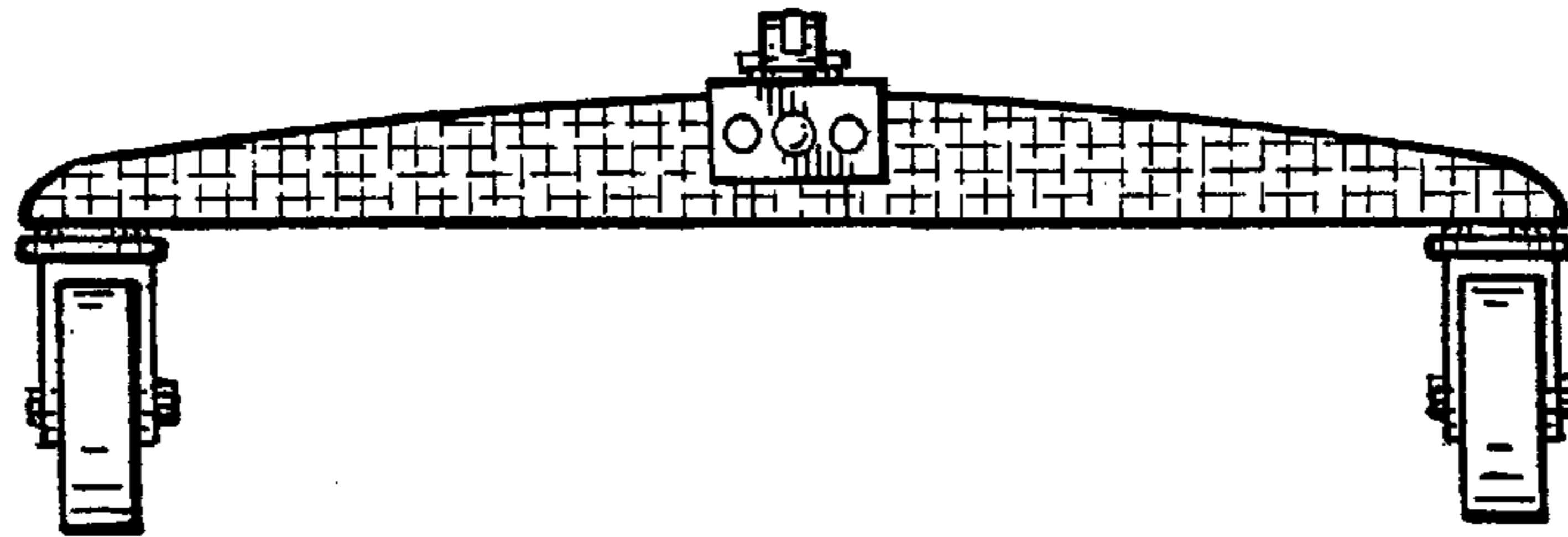
