[57] **CLAIM**

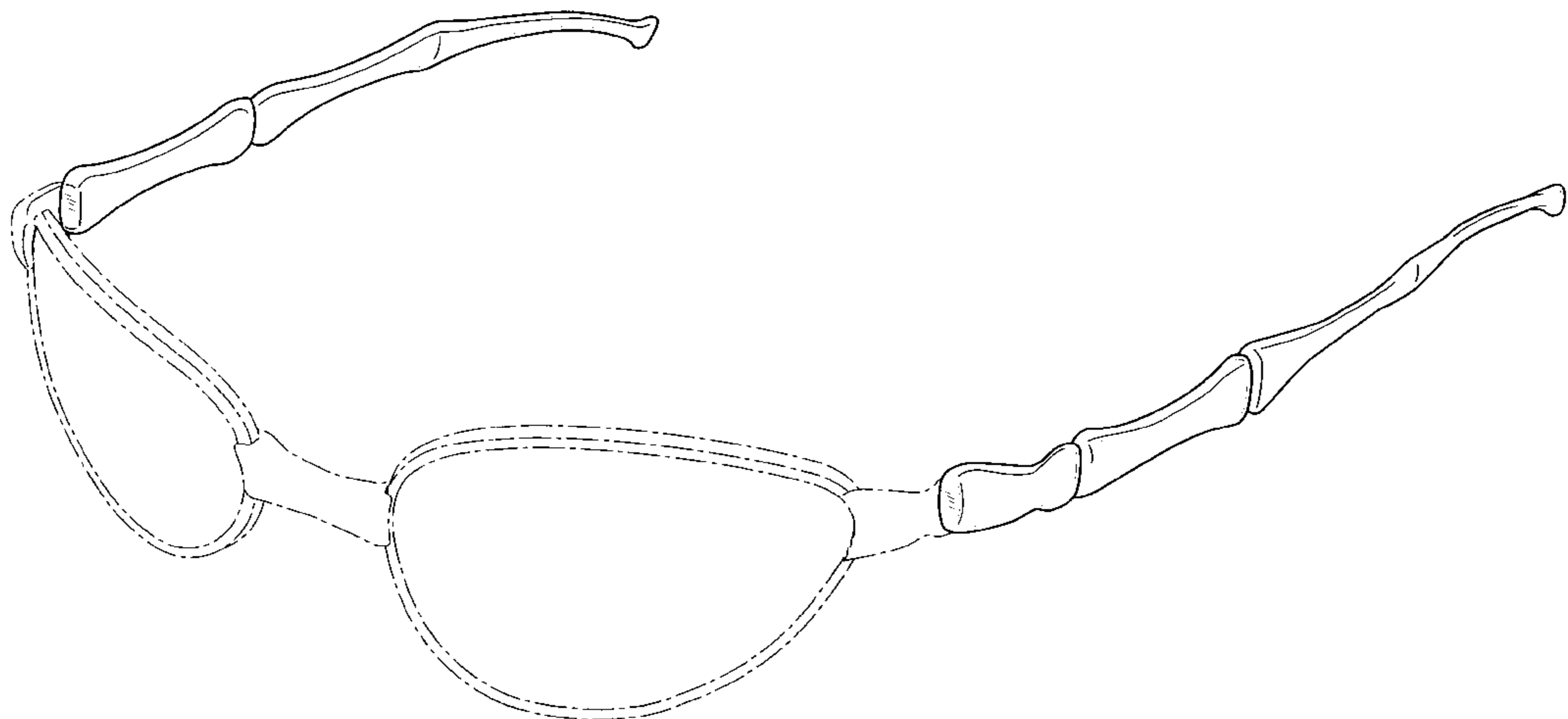
The ornamental design for a temple piece for eyewear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the temple piece for eyewear according to the present invention;
 FIG. 2 is a front view of a temple piece for eyewear of FIG. 1;
 FIG. 3 is a top view of the temple piece for eyewear of FIG. 1;
 FIG. 4 is a left side view of the temple piece for eyewear of FIG. 1;
 FIG. 5 is a right side view of the temple piece for eyewear of FIG. 1;
 FIG. 6 is a back view of the temple piece for eyewear of FIG. 1; and,
 FIG. 7 is a bottomview of the temple piece for eyewear of FIG. 1.

The broken line showing of a portion of the eyewear in FIGS. 1-7 is for illustrative purposes only and forms no part of the claimed design.

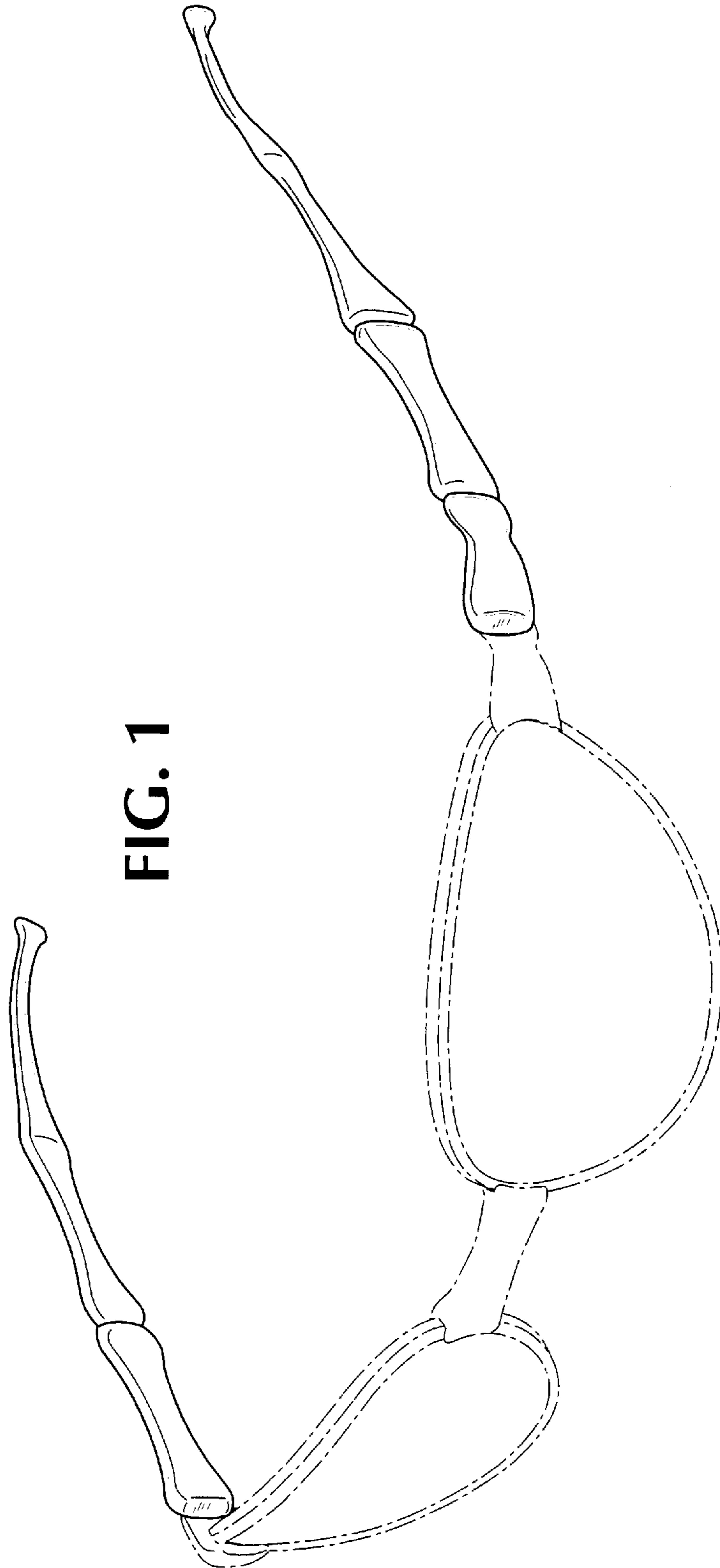

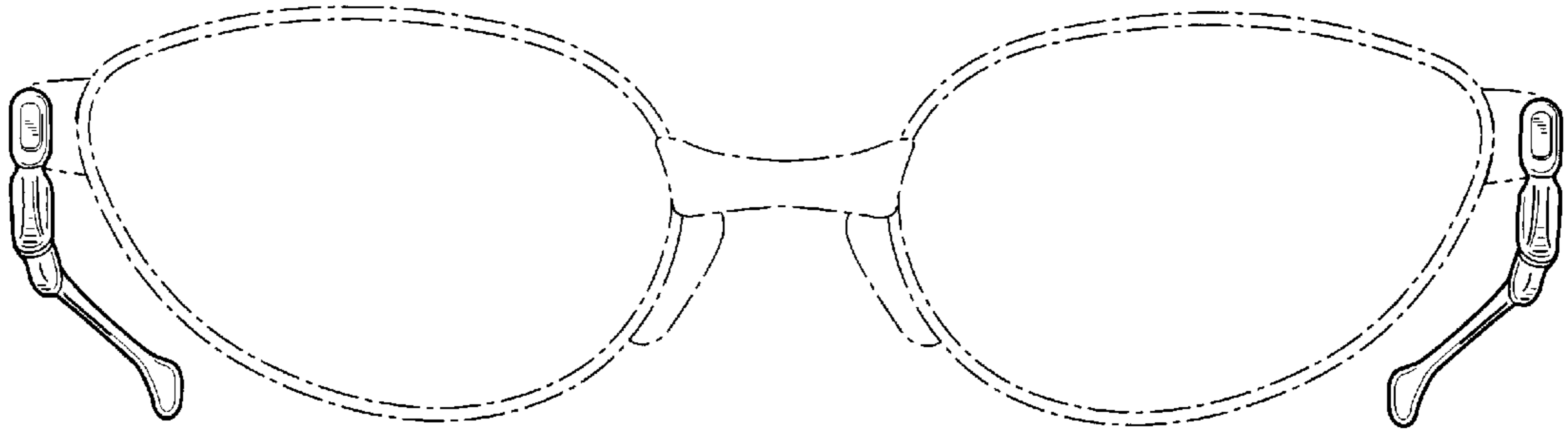

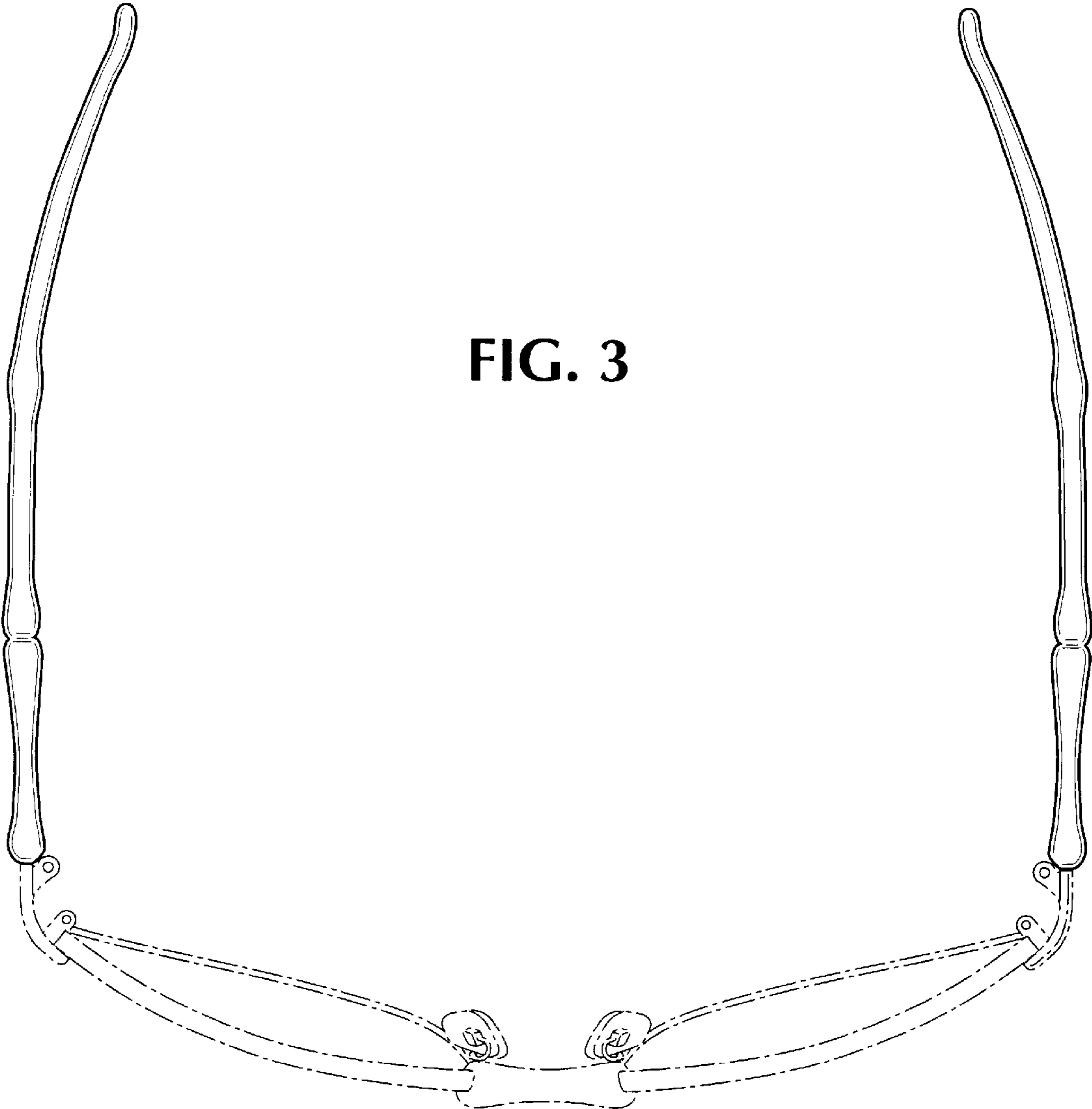

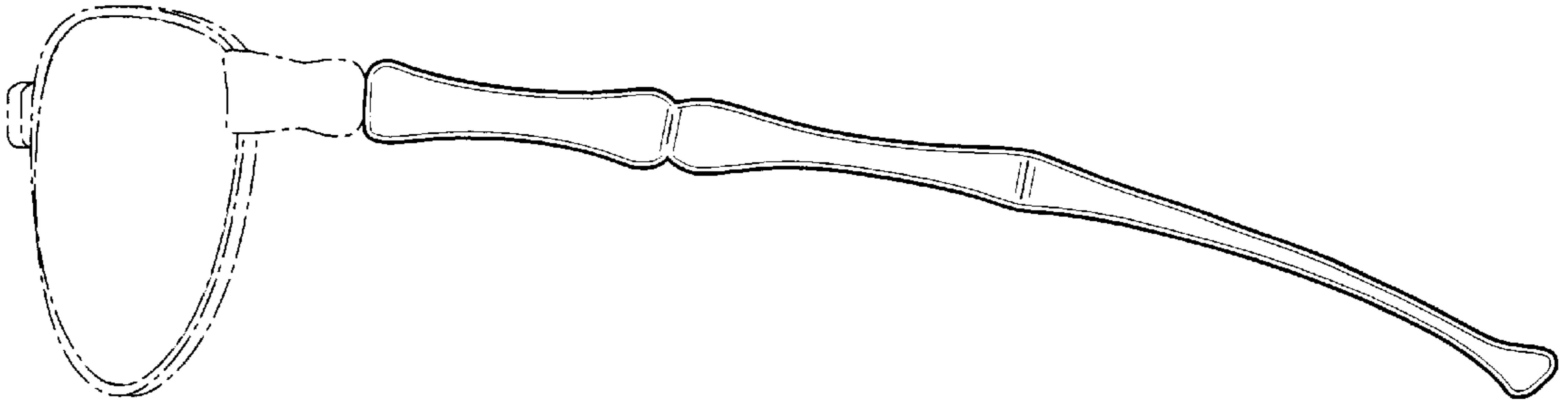

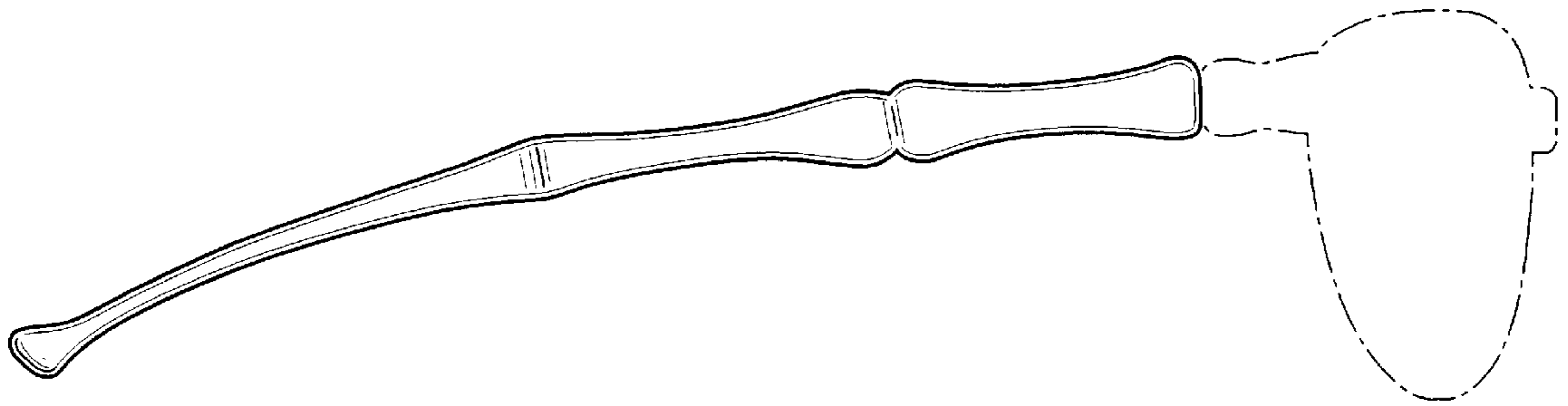

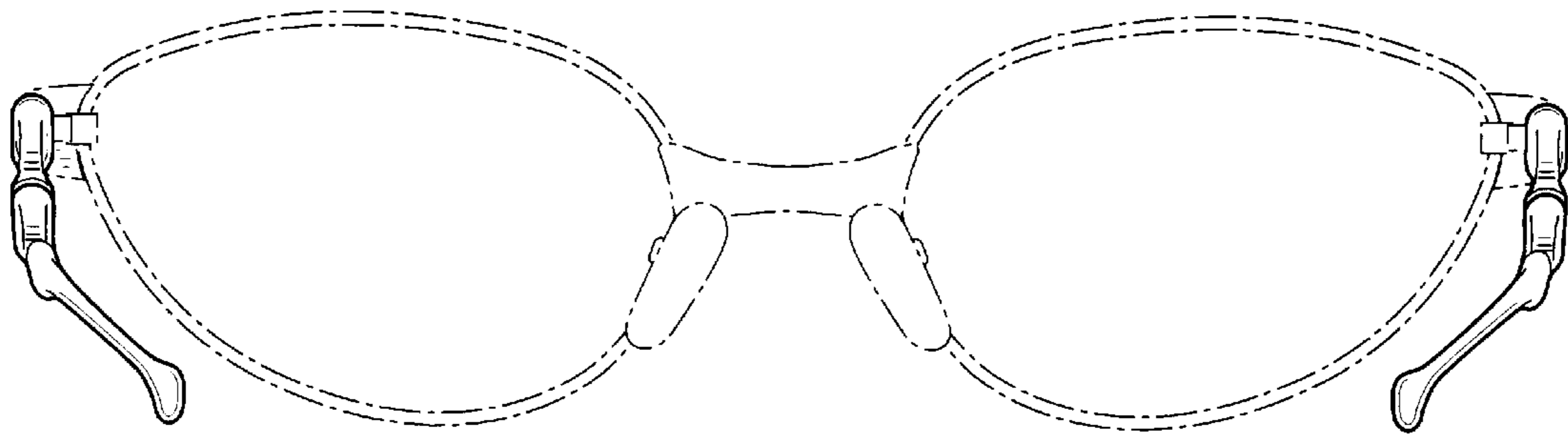
