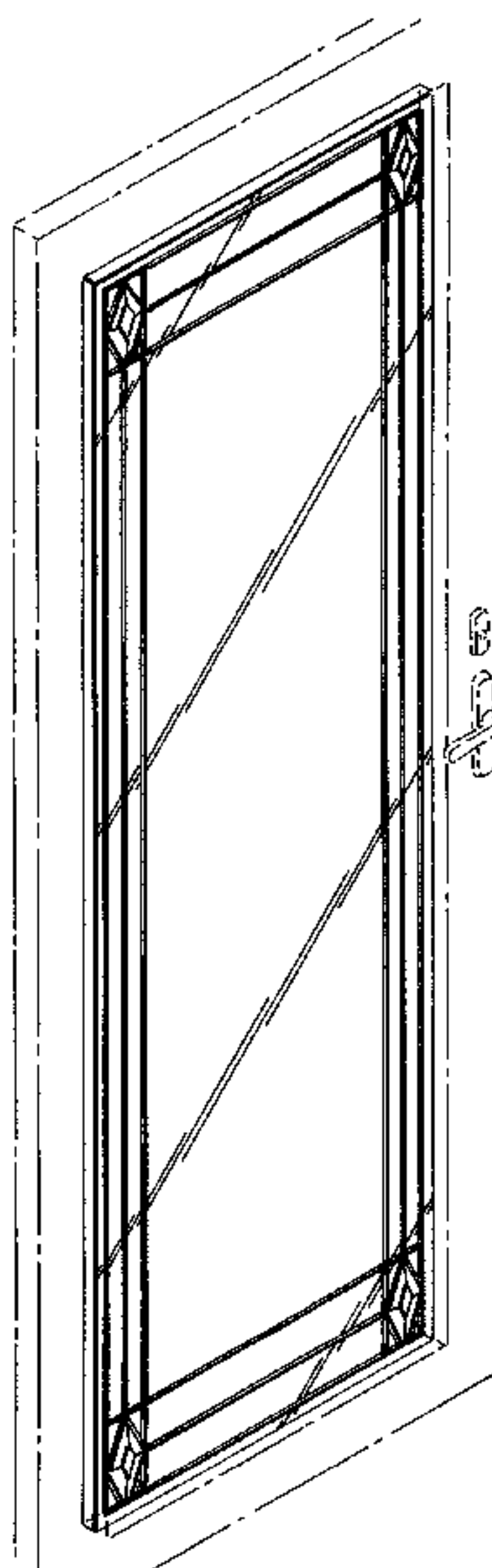
[57] **CLAIM**

The ornamental design for glass door with brass trim and beveled facets, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a full view glass door with brass trim and beveled facets showing my new design;  
 FIG. 2 is a front plan view thereof;  
 FIG. 3 is a right side elevational view, the left side elevational view being a mirror image thereof;  
 FIG. 4 is a bottom plan view, the top plan view being a mirror image thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is an enlarged side elevational view taken generally along the lines 6—6 of FIG. 2;  
 FIG. 7 is an enlarged fragmentary top plan view of a portion of FIG. 1;  
 FIG. 8 is a perspective mid view of a mid view glass door with brass trim and beveled facets showing my new design;  
 FIG. 9 is a front plan view thereof;  
 FIG. 10 is the right side elevational view, the left side elevational view being a mirror image thereof;  
 FIG. 11 is a bottom plan view, the top plan view being a mirror image thereof;  
 FIG. 12 is a rear elevational view thereof;  
 FIG. 13 is an enlarged side elevational view taken generally along the lines 13—13 of FIG. 8;  
 FIG. 14 is an enlarged fragmentary top plan view of a portion of FIG. 8; and  
 FIG. 15 is a perspective view of a high view glass door with brass trim and beveled facets showing my new design;  
 FIG. 16 is a front plan view thereof;  
 FIG. 17 is the right side elevational view, the left side elevational view being a mirror image thereof;  
 FIG. 18 is a bottom plan view, the top plan view being a mirror image thereof;  
 FIG. 19 is a rear elevational view thereof;  
 FIG. 20 is an enlarged side elevational view taken generally along the lines 20—20 of FIG. 16; and  
 FIG. 21 is an enlarged fragmentary top plan view of a portion of FIG. 15.  
 The broken lines shown in FIGS. 1, 8 and 15 are for illustrative purposes only and form no part of the claimed design.

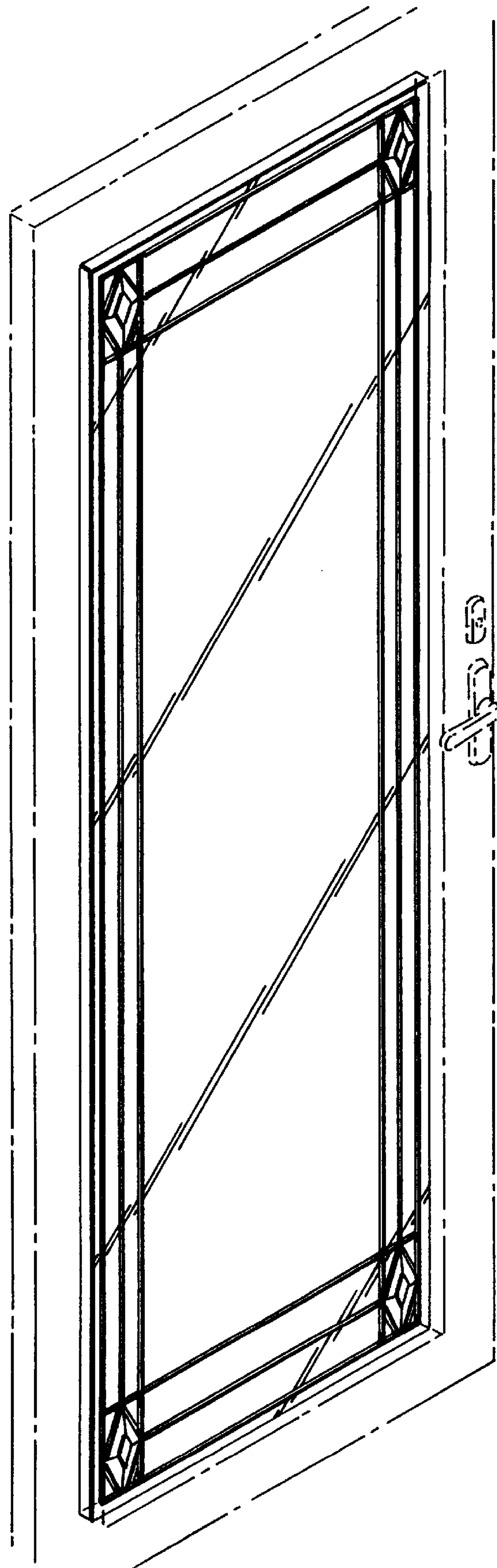

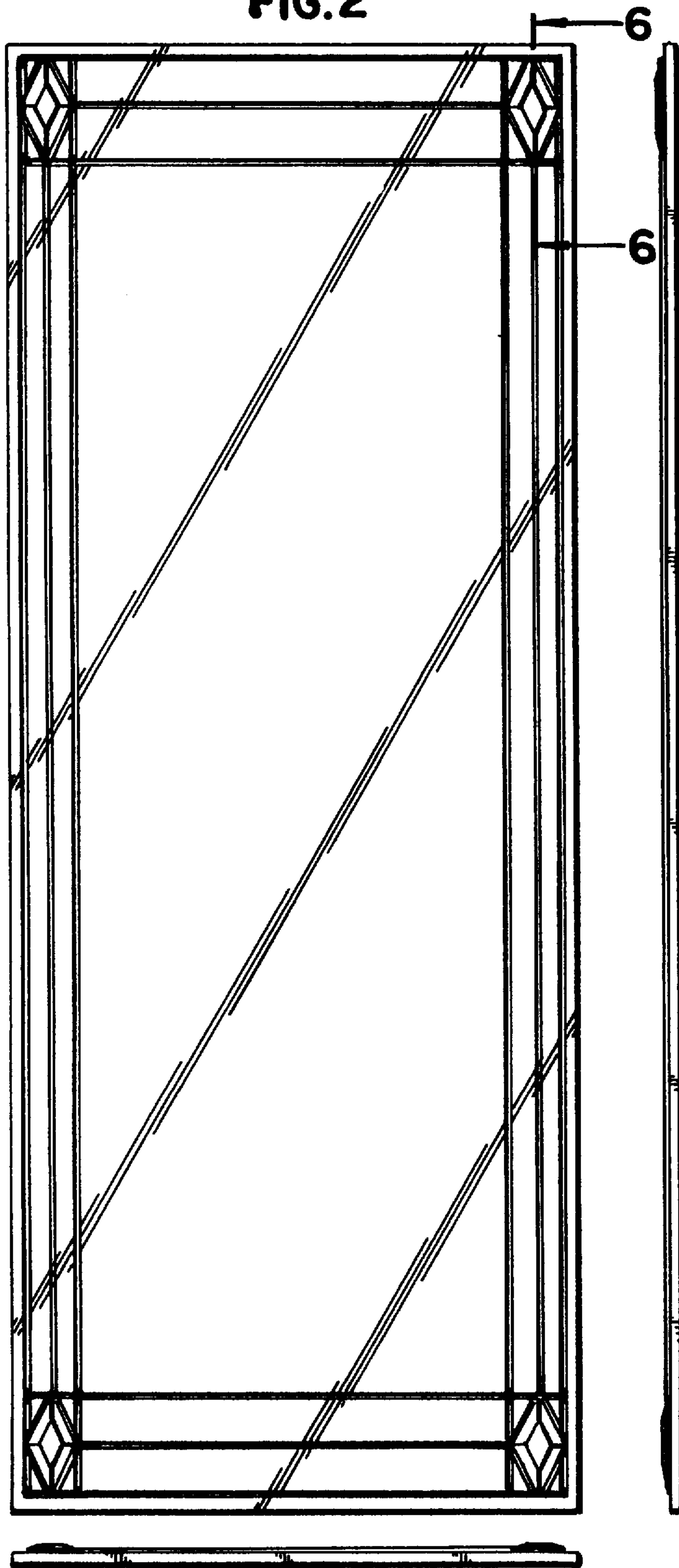

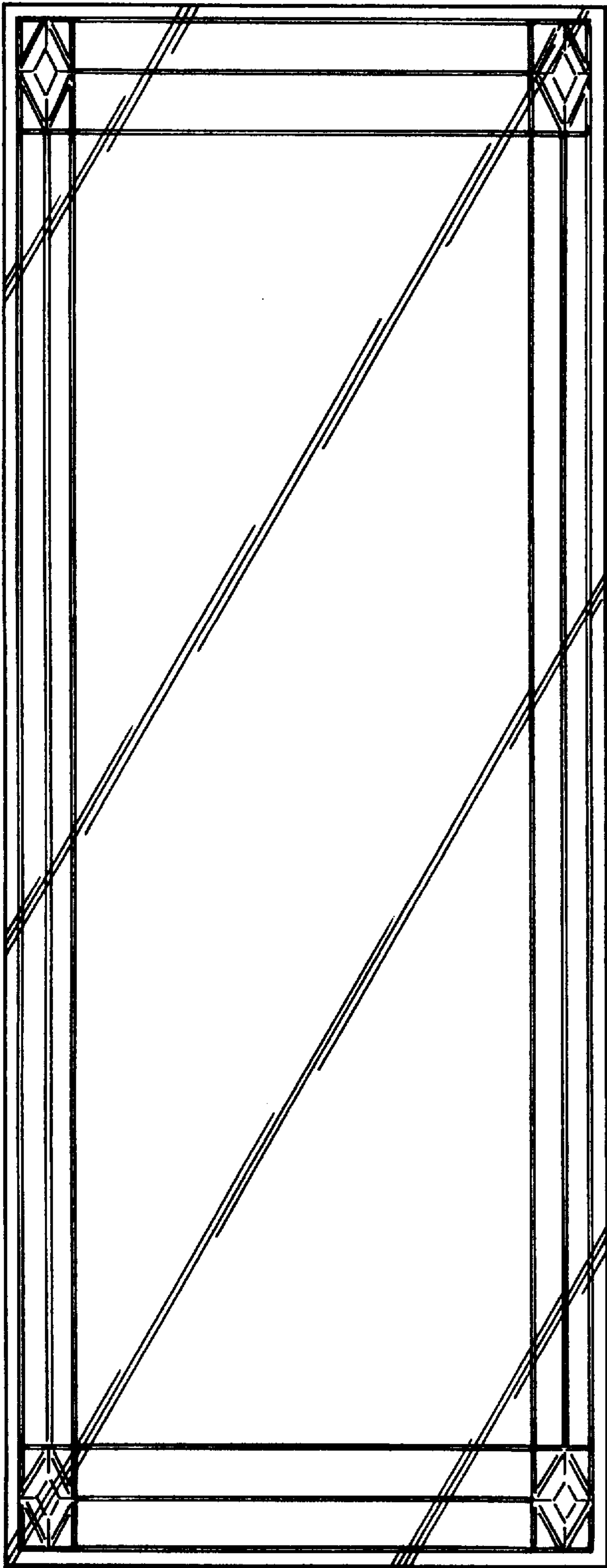

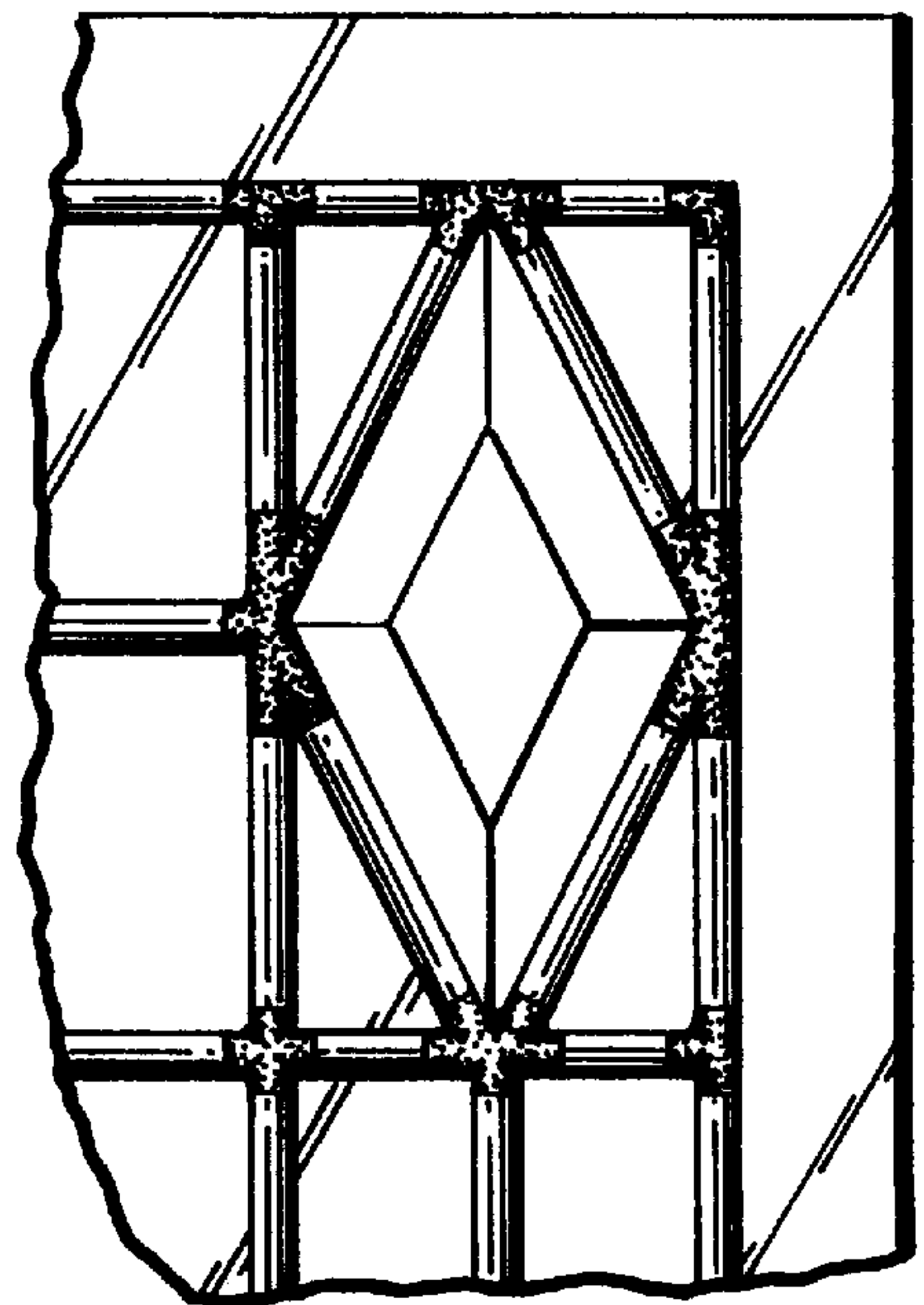
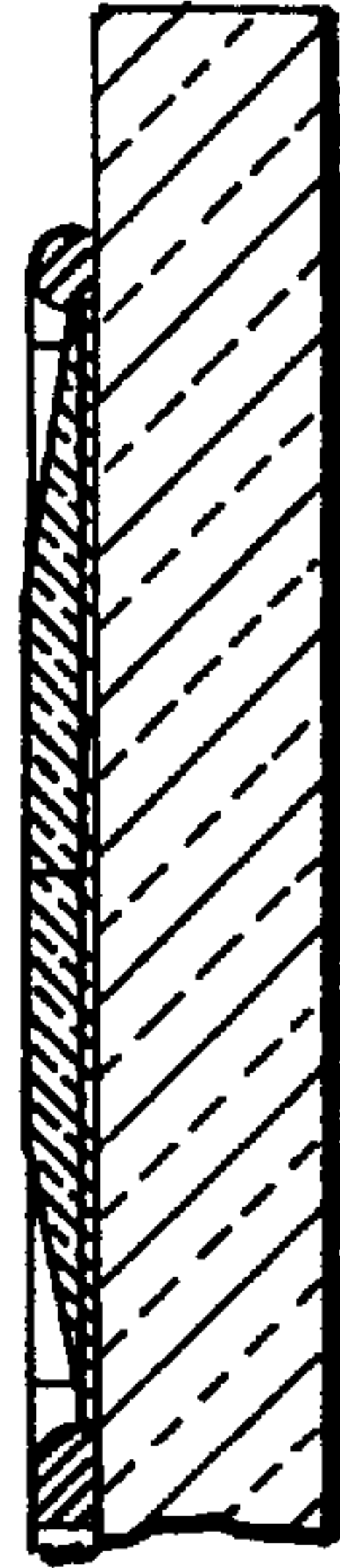

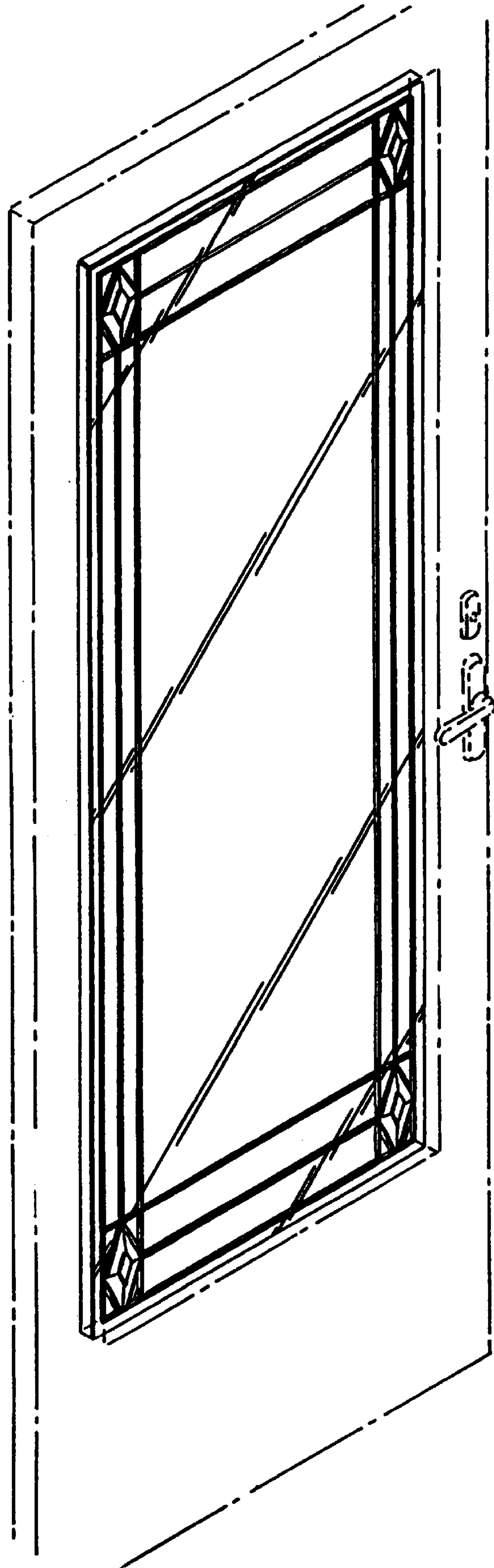

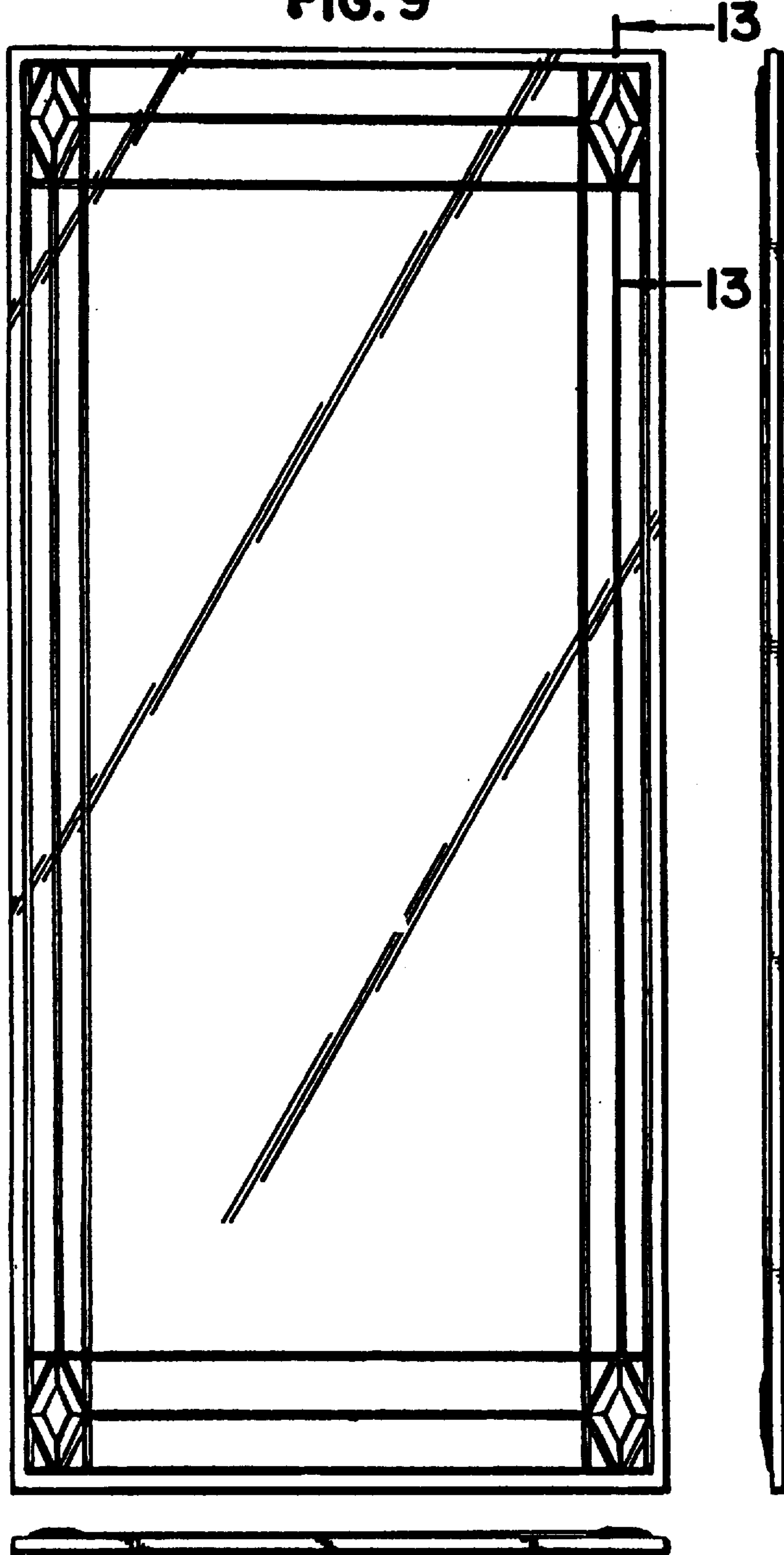

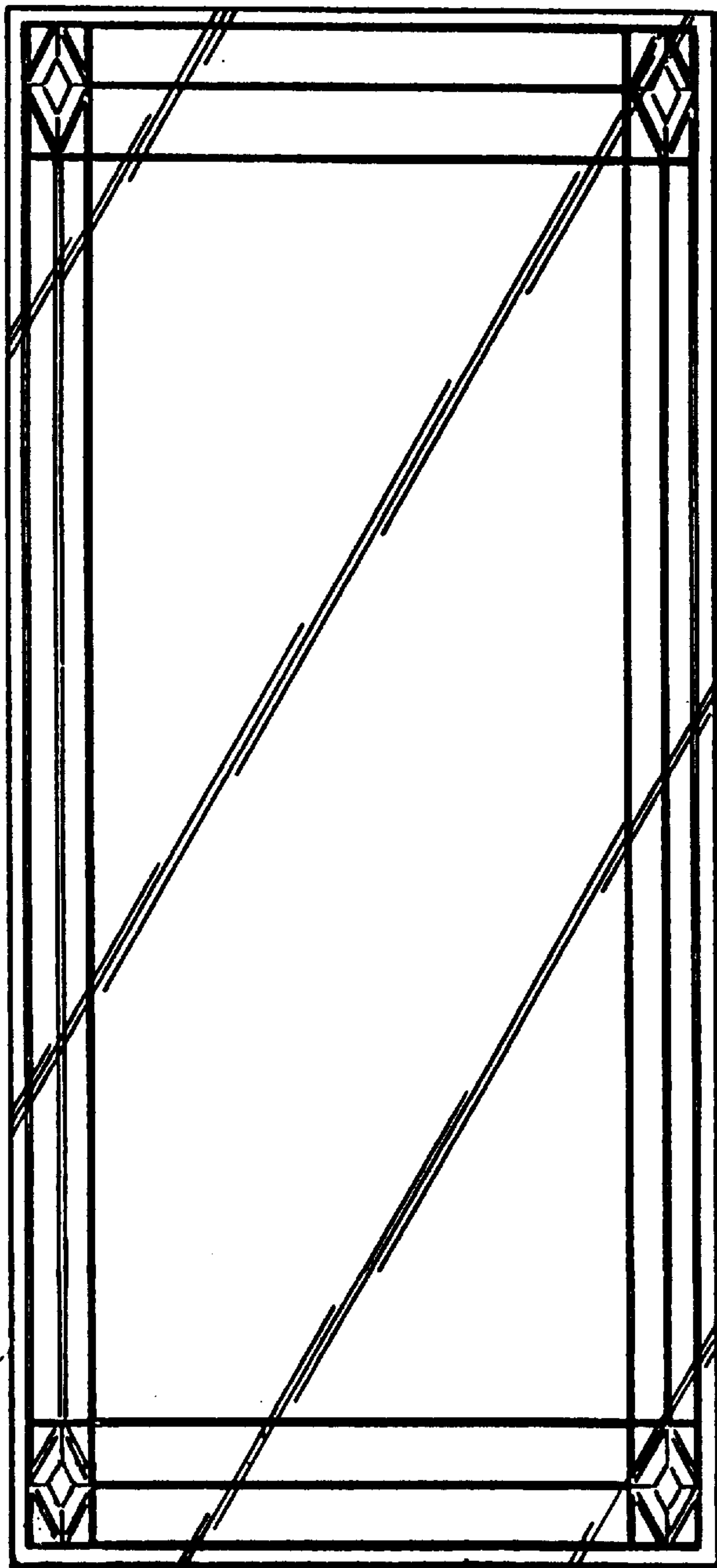

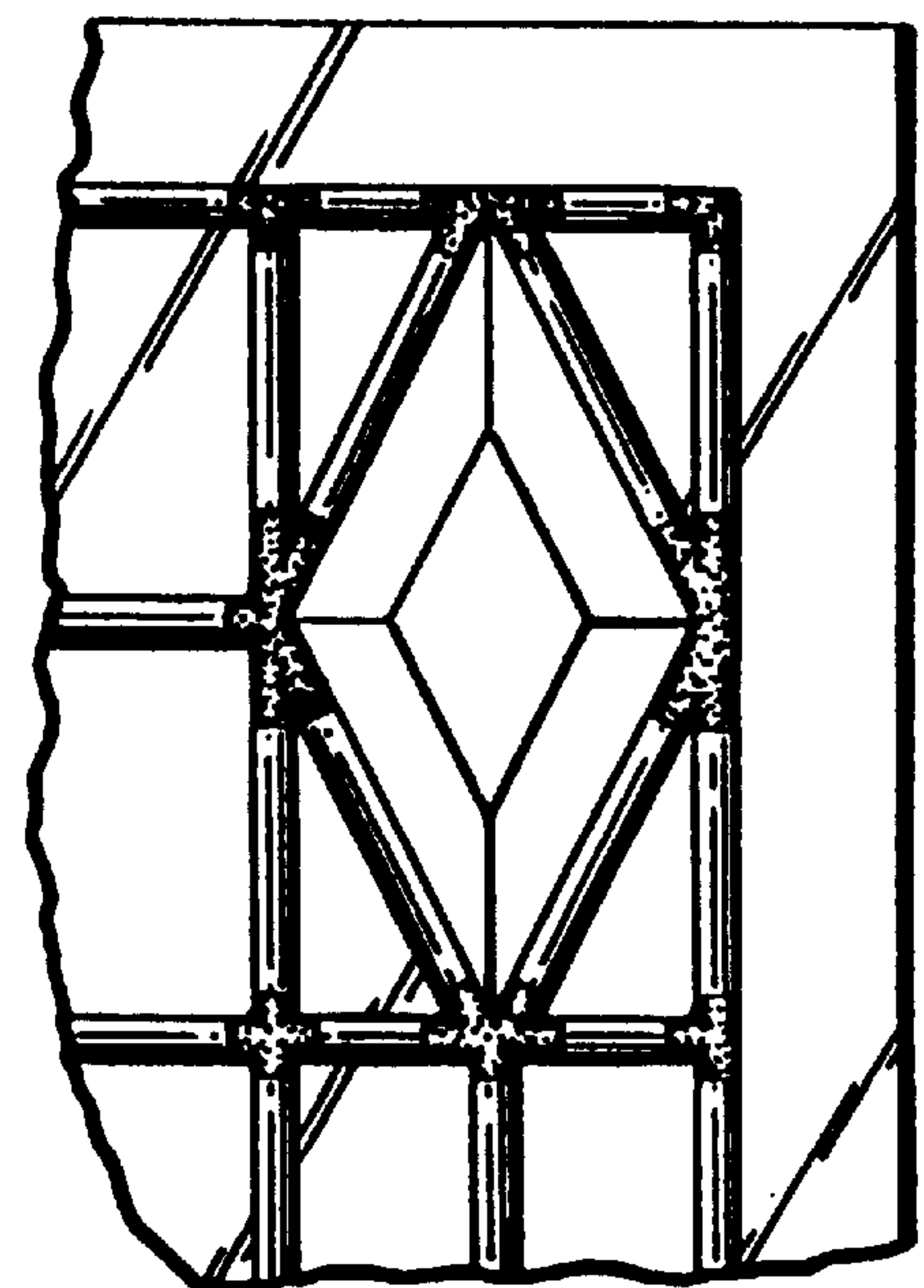
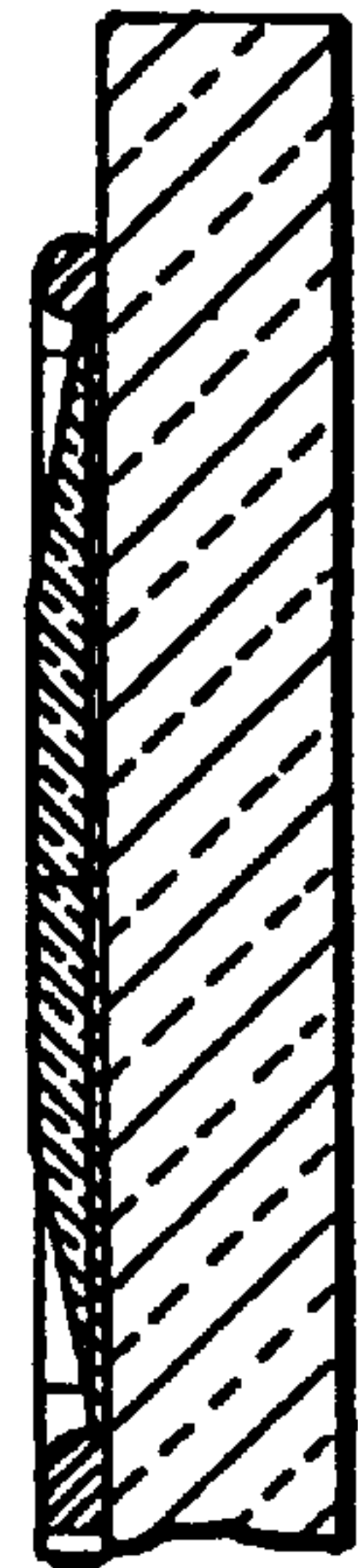

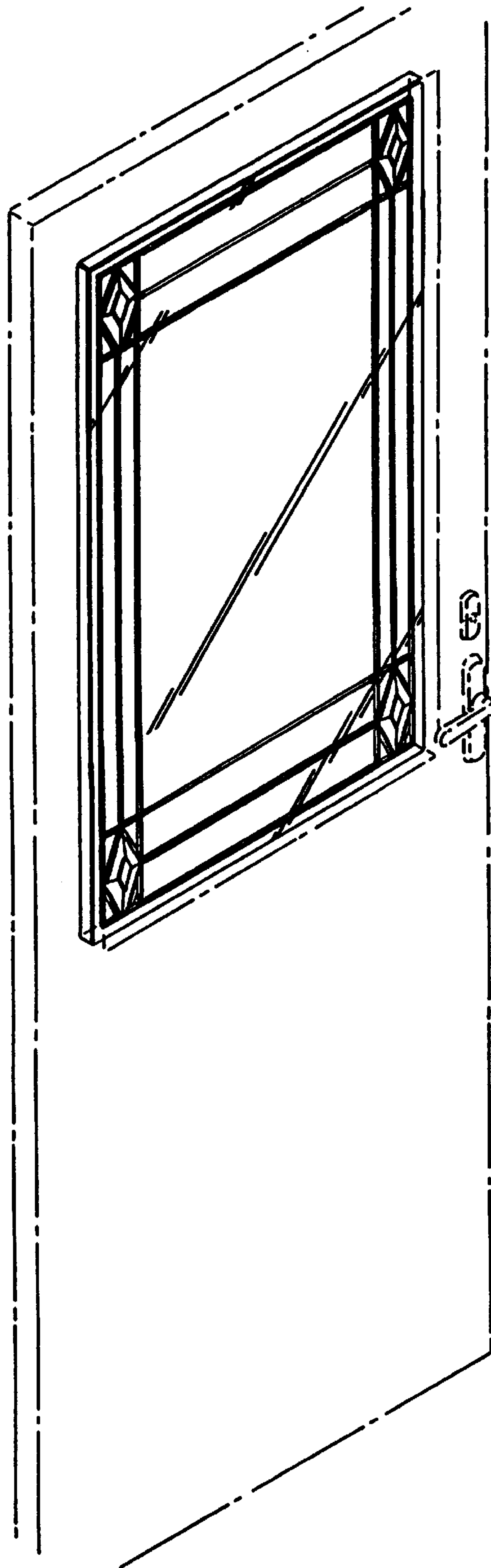

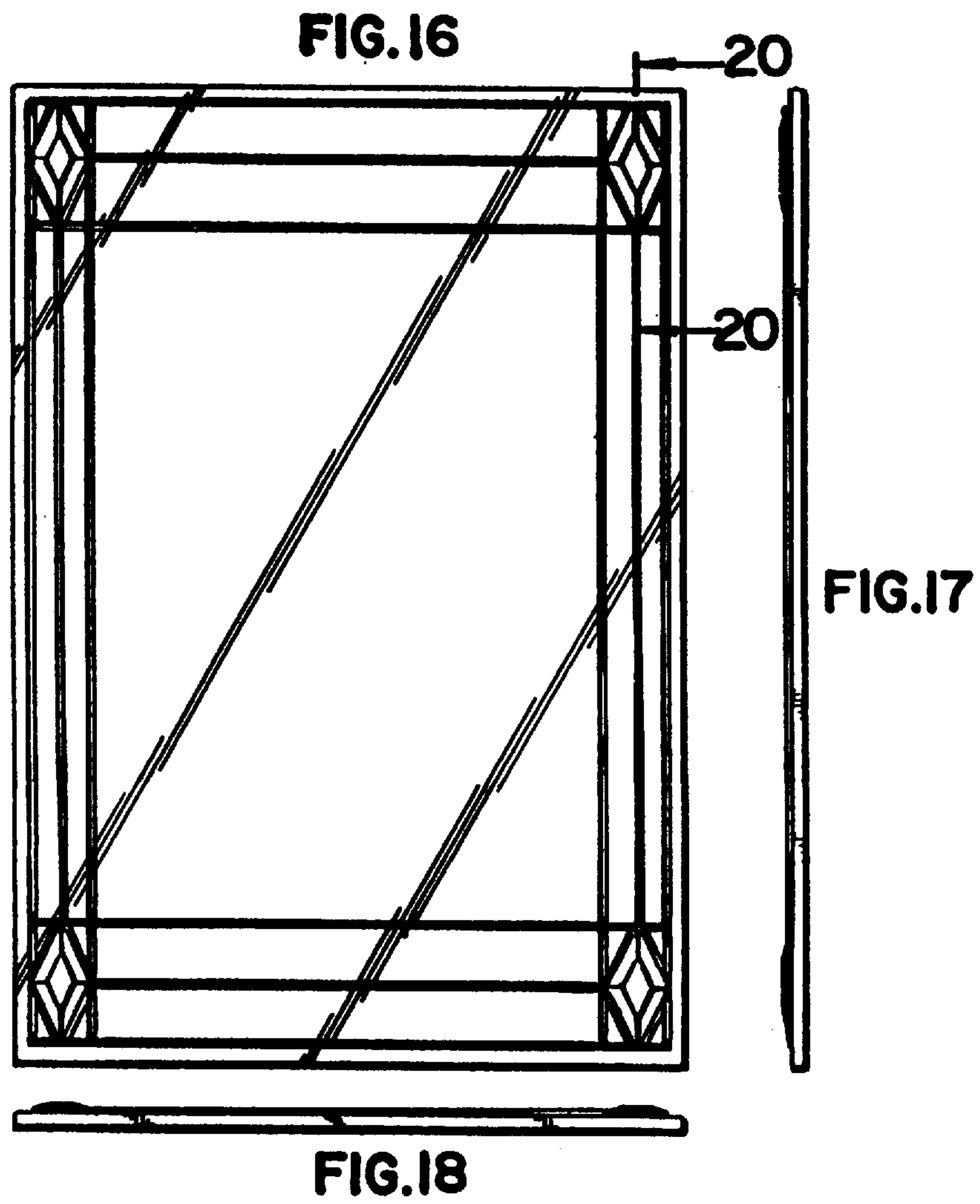

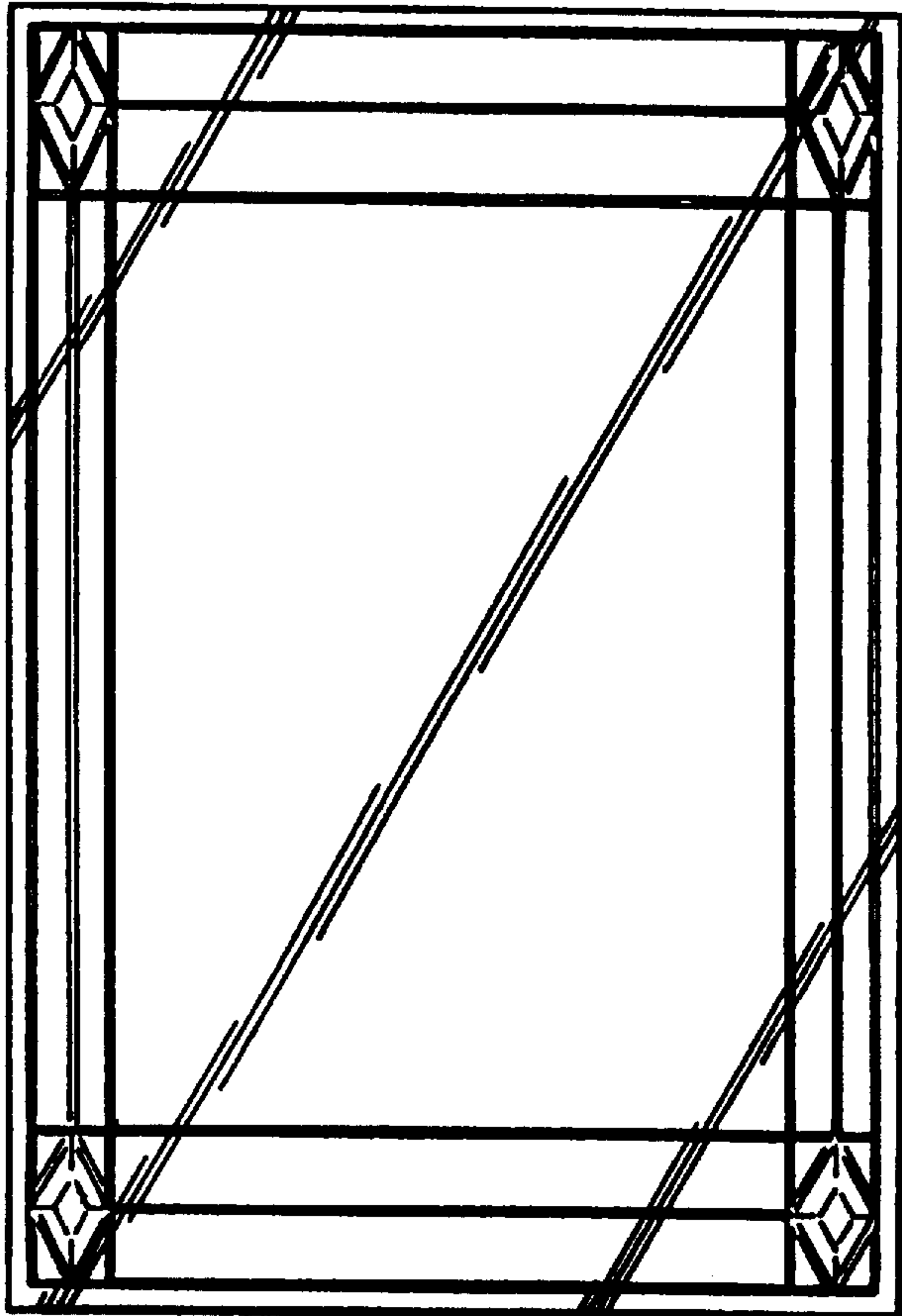

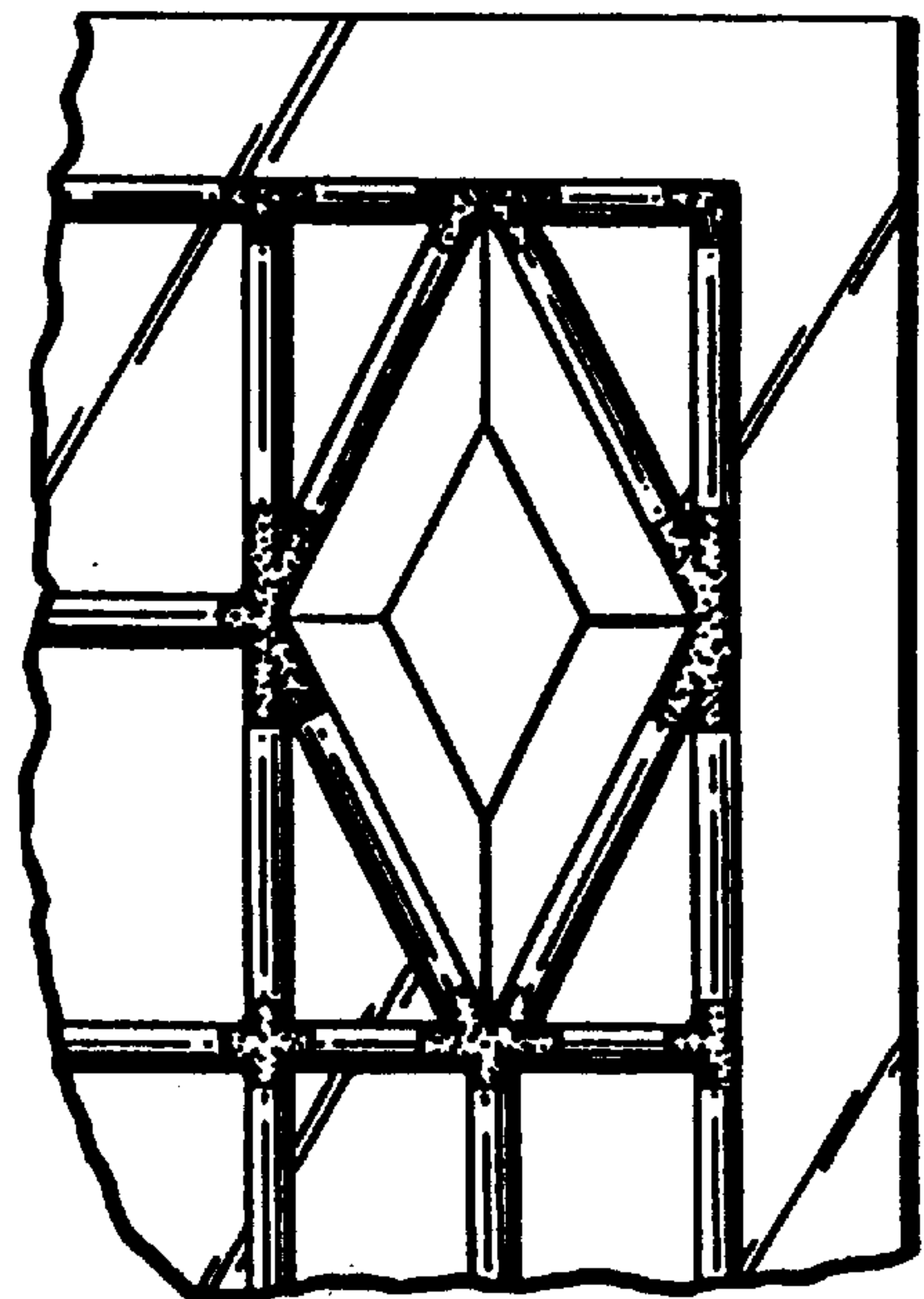
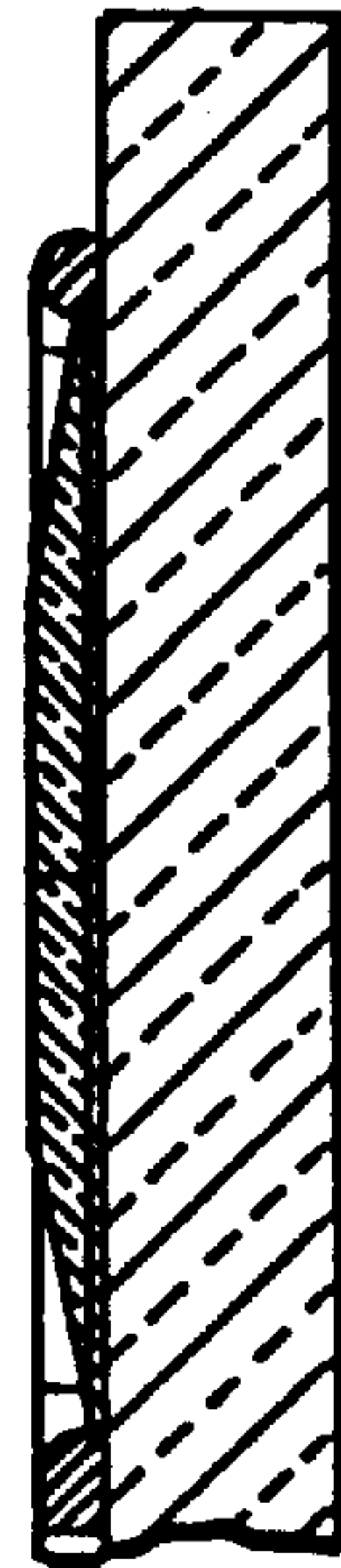
