The ornamental design for a depilator, as shown.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a depilator, showing my design;

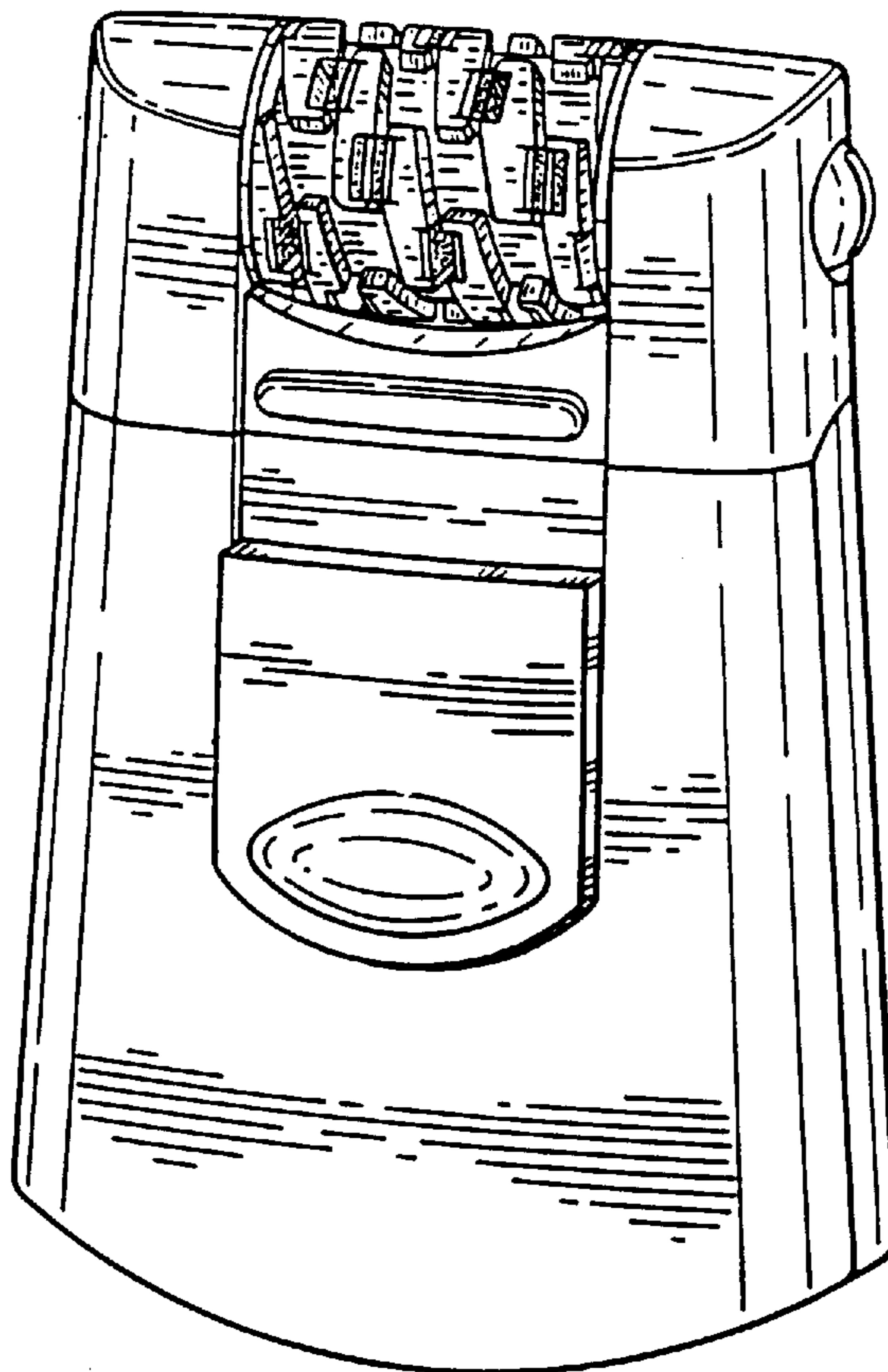

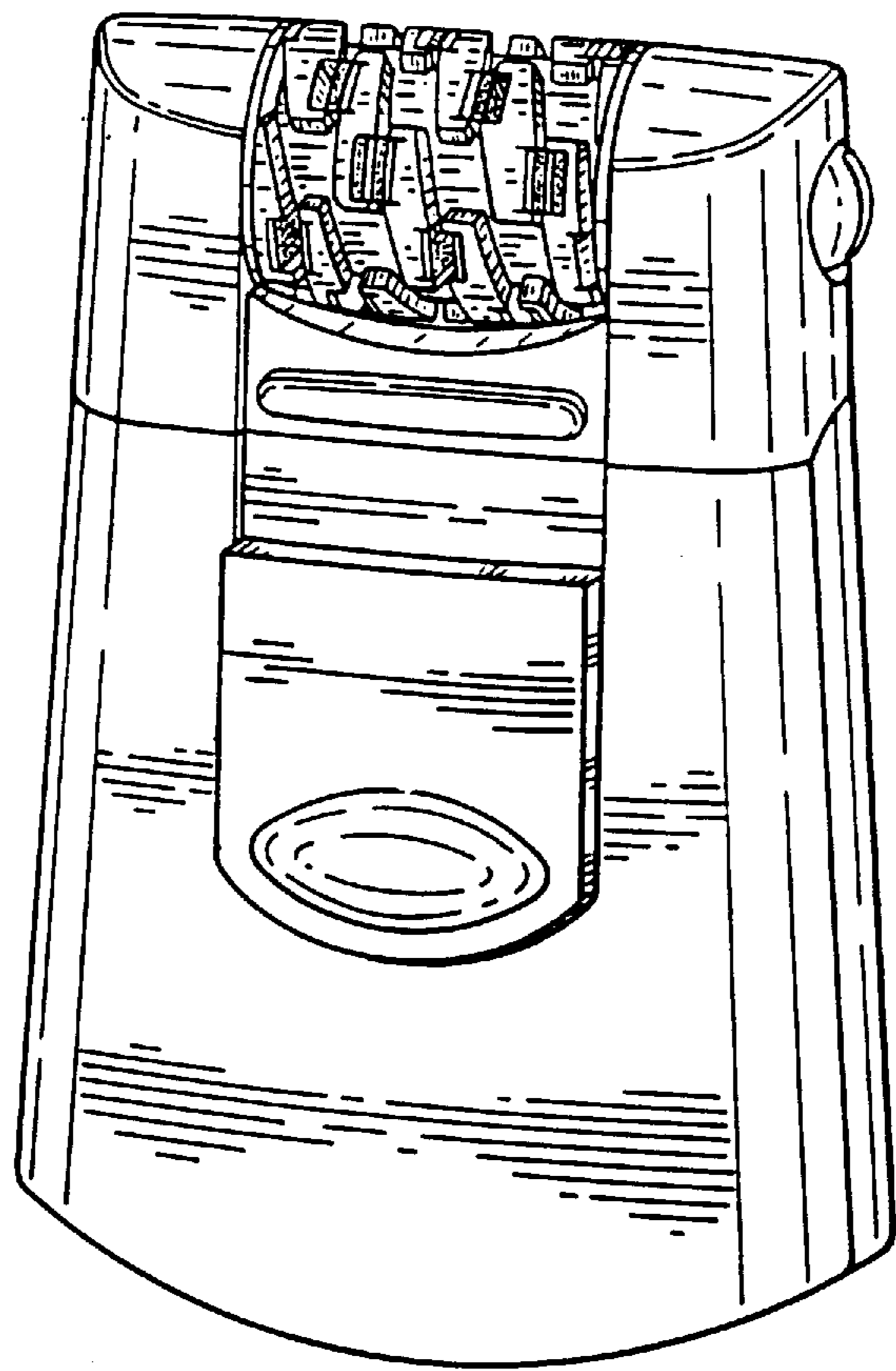

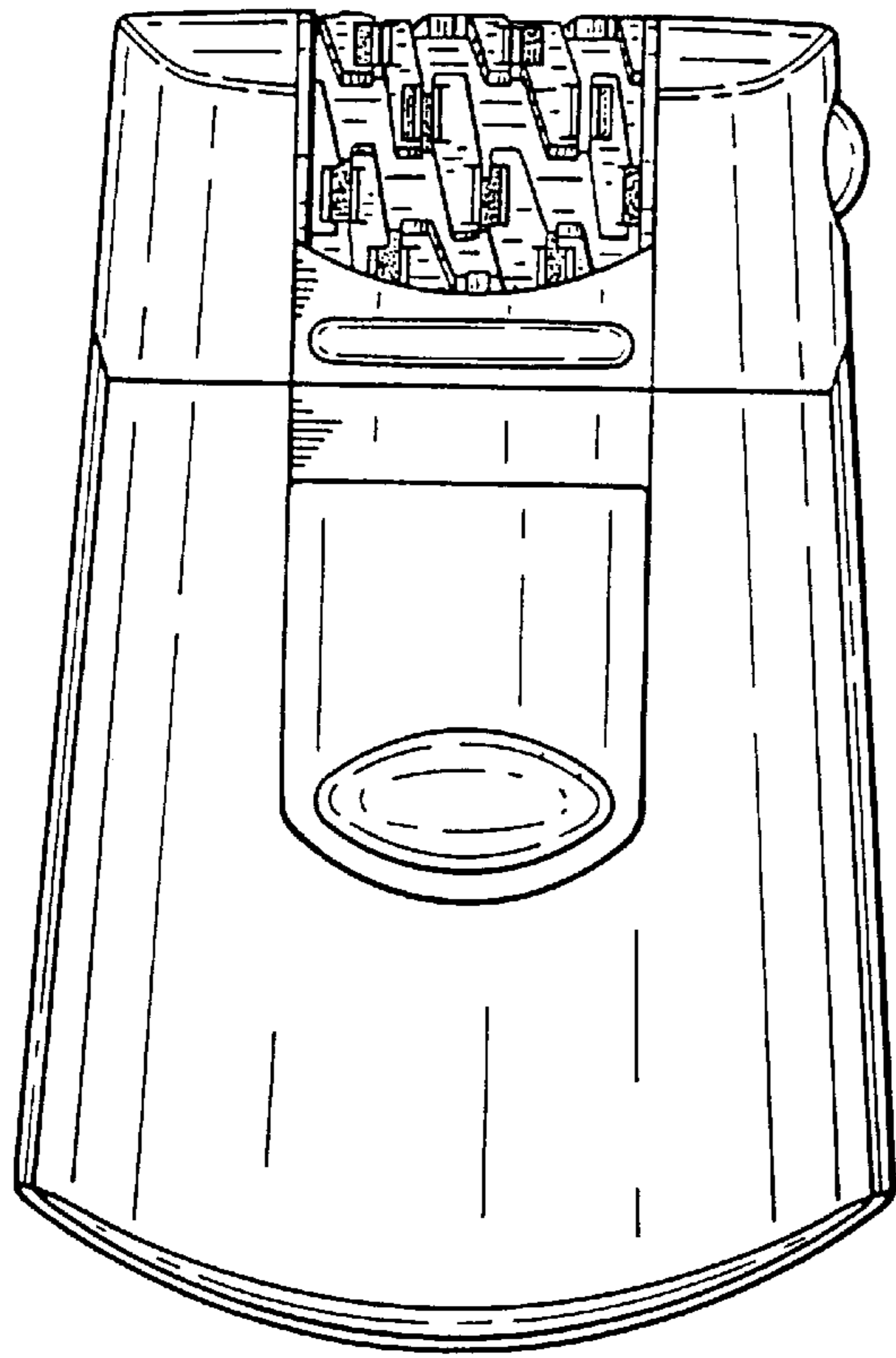

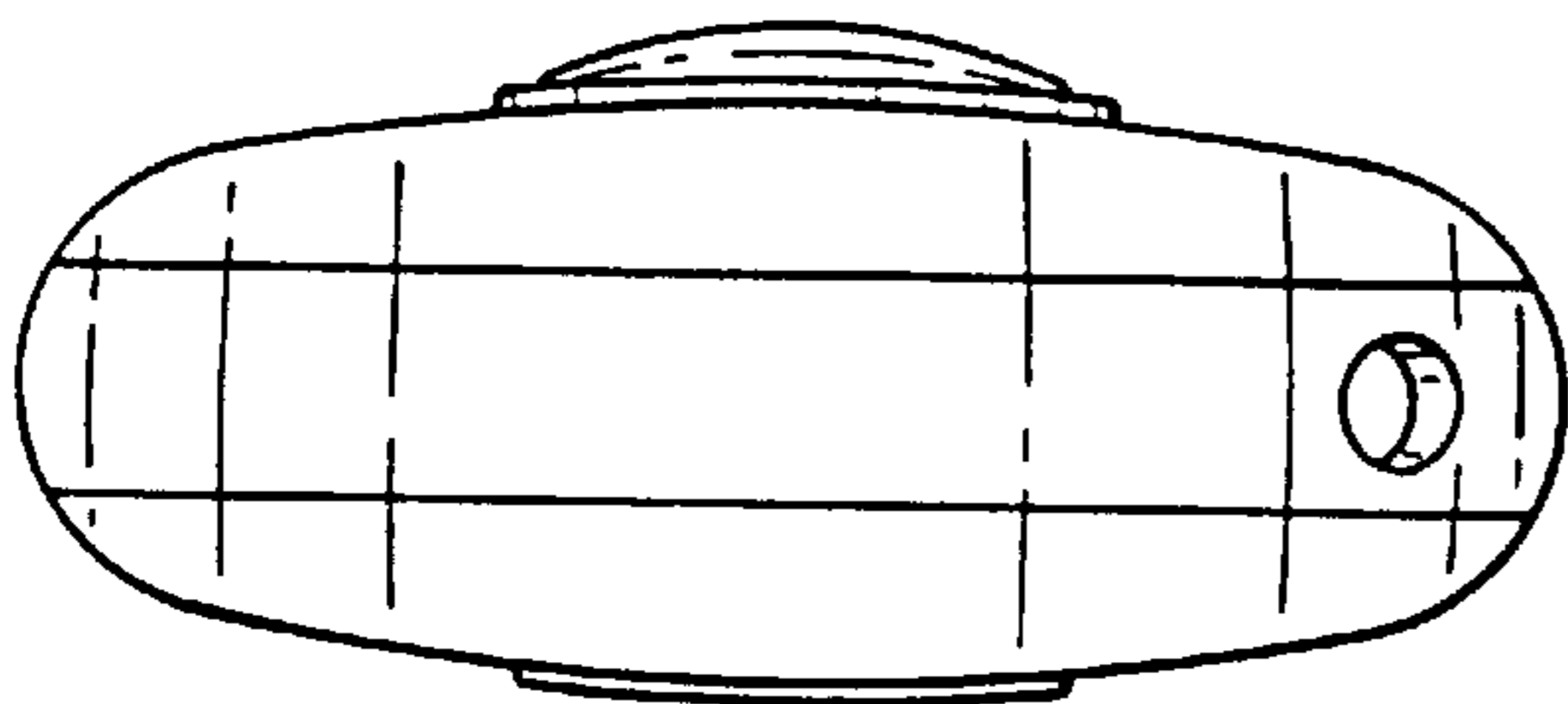
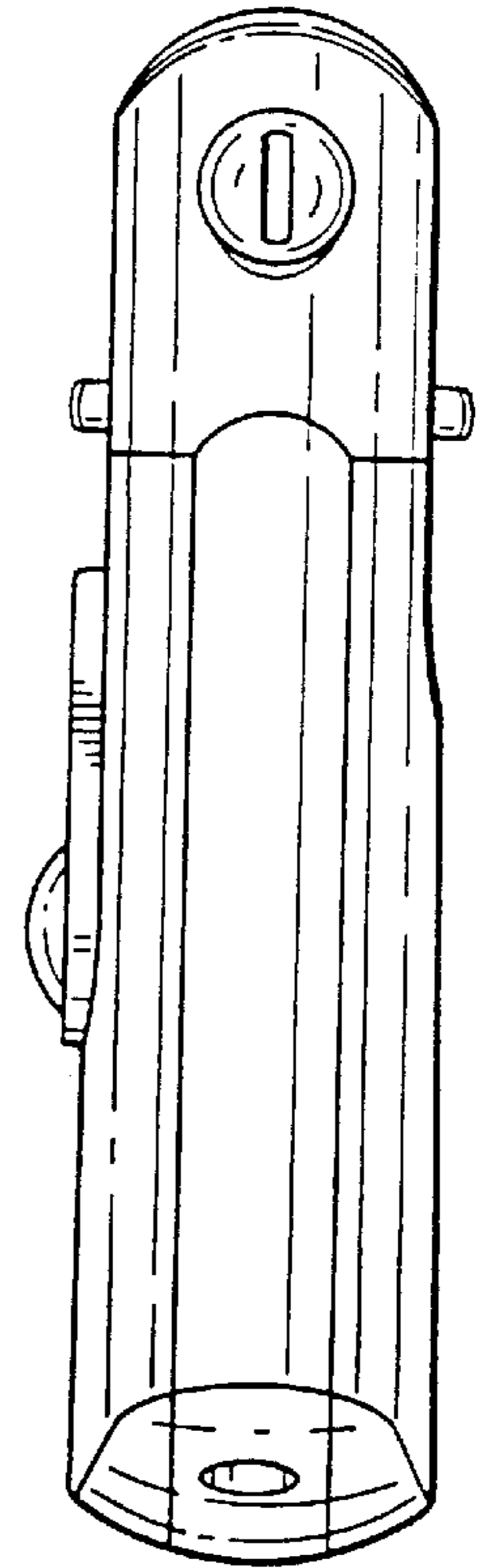

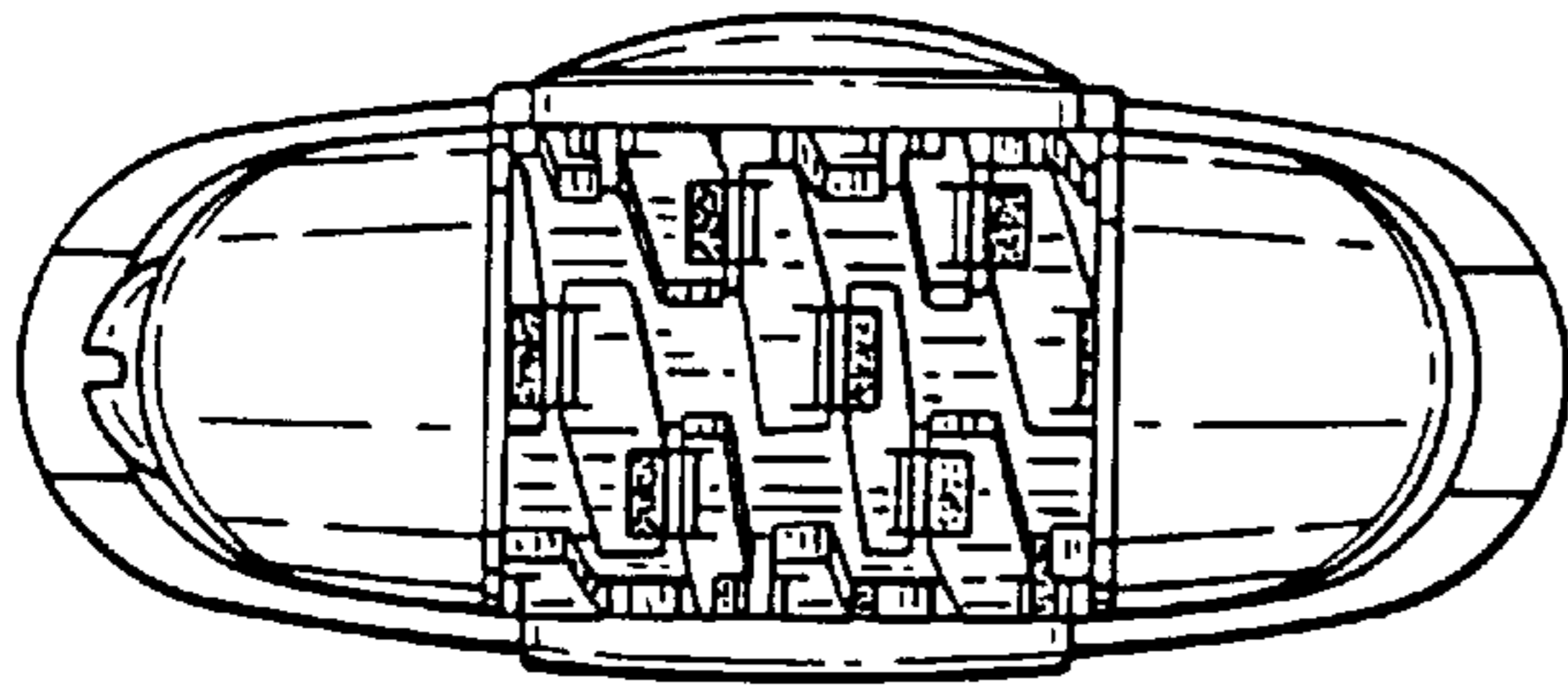

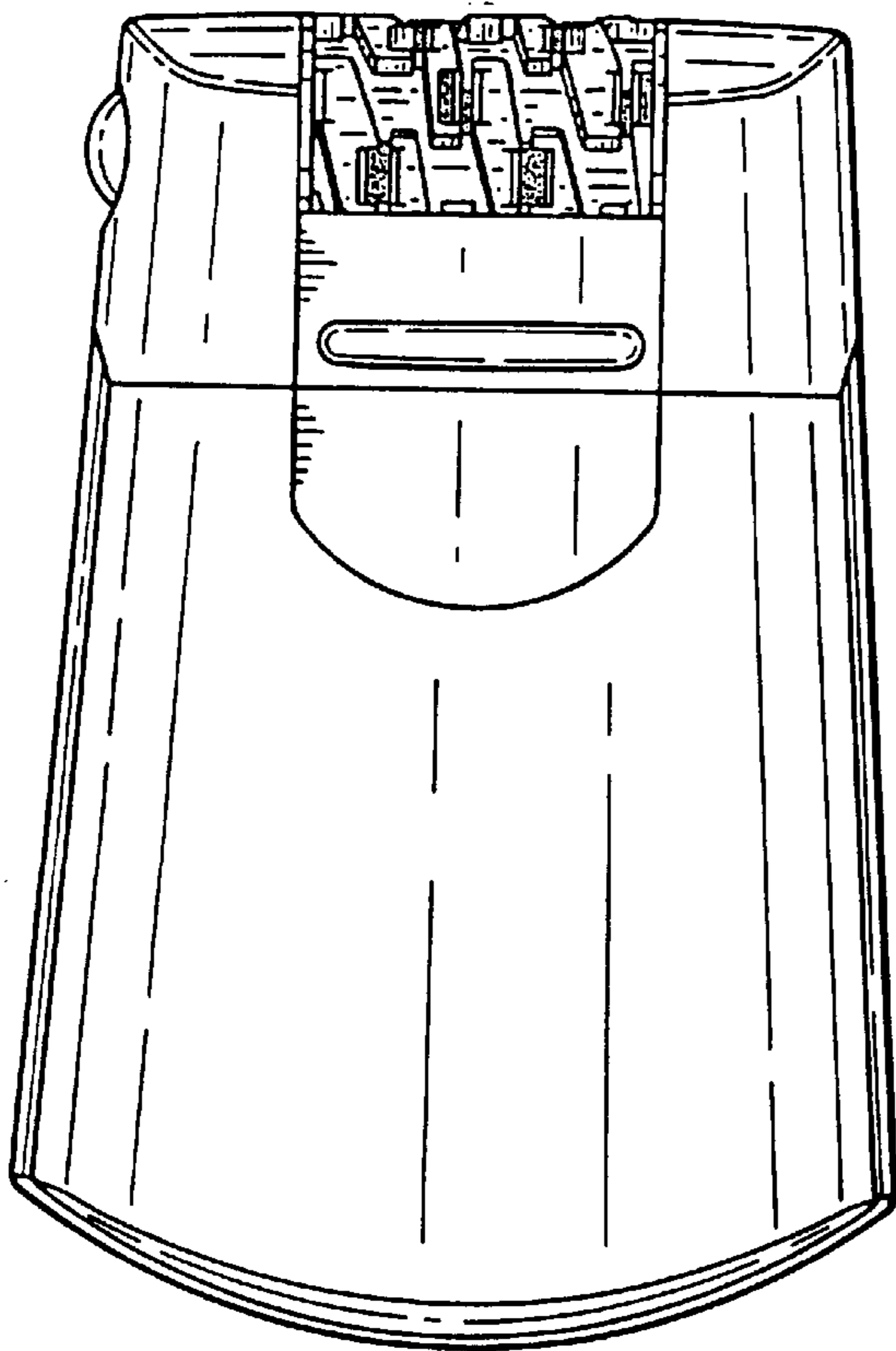
