### DESCRIPTION

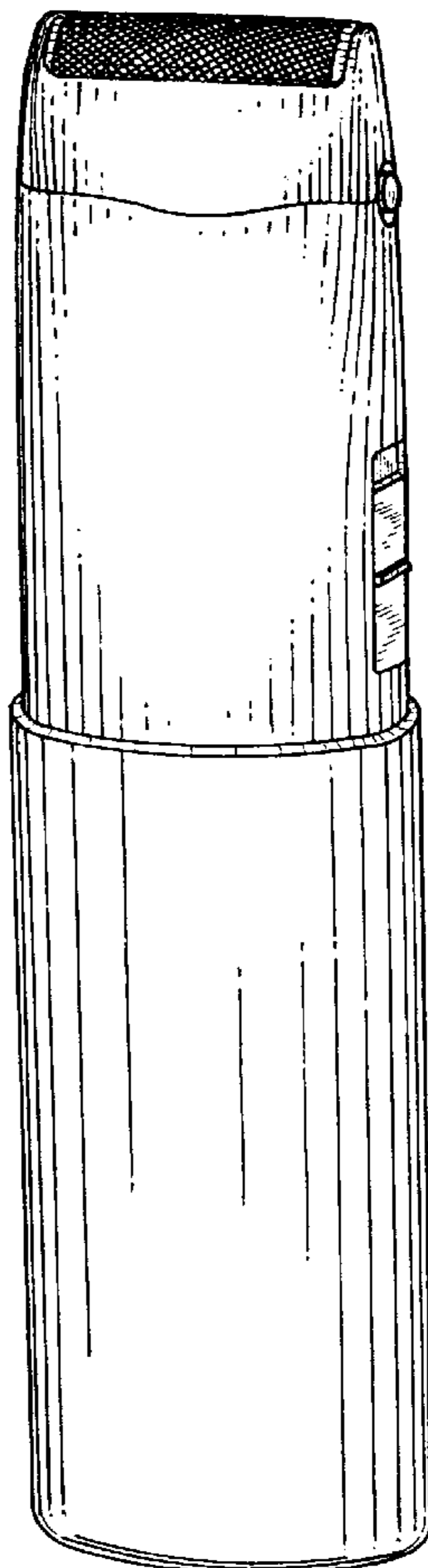

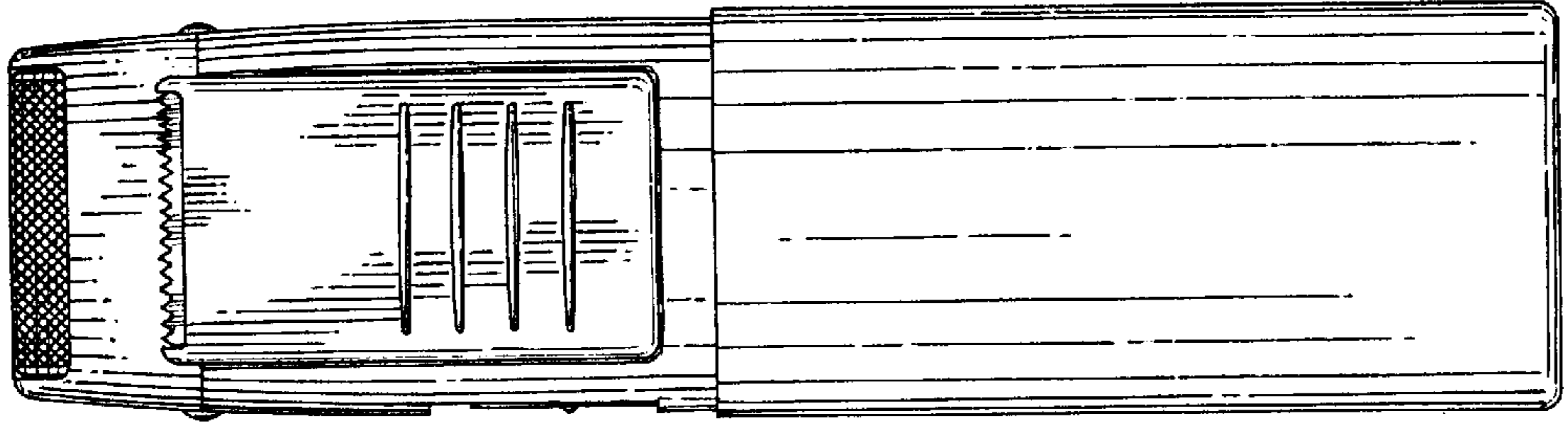

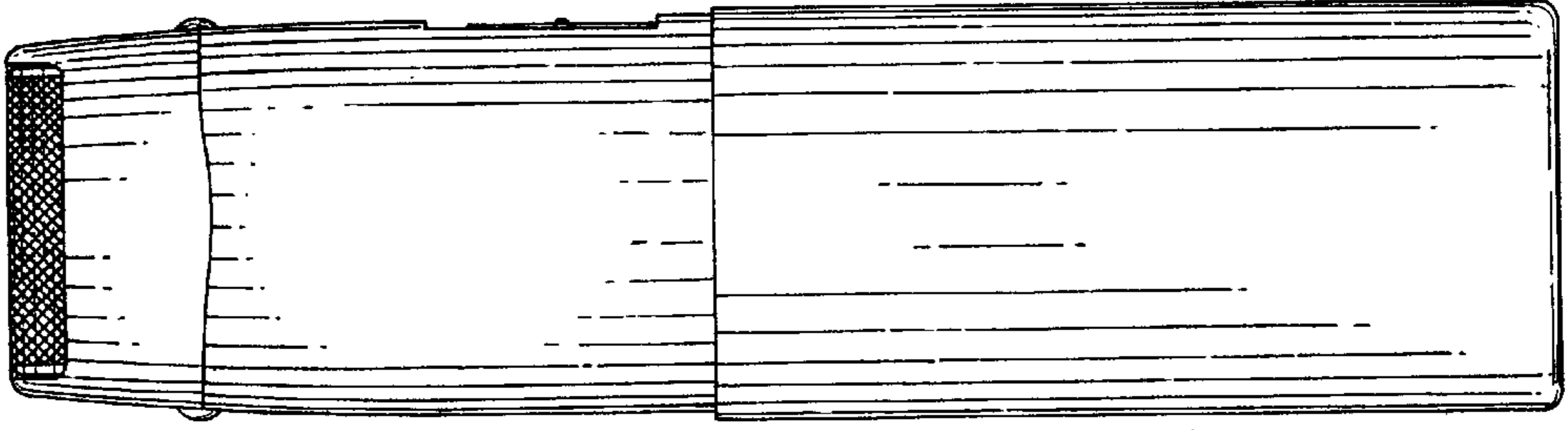

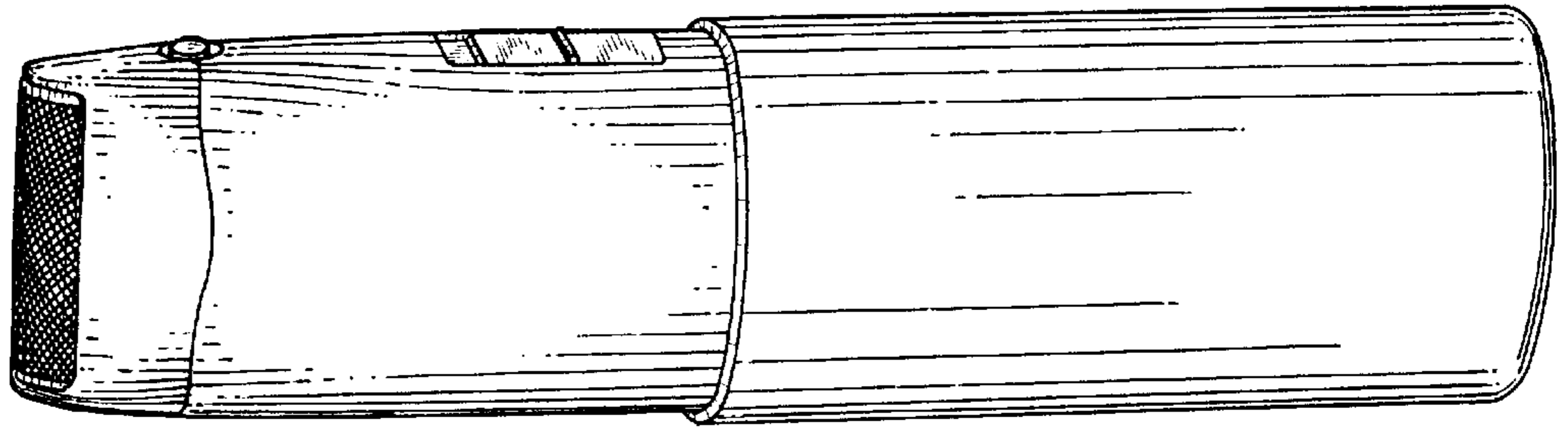

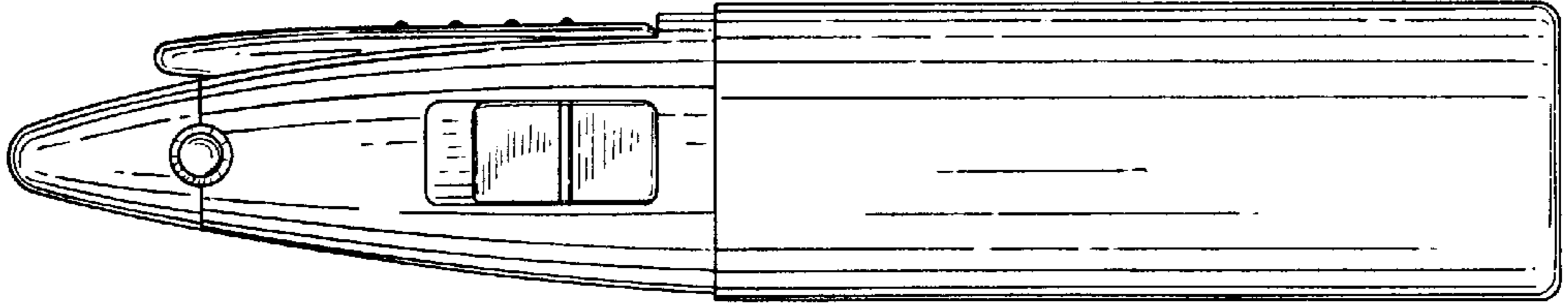

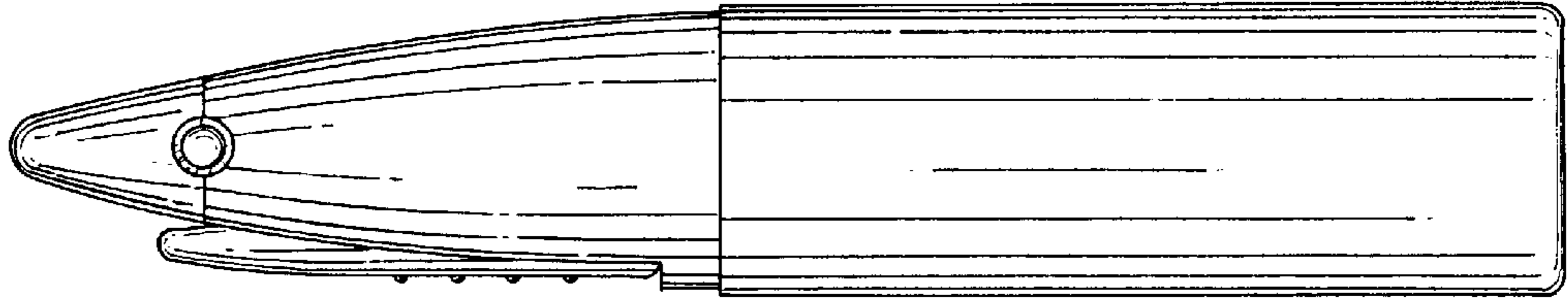

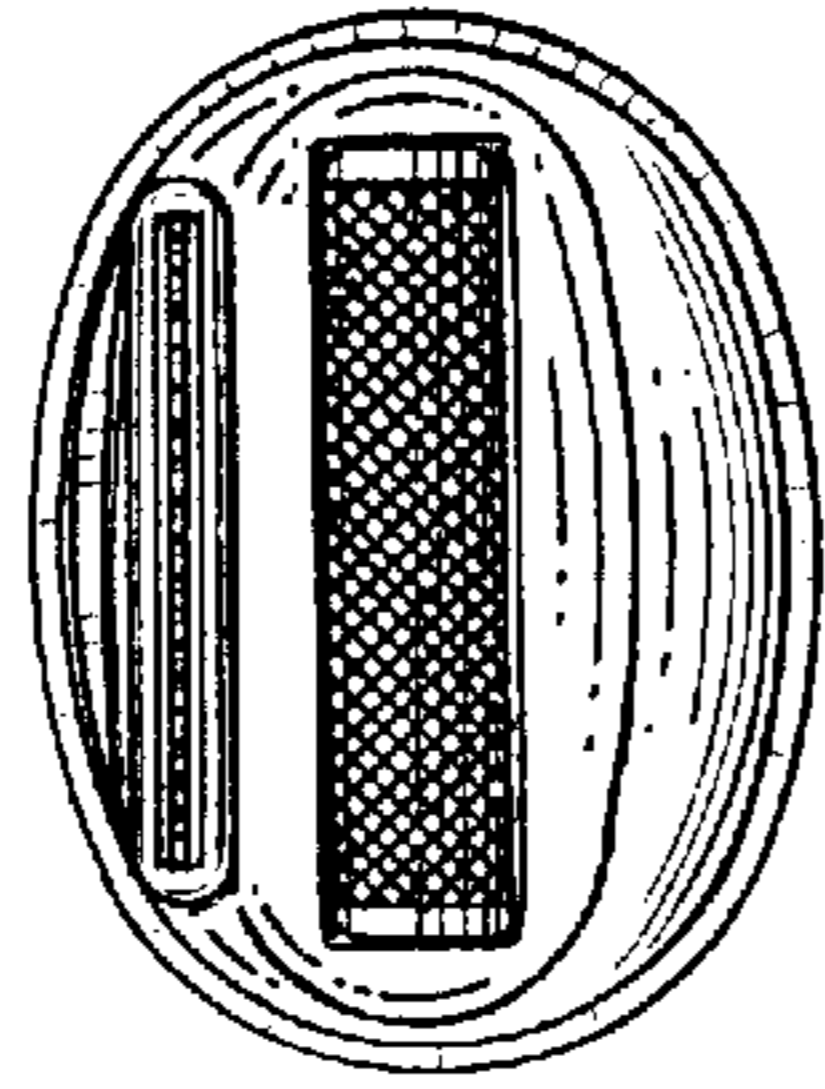
