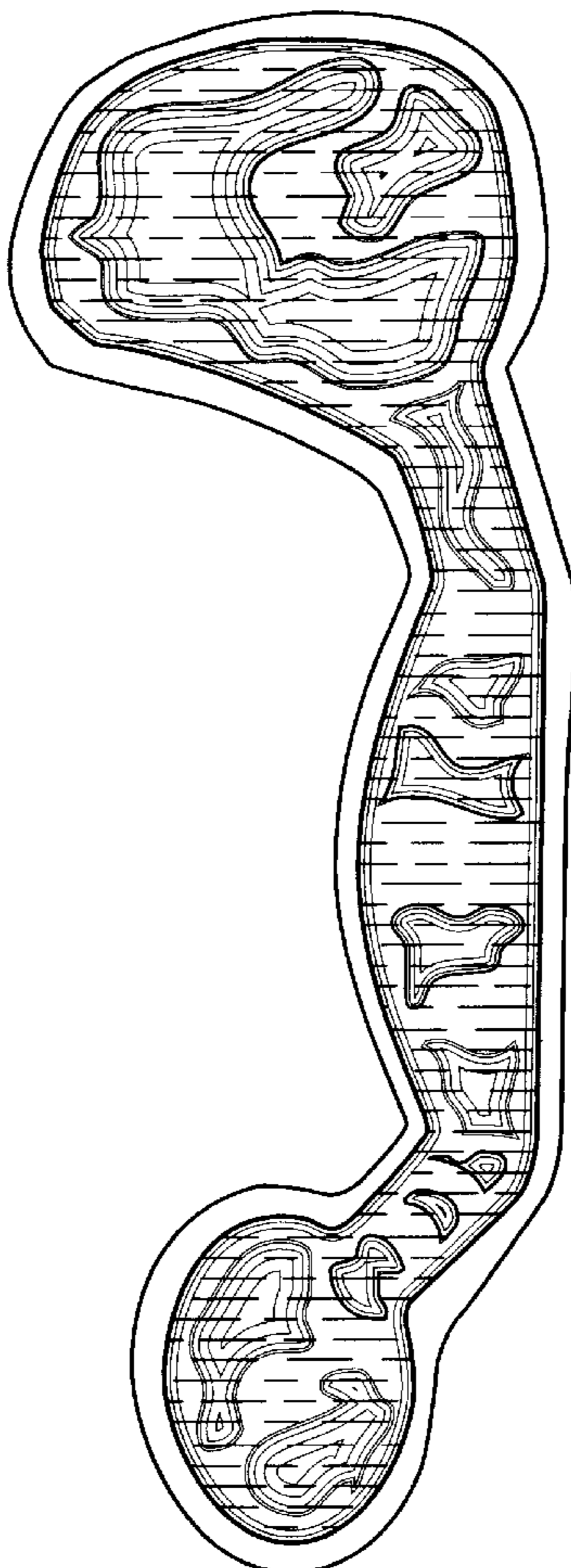
### [57] CLAIM

The ornamental design for a bladder for use in a shoe, as shown and described.

### DESCRIPTION

FIG. 1 is a top view of a bladder for use in a shoe according to the invention;  
FIG. 2 is a side view thereof;

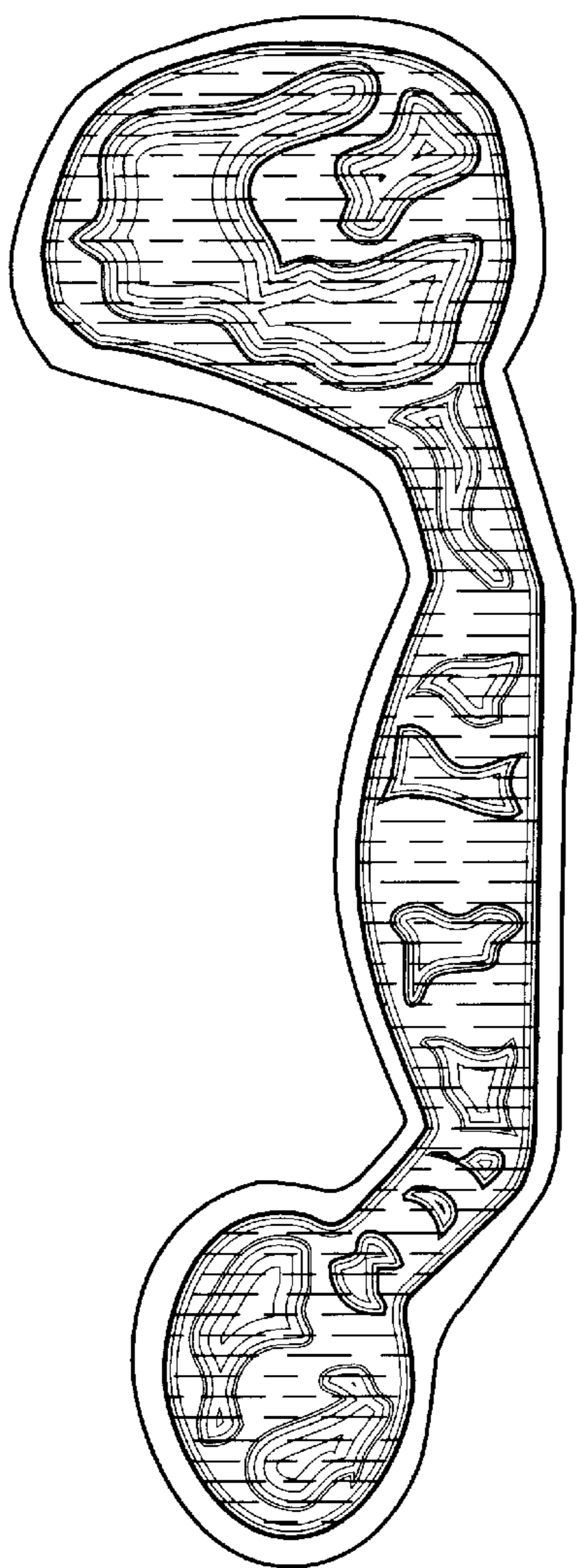

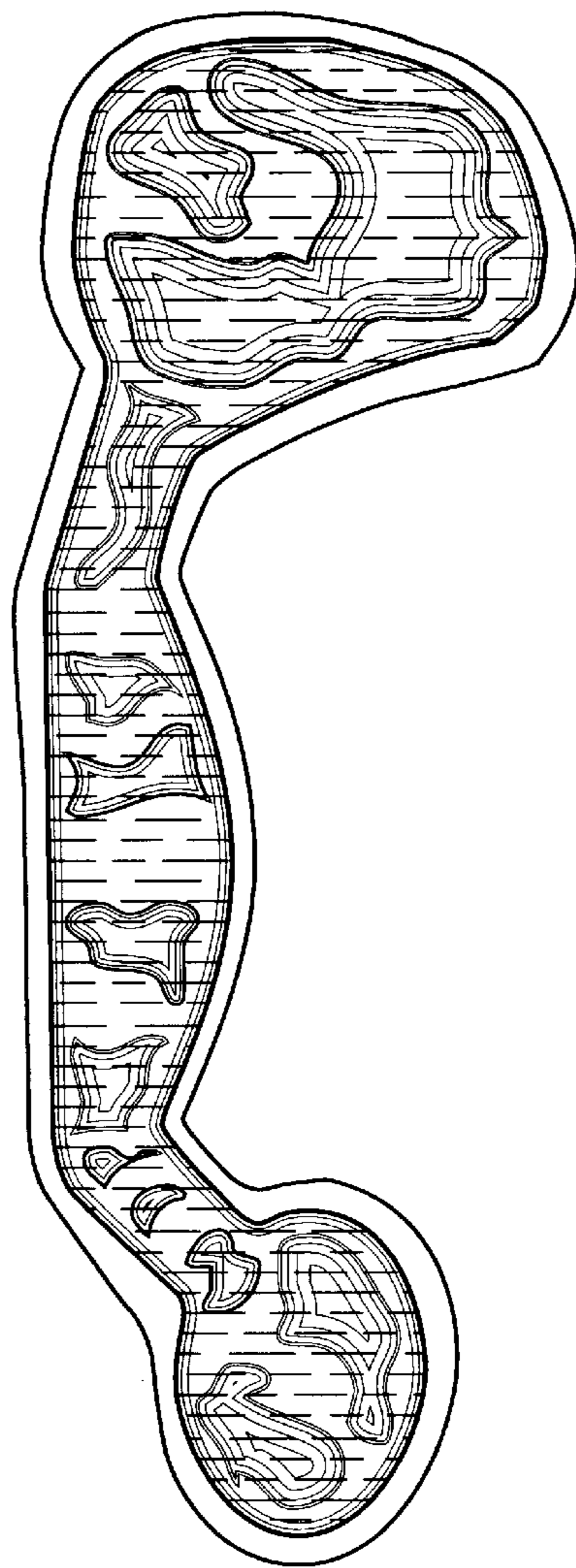

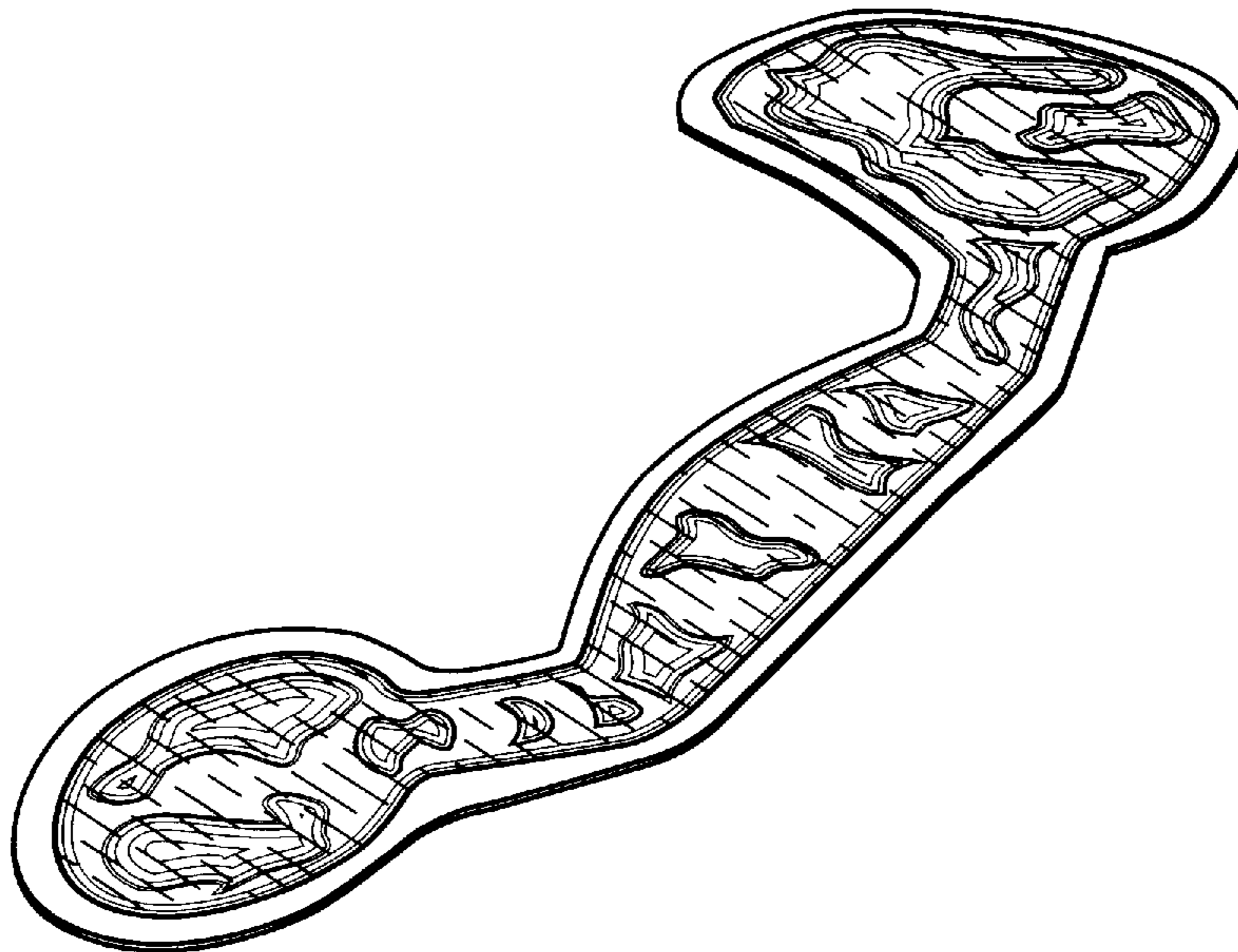
