FIG. 8 is an open view of the exterior;

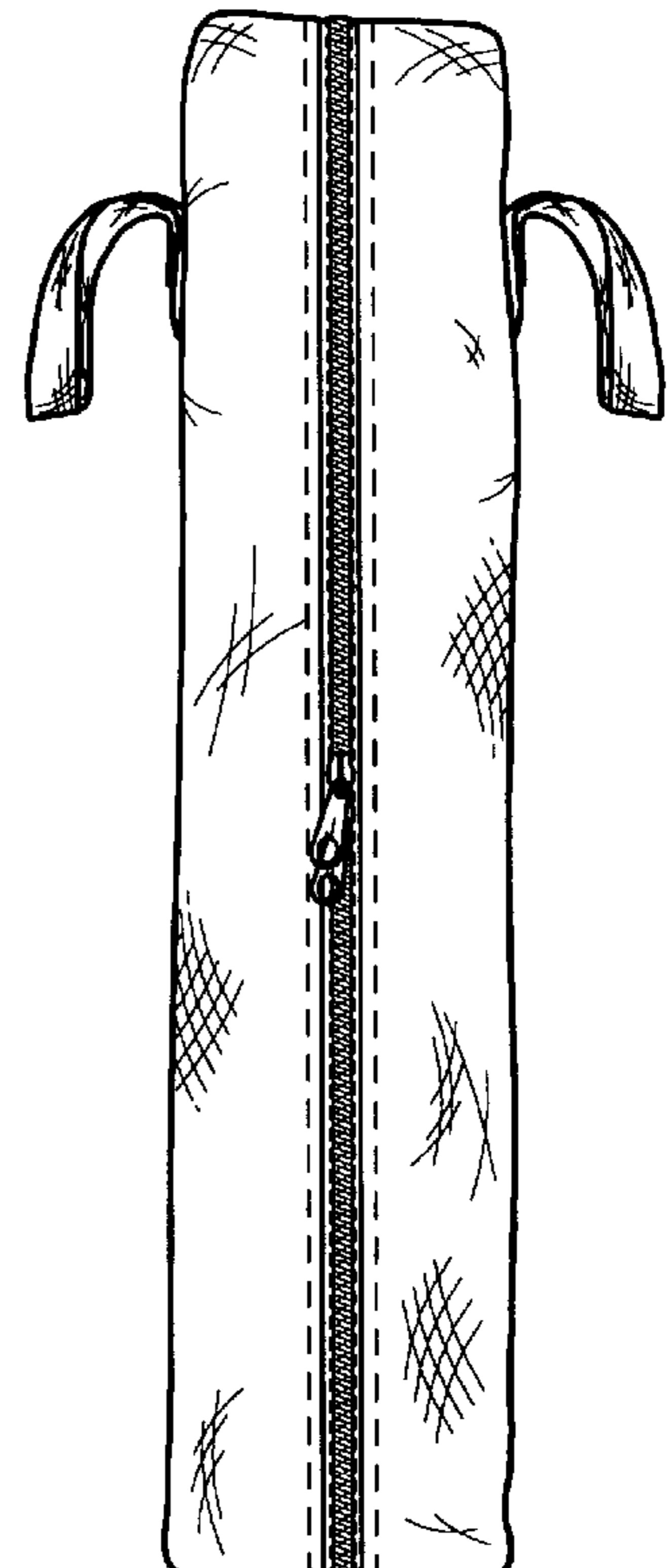
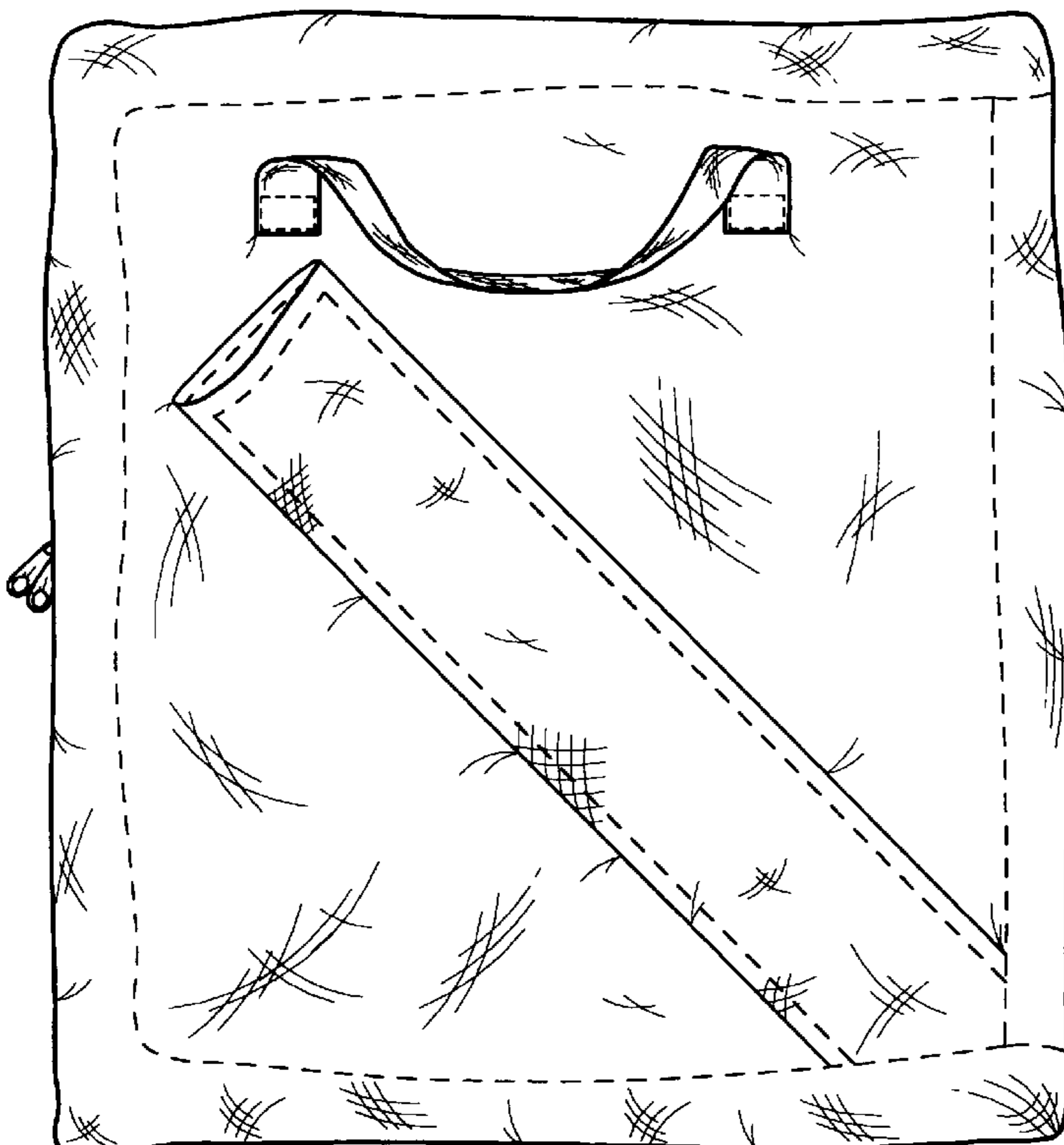
FIG. 9 is an open view of the interior, wherein the tool pouch

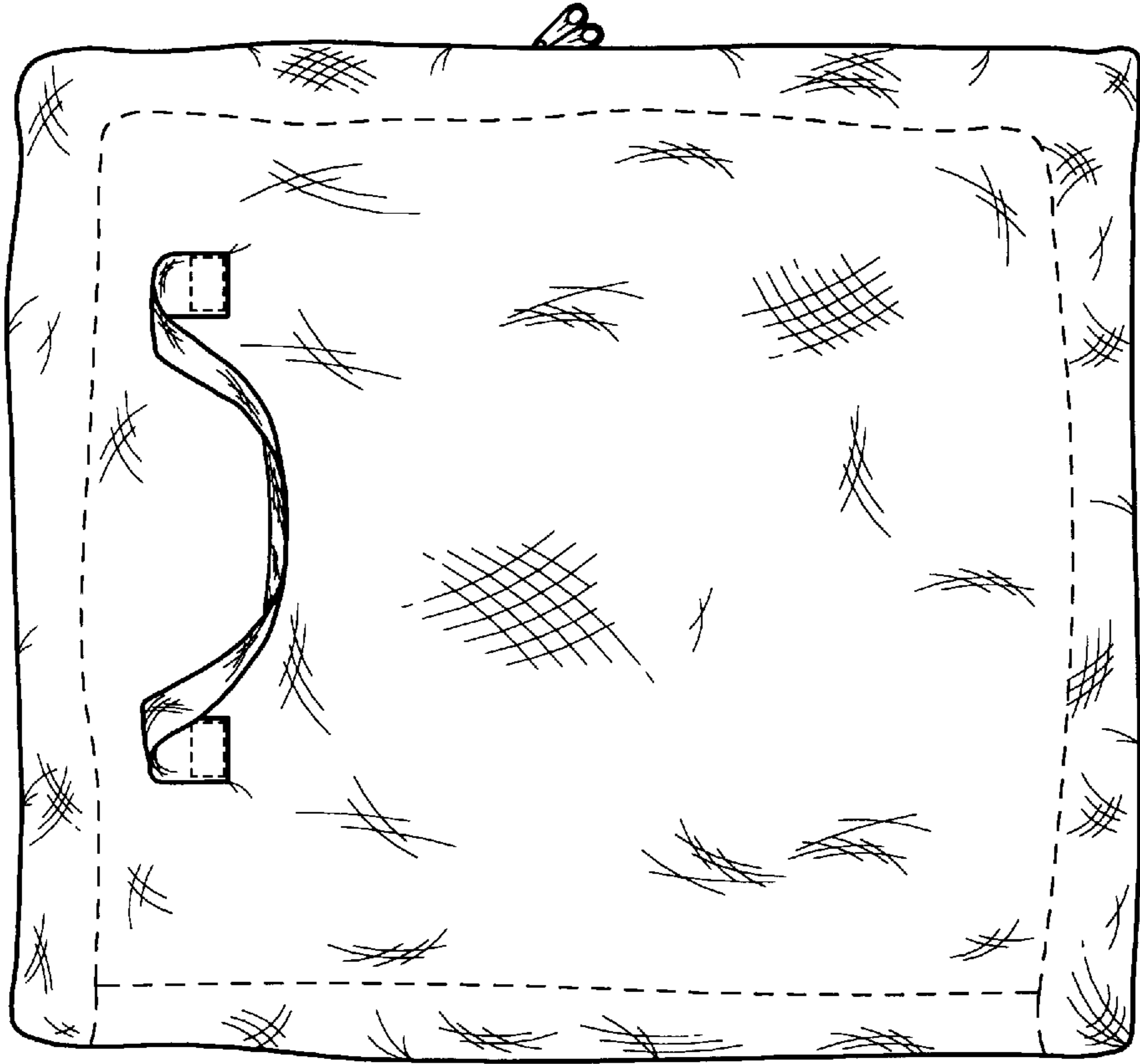

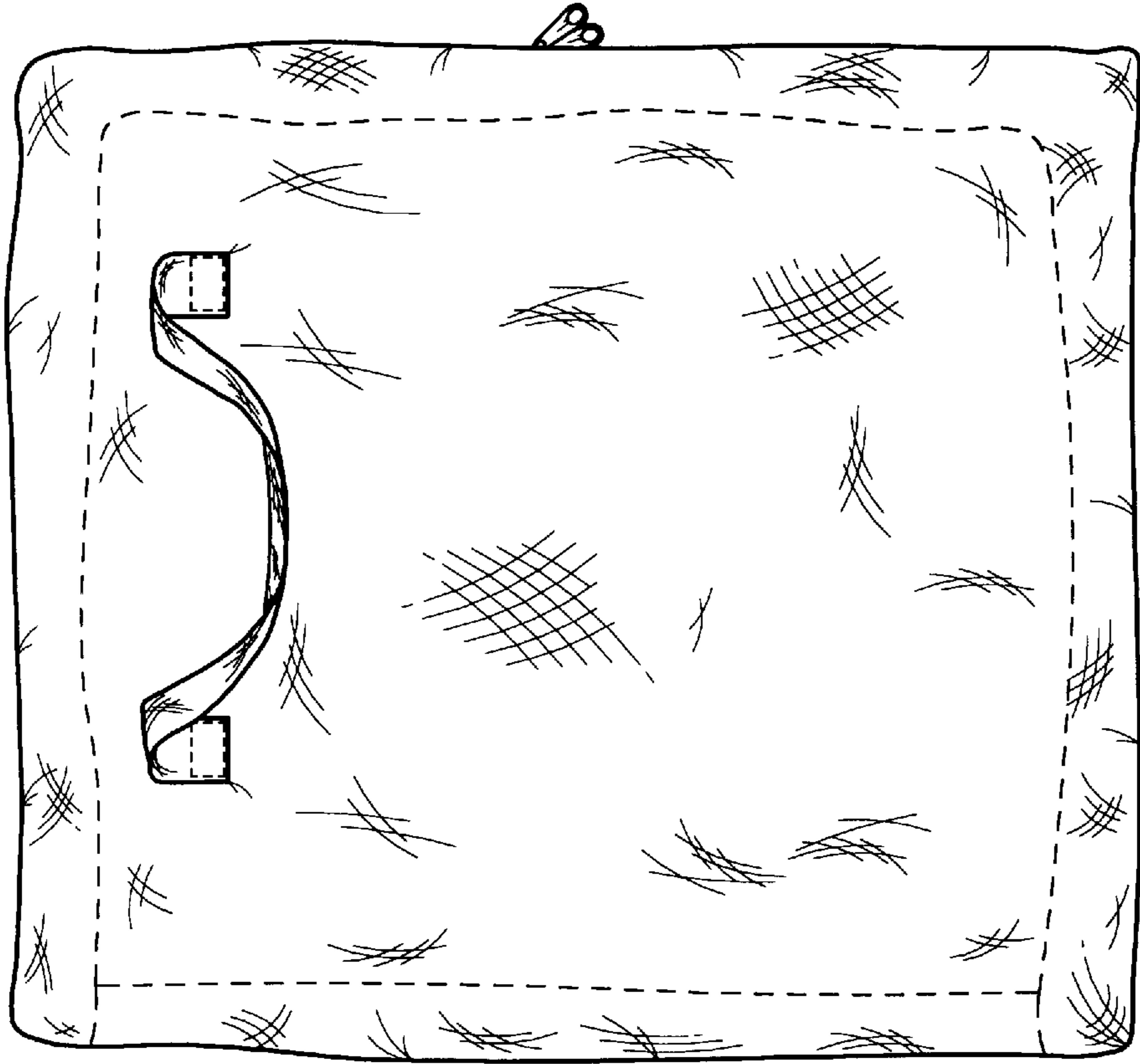

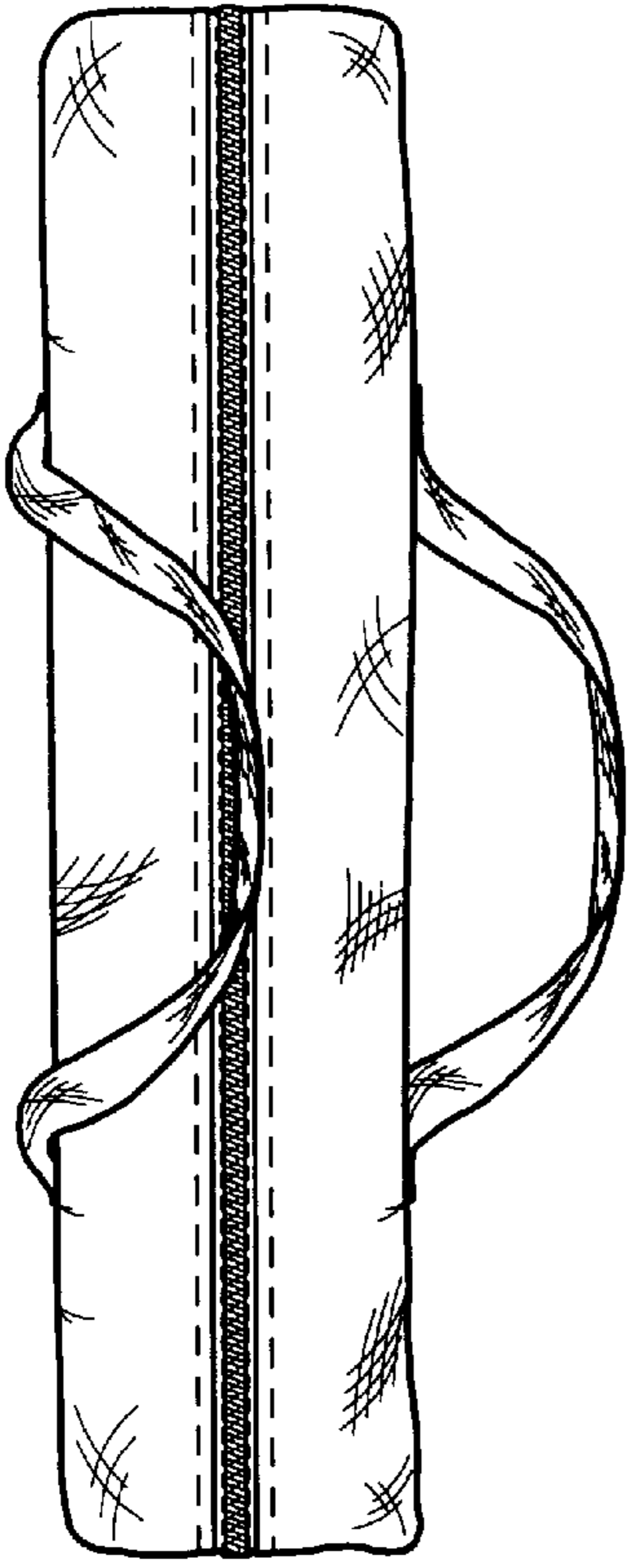

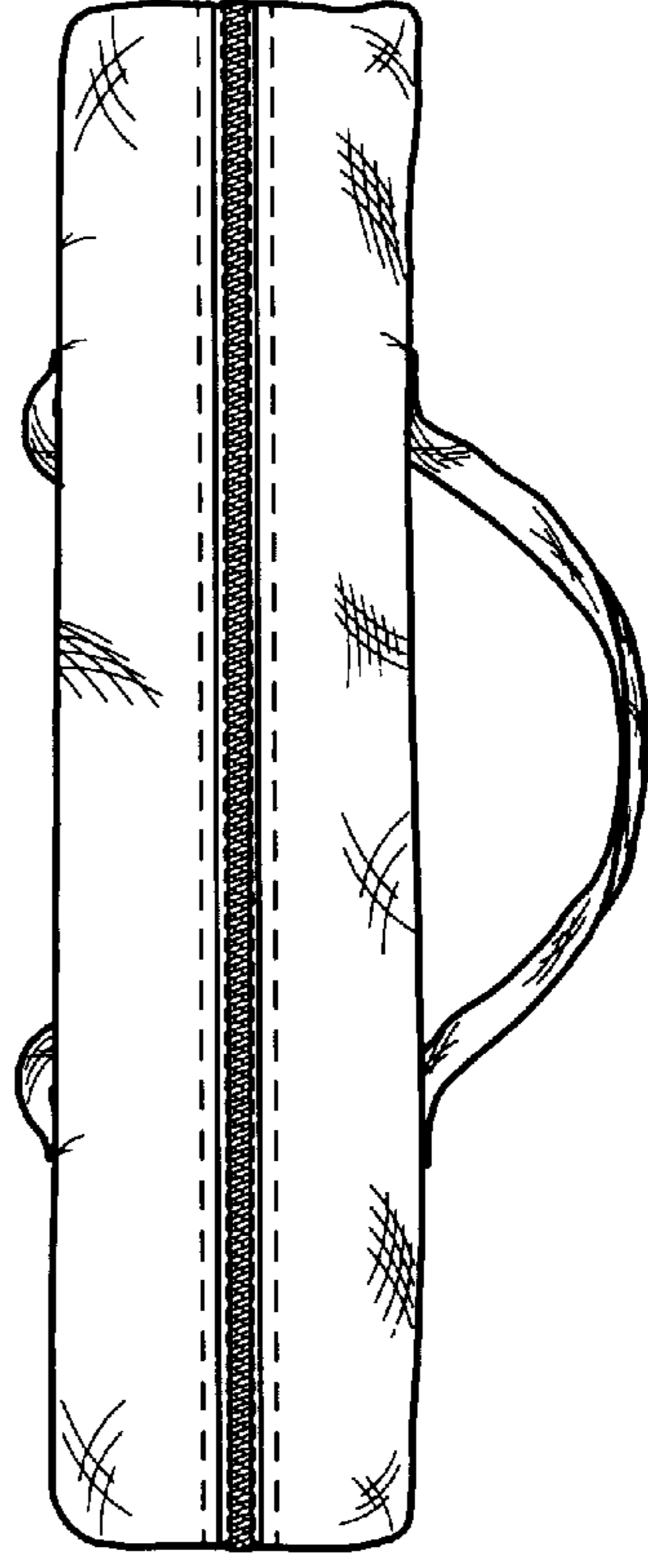

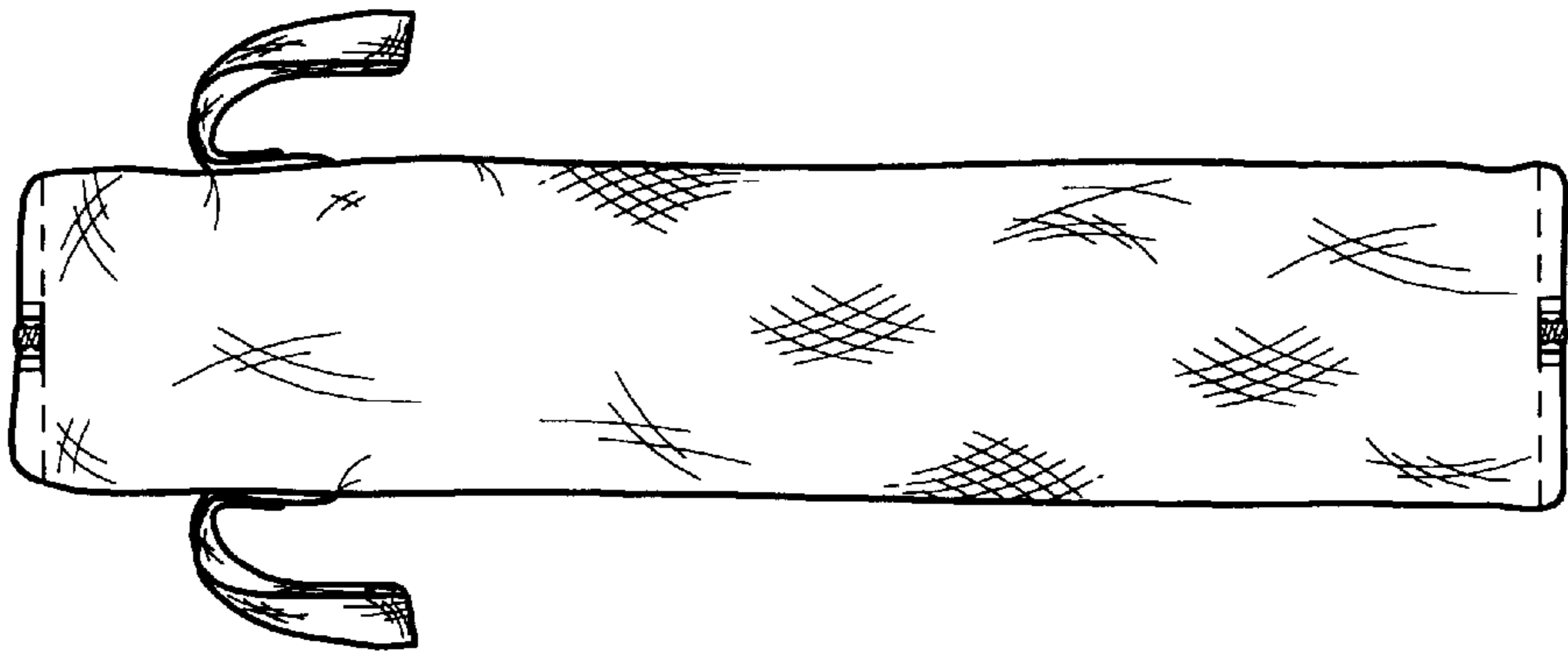

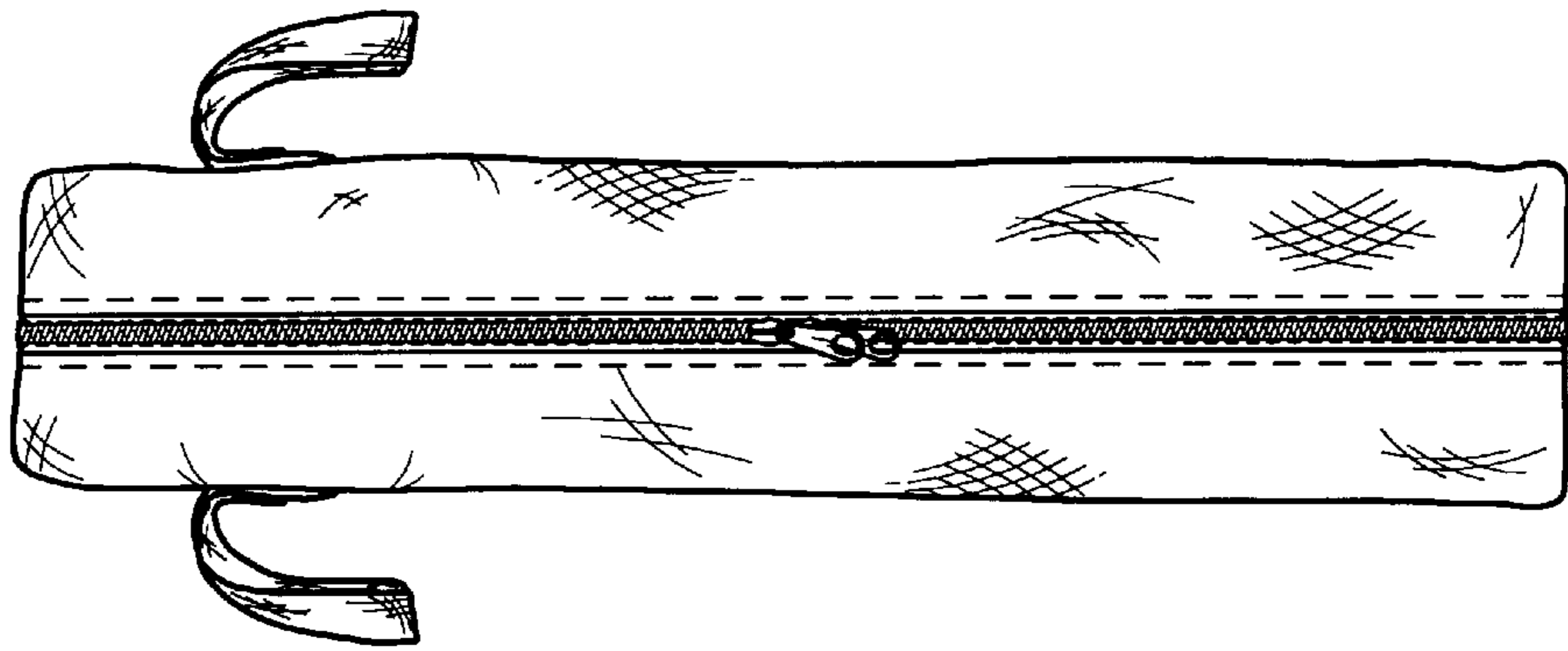

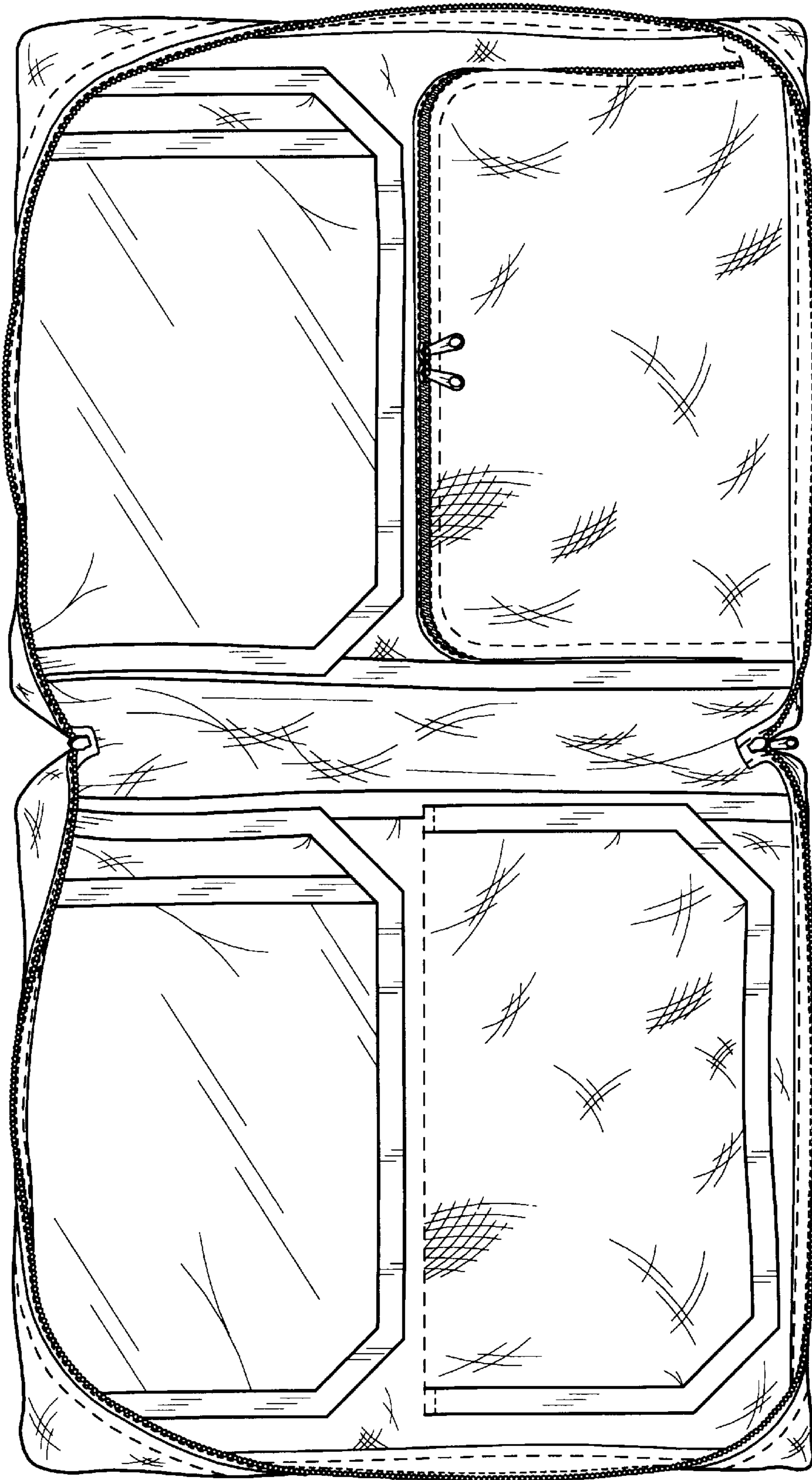

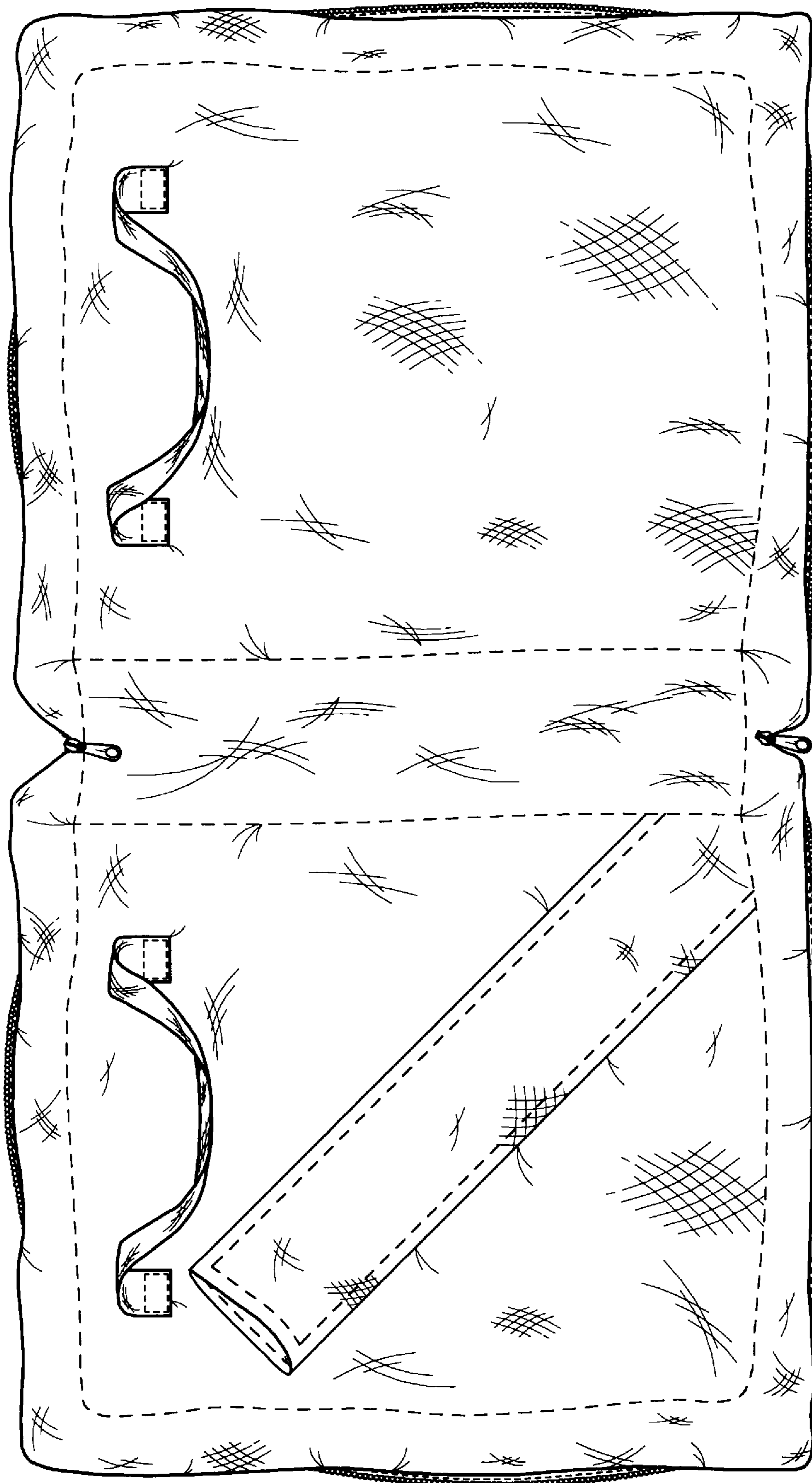

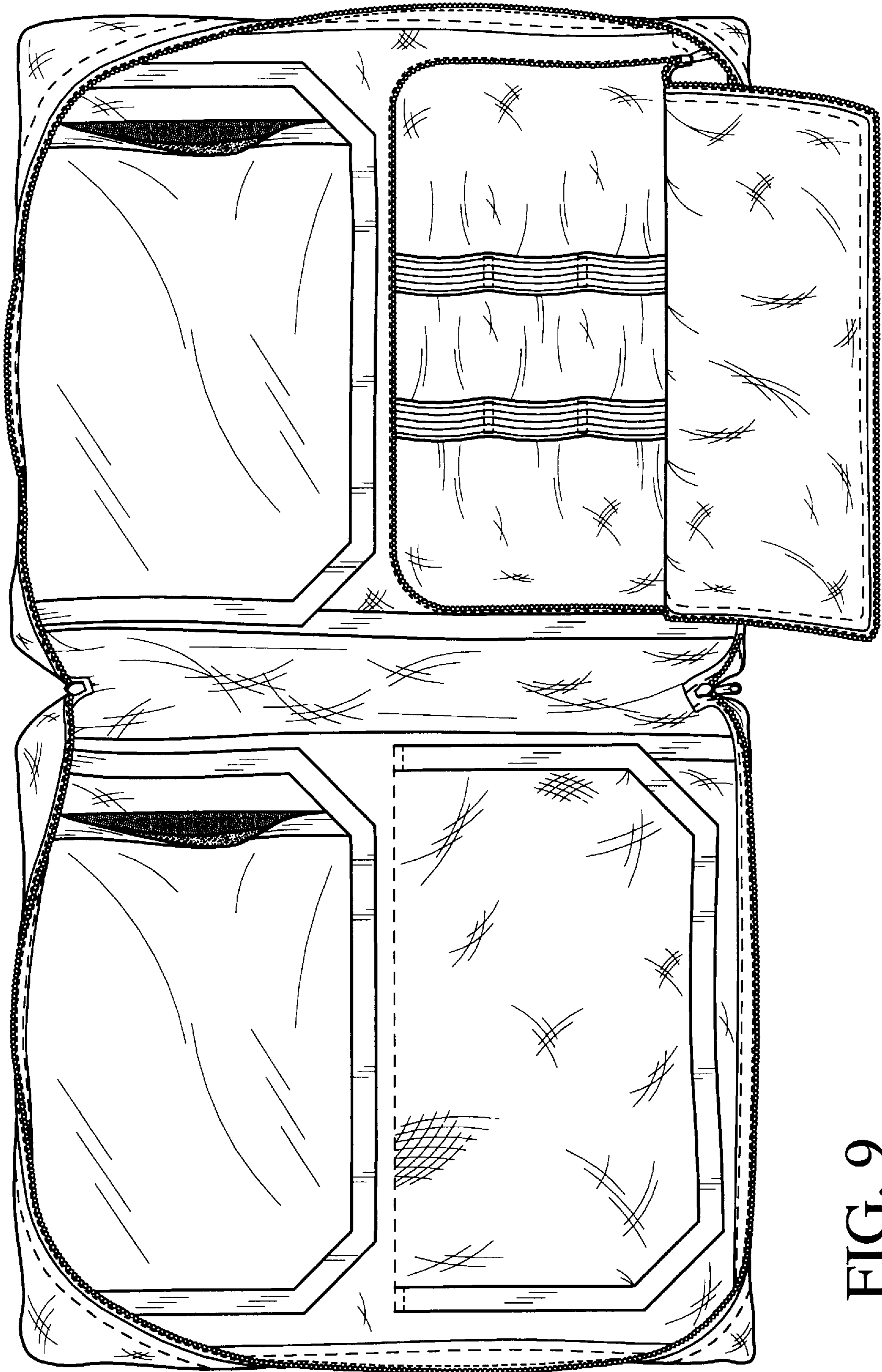

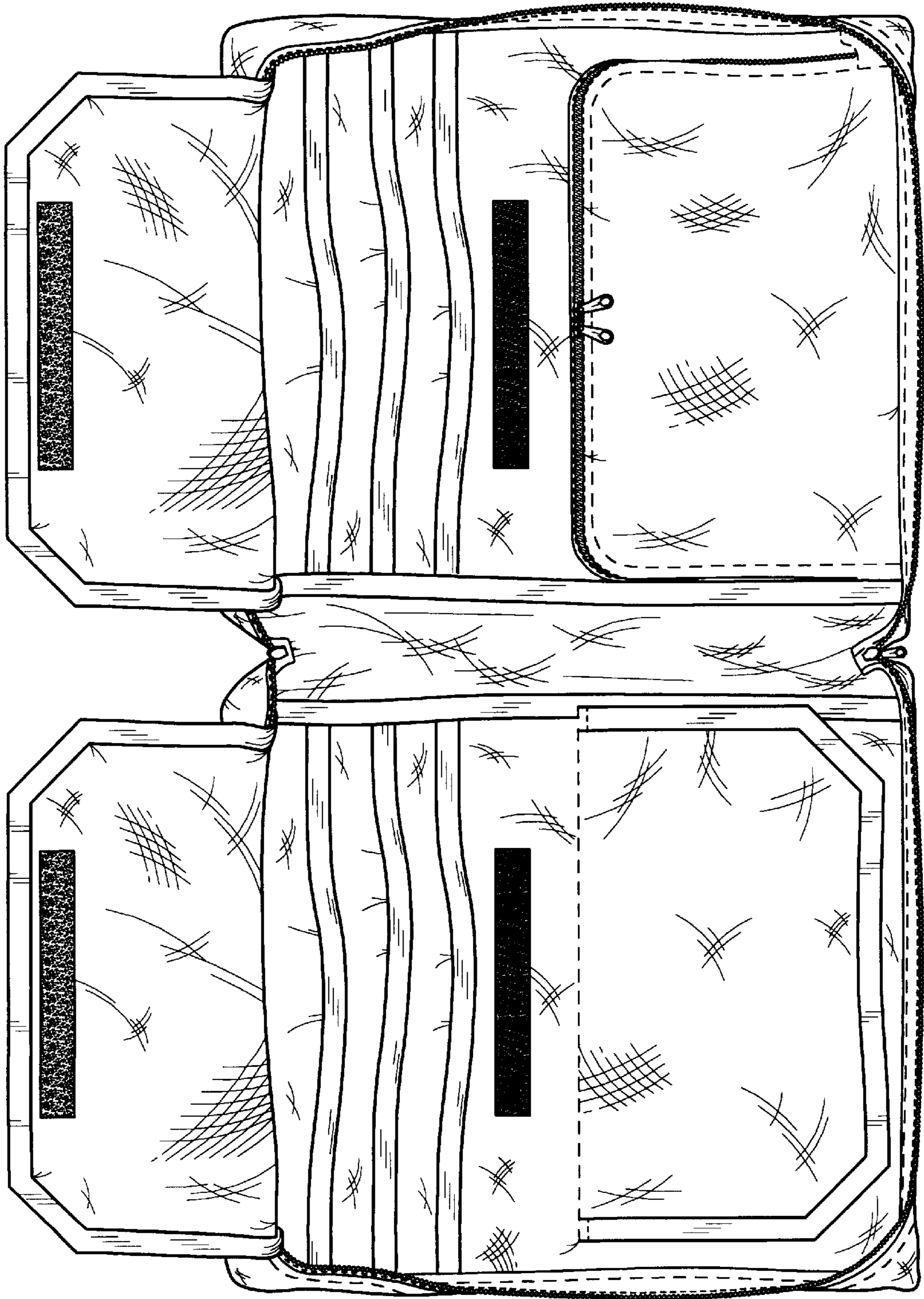

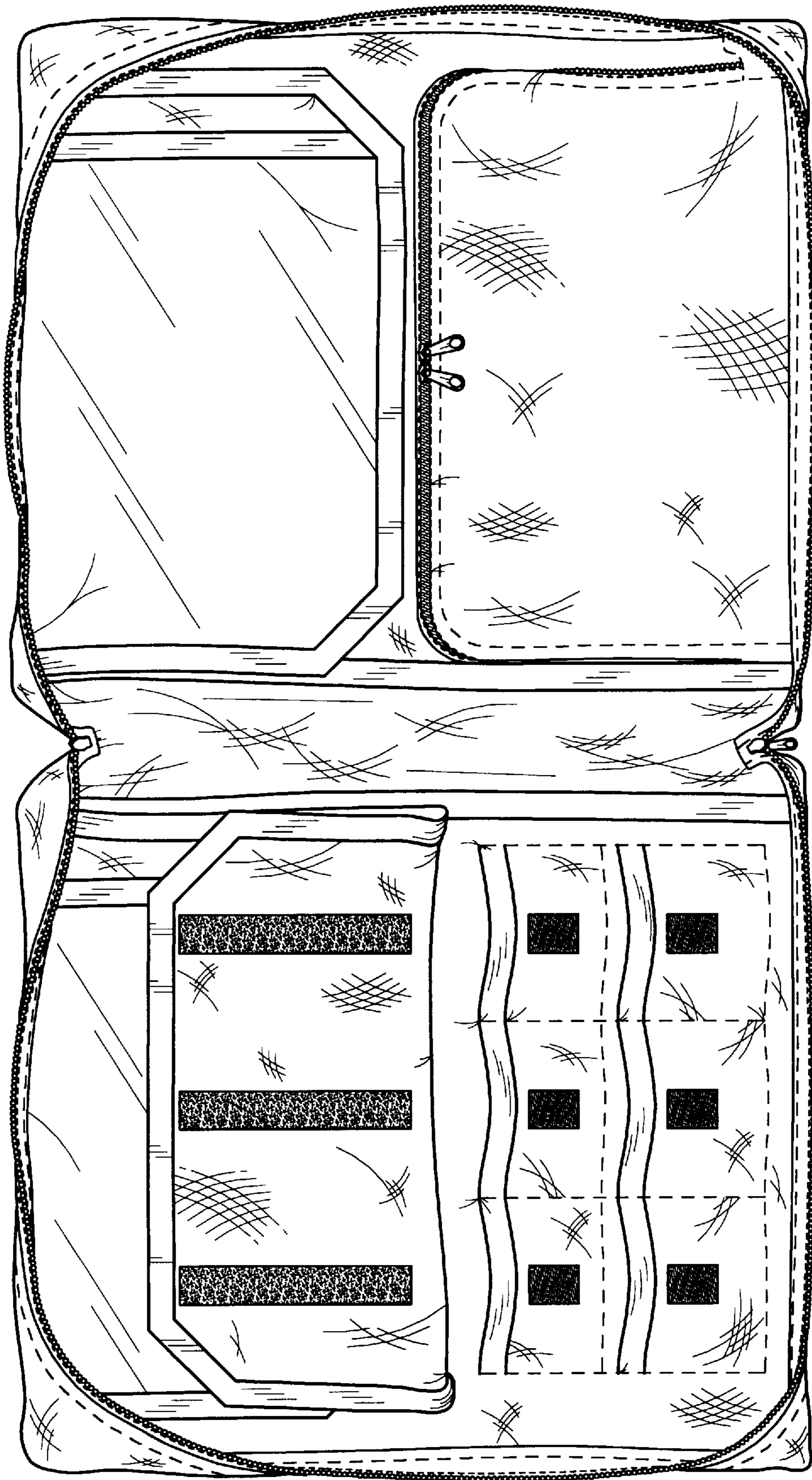

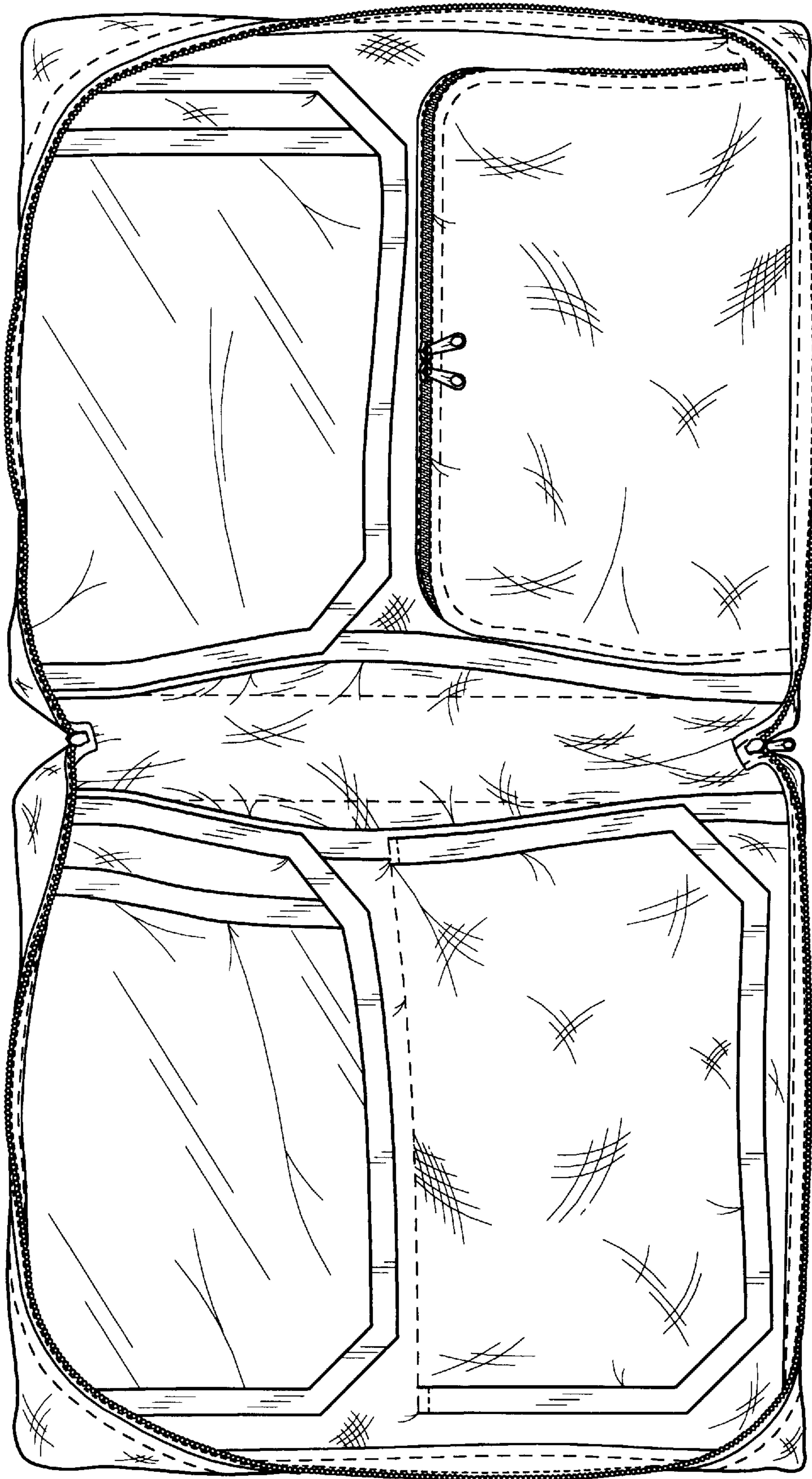
