FIG. 8 is a right side elevational view of FIG. 6, the left side

FIG. 9 is a rear elevational view of FIG. 6; and,
FIG. 10 is a sectional view along line FIG. 10-10 of FIG. 6.

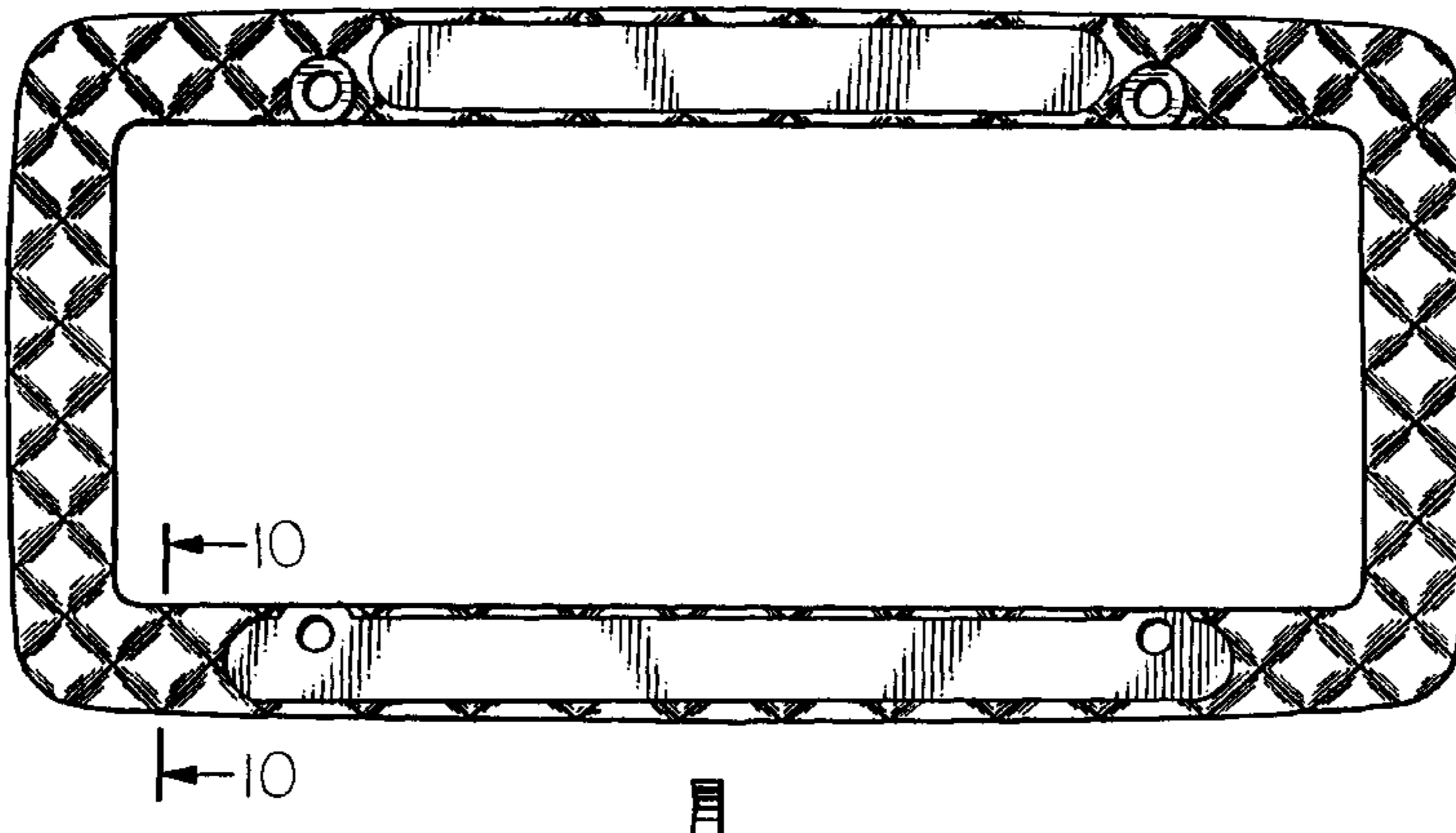
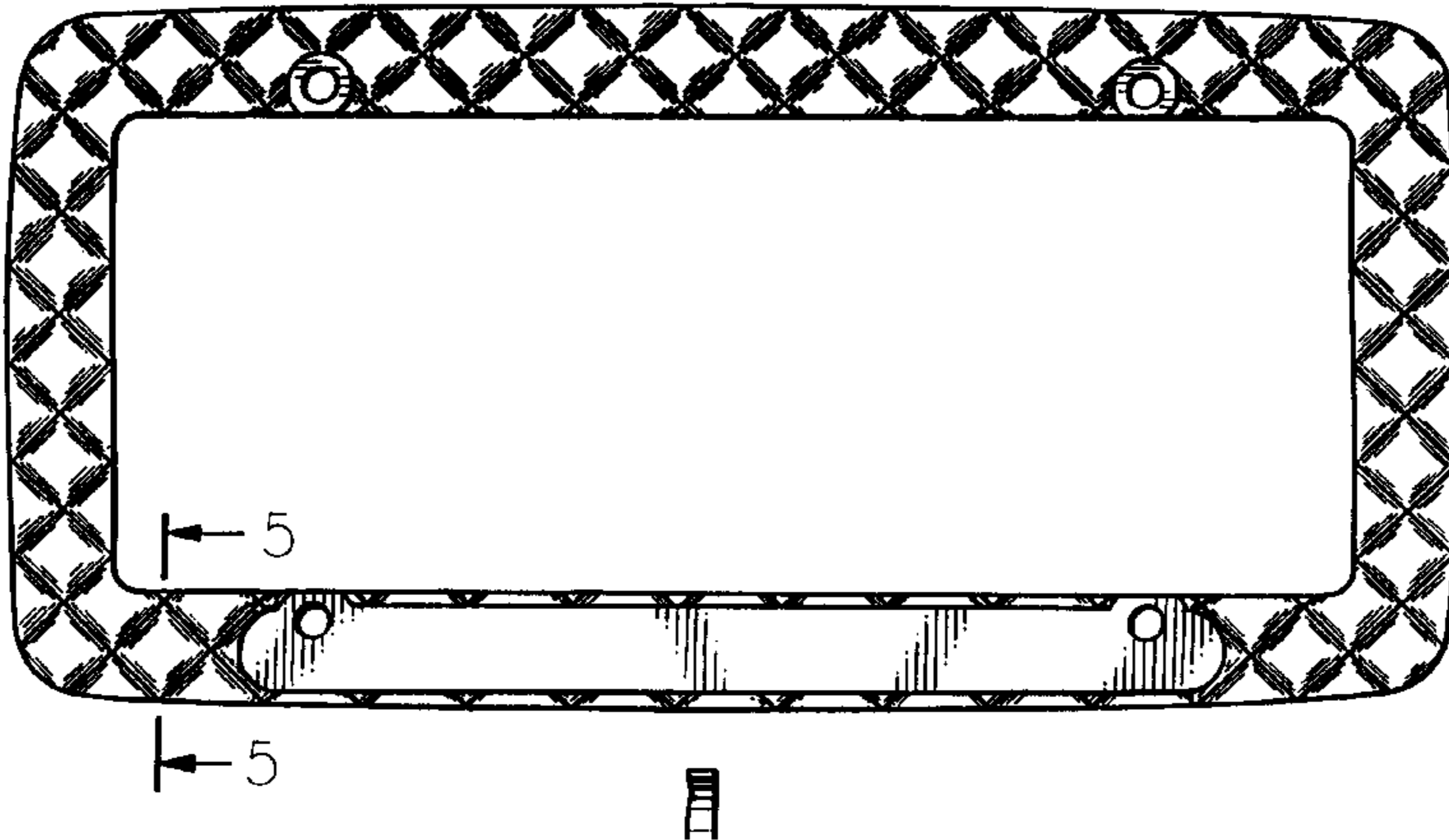

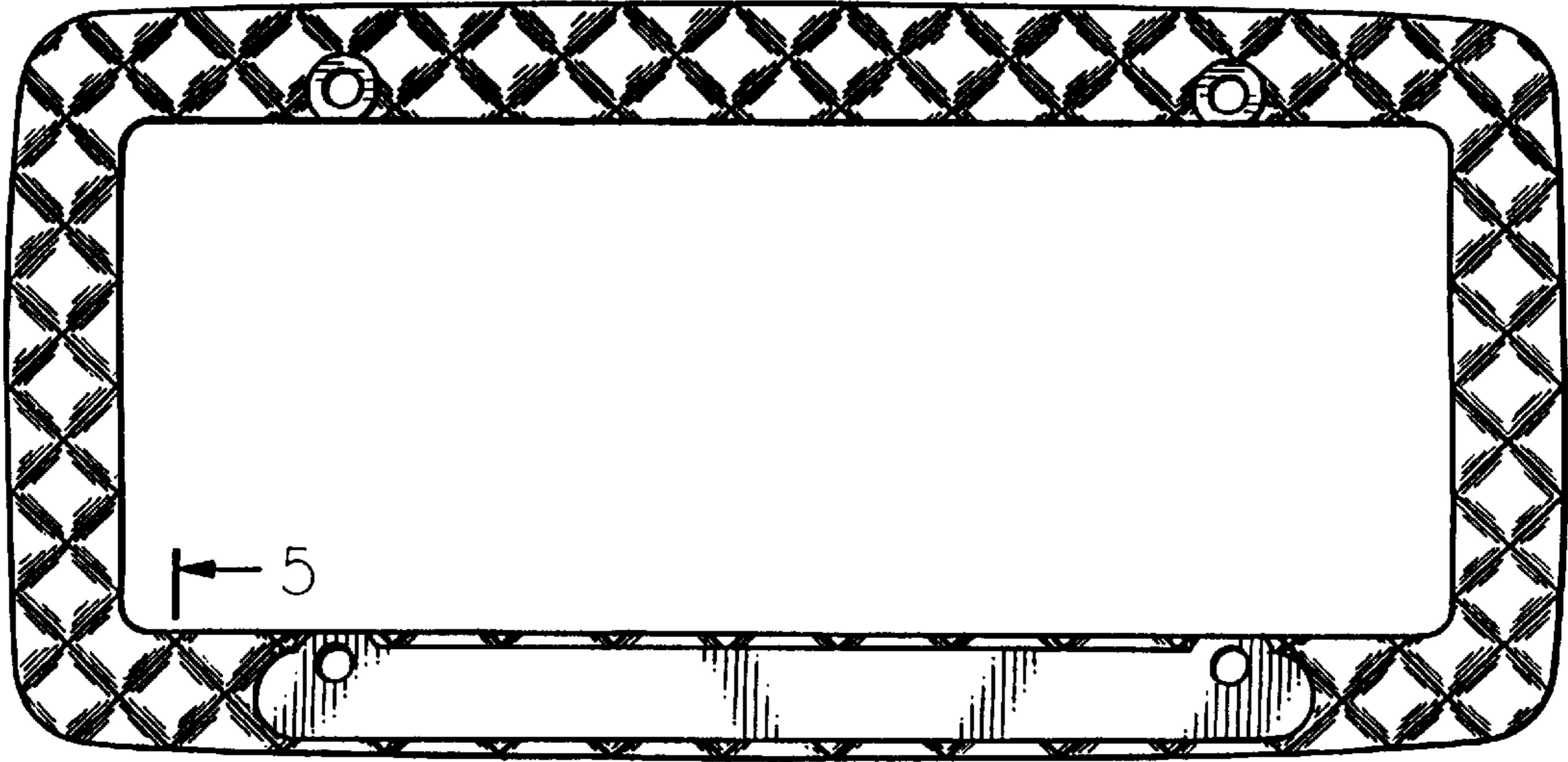

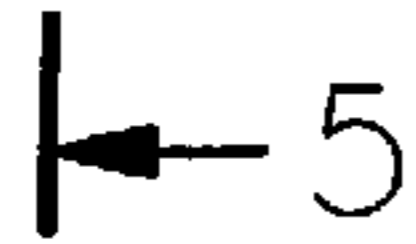
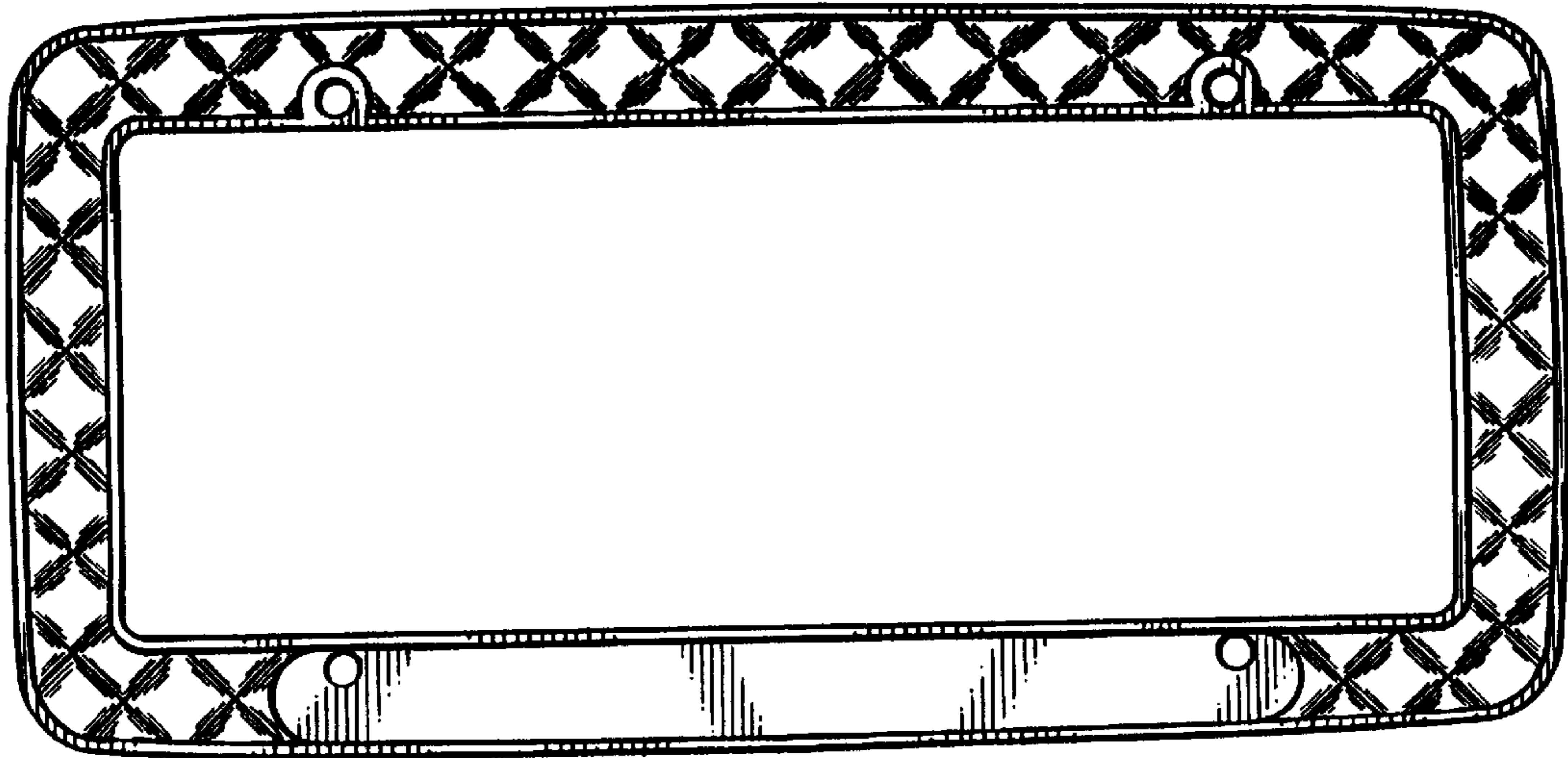

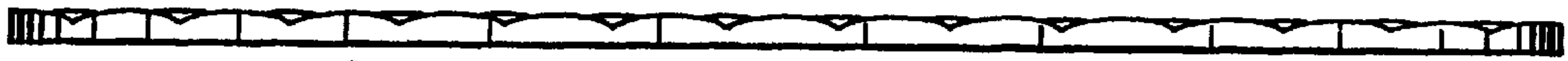
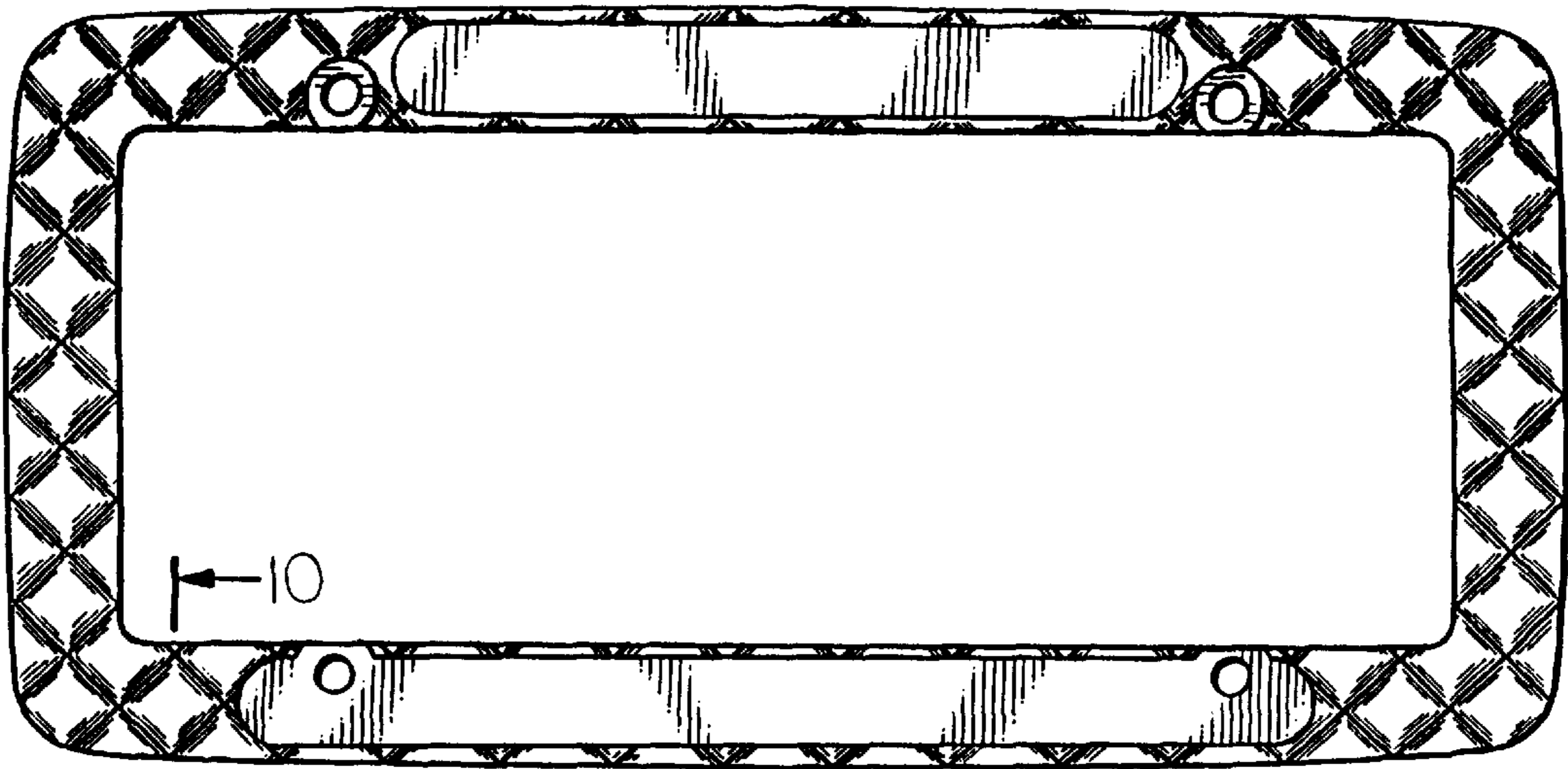

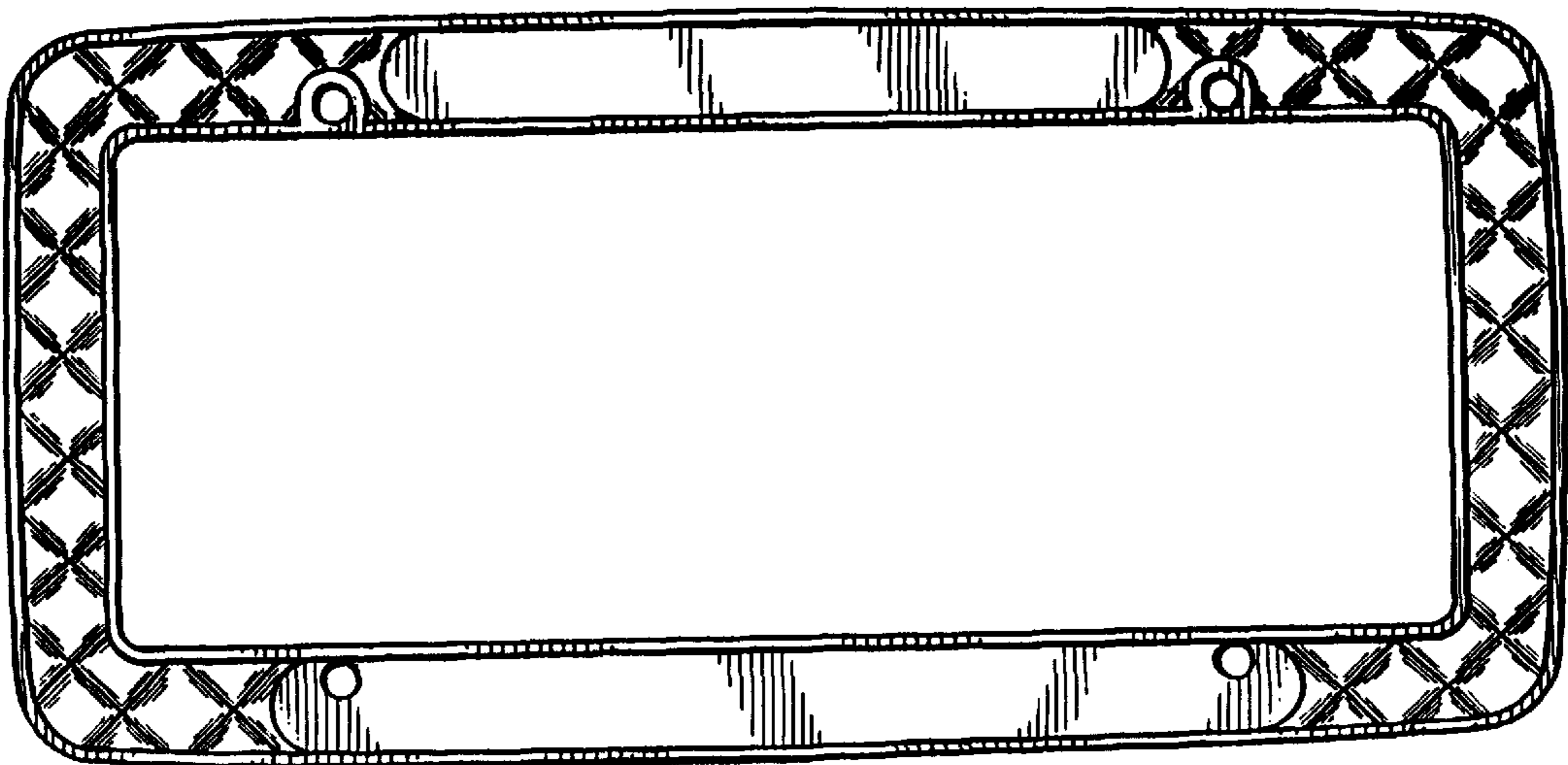
