### [57] CLAIM

The ornamental design for vented cabinet door with full length window, as shown and described.

### DESCRIPTION

FIG. 1 shows a perspective view of a door according to the principles of the present invention;

FIG. 2 shows a front elevational view of the door shown in FIG. 1;

FIG. 3 show a rear elevational view of the door shown in FIG. 1;

FIG. 4 shows a left side elevational view of the door shown in FIG. 1, a right side elevational view not being shown as it is a mirror image of the left side elevational view; and,

FIG. 5 shows a top plan view of the door shown in FIG. 1, a bottom plan view not being shown as it is a mirror image of the top plan view.

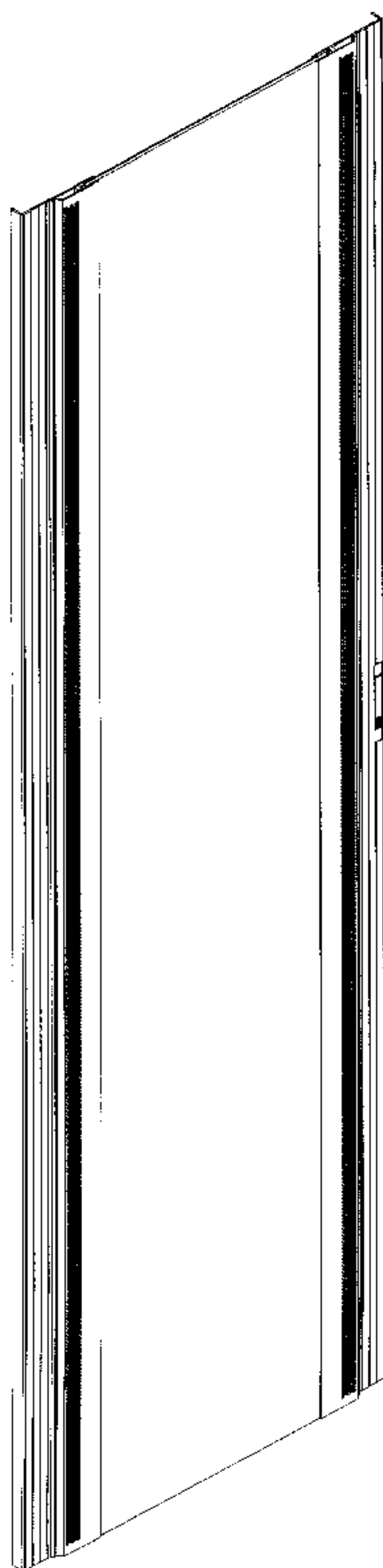

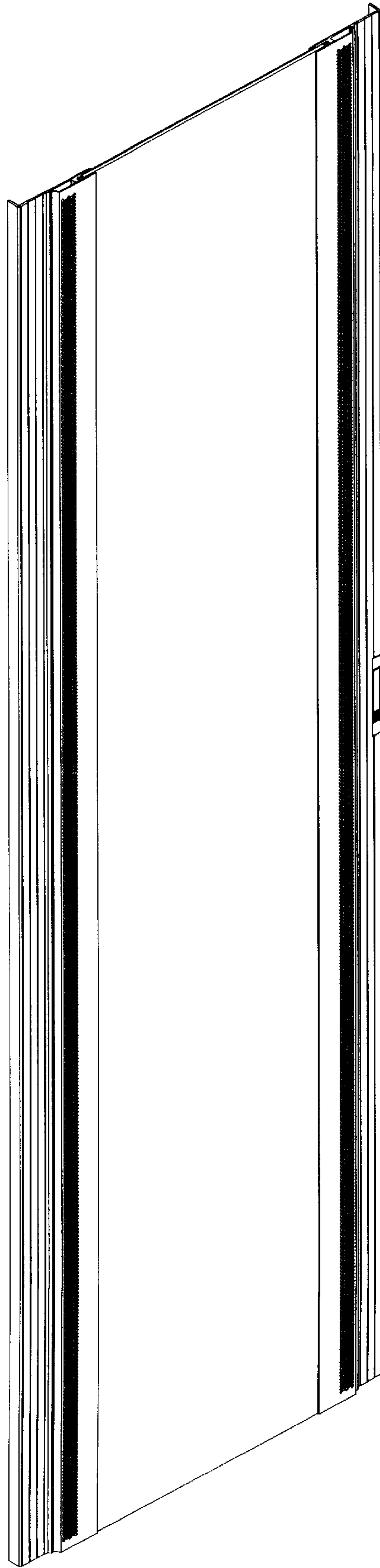

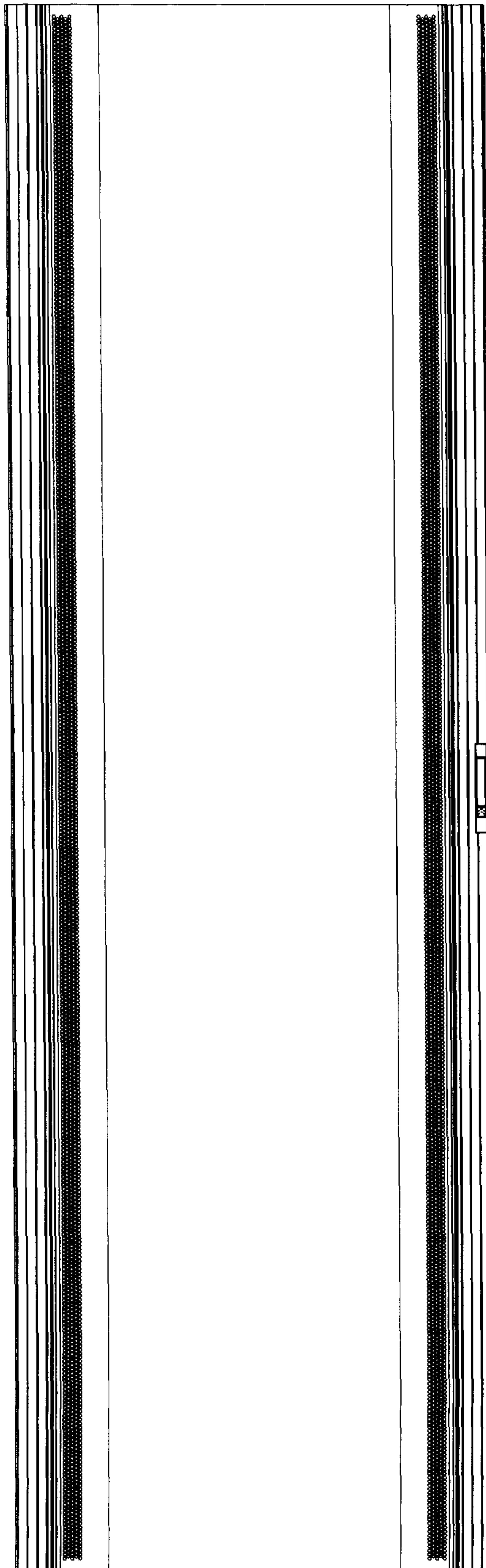
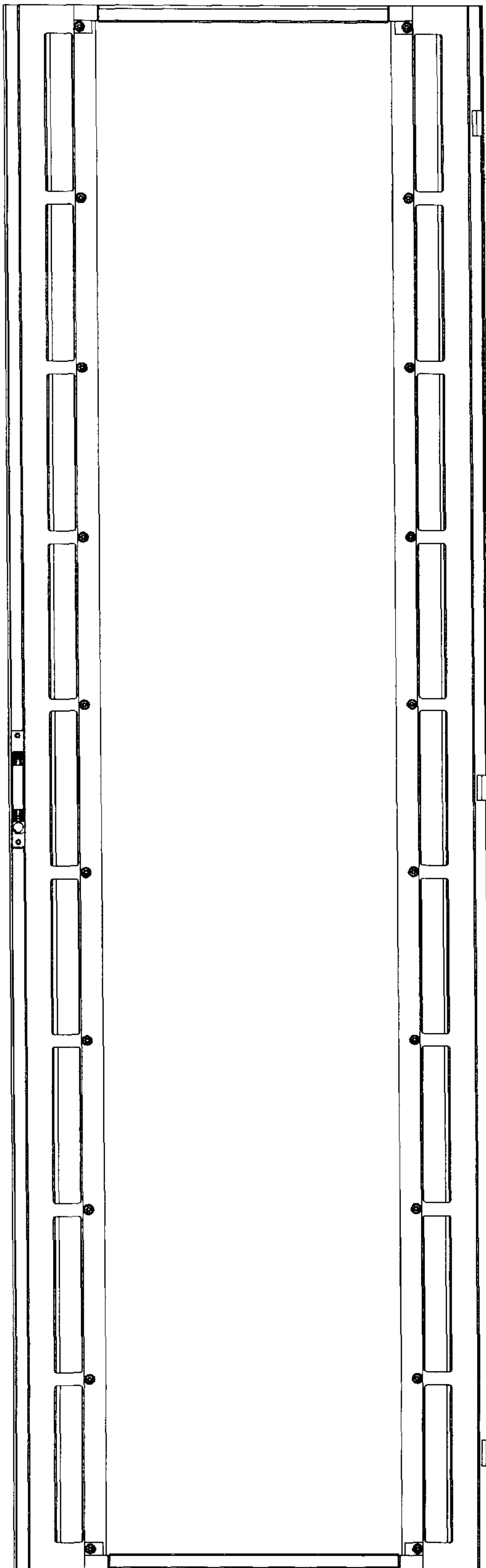
