FIG. 1 is a front elevational view of a computer generated icon for a computer monitor showing our new design;

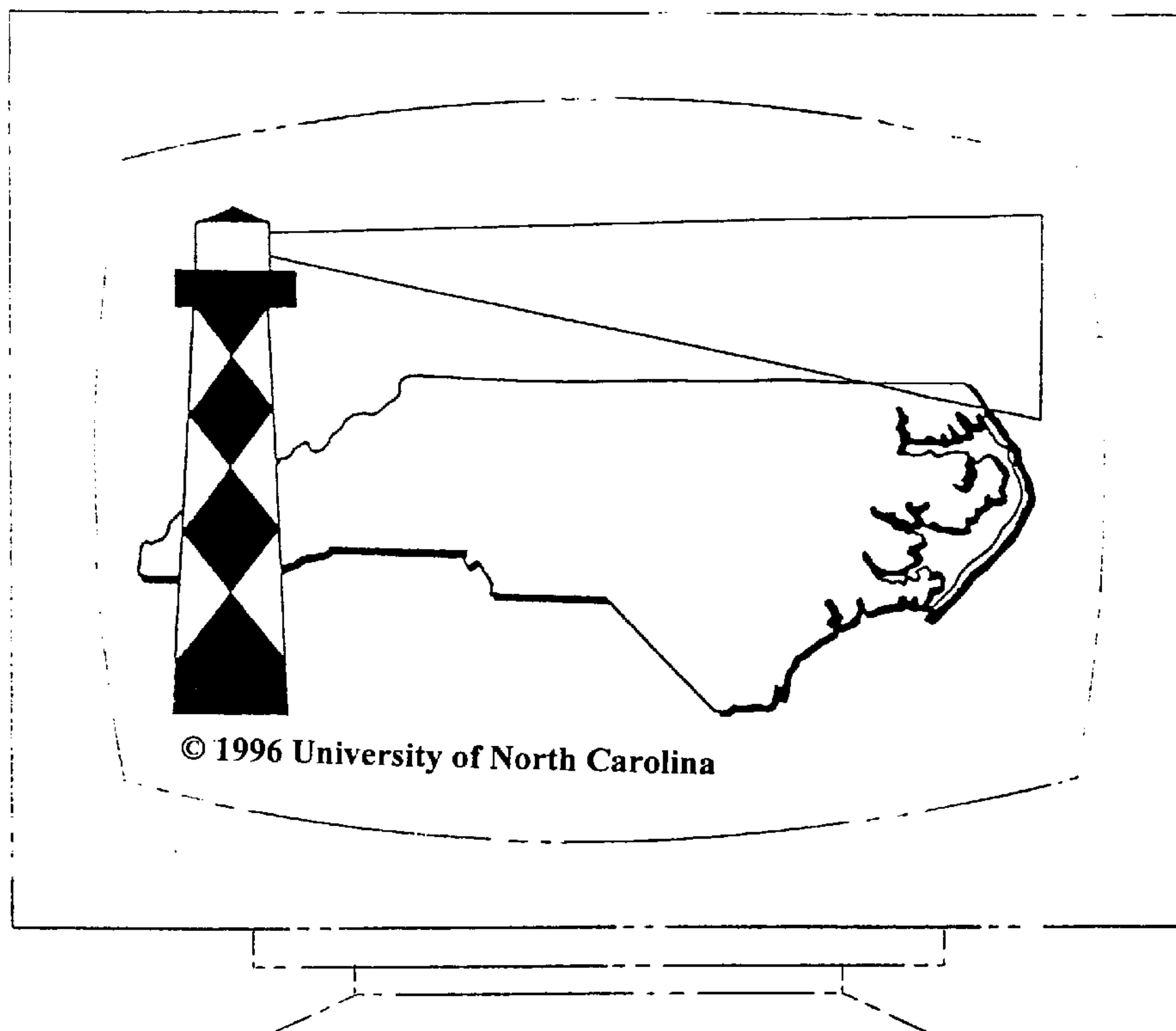
FIG. 2 is a front elevational view of a second embodiment thereof; and,

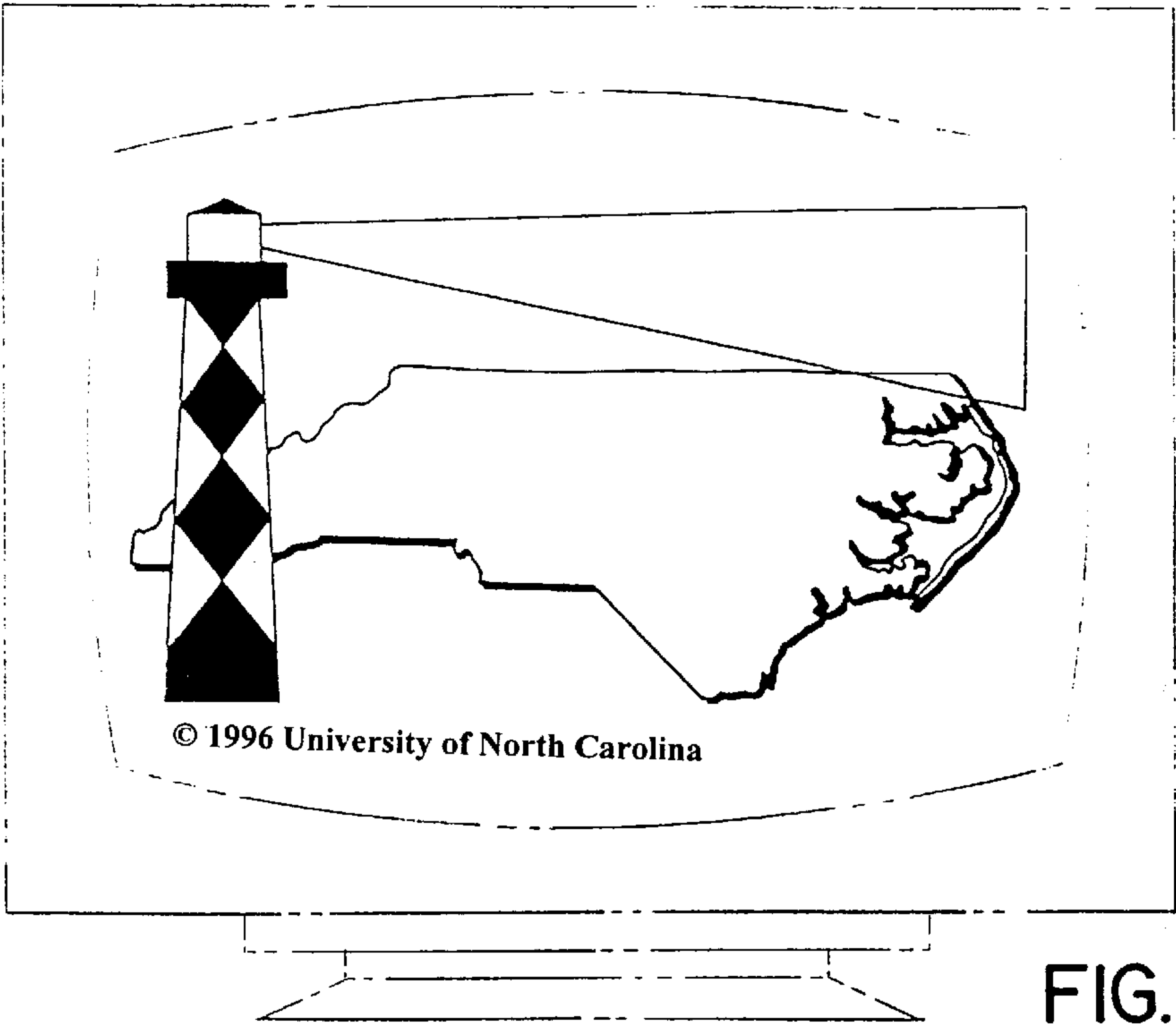

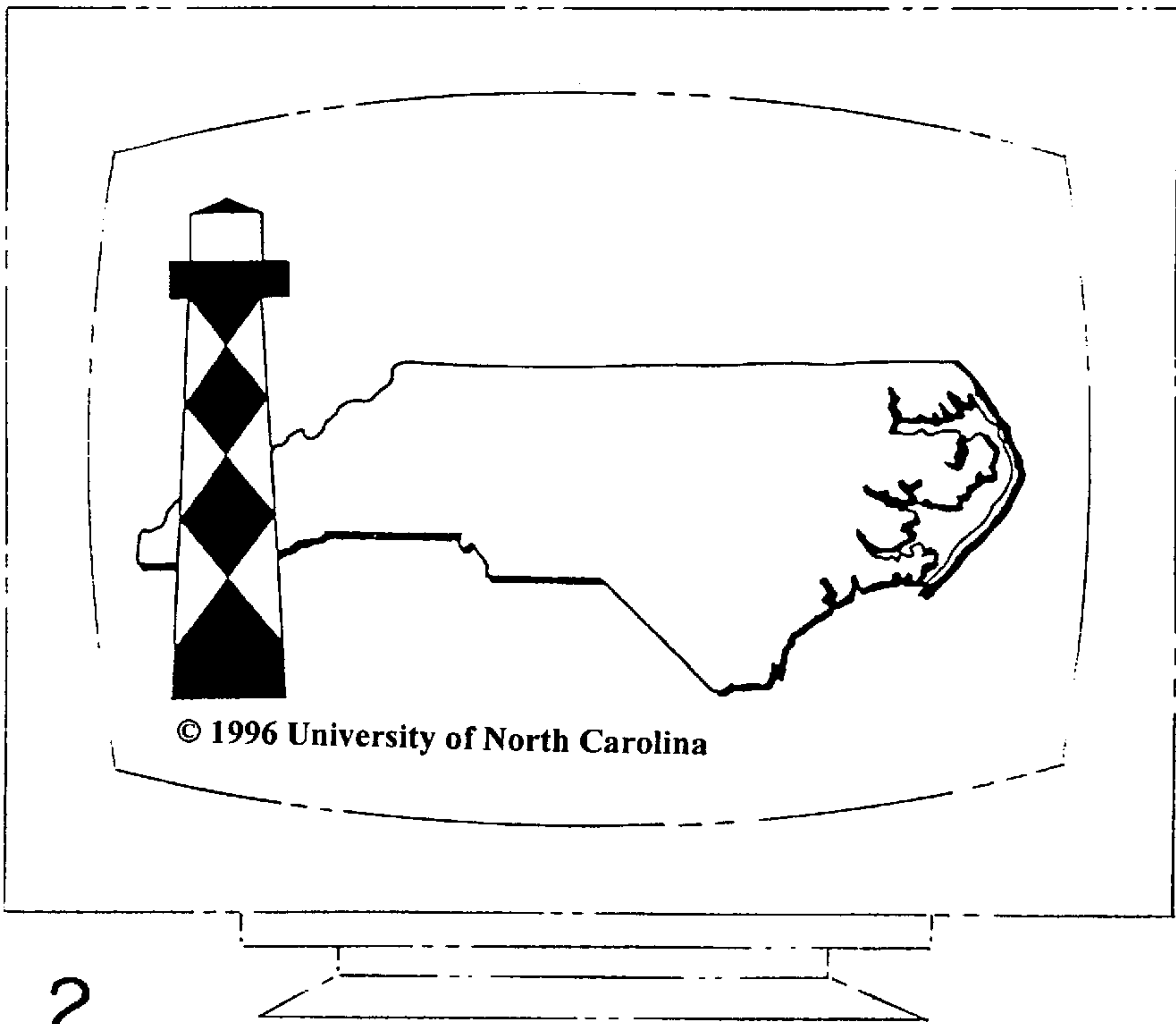

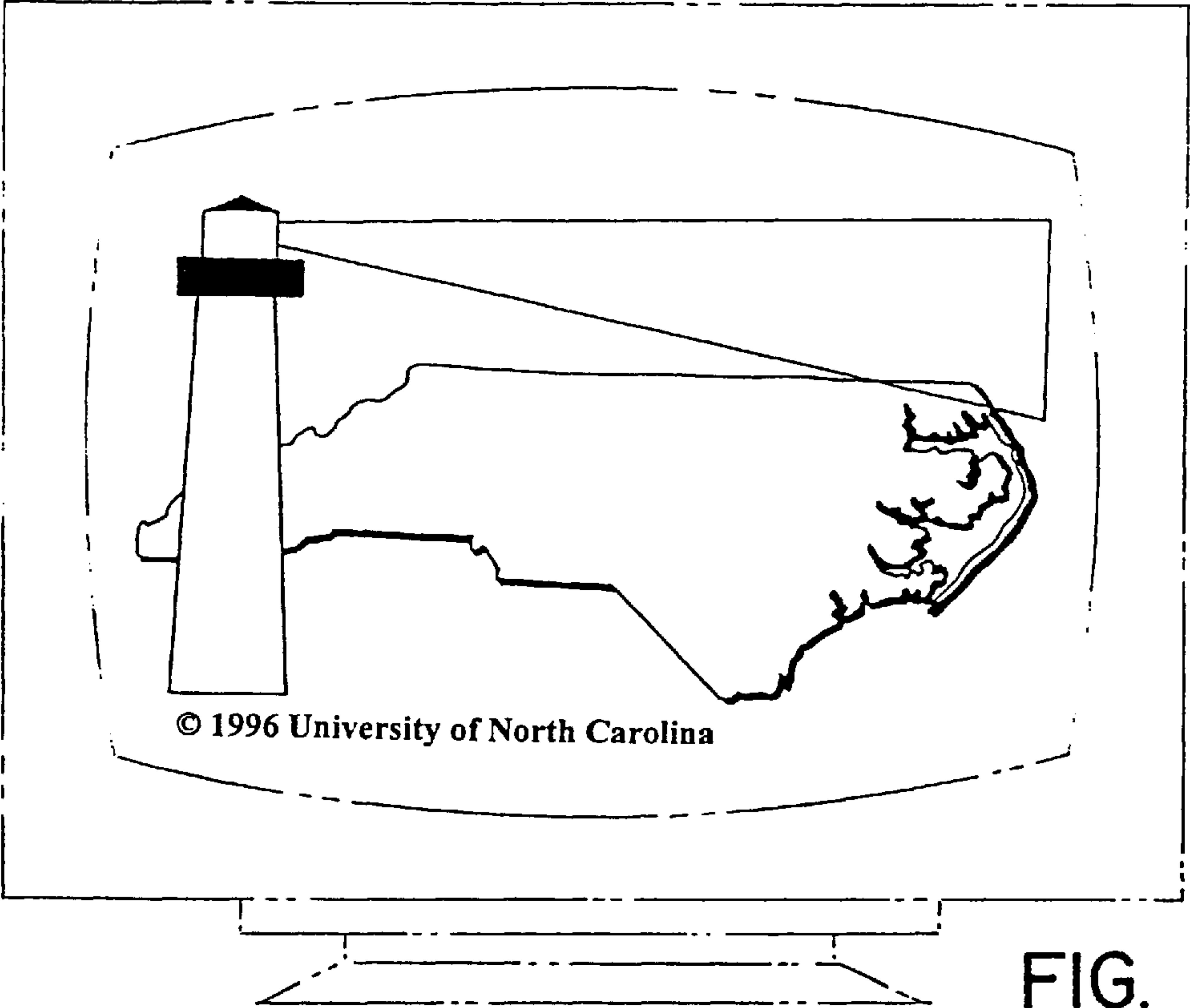
