[57] **CLAIM**

The ornamental design for a type font, as shown and described.

DESCRIPTION

FIGS. 1A, 1B and 1C are views of a light form of a type font showing the new design.

FIGS. 2A, 2B and 2C are views of a condensed form of the type font shown in FIGS. 1A, 1B and 1C;

FIGS. 3A, 3B and 3C are views of a regular form of the type font shown in FIGS. 1A, 1B and 1C;

FIGS. 4A, 4B and 4C are views of a condensed form of the type font shown in FIGS. 3A, 3B and 3C;

FIGS. 5A, 5B and 5C are views of a semibold form of the type font shown in FIGS. 1A, 1B 1C;

FIGS. 6A, 6B and 6C are views of a condensed form of the type font shown in FIGS. 5A, 5B 5C.

FIGS. 7A, 7B and 7C are views of a bold form of the type font shown in FIGS. 1A, 1B and 1C; and,

FIGS. 8A, 8B and 8C are views of a condensed form of the type font shown in FIGS. 7A, 7B and 7C.
