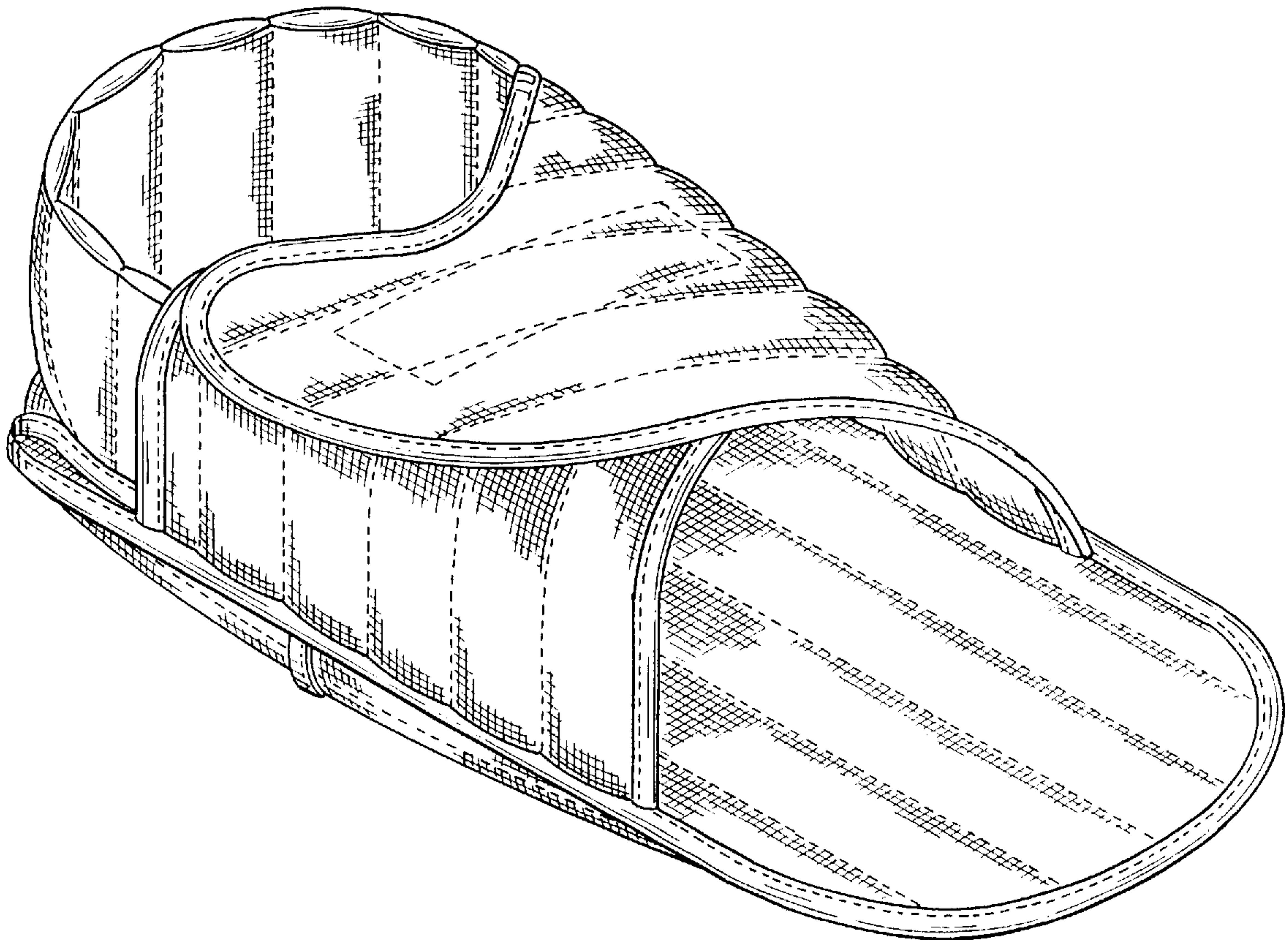
The ornamental design for a slipper for rehabilitation exercisers, as shown and described.

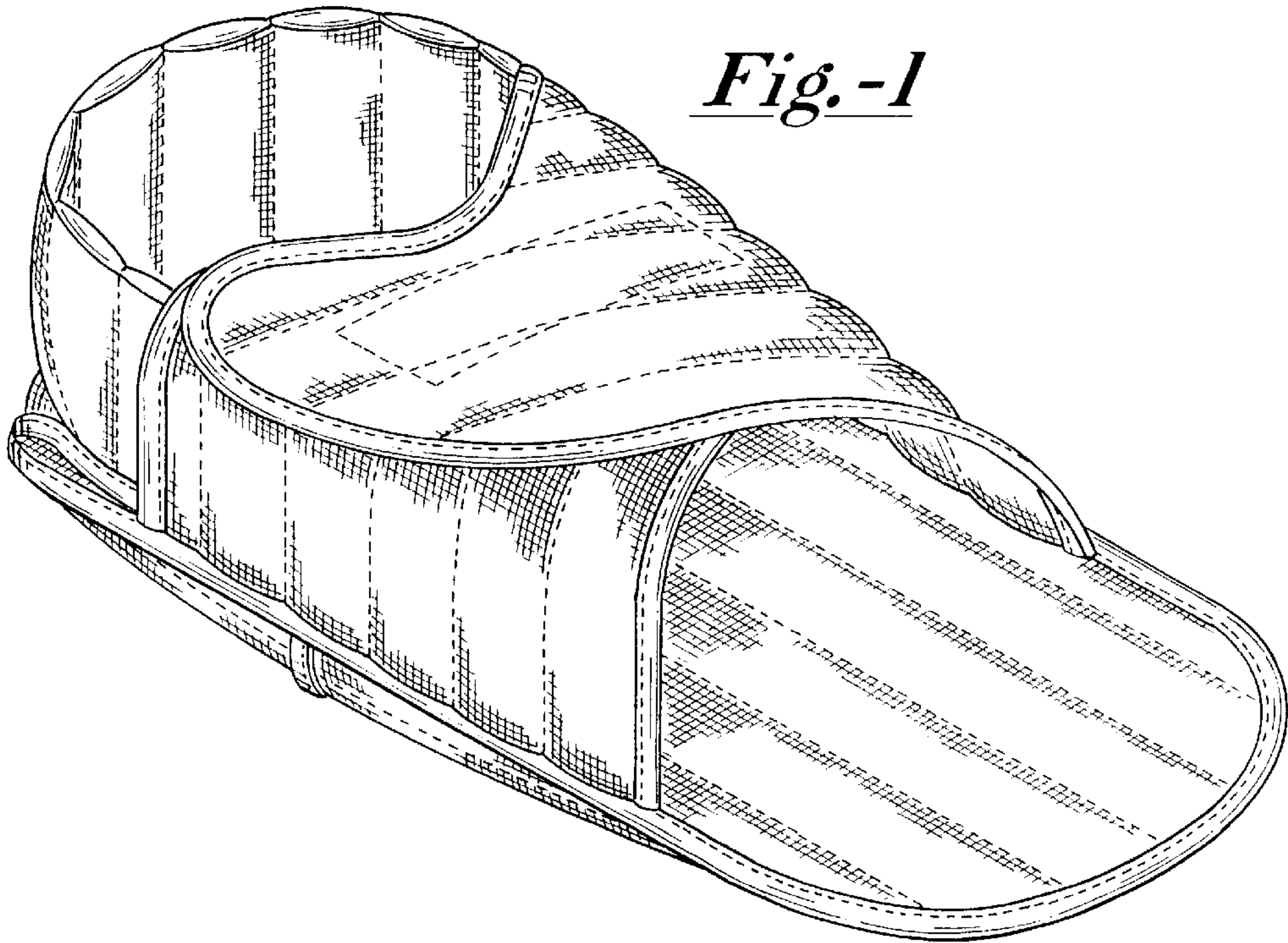
**DESCRIPTION**

FIG. 1 is perspective view of a slipper for rehabilitation exercisers, showing our new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a rear elevational view thereof.

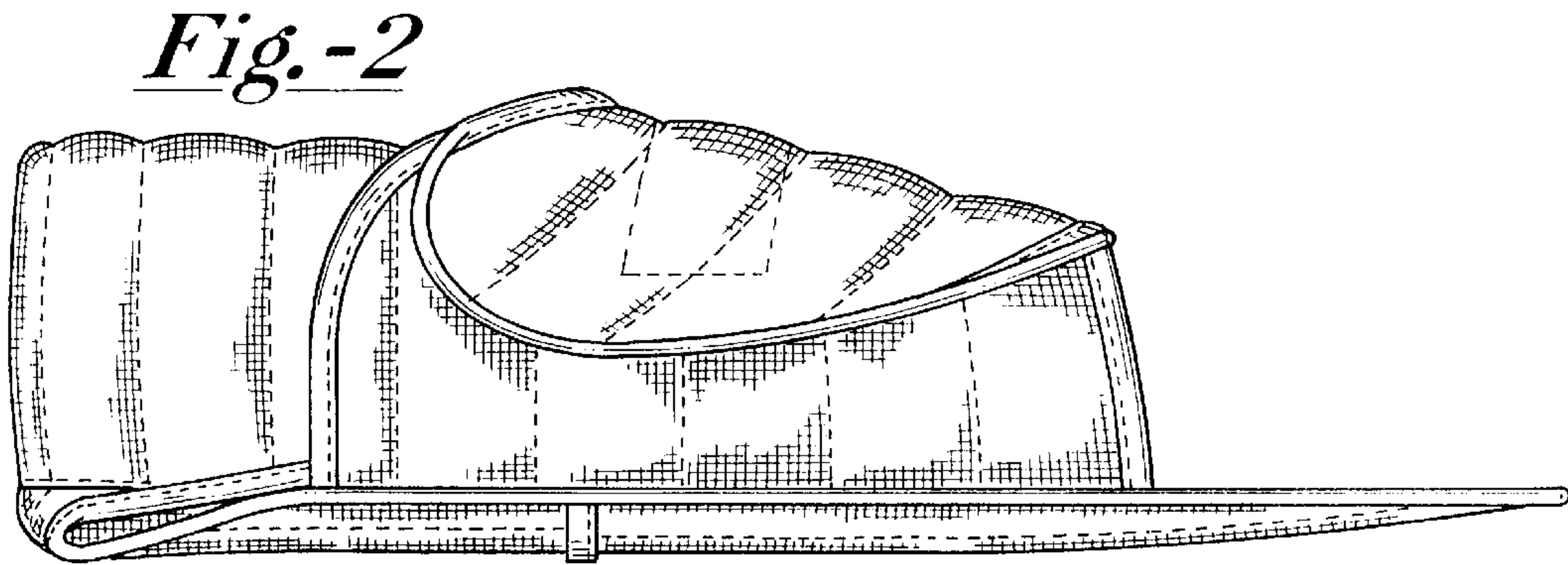
The broken lines throughout claimed design represent conventional stitching.

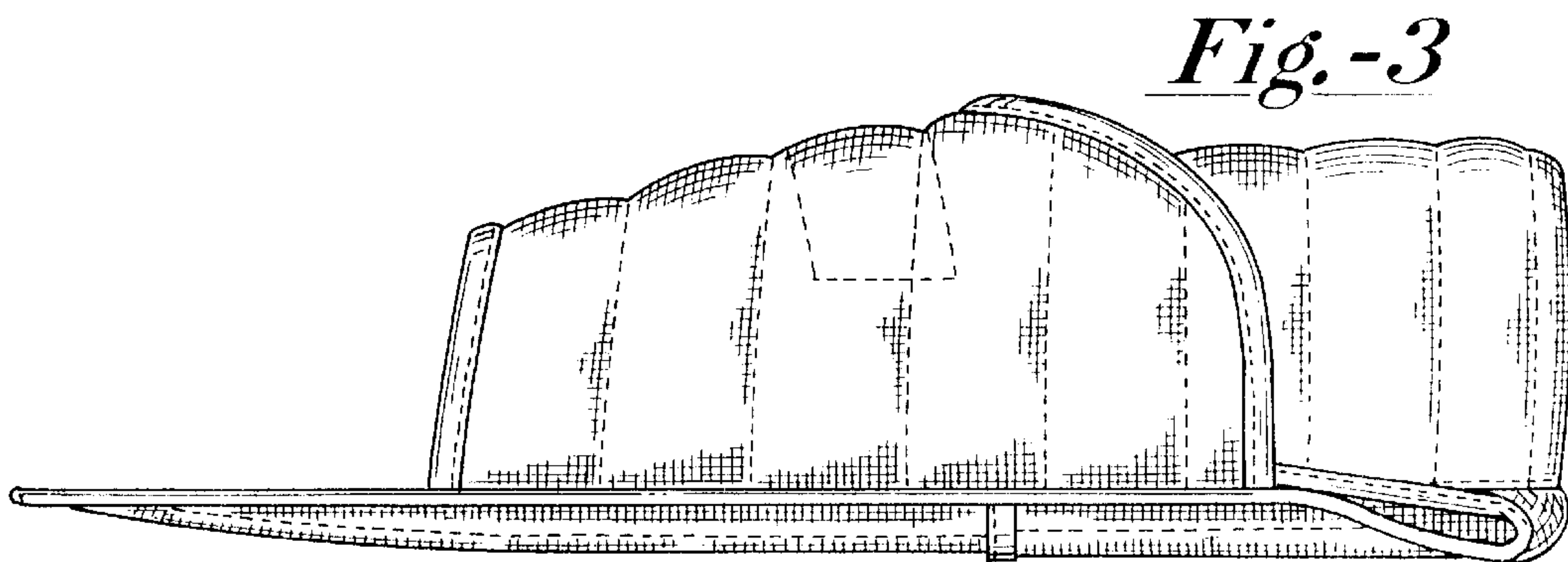

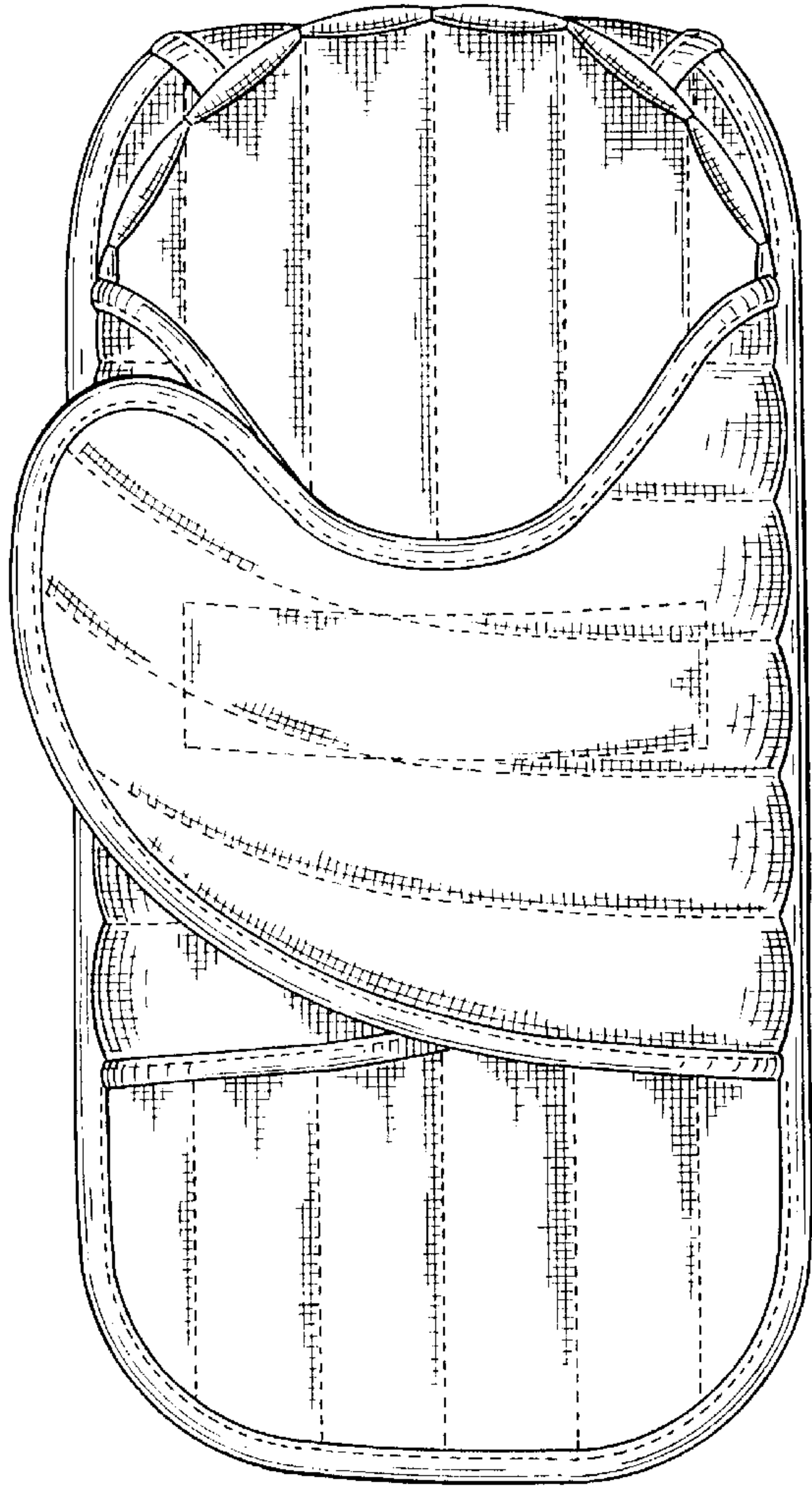

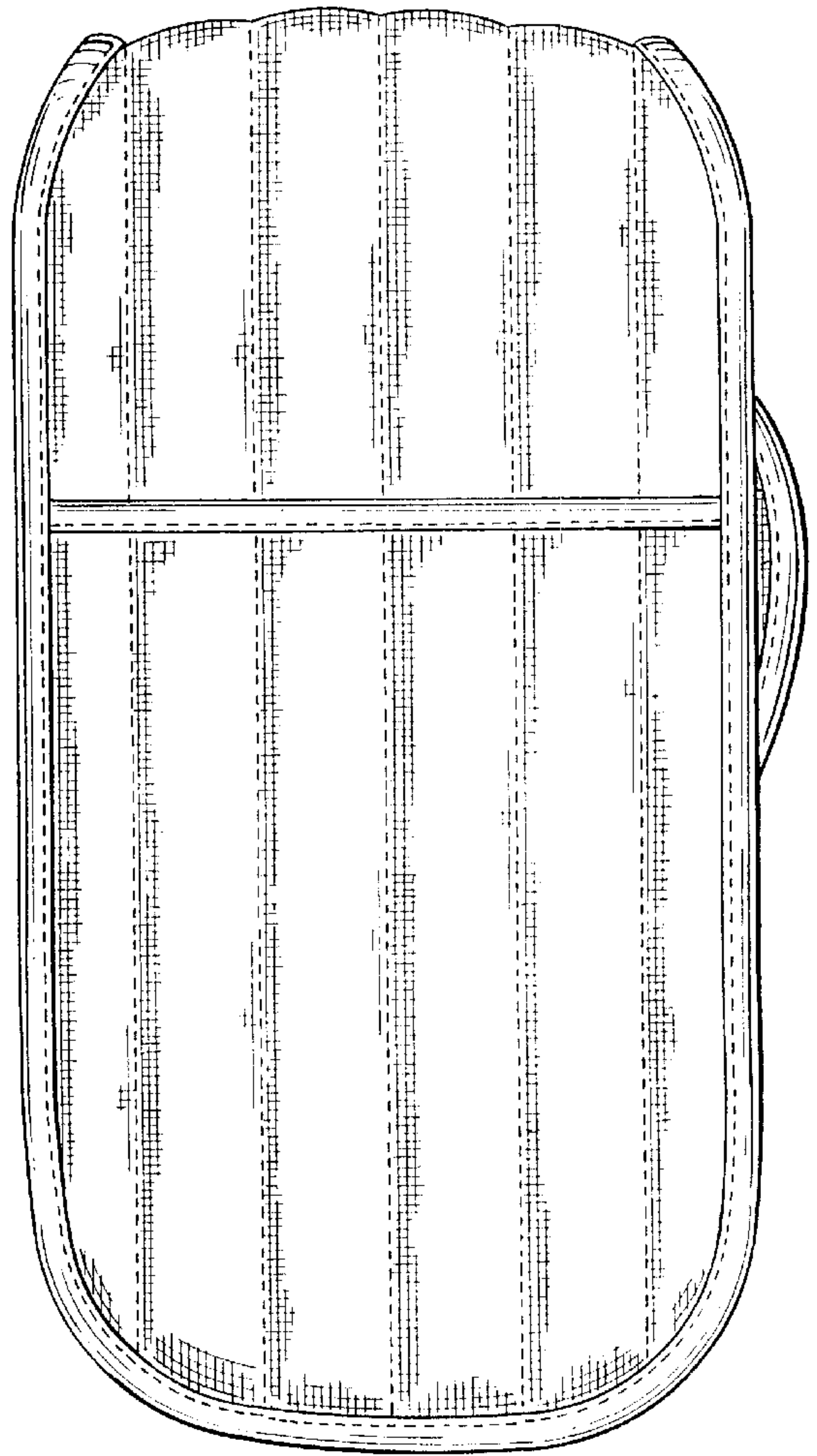

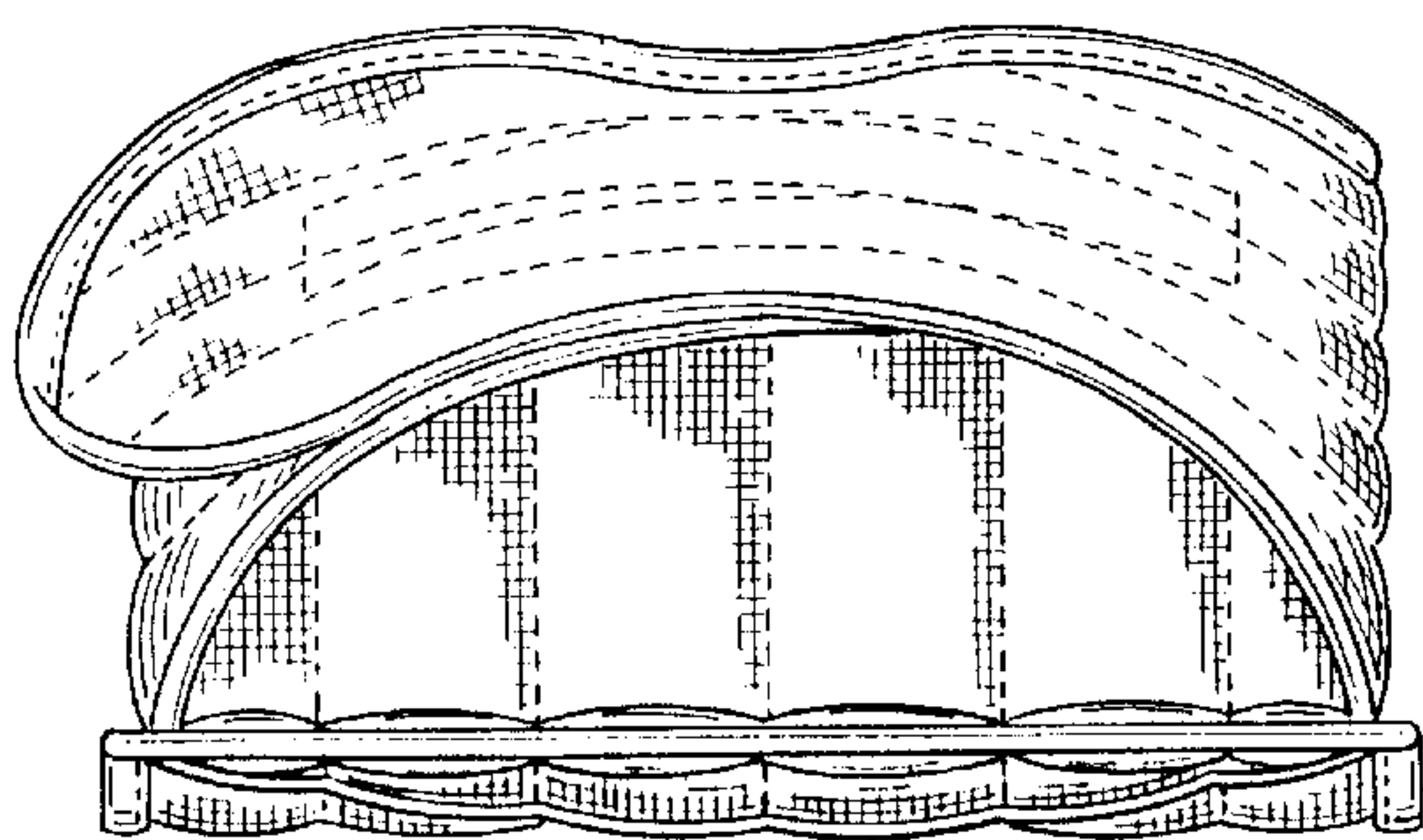
