FIG. 10 is a right side view thereof;

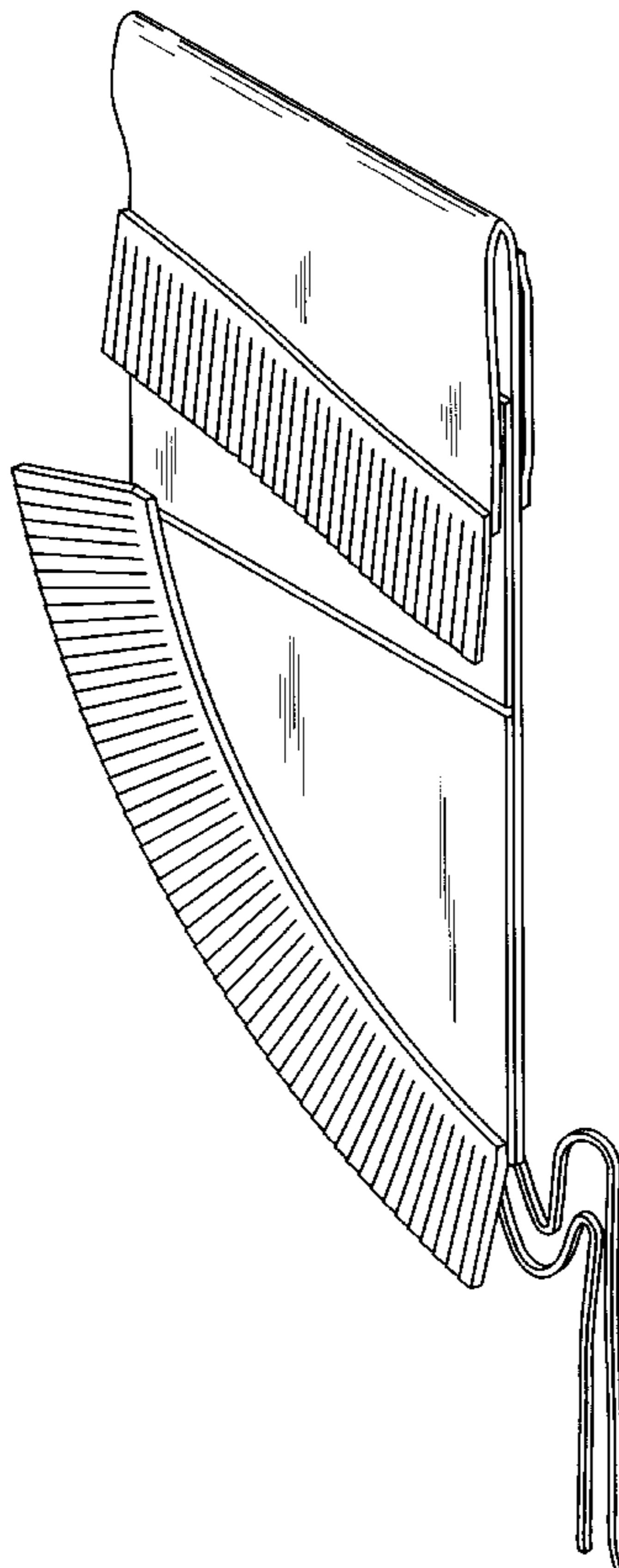
FIG. 11 is a front view thereof;

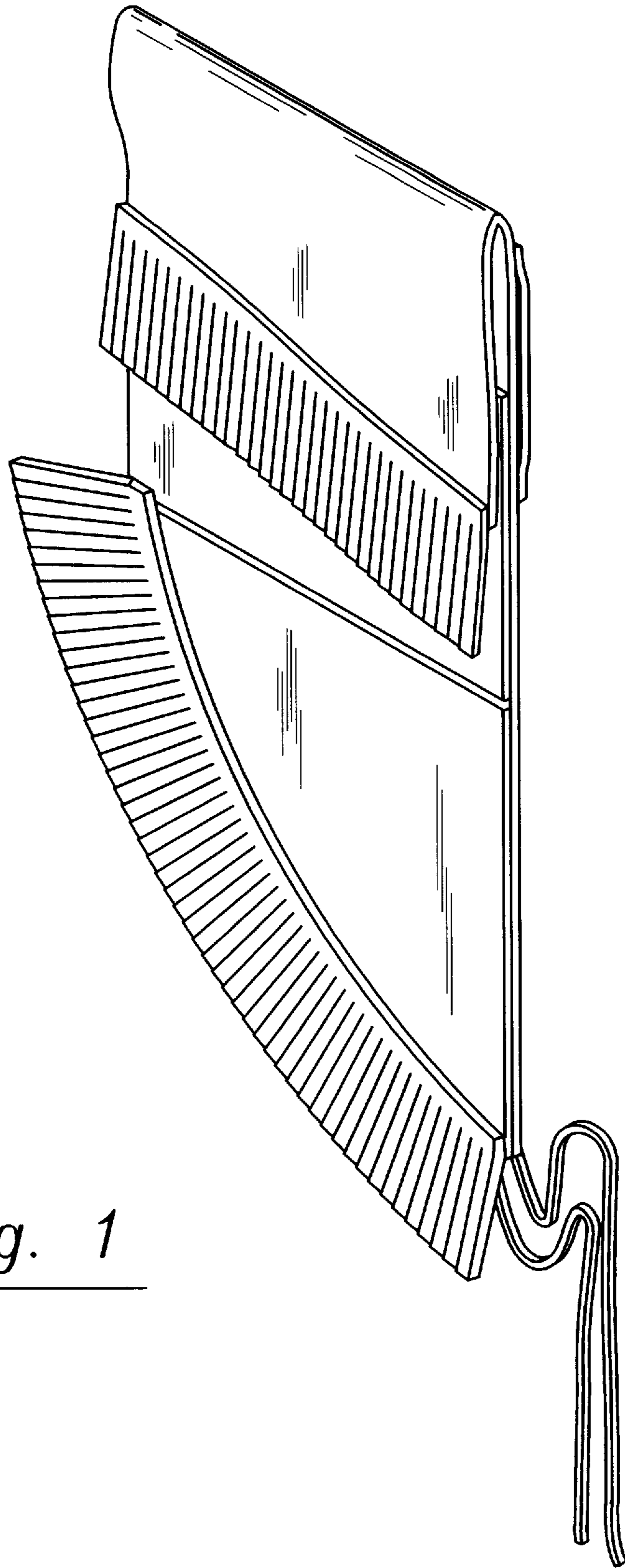

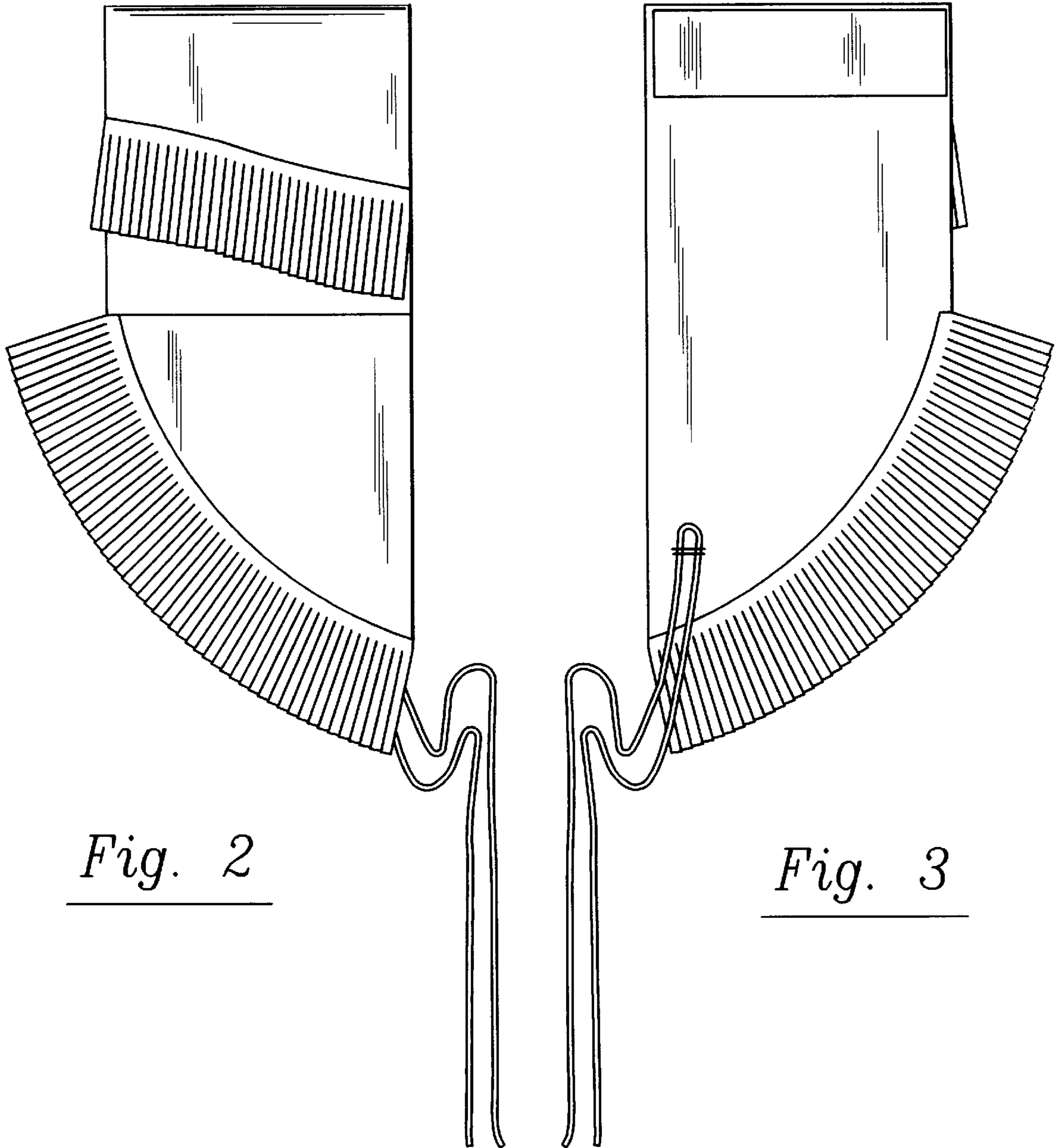

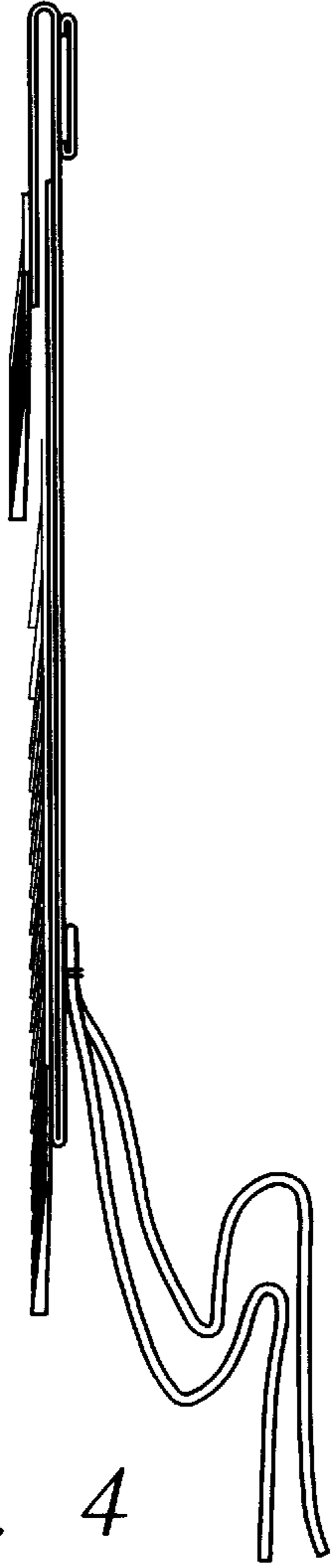

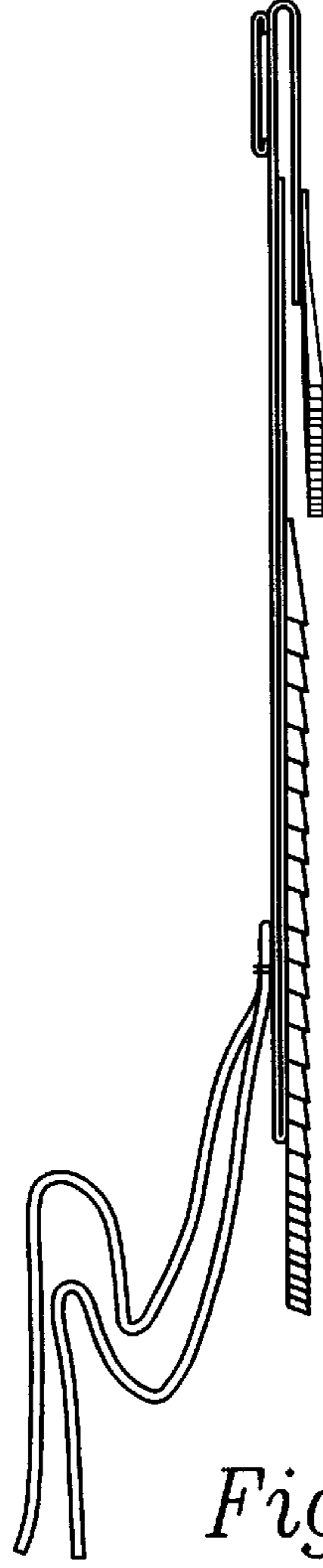

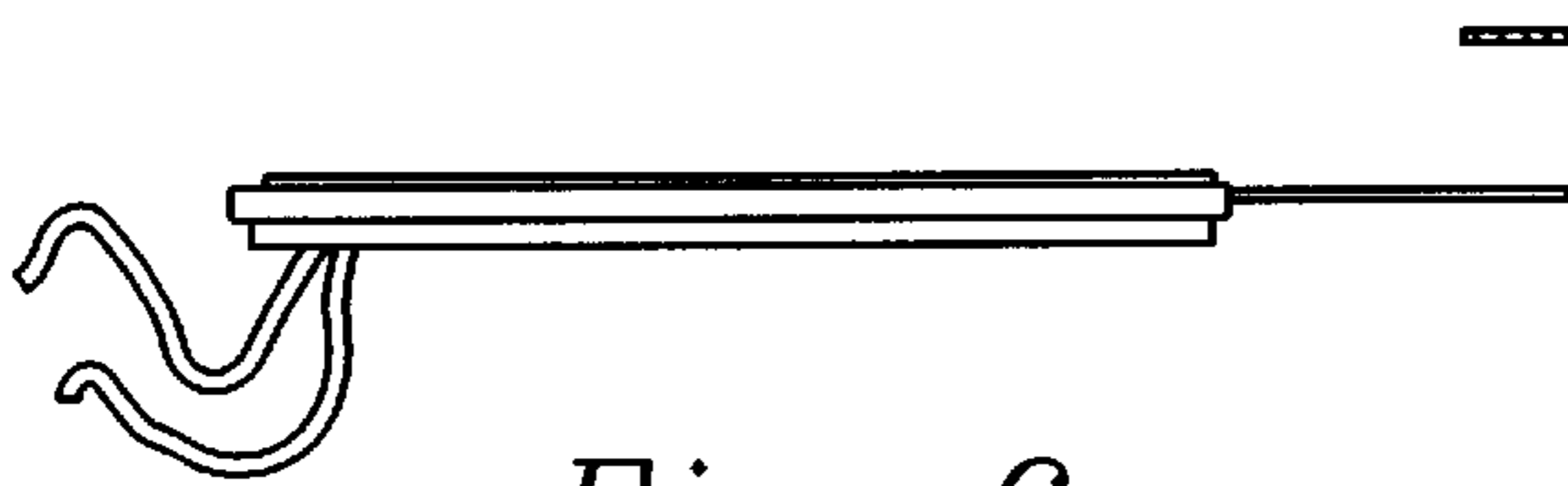

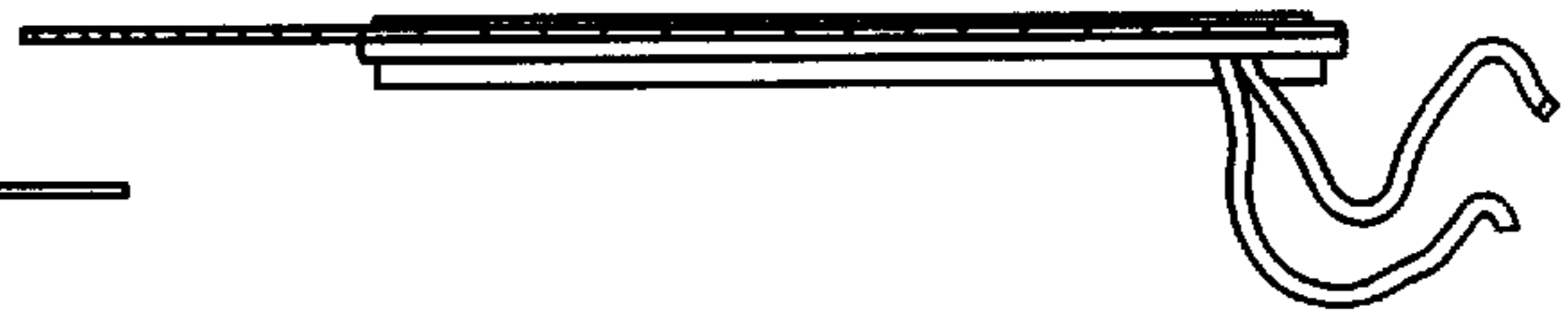

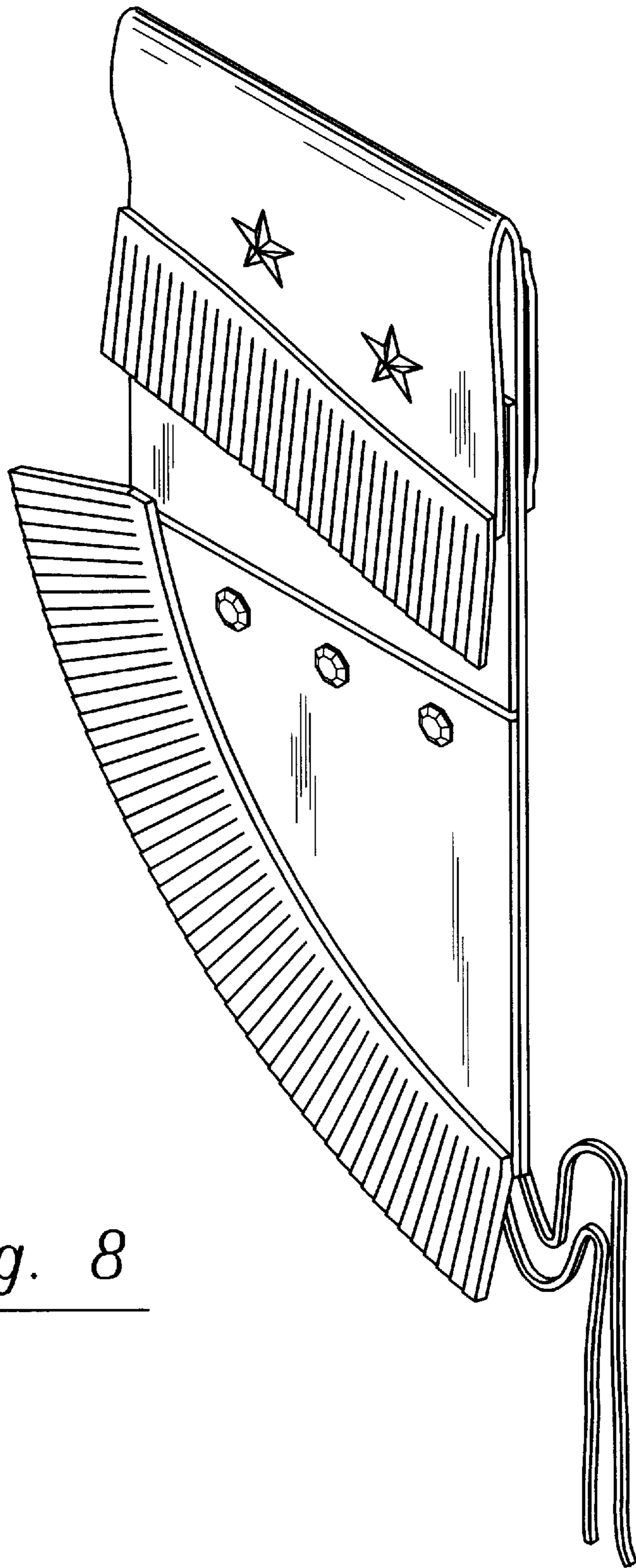

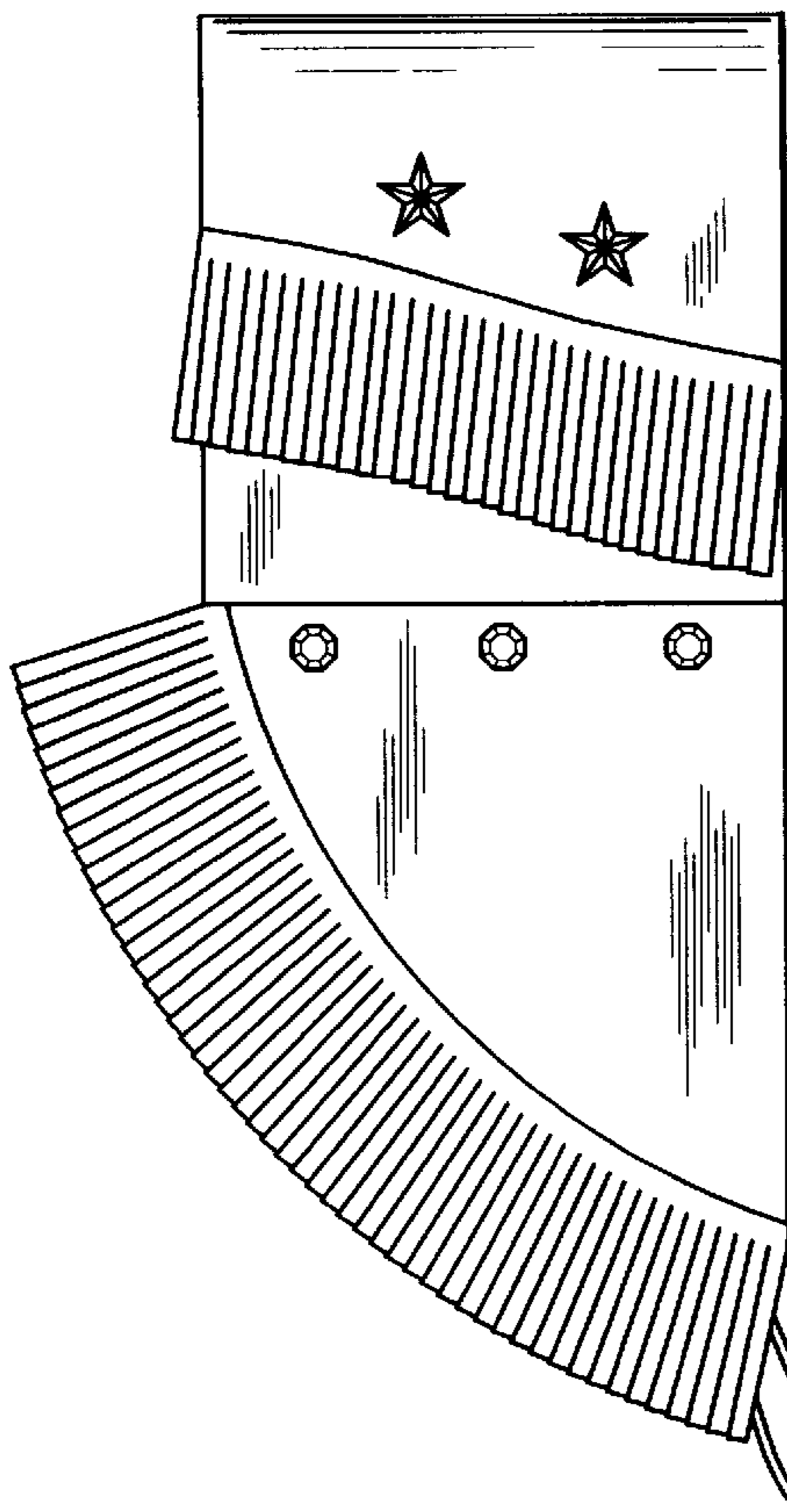

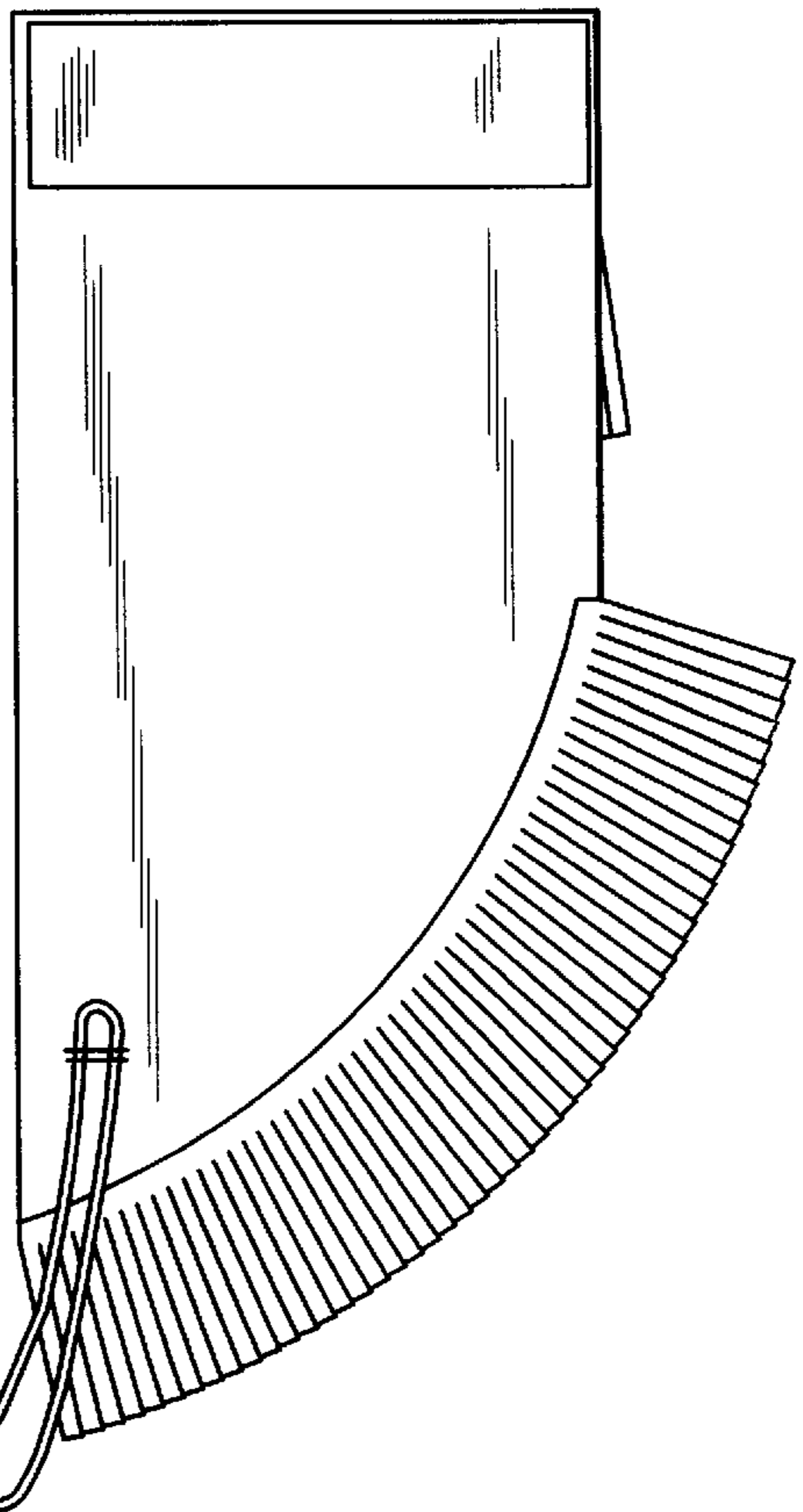

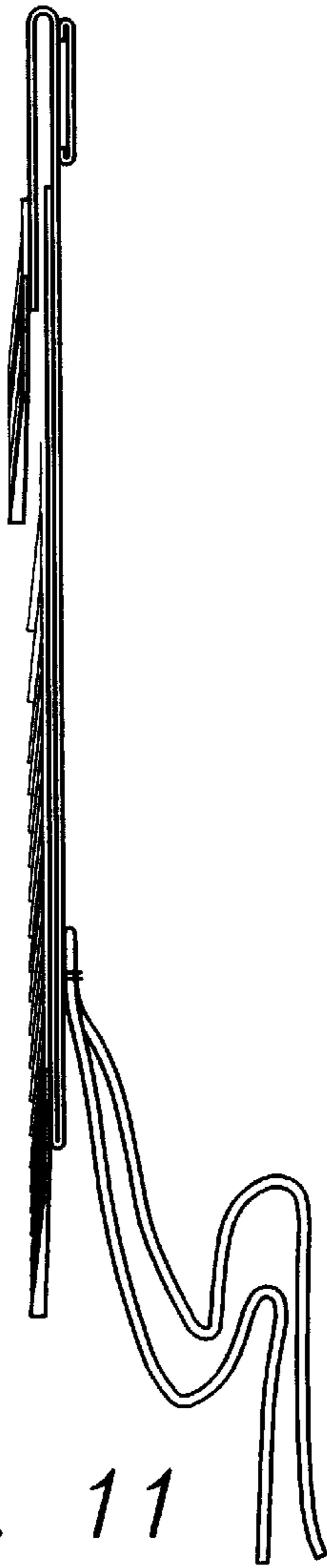

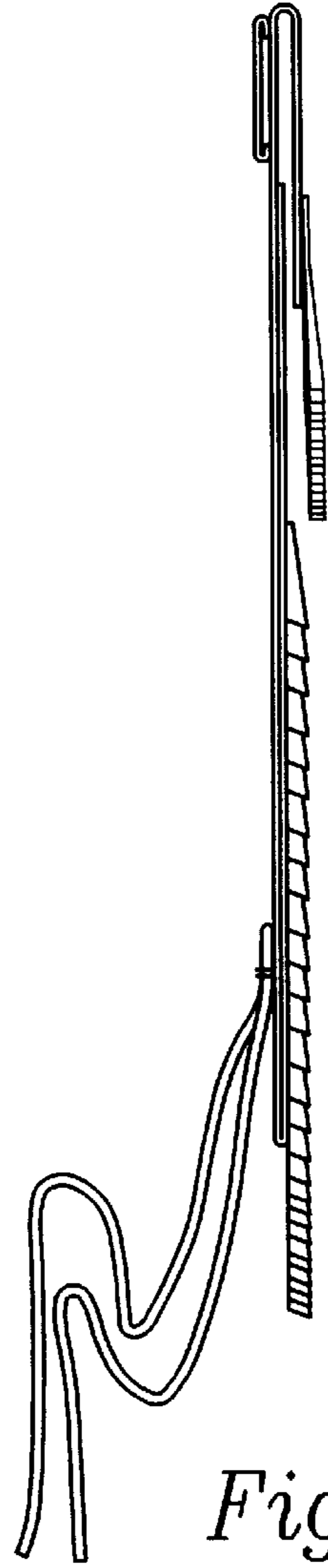

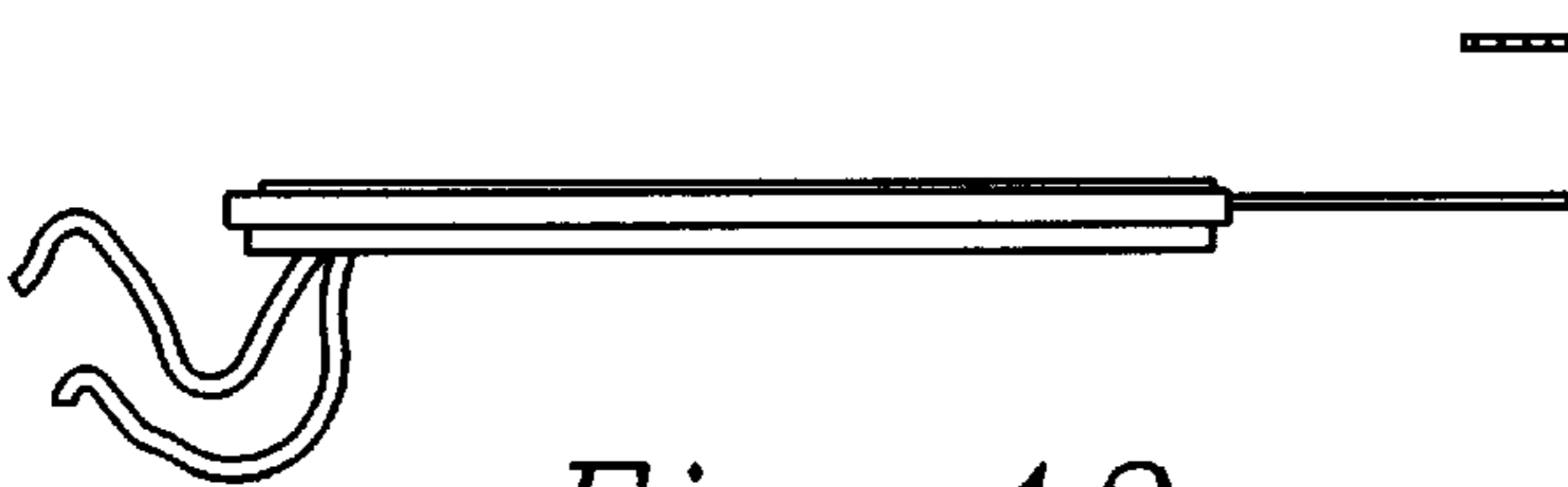

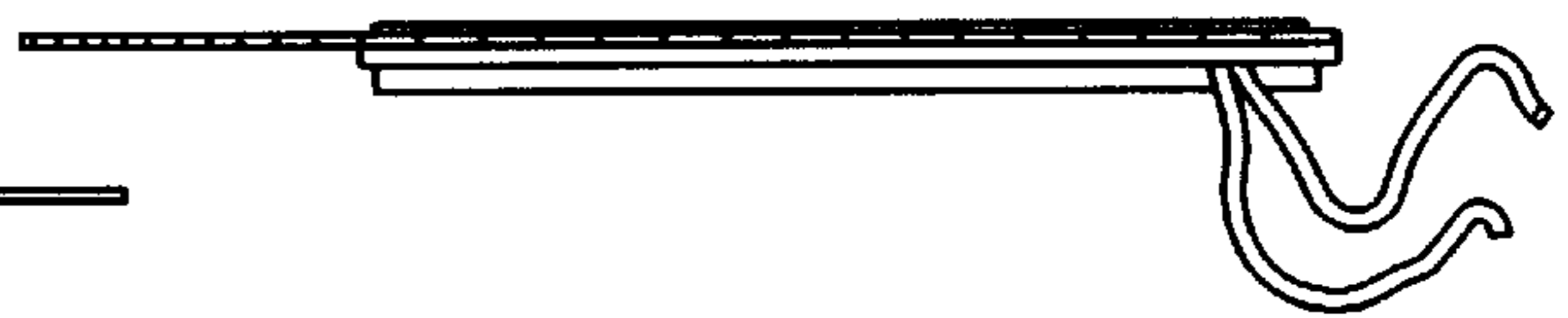
