[57] **CLAIM**

The ornamental design for a baby food organizer, as shown and described.

FIG. 1 is a top, front, and left side perspective view of a baby food organizer showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is an enlarged vertical cross-sectional view thereof, taken along line 7—7 of FIG. 2;  
 FIG. 8 is a top, front, and left side perspective view of a baby food organizer showing a second embodiment of my new design;  
 FIG. 9 is a front elevational view thereof;  
 FIG. 10 is a top plan view thereof;  
 FIG. 11 is a rear elevational view thereof;  
 FIG. 12 is a bottom plan view thereof;  
 FIG. 13 is a left side elevational view thereof;  
 FIG. 14 is an enlarged vertical cross-sectional view thereof, taken along line 14—14 of FIG. 9; and,  
 FIG. 15 is a reduced front elevational view of a baby food organizer showing a third embodiment of my new design, the only difference from the first embodiment residing in the inclusion of two additional units grouped together.  
 The broken-line disclosure in the views is for illustrative purposes only and forms no part of the claimed design.

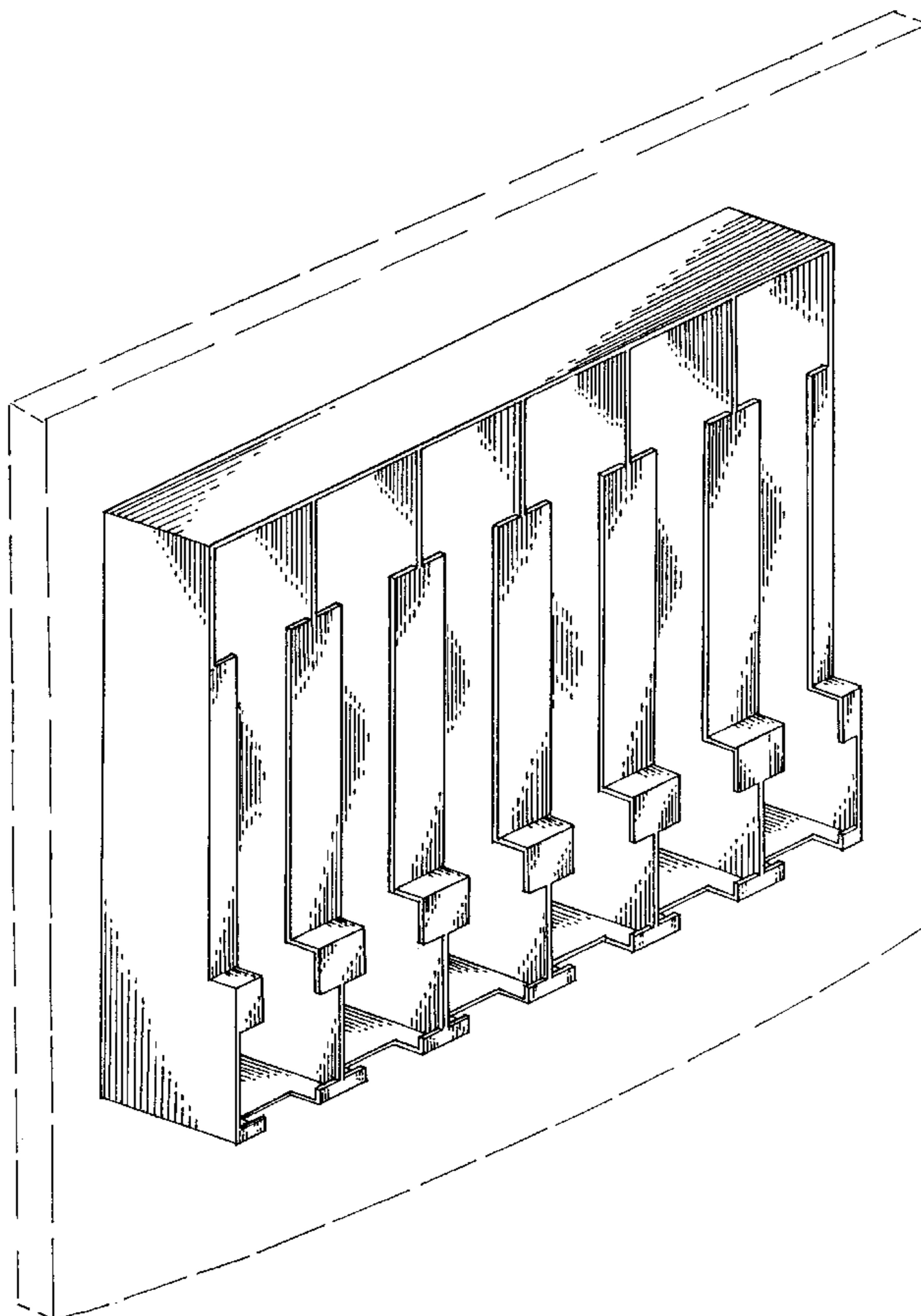

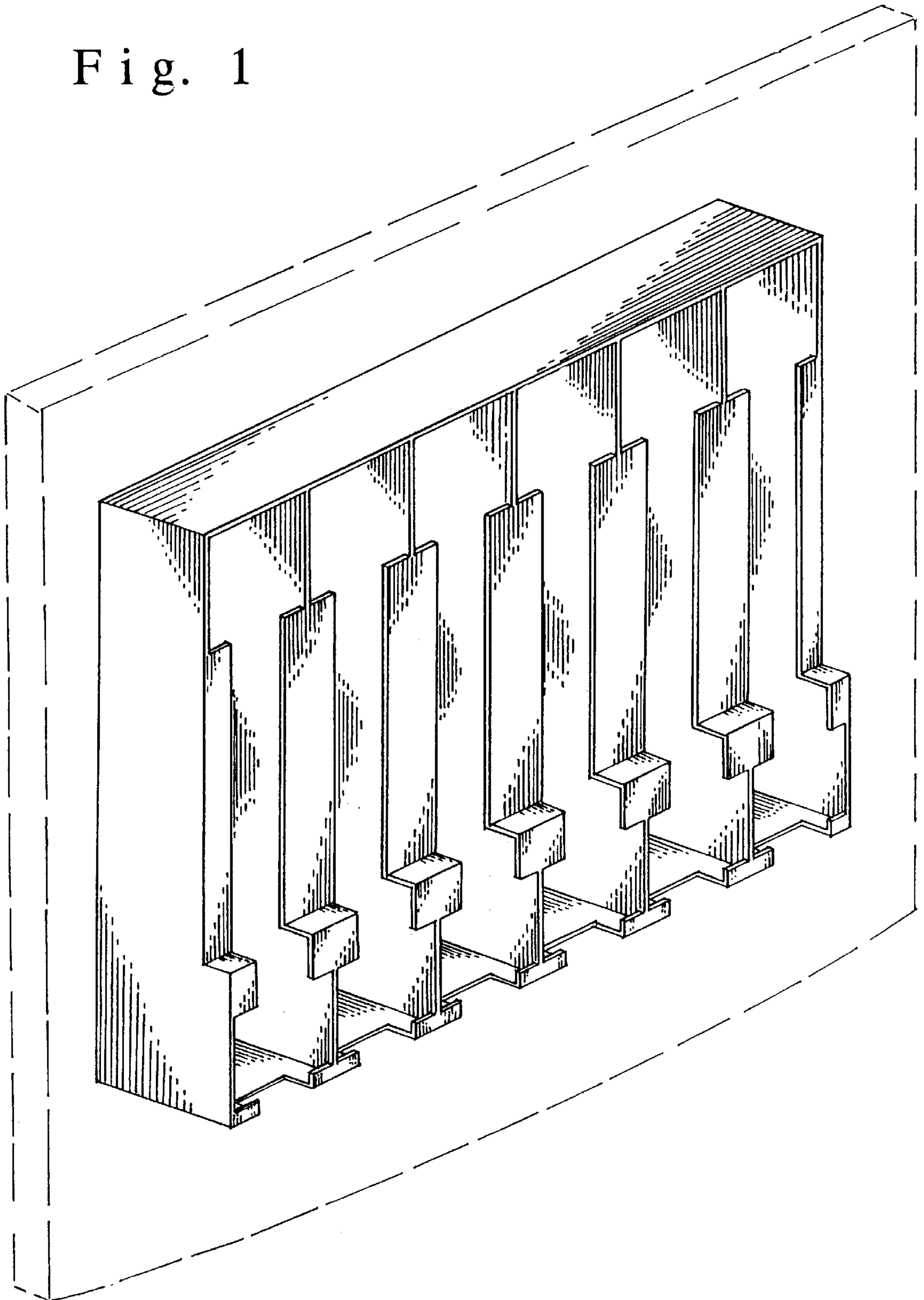

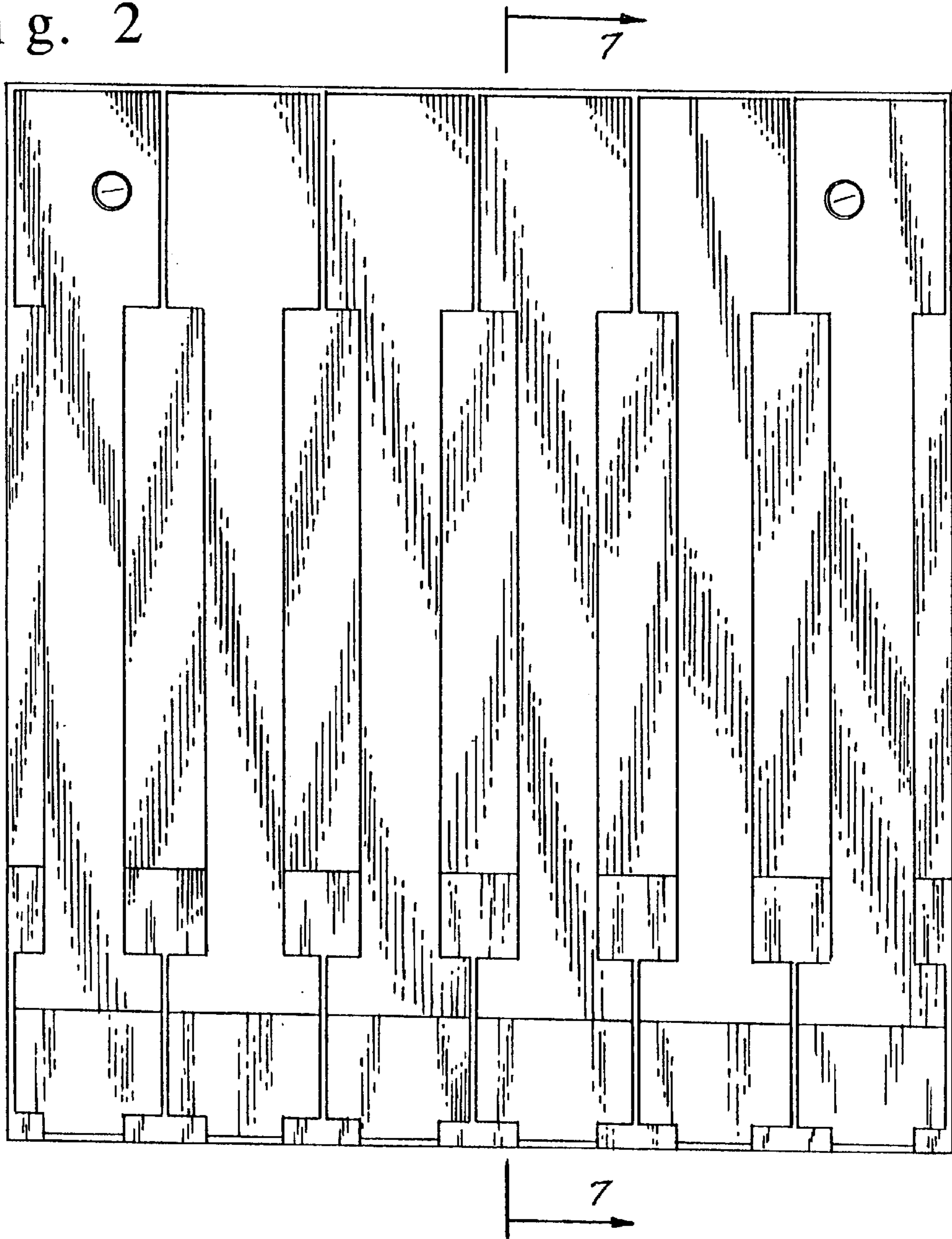

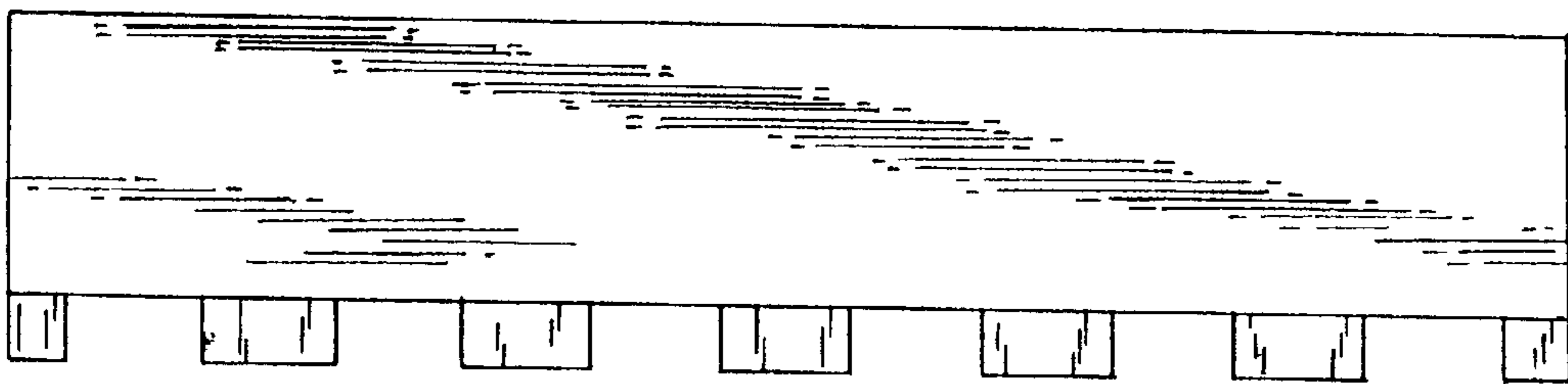

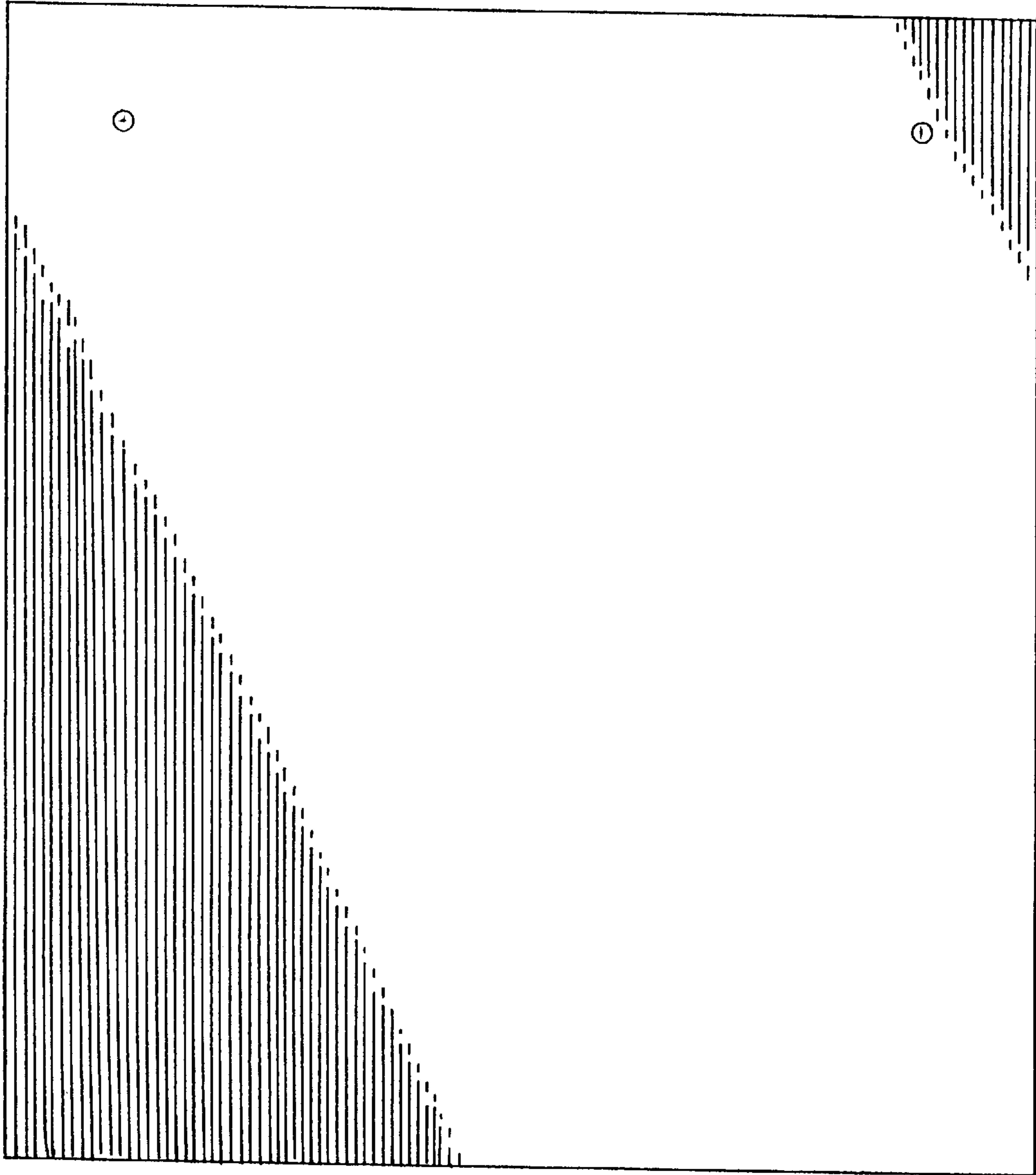

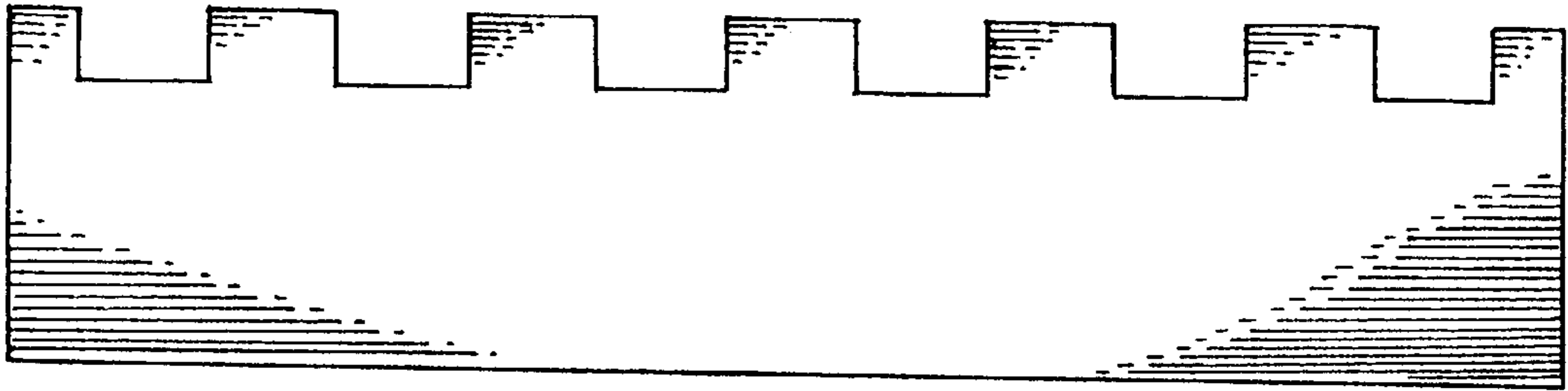
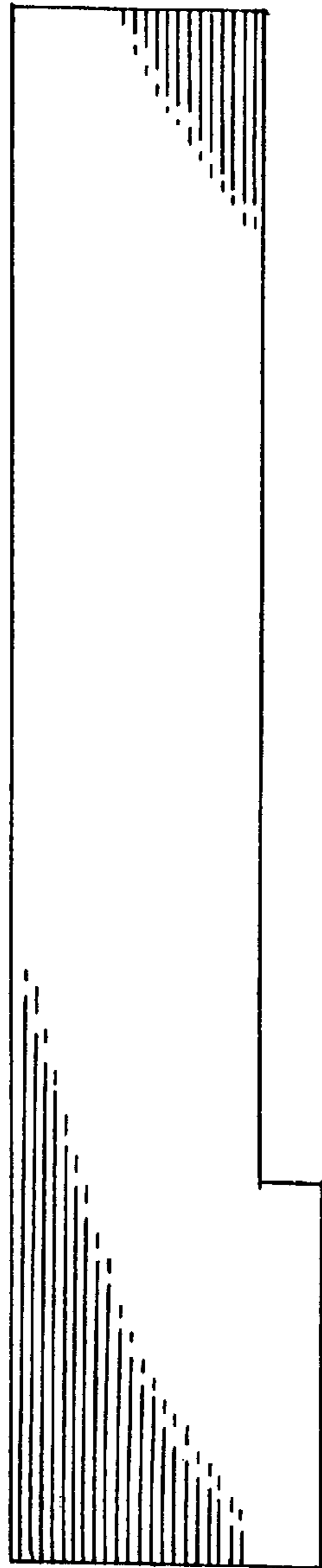

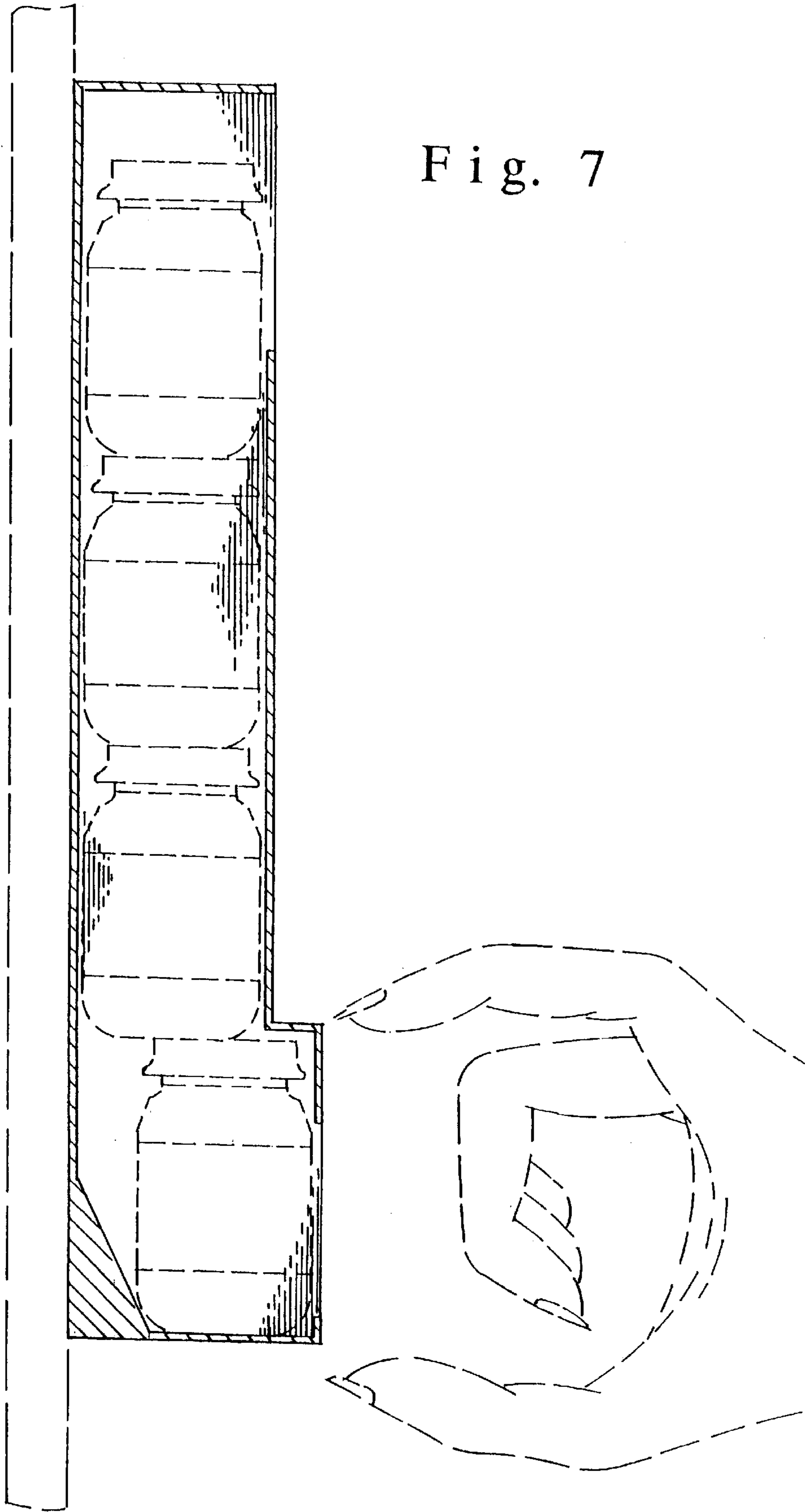

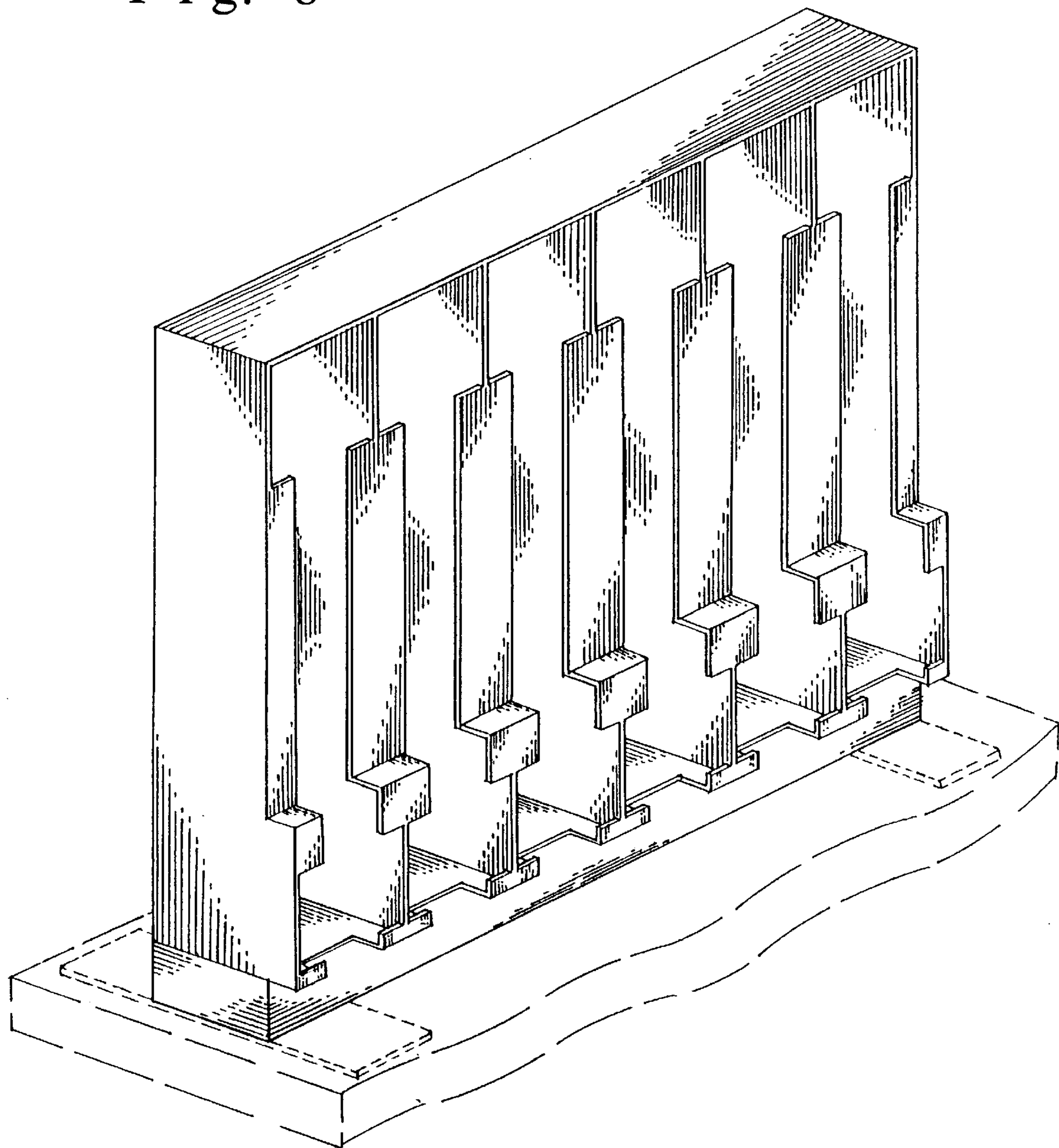

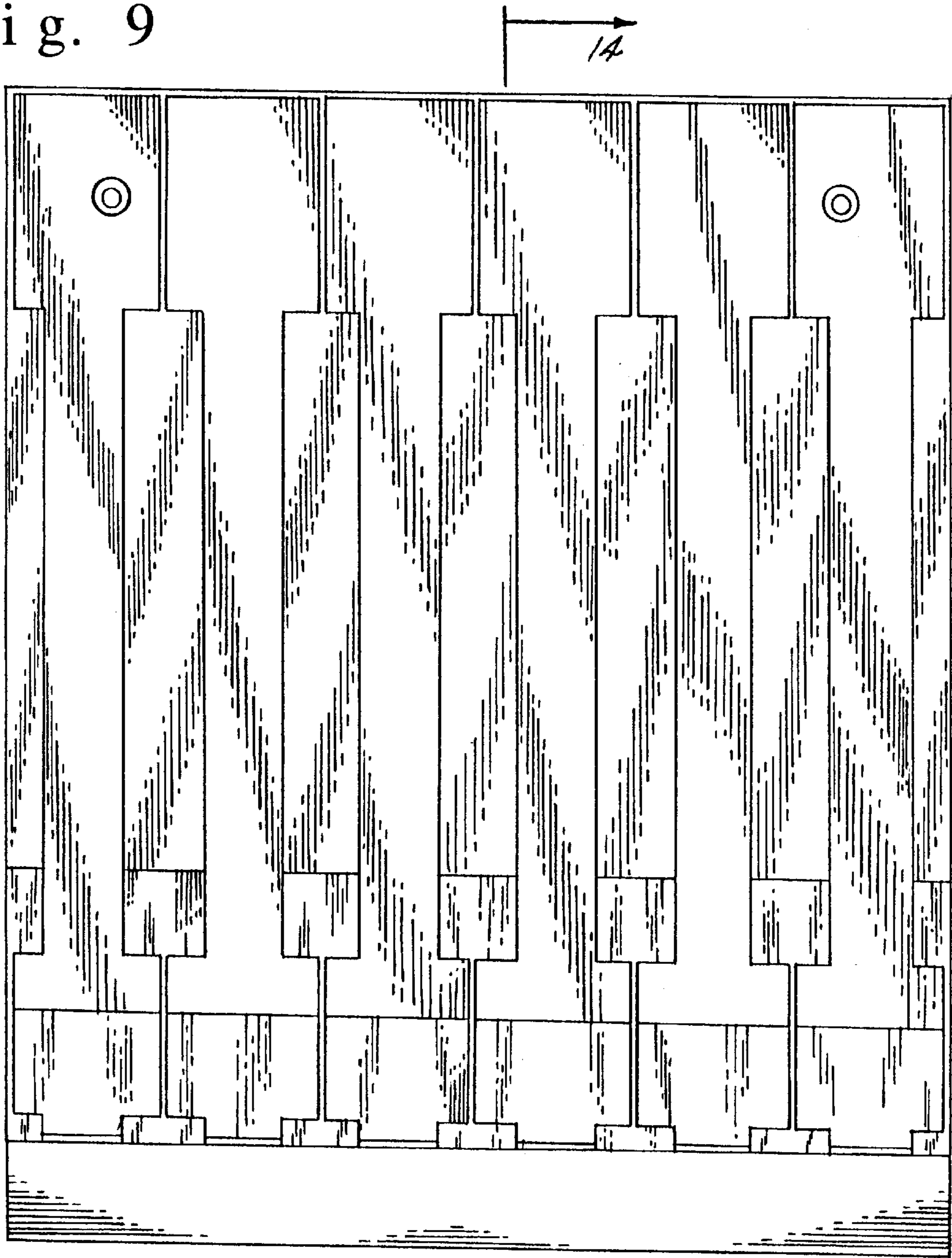

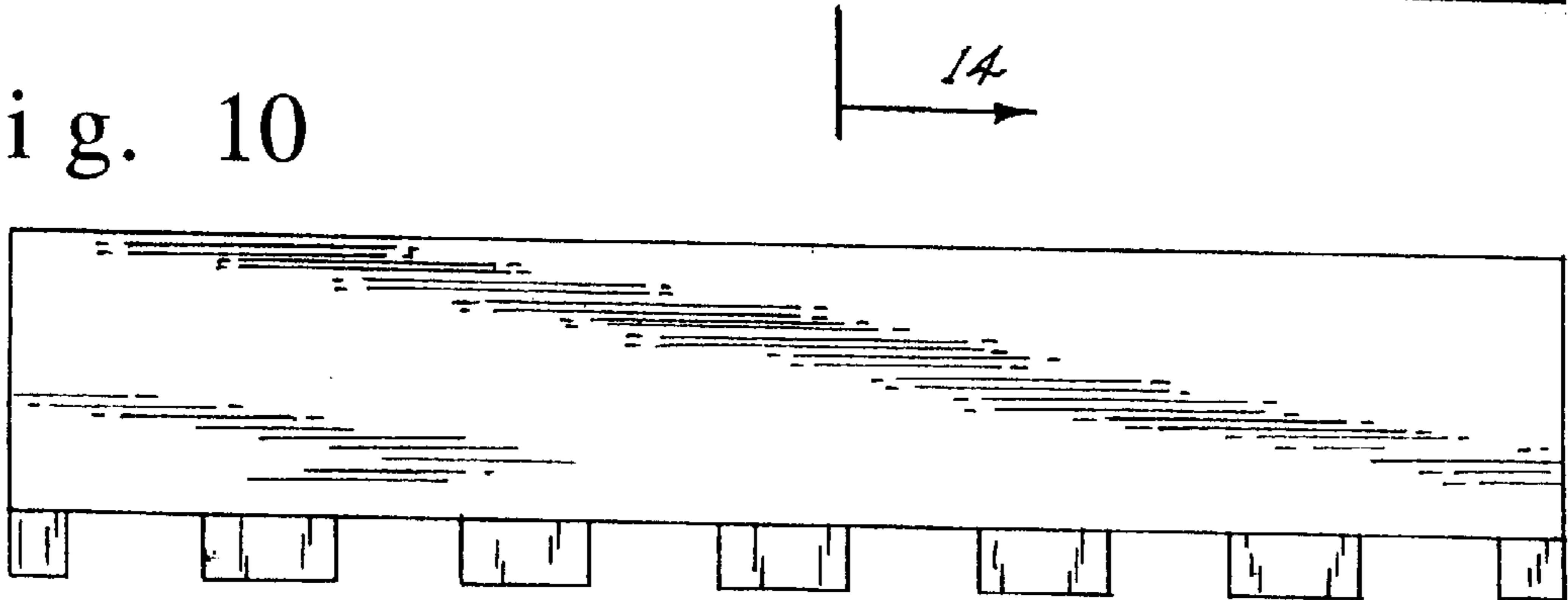

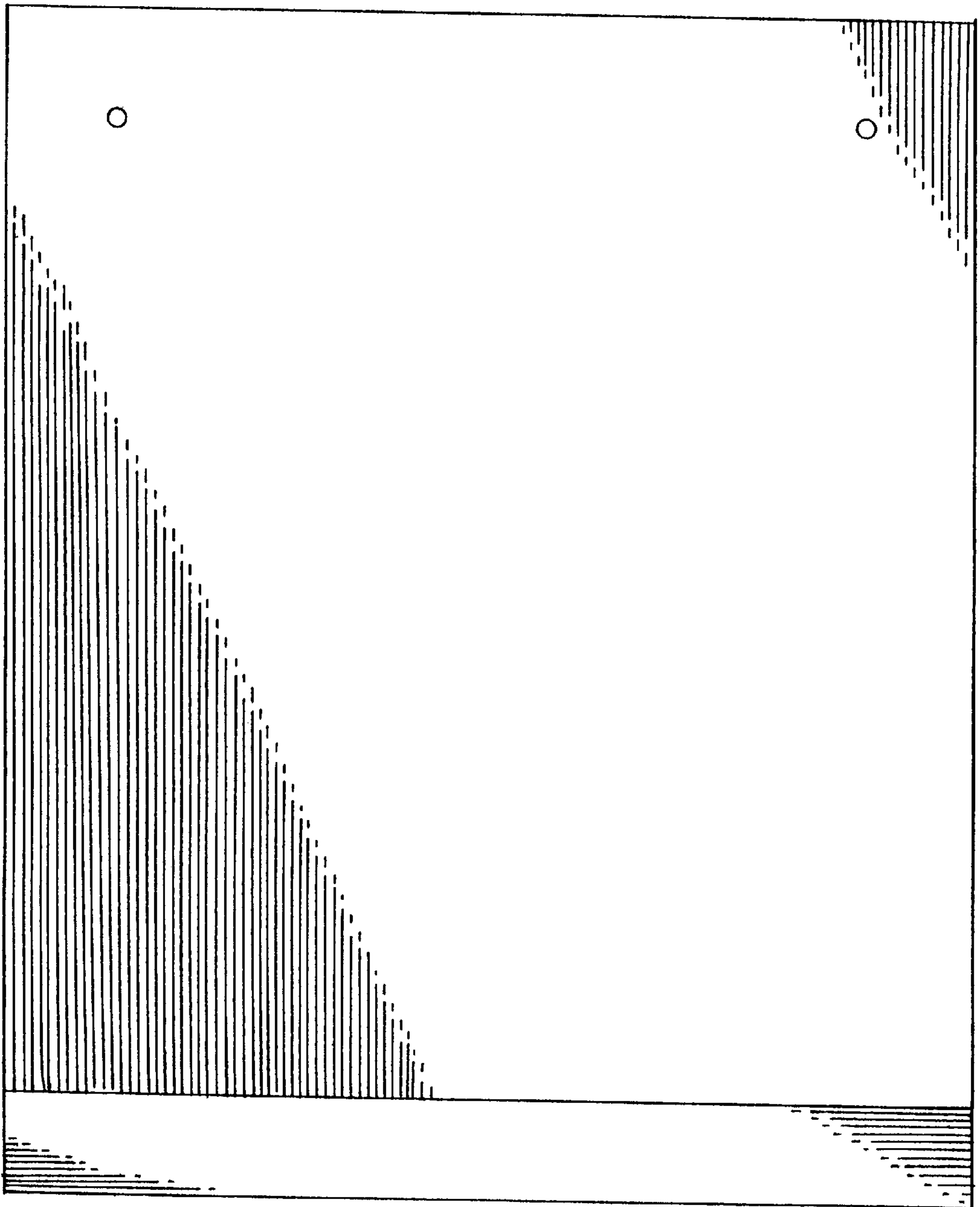

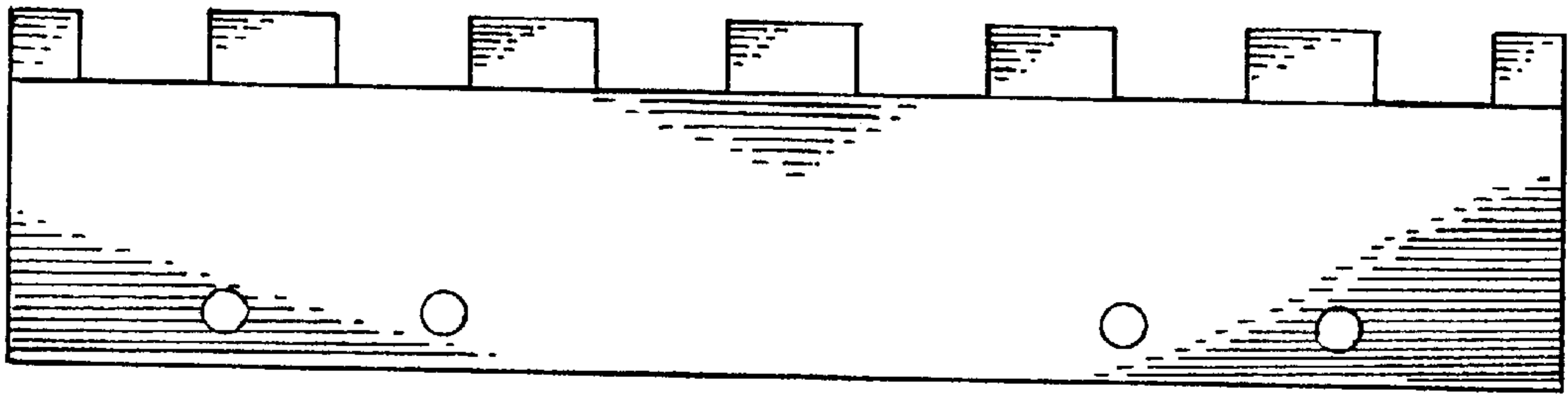
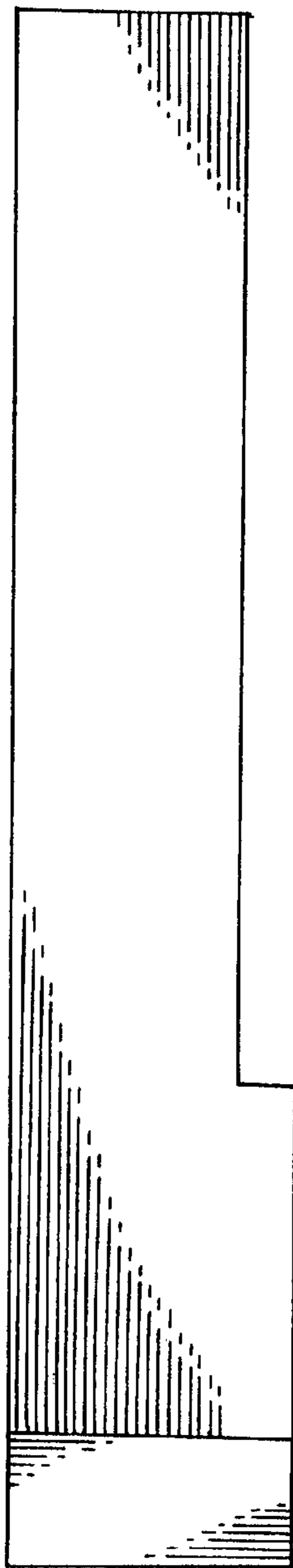

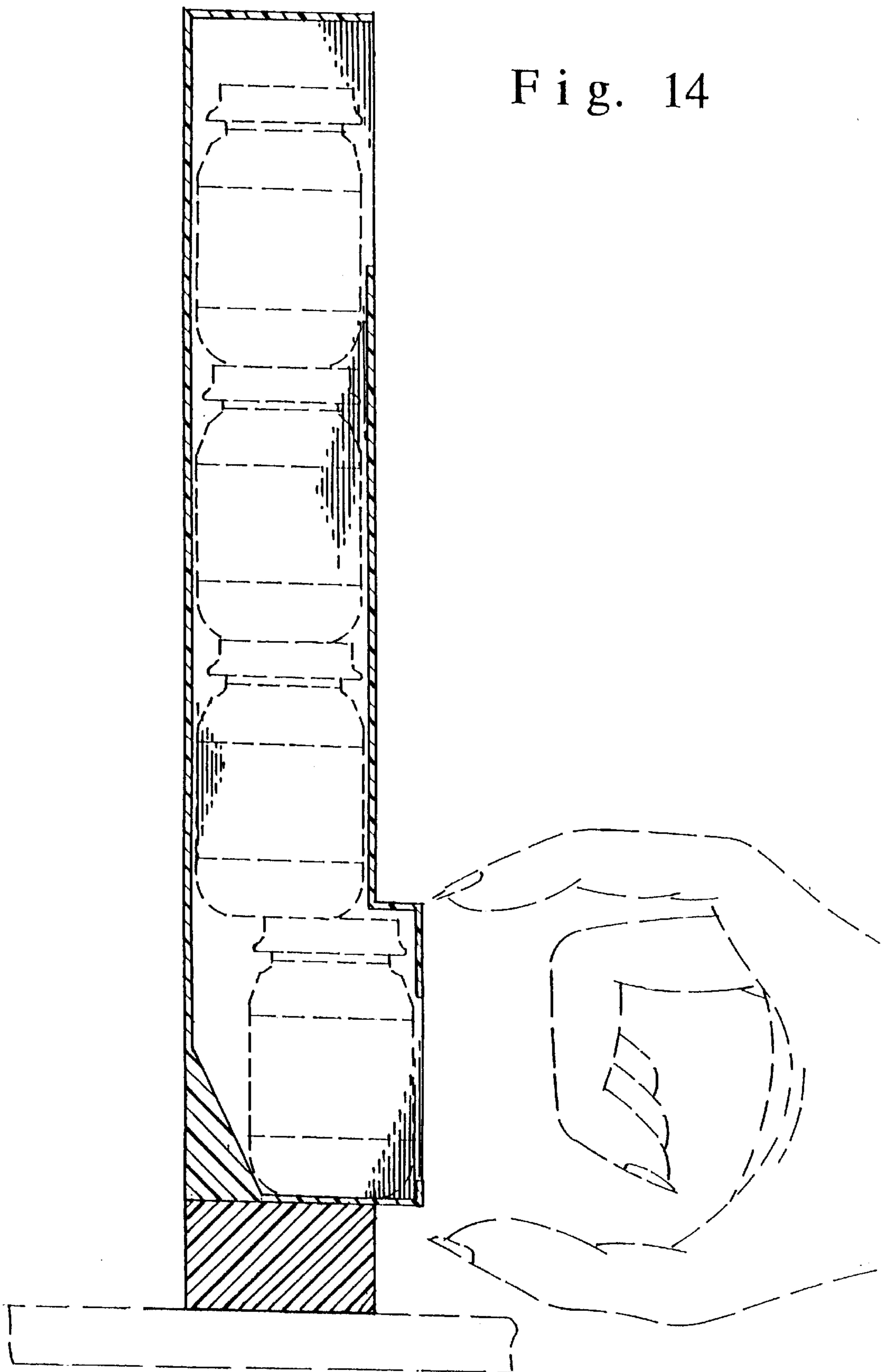
