The ornamental design for a “convertible hanging/carrying bag”, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a convertible hanging/carrying bag according to my invention, the broken lines shown are for illustrative purposes only and form no part of the claimed design;

FIG. 3 is a front elevational view thereof;

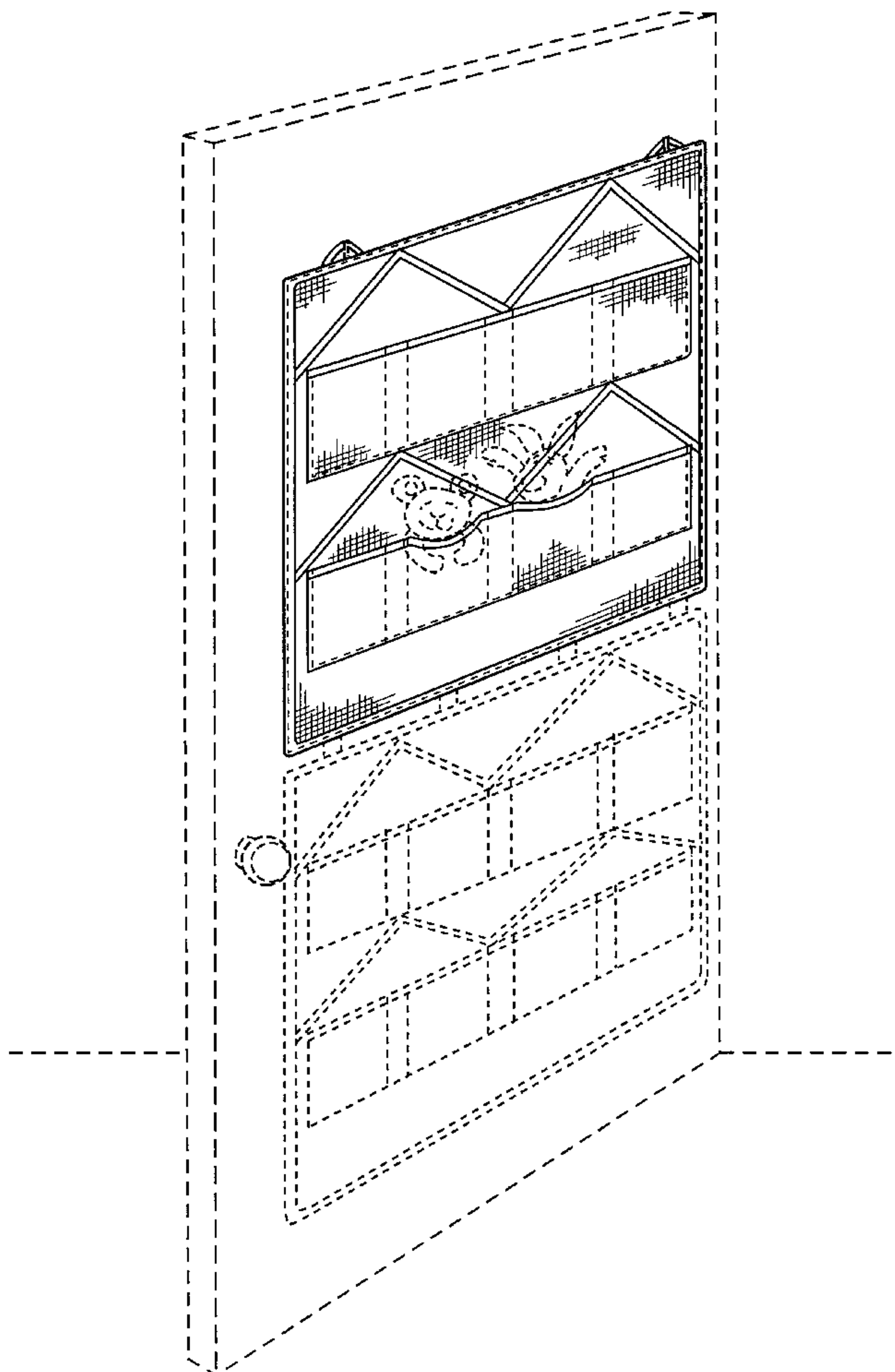
FIG. 4 is a right side elevational view thereof;

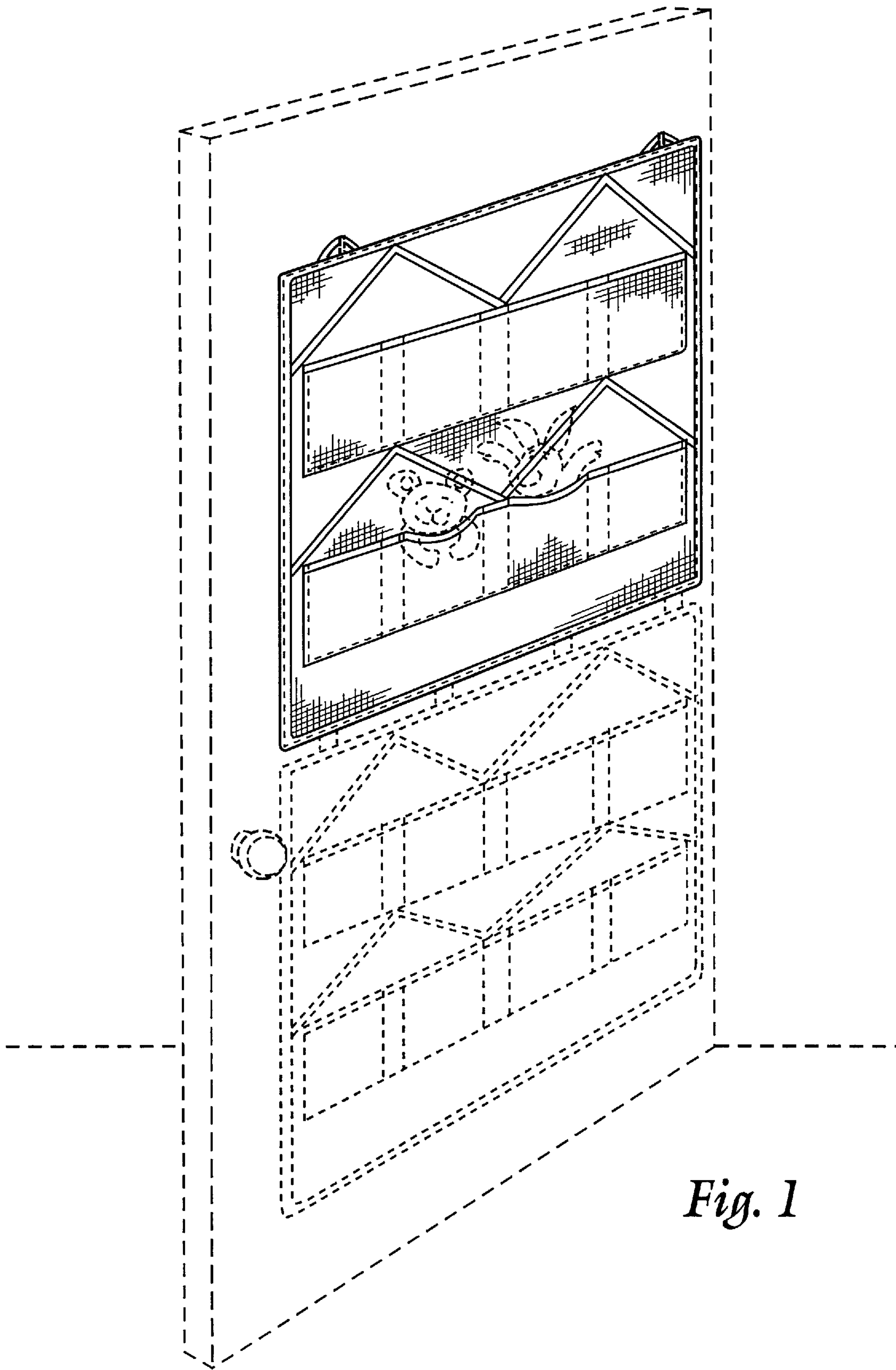

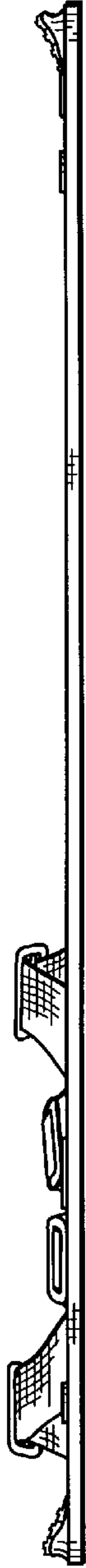

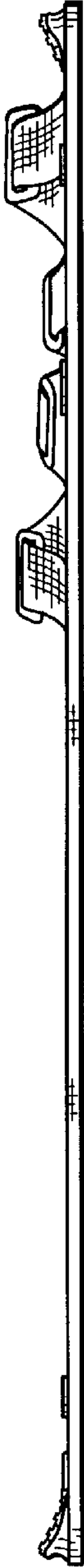

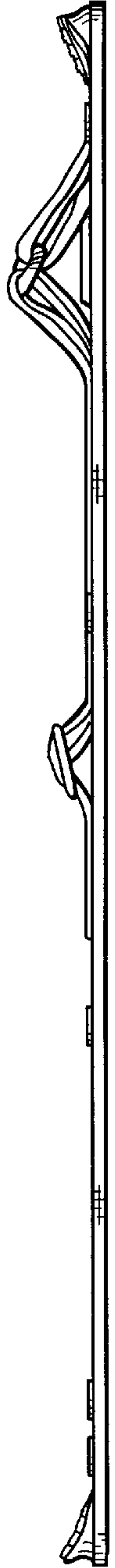

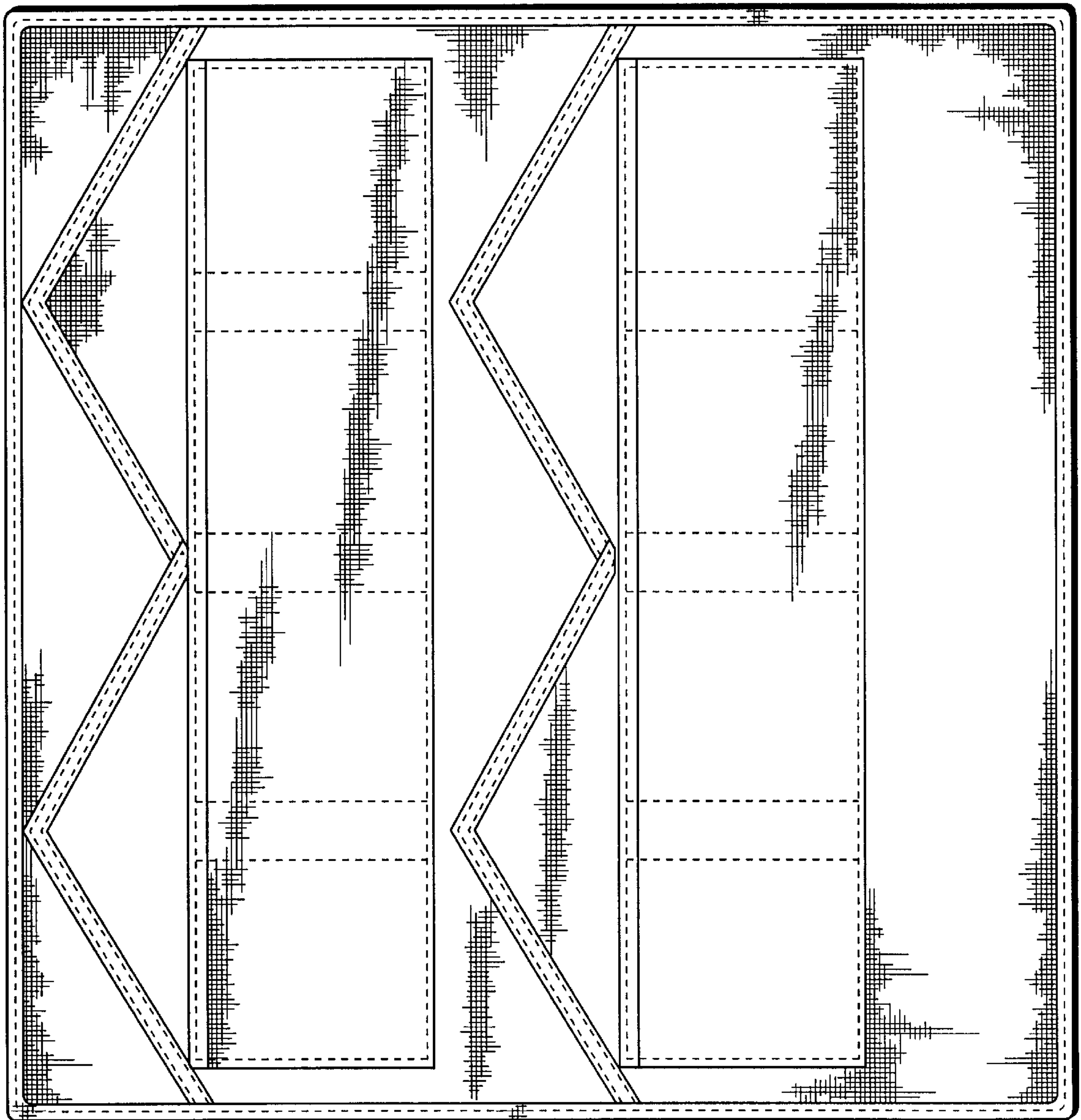
