DESCRIPTION

FIG. 1 is a top left front perspective view of a shell applique showing our new design;

FIG. 2 is a top plan view thereof; the bottom plan view being a mirror image;

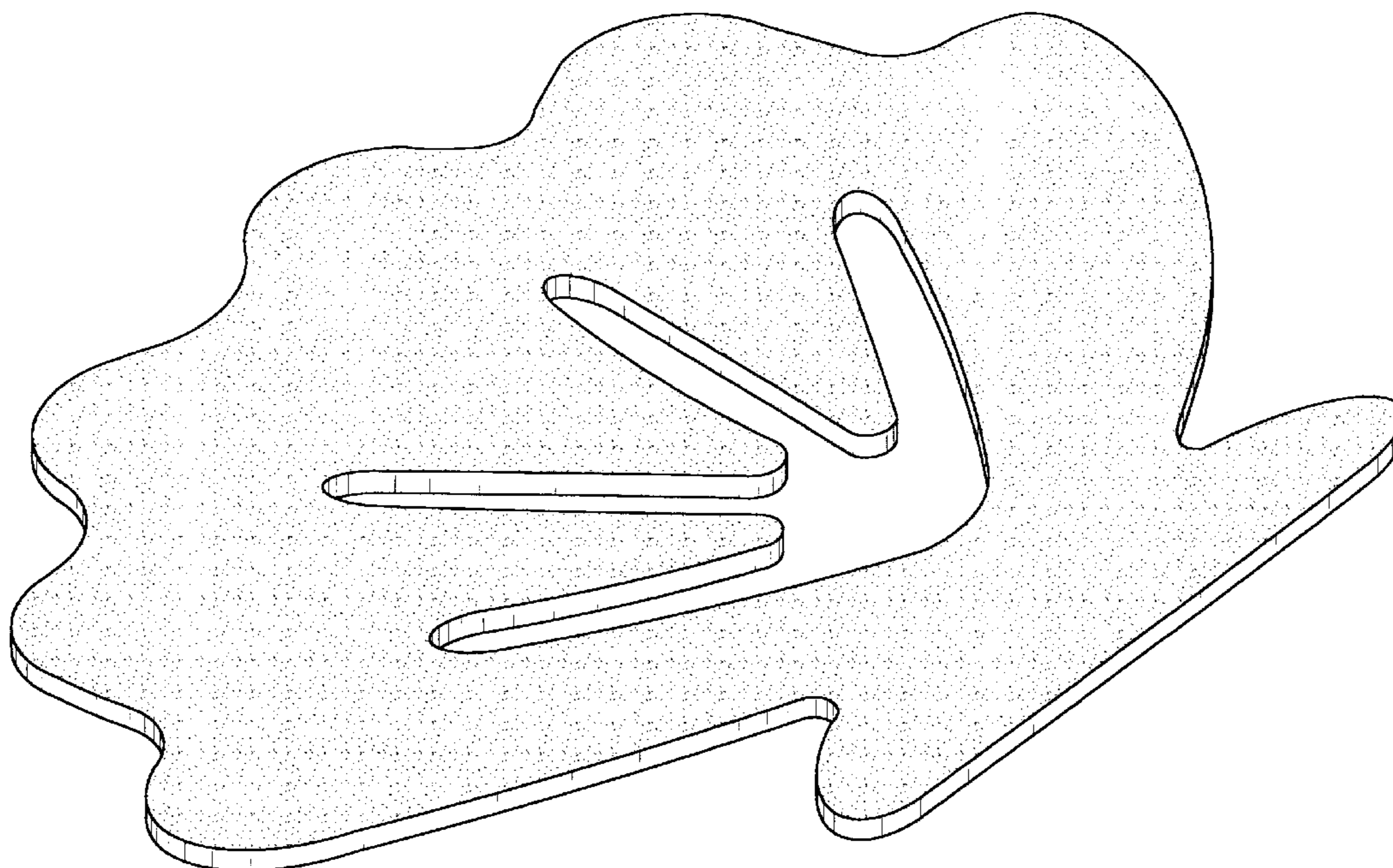
FIG. 3 is a front elevational view thereof;

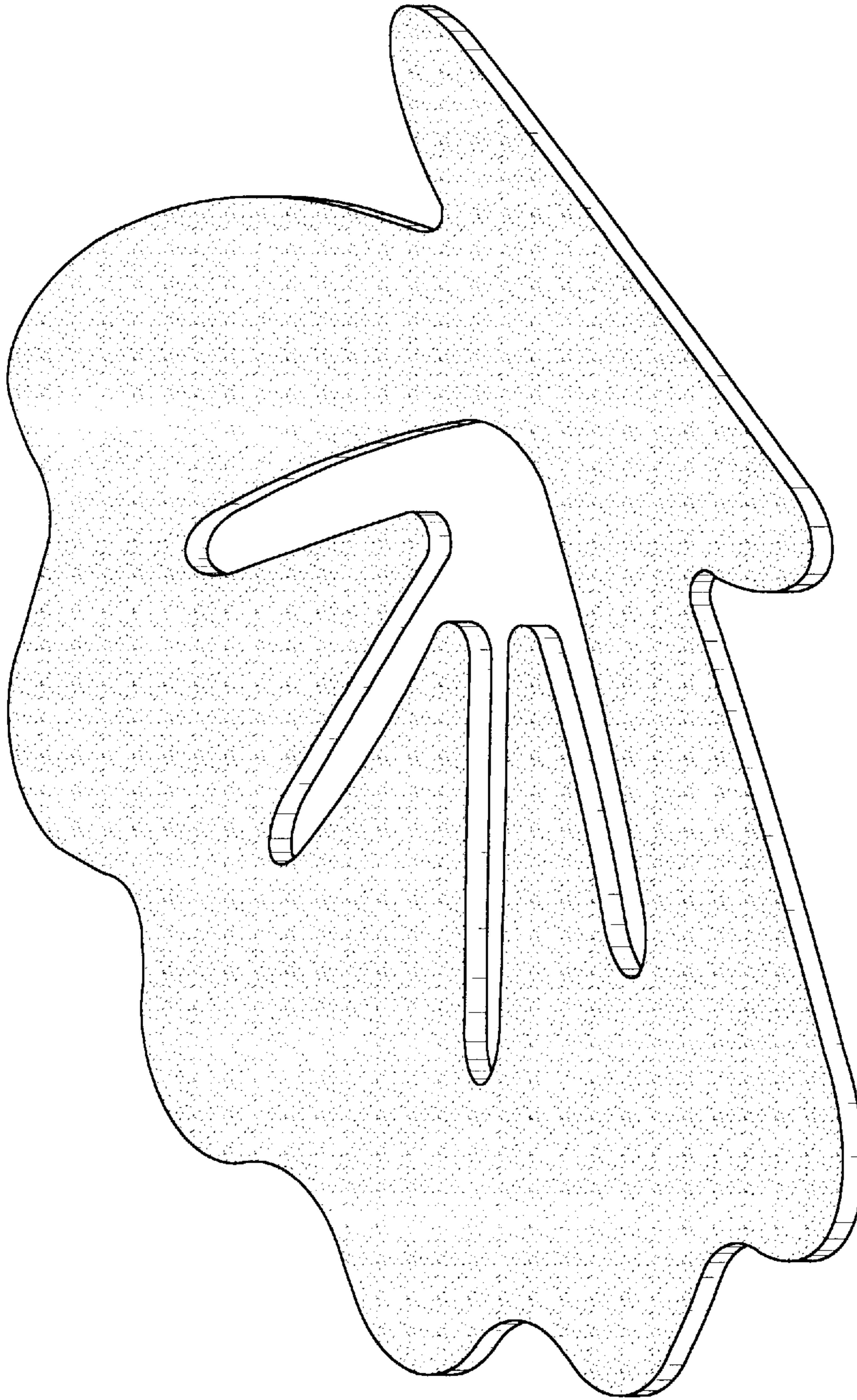

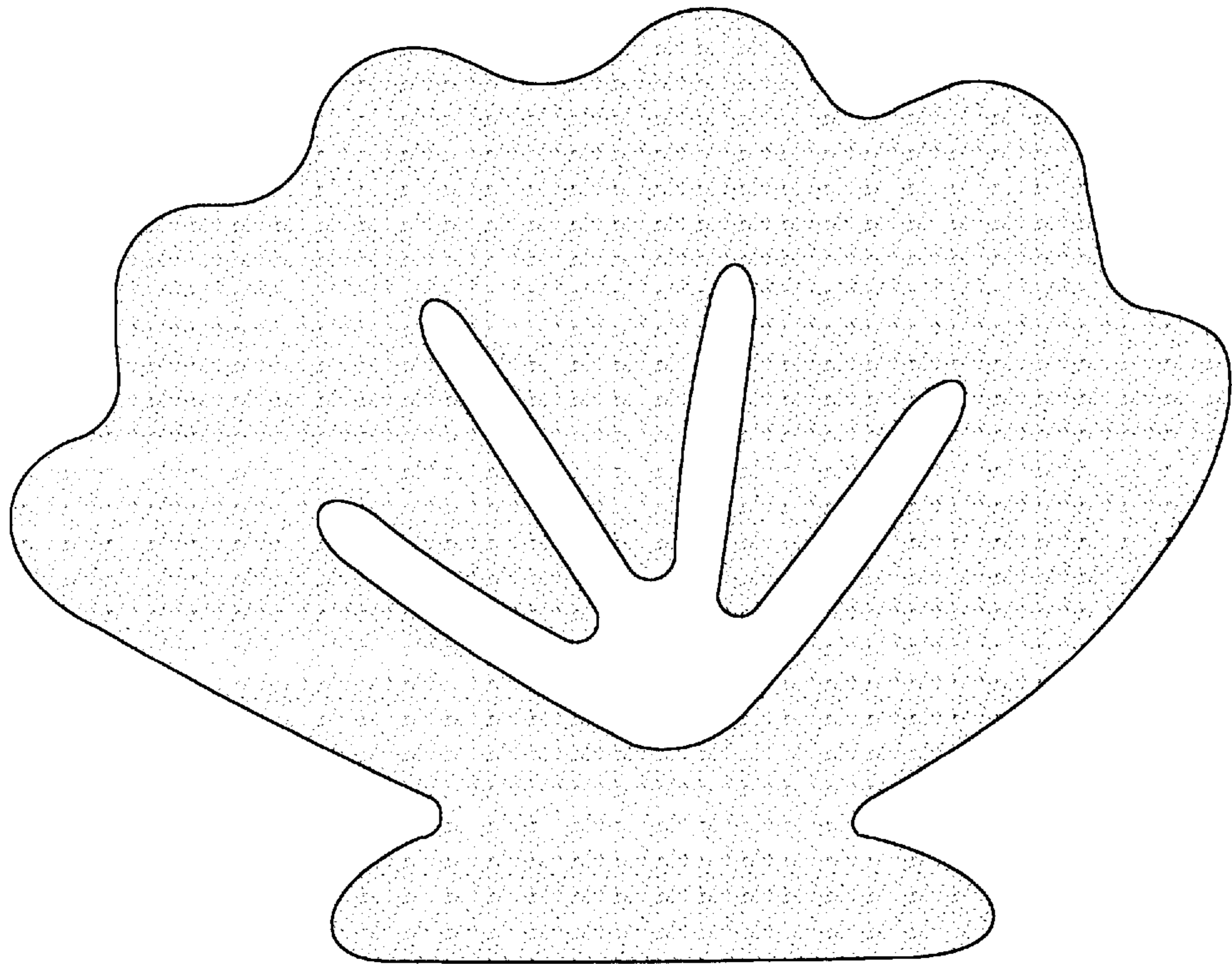

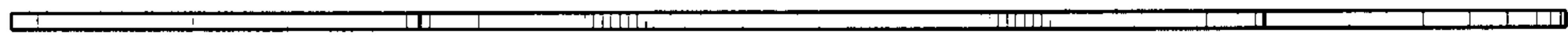

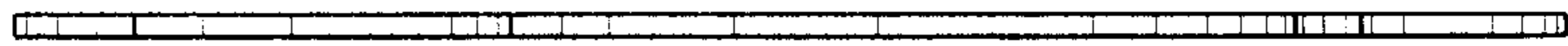

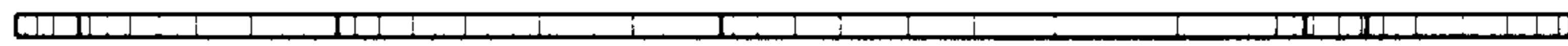
