[57] **CLAIM**

The ornamental design for a light bar housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a light bar housing incorporating our new design;

FIG. 2 is a front elevational view of the light bar housing of FIG. 1, of which the rear elevational view is a mirror image; FIG. 3 is a left elevational view of the light bar housing of FIG. 1, of which the right elevational view is a mirror image; FIG. 4 is a top plan view of the light bar housing of FIG. 1; FIG. 5 is a bottom plan view of the light bar housing of FIG. 1;

FIG. 6 is a bottom perspective view of the light bar housing of FIG. 1;

FIG. 7 is a perspective view of an alternative embodiment of the light bar housing incorporating our new design;

FIG. 8 is a front elevational view of the light bar housing of FIG. 7, of which the rear elevational view is a mirror image;

FIG. 9 is a left elevational view of the light bar housing of FIG. 7, of which the right elevational view is a mirror image;

FIG. 10 is a top plan view of the light bar housing of FIG. 7;

FIG. 11 is a bottom plan view of the light bar housing of FIG. 7;

FIG. 12 is a bottom perspective view of the light bar housing of FIG. 7;

FIG. 13 is a perspective view of another alternative embodiment of the light bar housing incorporating our new design;

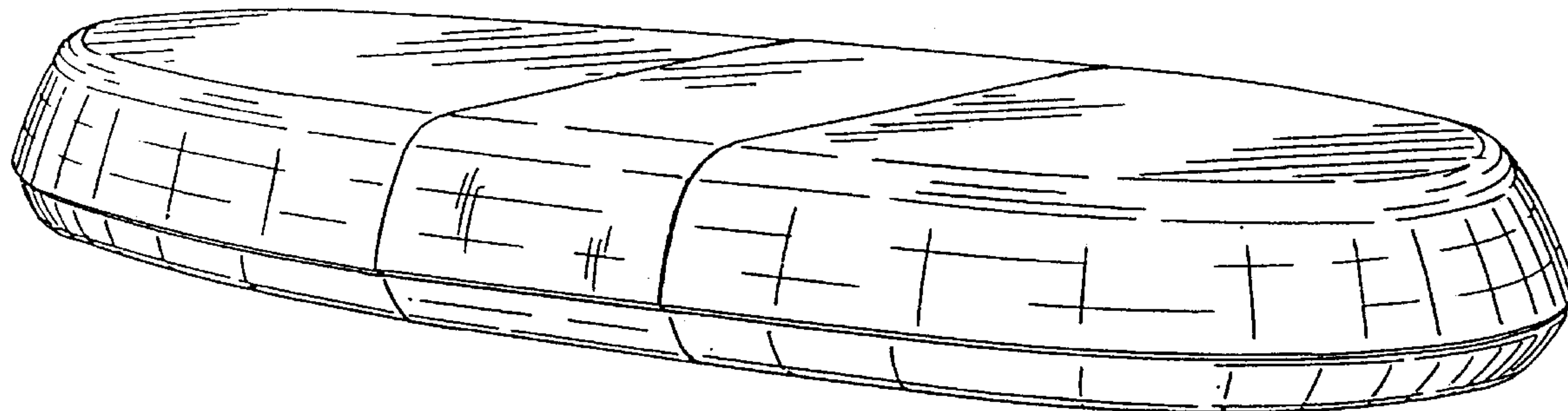
FIG. 14 is a front elevational view of the light bar housing of FIG. 13, of which the rear elevational view is a mirror image;

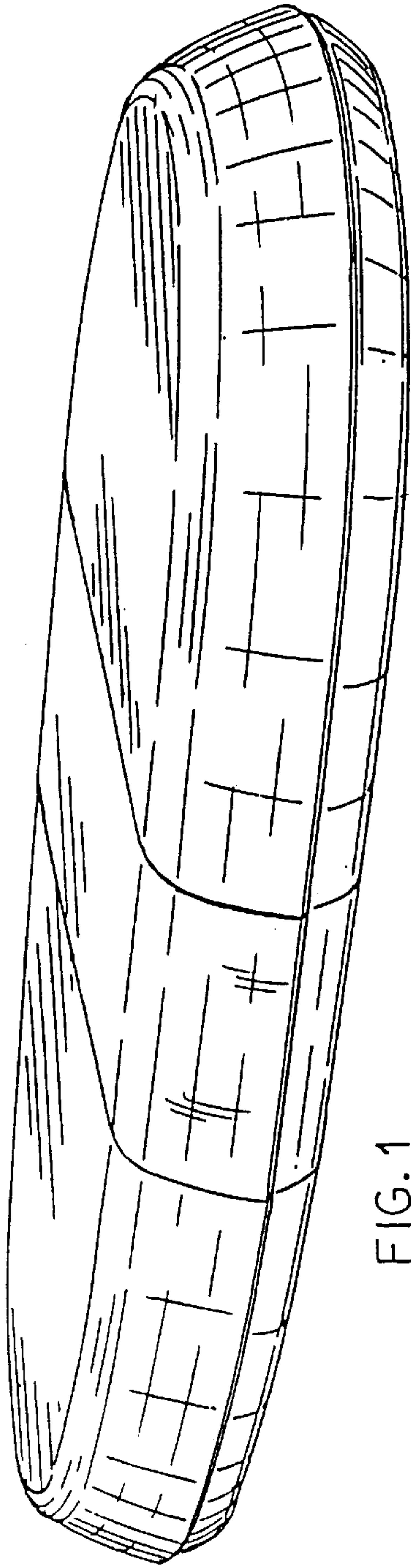

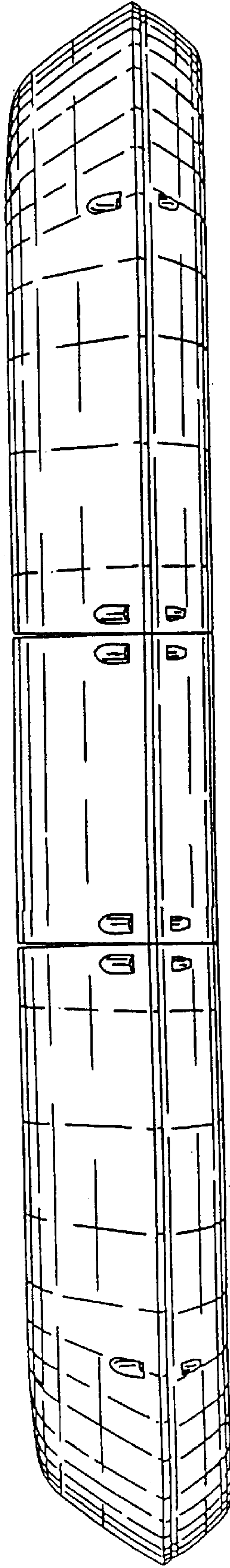

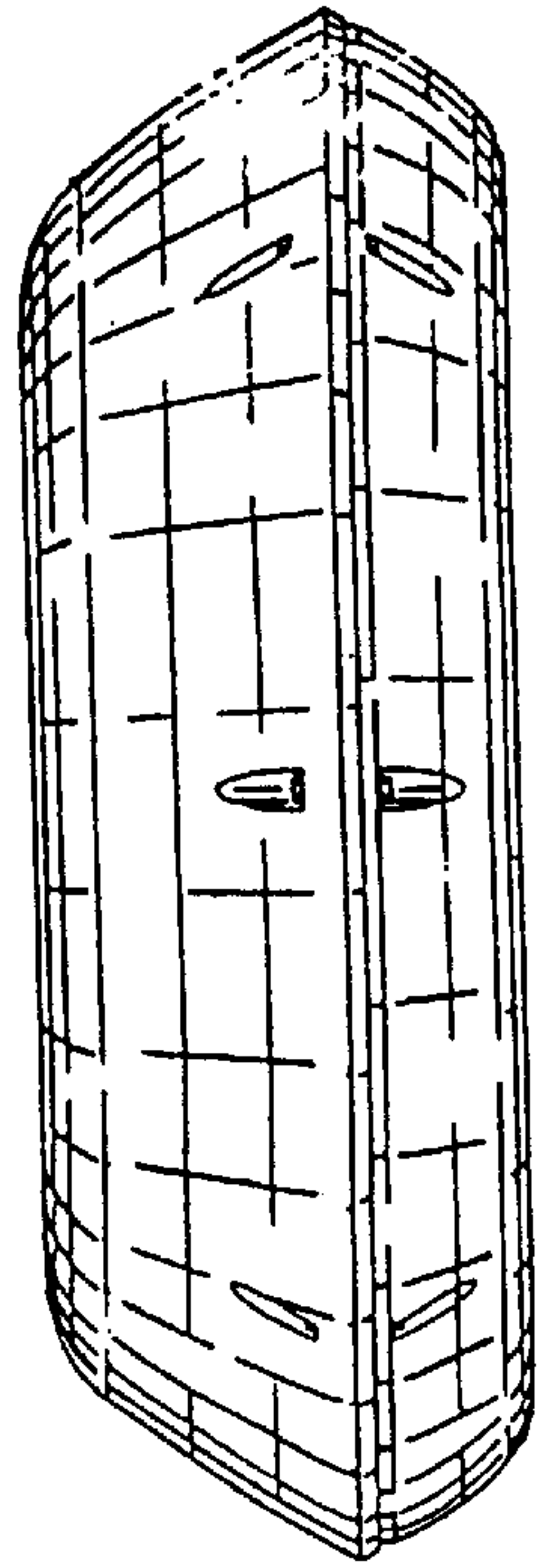

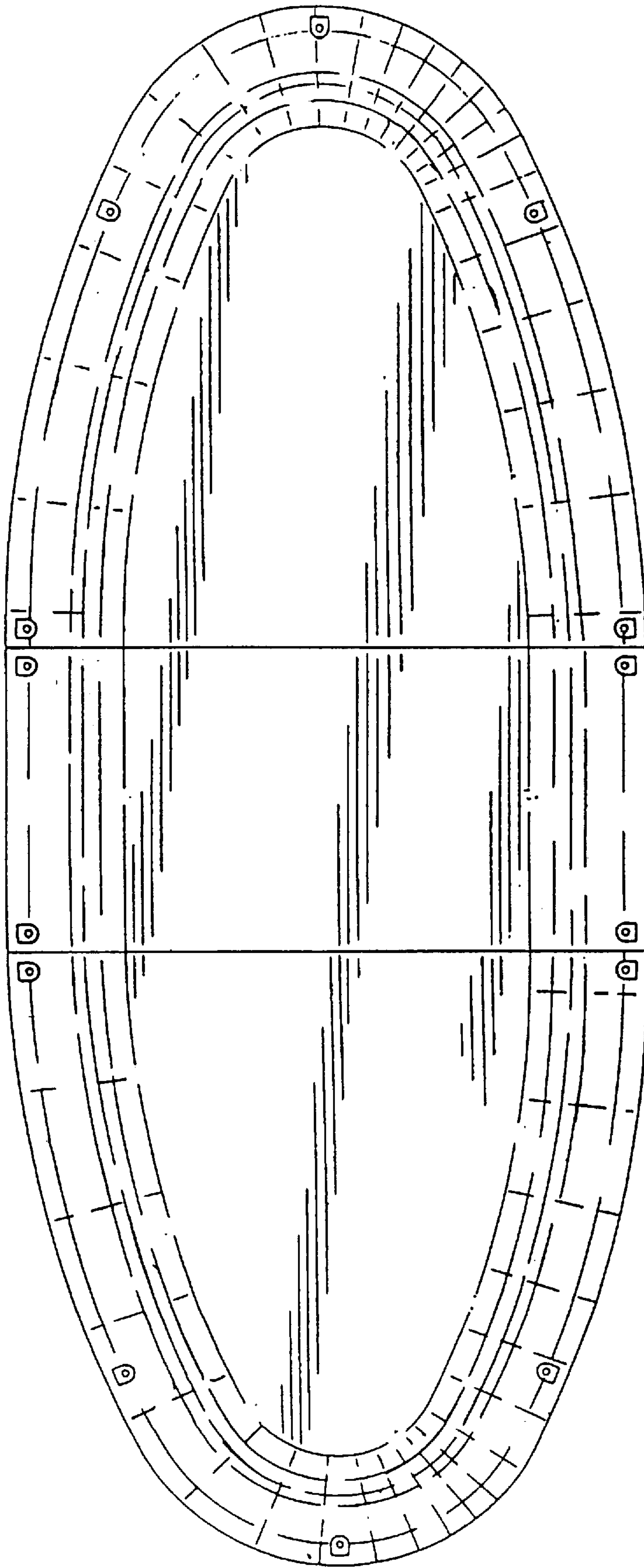

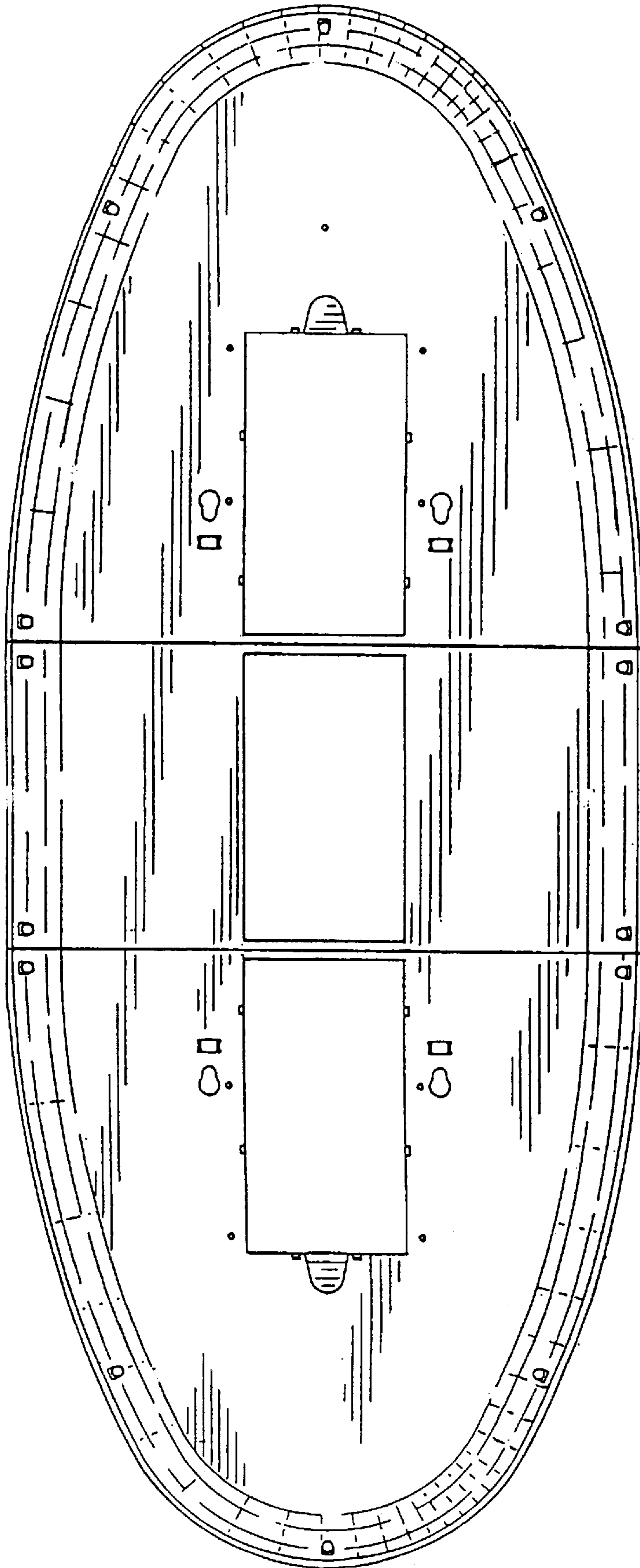

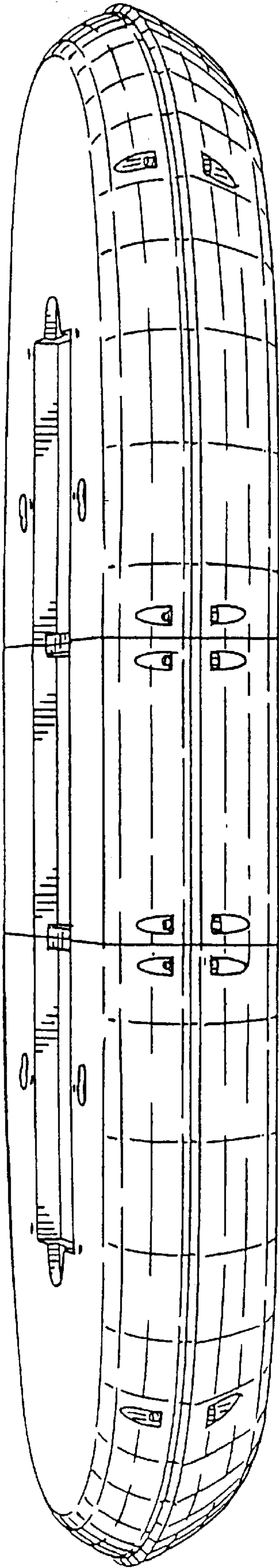

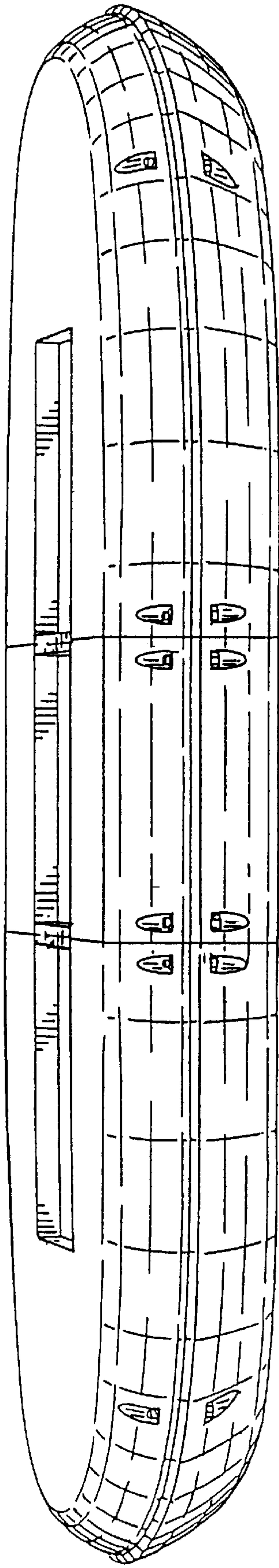

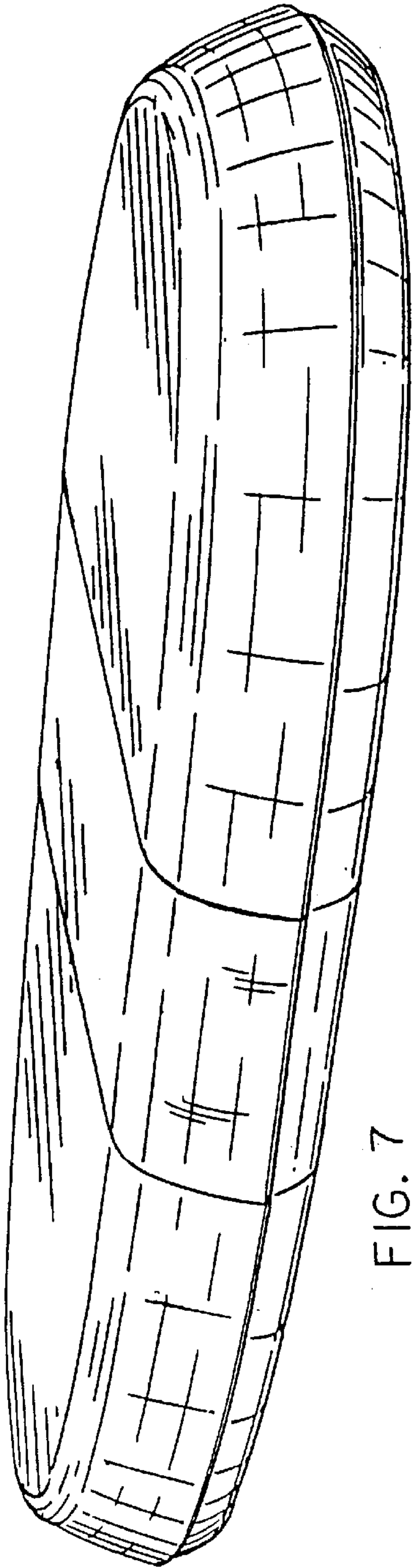

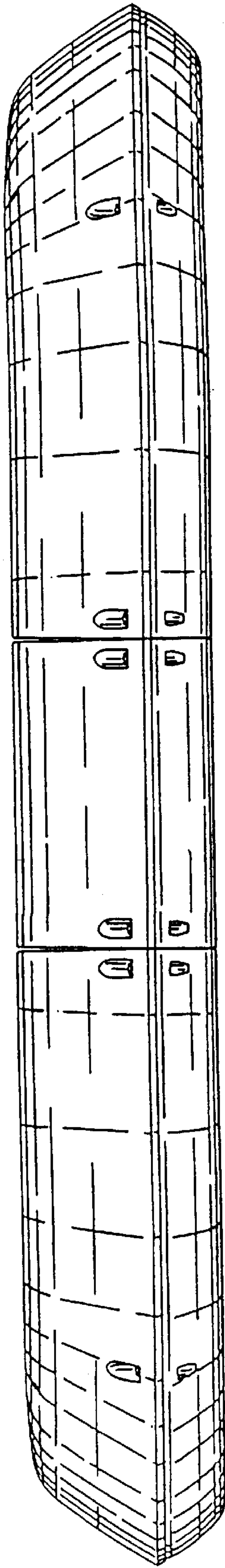

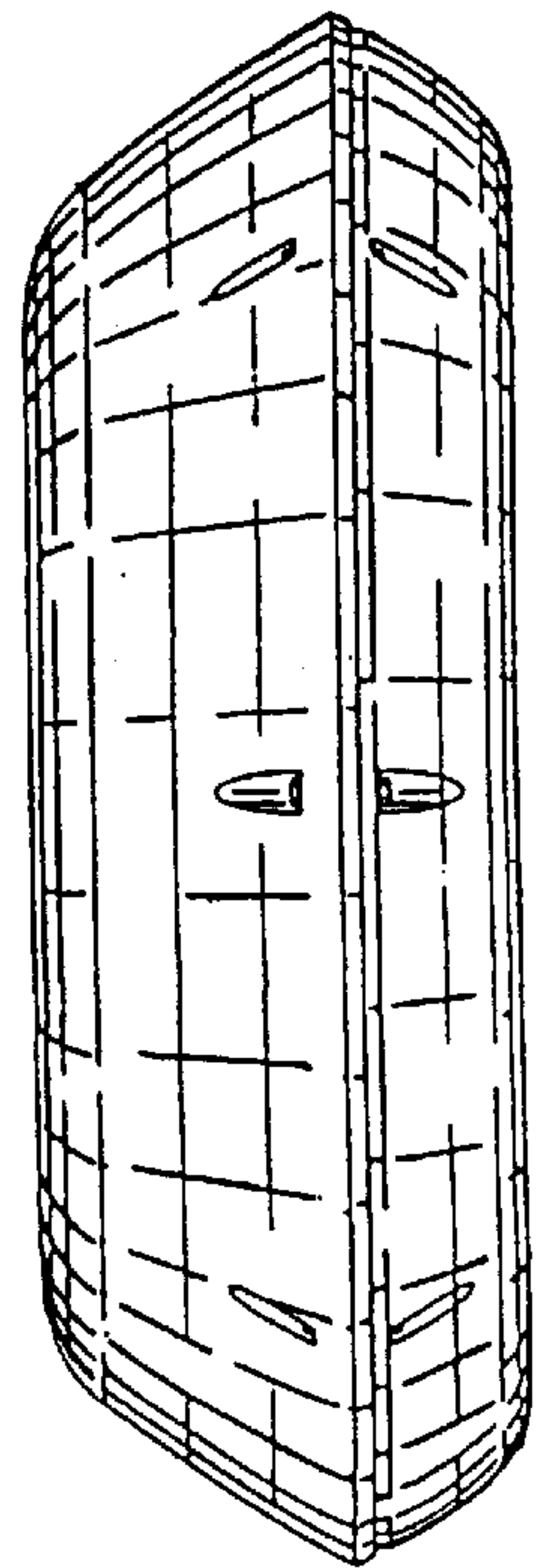

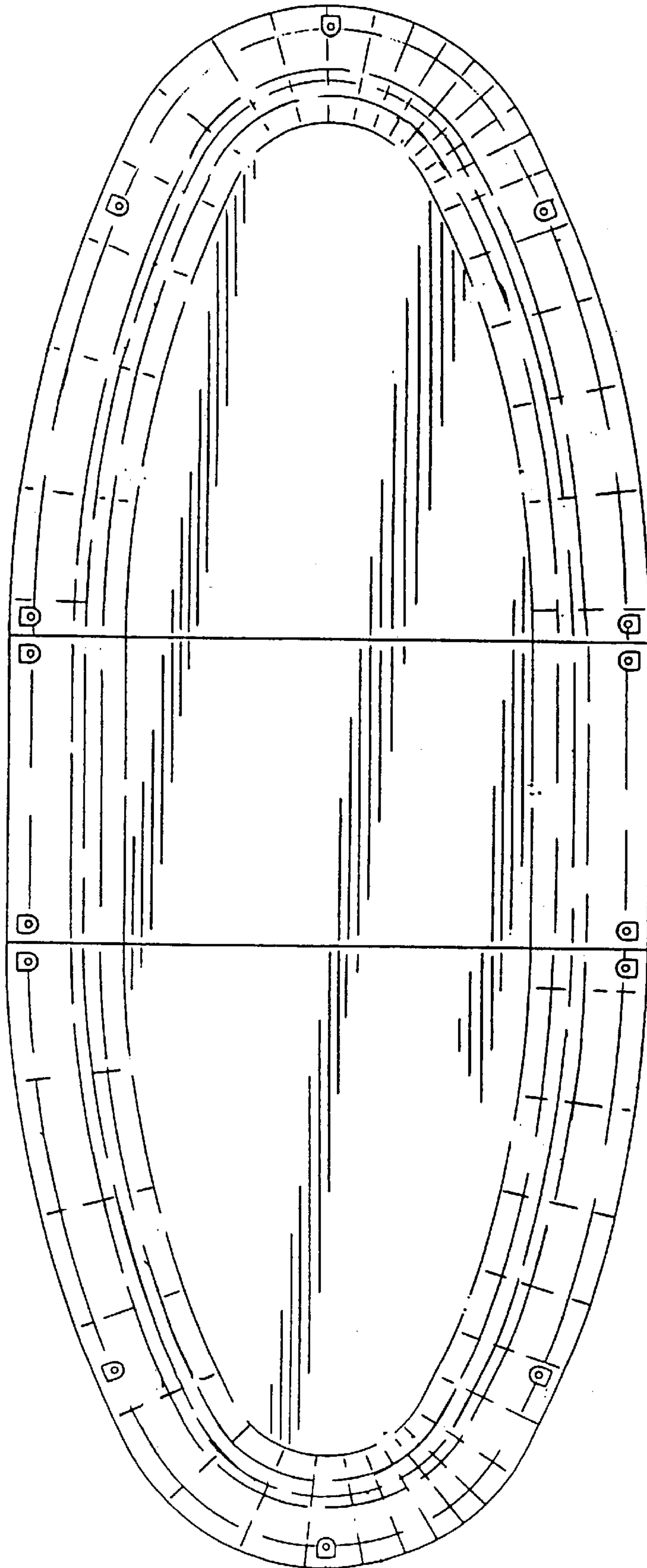

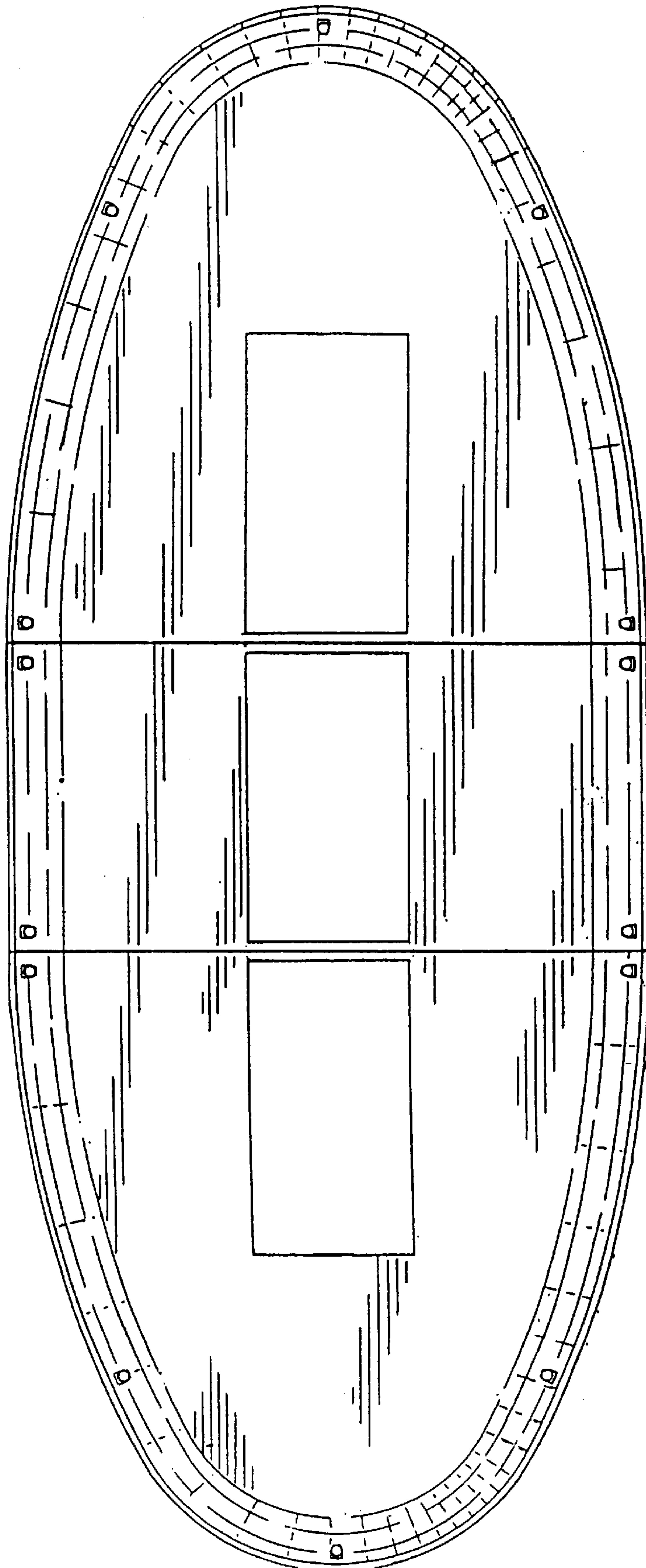

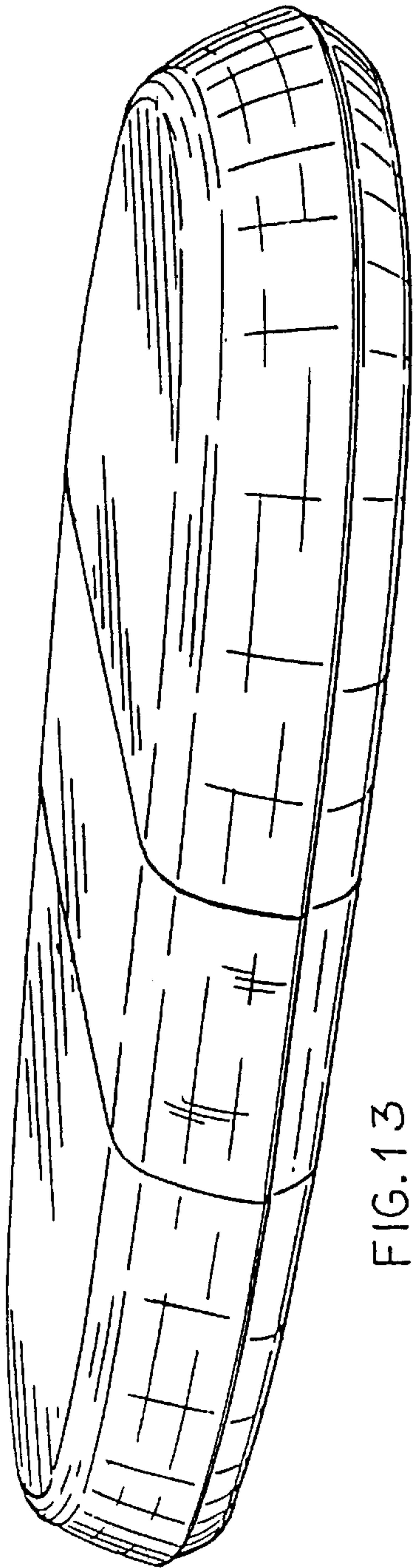

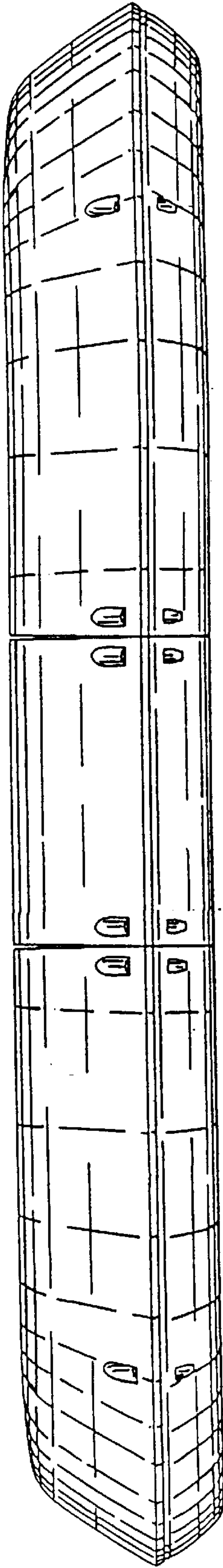

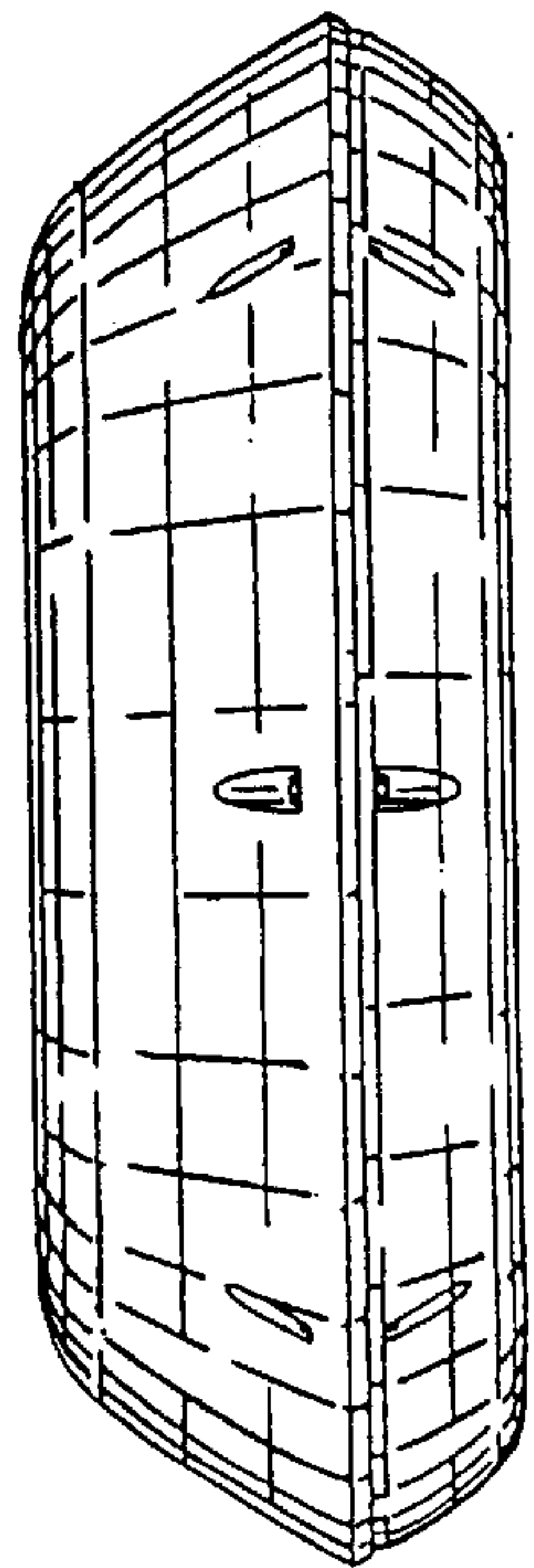

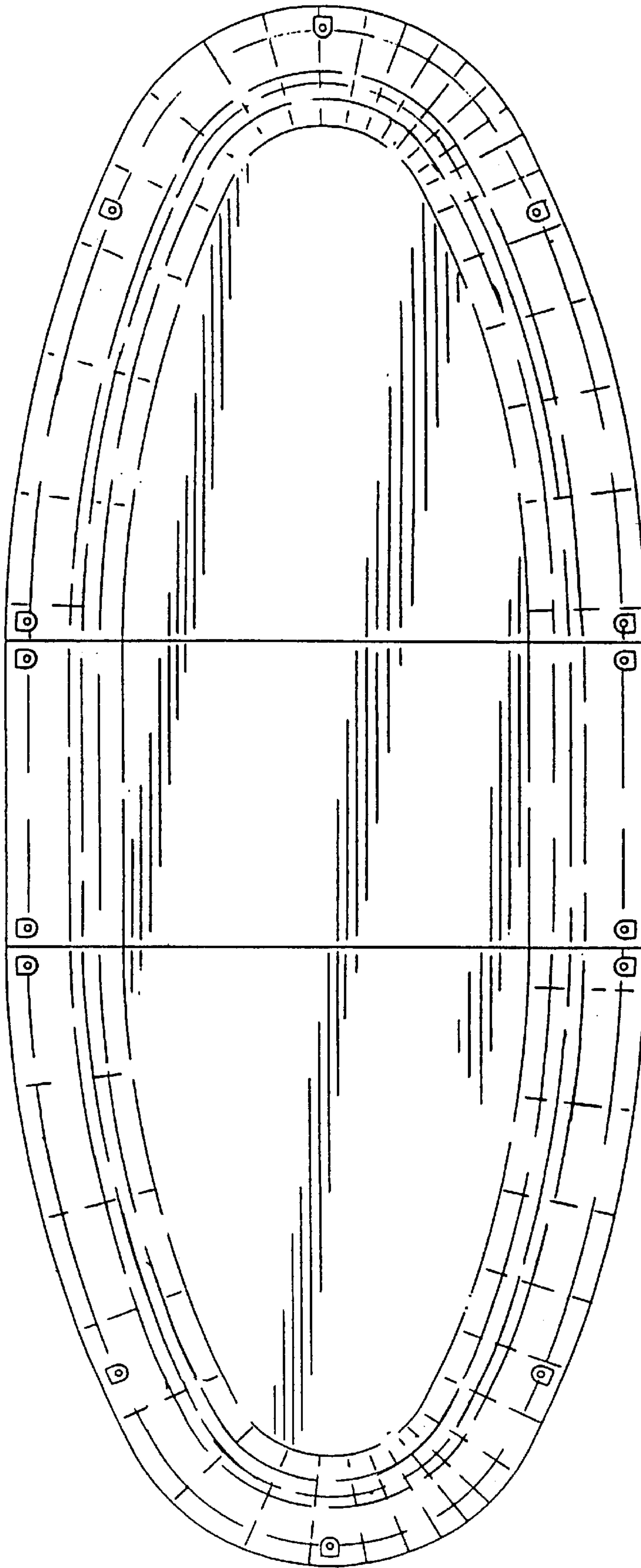

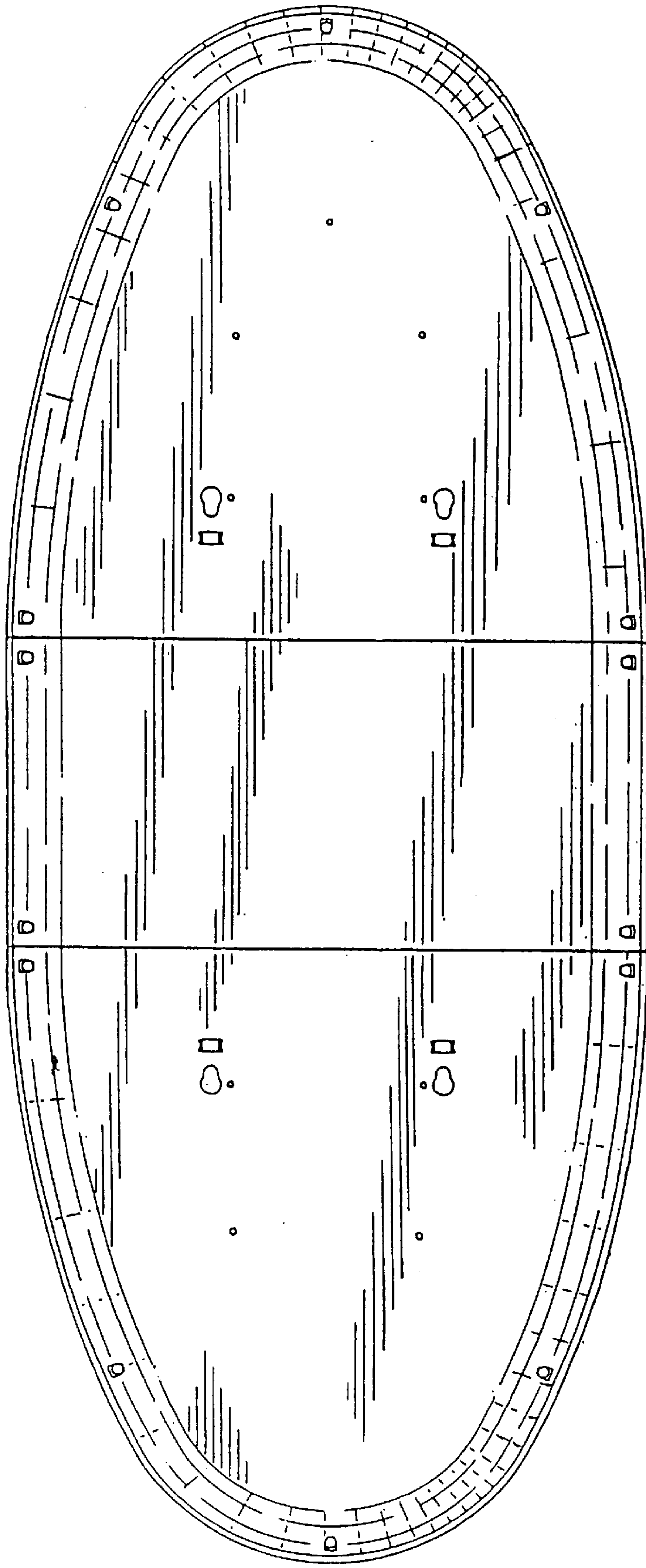
