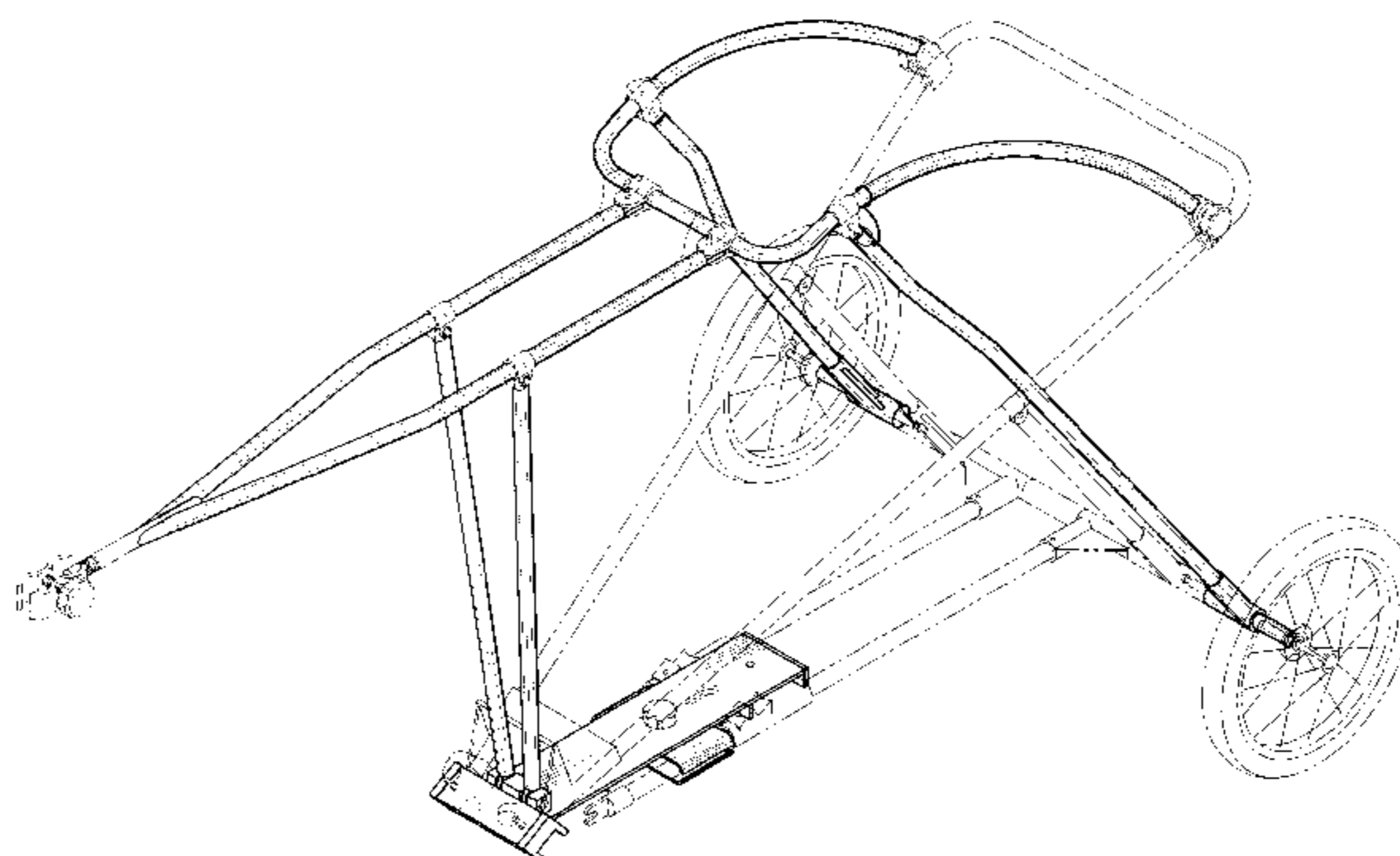
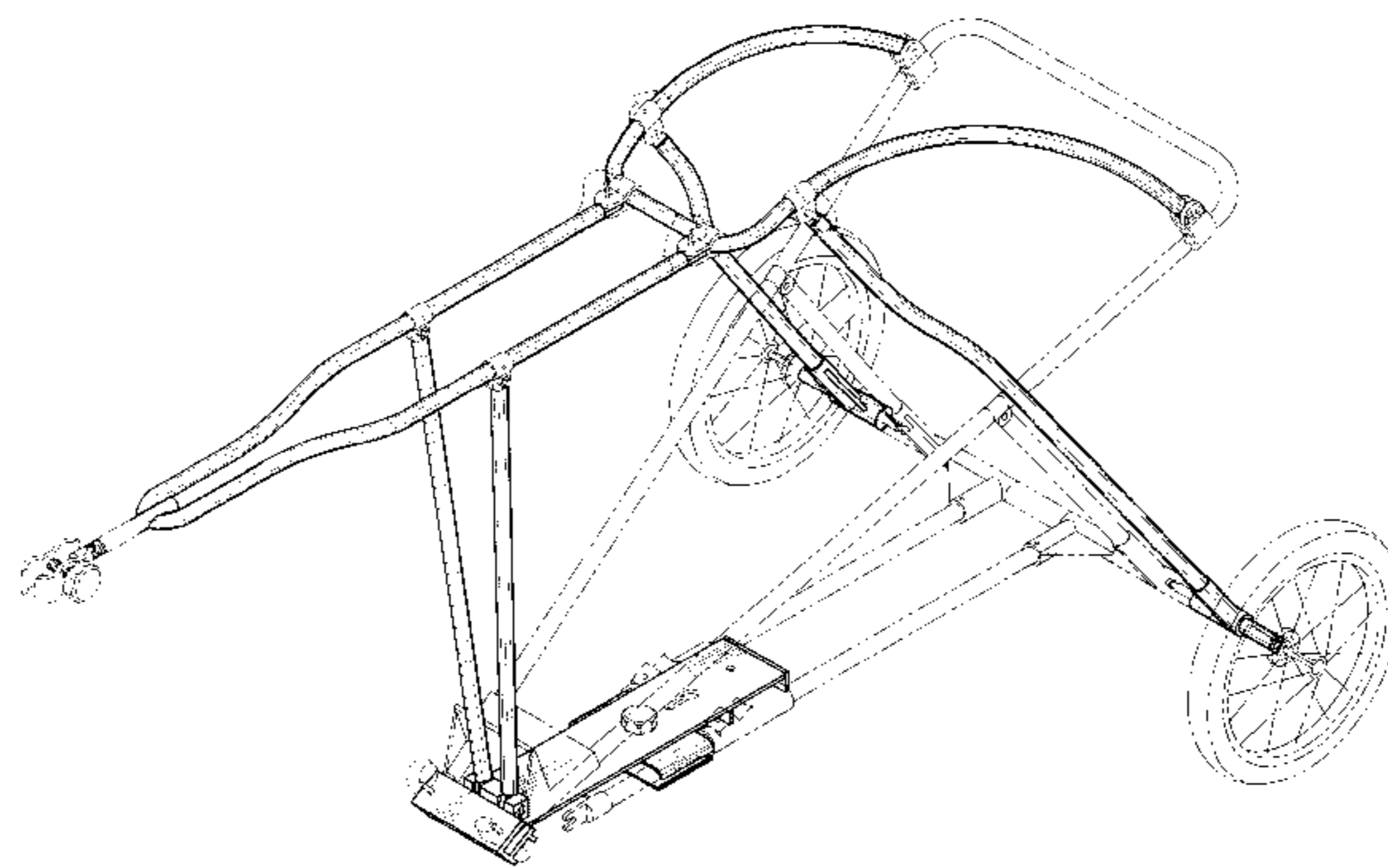
FIG. 10 is a bottom-plan view of FIG. 7;

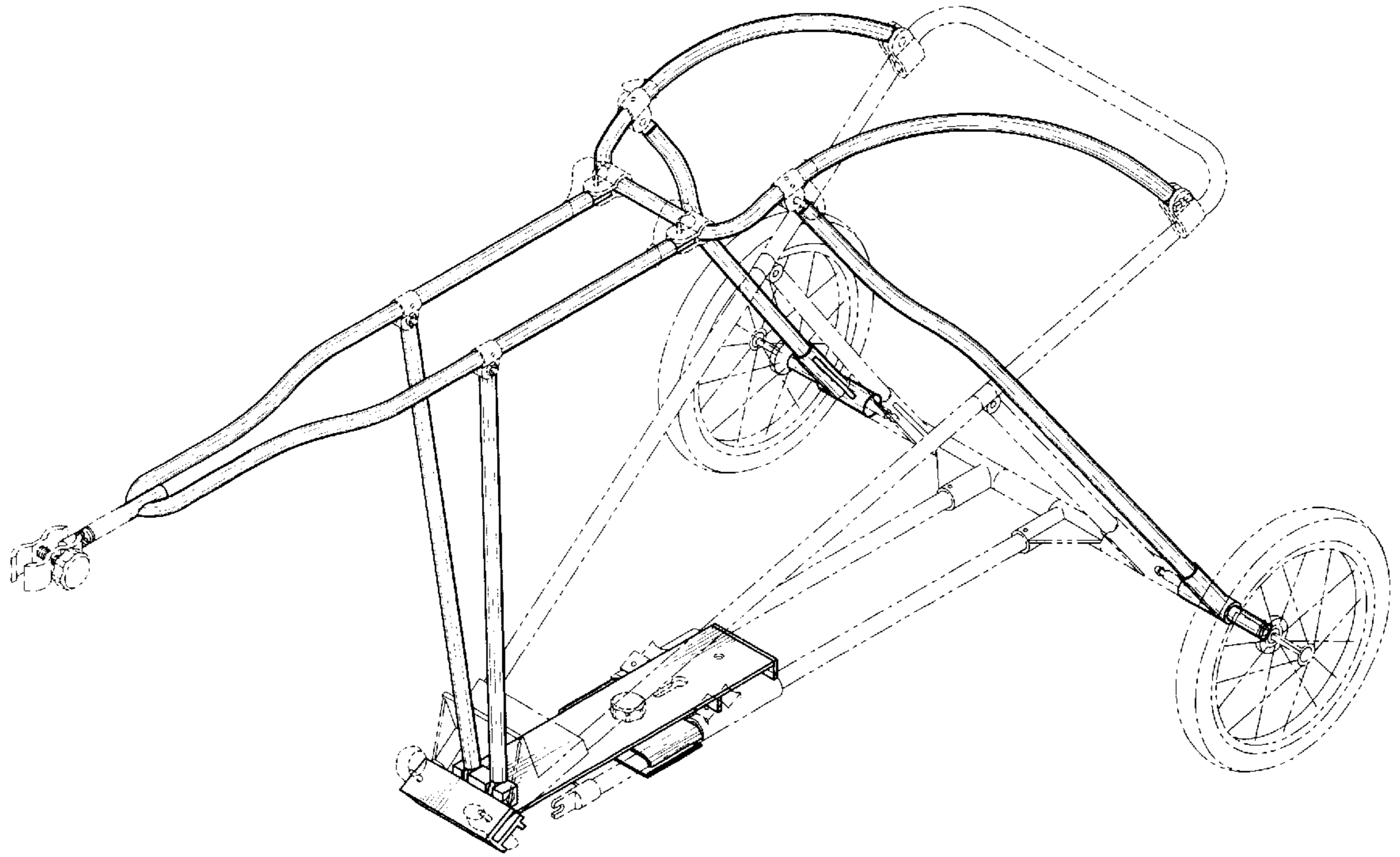

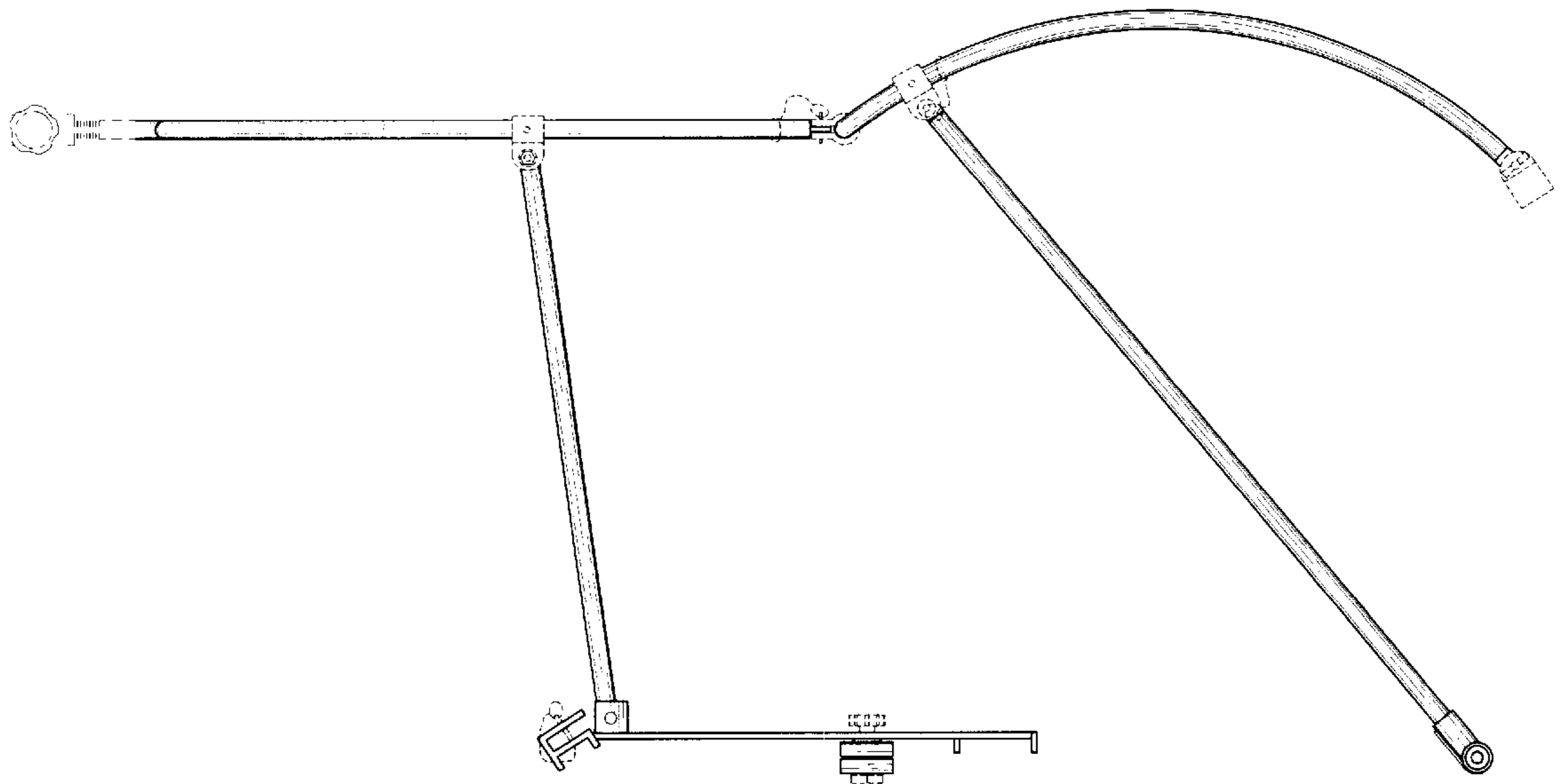

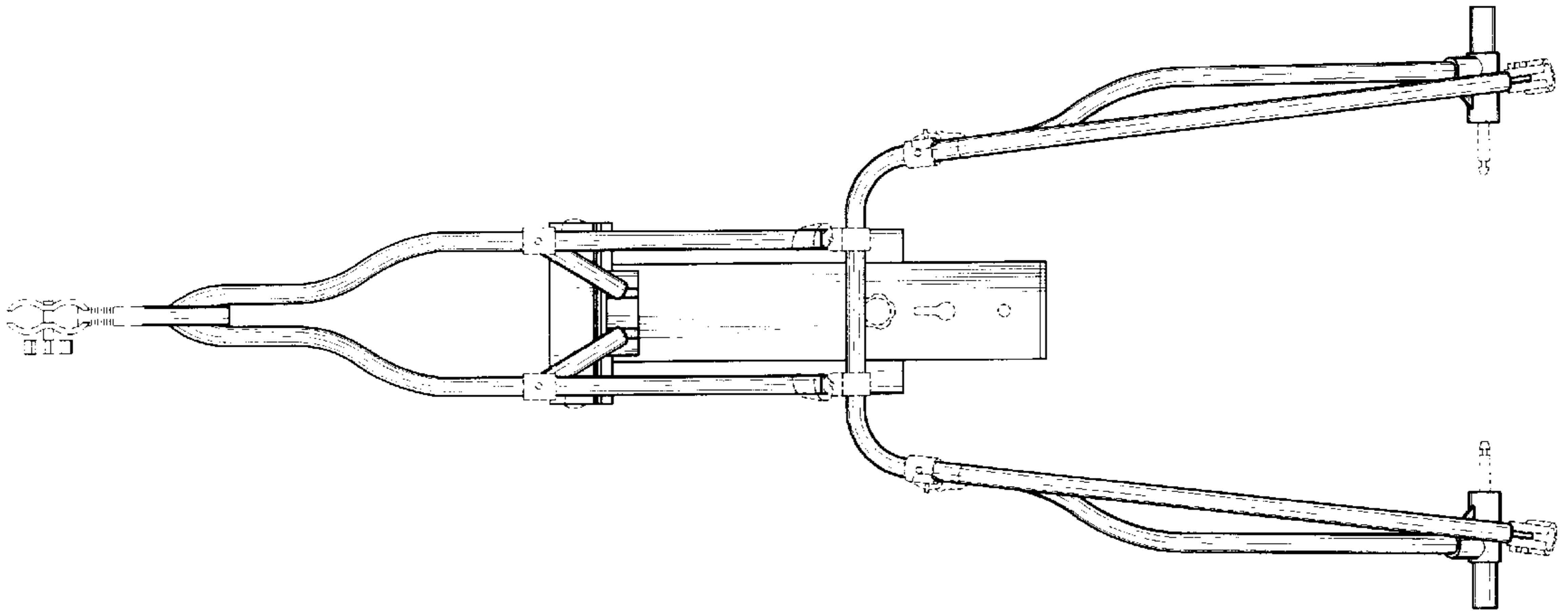

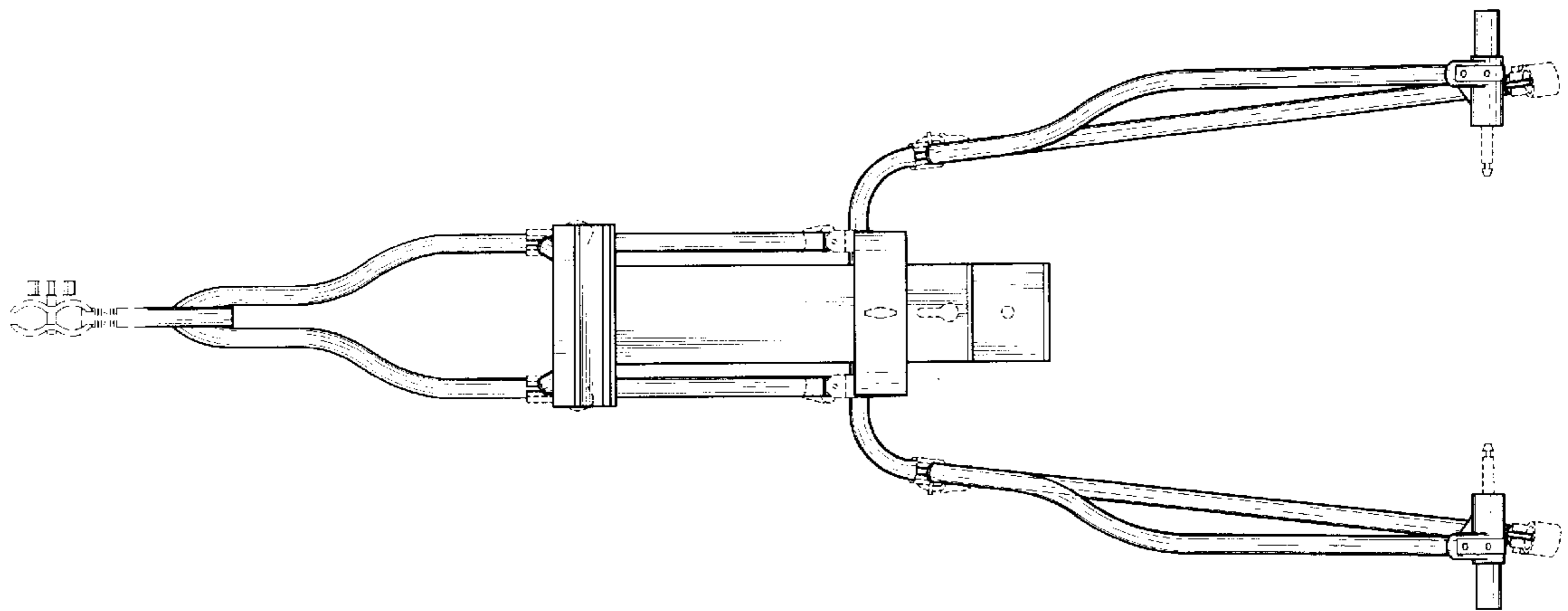

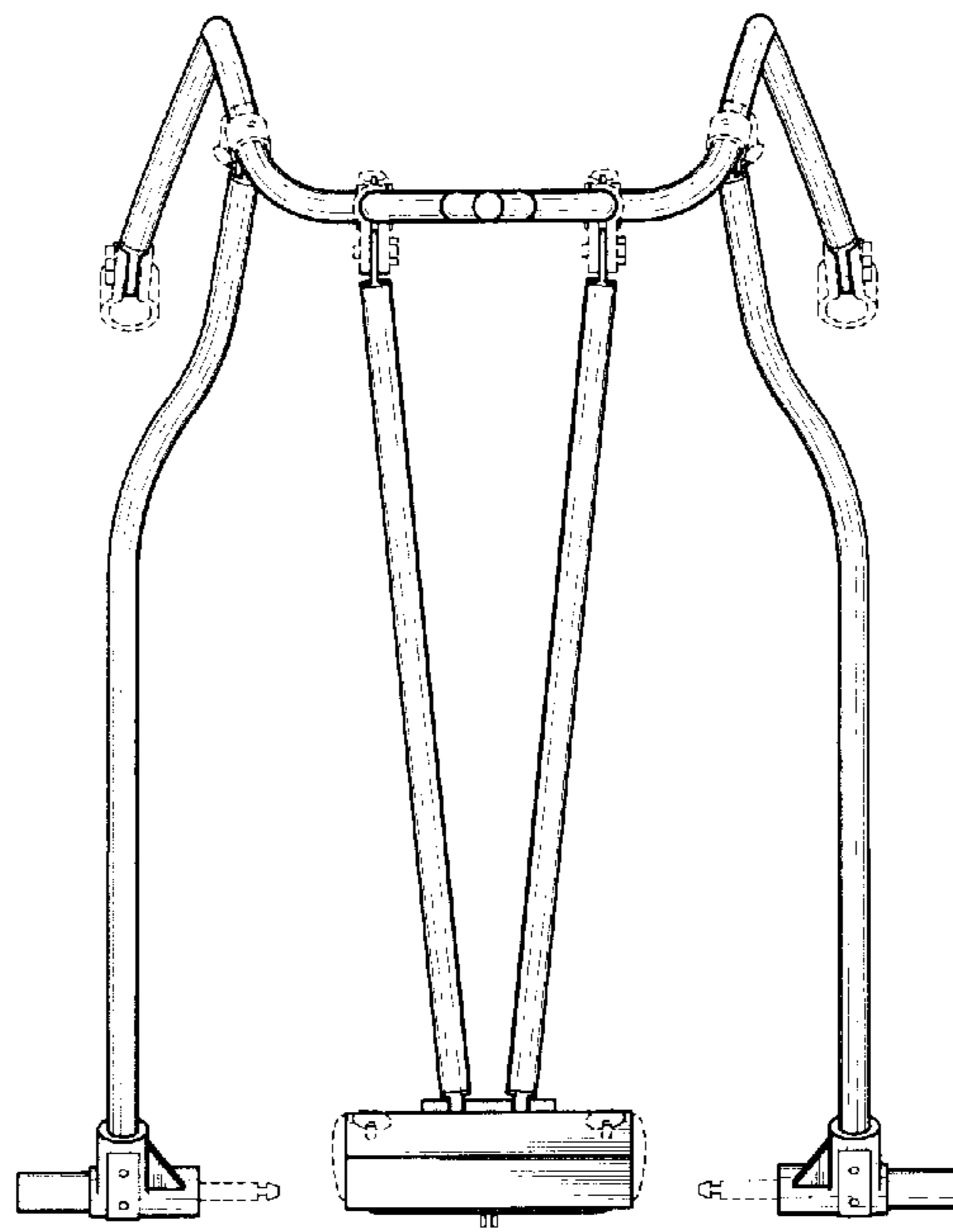

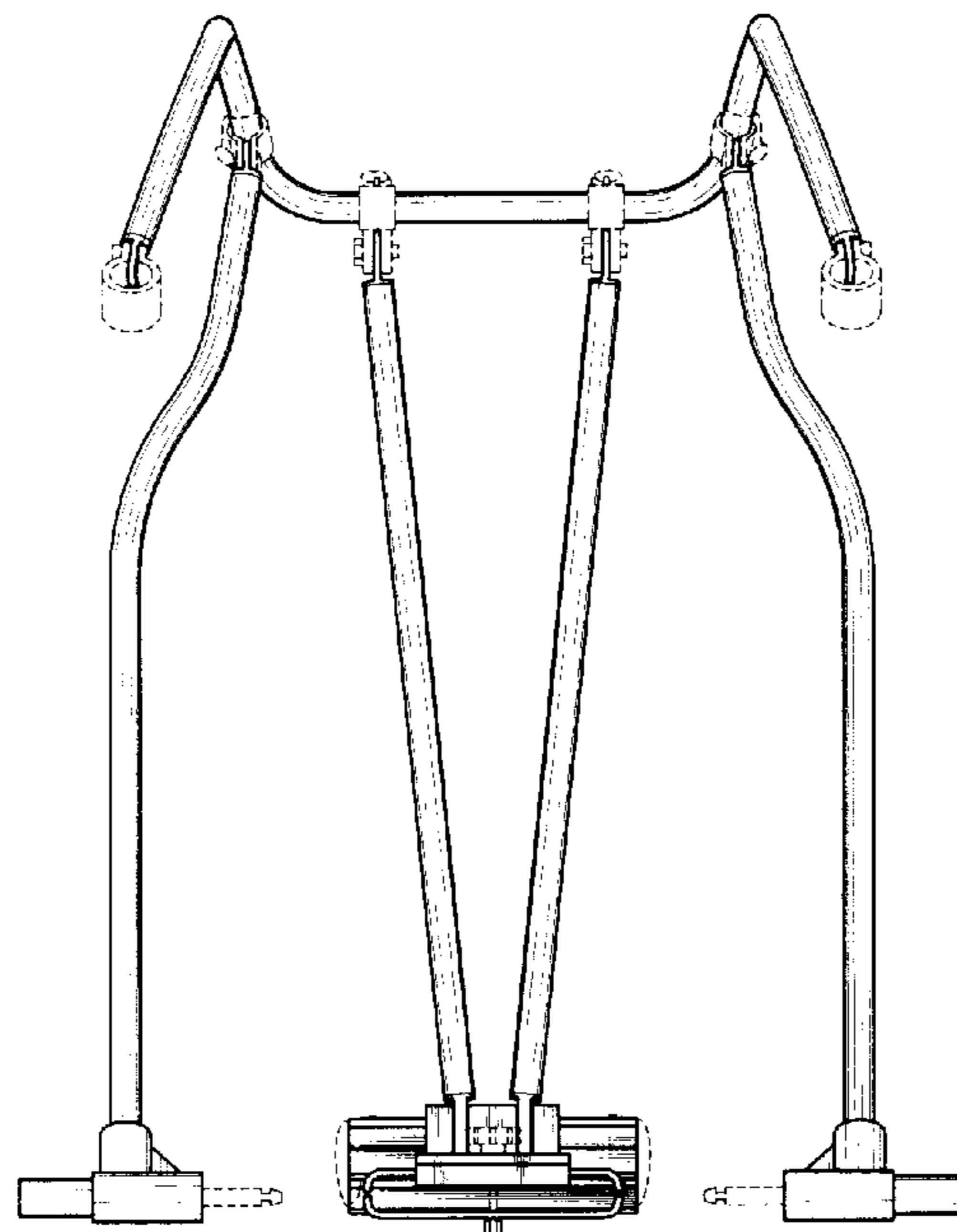

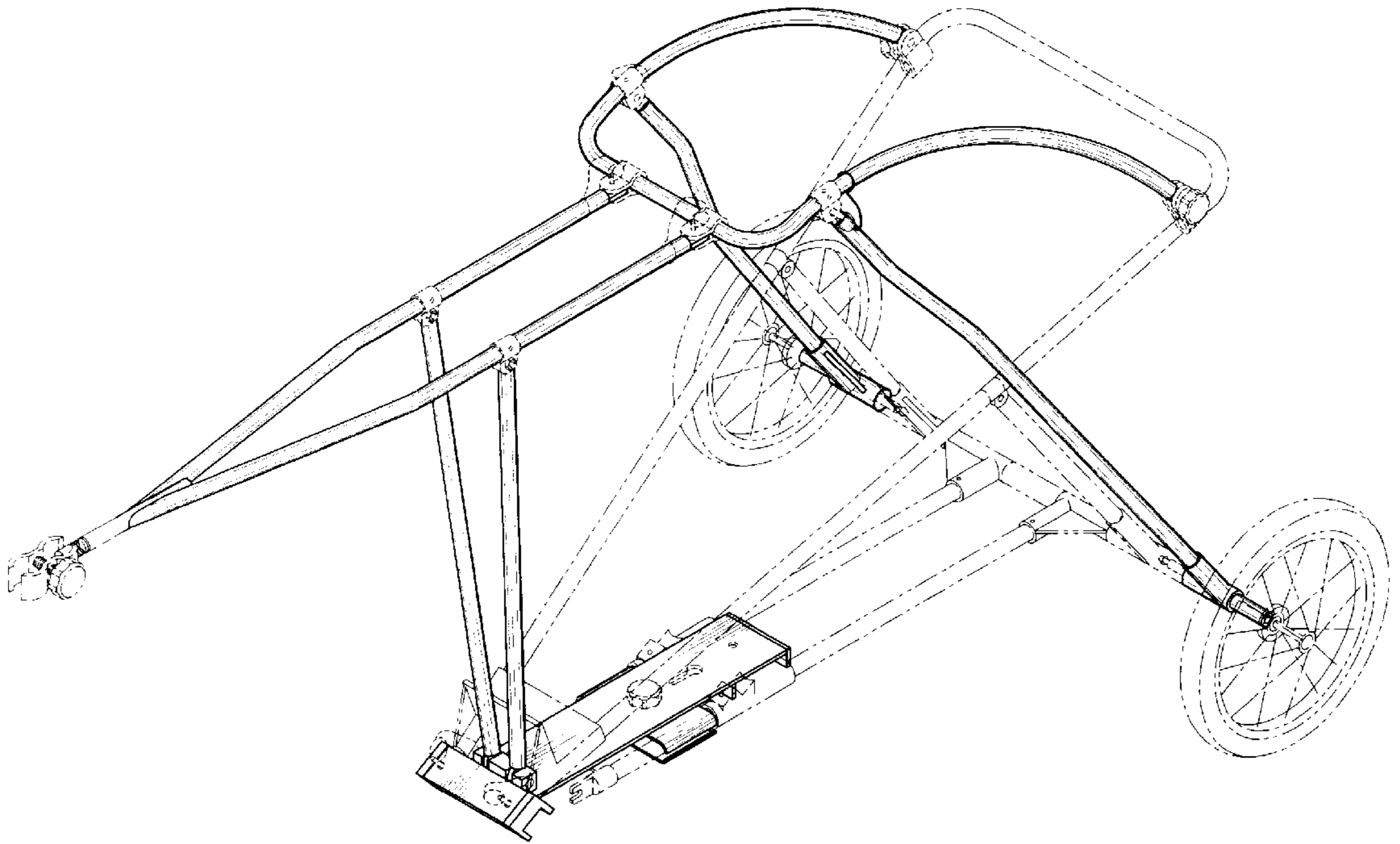

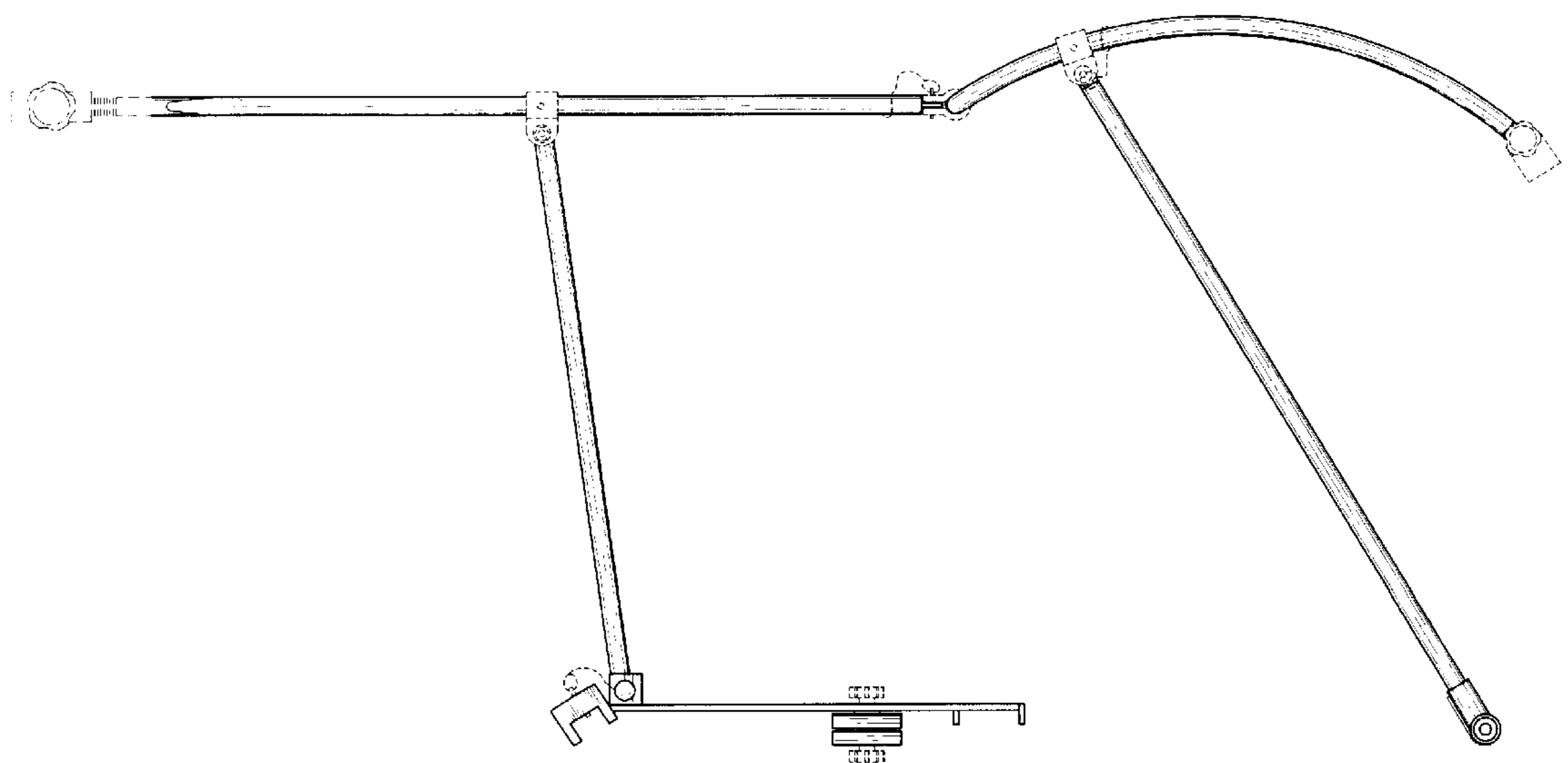

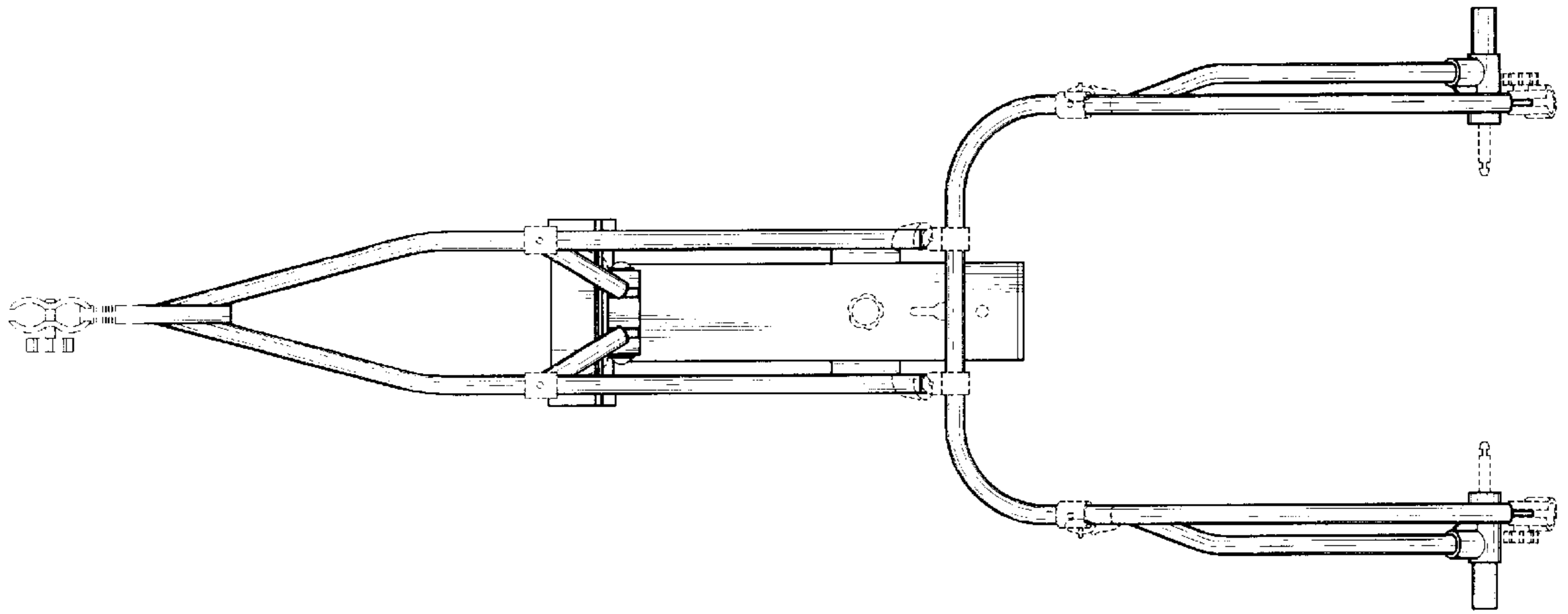

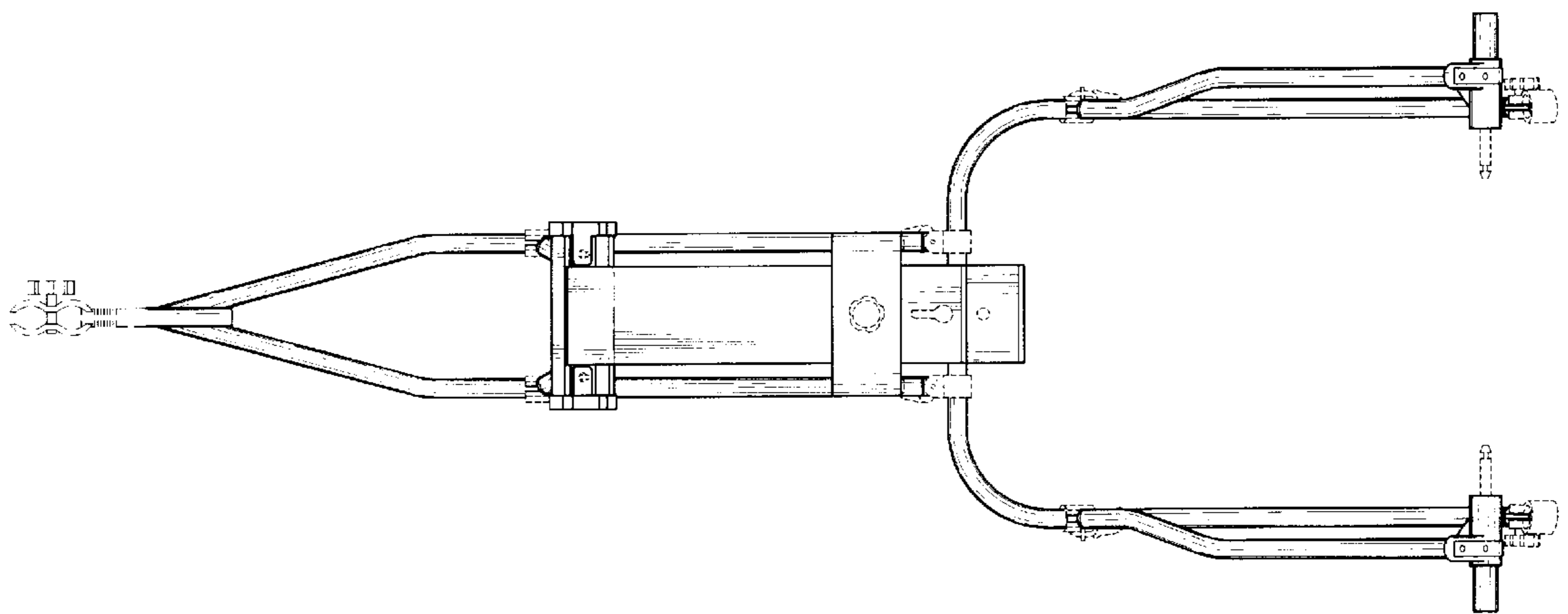

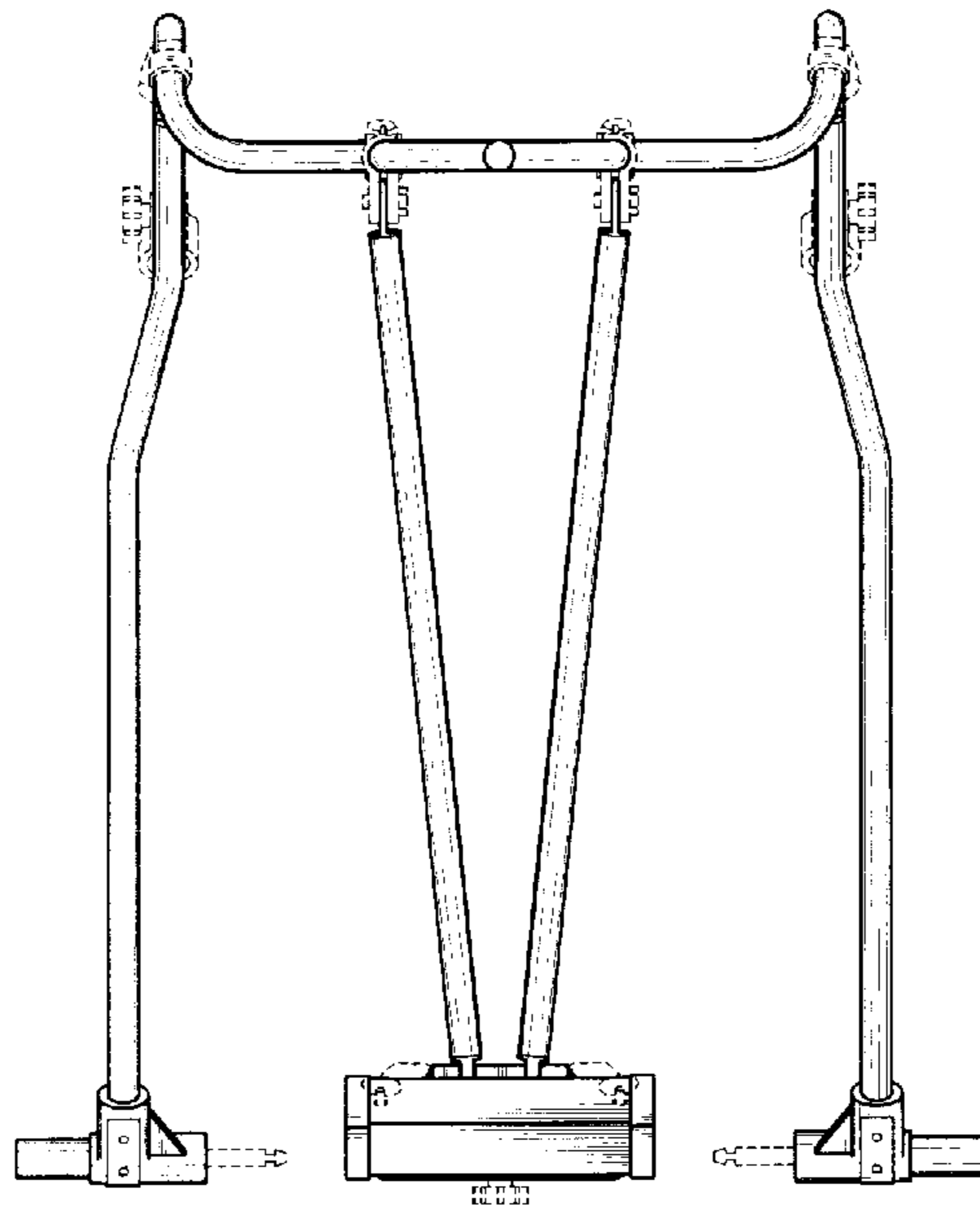

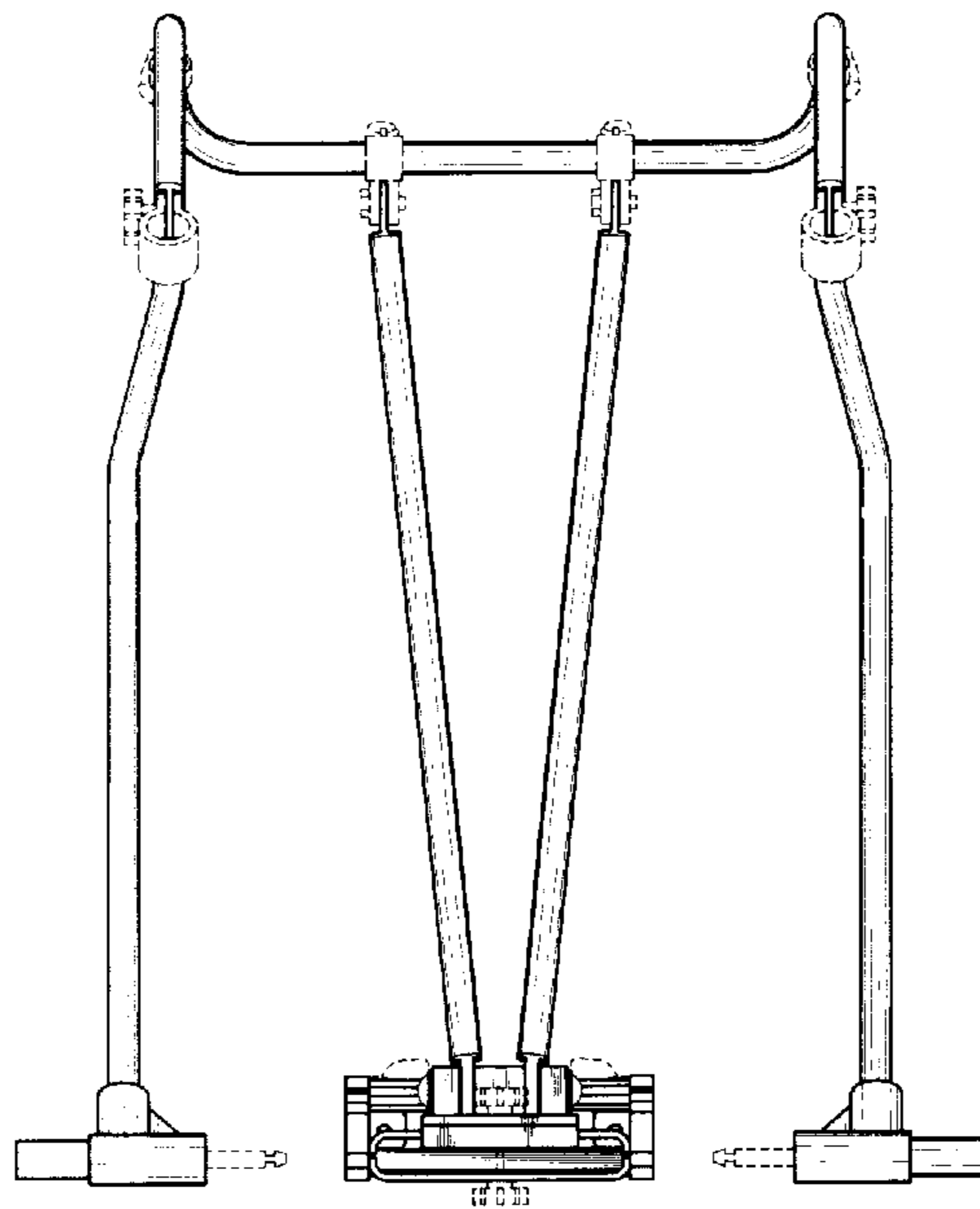
