[57] **CLAIM**

The ornamental design for a tire tread, as shown and described.

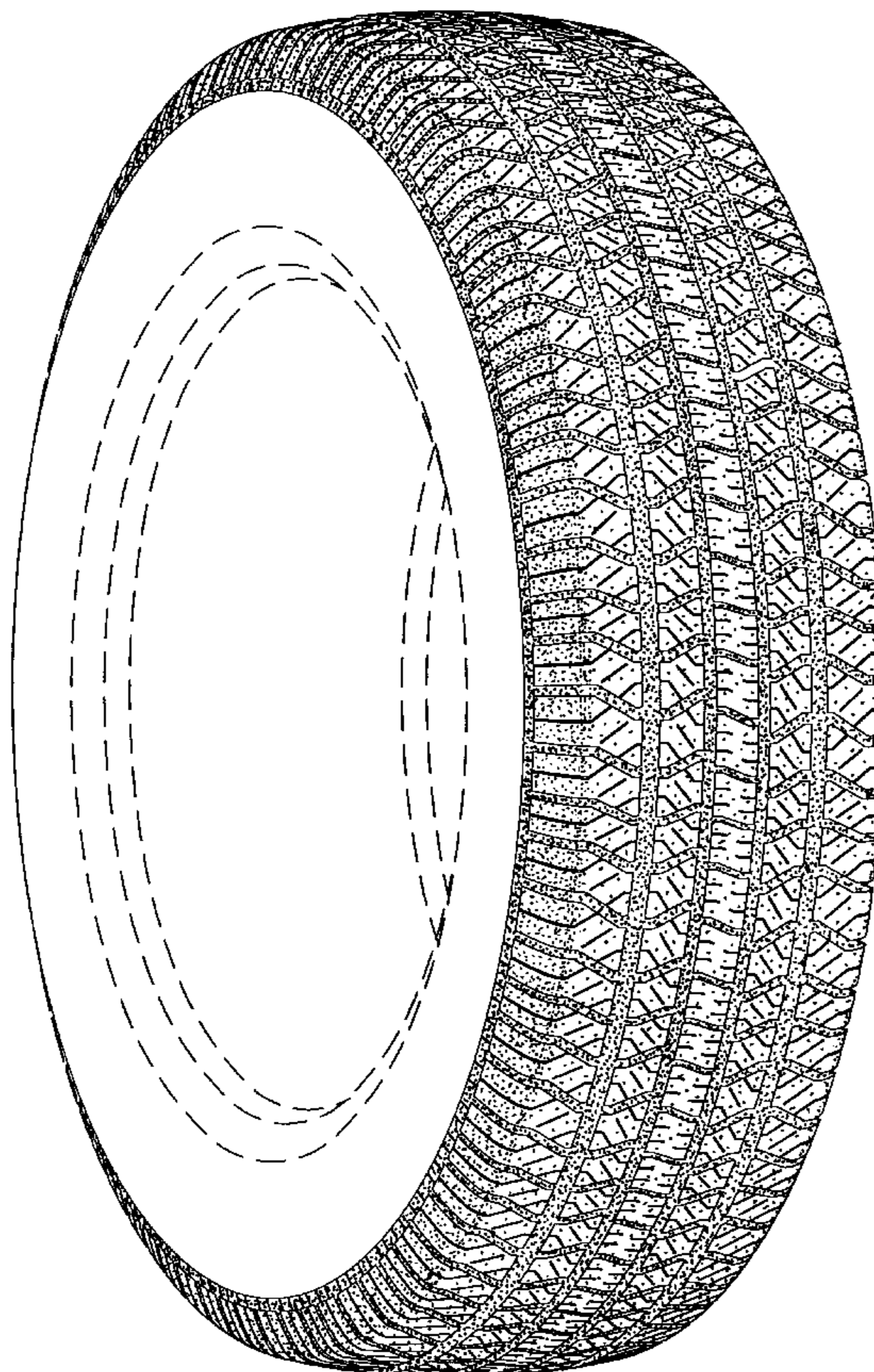
DESCRIPTION

FIG. 1 is a first perspective view of a tire tread showing my new tire tread design, it being understood that the tread pattern is repeated uniformly throughout the circumference of the tire tread with the opposite side being the same as for the side shown; and,

FIG. 2 is an enlarged fragmentary front elevation view of my new tire tread thereof.

The broken line showing of a tire sidewall and inner bead is for illustrative purposes only and forms no part of the claimed design.

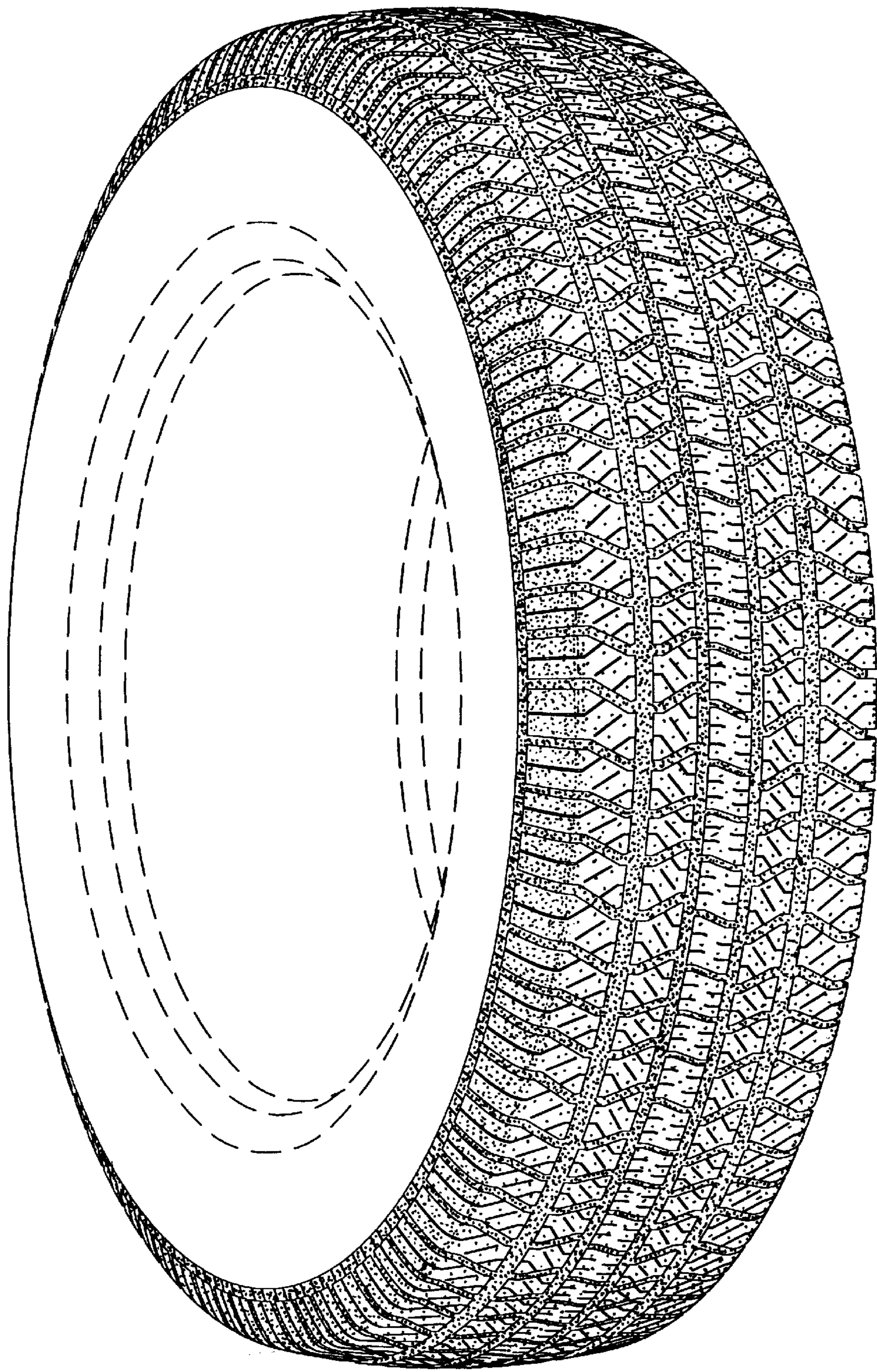

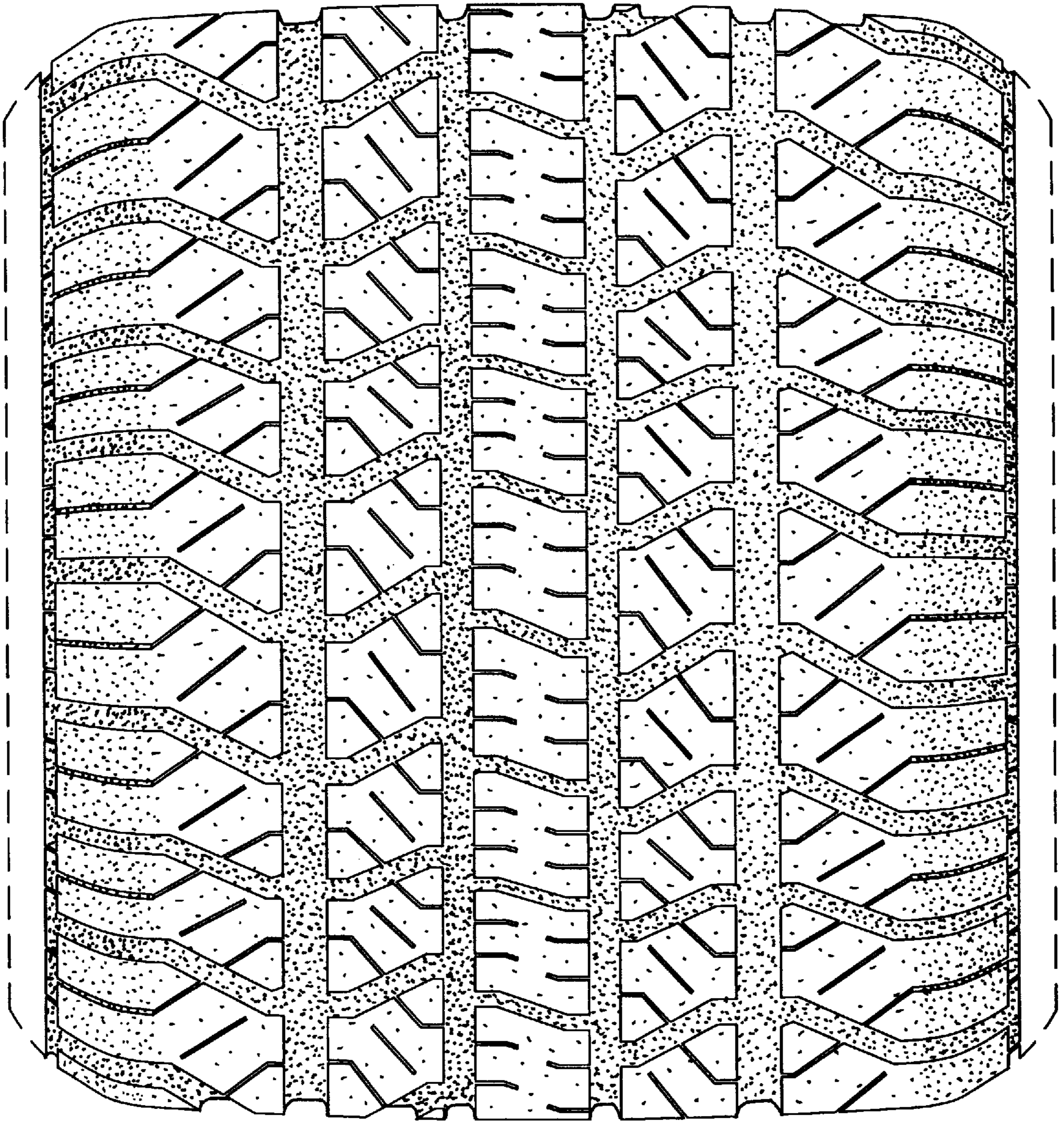
