The ornamental design for a flashlight case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a flashlight case showing our new design;

FIG. 2 is a front elevation view of the embodiment shown in FIG. 1;

FIG. 3 is a top plan view;

FIG. 4 is a bottom plan view;

FIG. 5 is a side elevation view showing the side shown in FIG. 1;

FIG. 6 is a side elevation view showing the side opposite from that shown in FIG. 6;

FIG. 7 is a back elevation view;

FIG. 8 is a perspective view of a second embodiment of a flashlight case showing our new design;

FIG. 9 is a front elevation view of the embodiment shown in FIG. 8;

FIG. 10 is a top plan view of the second embodiment;

FIG. 11 is a bottom plan view of the second embodiment;

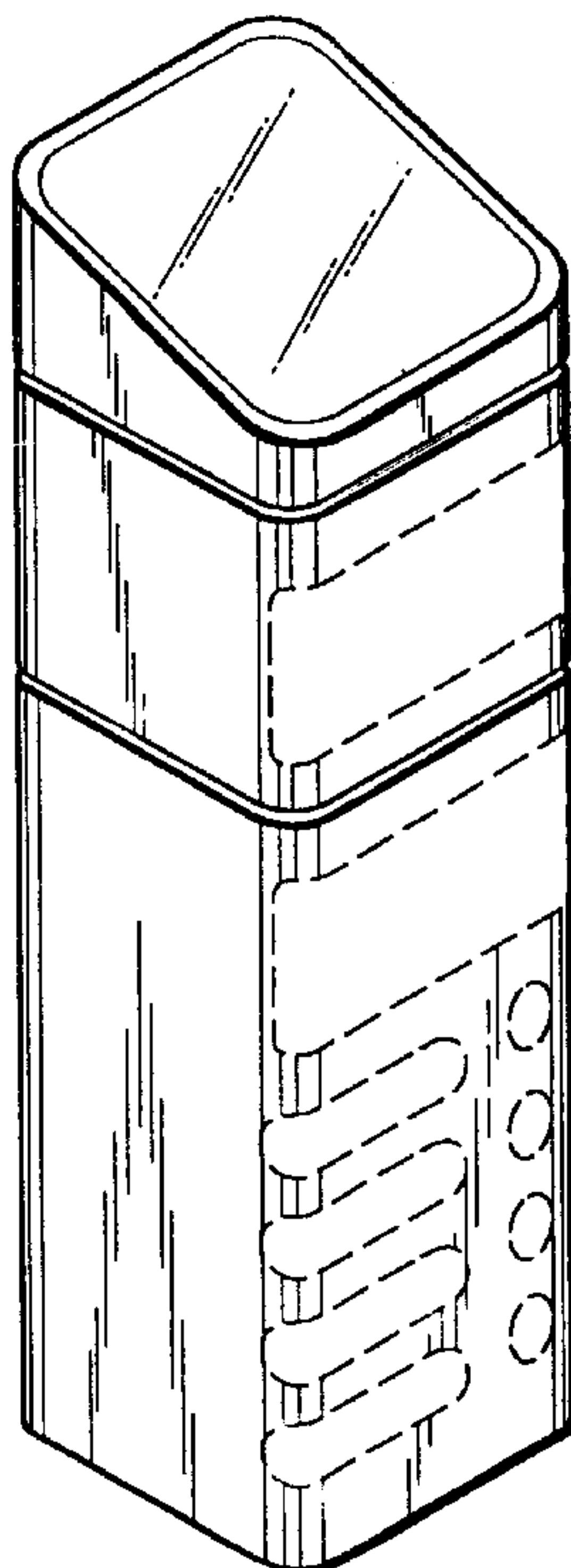
FIG. 12 is a side elevation view showing the side shown in FIG. 8;

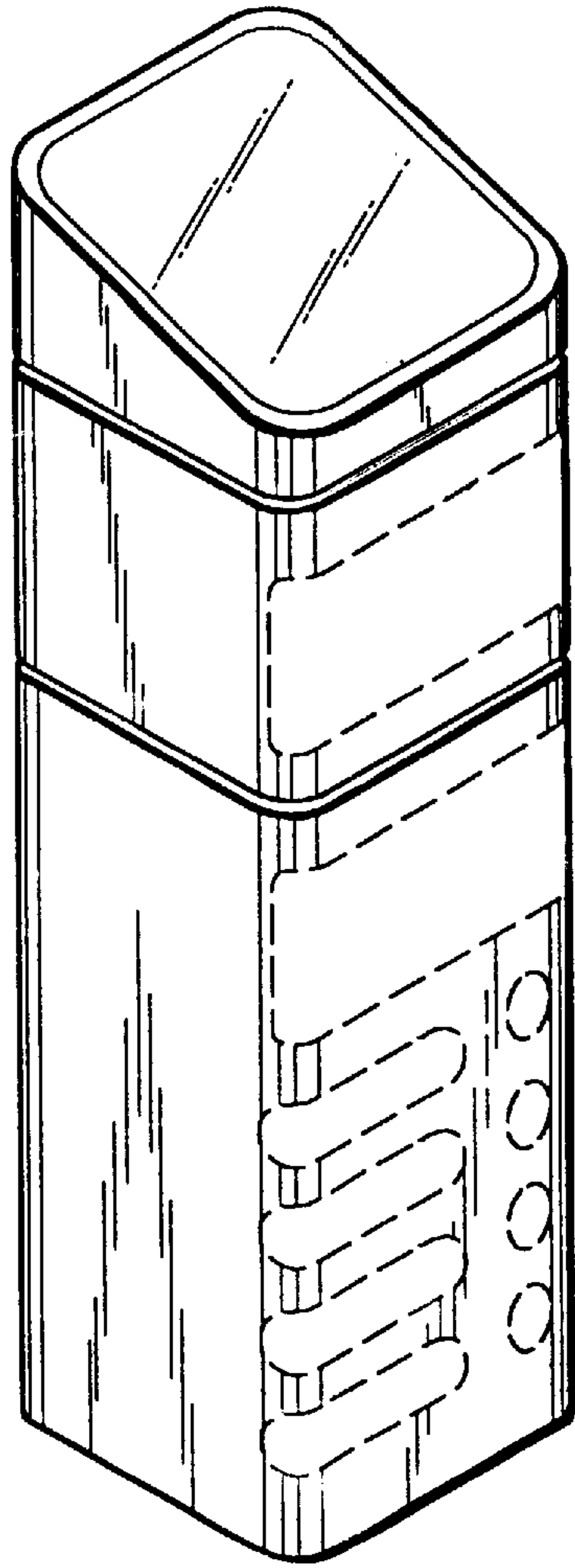

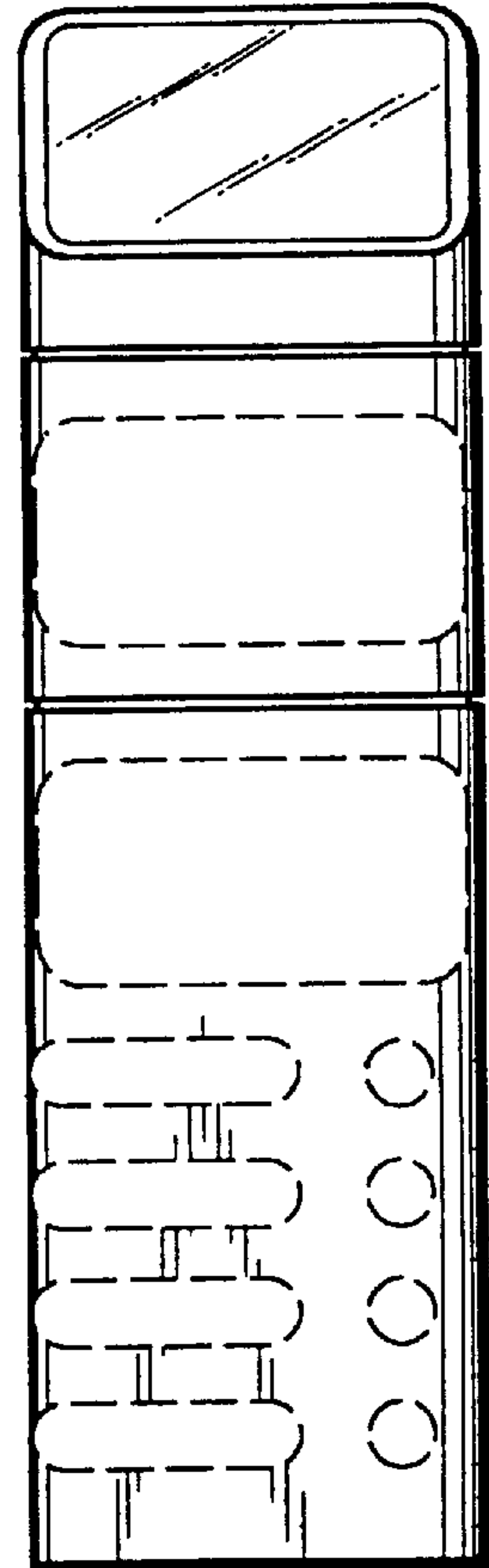

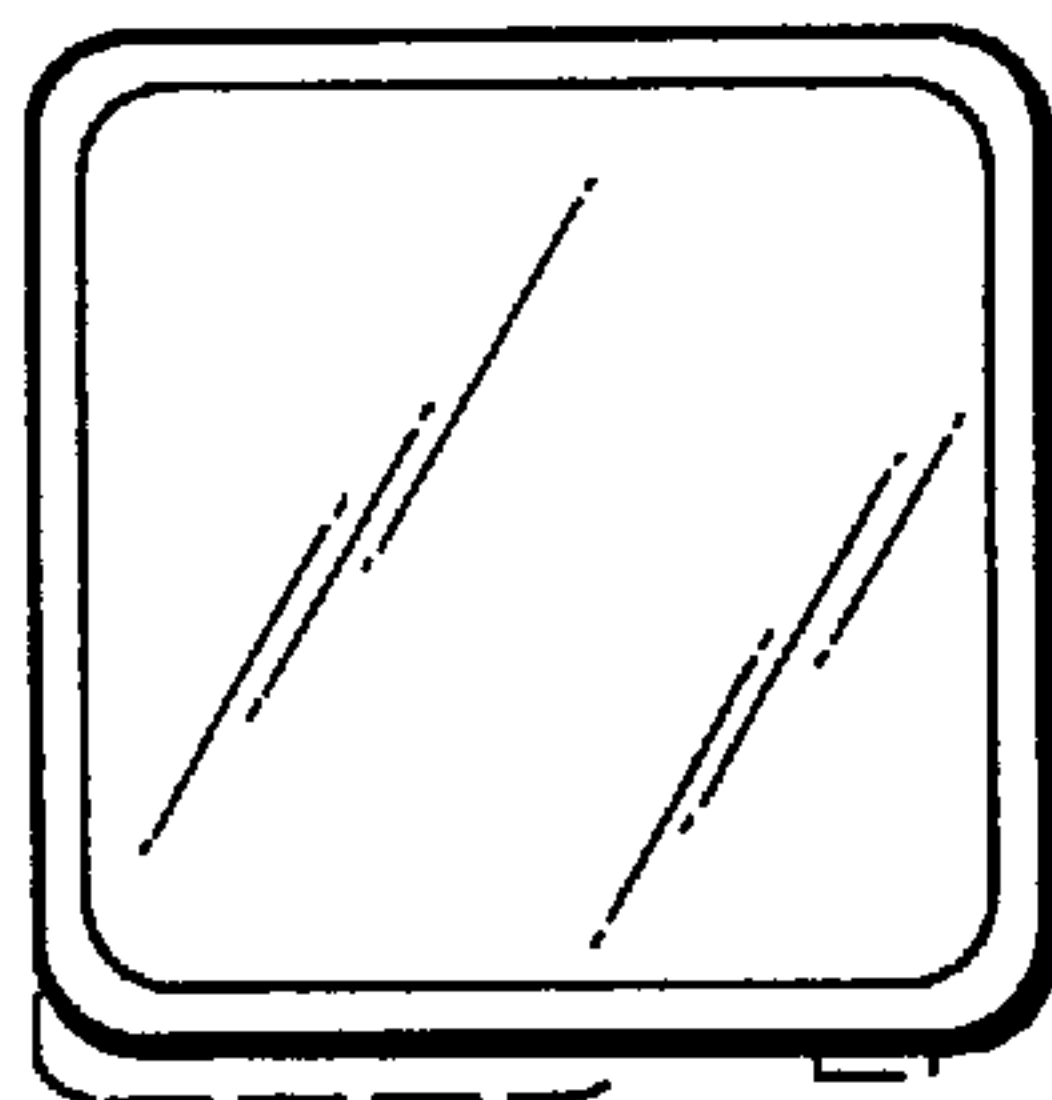

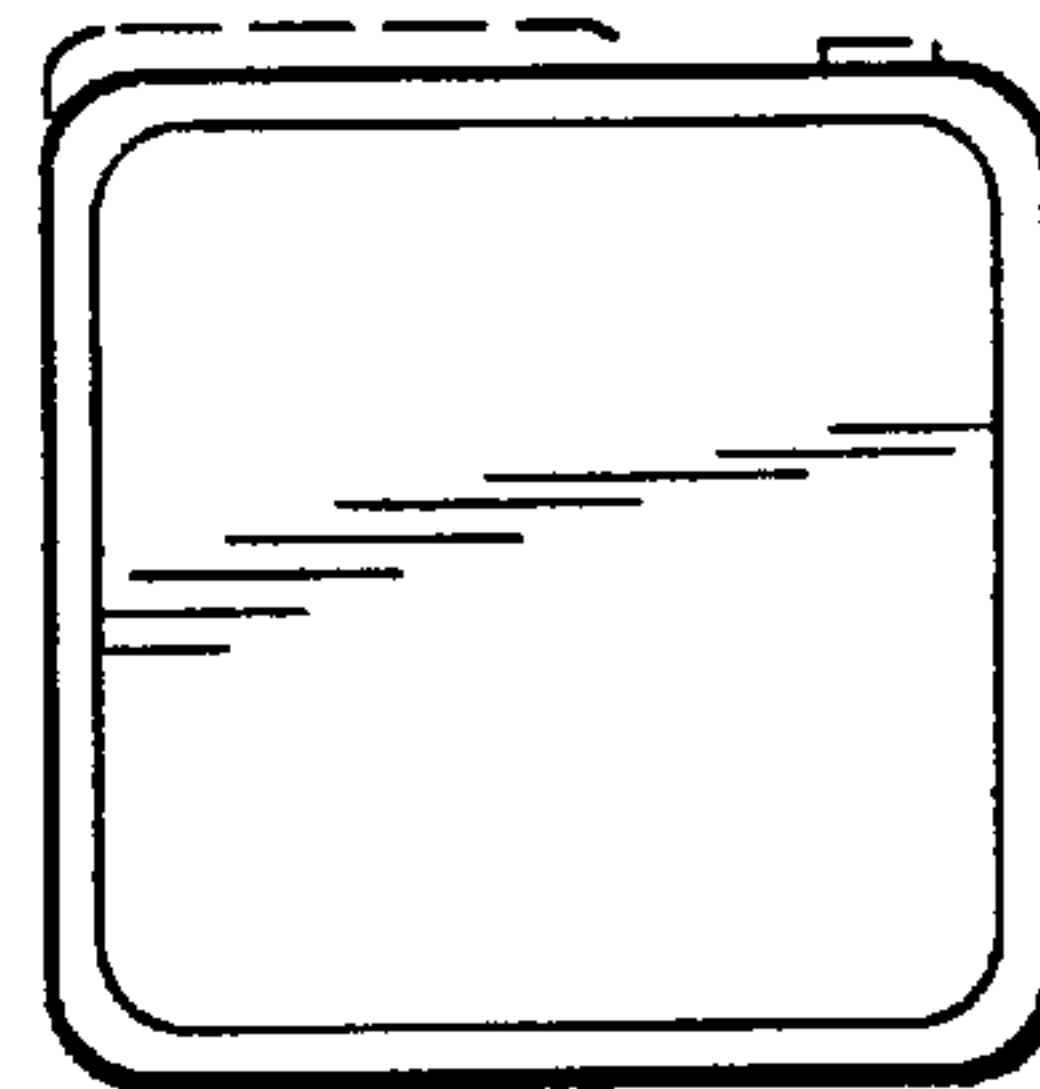

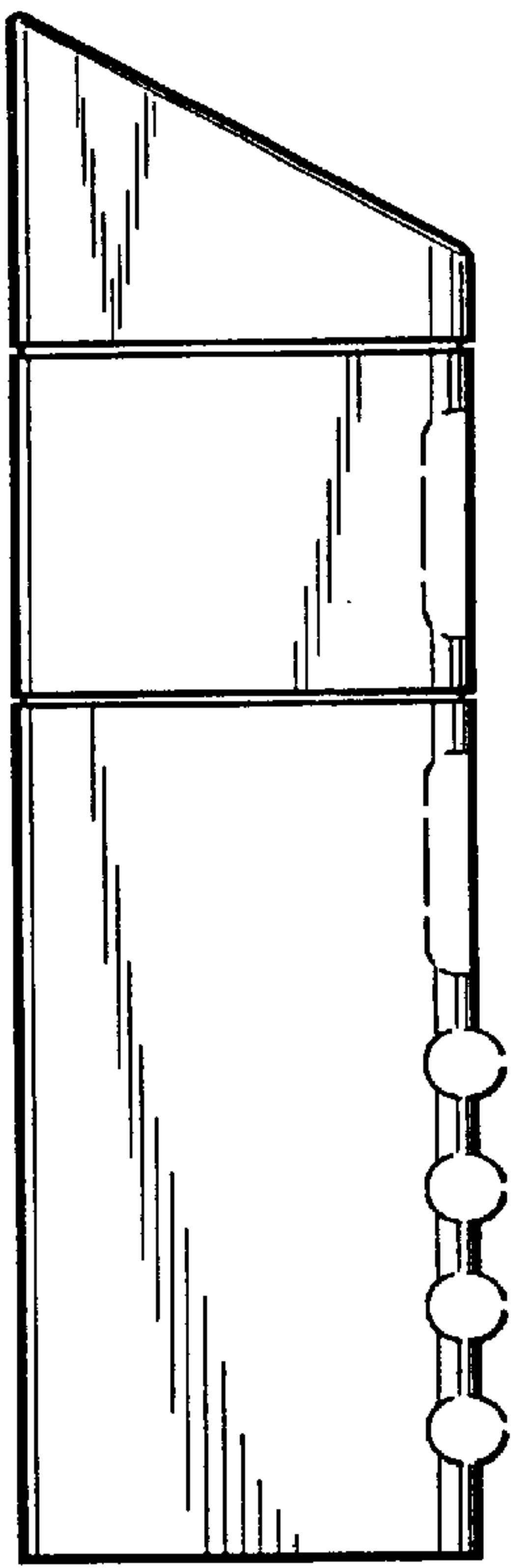

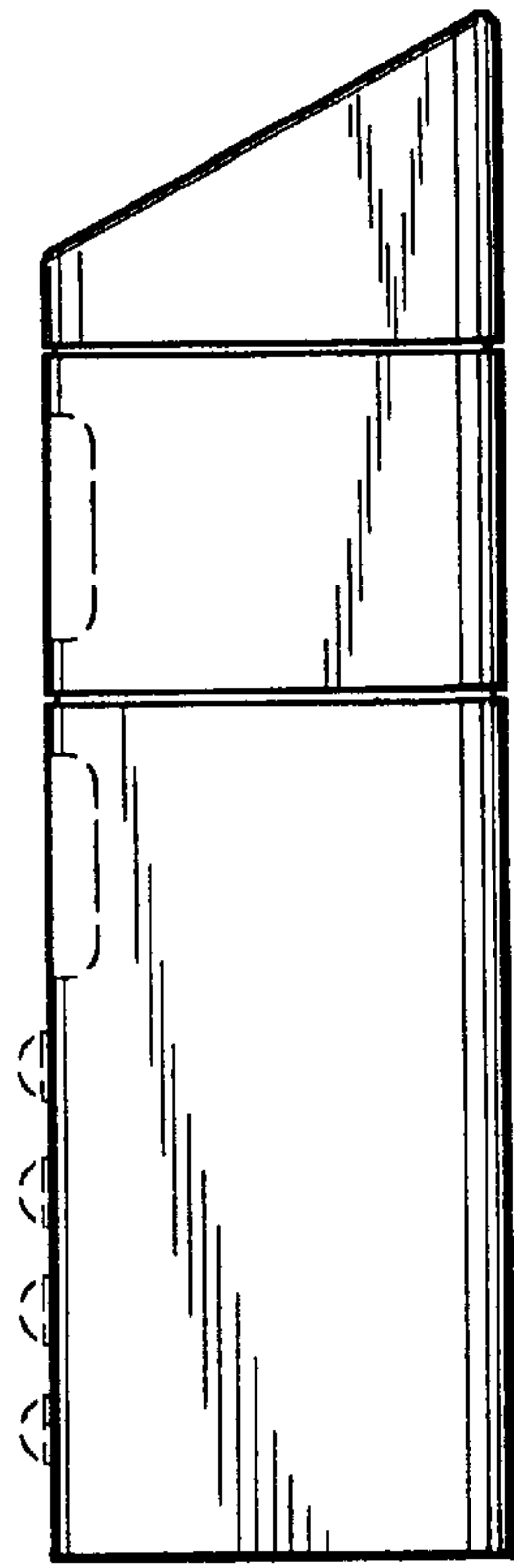

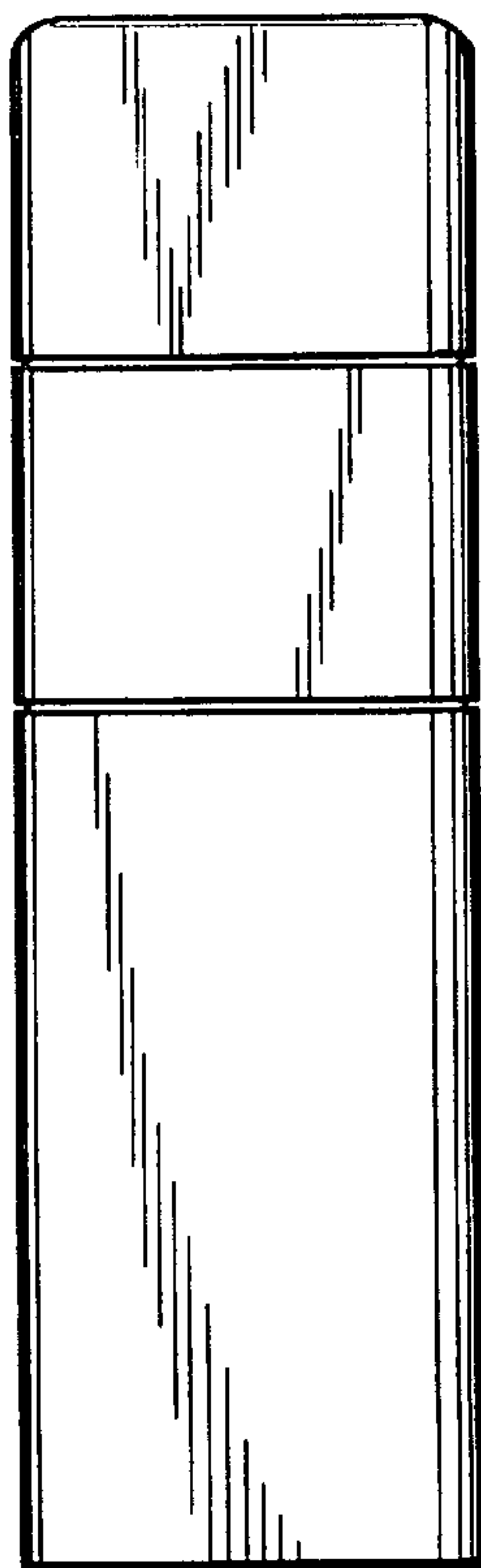

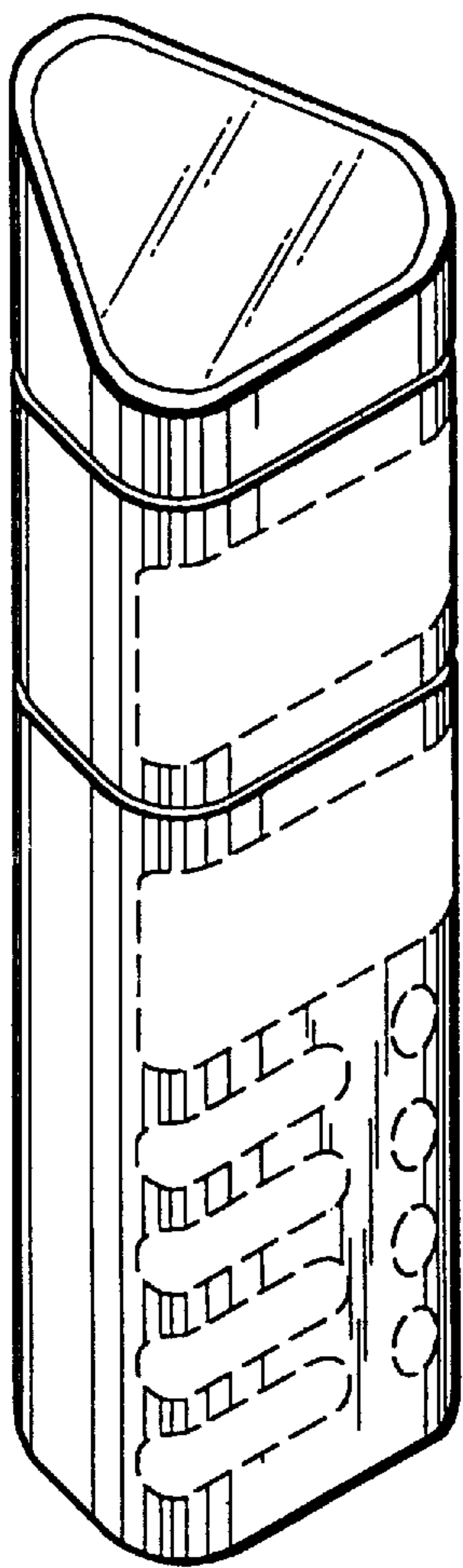

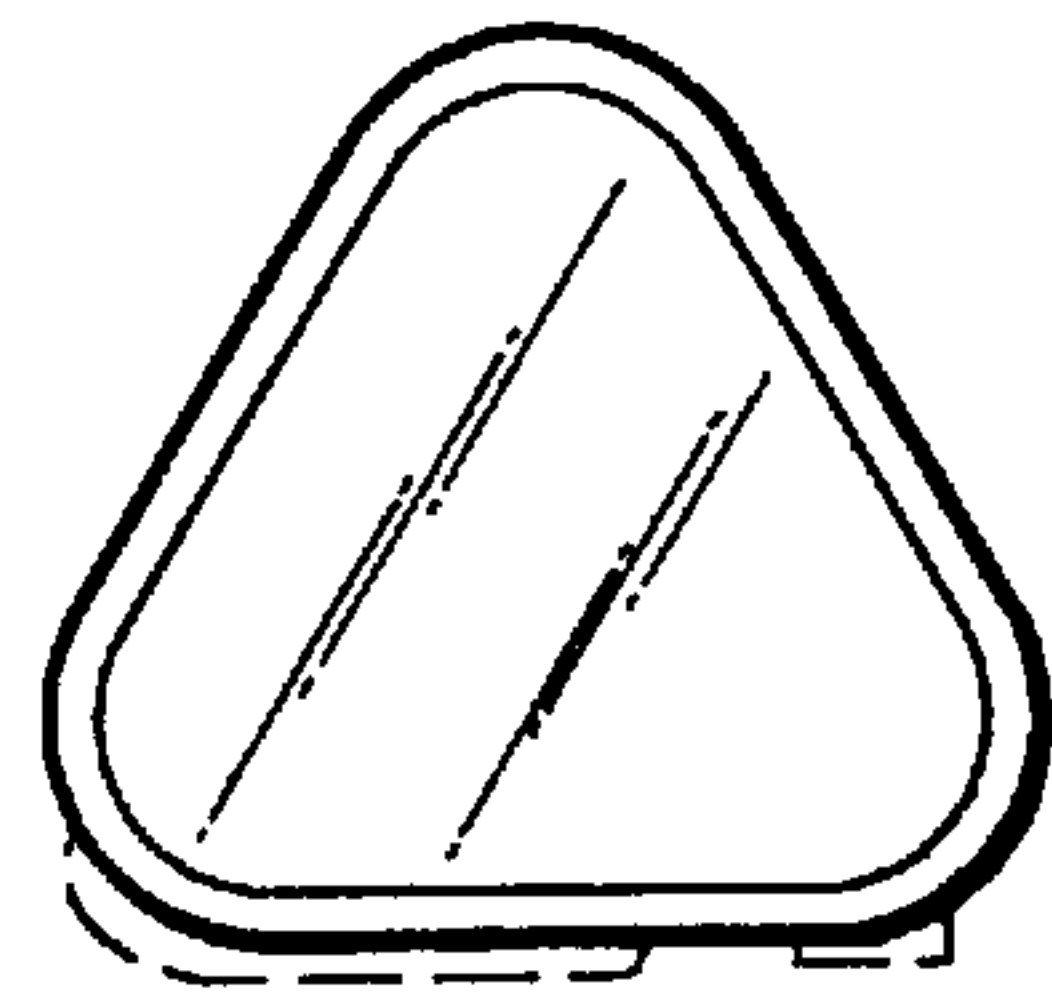

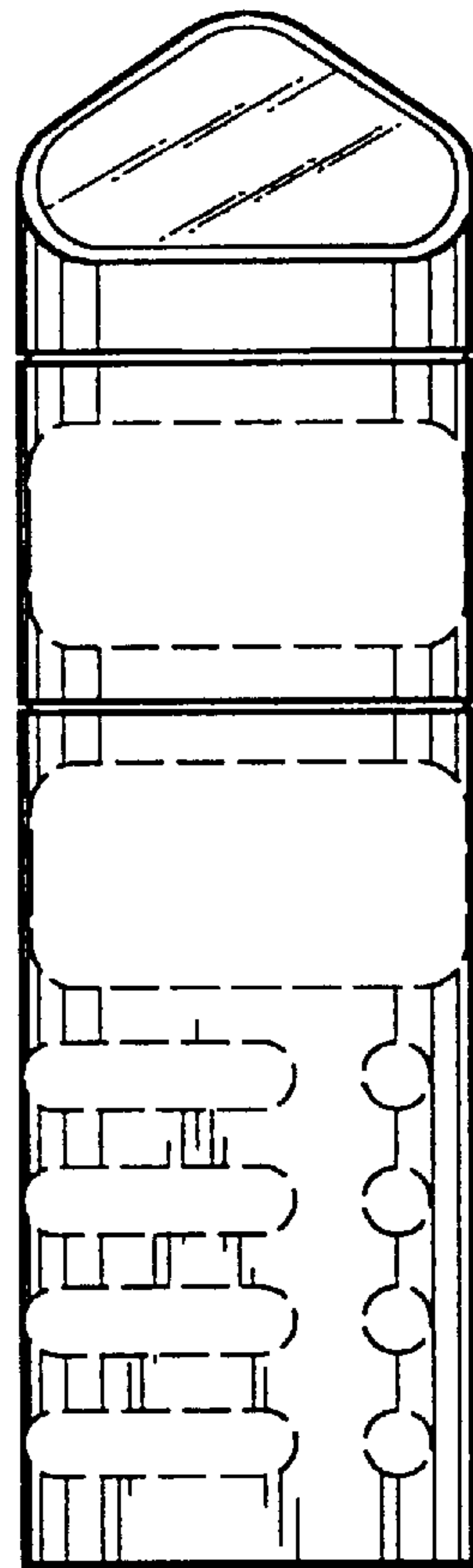
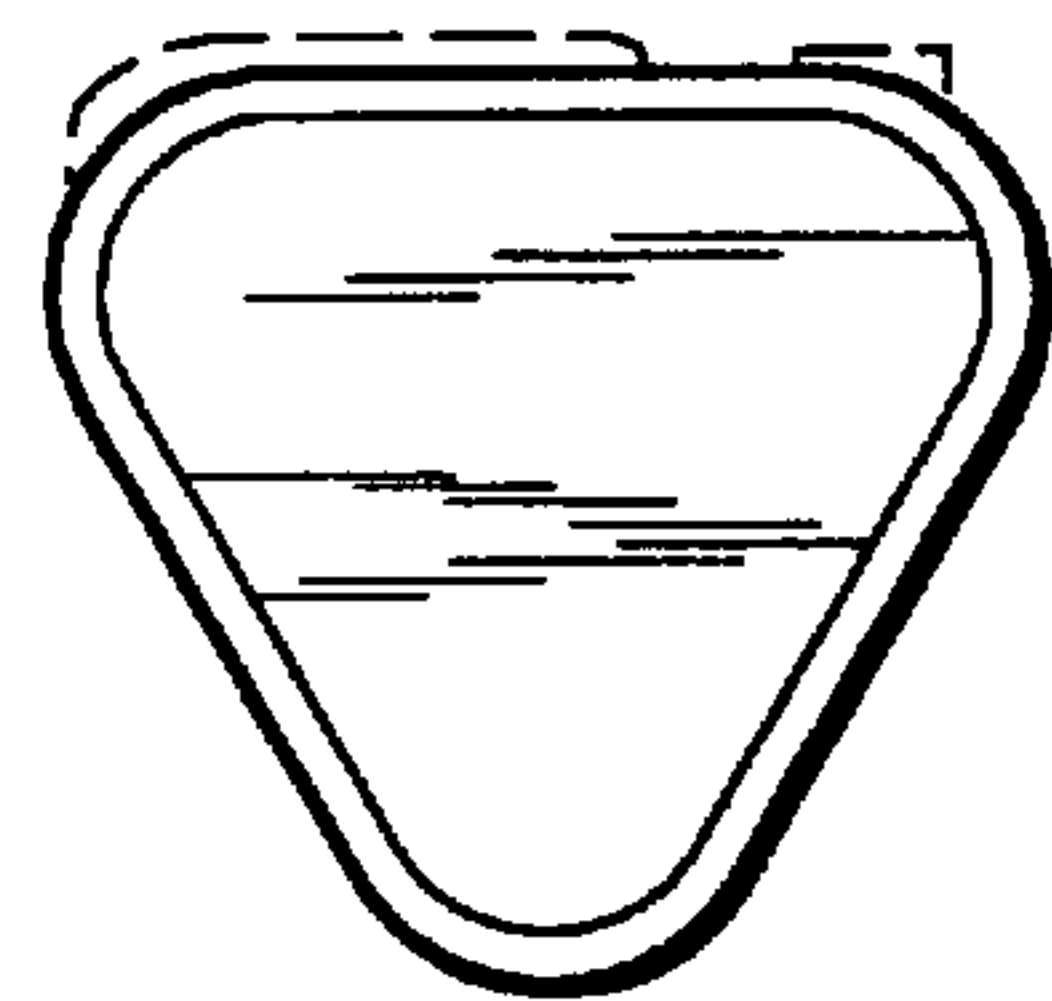

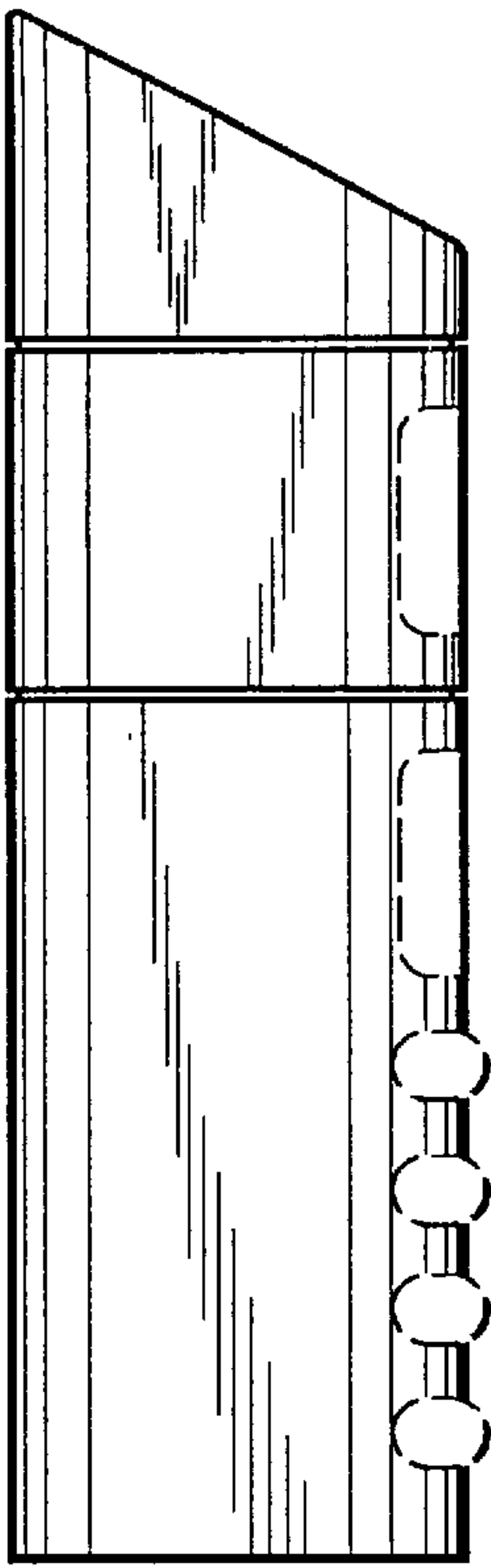

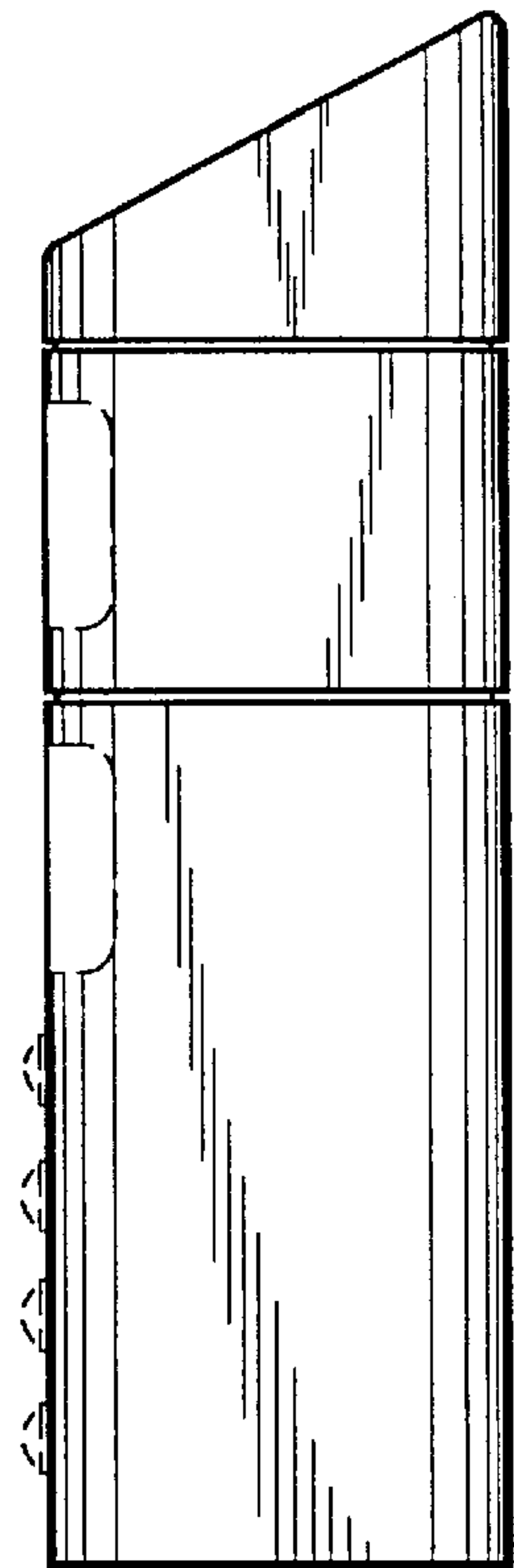

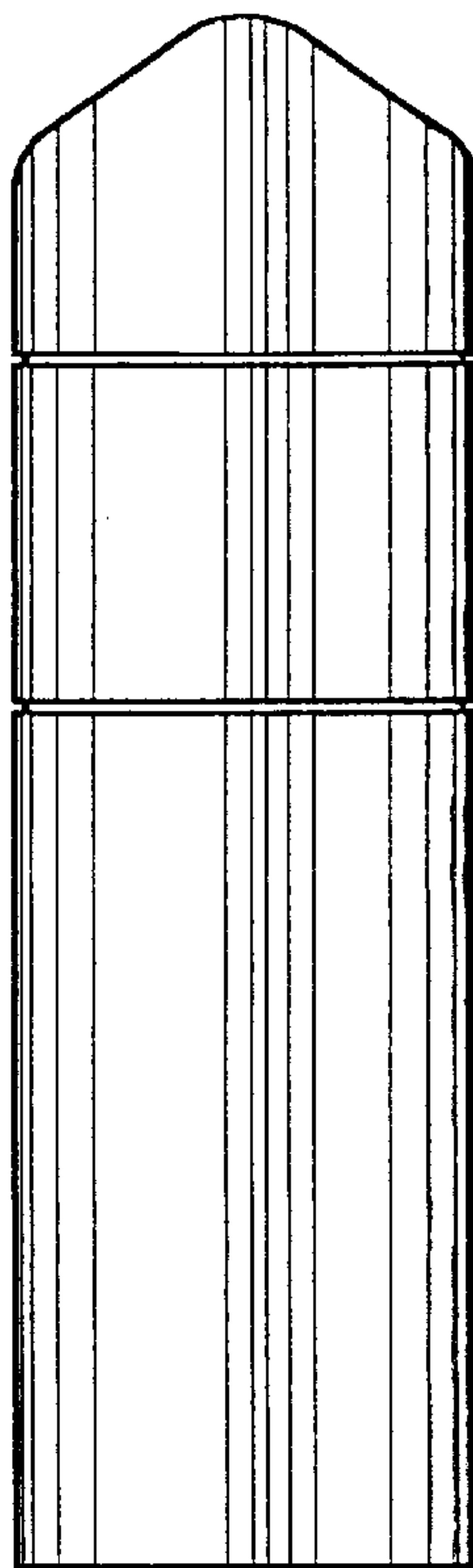
