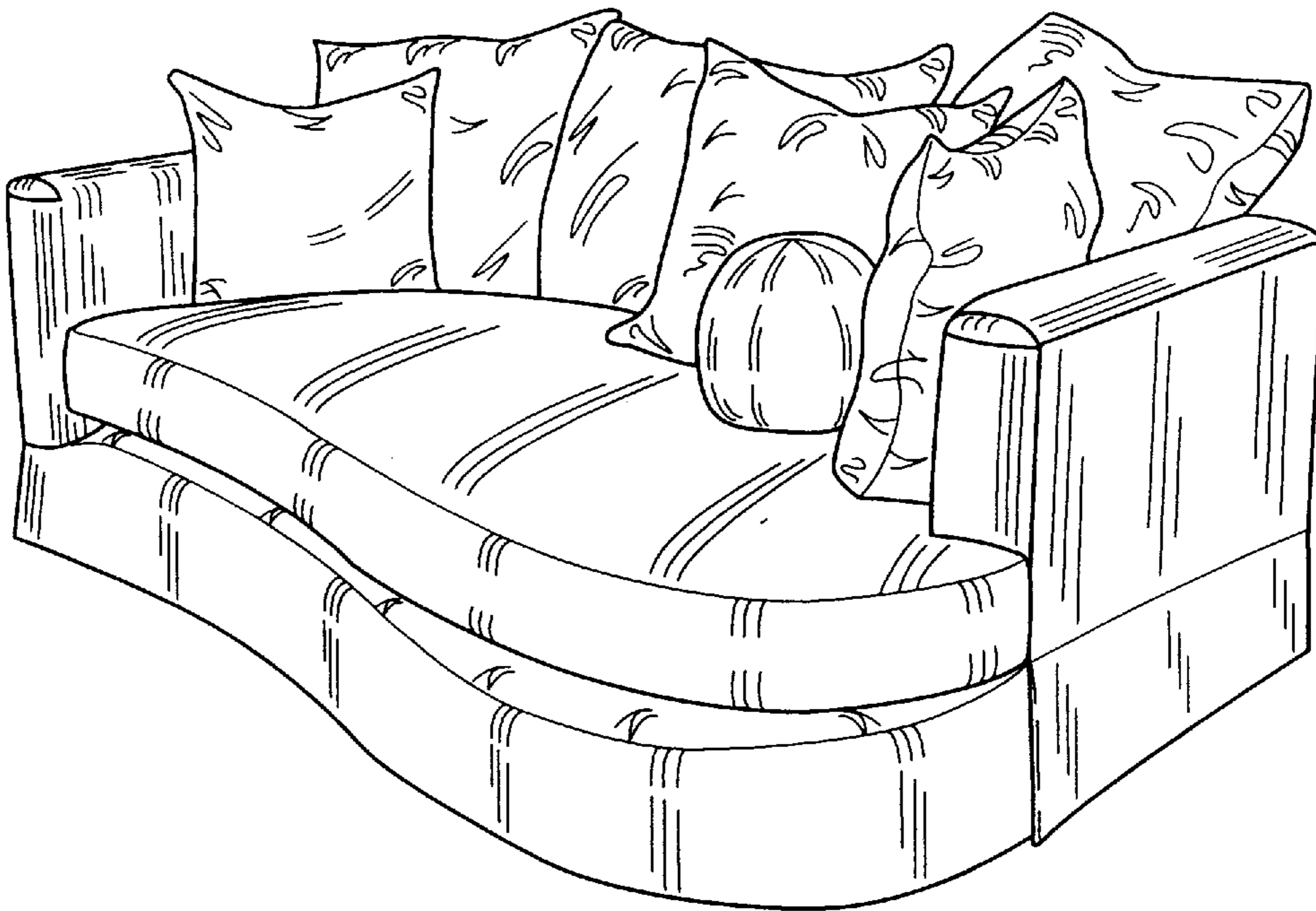
[57] **CLAIM**

The ornamental design for a seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a right front perspective view of a seat showing my new design;  
 FIG. 2 is a left front perspective view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a rear elevational view thereof;  
 FIG. 7 is a top view thereof;  
 FIG. 8 is a left perspective view similar to FIG. 2, the pillows having been removed for illustrative purposes;  
 FIG. 9 is a front elevational view similar to FIG. 3, the pillows having been removed for illustrative purposes;  
 FIG. 10 is a top view similar to FIG. 7, the pillows having been removed for illustrative purposes; and,  
 FIG. 11 is a left front perspective view of a second embodiment of the seat of my design, similar to FIG. 1 except being the mirror image thereof, being without a skirted bottom, and having no spherical pillow.

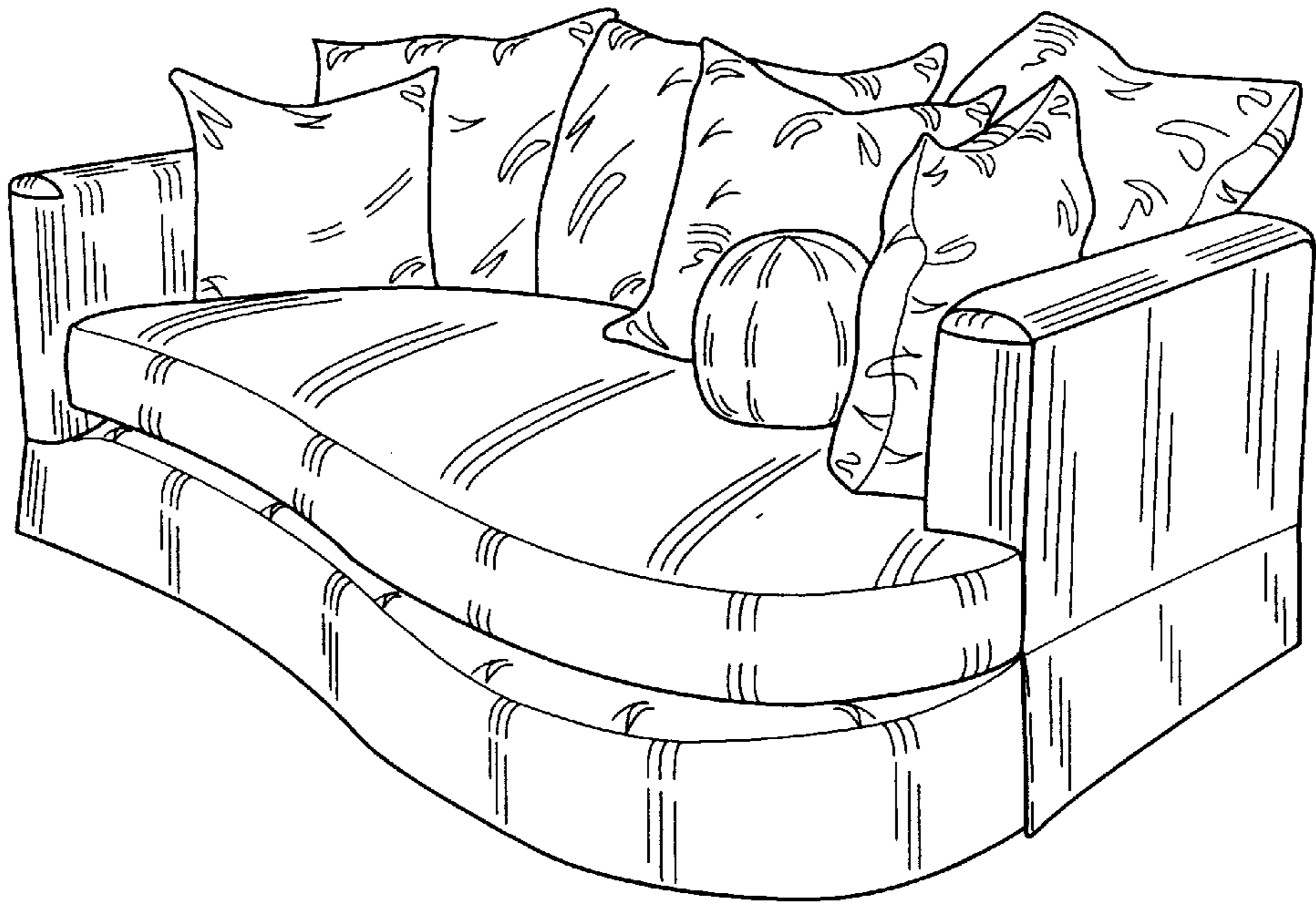

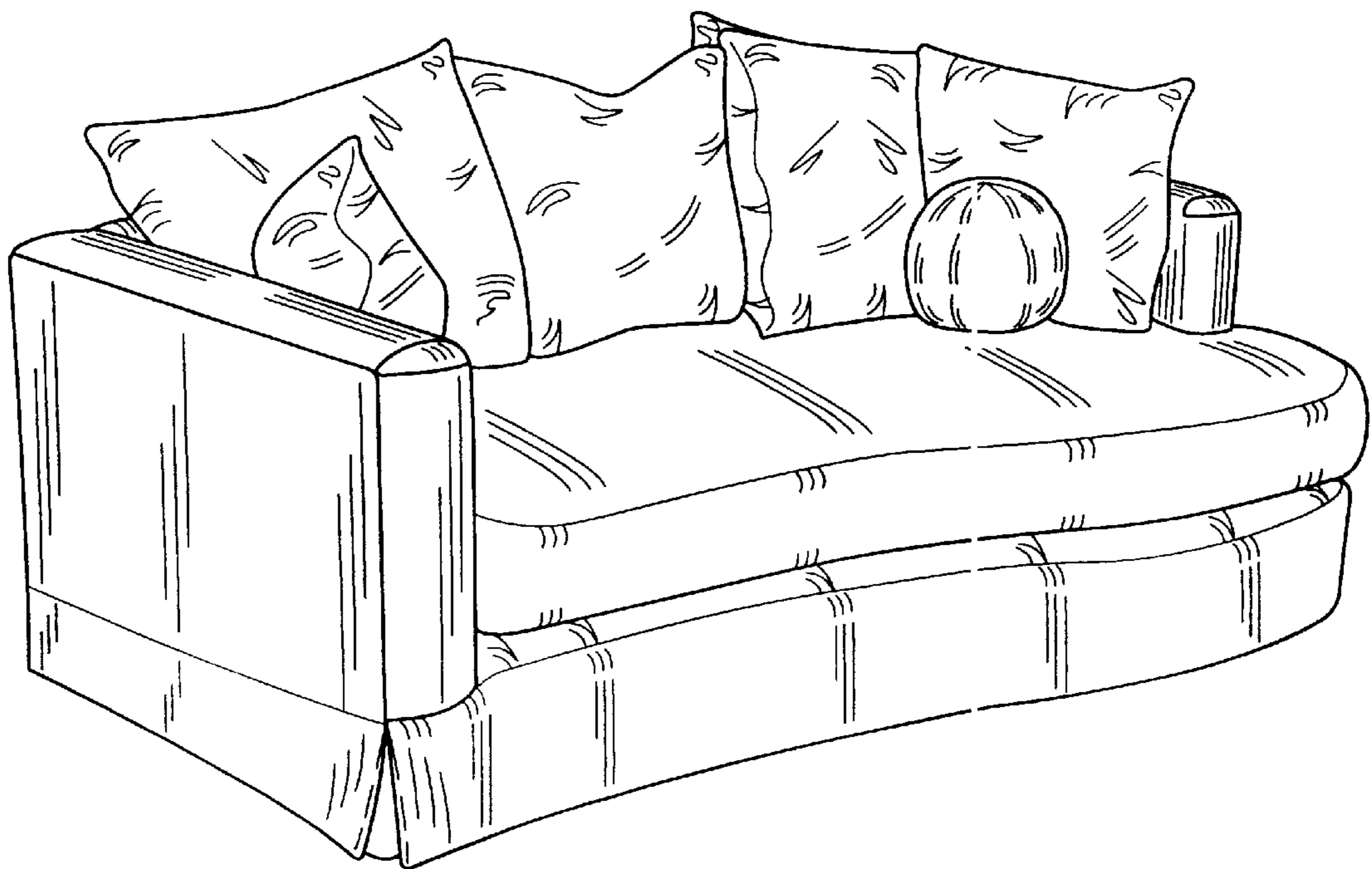

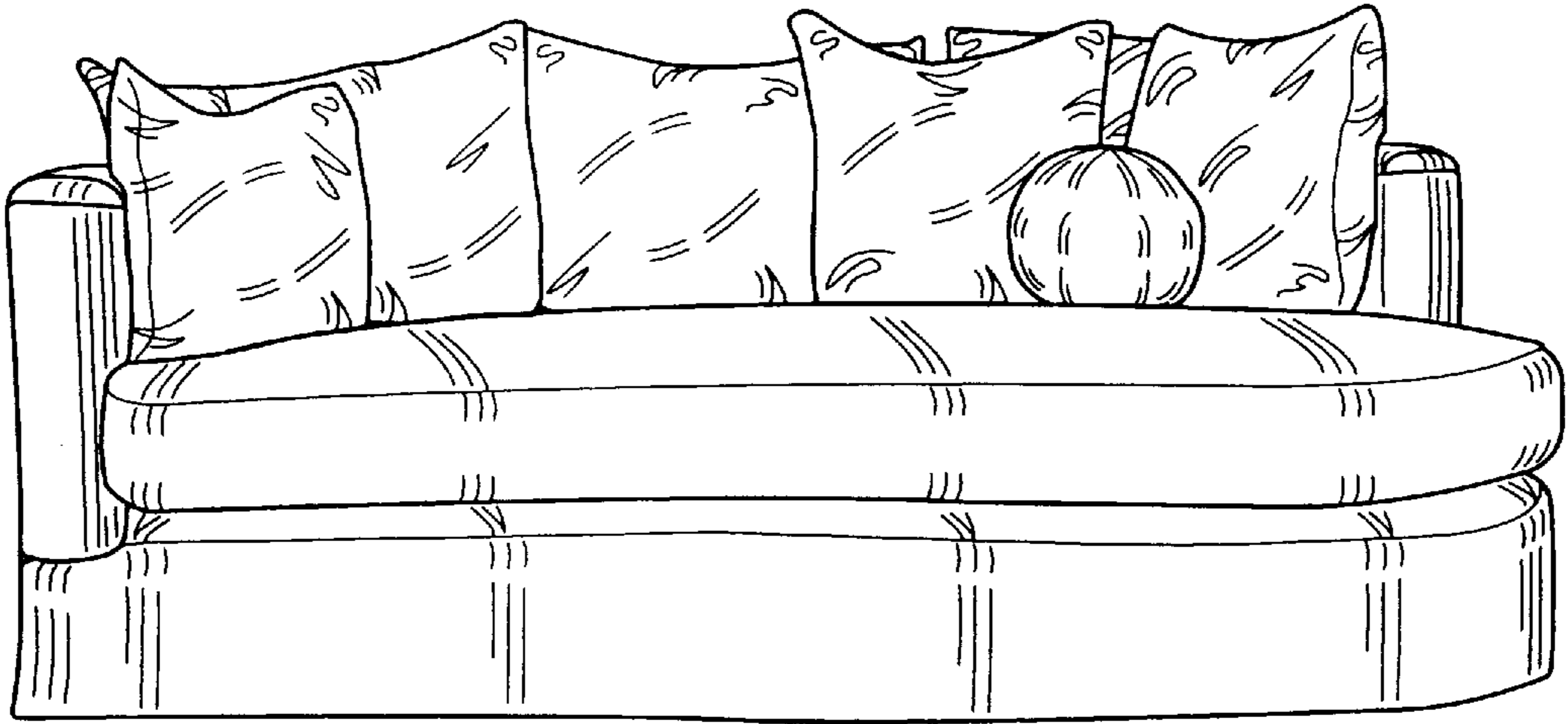

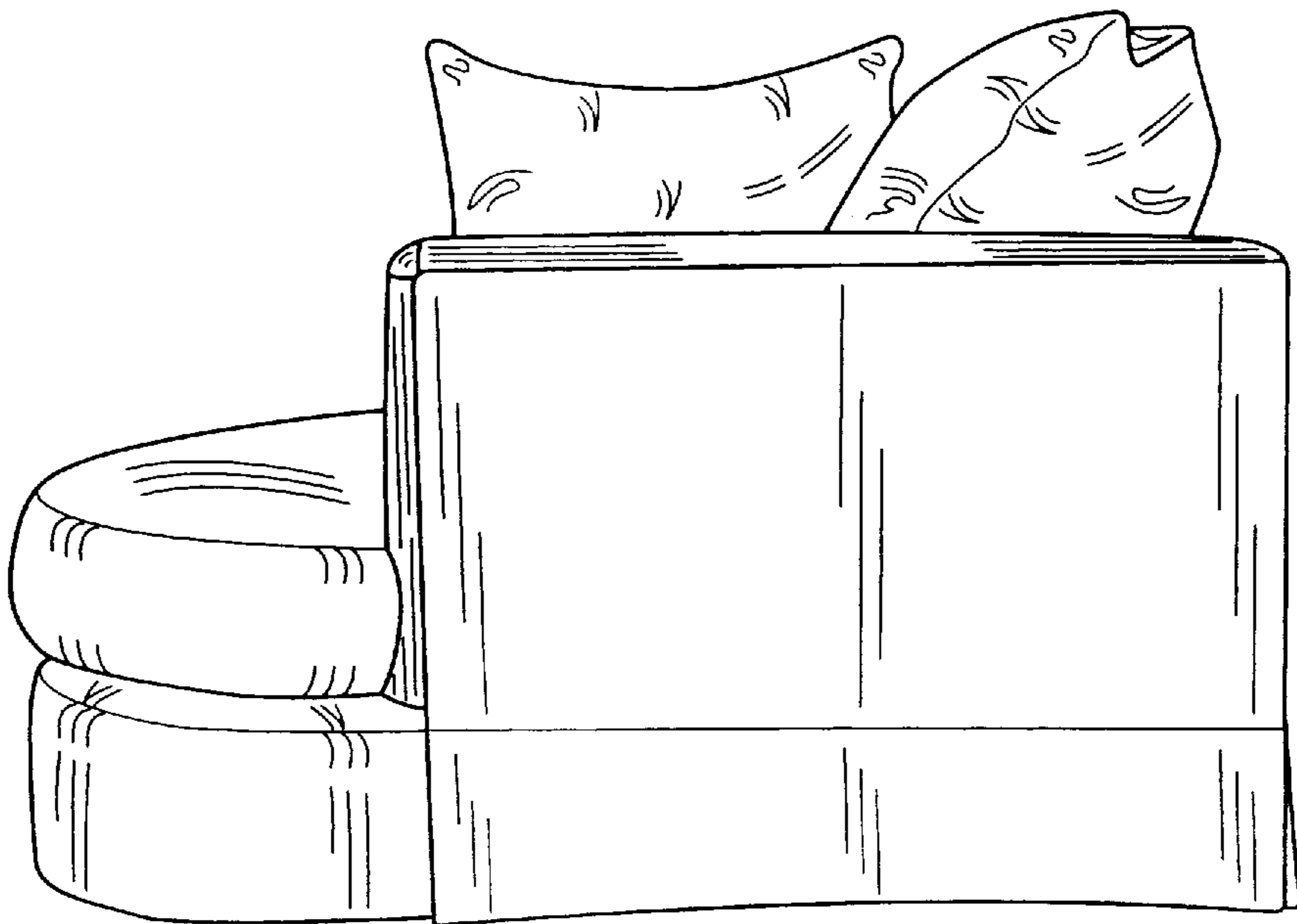

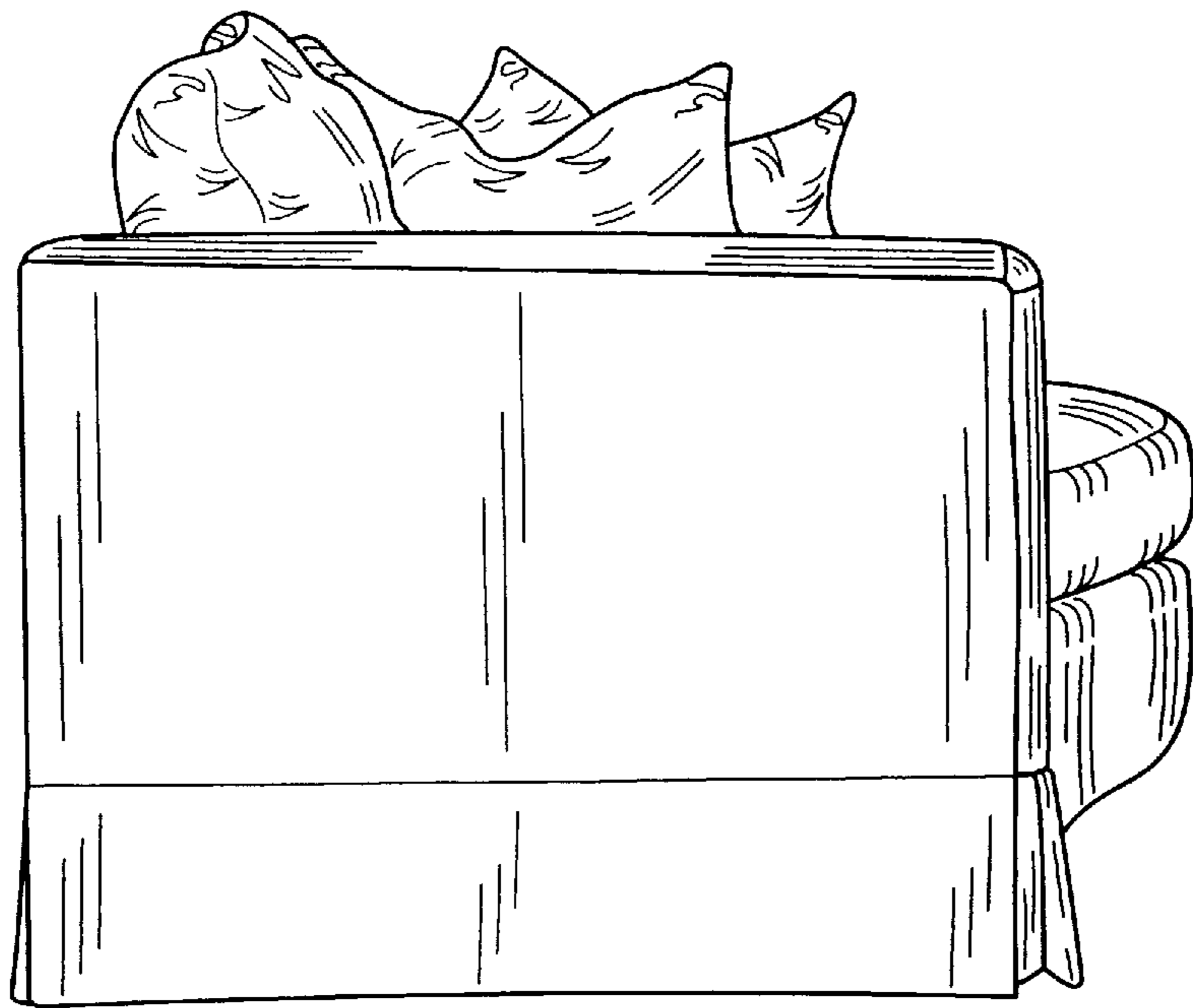

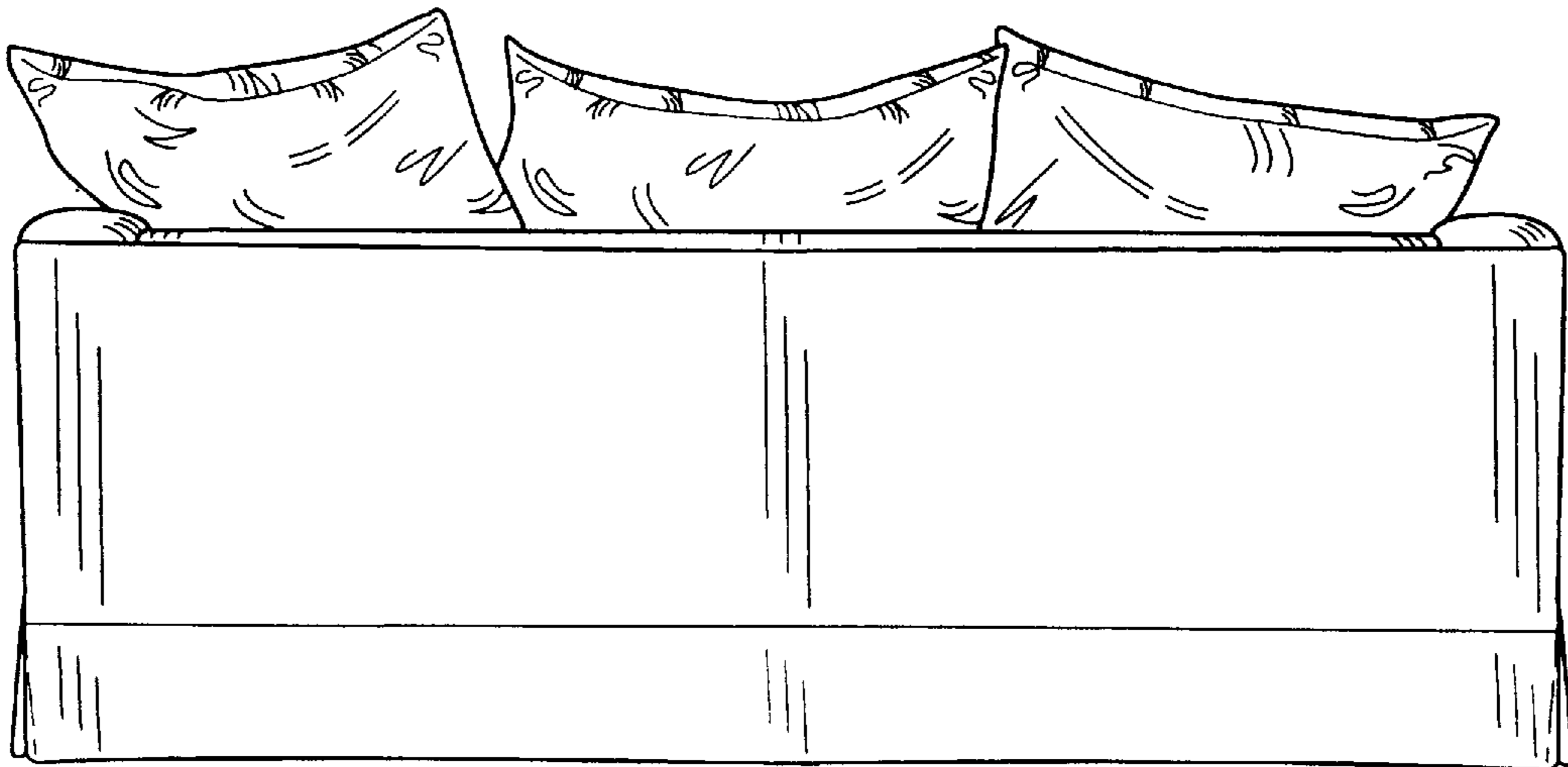

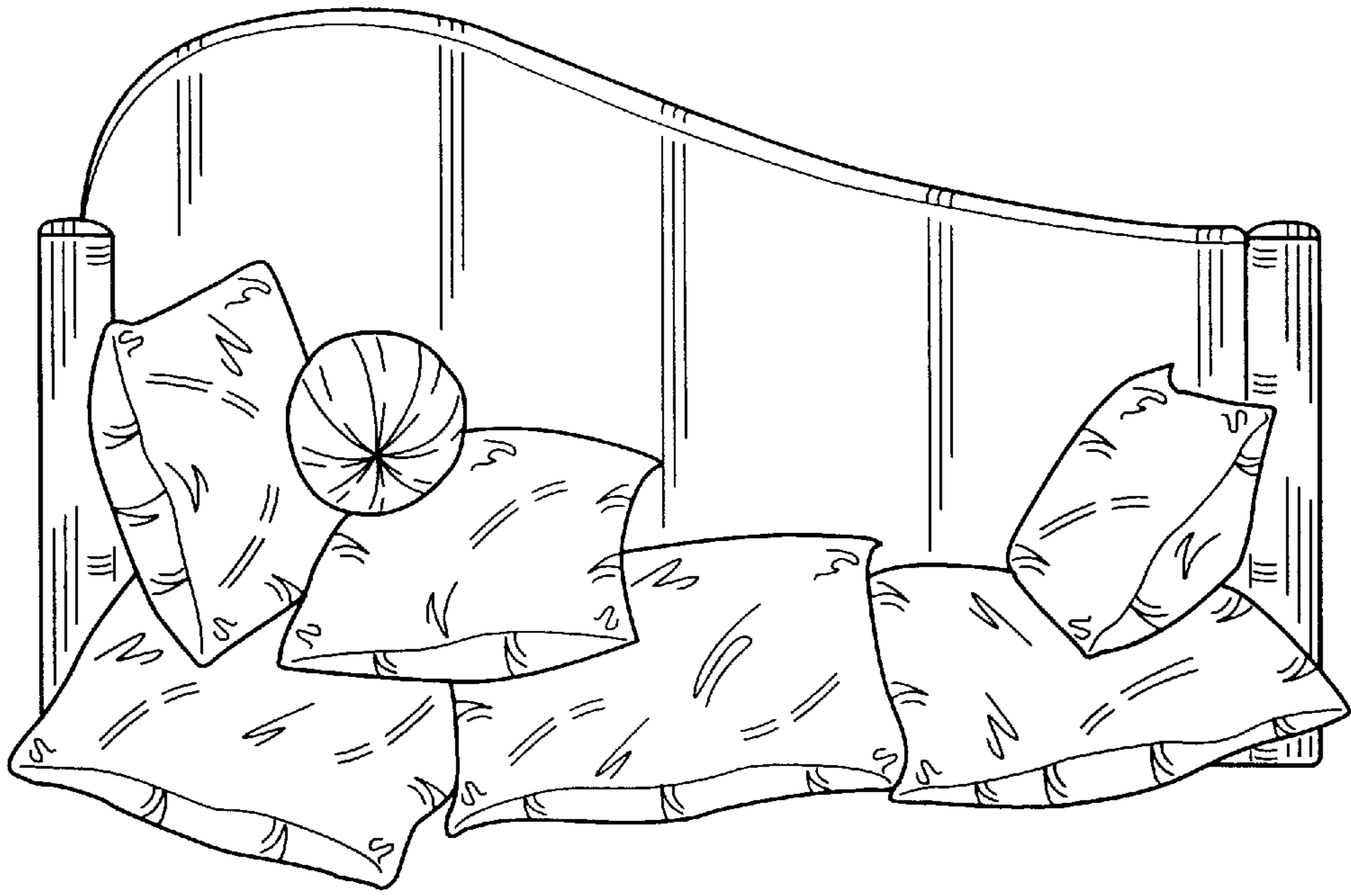

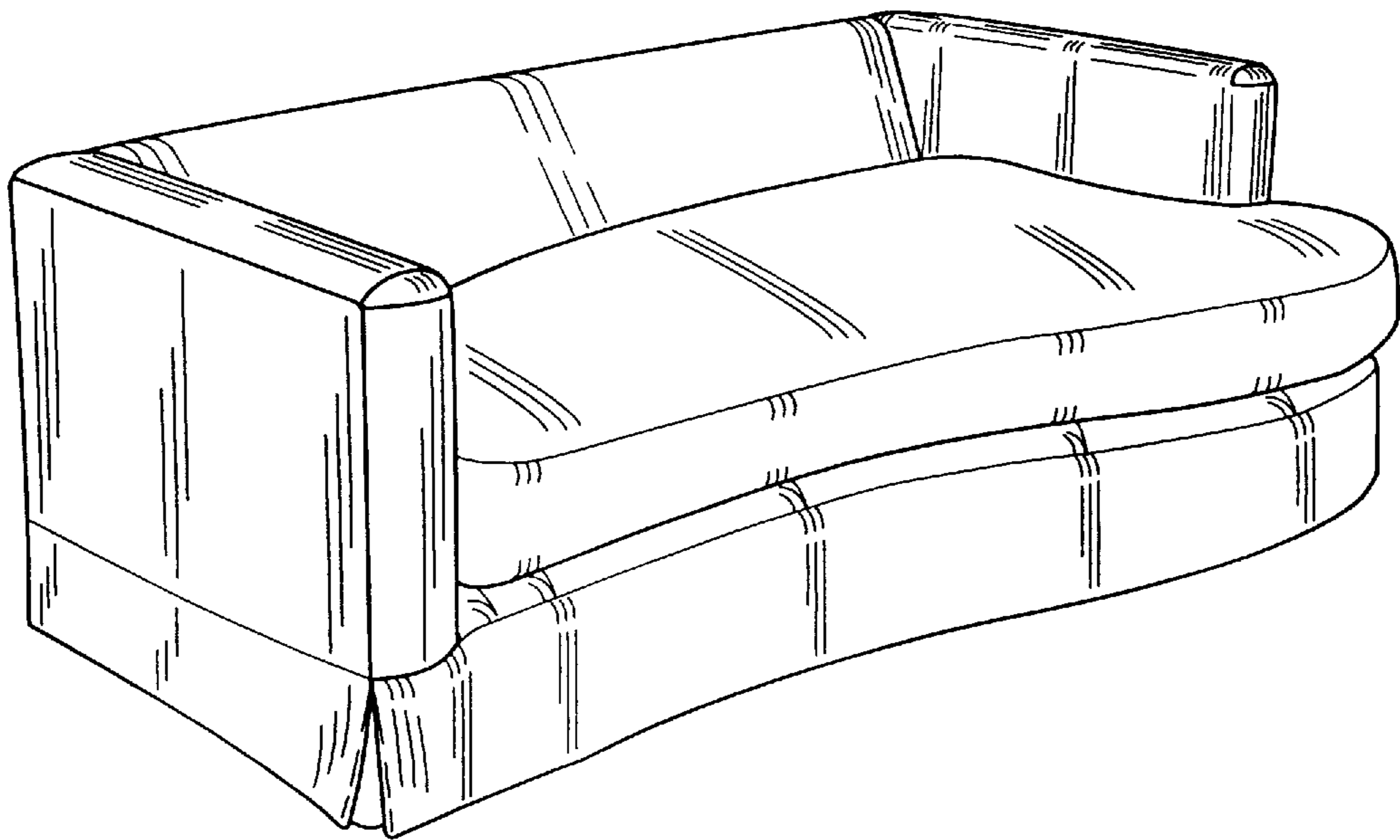

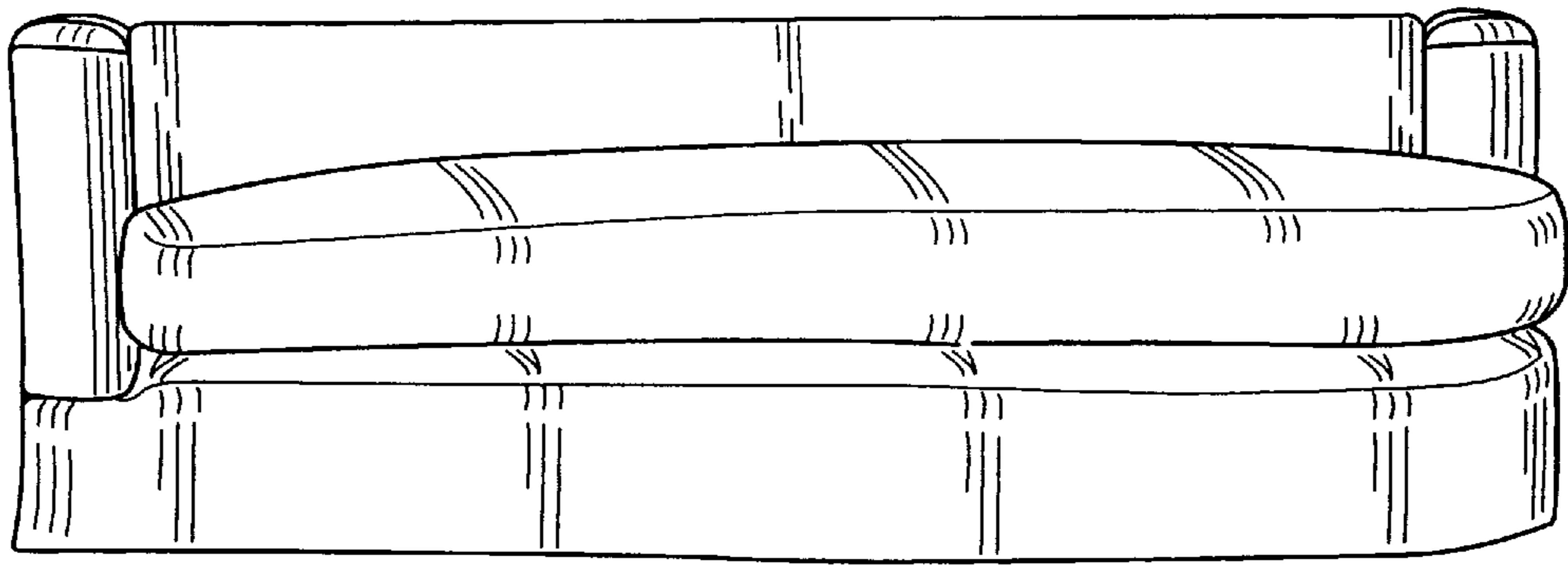

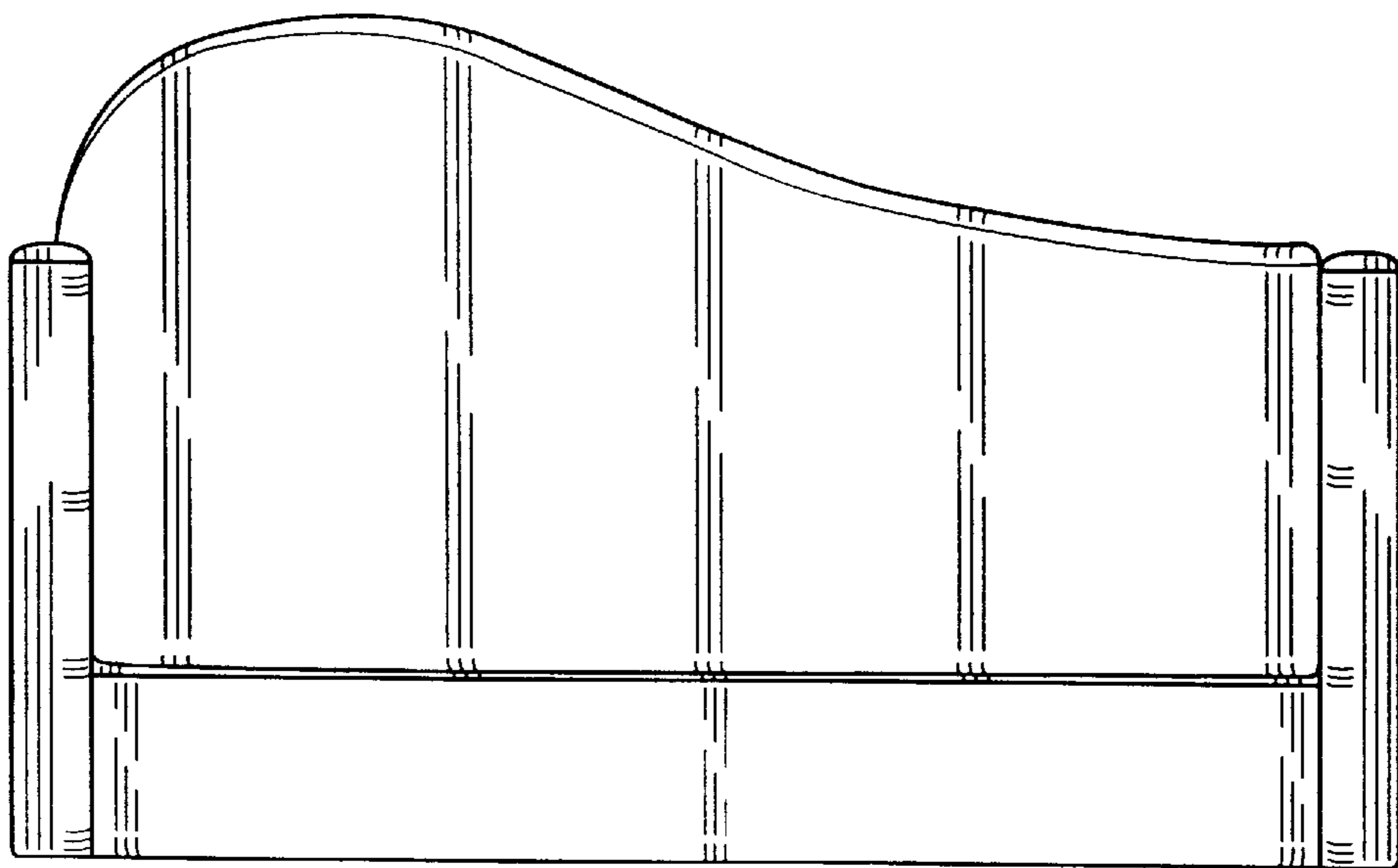

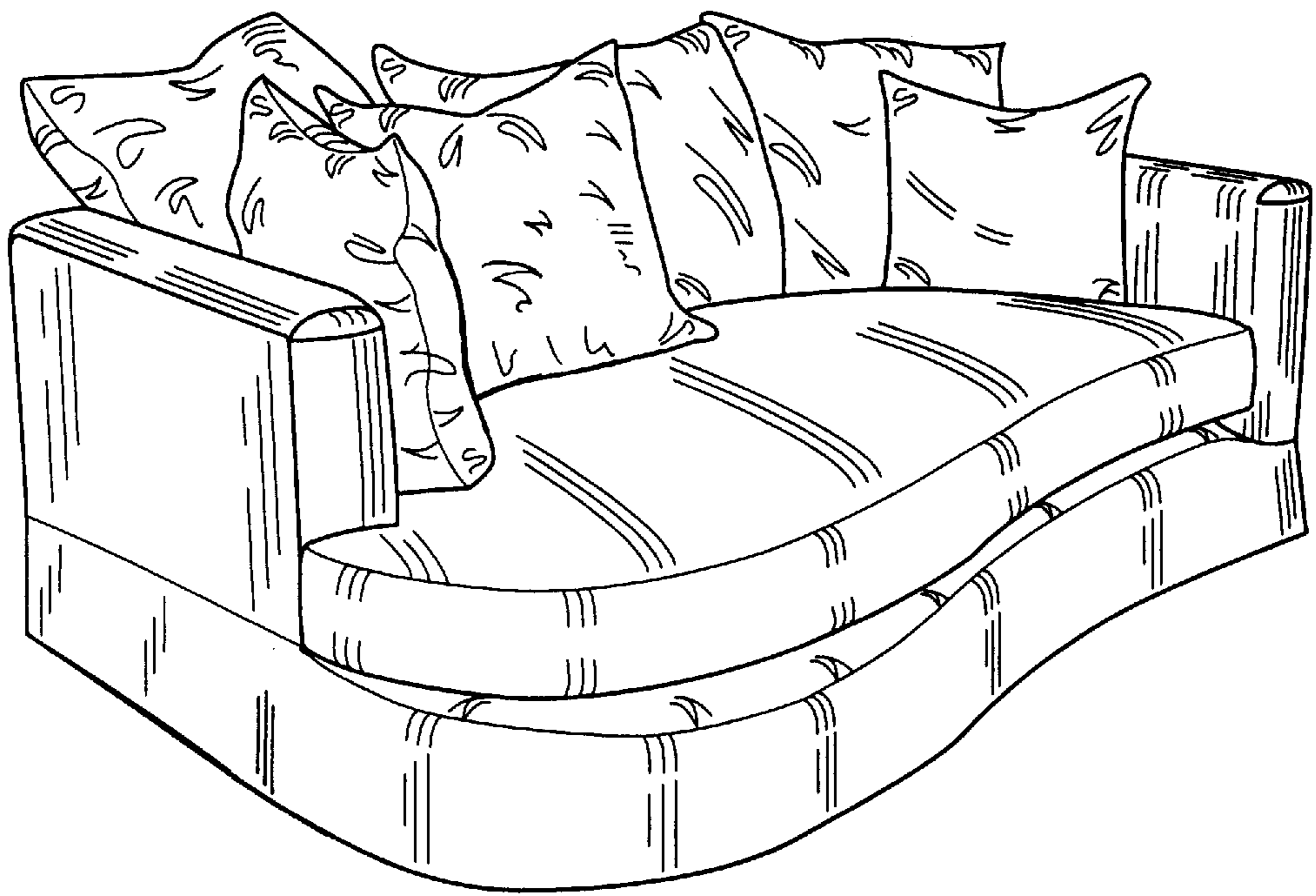
