[57] **CLAIM**

The ornamental design for a convoluted foam pad, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a convoluted foam pad of the present invention;

FIG. 2 shows a top planar view thereof;

FIG. 3 is a left side elevational view (the right side being the same);

FIG. 4 is a first end elevational view;

FIG. 5 is a second end elevational view;

FIG. 6 is a bottom plan view with intermediate section removed which illustrates an indeterminate length (or width) feature of the present invention;

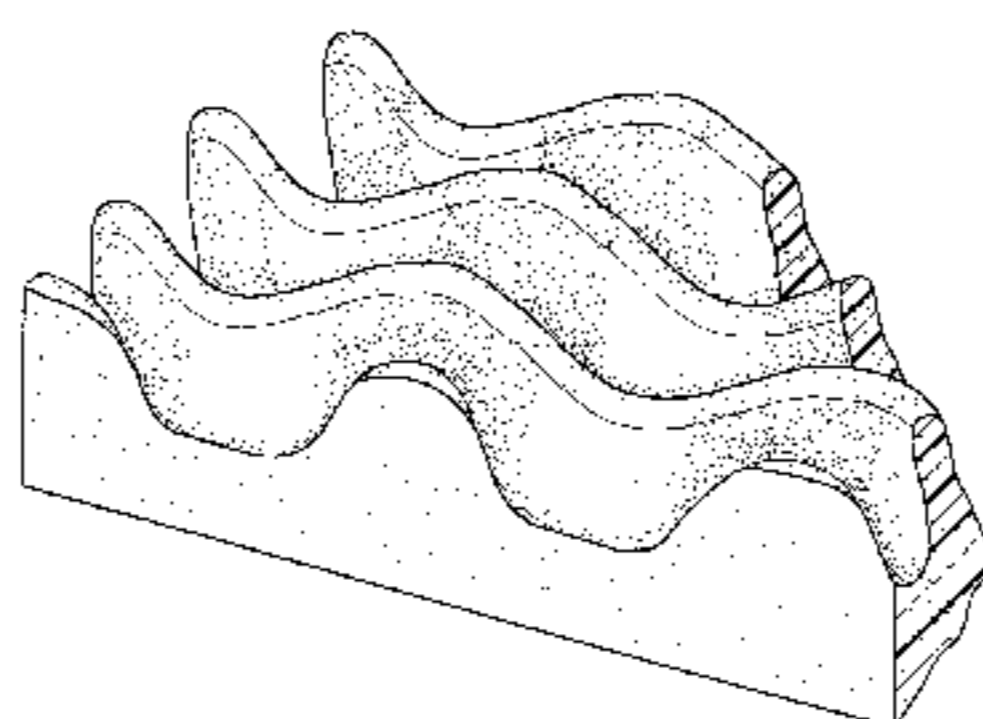
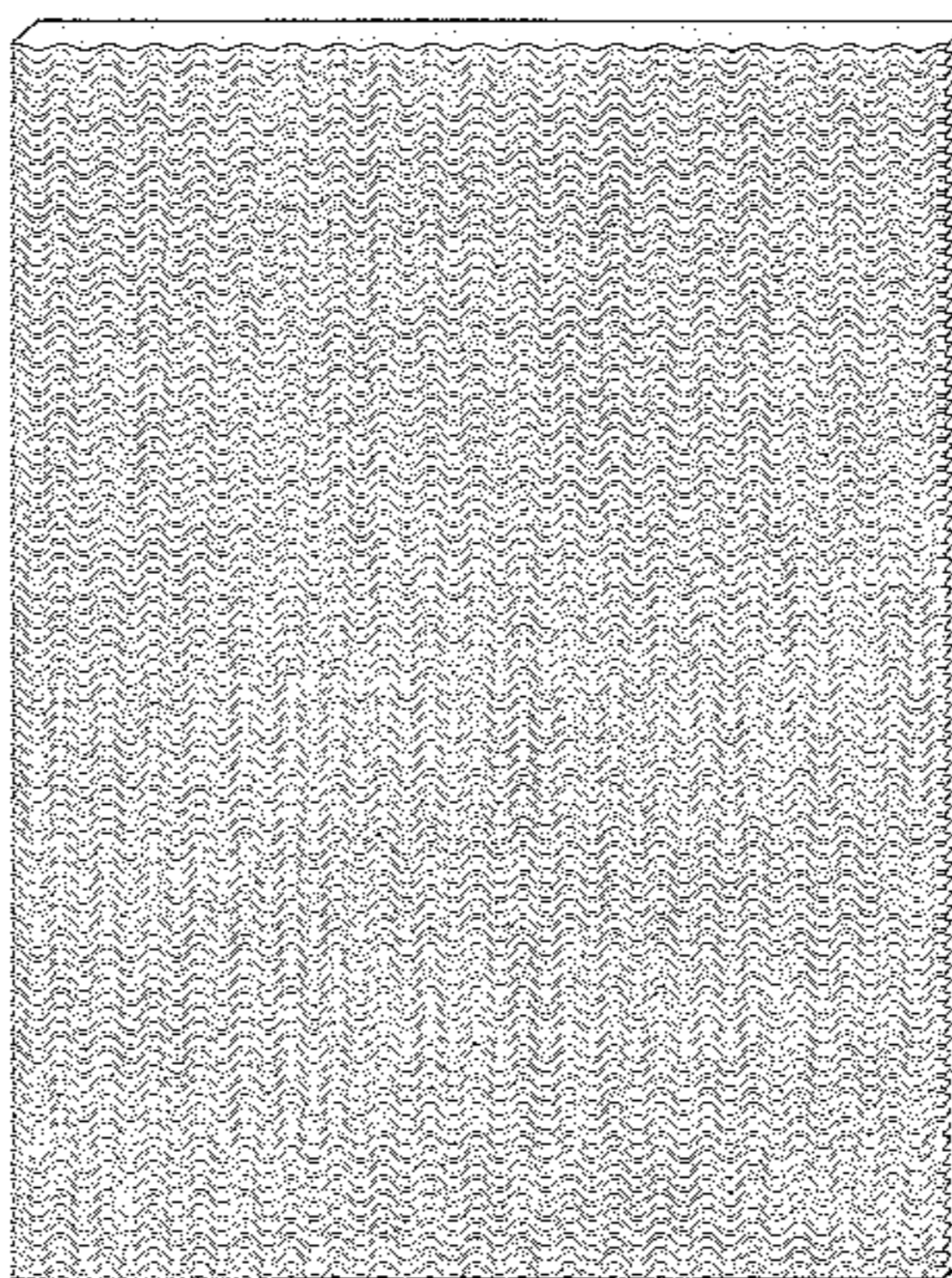
FIG. 7 is an enlarged, cut-away view of the lower left hand corner of FIG. 2;

FIG. 8 shows an enlarged, cut-away view of that which is shown in FIG. 3;

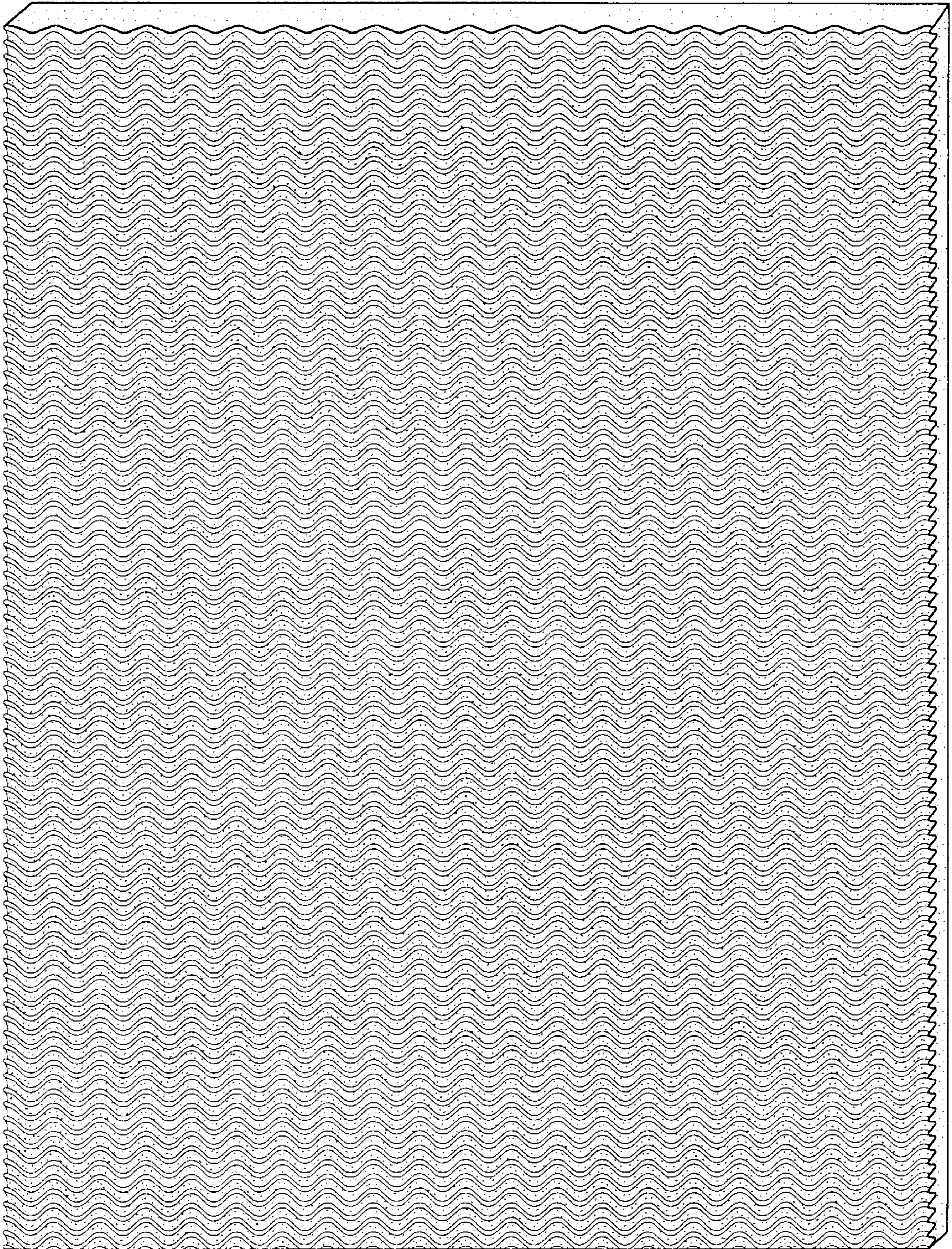

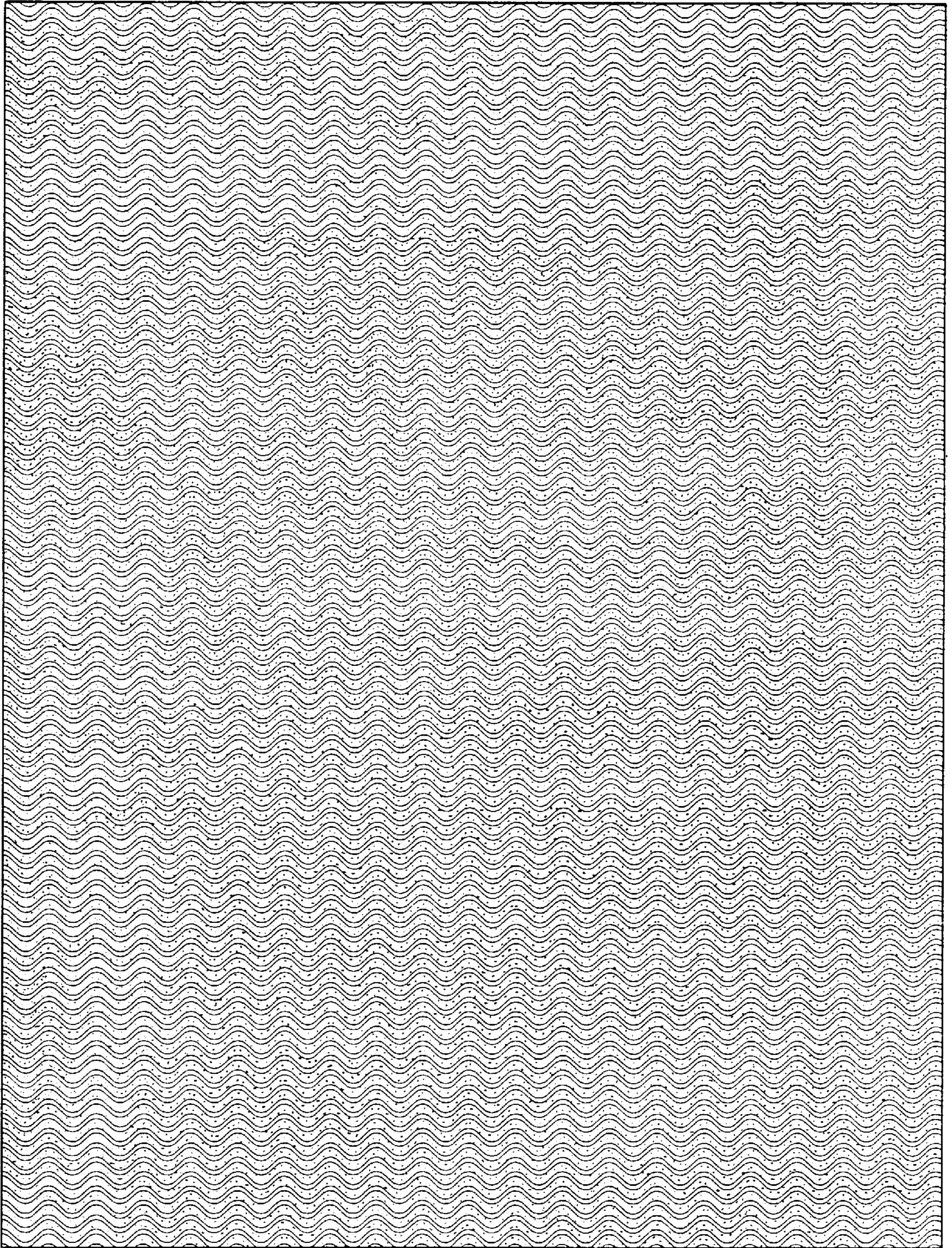

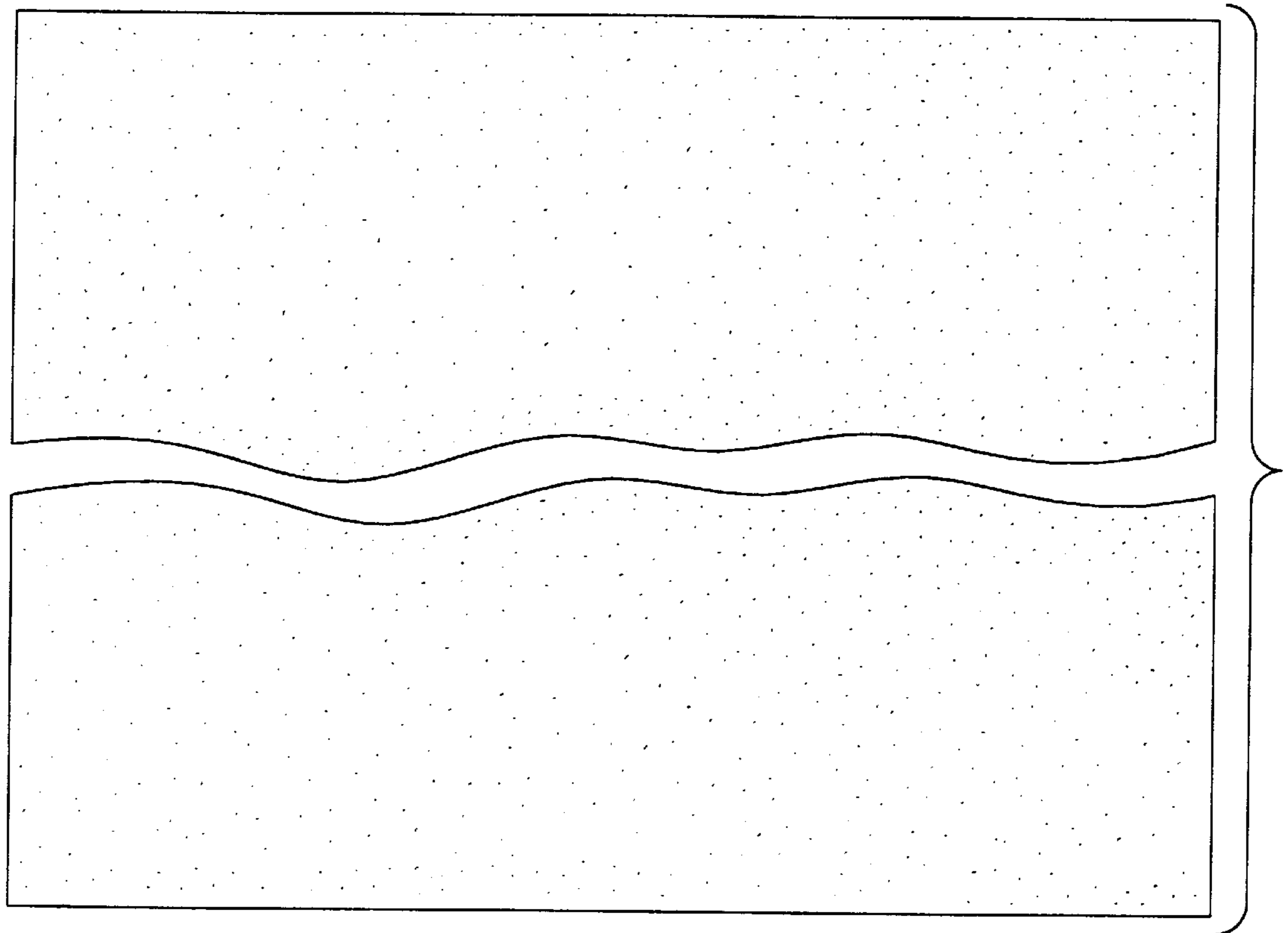

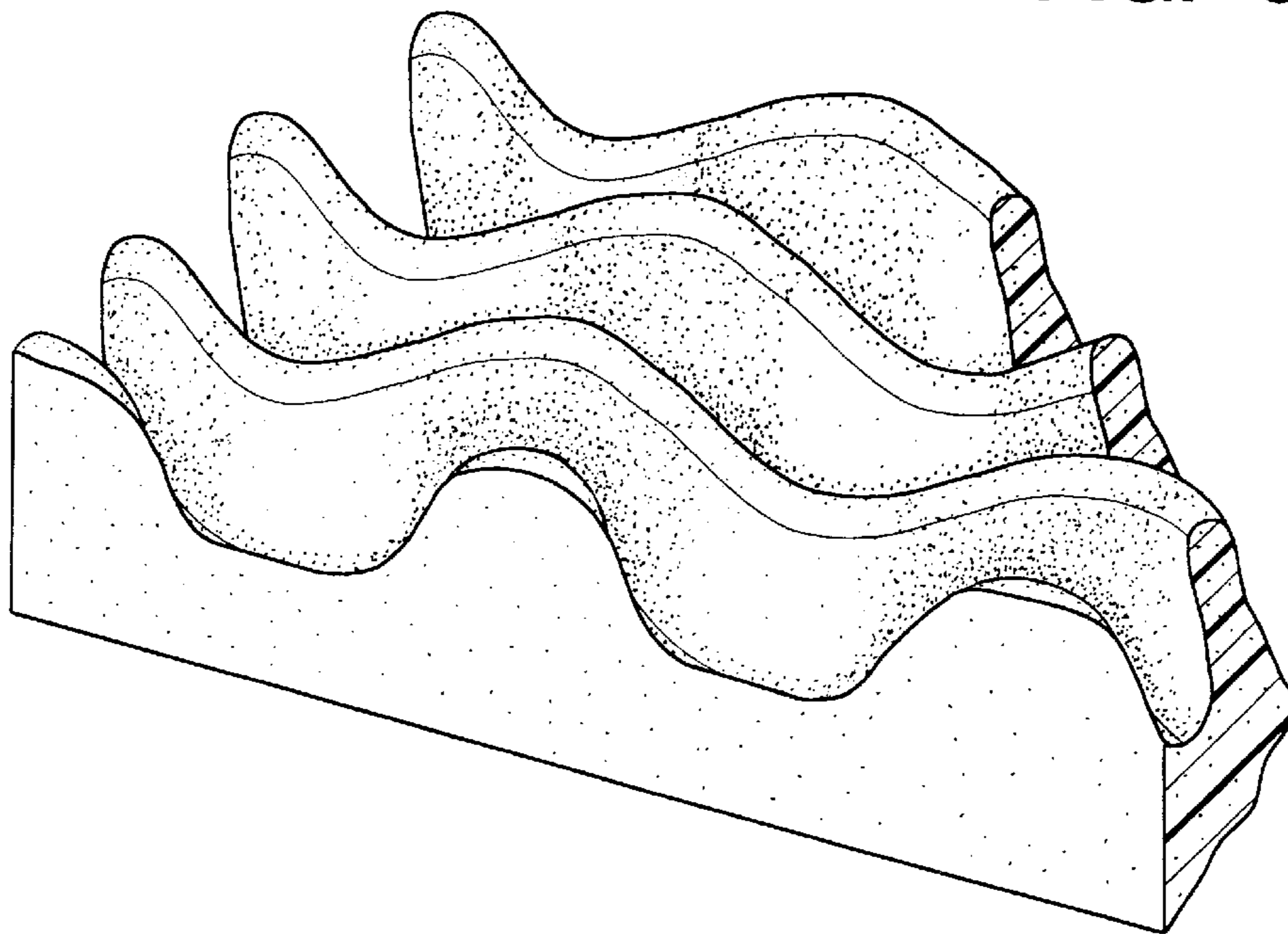

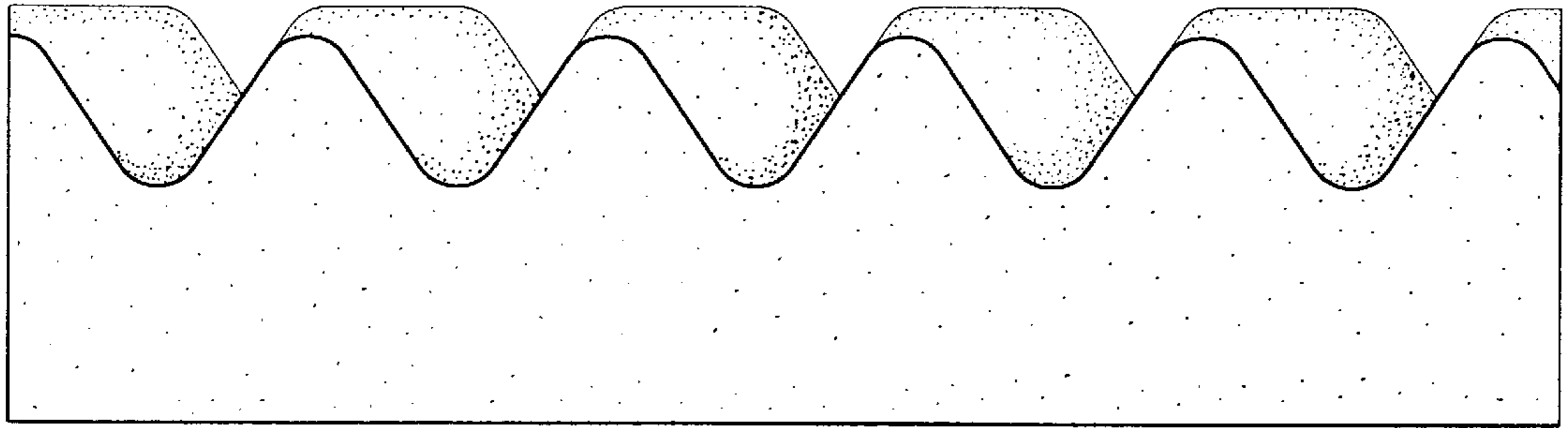

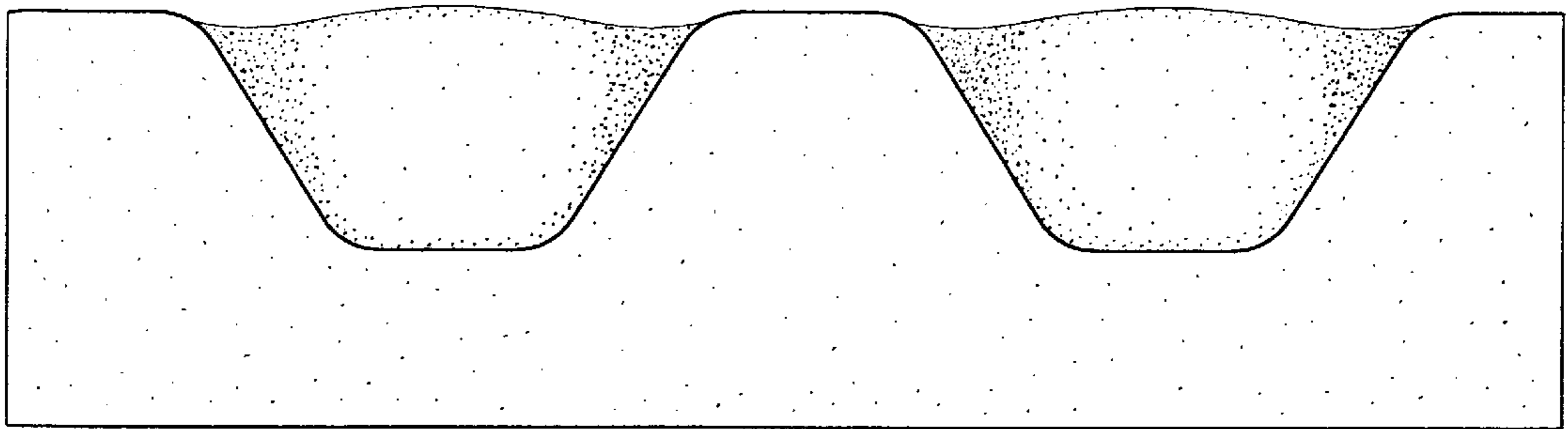

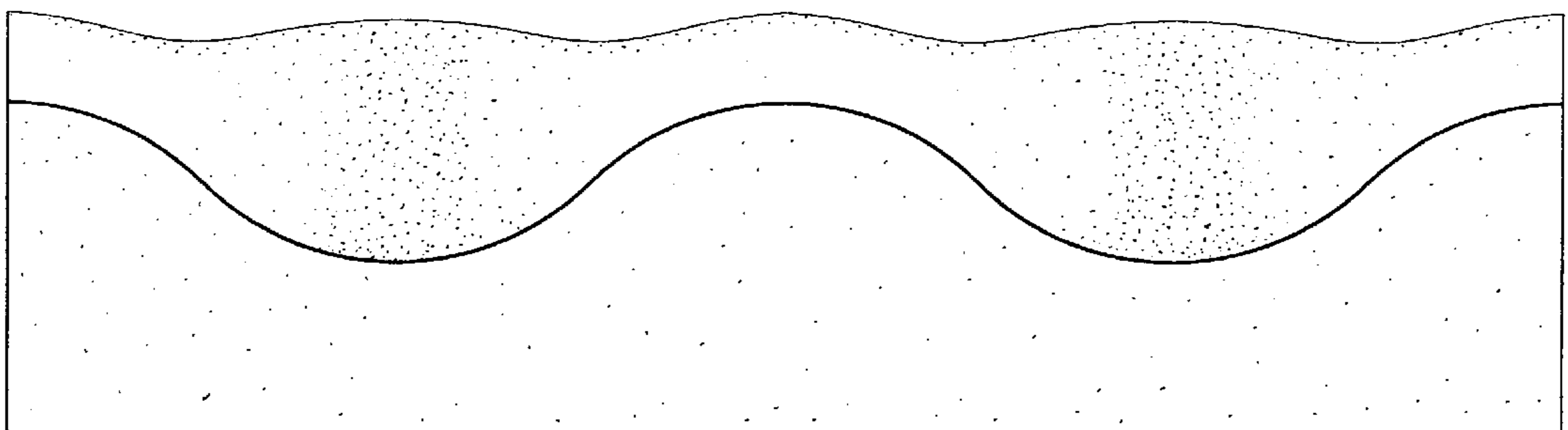
