The ornamental design for a flatware handle, as shown and described.

DESCRIPTION

FIG. 1 is a front side elevational view of a flatware handle

showing my new design and showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a left side elevational view of the flatware handle, showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design;

FIG. 3 is a rear side elevational view of the flatware handle, showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design;

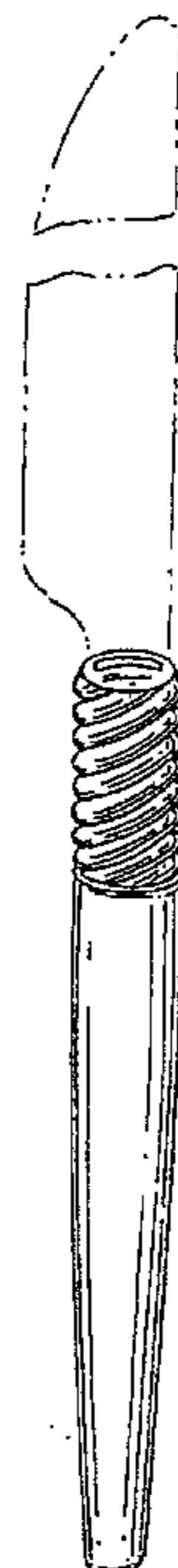

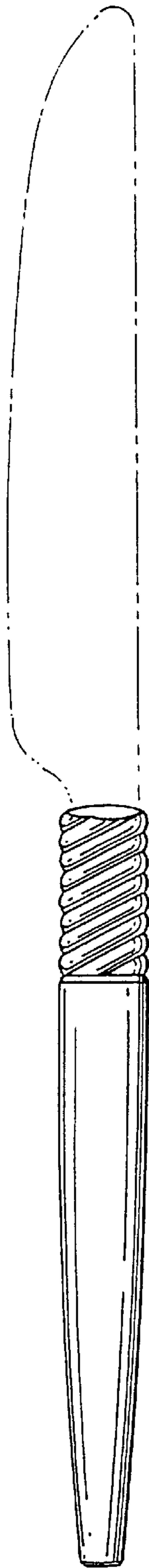

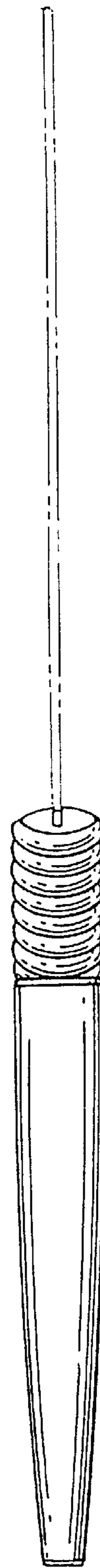

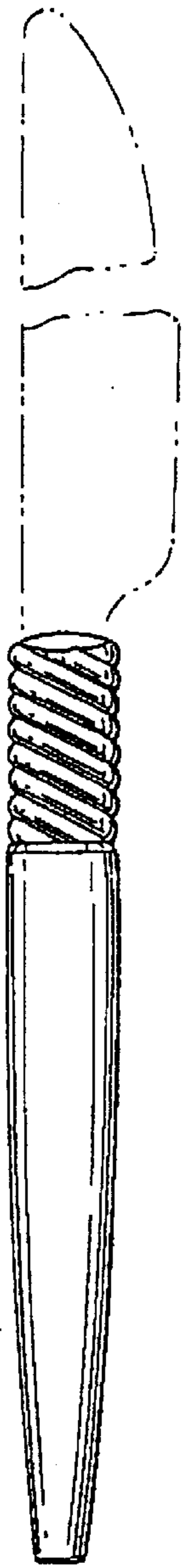

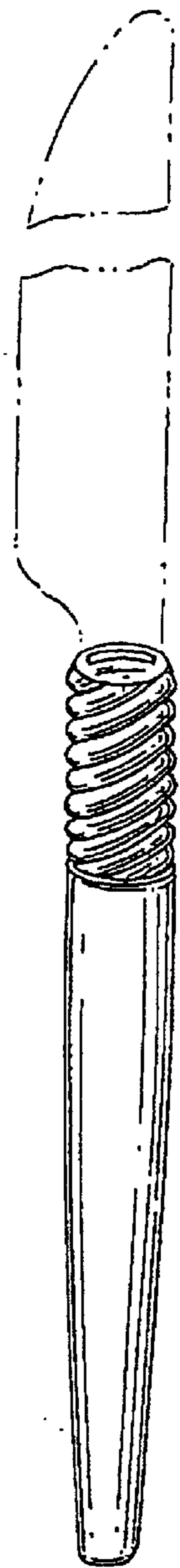

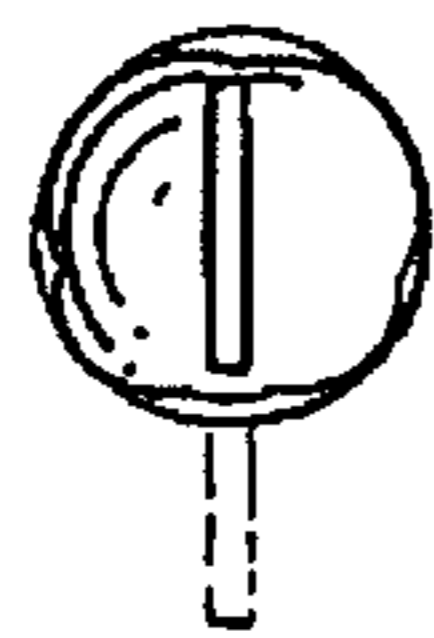
