The ornamental design for a welding gun handle and housing, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a welding gun handle and housing showing our new design, the broken lines are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a front elevational view thereof;

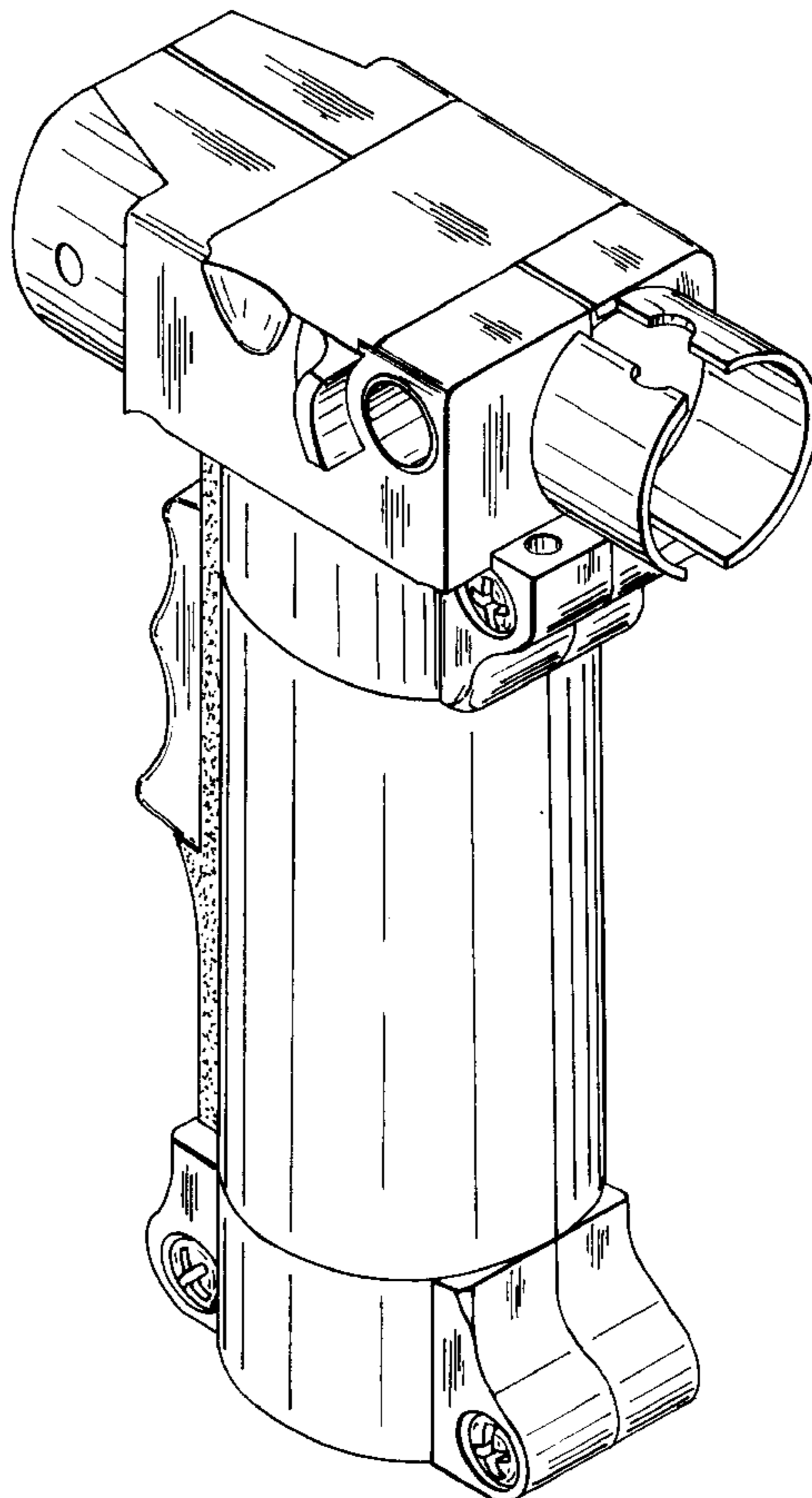

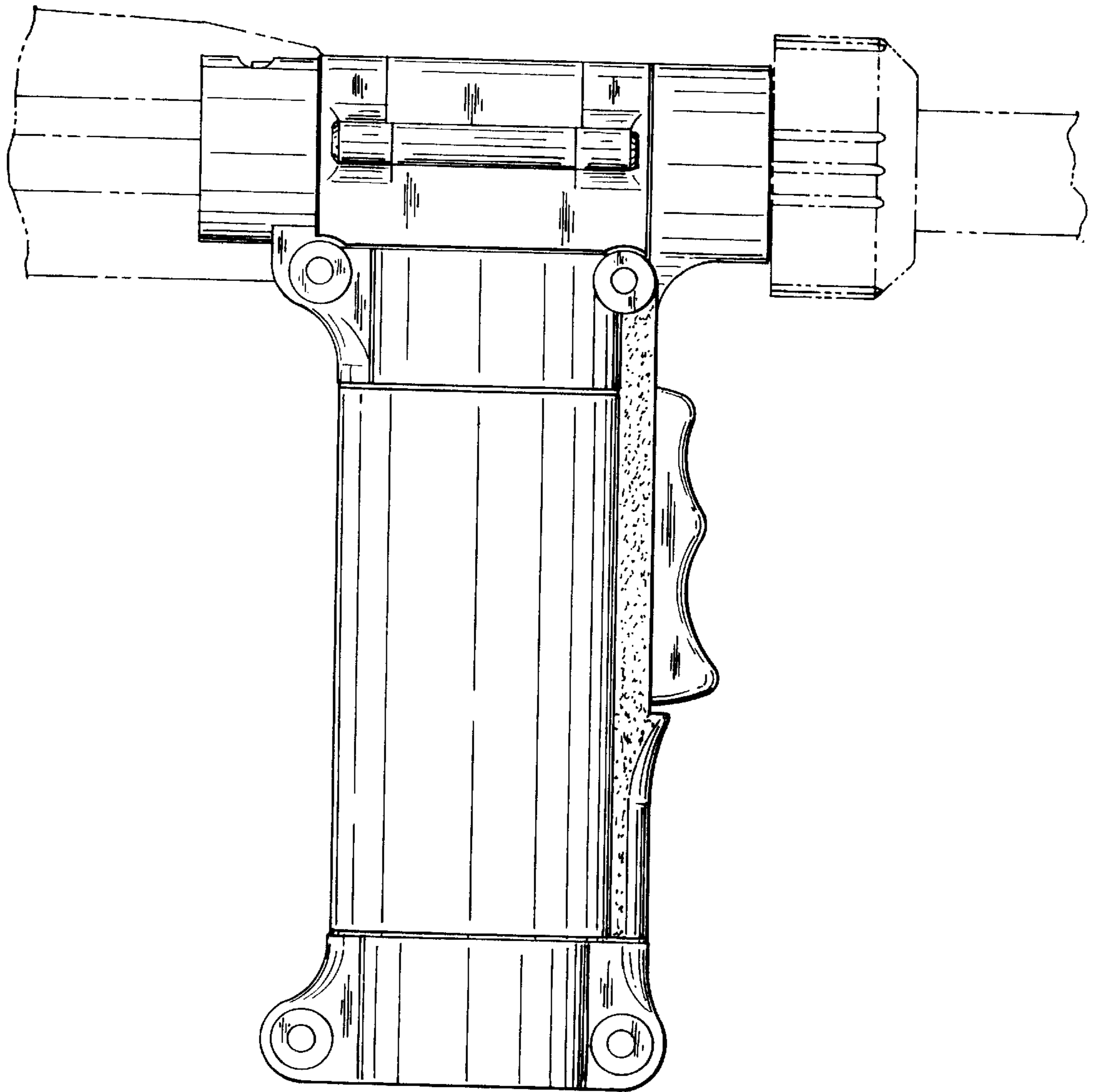

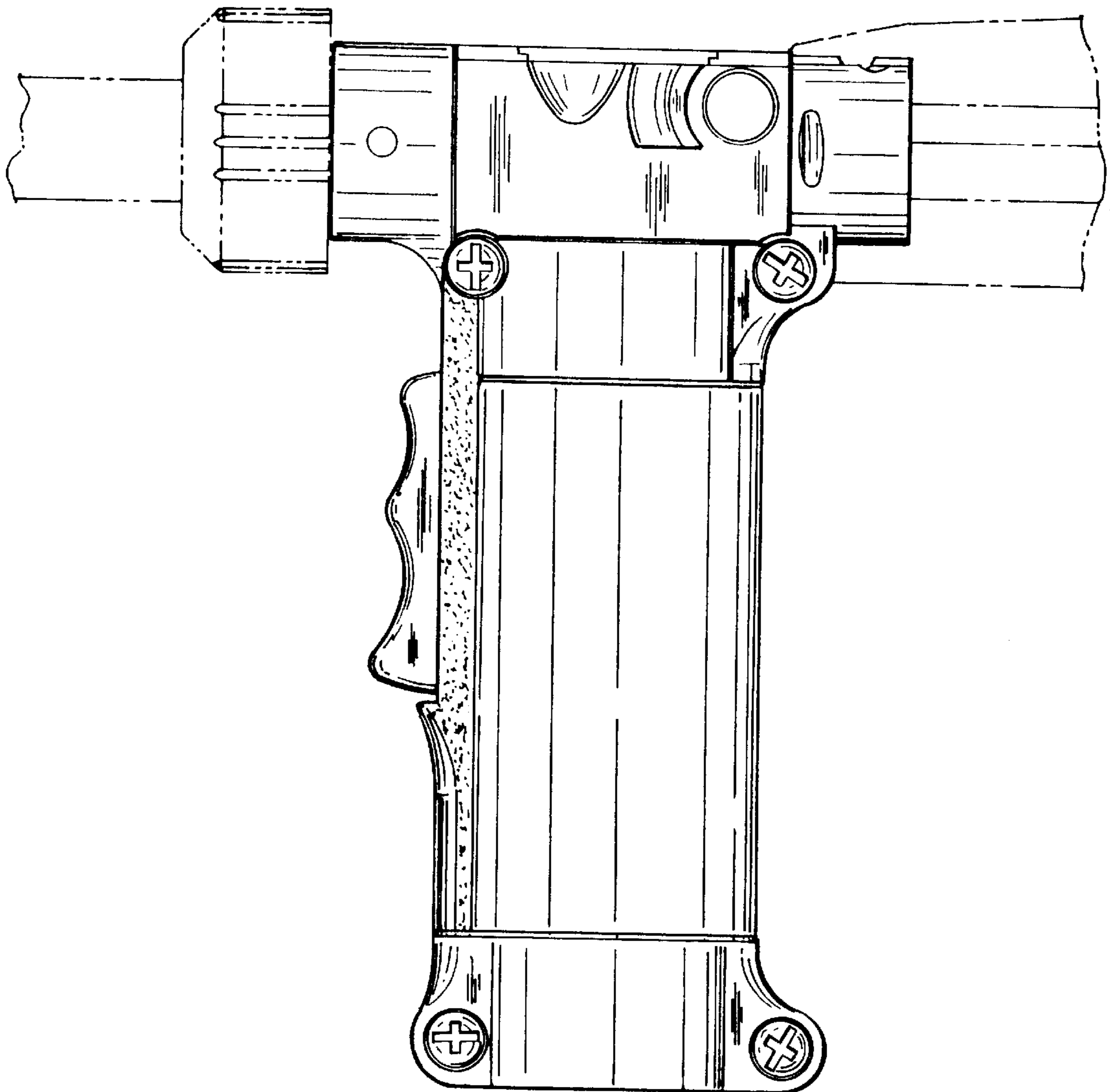

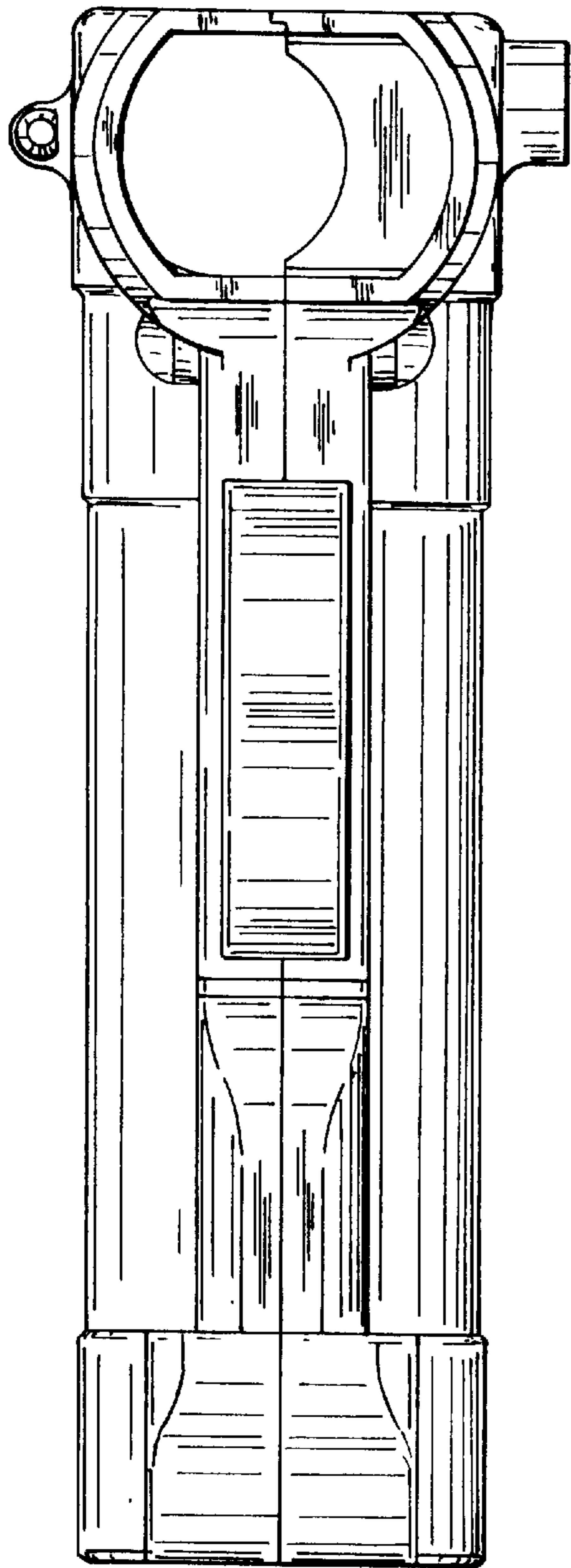

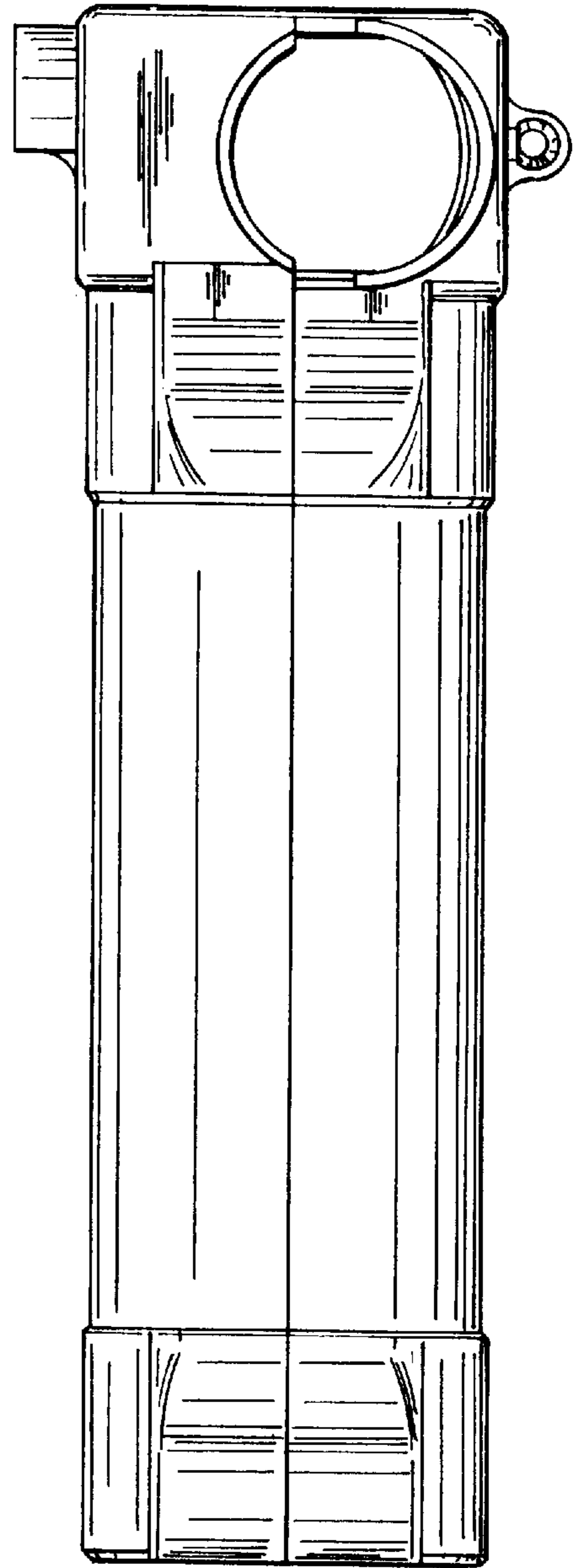

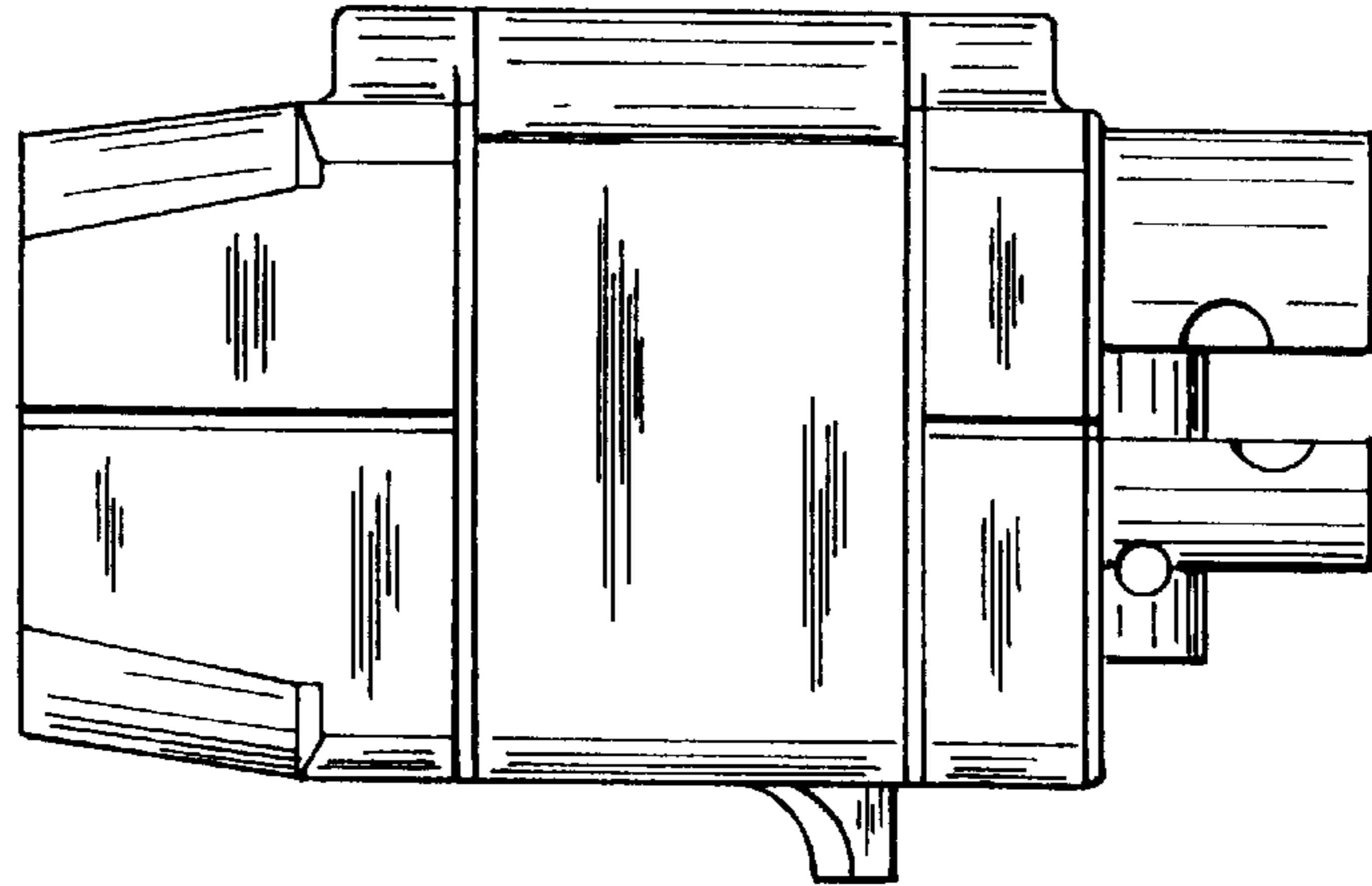

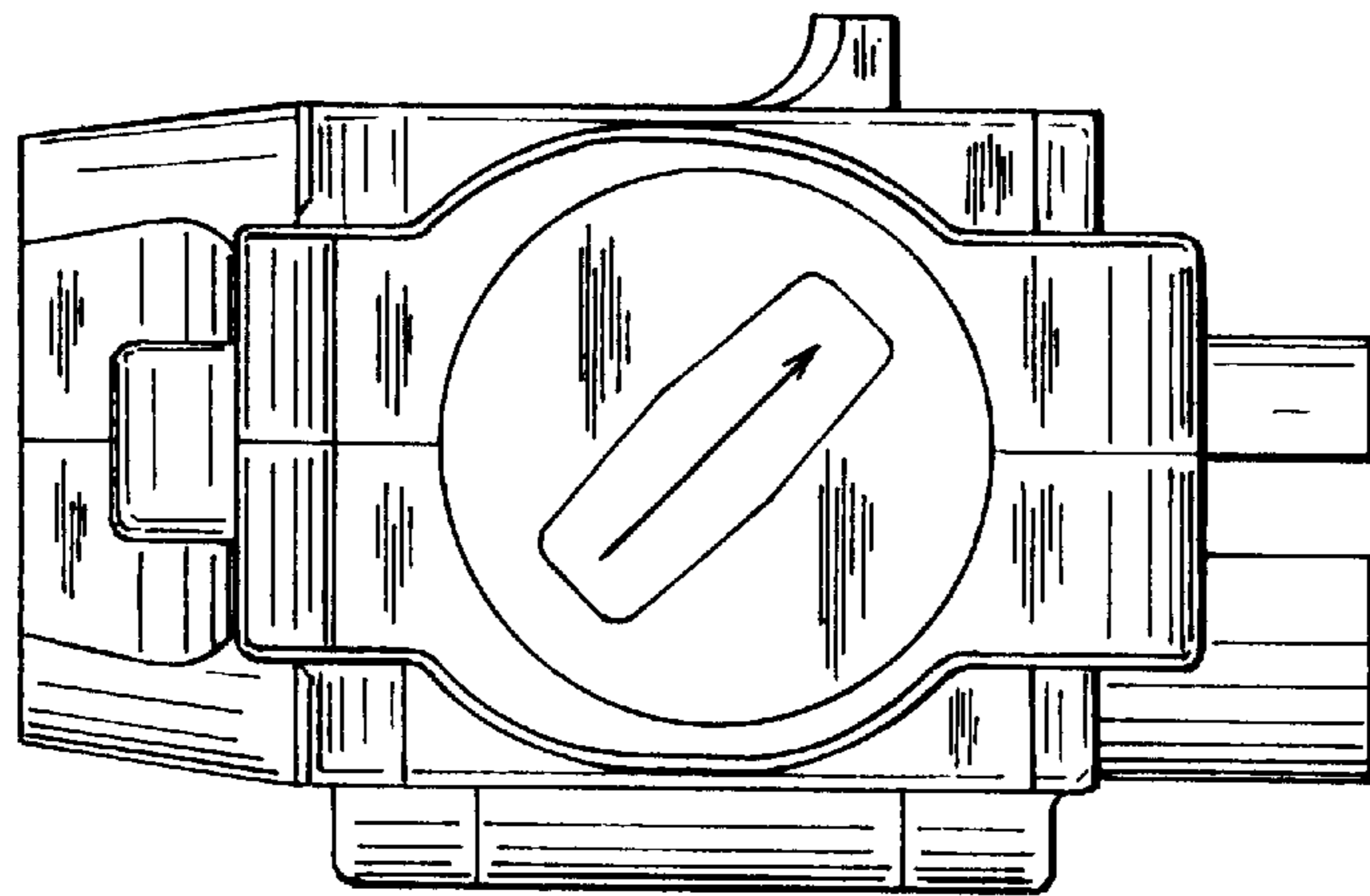
