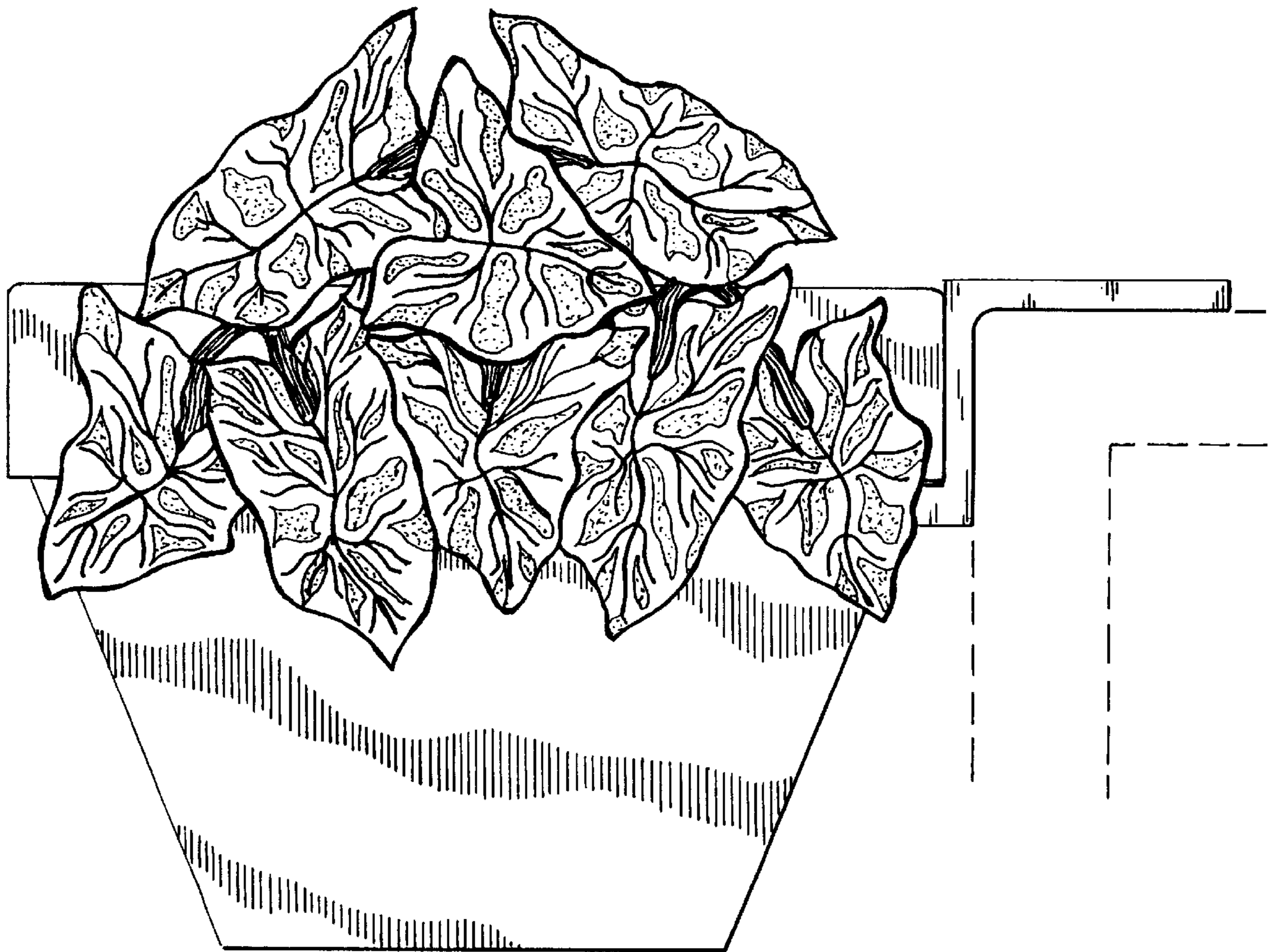
The fragmentary portion of a computer monitor depicted by means of broken lines in FIG. 1 has been shown for illustrative purposes only and forms no part of the claimed design.

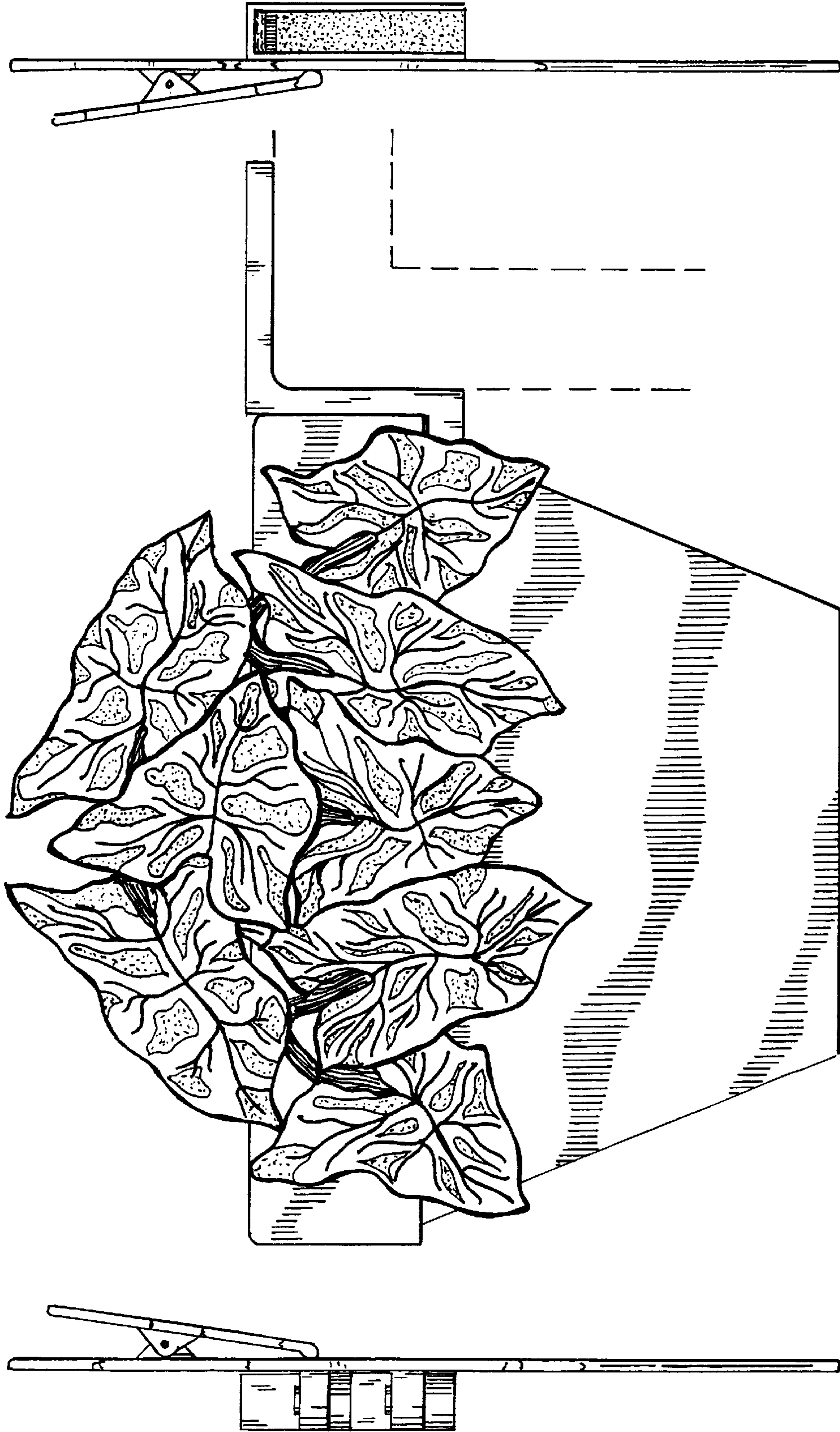

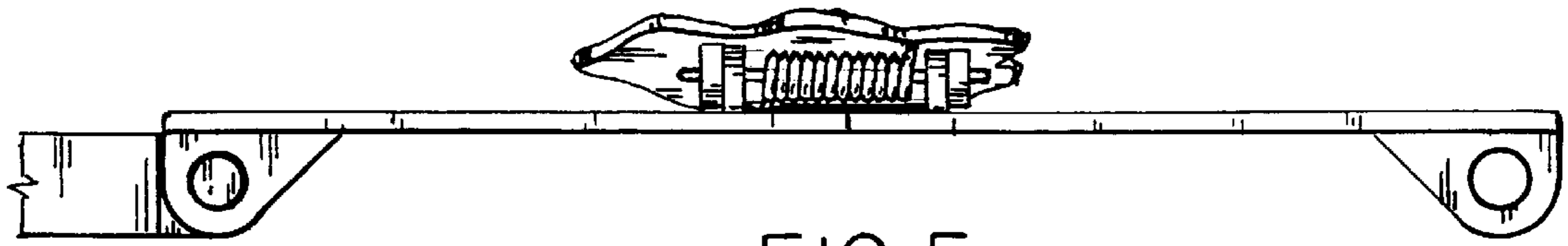

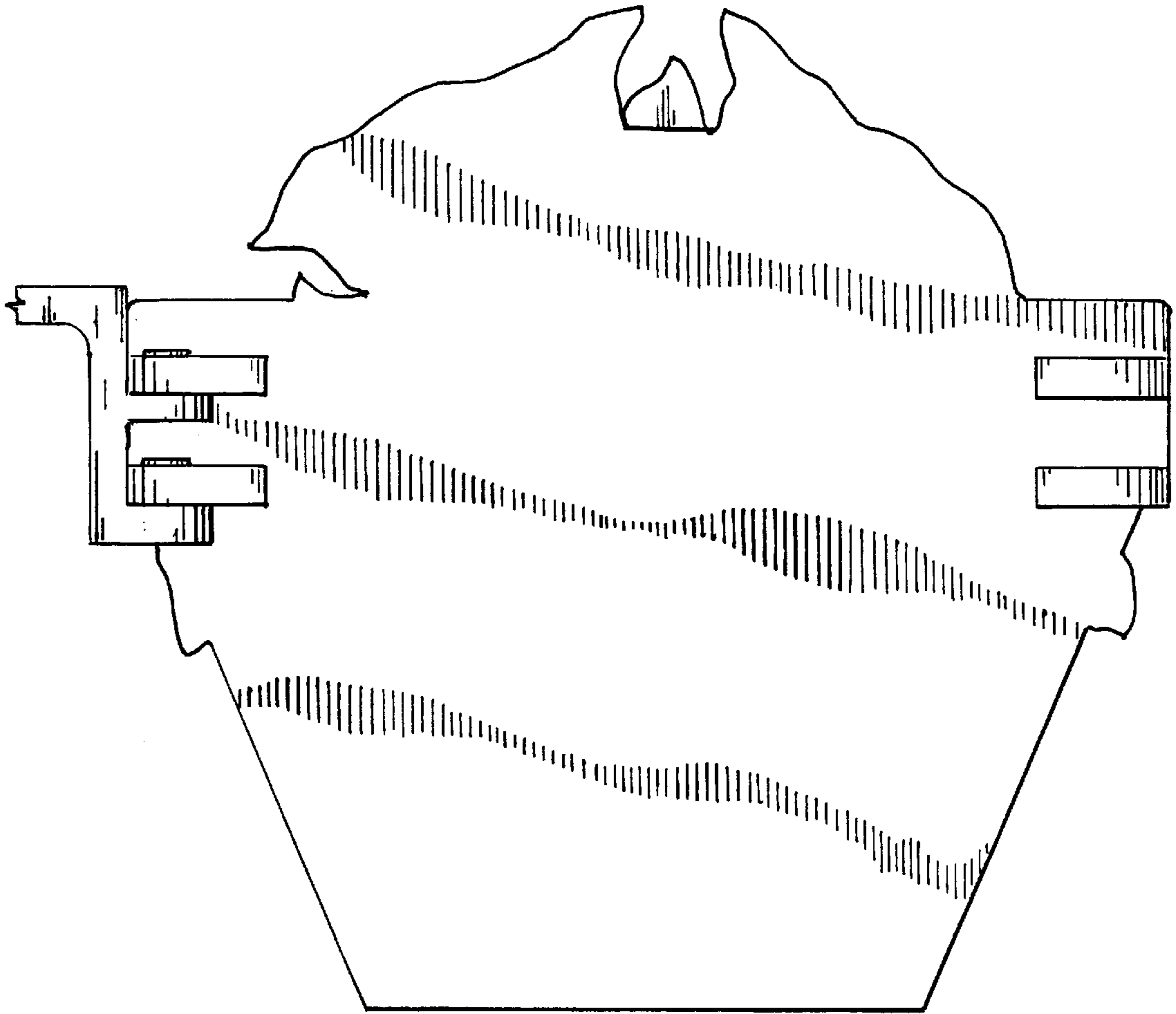

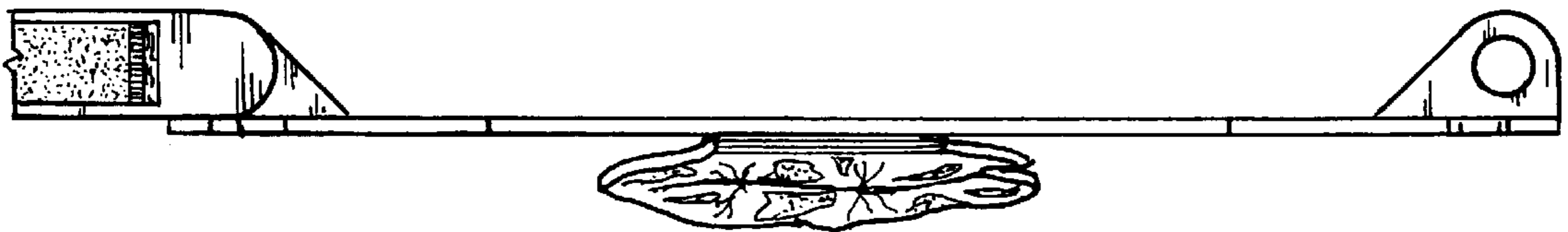
