[57] **CLAIM**

The ornamental design for a tablet, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a tablet showing our new design; FIG. 2 is a side elevational view thereof, the undisclosed side being a mirror image; FIG. 3 is a front elevational view thereof, the undisclosed rear being a mirror image; FIG. 4 is a bottom plan view thereof; FIG. 5 is a top plan view of a tablet showing a second embodiment of FIG. 1; FIG. 6 is a side elevational view thereof, the undisclosed side being a mirror image; FIG. 7 is a front elevational view thereof, the undisclosed rear being a mirror image; and, FIG. 8 is a bottom plan view thereof.

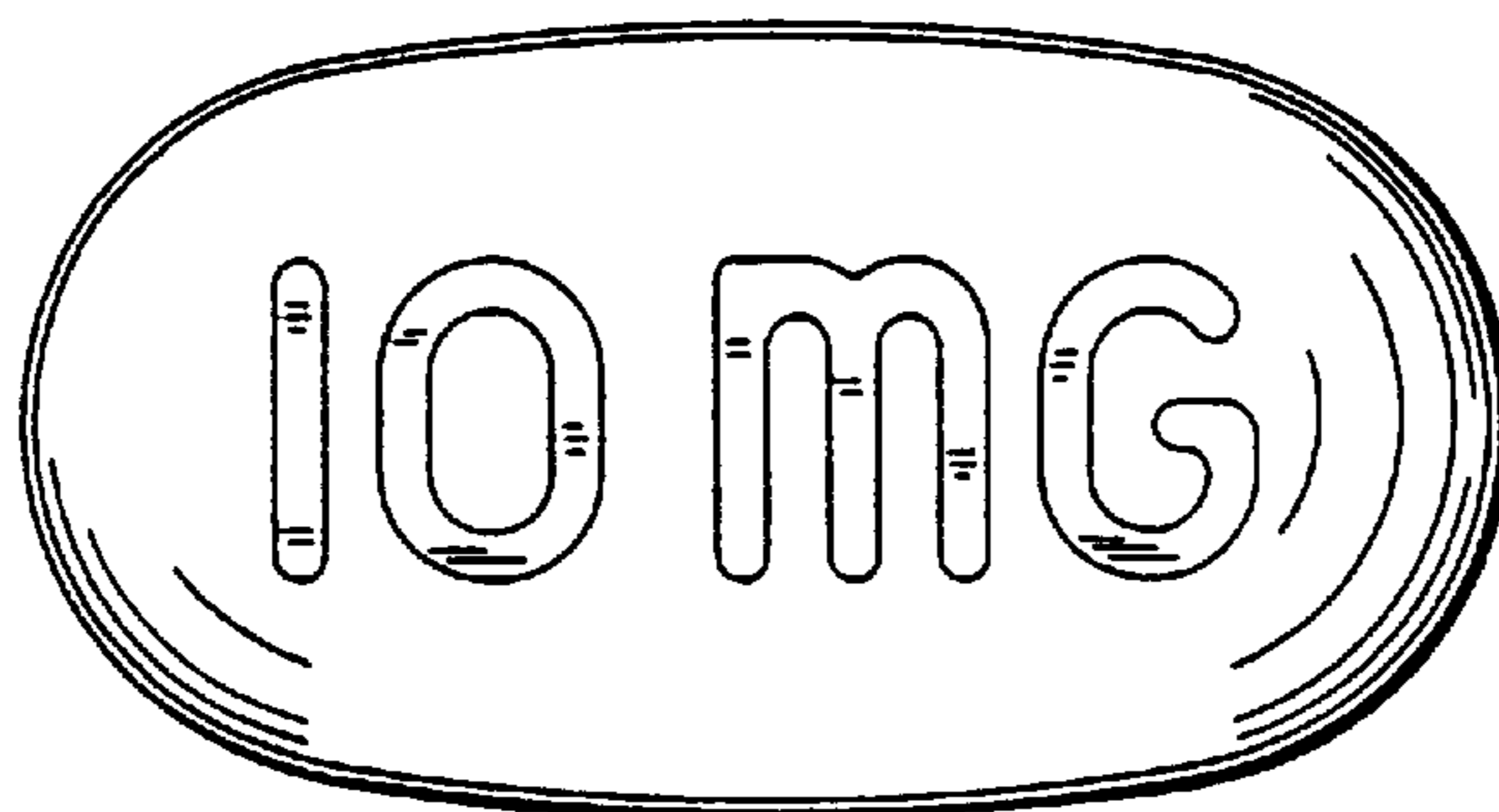

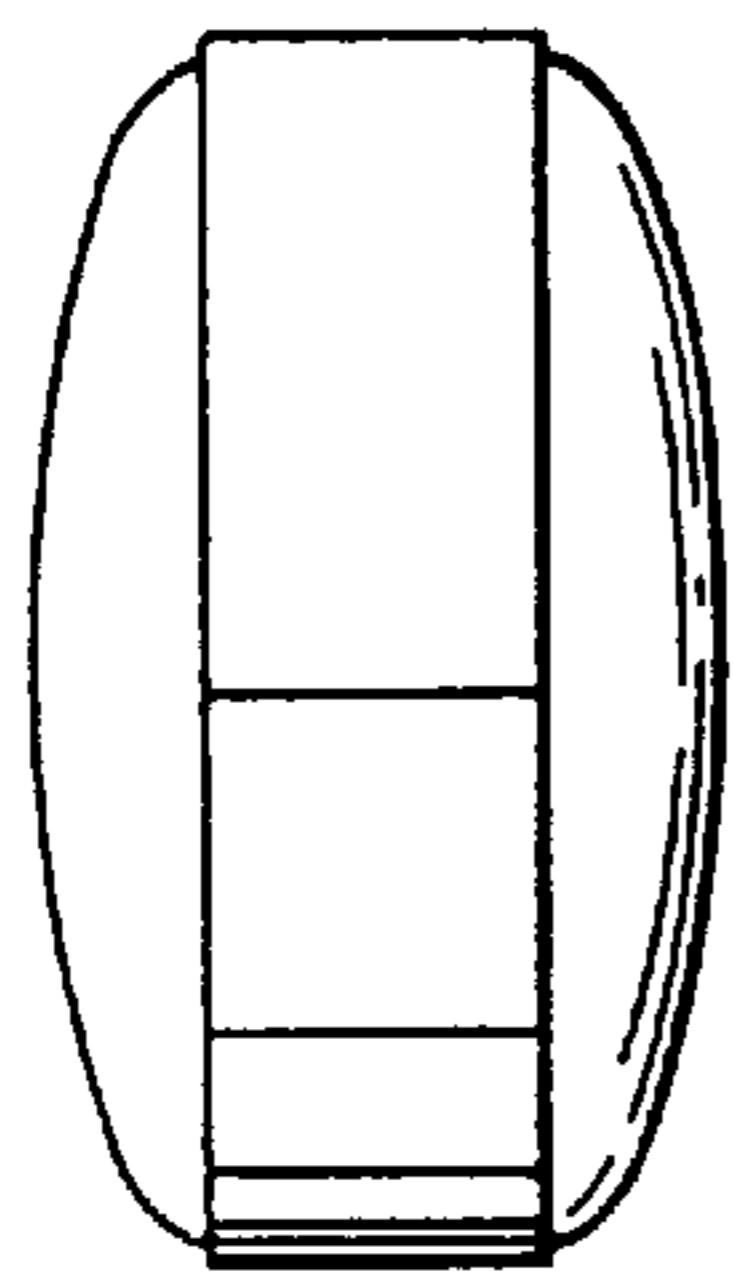

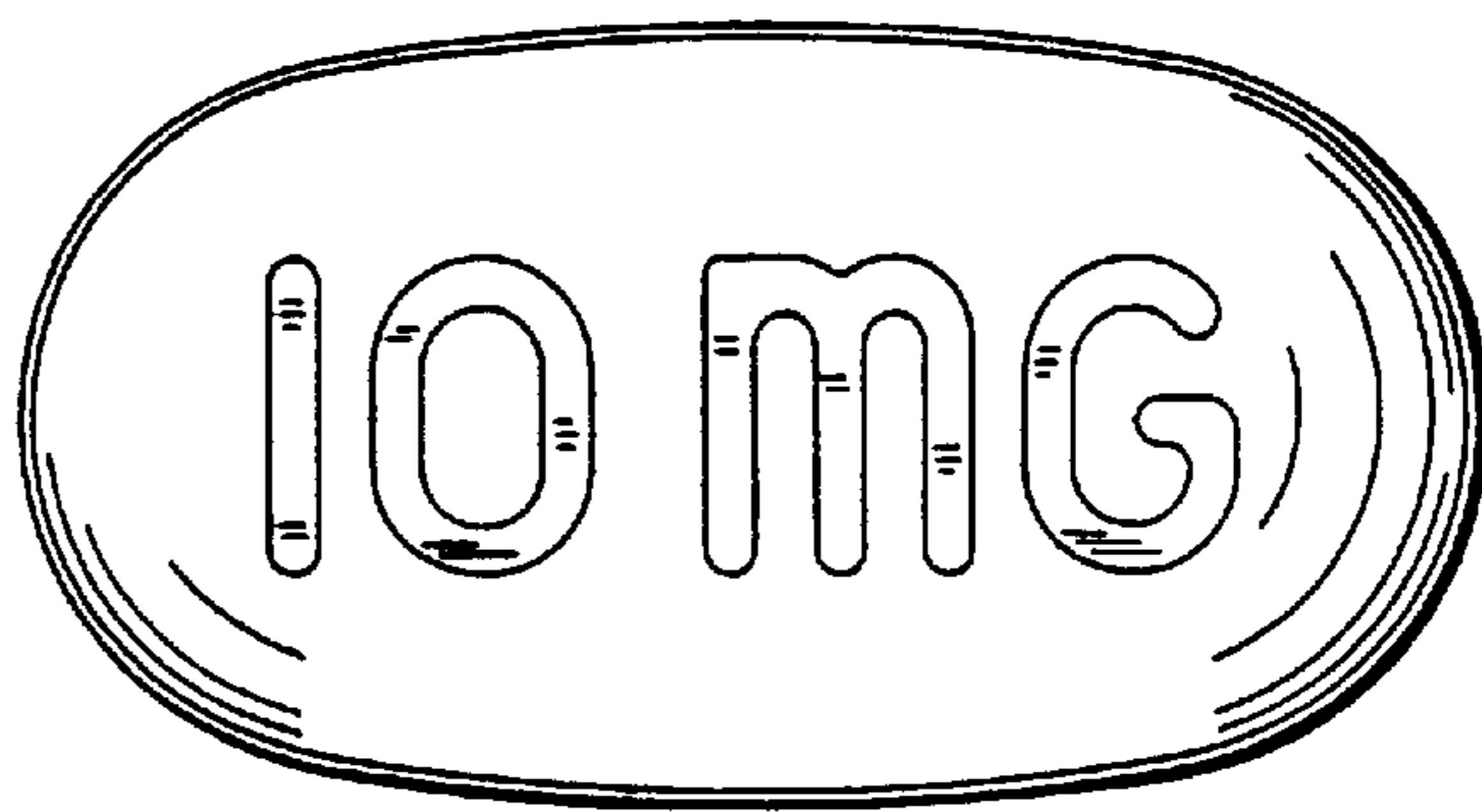

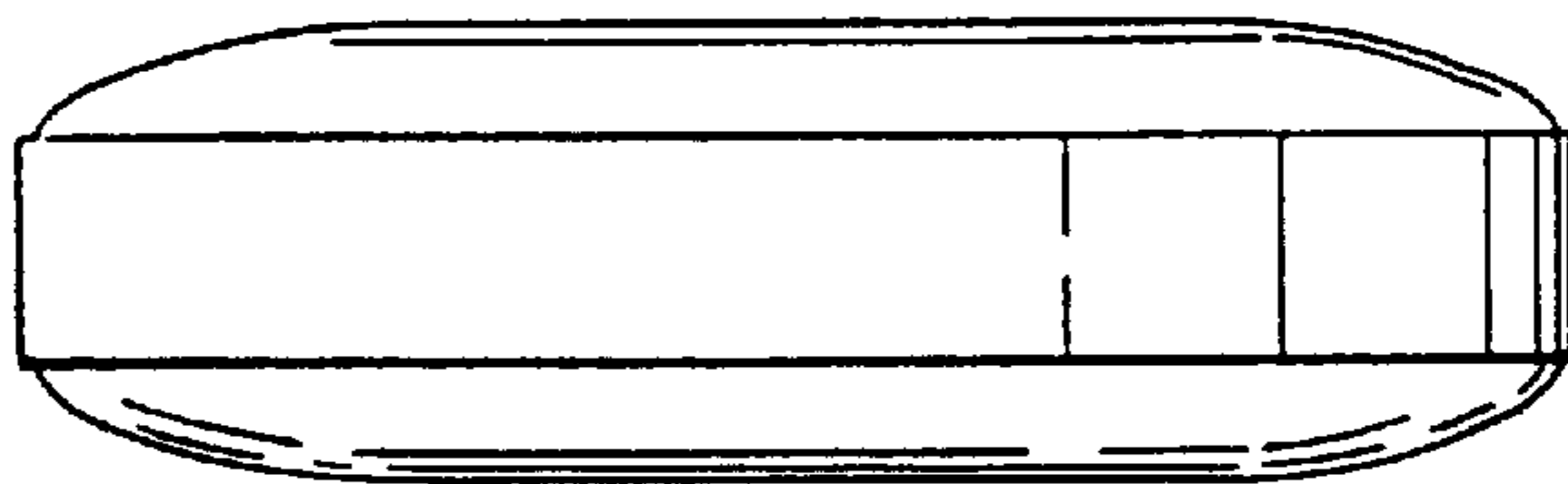

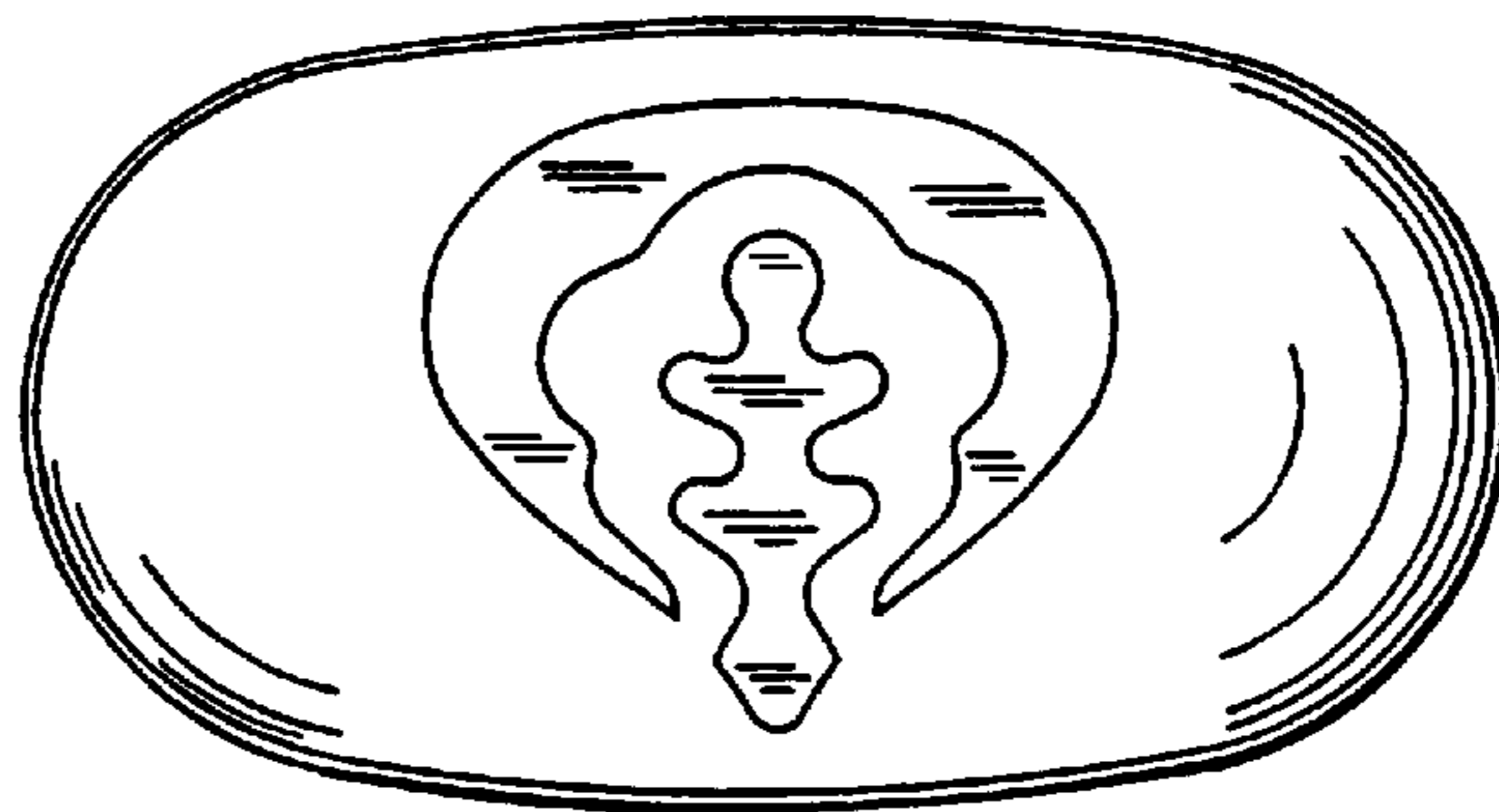

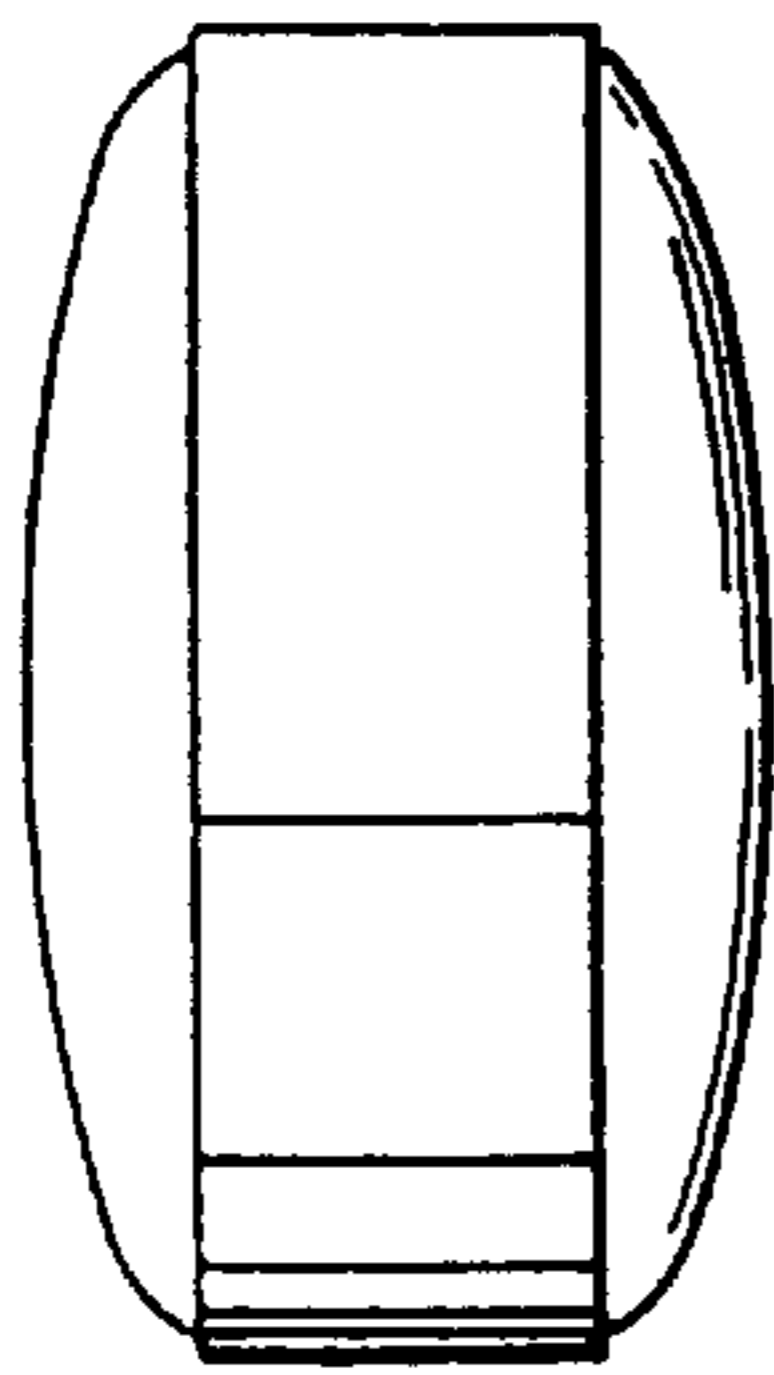

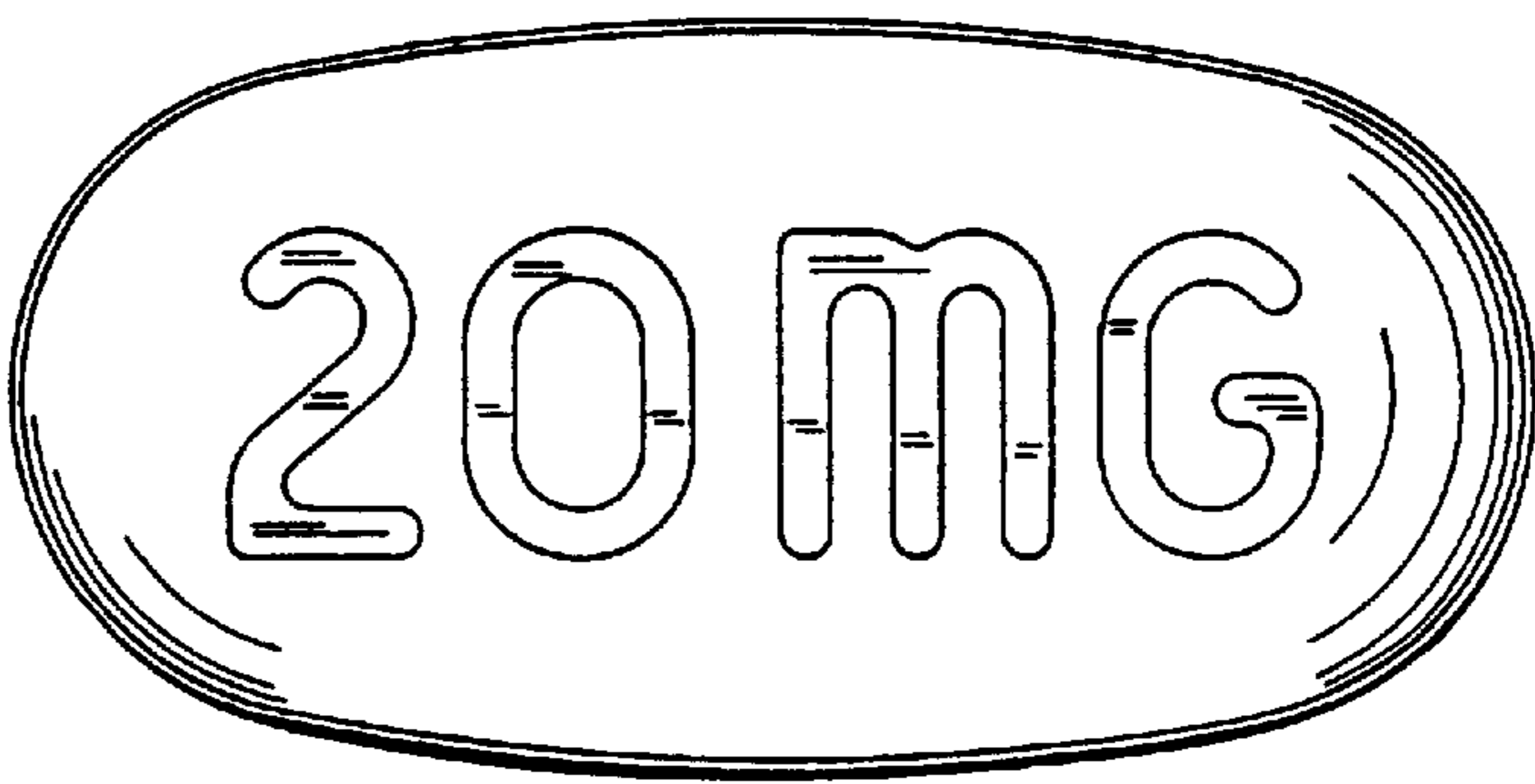

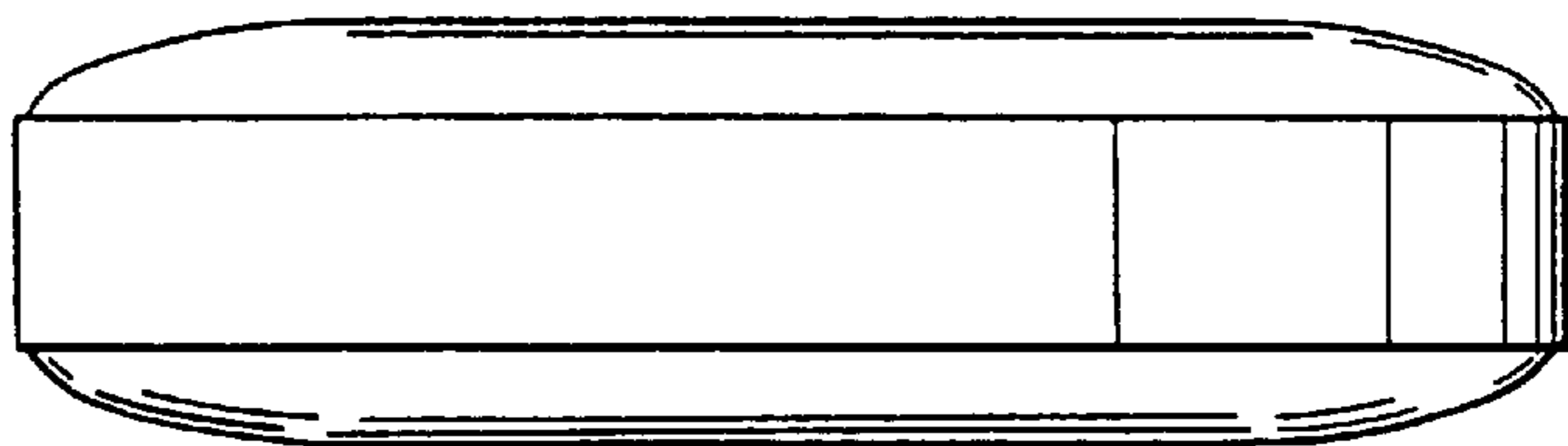
