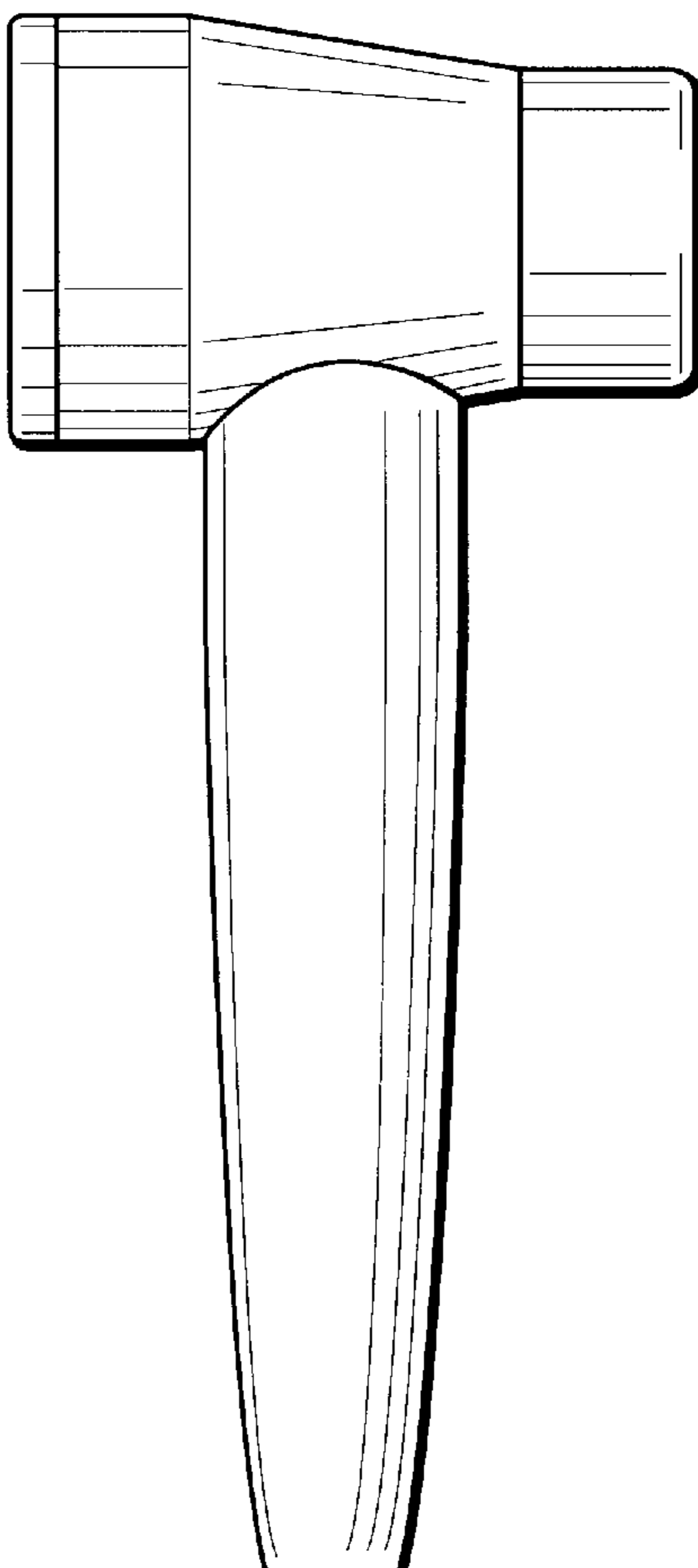

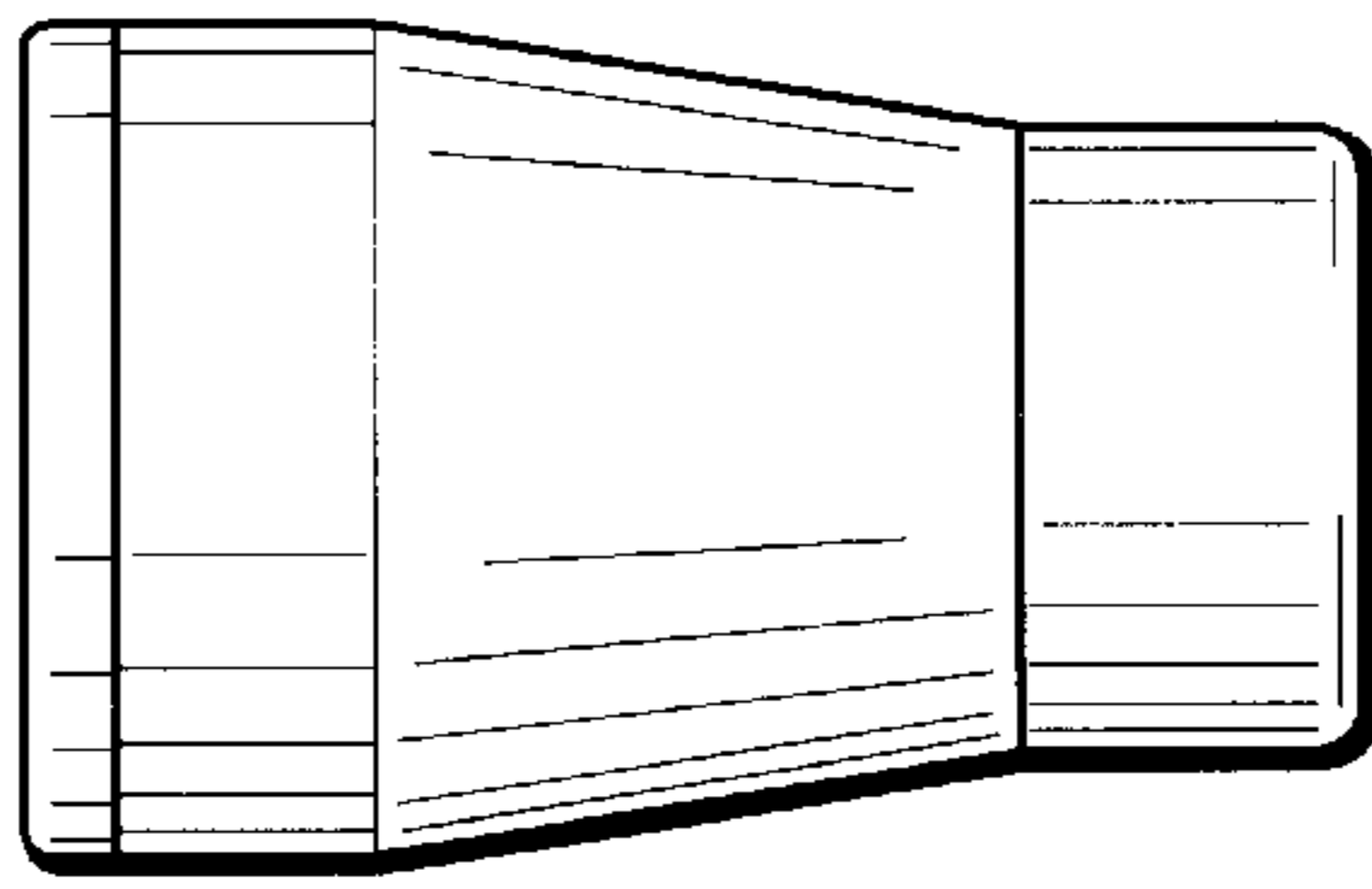
The ornamental design for an ultrasonic applicator, as shown and described.

**DESCRIPTION**

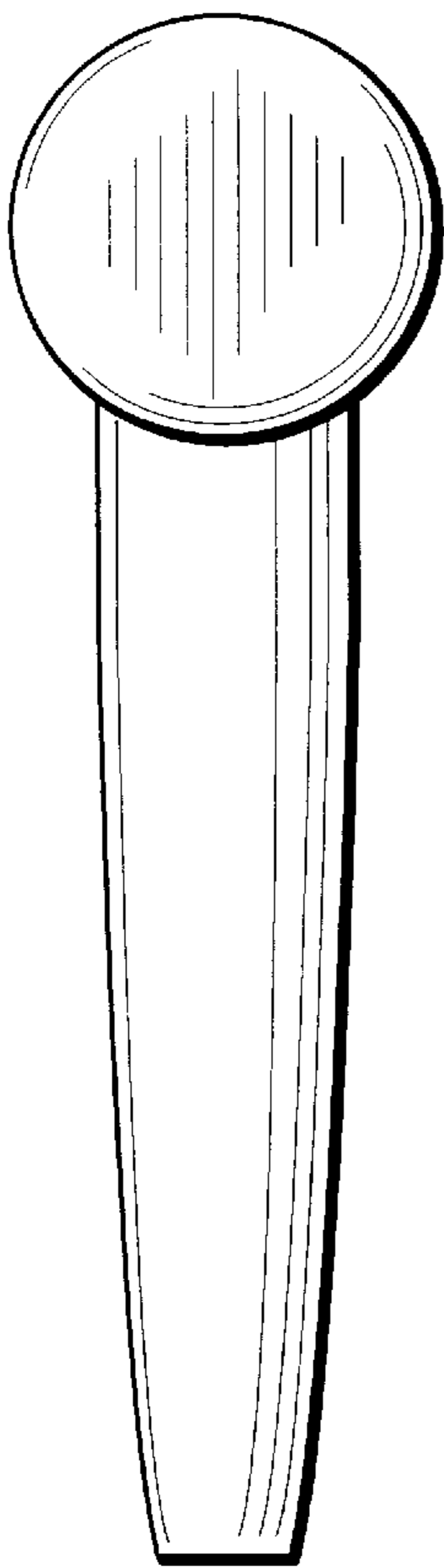
FIG. 1 is a front elevational view of an ultrasonic applicator of my new design, the rear elevational view being the mirror opposite thereof;

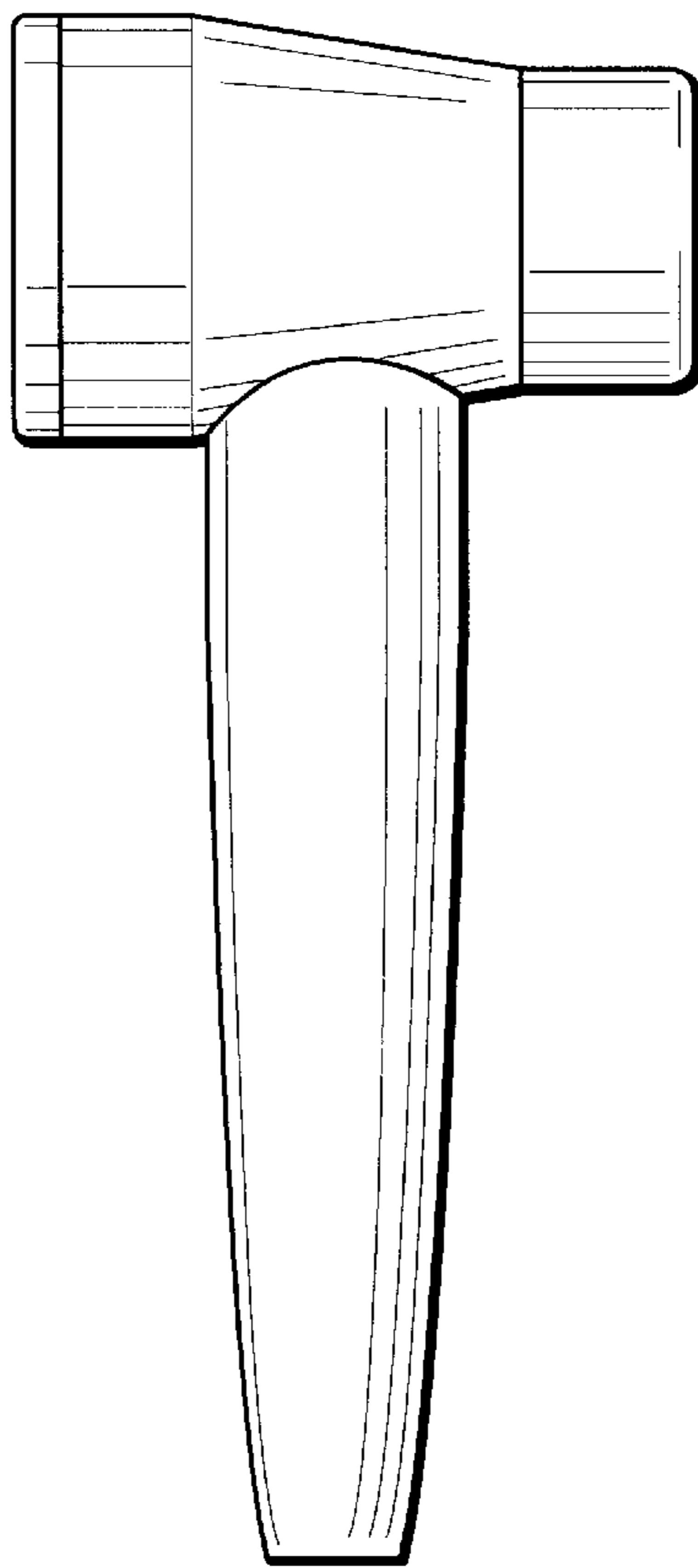




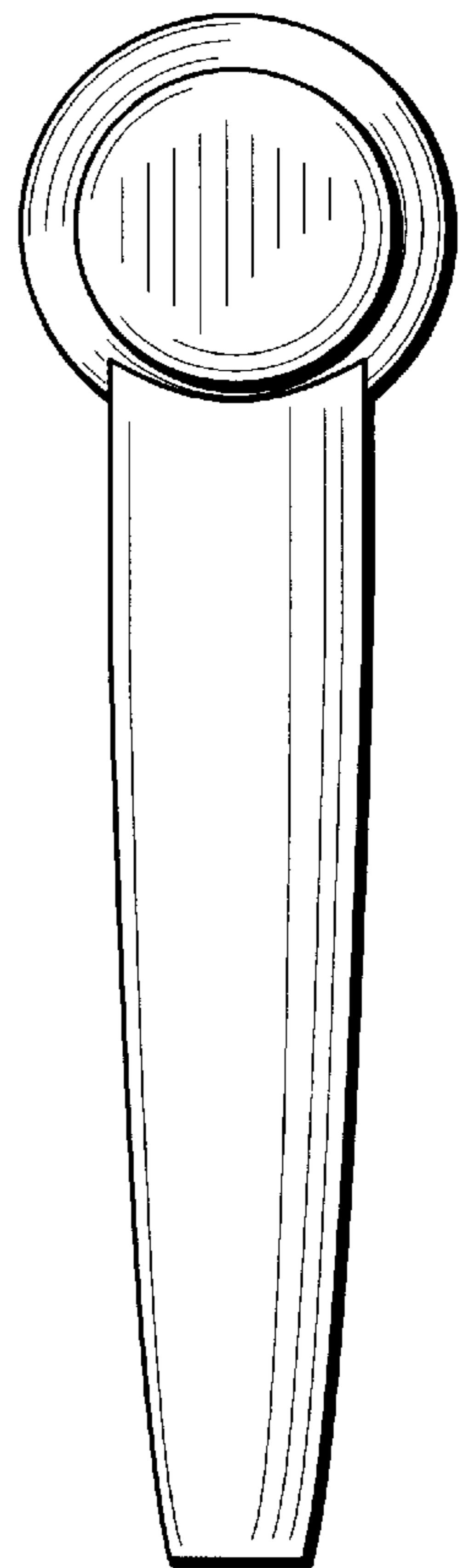

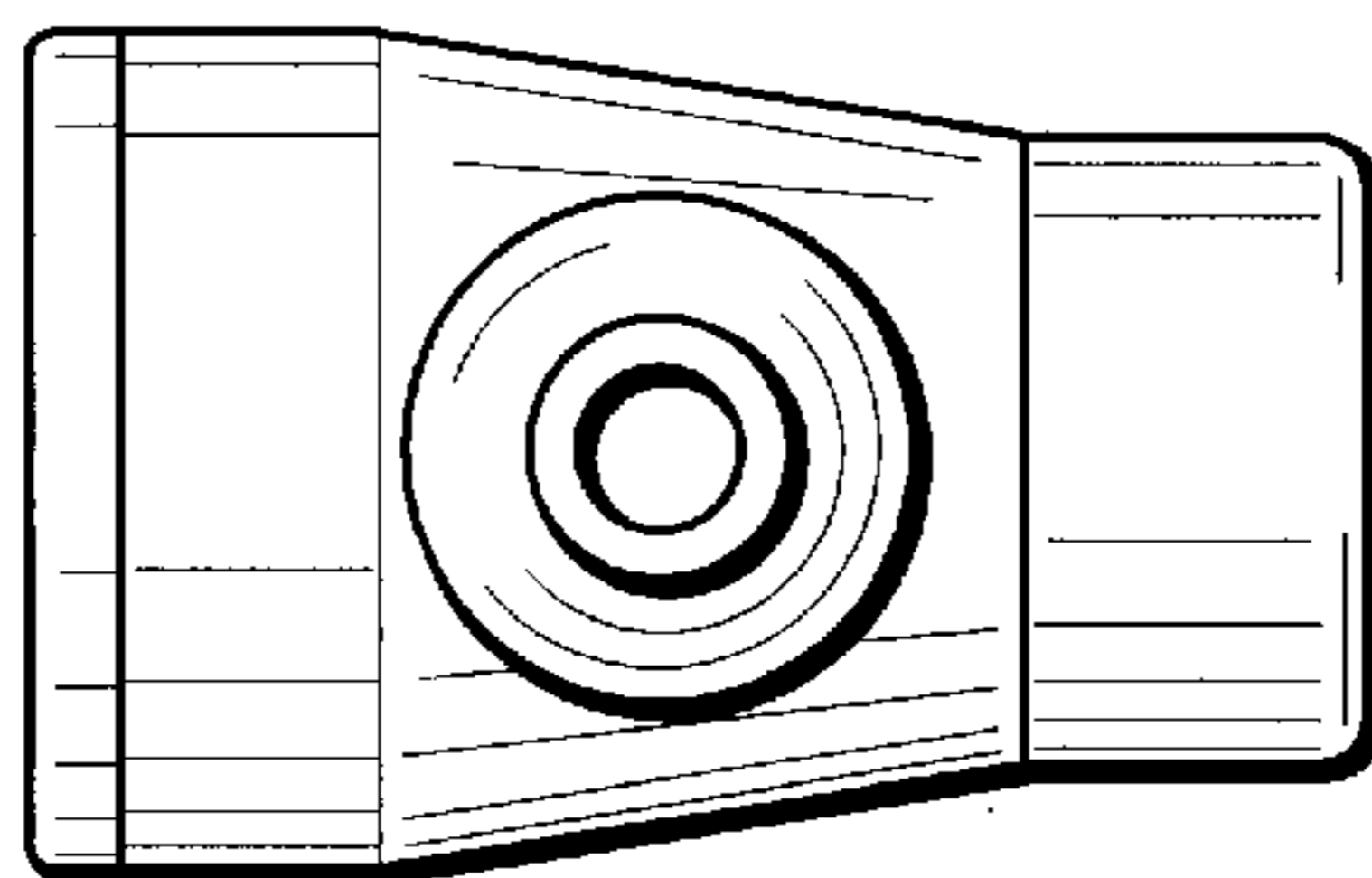
