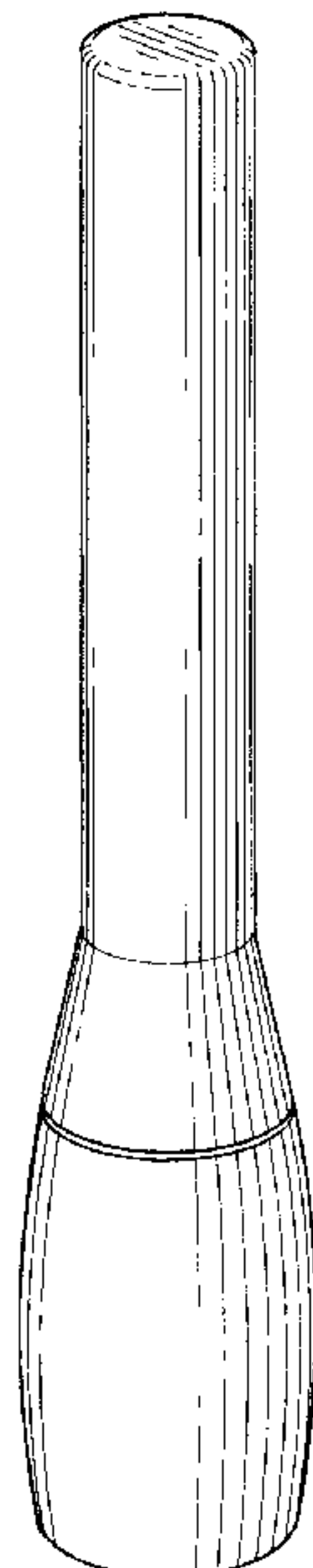
### [57] **CLAIM**

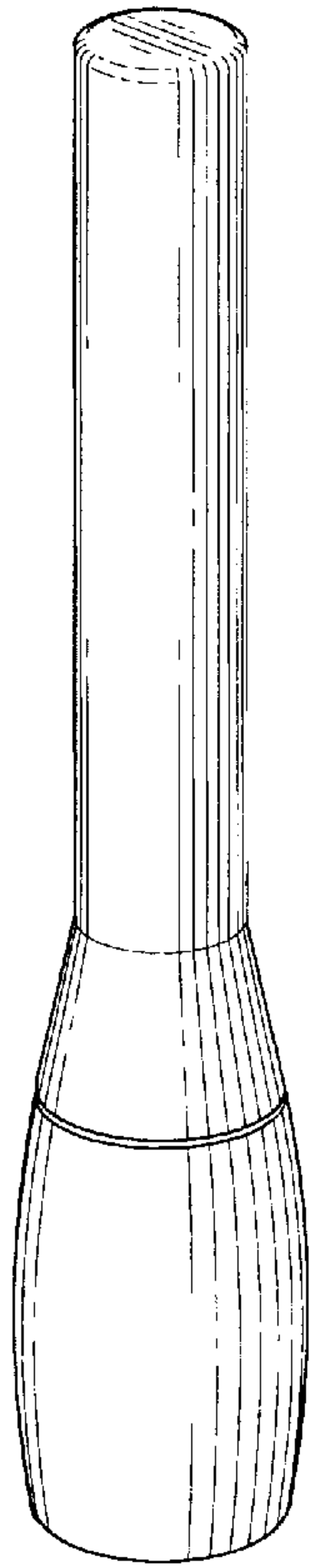

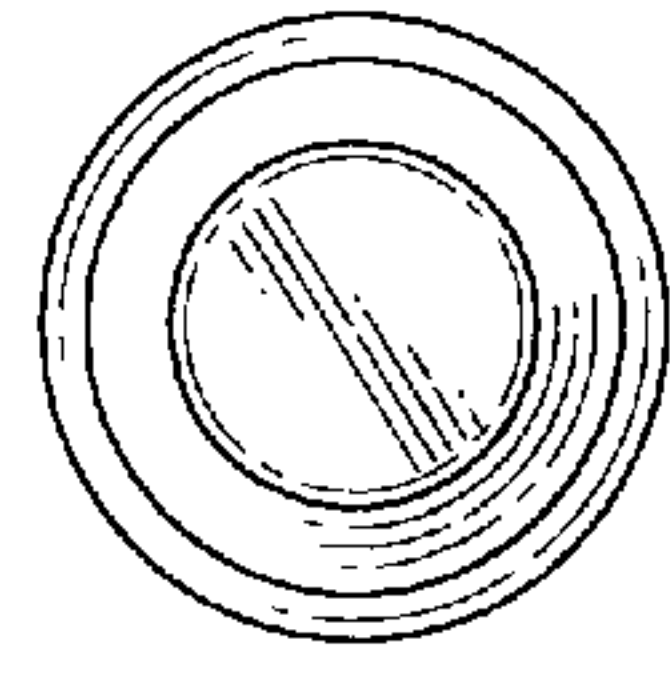

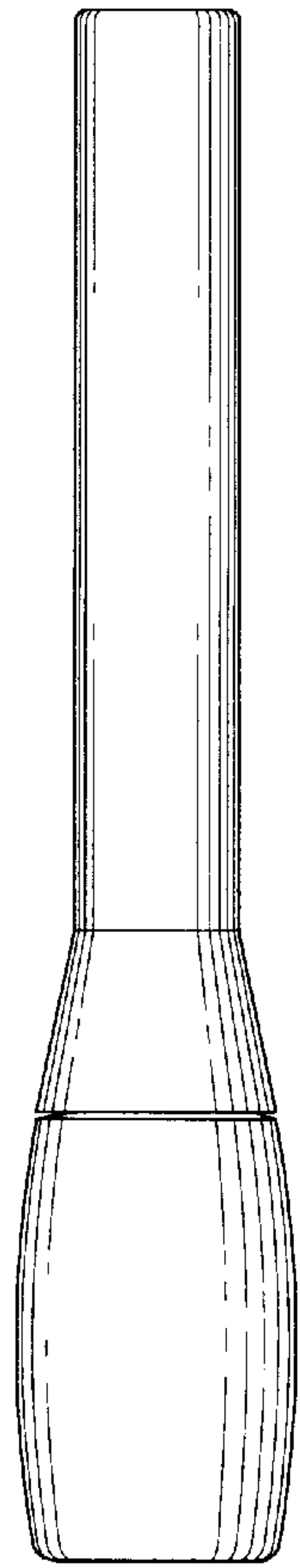

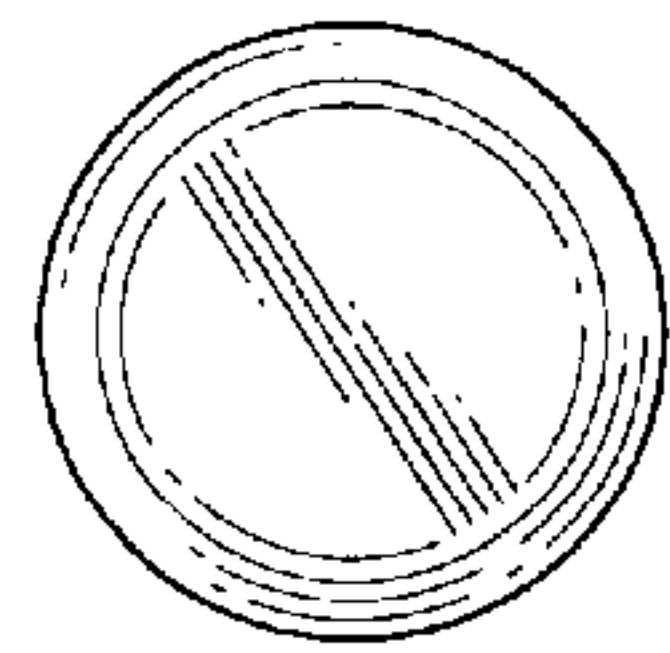
