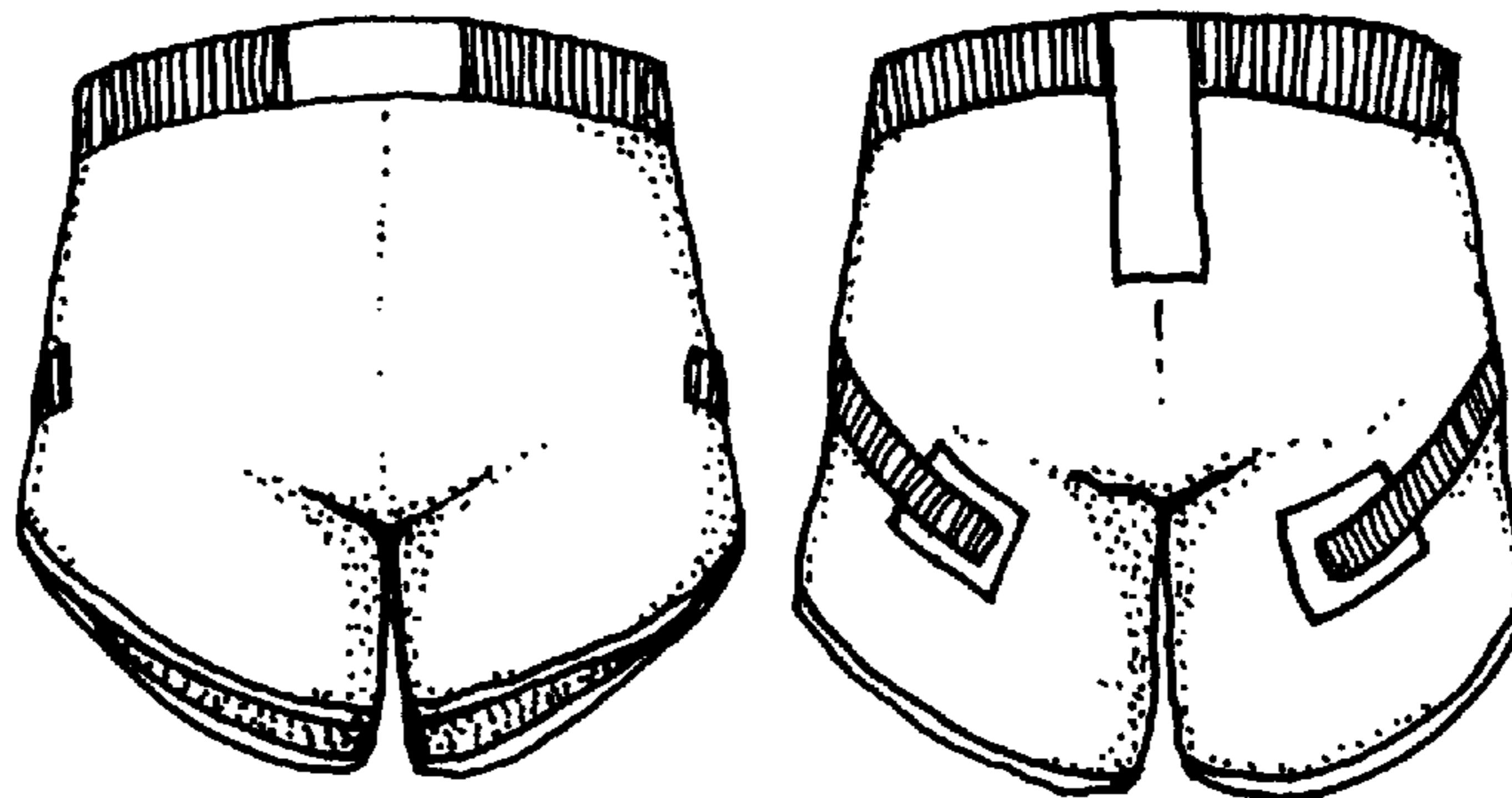
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of the groin protector in accordance with the design;

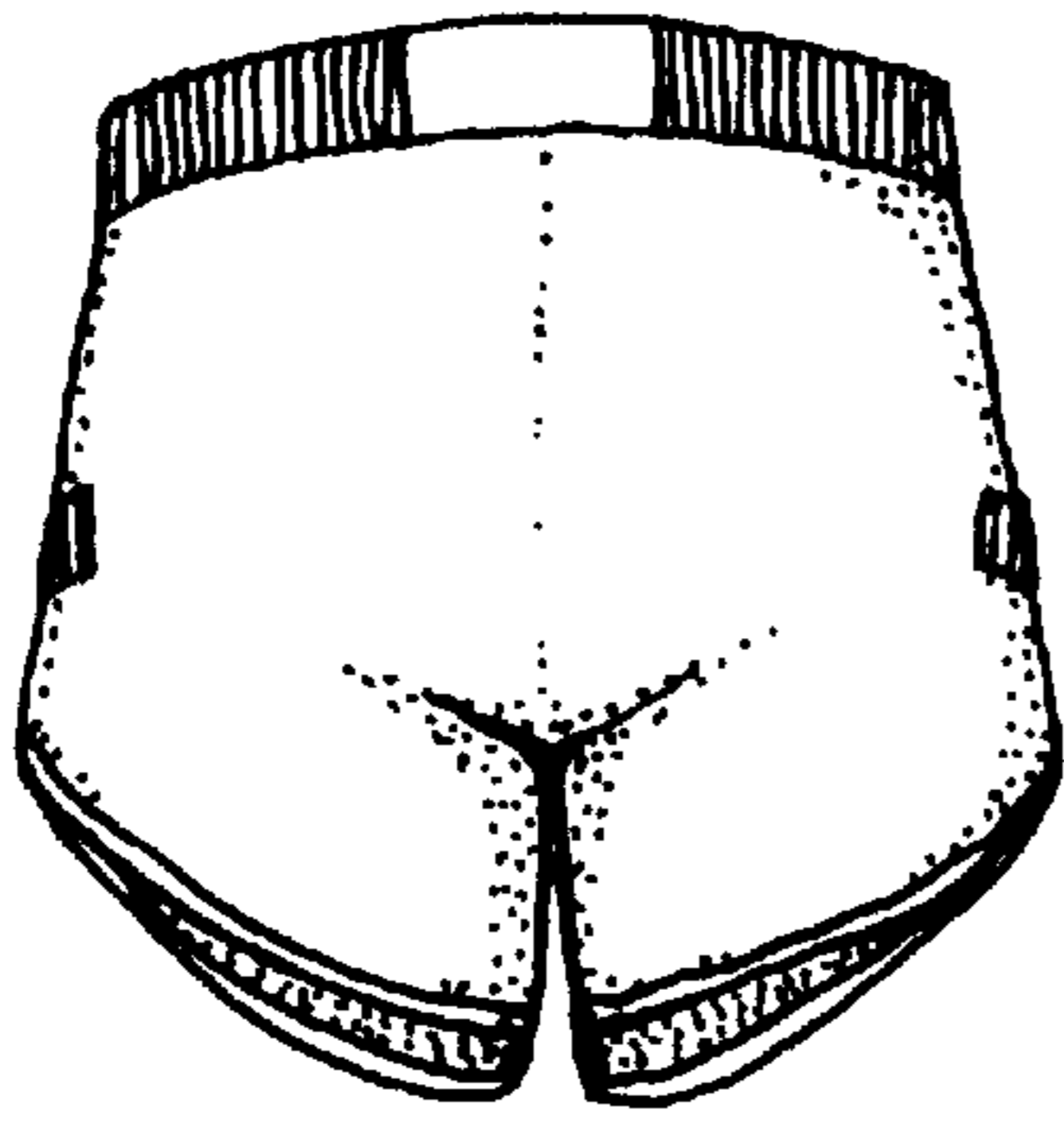

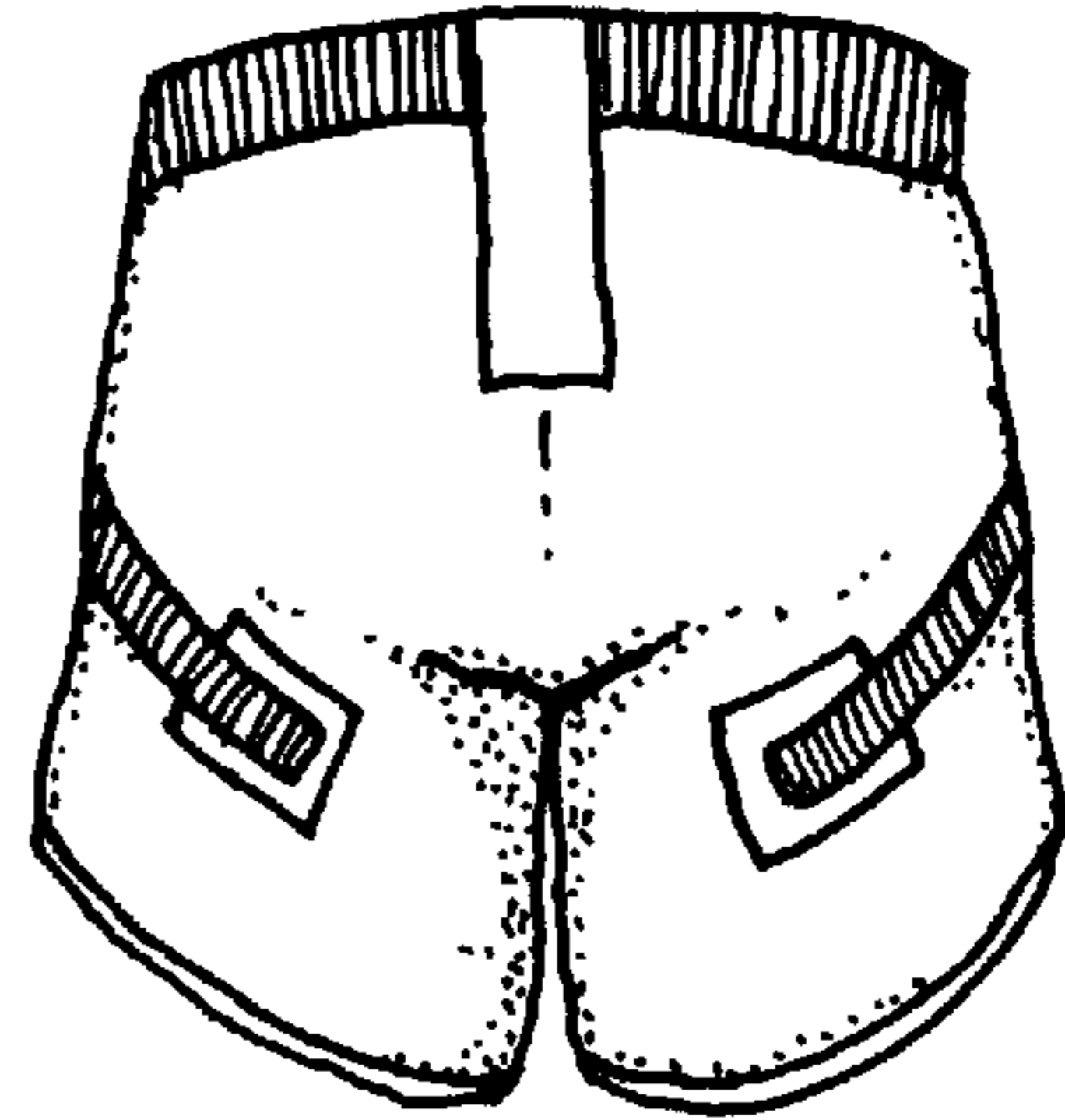

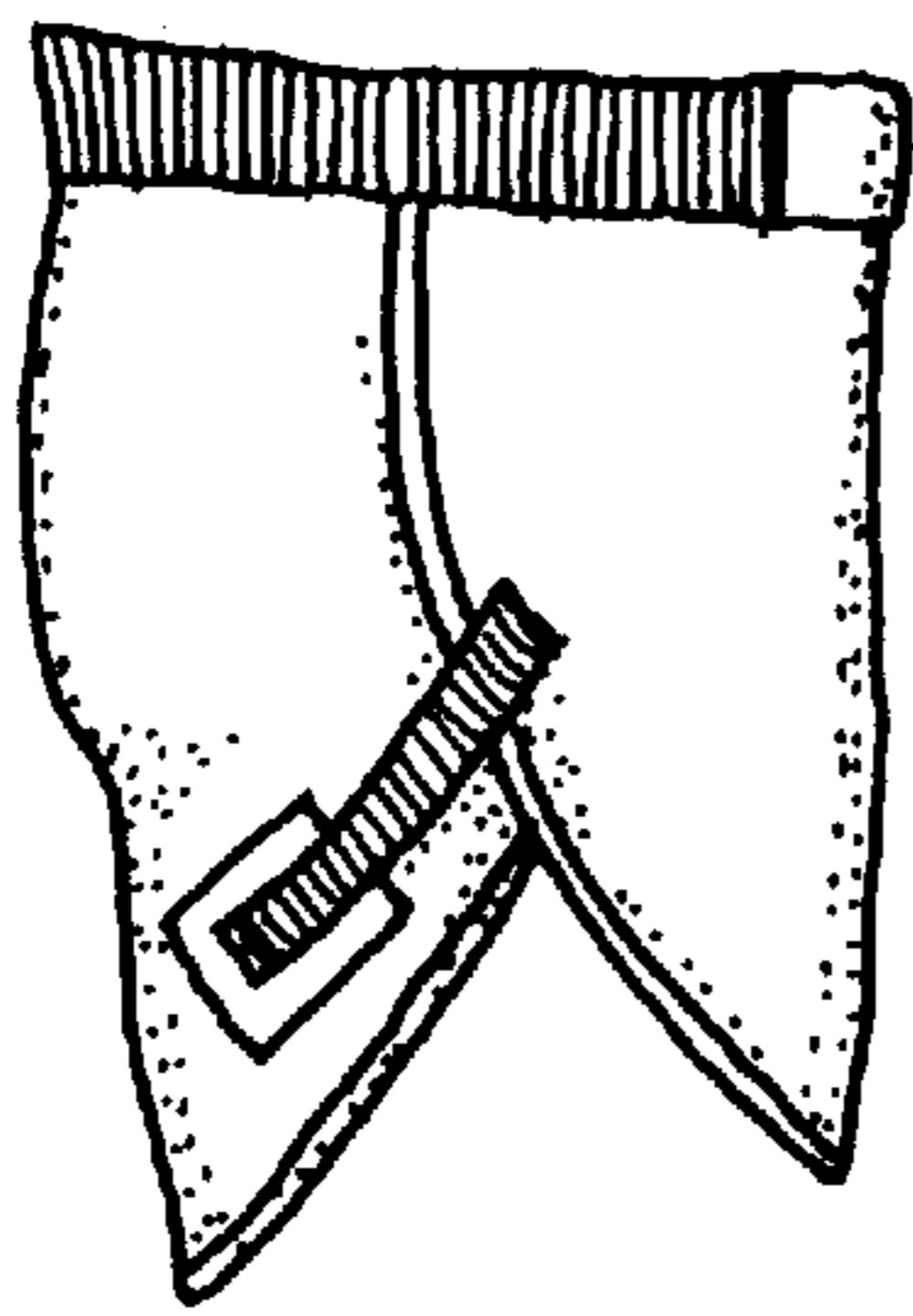

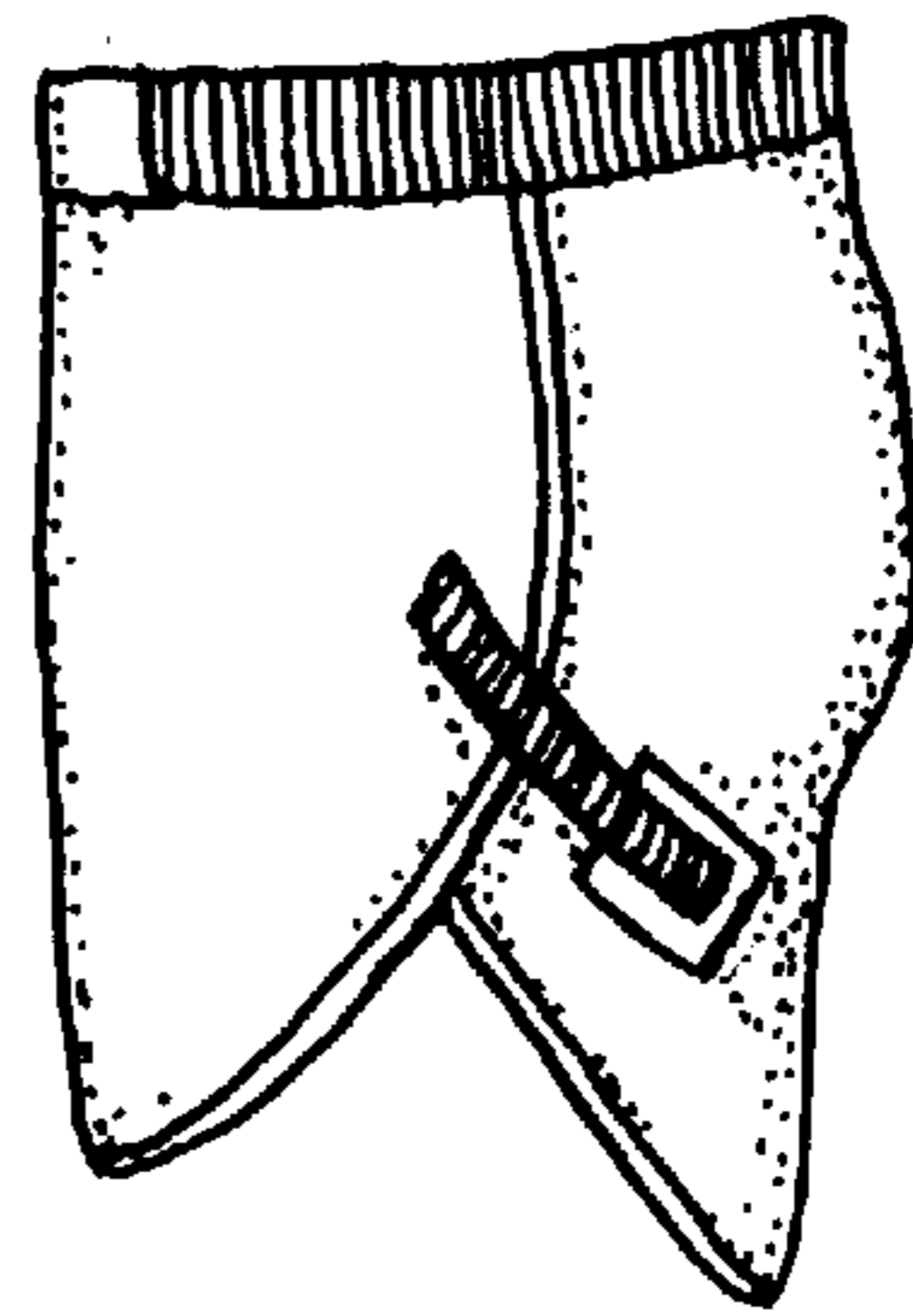

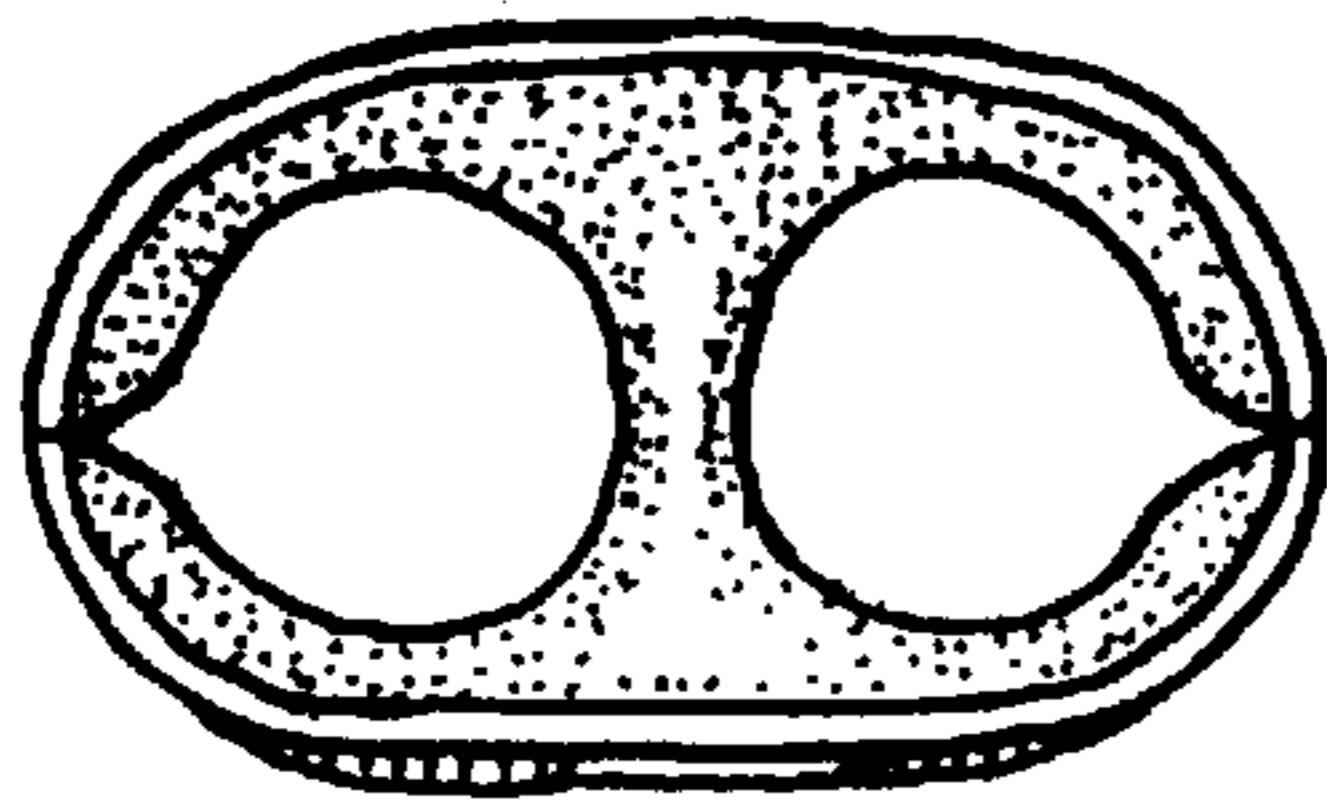

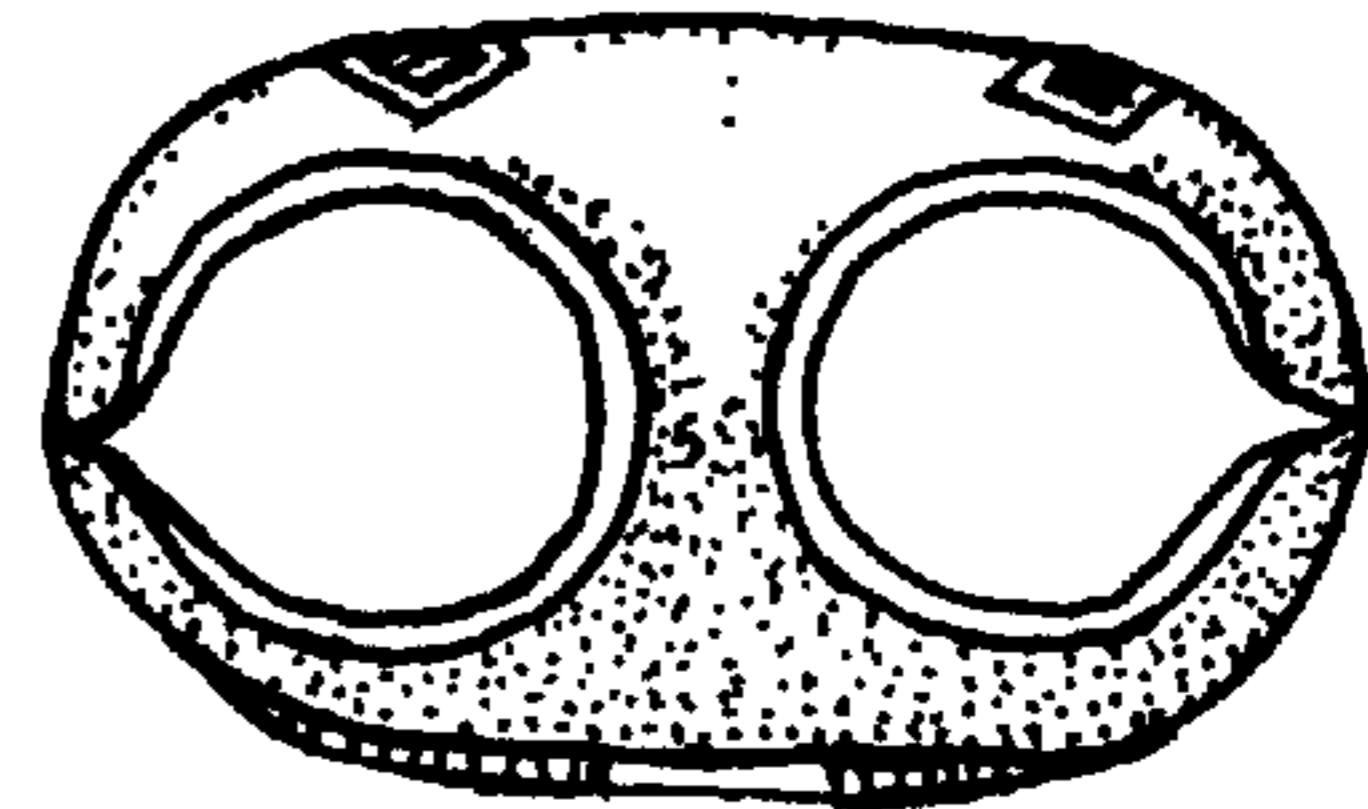
